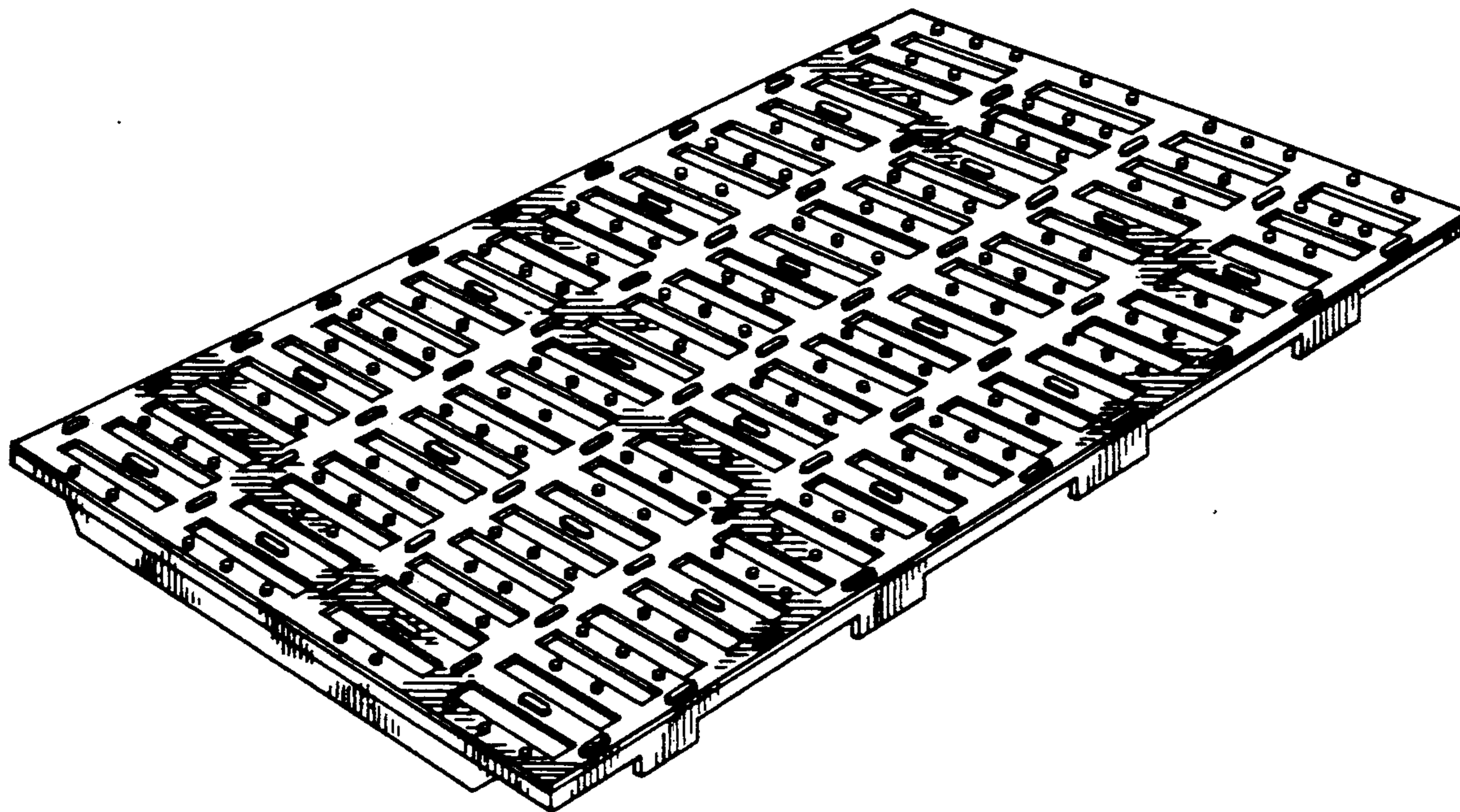

 FIG. 10 is a cross-section detail thereof on line 10—10 in FIG. 2.



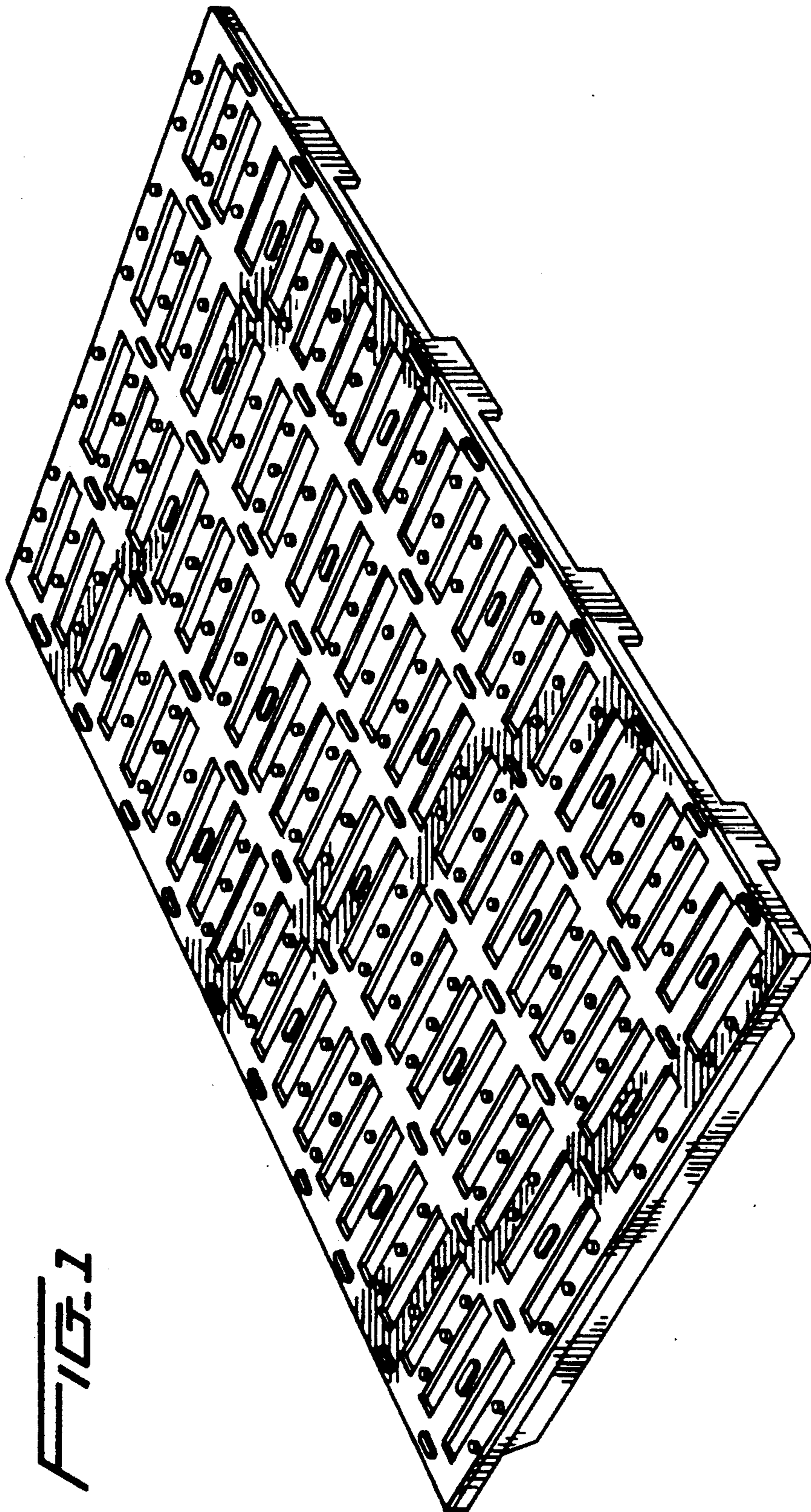

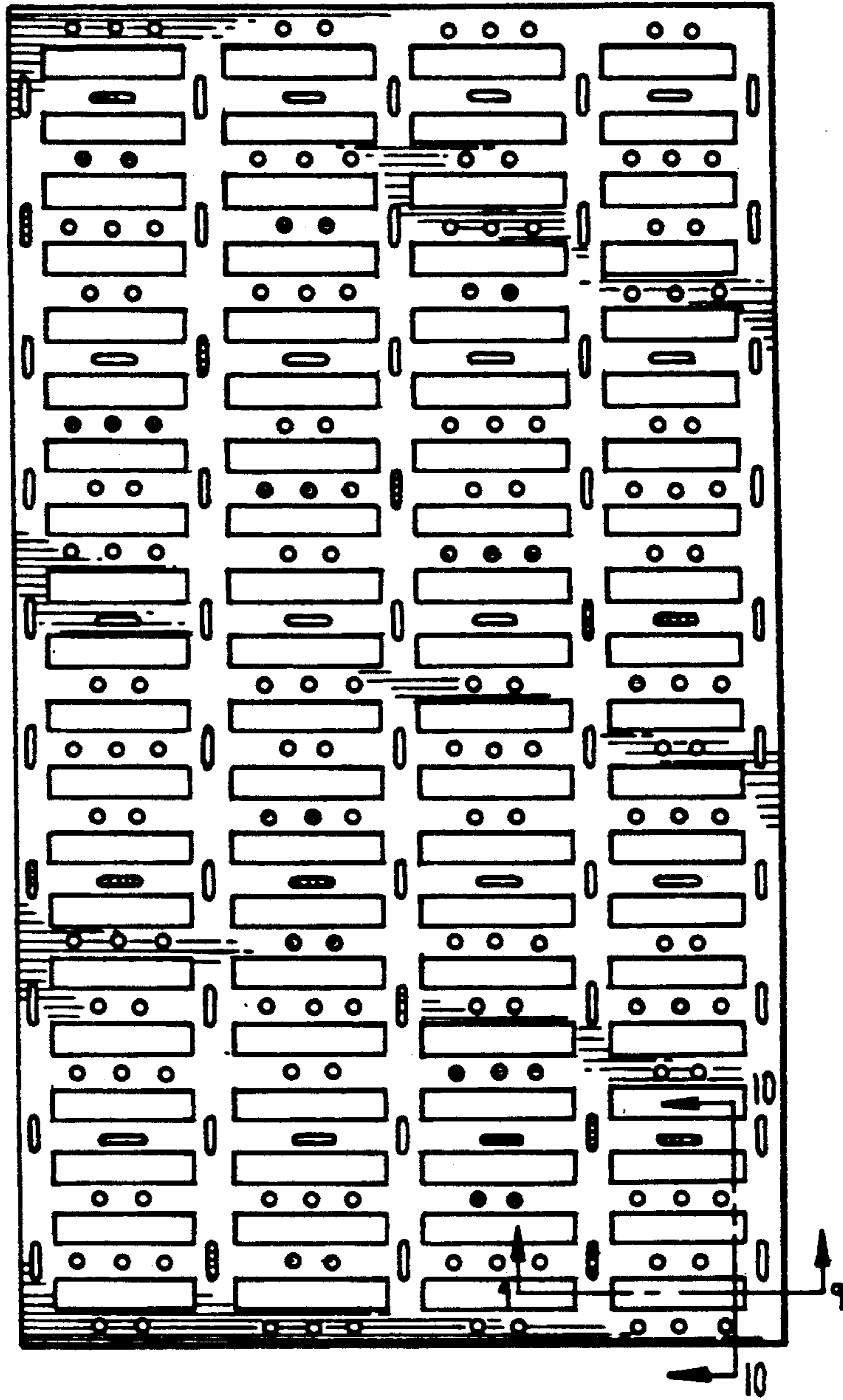

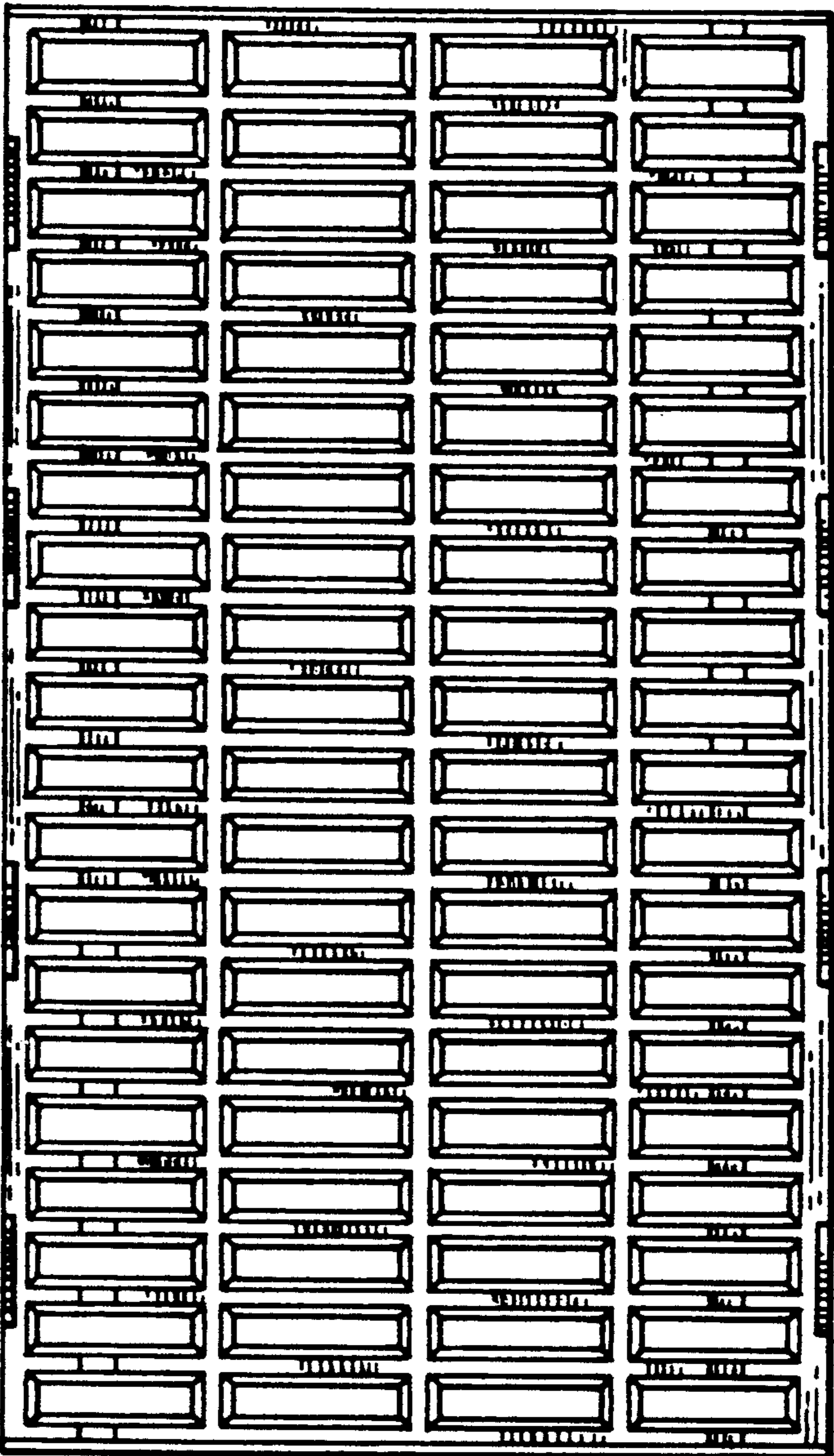

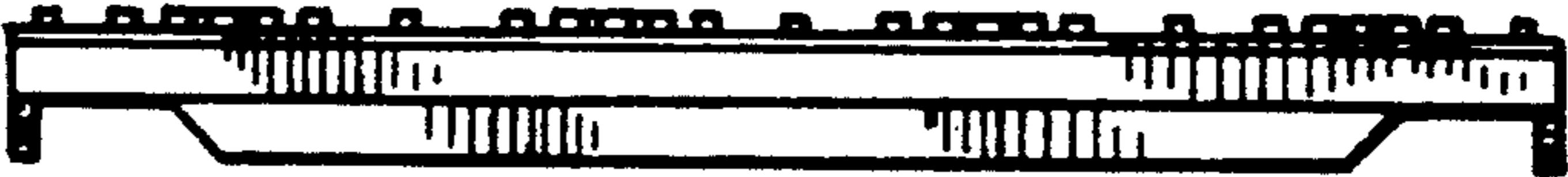

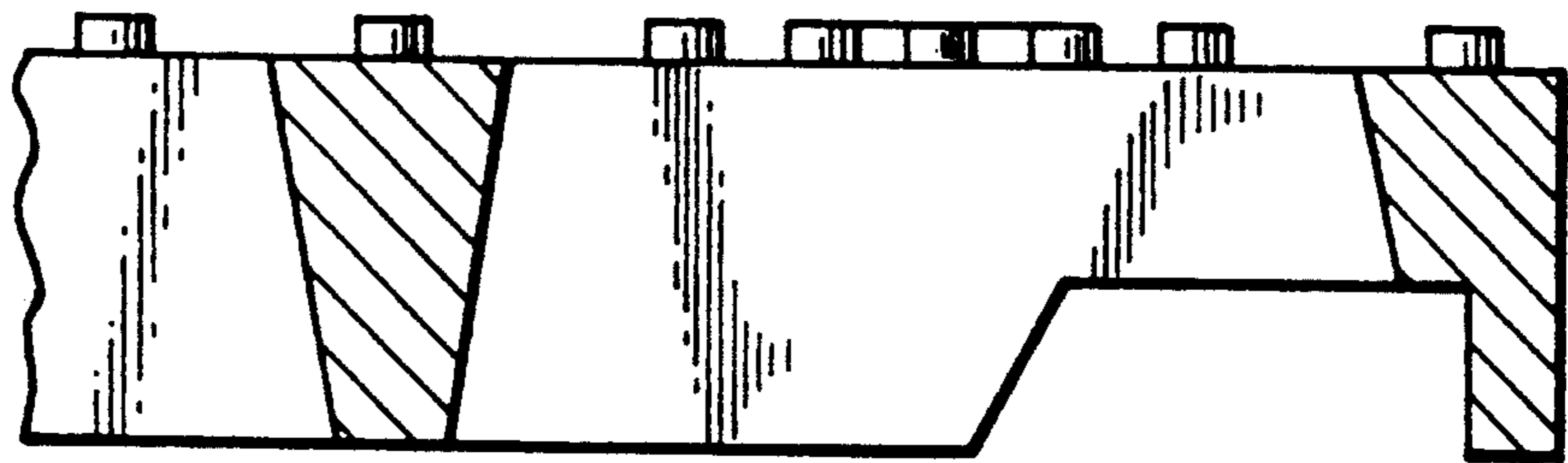
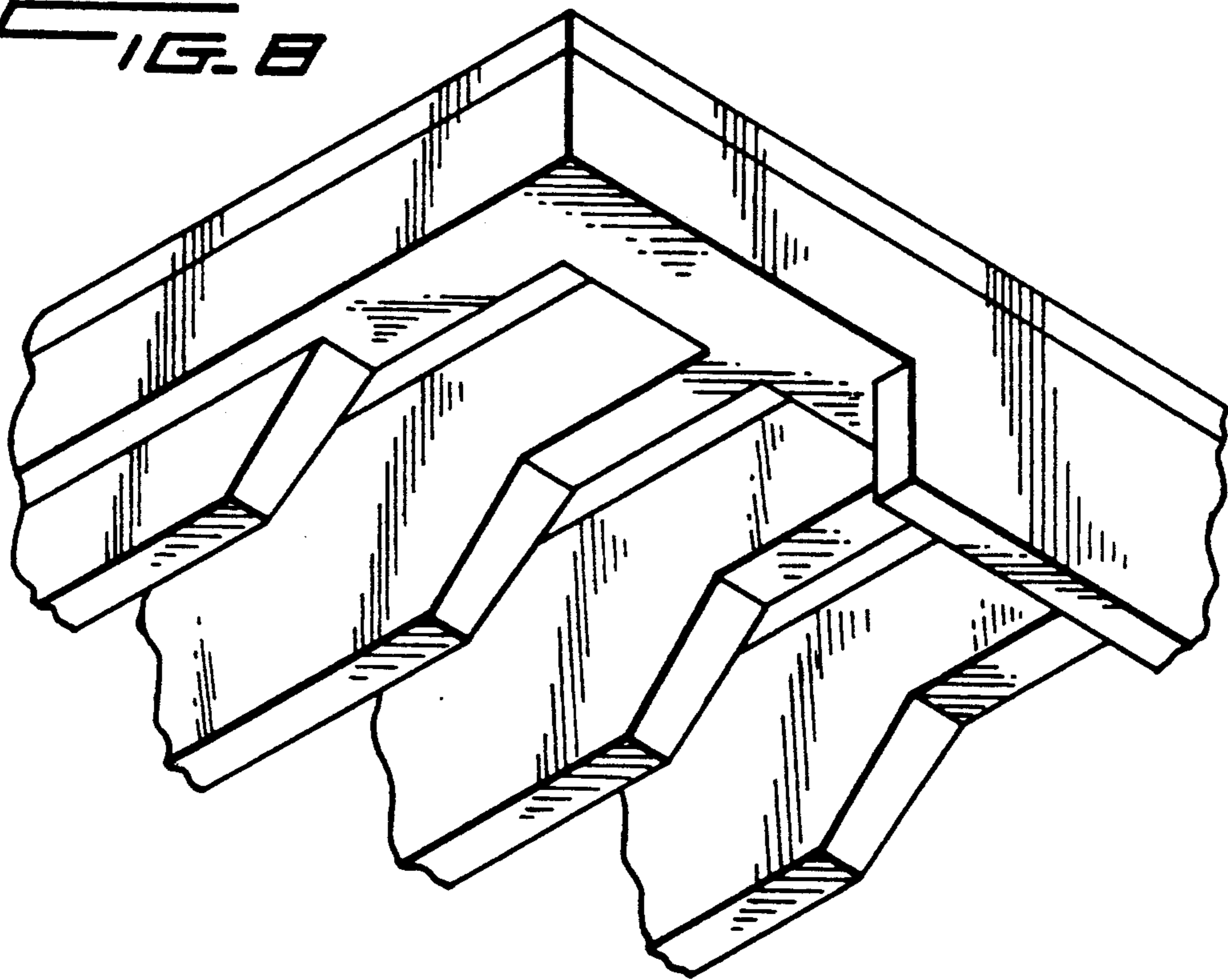

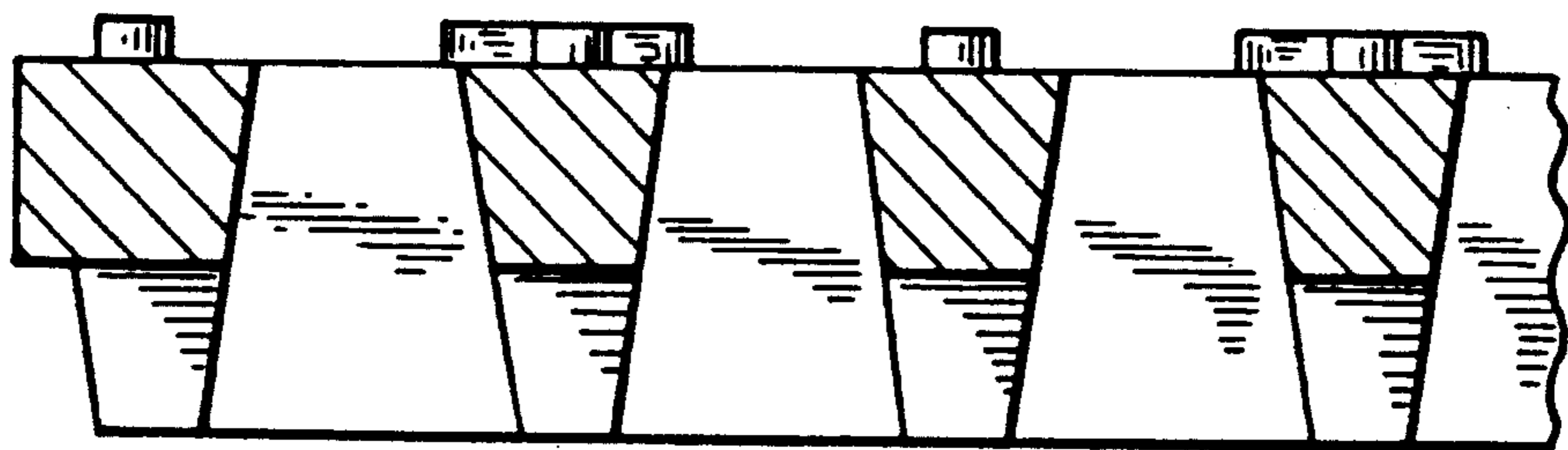
