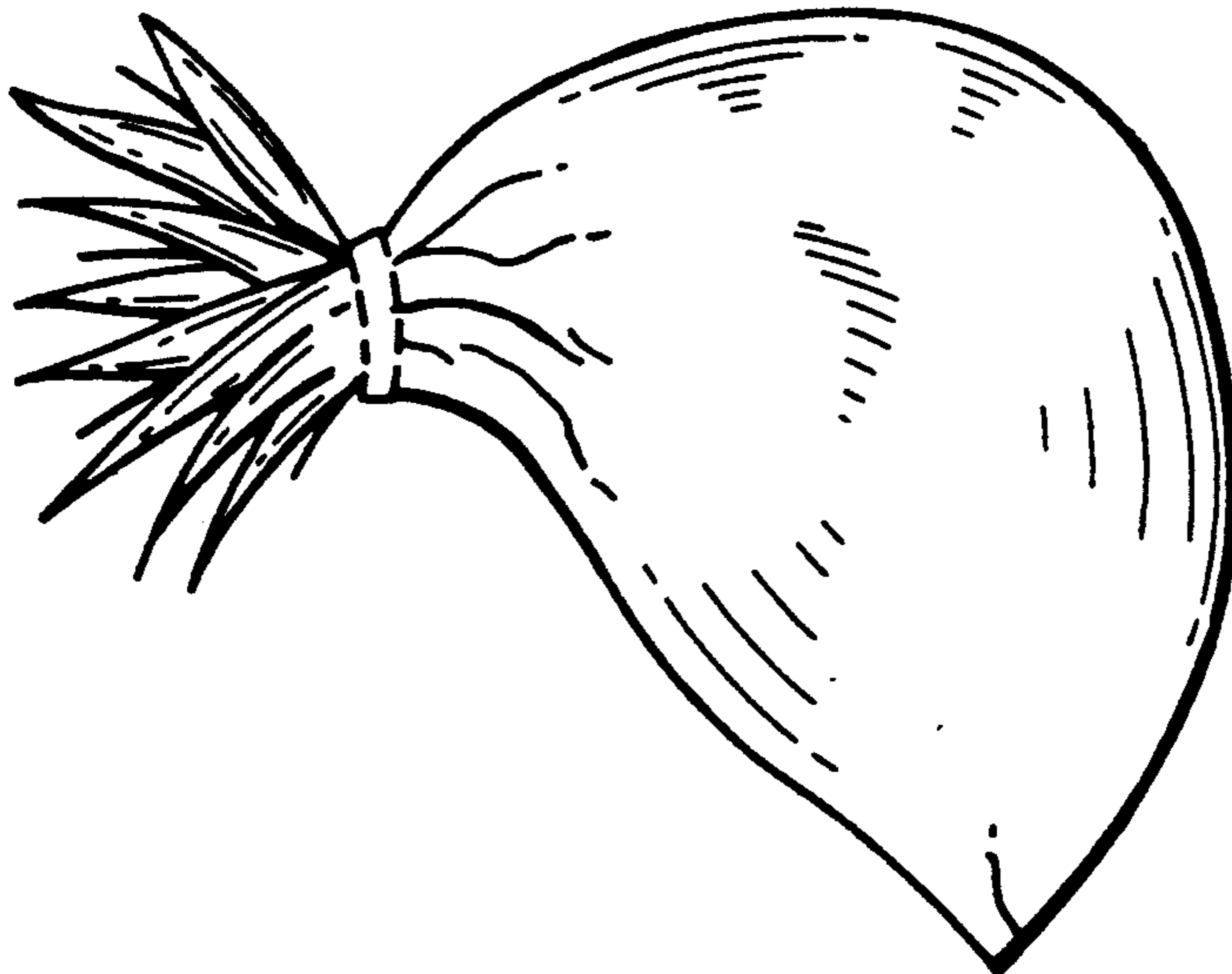
### [57] CLAIM

The ornamental design for a swim cap, as shown and described.

### DESCRIPTION

FIG. 1 is a front elevational view of a swim cap showing my new design in an open position;  
 FIG. 2 is a side perspective view thereof, the opposite side being a mirror image;  
 FIG. 3 is a top end view looking down in FIG. 1; and,  
 FIG. 4 is a bottom end view looking up in FIG. 1.  
 The broken line showing of the band in FIG. 2 is for illustrative purposes only and forms no part of the claimed design.

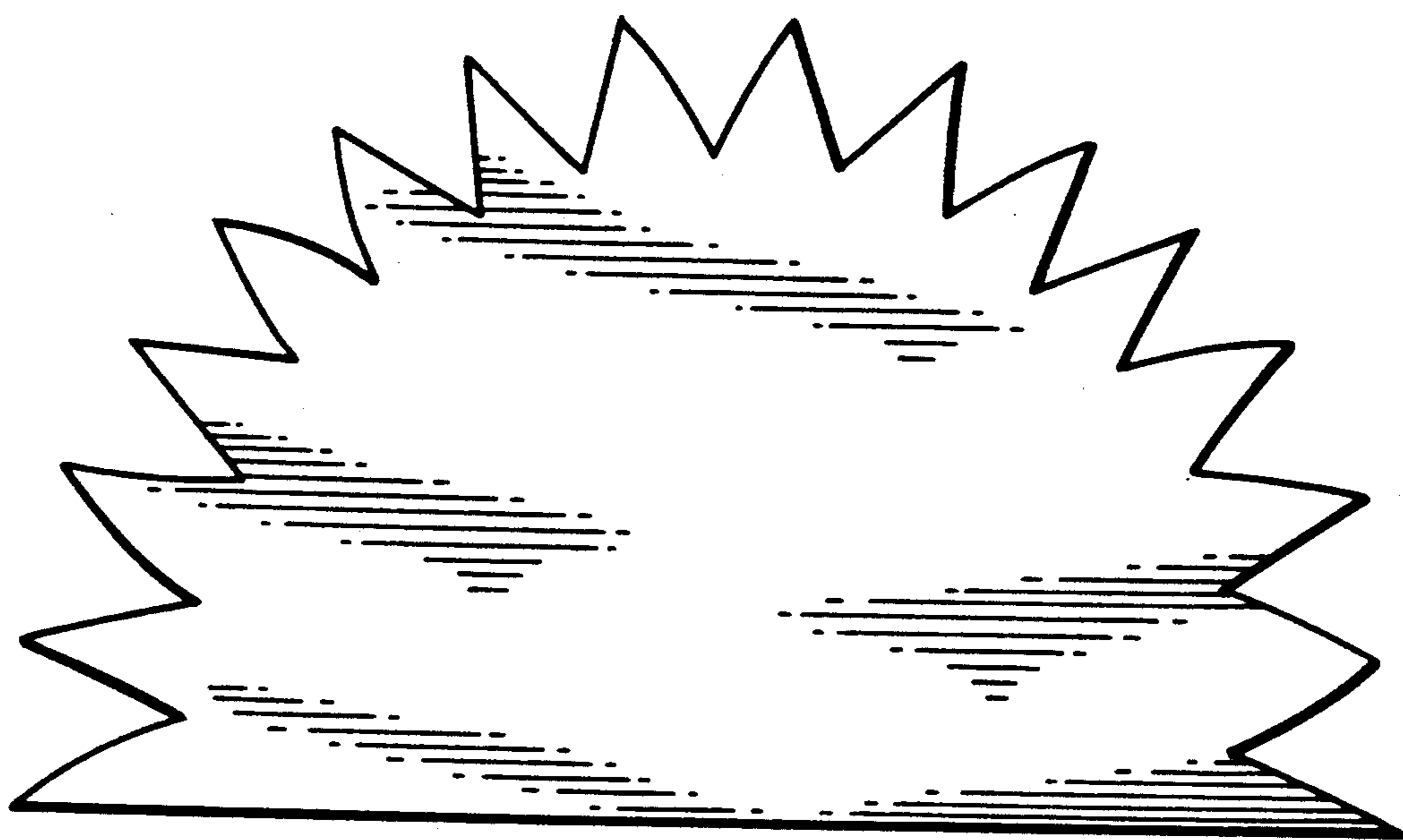

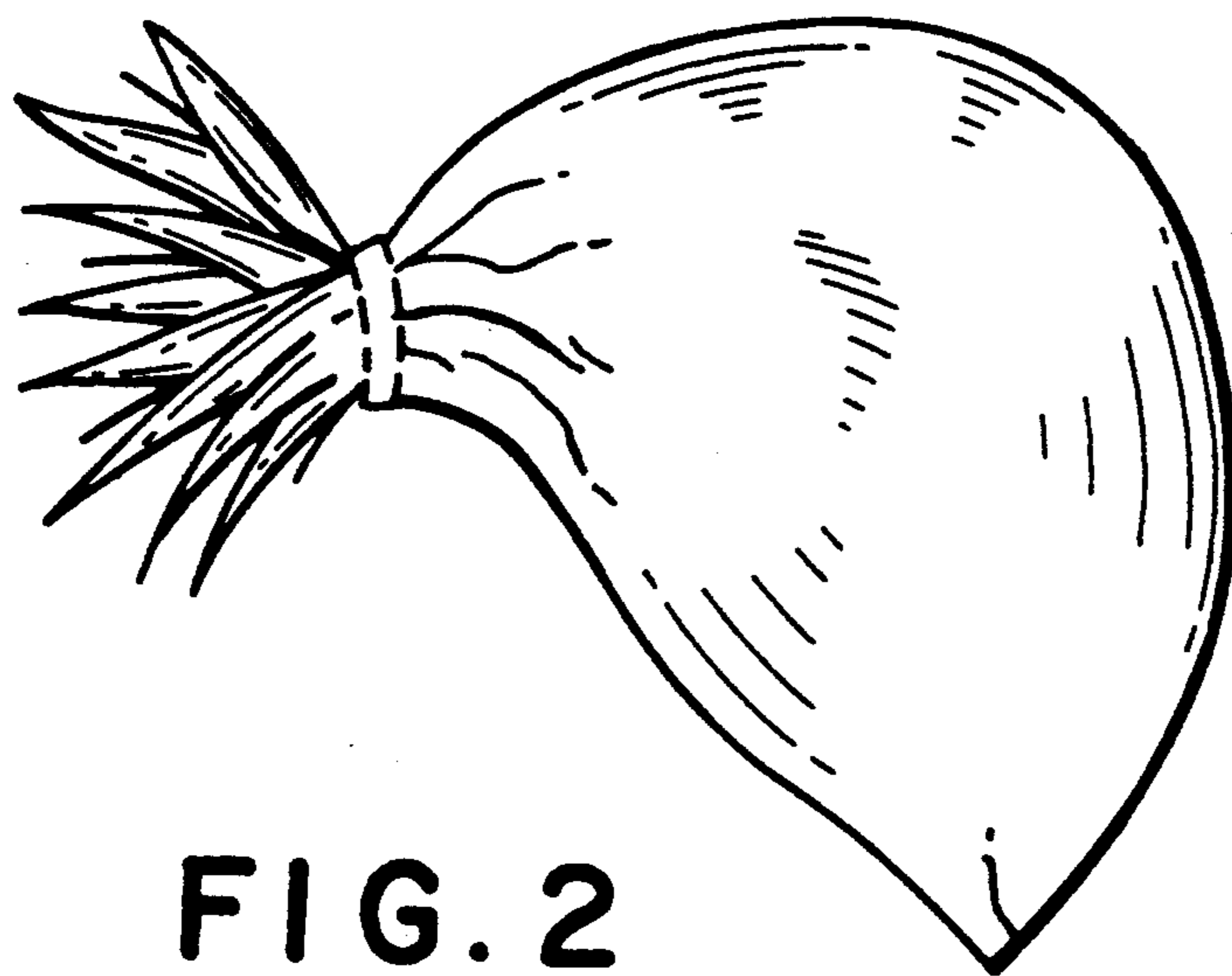
