## [57] CLAIM

The ornamental design for an electric dental flosser, as shown and described.

## DESCRIPTION

FIG. 1 is a front perspective view of an electric dental flosser showing our design;

FIG. 2 is a front elevational view thereof, the rear side being a mirror image;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a left side elevational view thereof on an enlarged scale, the rear view being a mirror image, the head and neck of the flosser are shown separately for convenience and clarity of illustration on an enlarged scale;

FIG. 5 is a right side elevational view thereof on an enlarged scale;

FIG. 6 is a top plan view thereof on an enlarged scale;

FIG. 7 is a bottom plan view of head on an enlarged scale;

FIG. 8 is a front elevational view thereof, the rear view being a mirror image, the head of the flosser is shown separately for convenience and clarity of illustration on an enlarged scale;

FIG. 9 is a left side elevational view of the flosser head on an enlarged scale;

FIG. 10 is a right side elevational view of the flosser head on an enlarged scale.

FIG. 11 is a right side elevational view thereof;

FIG. 12 is a top plan view thereof; and,

FIG. 13 is a bottom plan view thereof.

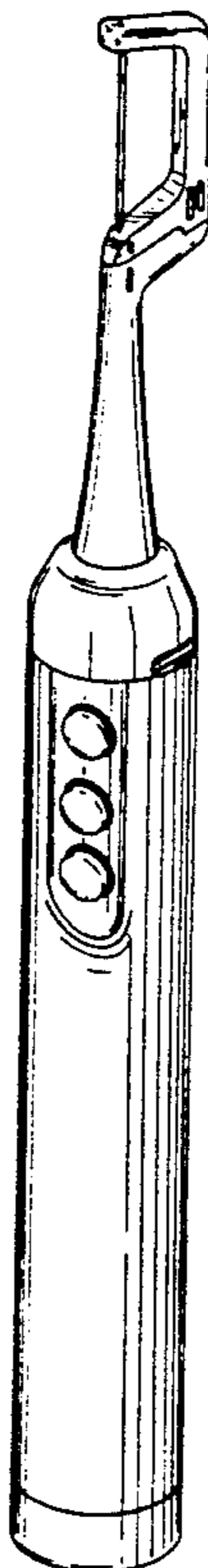

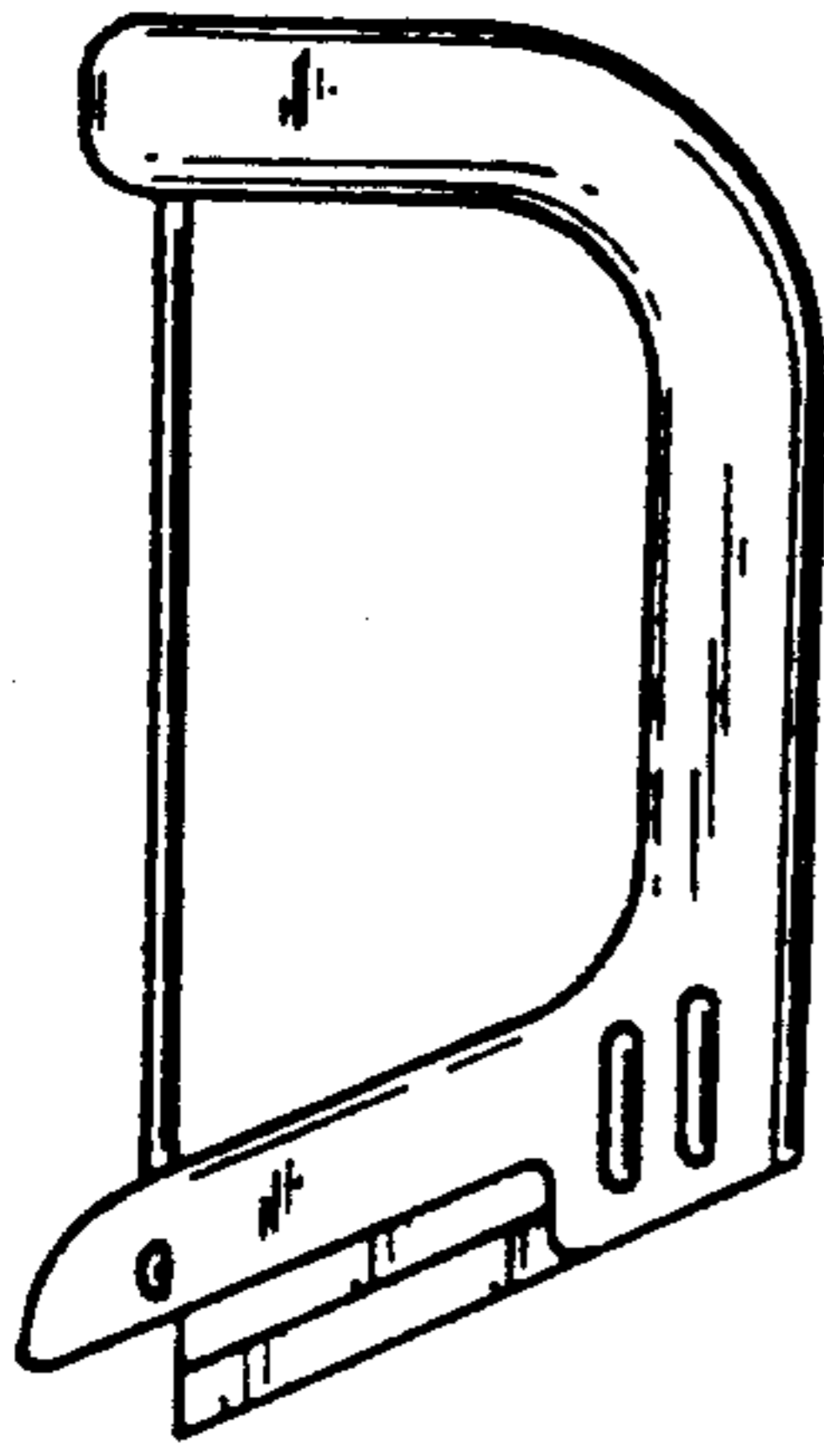

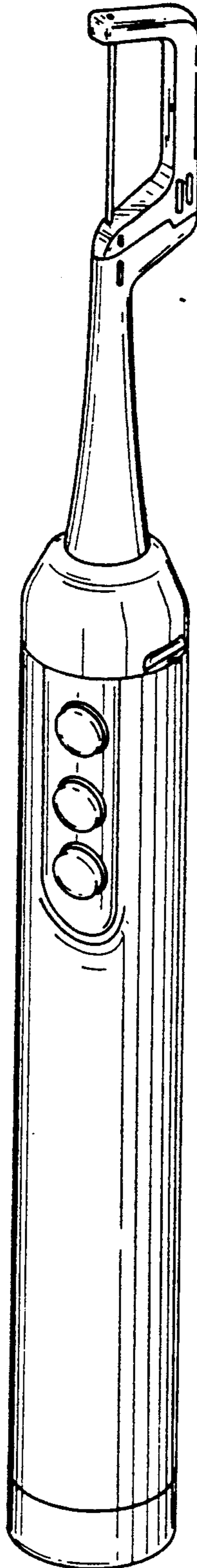

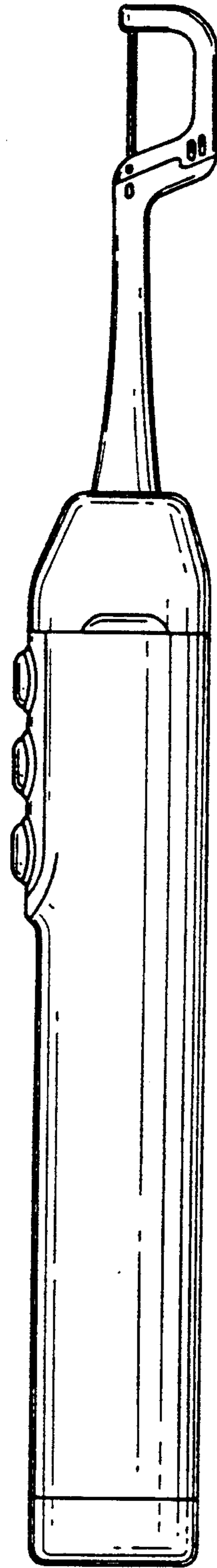

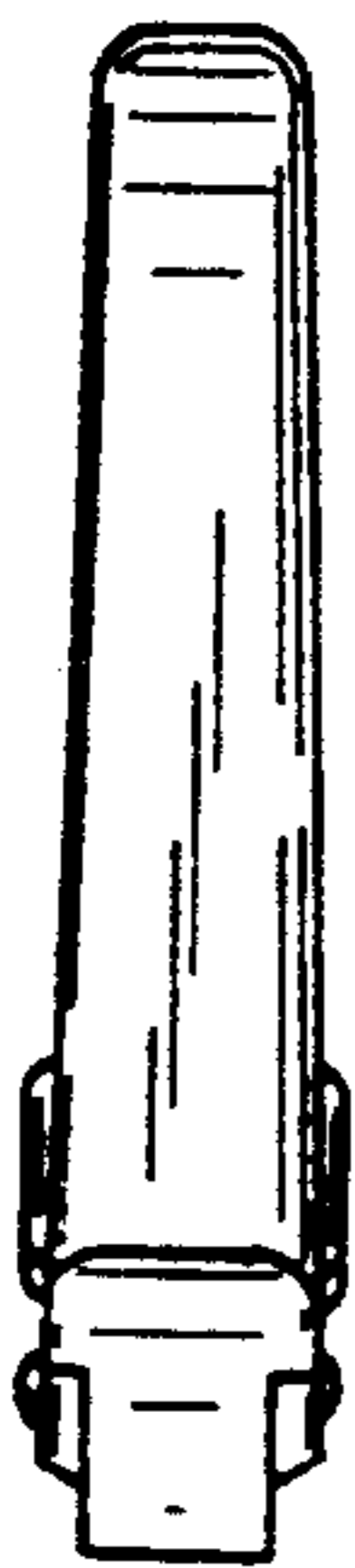

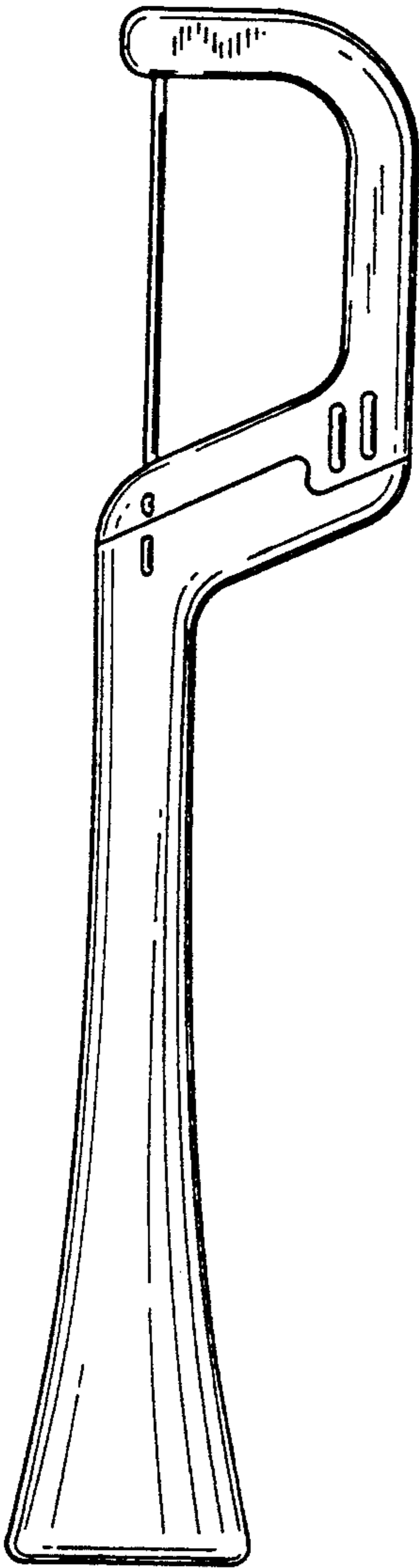

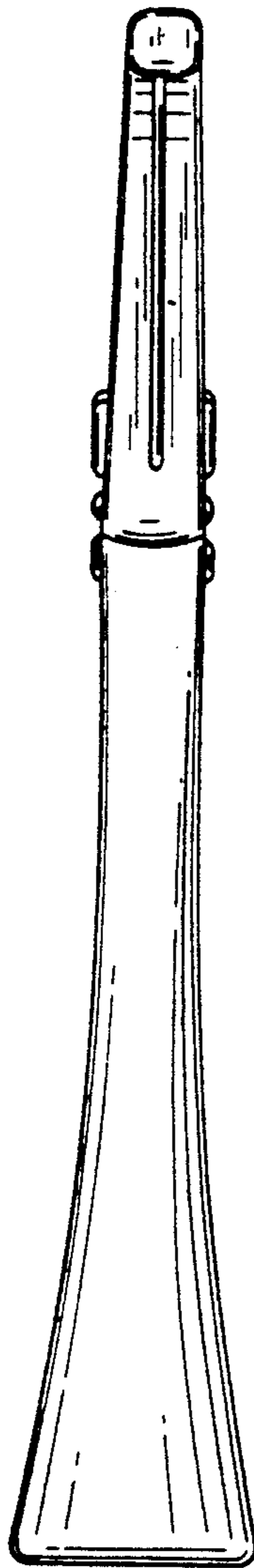

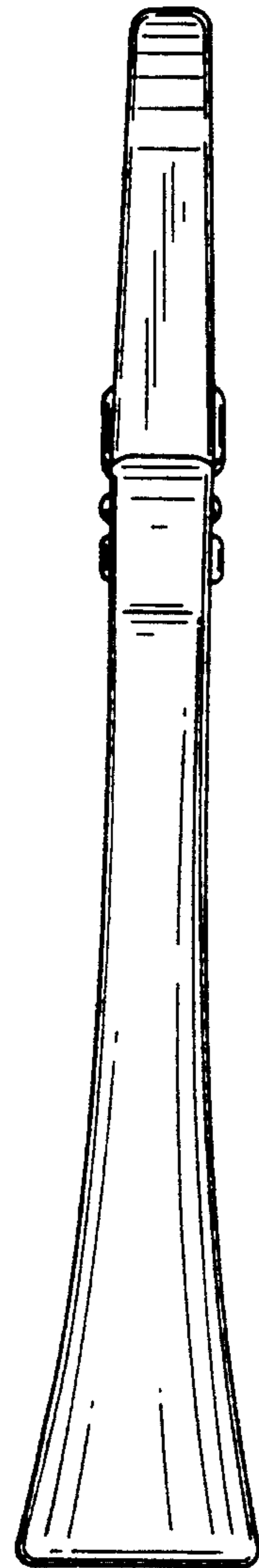

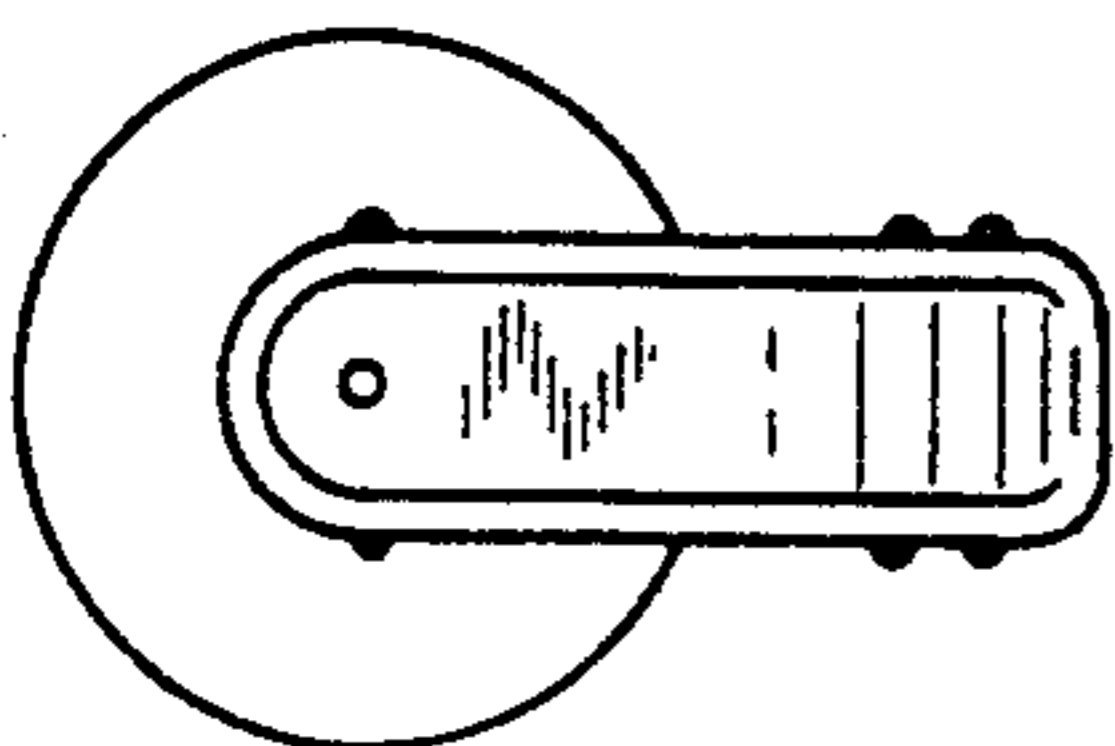
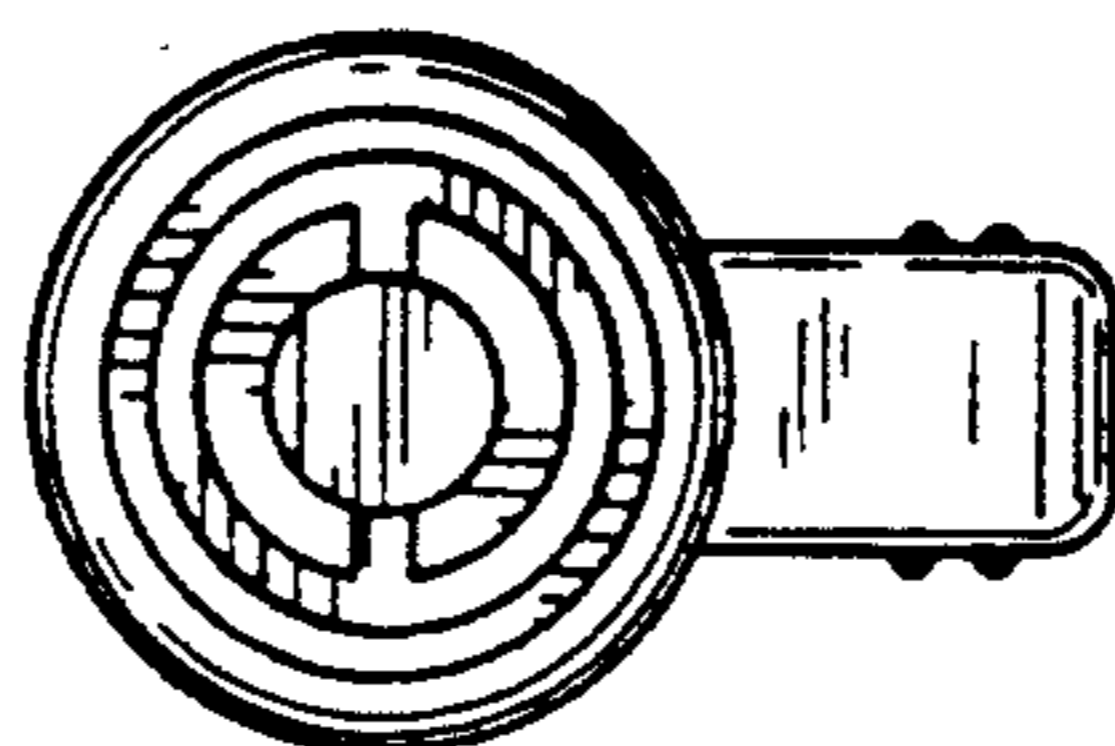

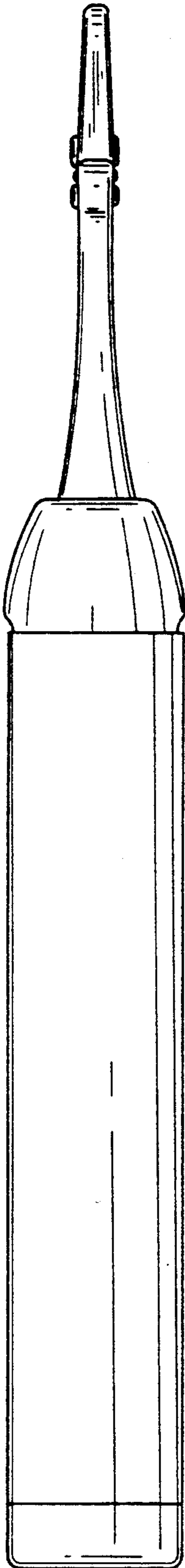

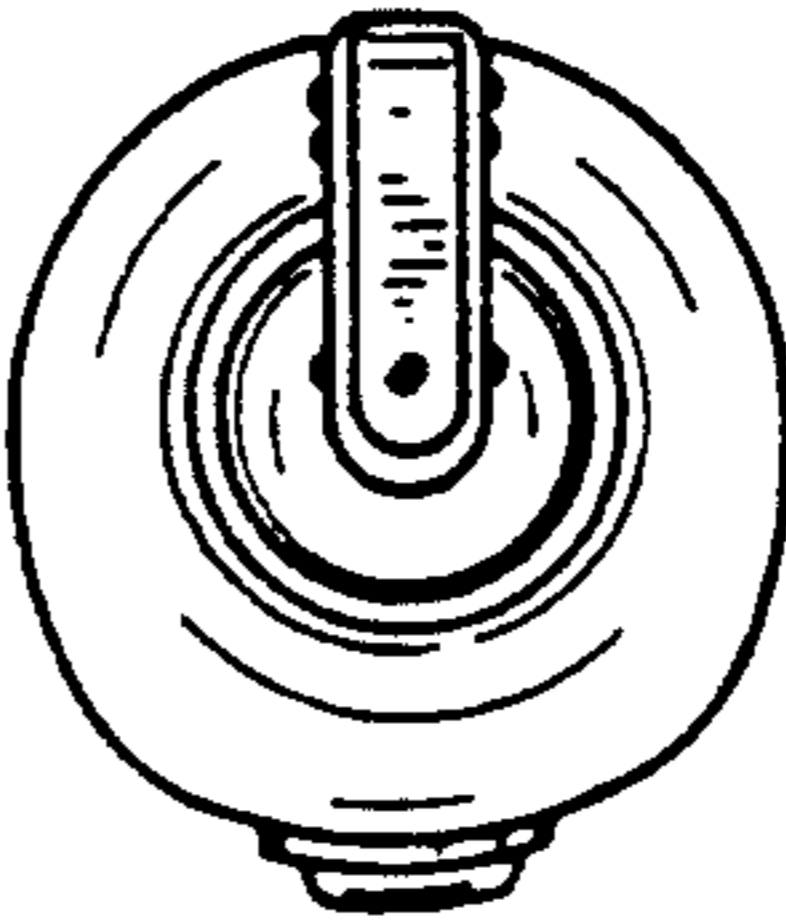

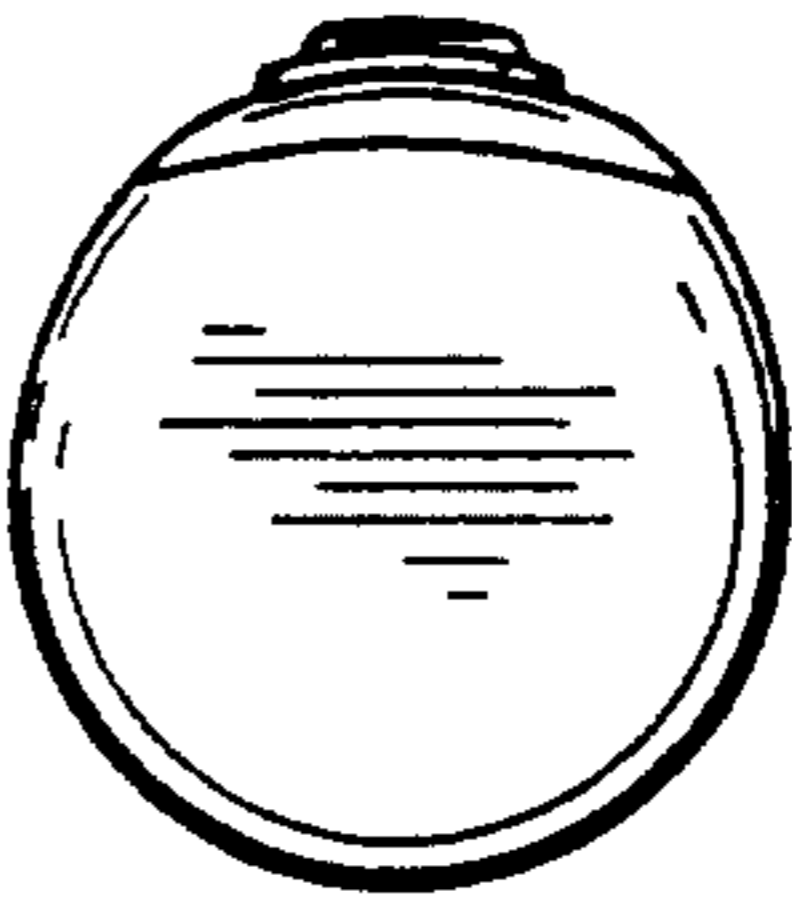
