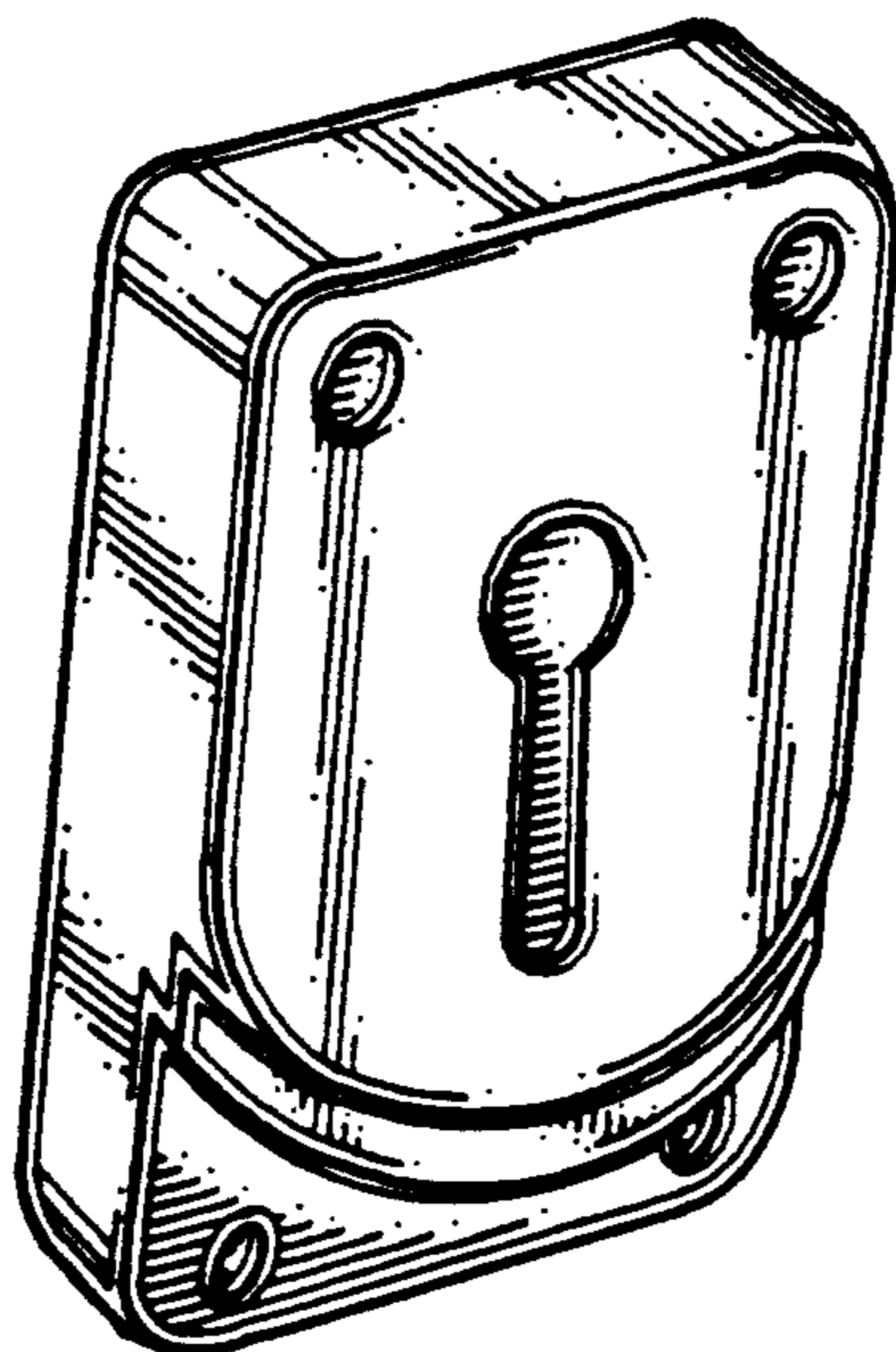

### [57] CLAIM

The ornamental design for a front latch portion of a latch assembly for a container, as shown and described.

### DESCRIPTION

FIG. 1 is a top left front perspective view of a front latch portion of a latch assembly for a container showing my new design;  
 FIG. 2 is a right side elevational view thereof; the opposite side being a mirror image;  
 FIG. 3 is a front elevational view thereof;  
 FIG. 4 is a rear elevational view thereof;  
 FIG. 5 is a top plan view thereof; and,  
 FIG. 6 is a bottom plan view thereof.



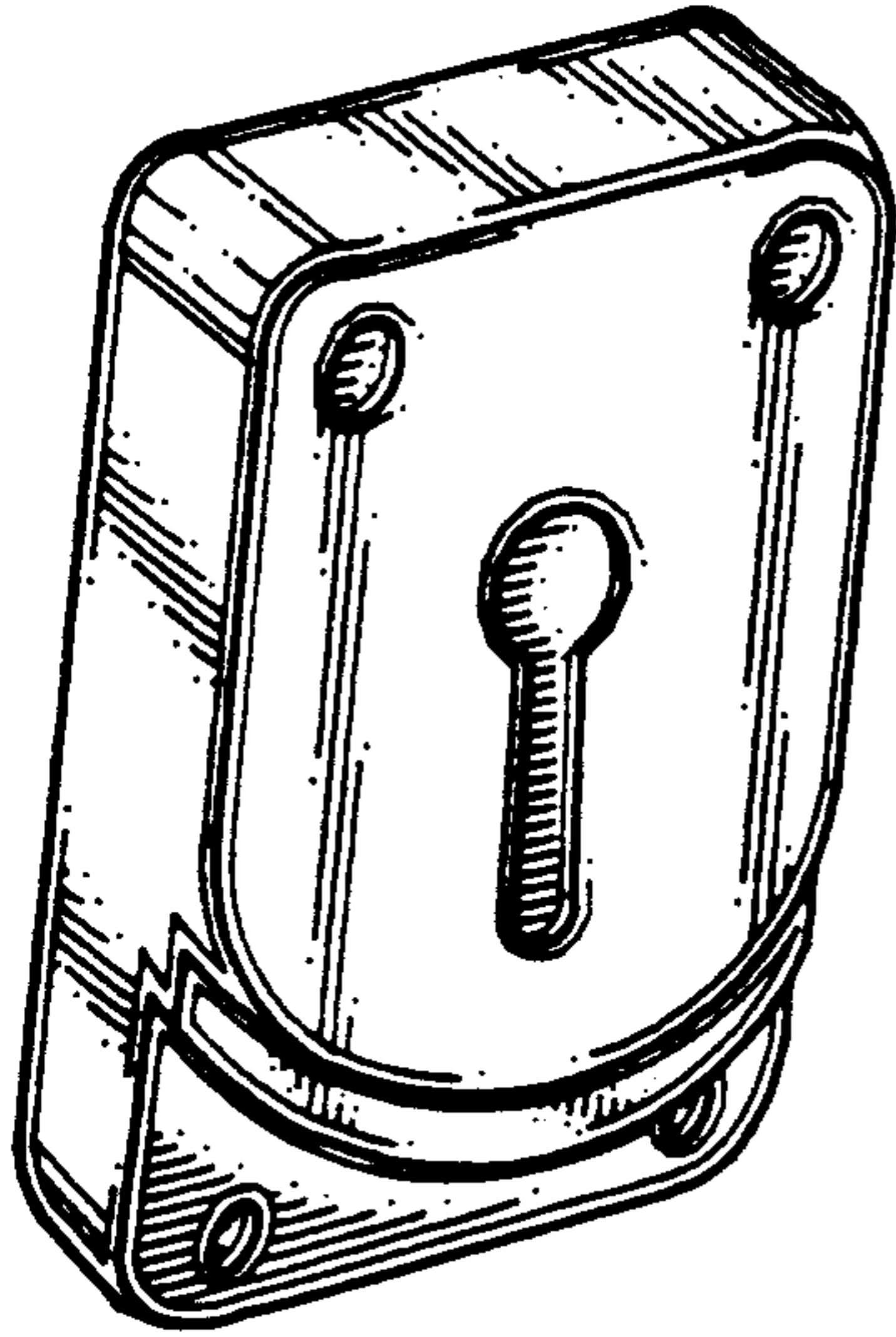

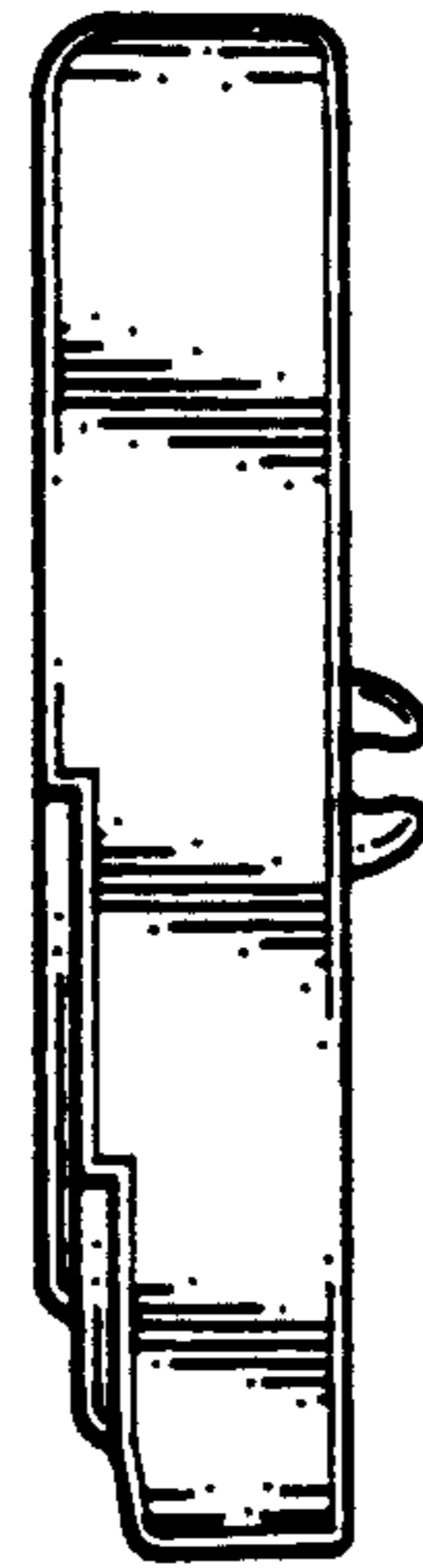

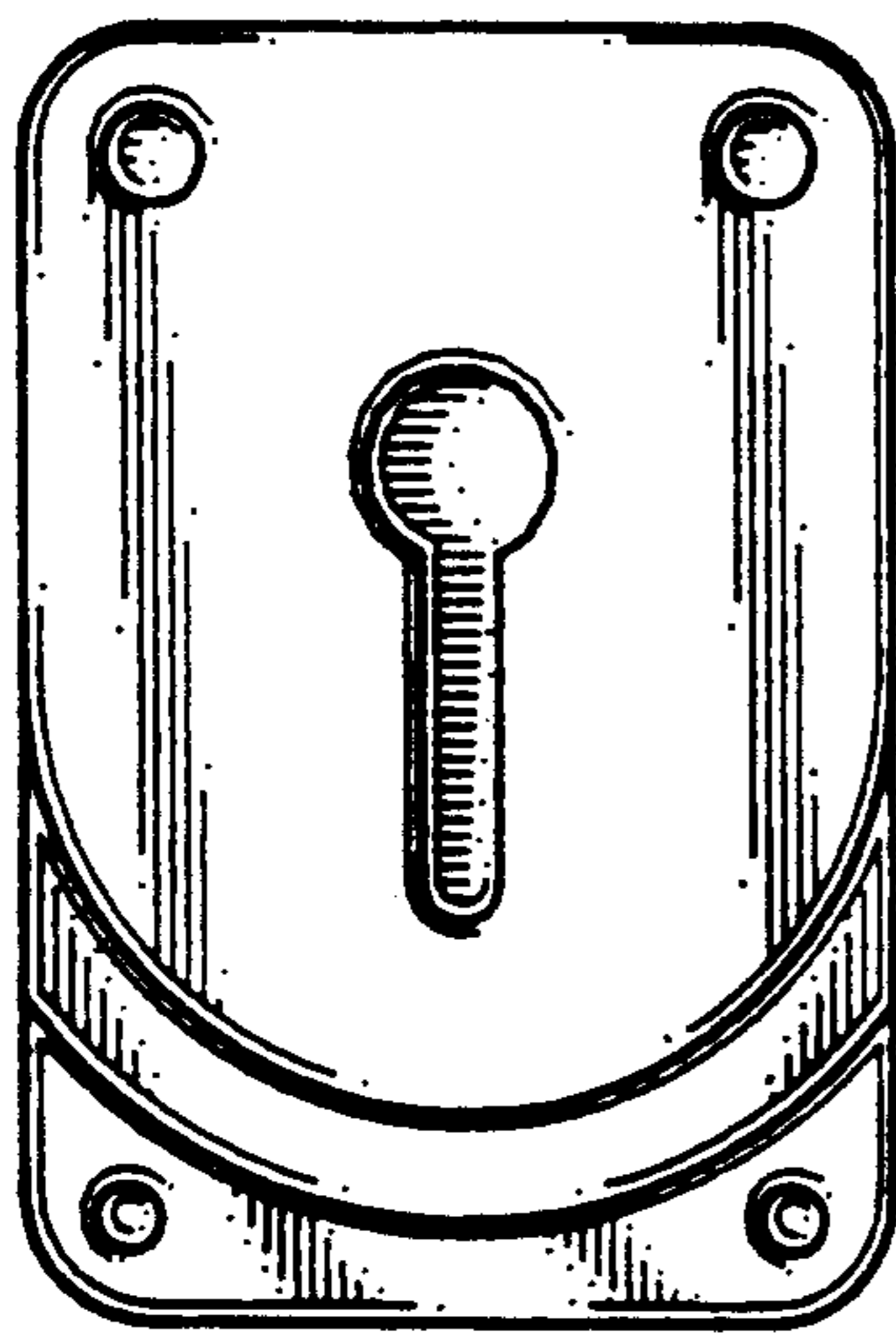

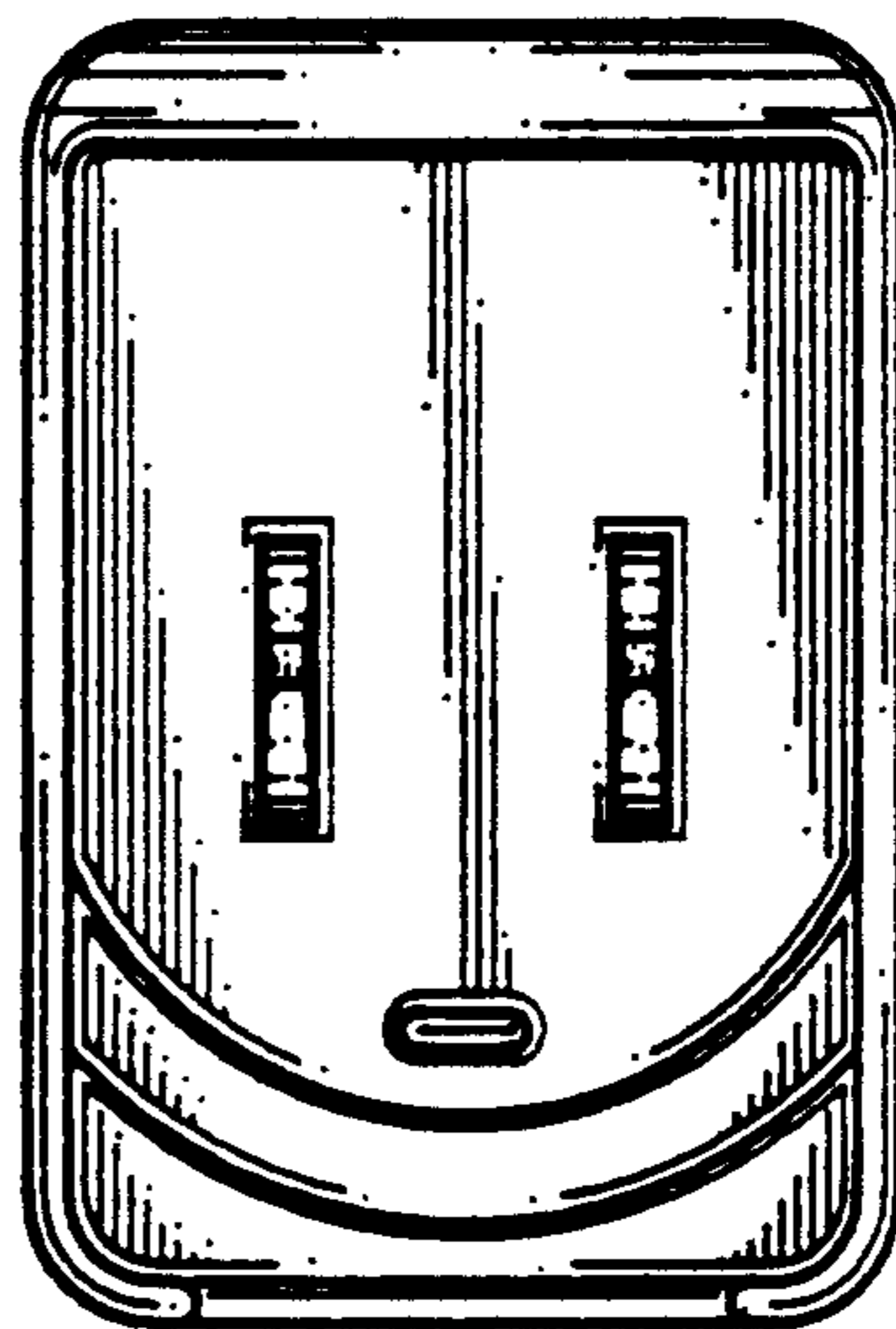

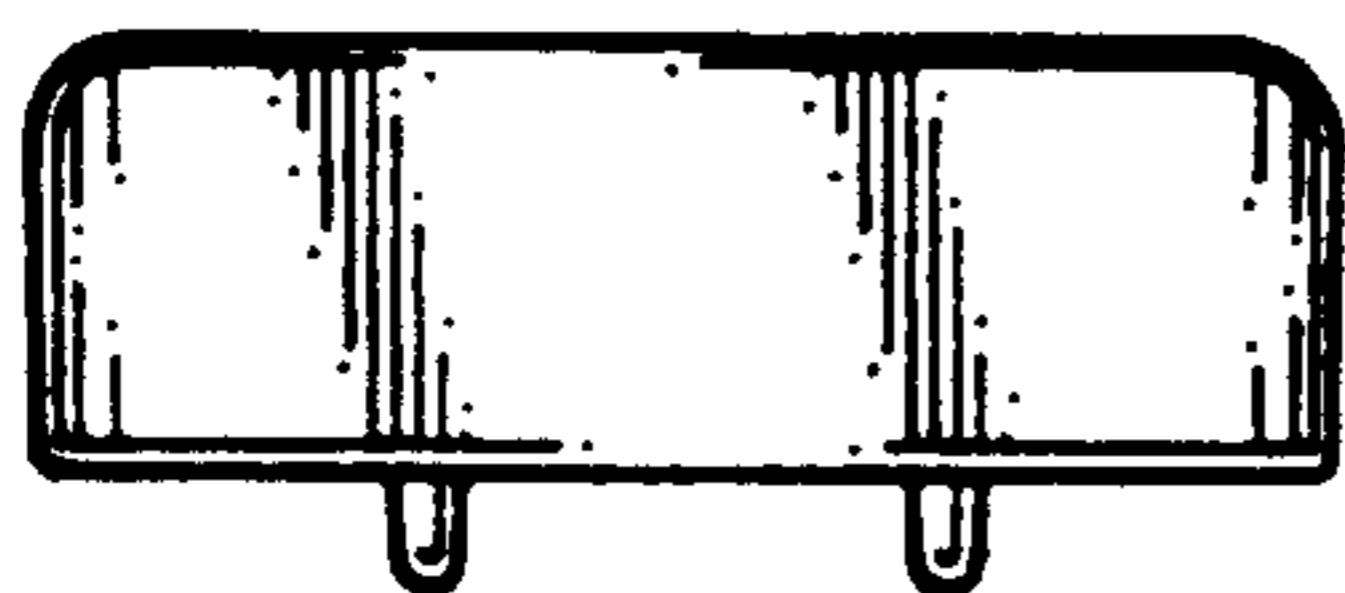
