The ornamental design for a truss hanger, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the truss hanger showing my new design;
 FIG. 2 is a rear elevational view thereof;
 FIG. 3 is a left side elevational view thereof;
 FIG. 4 is a right side elevational view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof; and,
 FIG. 7 is an isometric view of the invention in use.
 The broken line showing of a portion of a truss is for illustrative purposes only and forms no part of the claimed design.

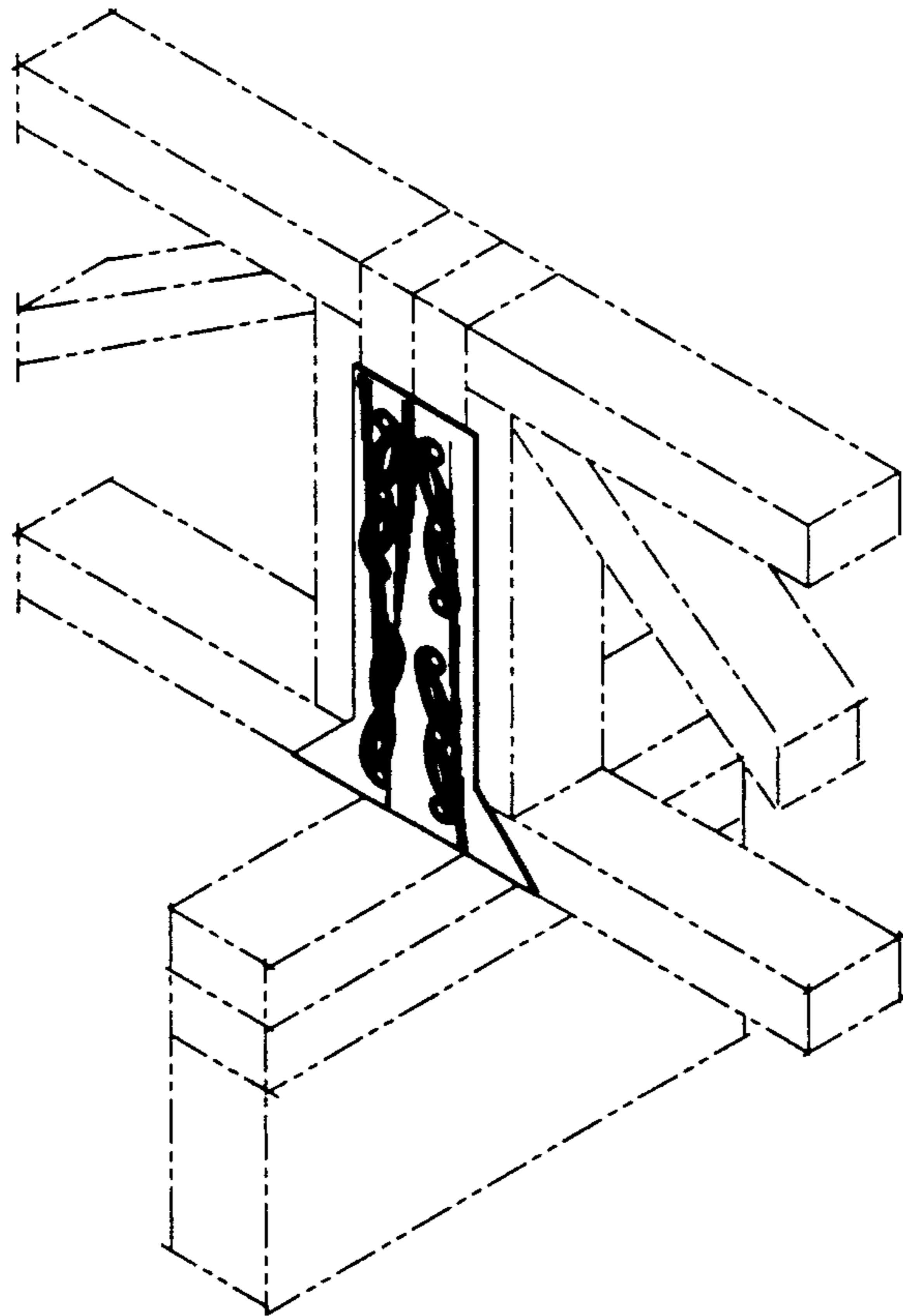

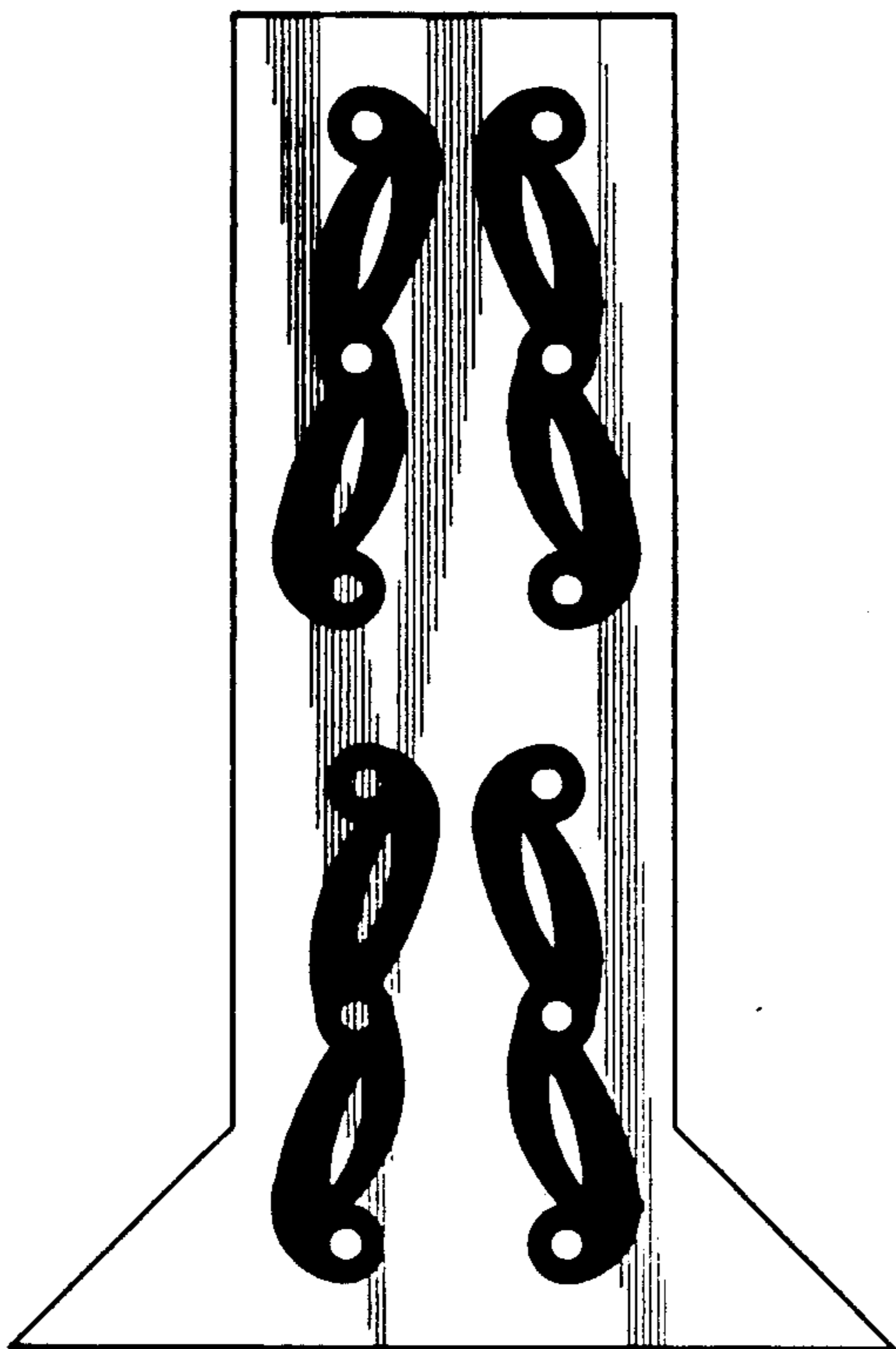

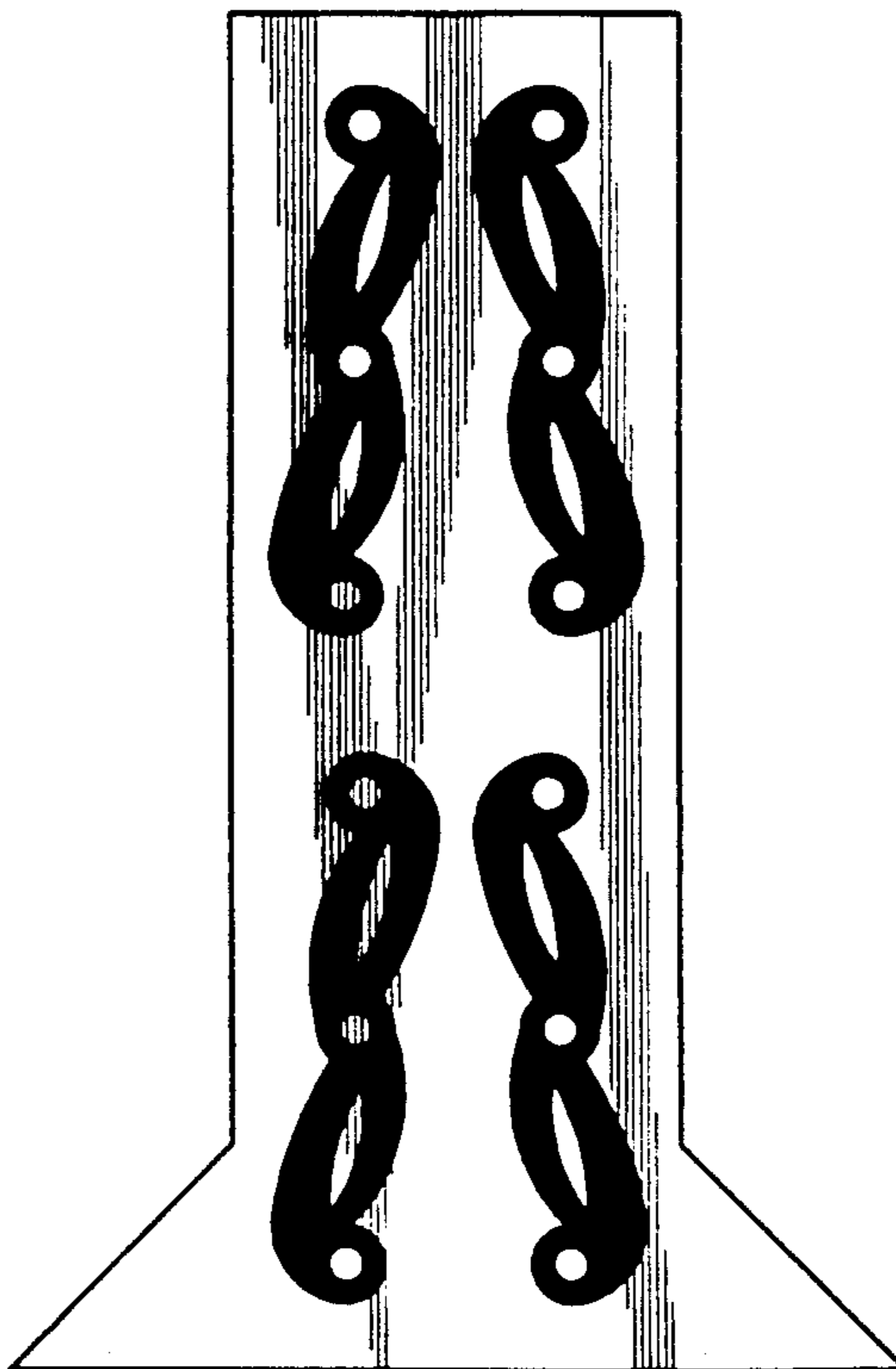

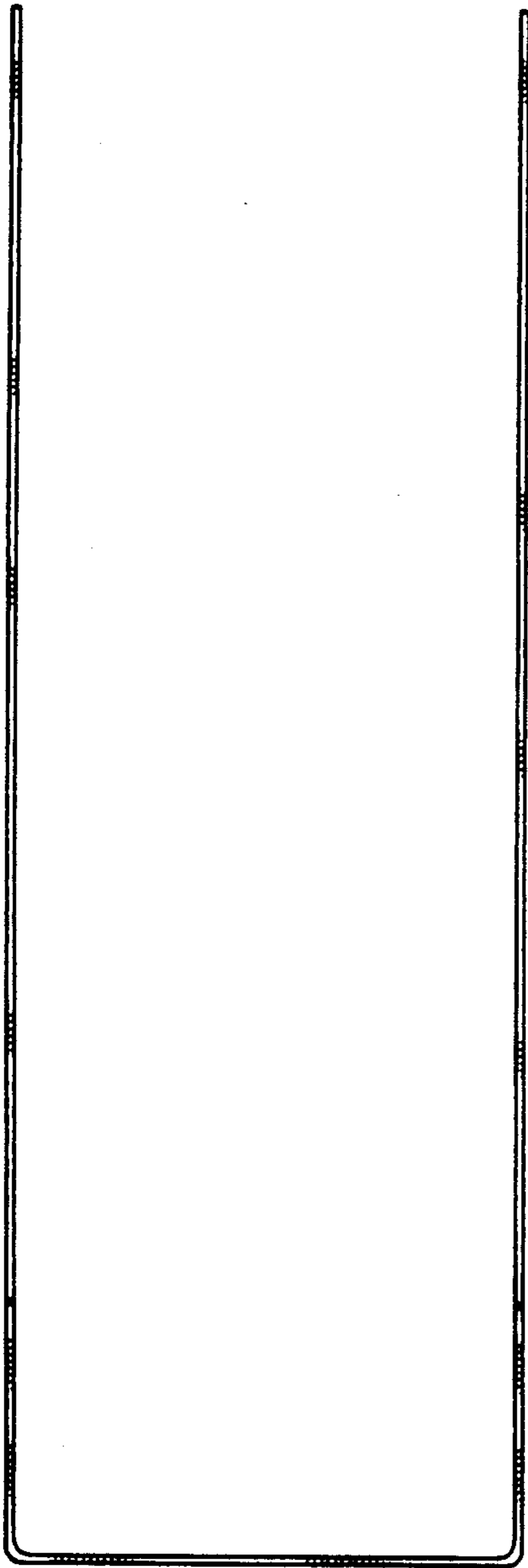

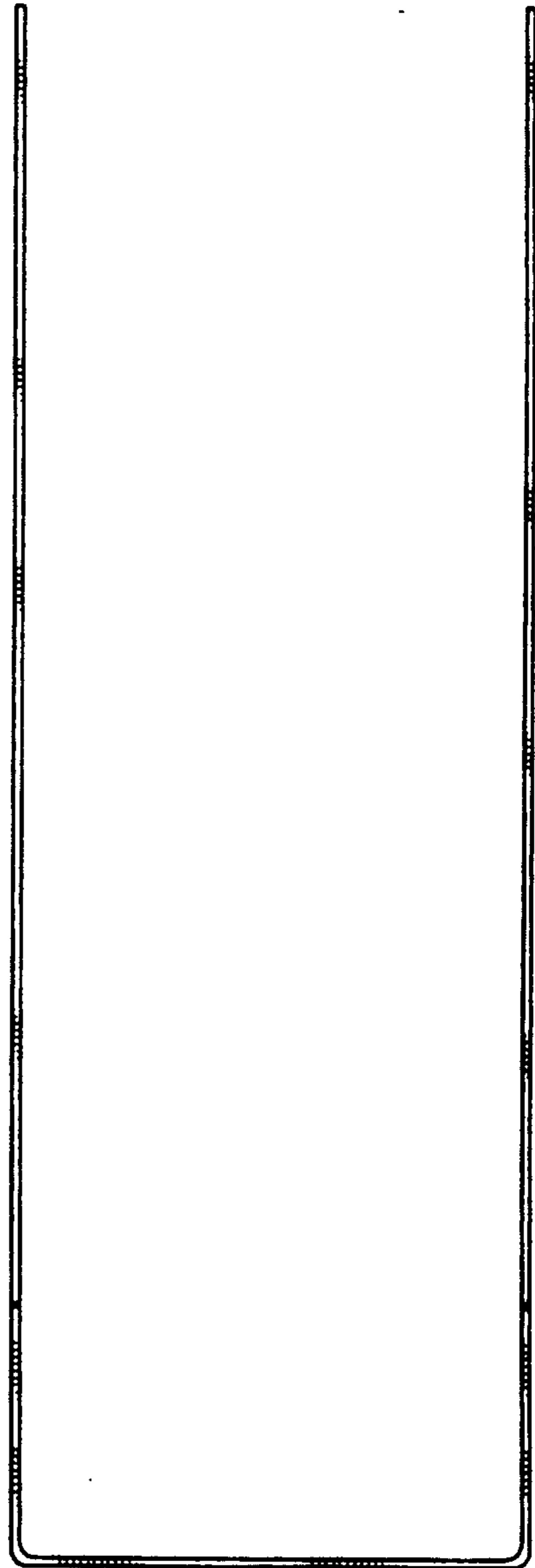

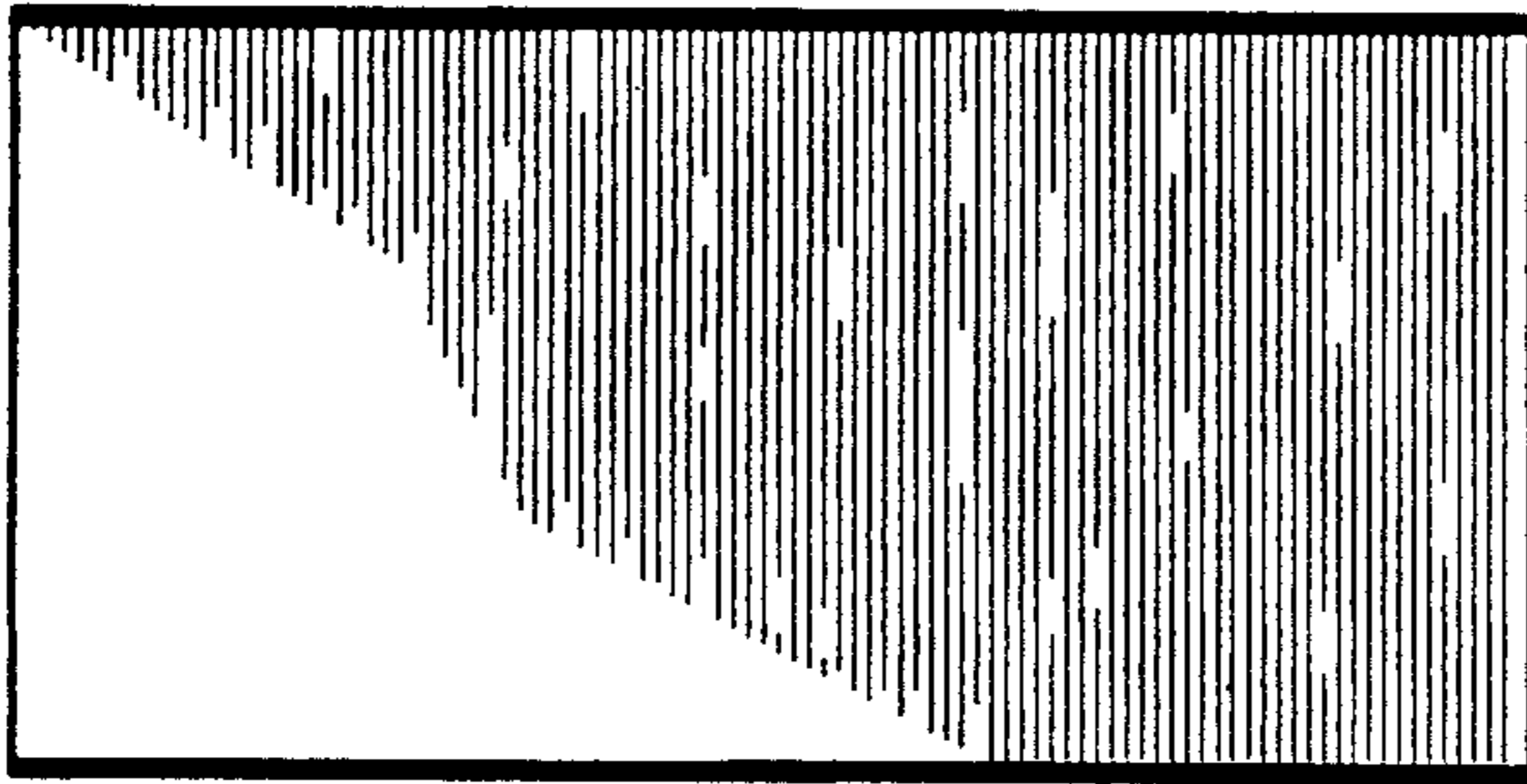

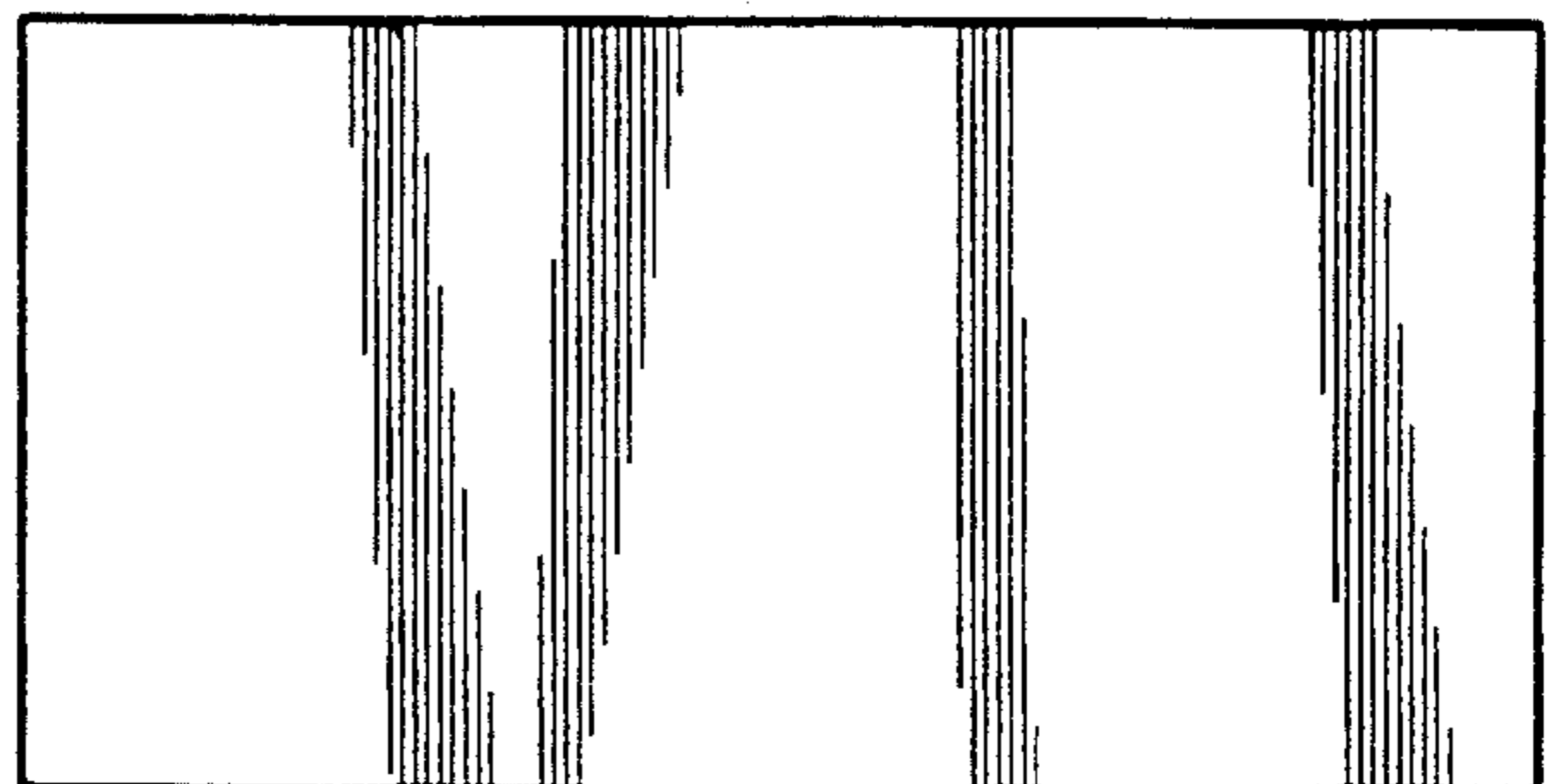
