The ornamental design for a printer for electronic computer, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a printer for electronic computer showing our new design;

 FIG. 7 is a perspective view thereof.

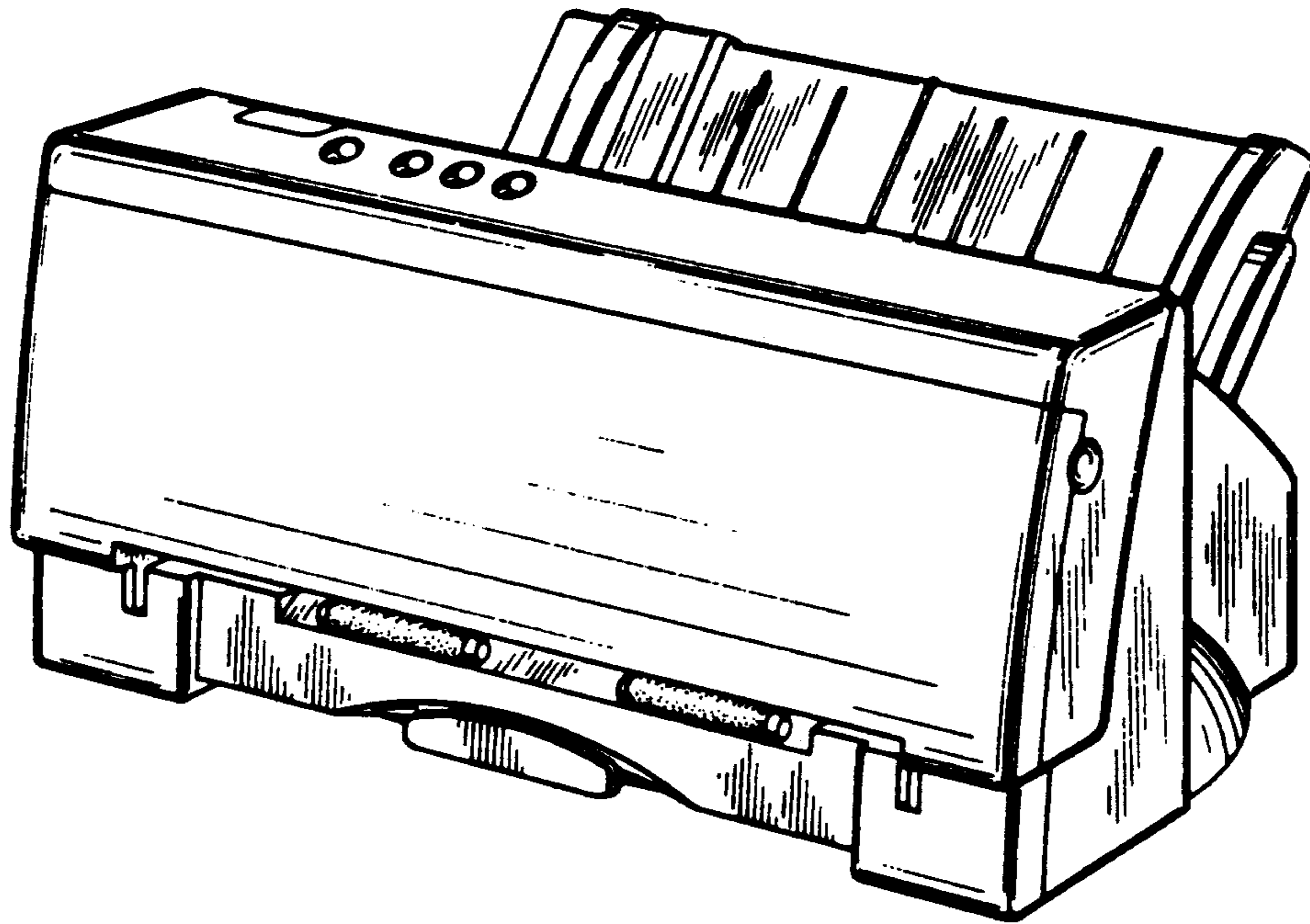

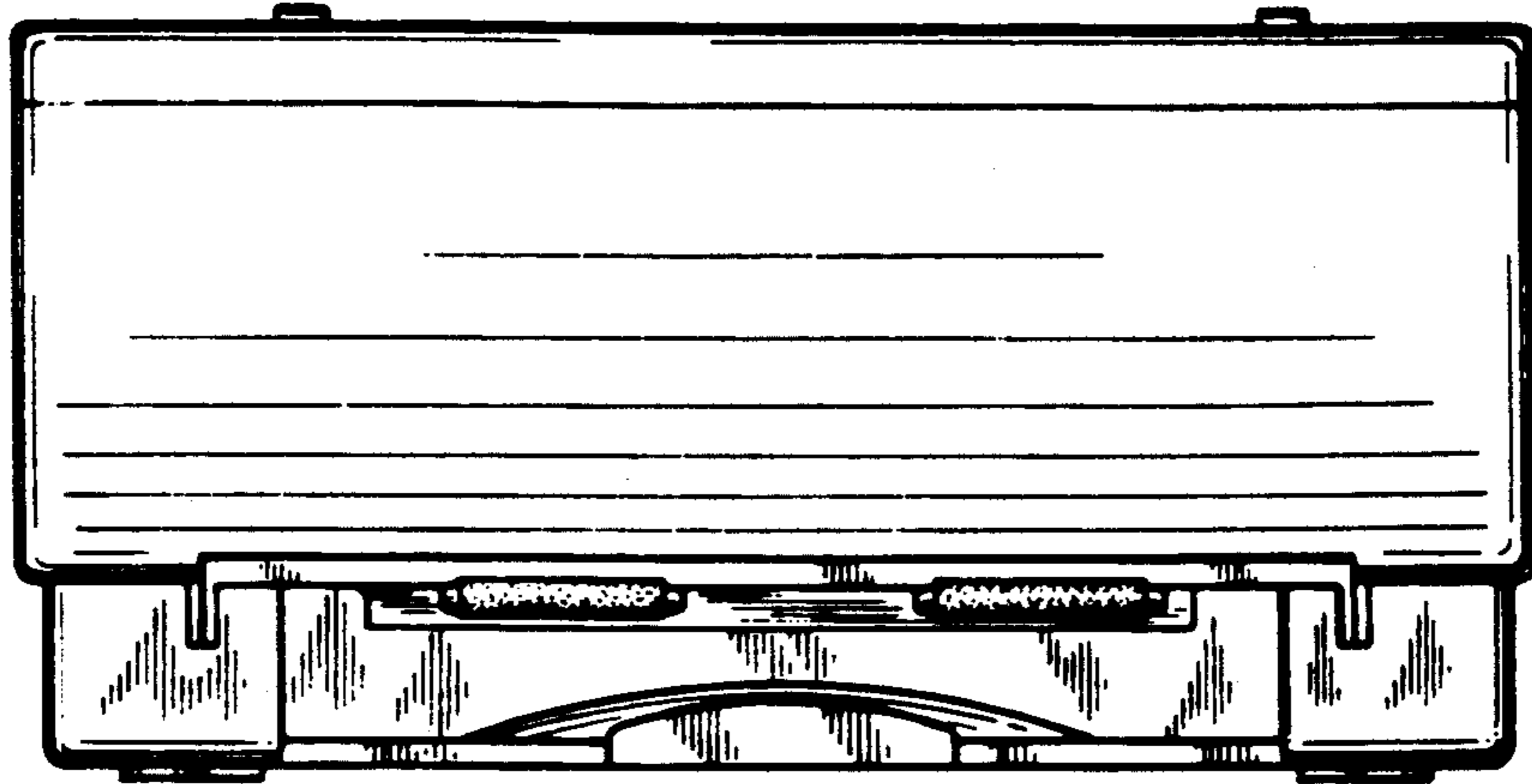

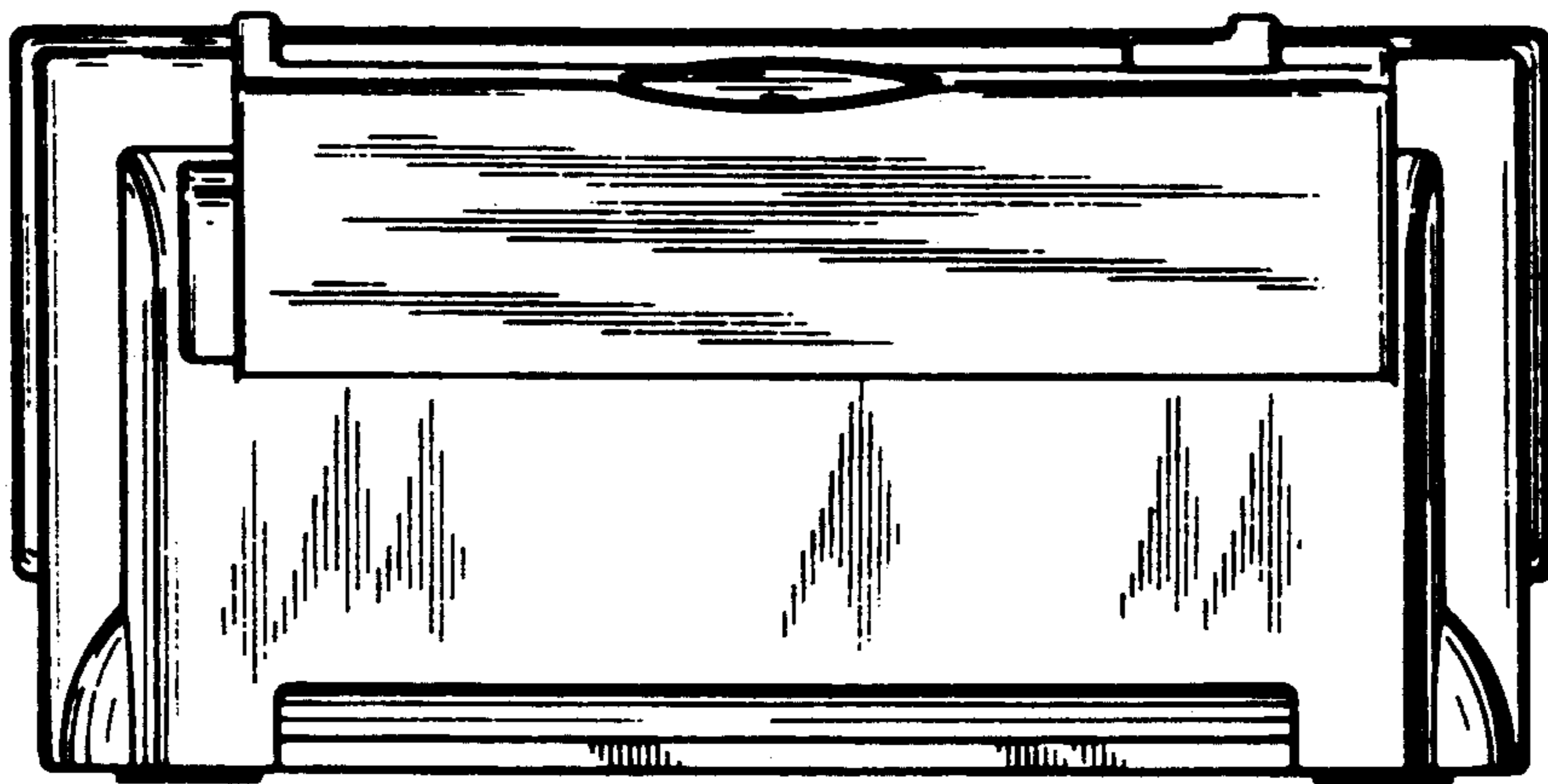

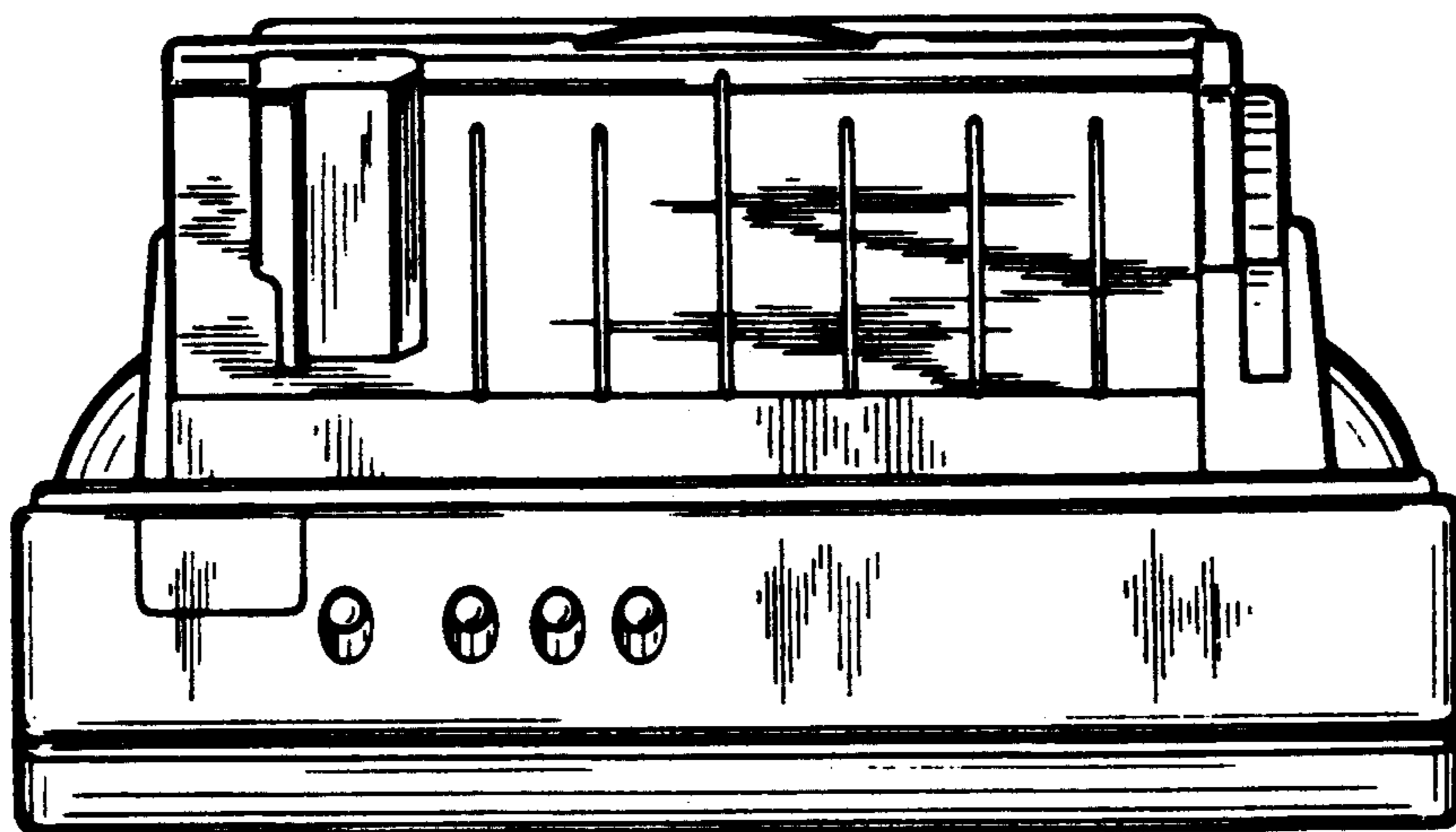

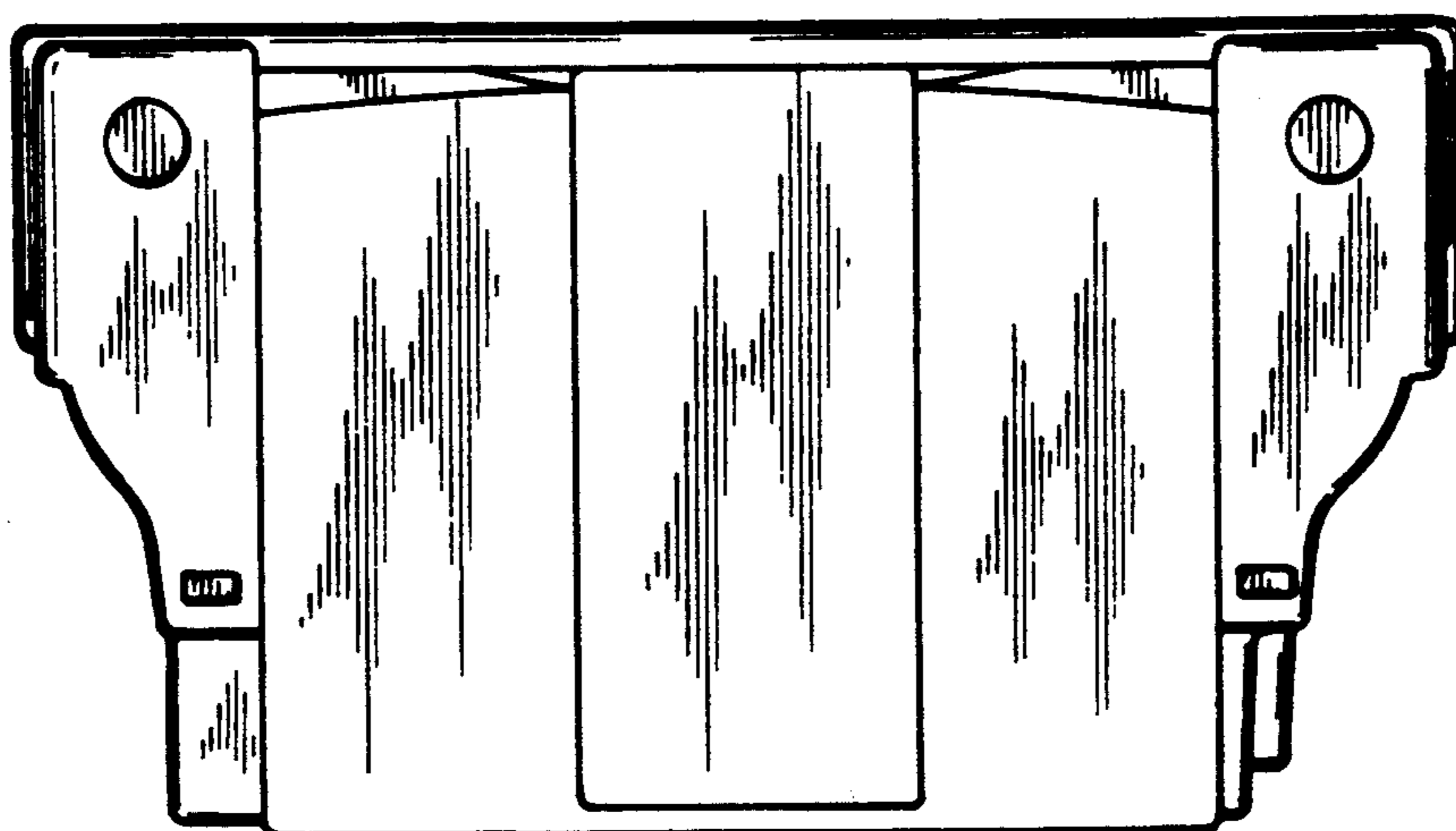

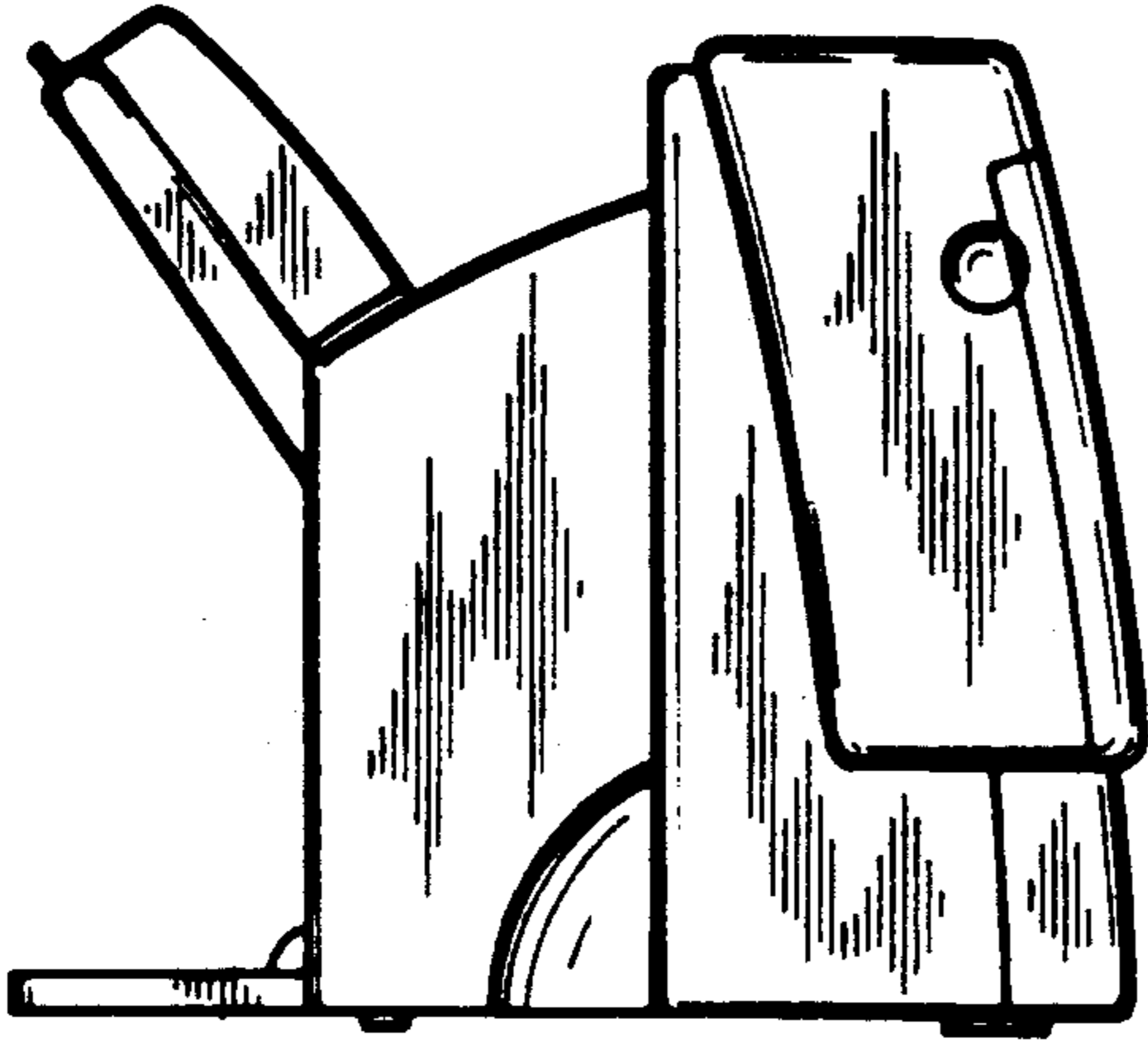

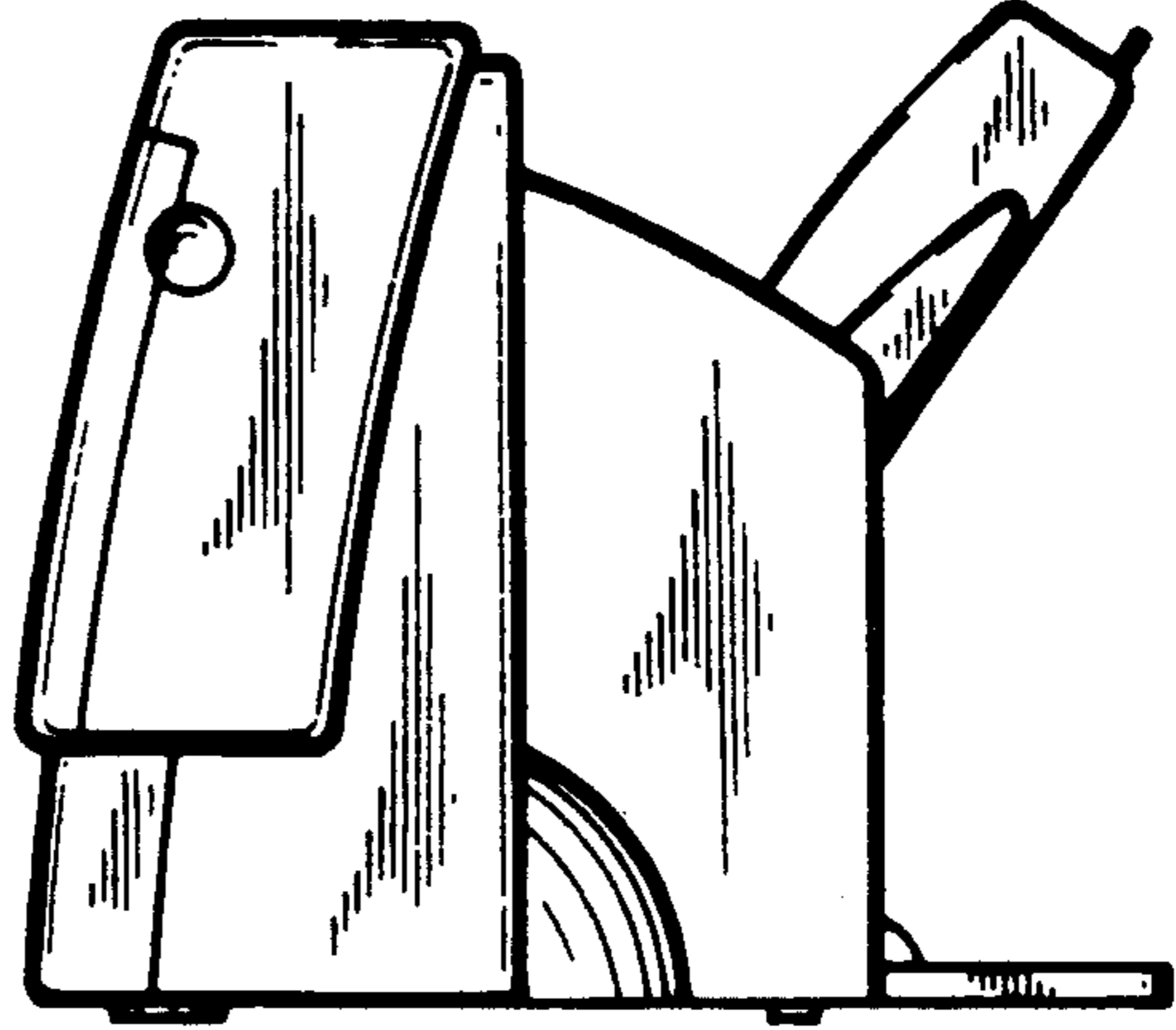
