[57] **CLAIM**

The ornamental design for a combined hand exerciser and cigarette lighter, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combined hand exerciser and cigarette lighter showing my new design from the rear, right side and top;
FIG. 2 is a front elevational view thereof;
Fig. 3 is a rear elevational view thereof;
FIG. 4 is a right side elevational view thereof, the left side being a mirror image thereof;
Fig. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.

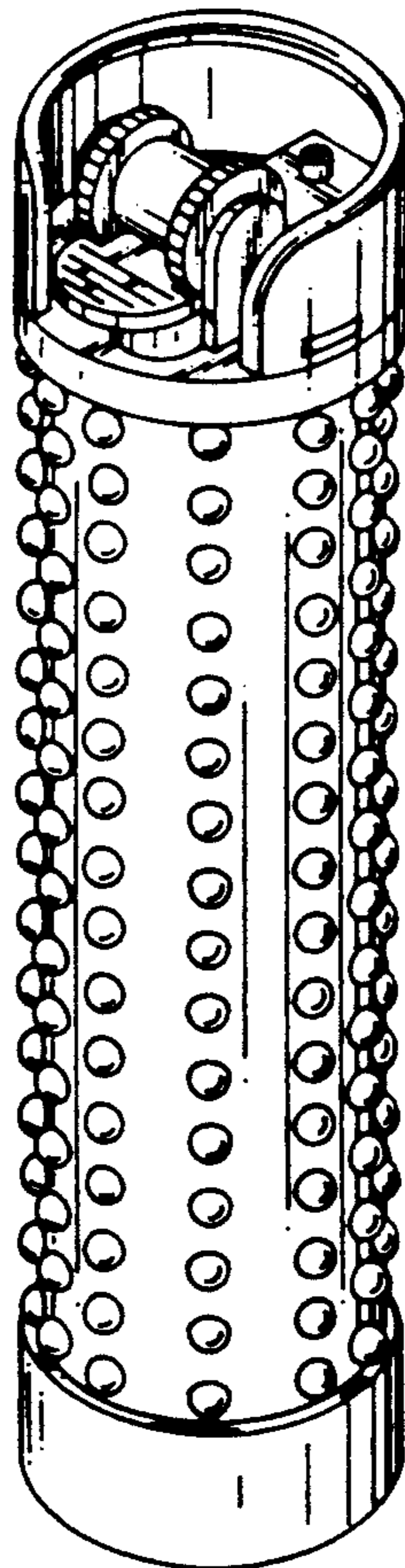

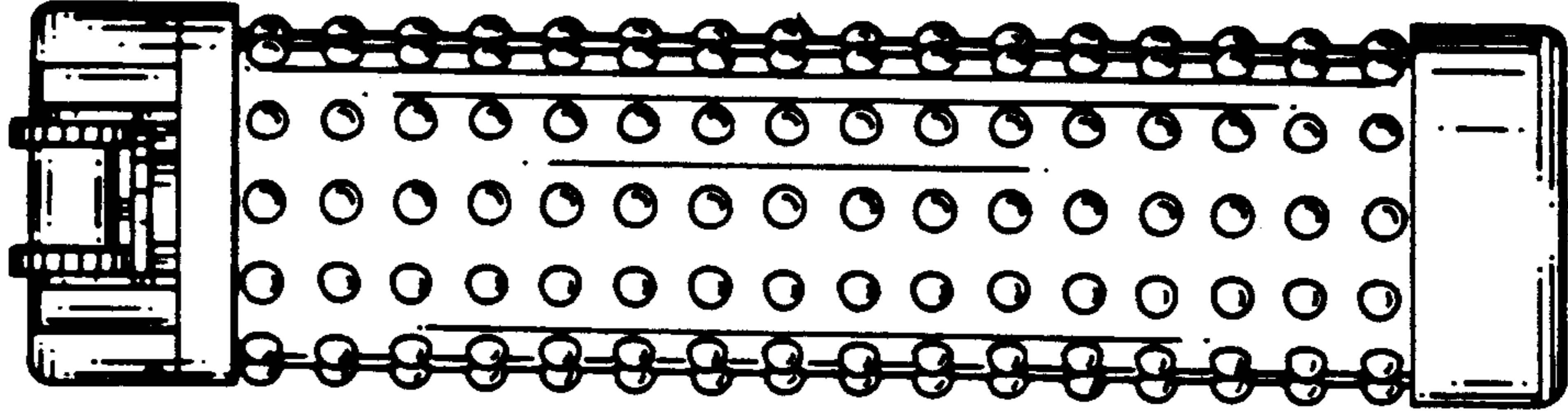

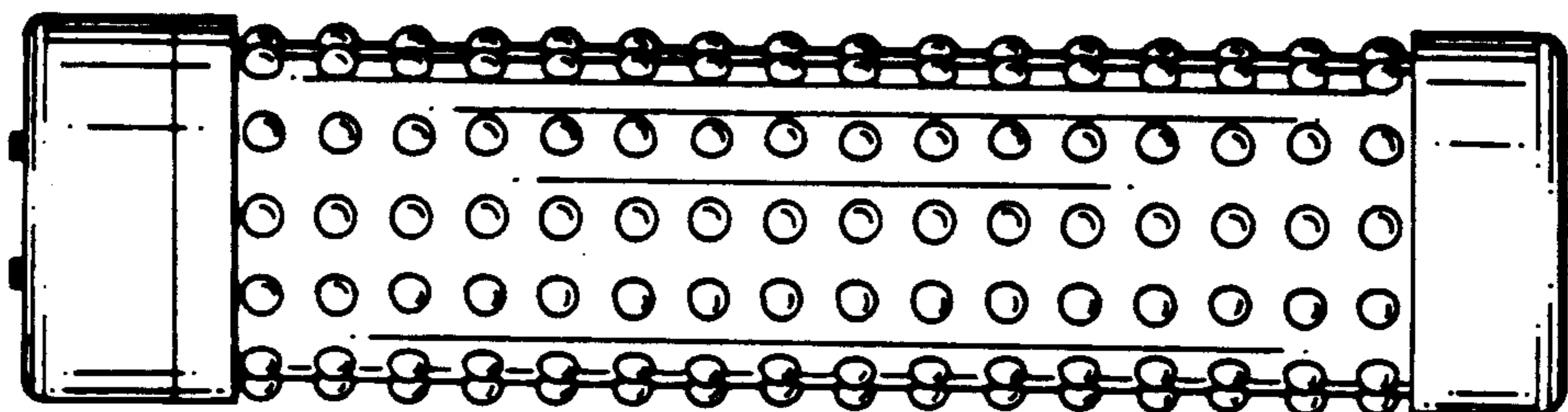

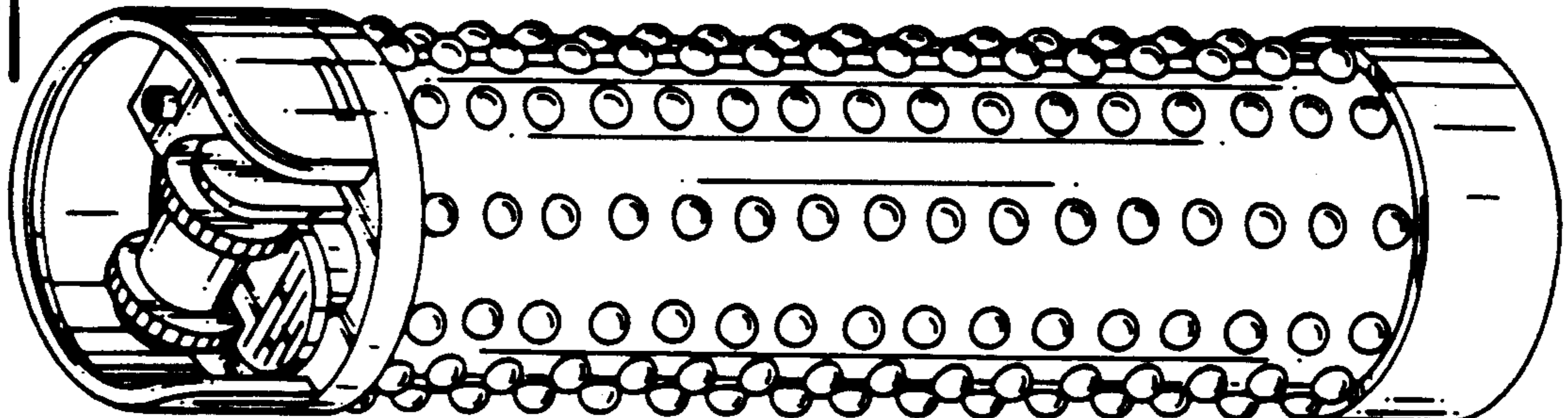

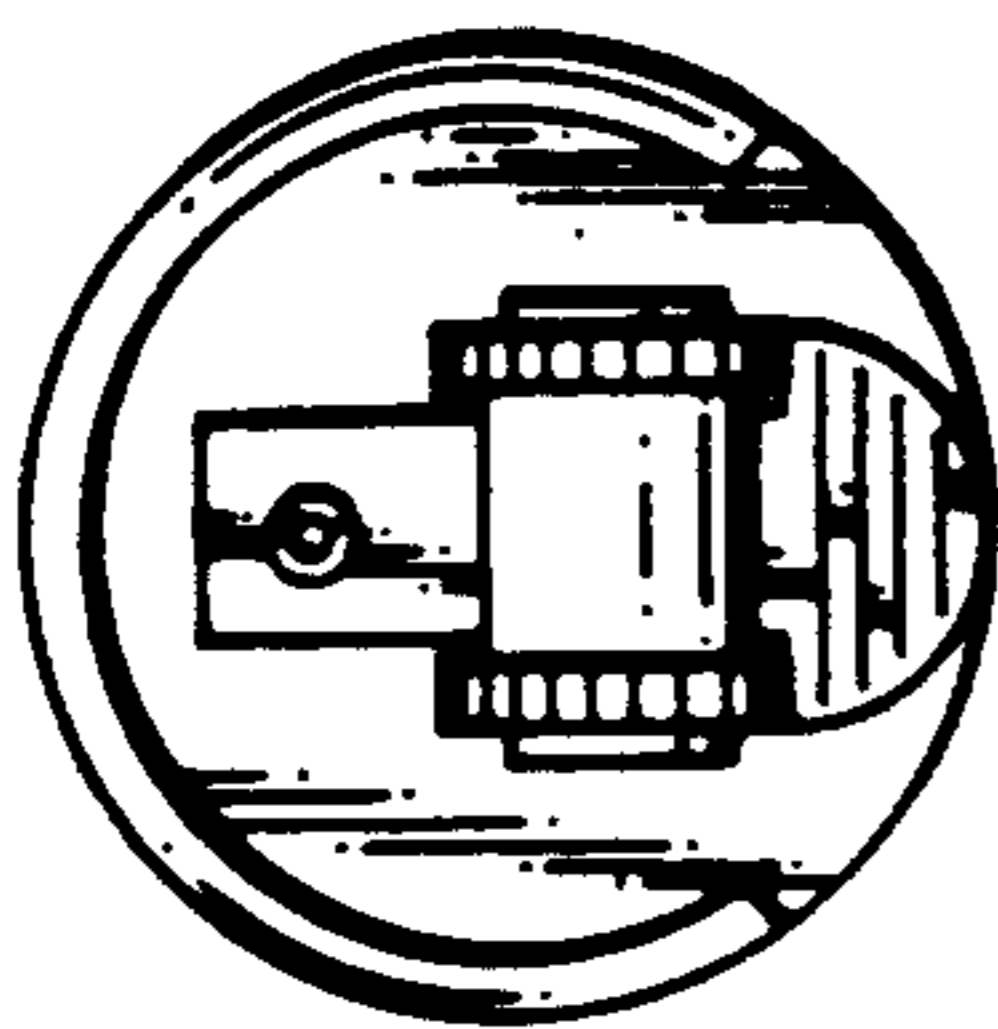

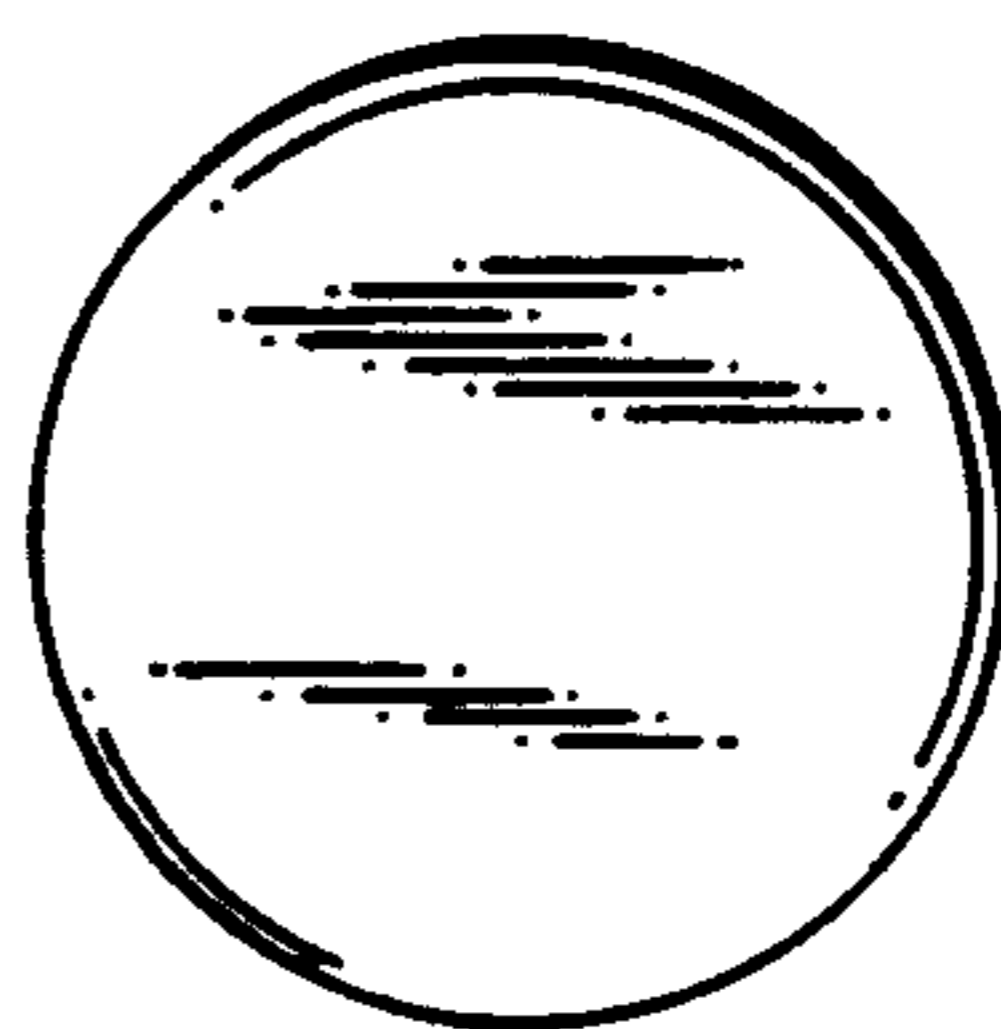
