### [57] CLAIM

The ornamental design for a cartridge for video game machine, as shown and described.

### DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a cartridge for a video game machine showing our new design;

FIG. 2 is a rear, bottom and left perspective view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a right side elevational view thereof, a left side being a mirror image;

FIG. 8 is a front, top and right side perspective view of a second embodiment of the cartridge for a video game machine illustrated in FIG. 1; and,

FIG. 9 is a rear, bottom and left side perspective view thereof.

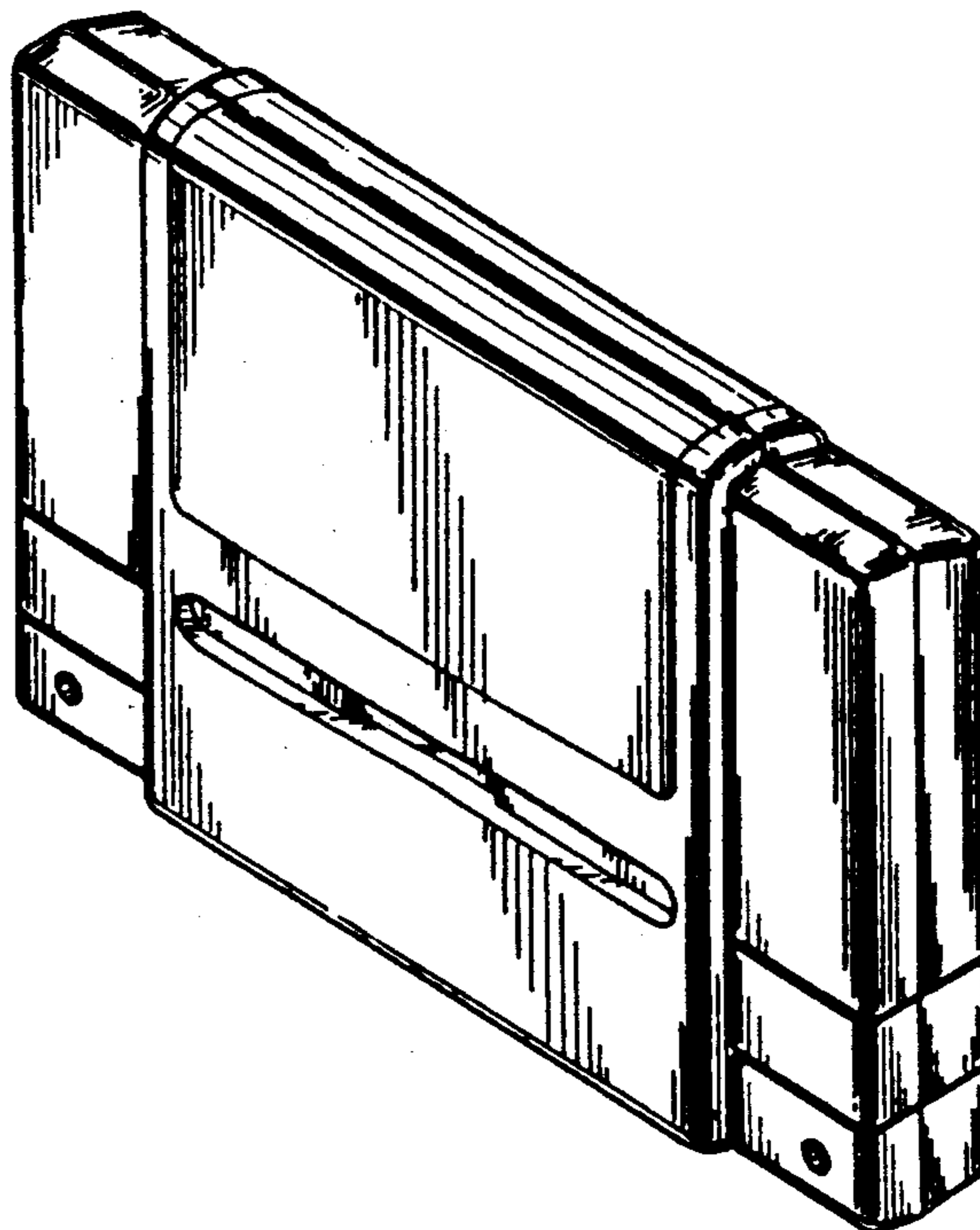
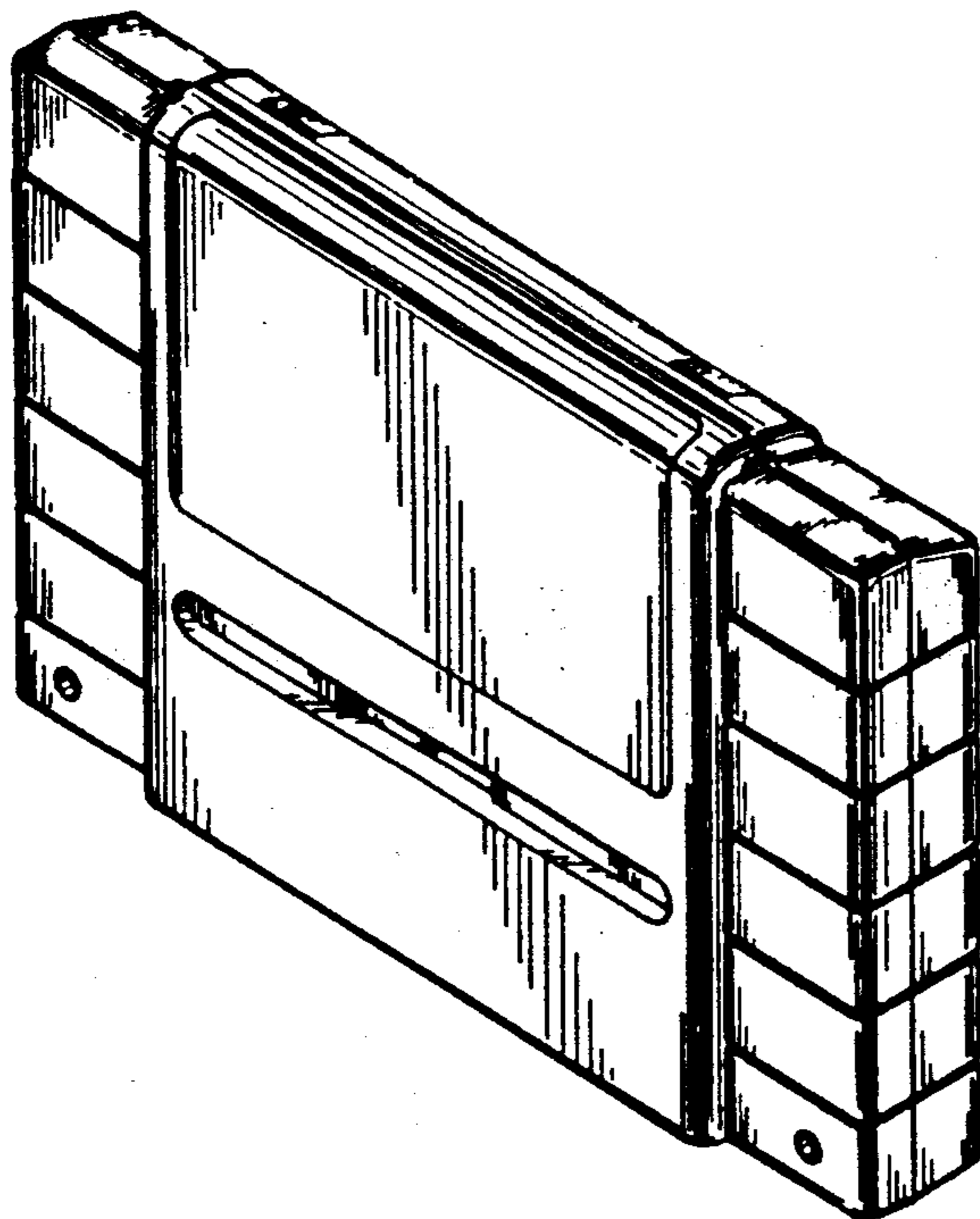

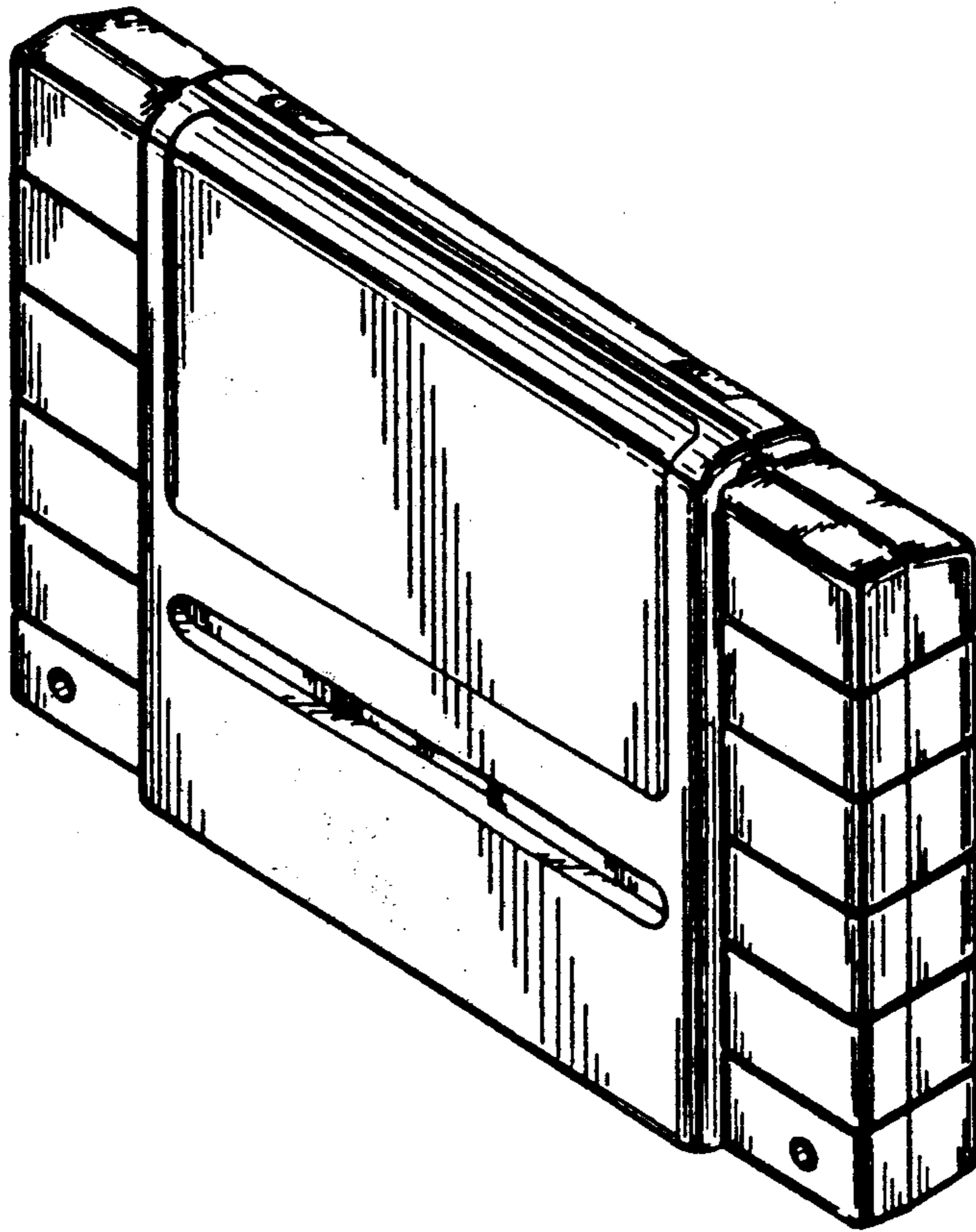

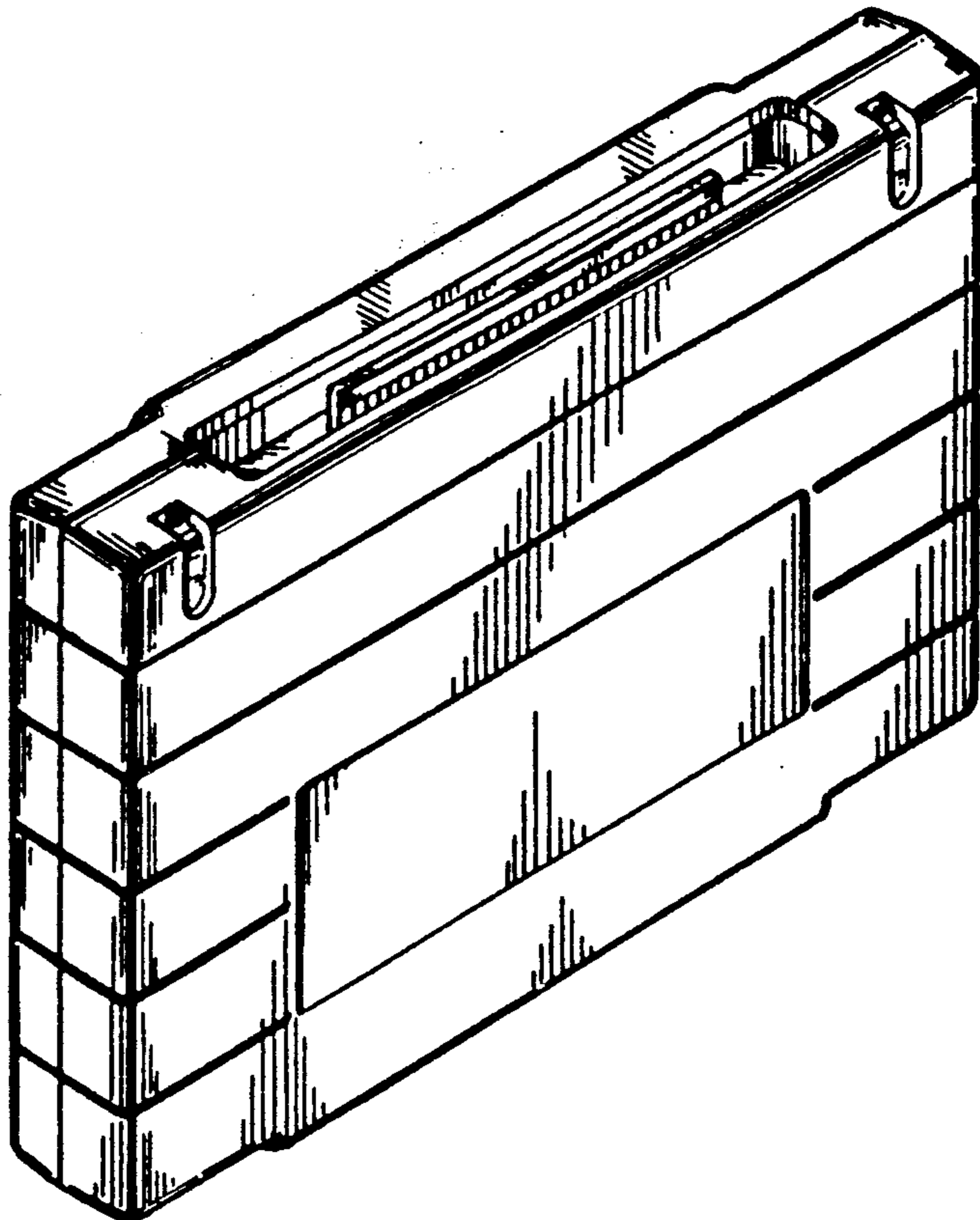

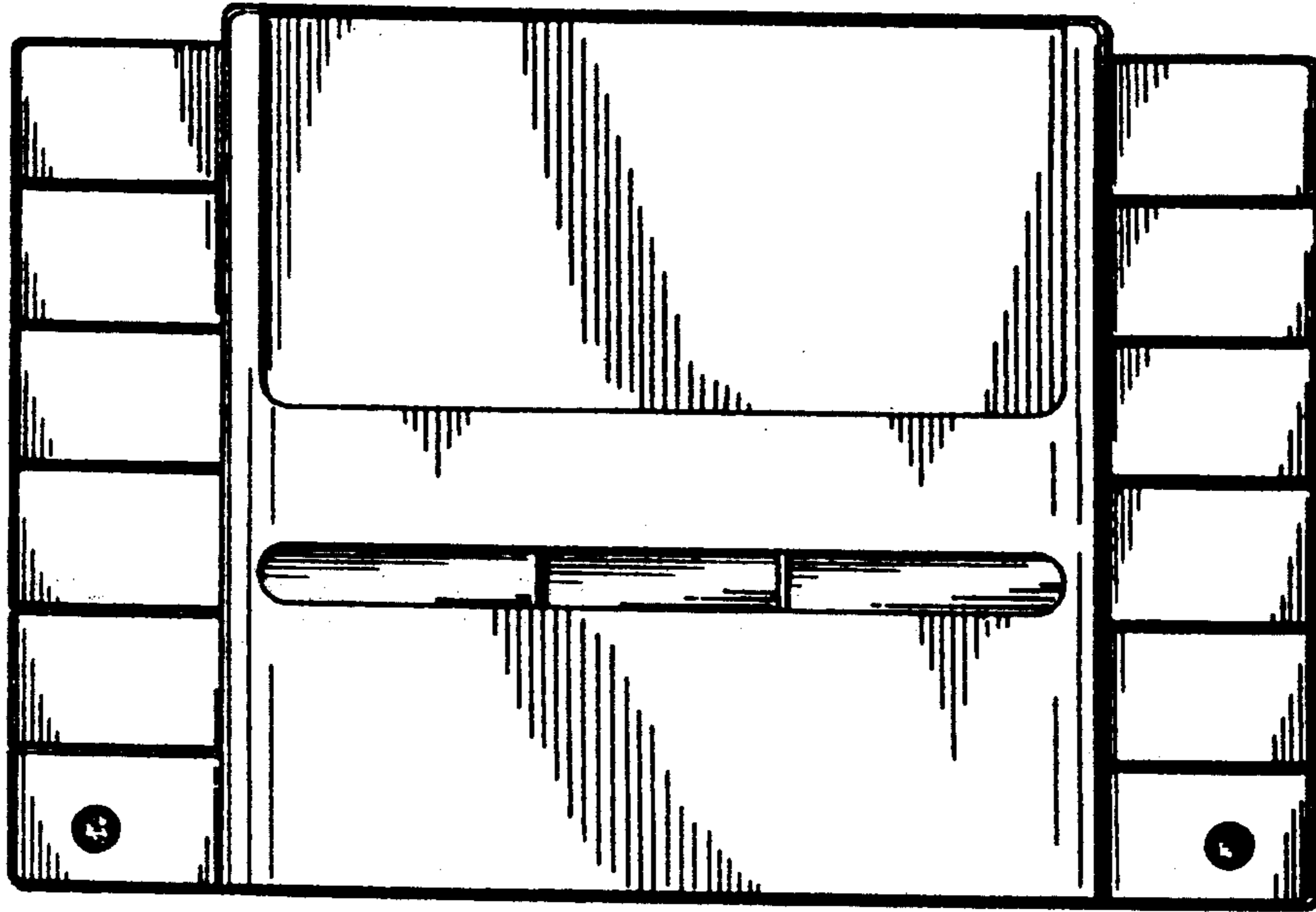

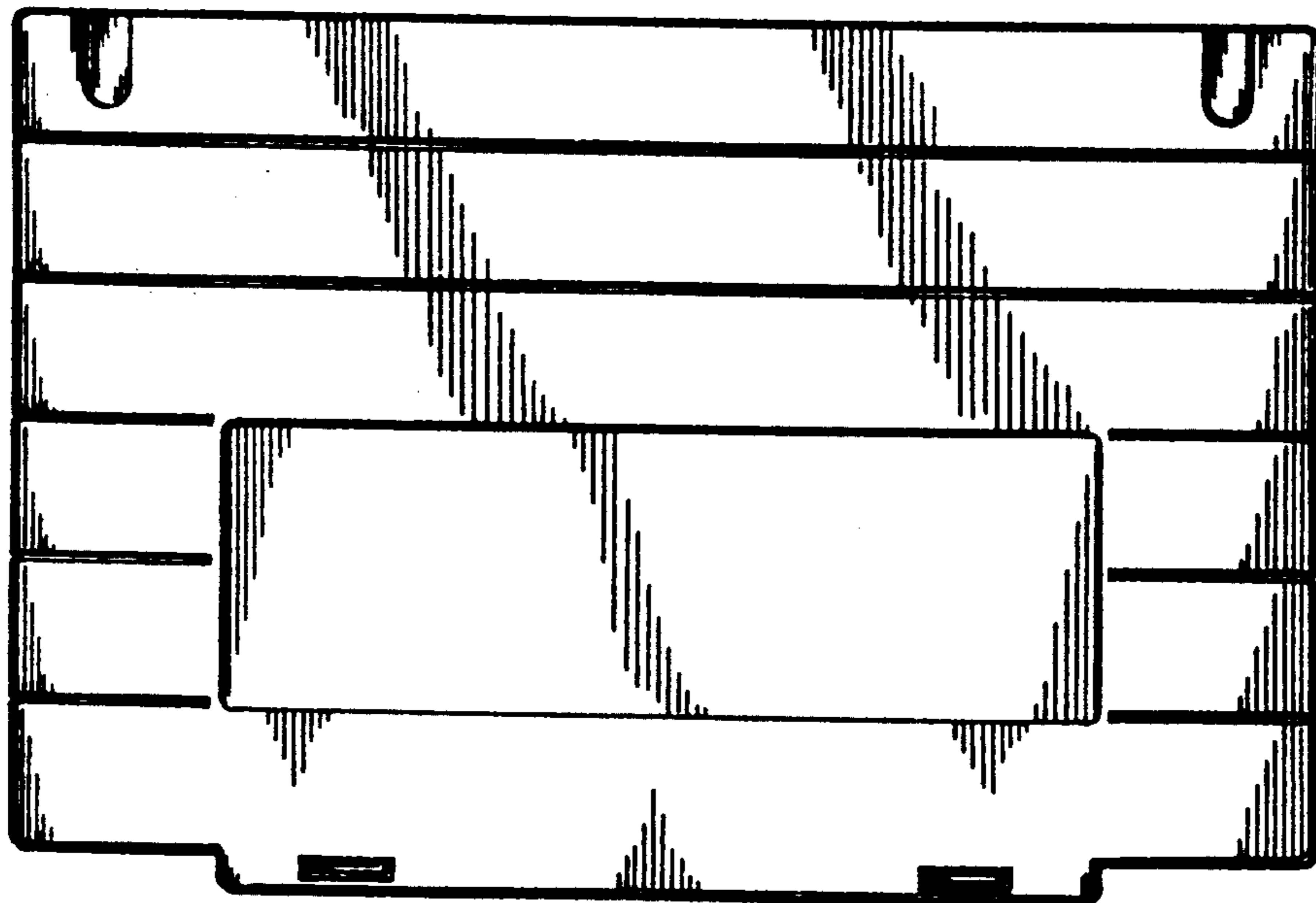

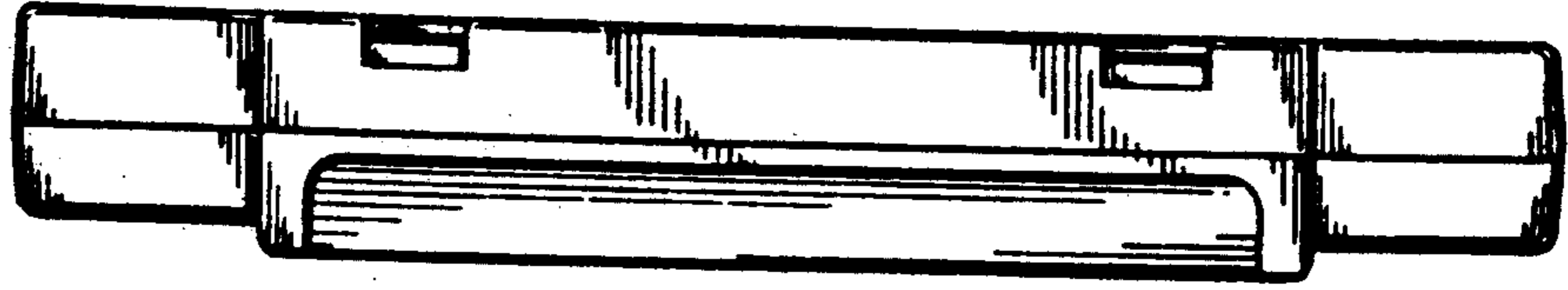

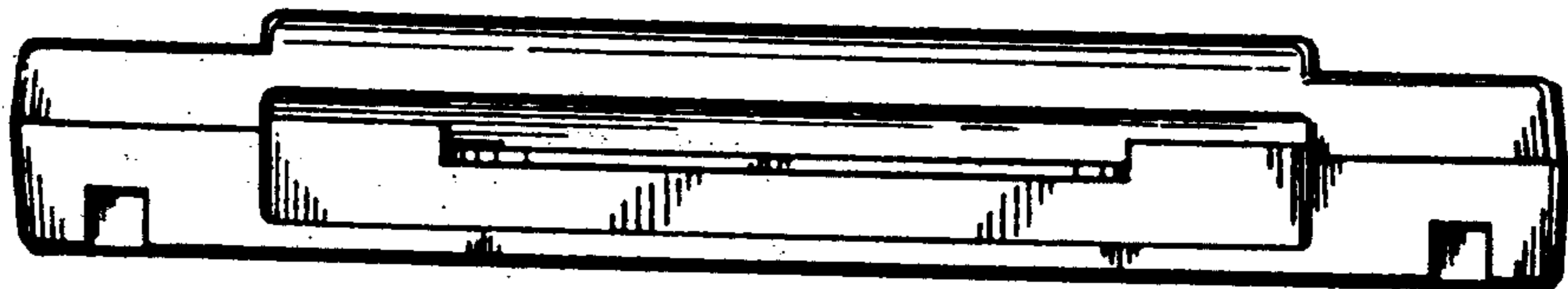

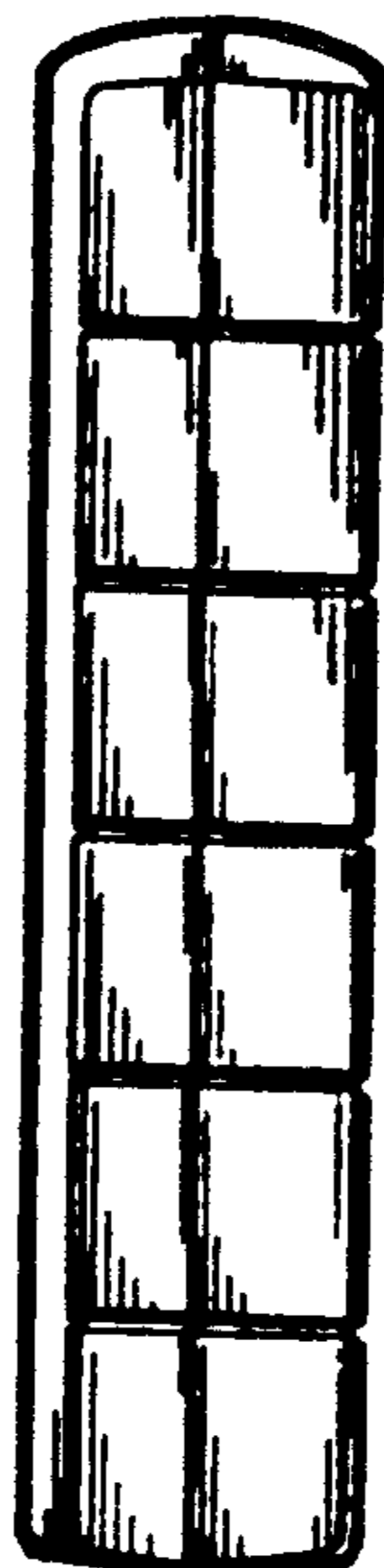

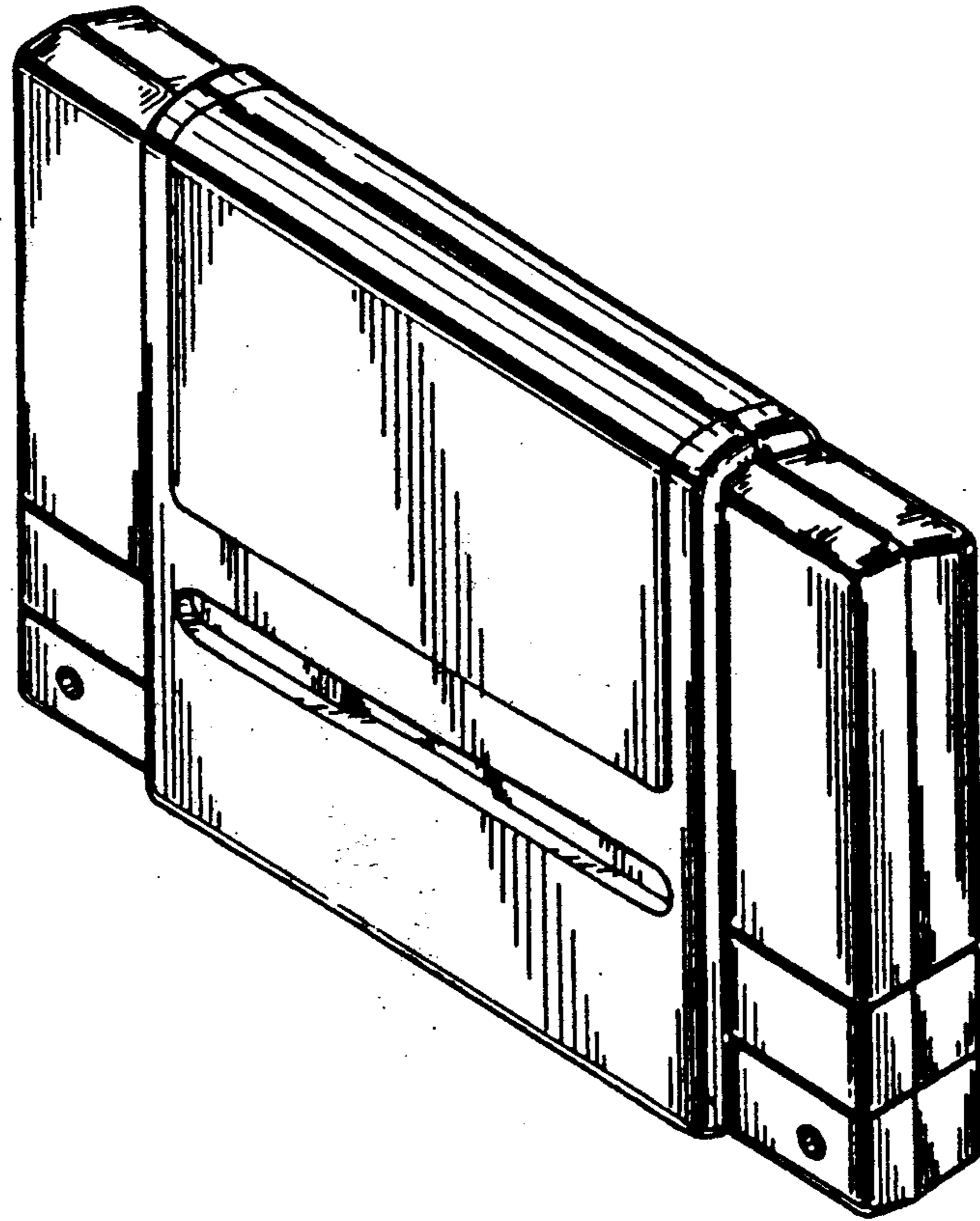
