[57] **CLAIM**

The ornamental design for anti-theft unit for securing portable articles to a vehicle or other non-portable objects, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the anti-theft unit for securing portable articles to a vehicle or other non-portable objects showing the new design; FIG. 2 is a top plan view of thereof; FIG. 3 is a side elevational view of thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a bottom plan view of the thereof; and, FIG. 6 is a bottom plan view of a second embodiment of the anti-theft unit for securing portable articles to a vehicle or other non-portable objects, with the remaining views being the same as FIGS. 1 to 4.

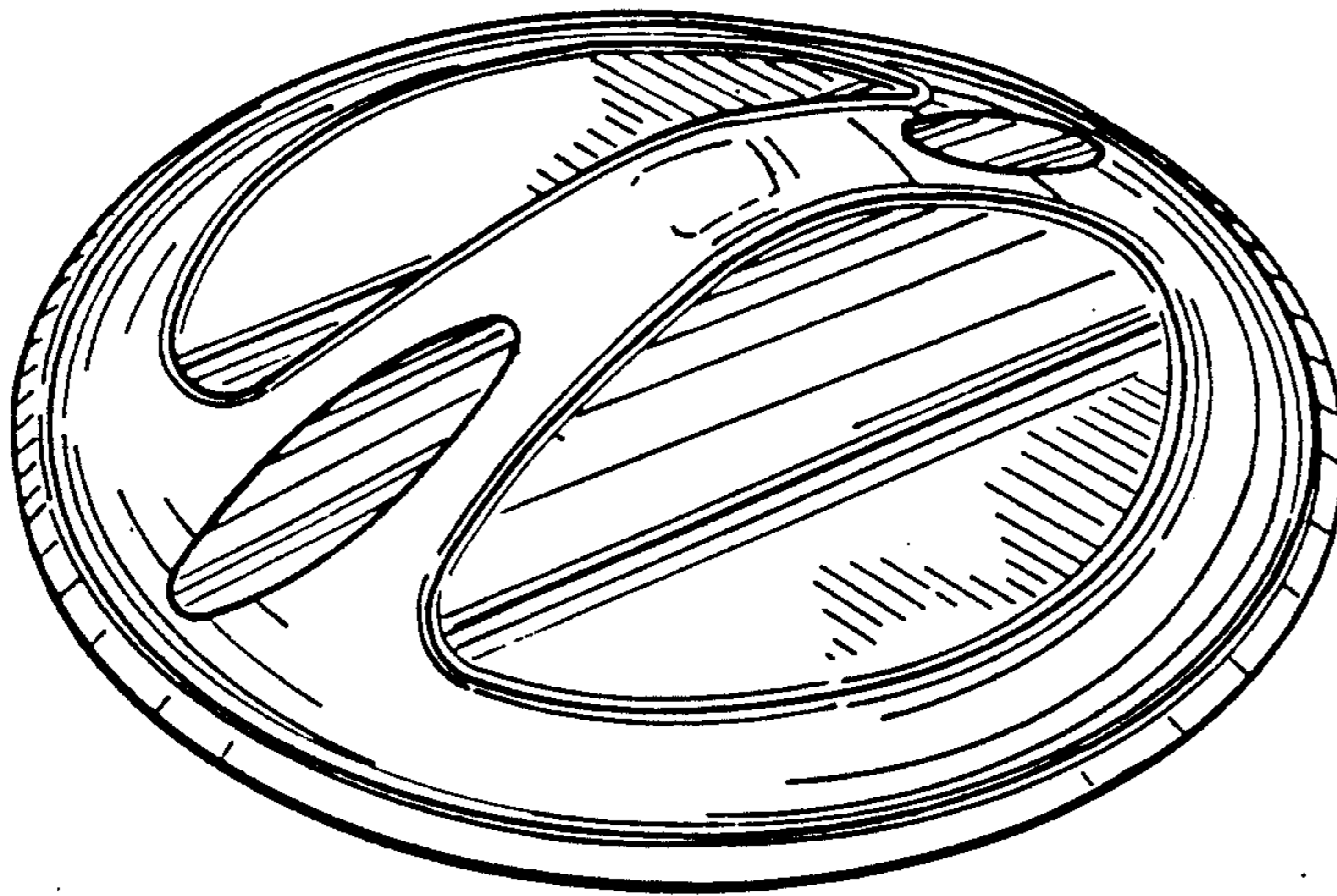

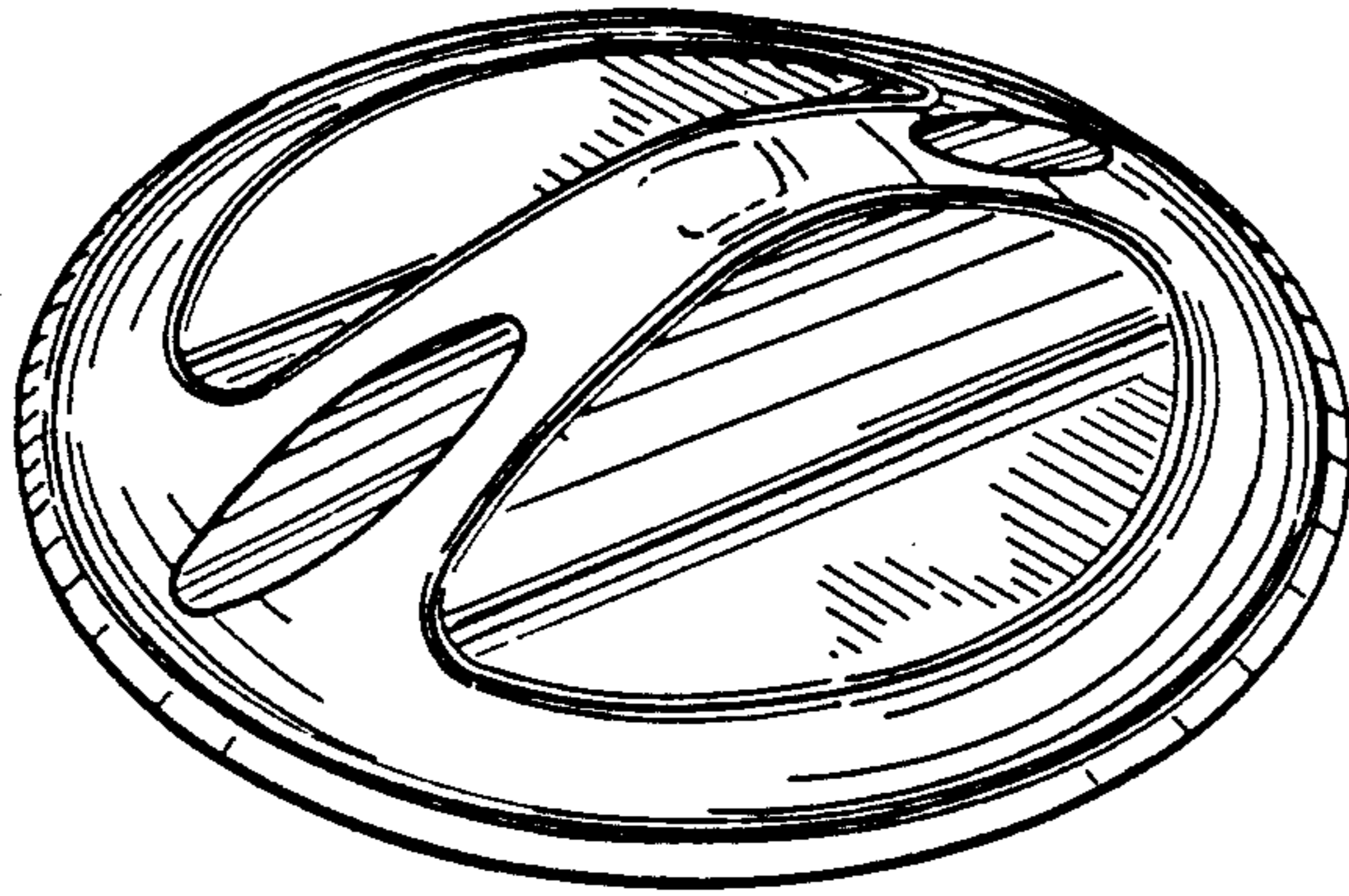

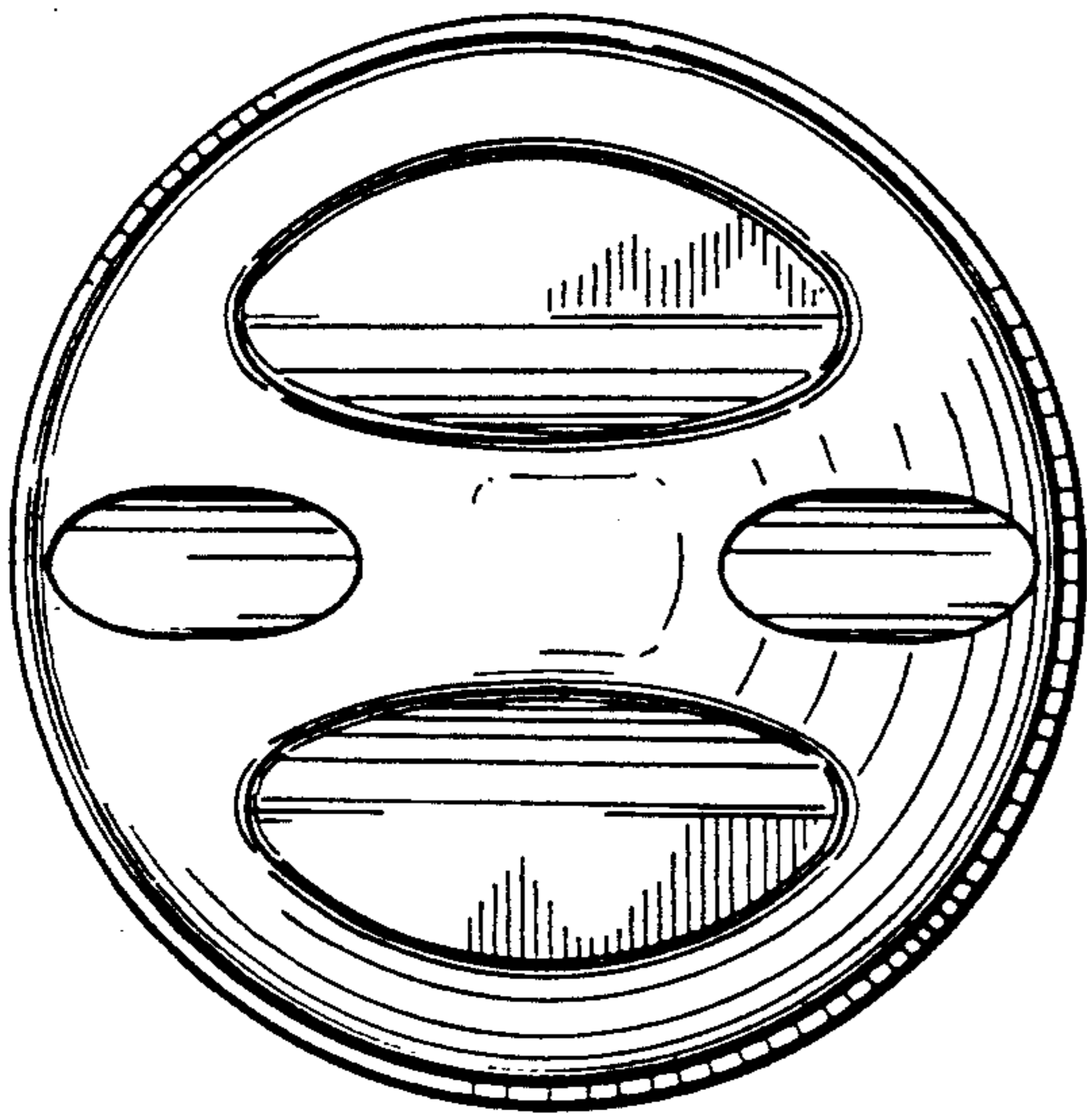

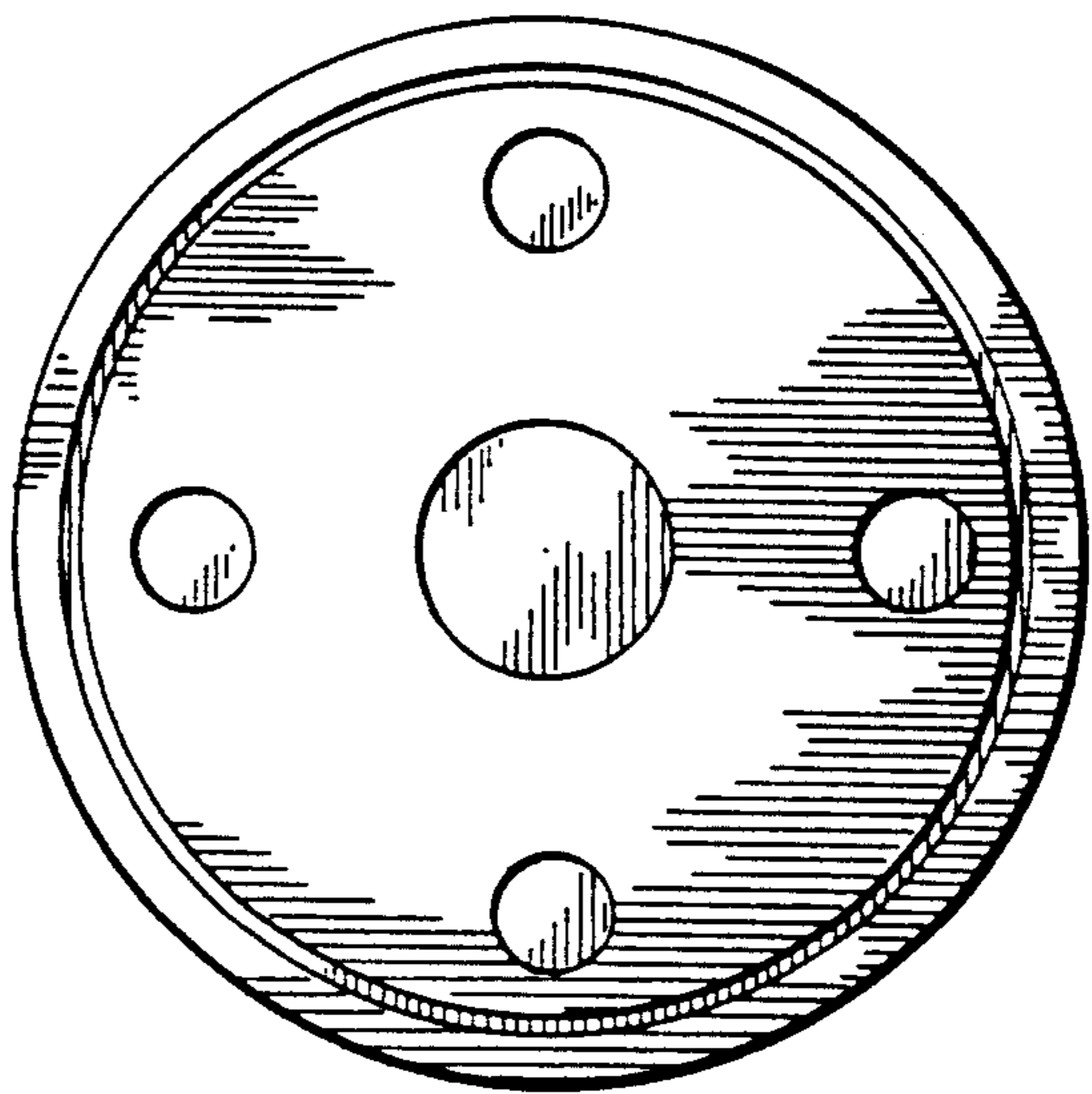

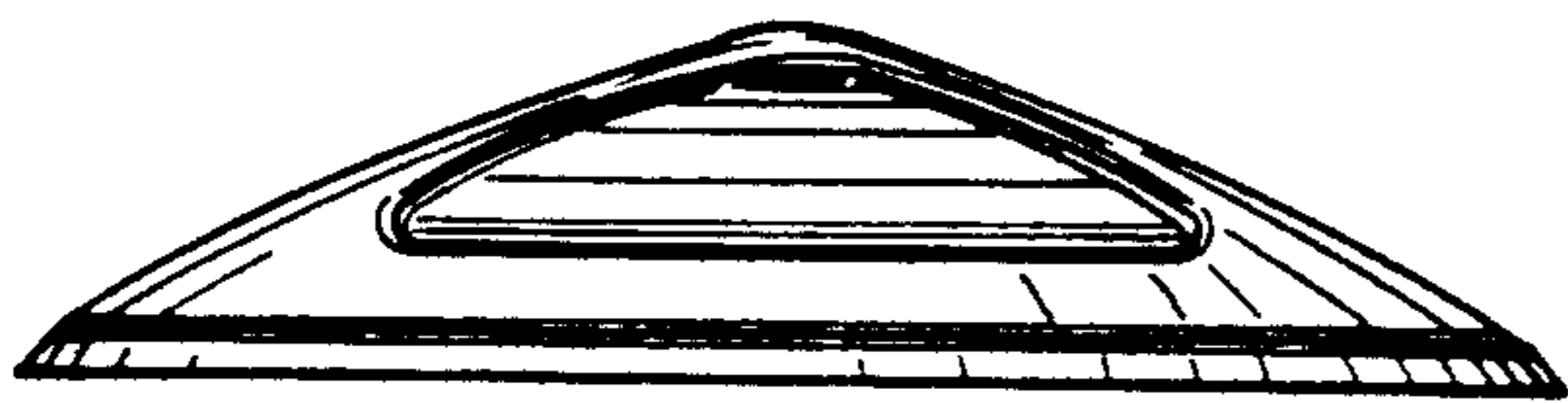

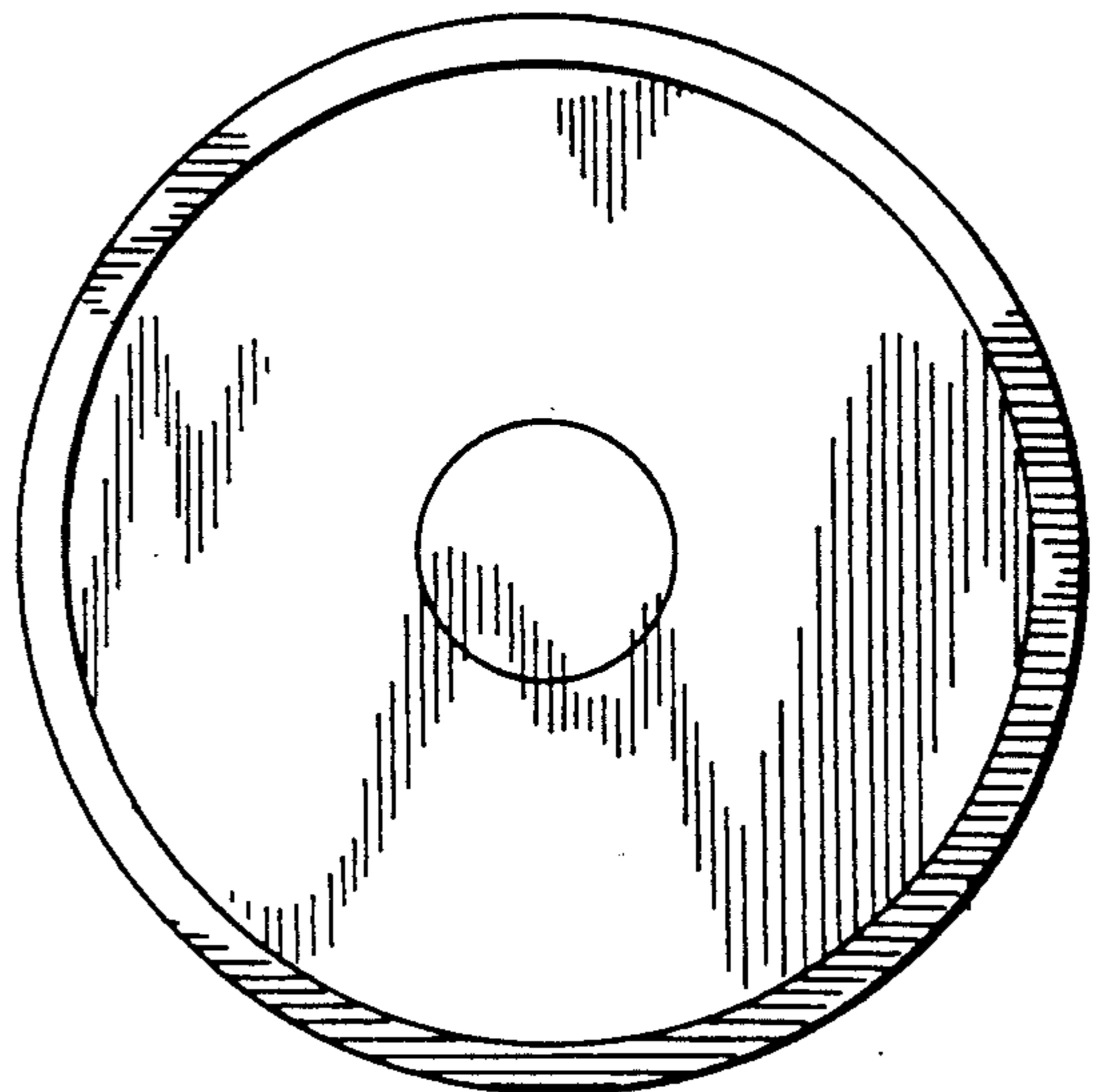
