[57] **CLAIM**

The ornamental design for a spray bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a spray bottle, showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a side elevational view thereof, the other side being a mirror copy of this side;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a perspective view of a second embodiment of the spray bottle as in FIG. 1;

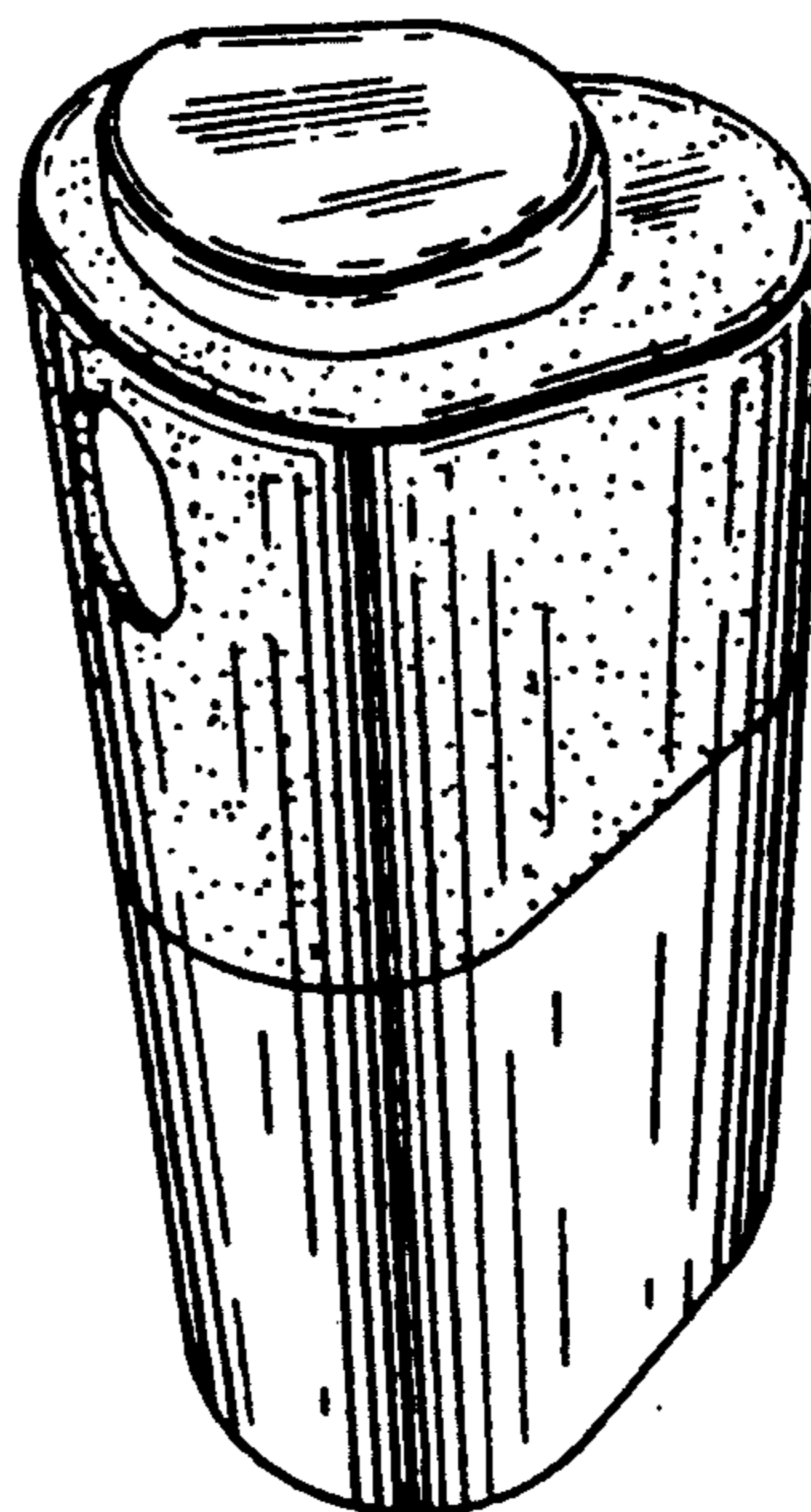
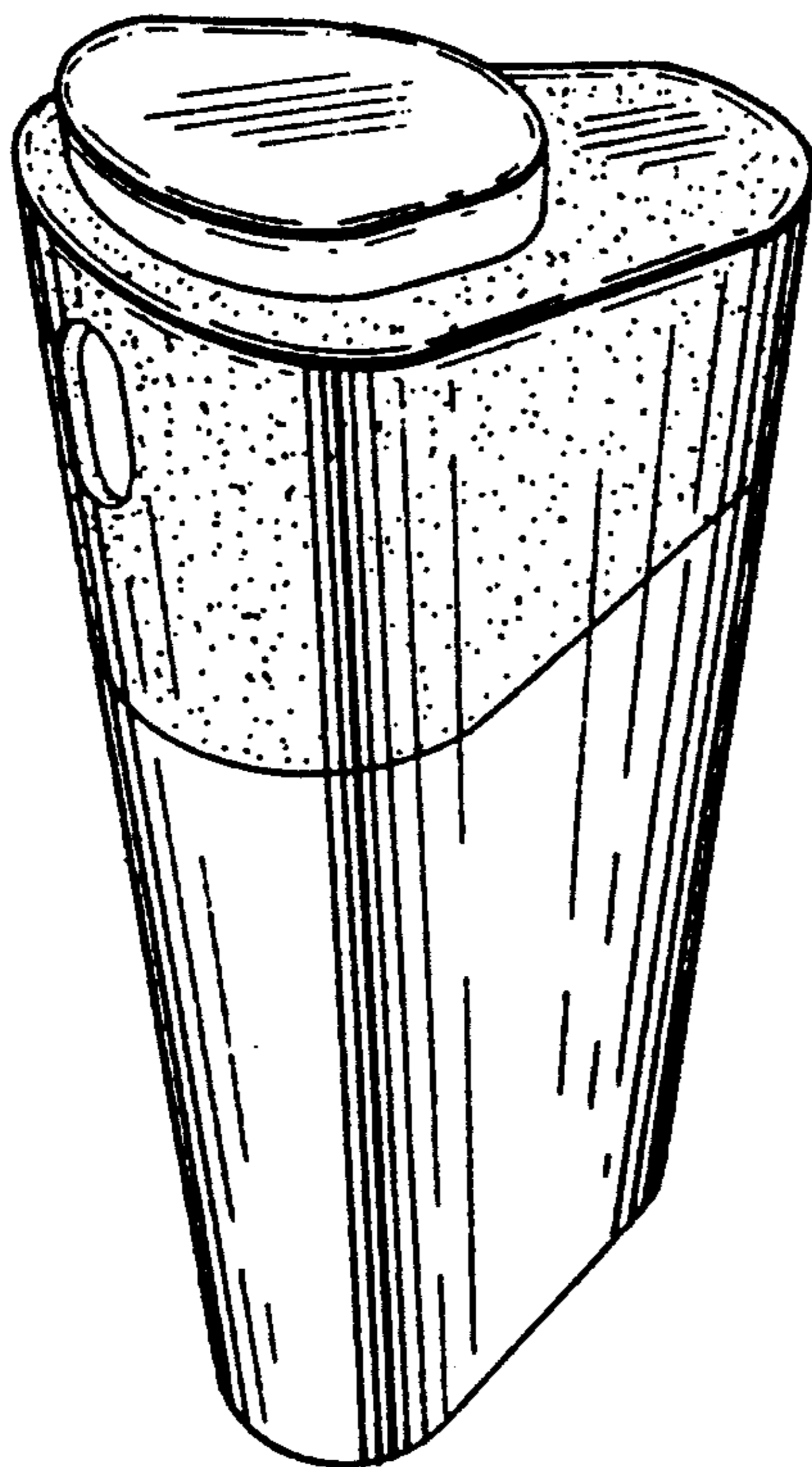
FIG. 8 is a top plan view of FIG. 7;

FIG. 12 is a bottom plan view of FIG. 7.



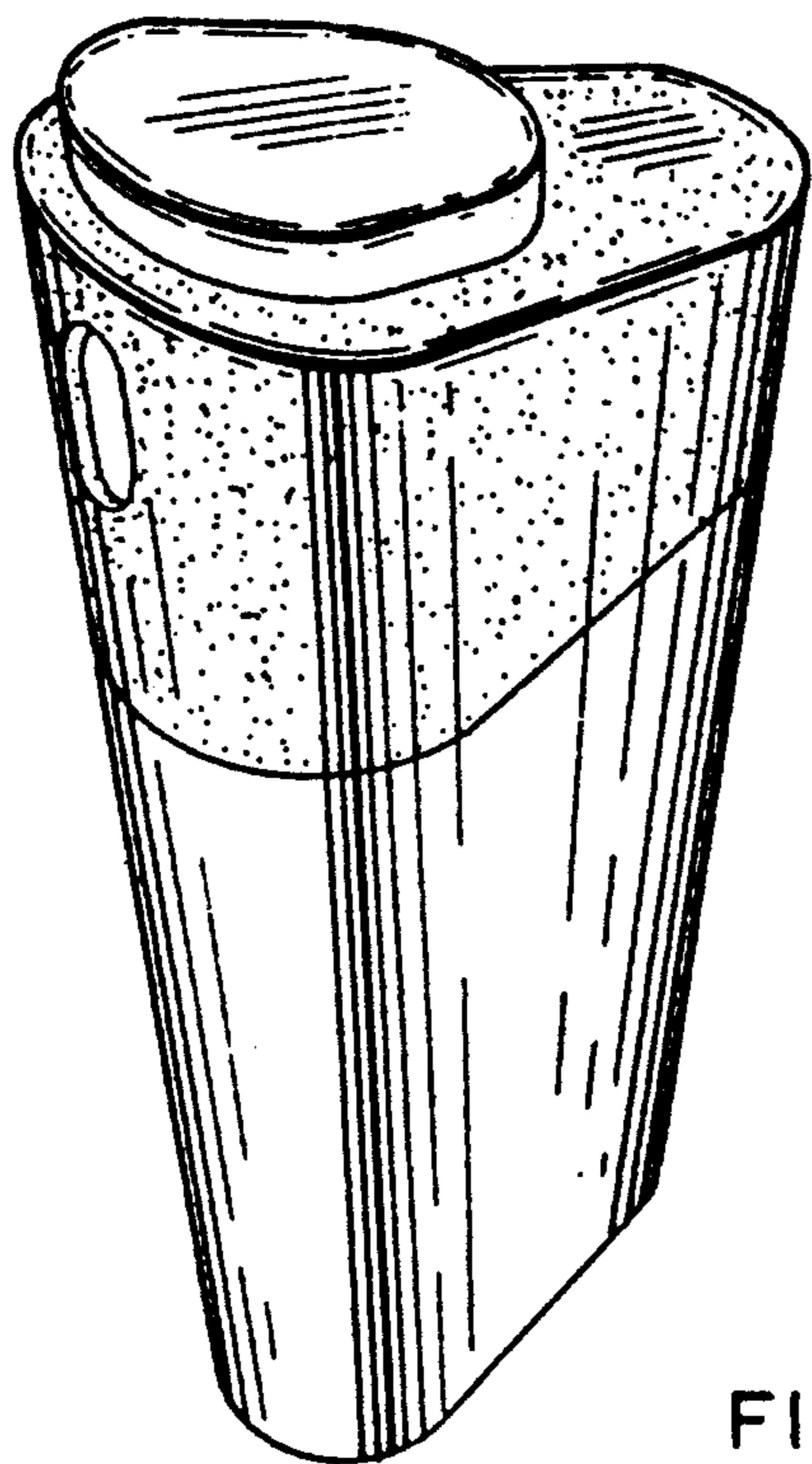

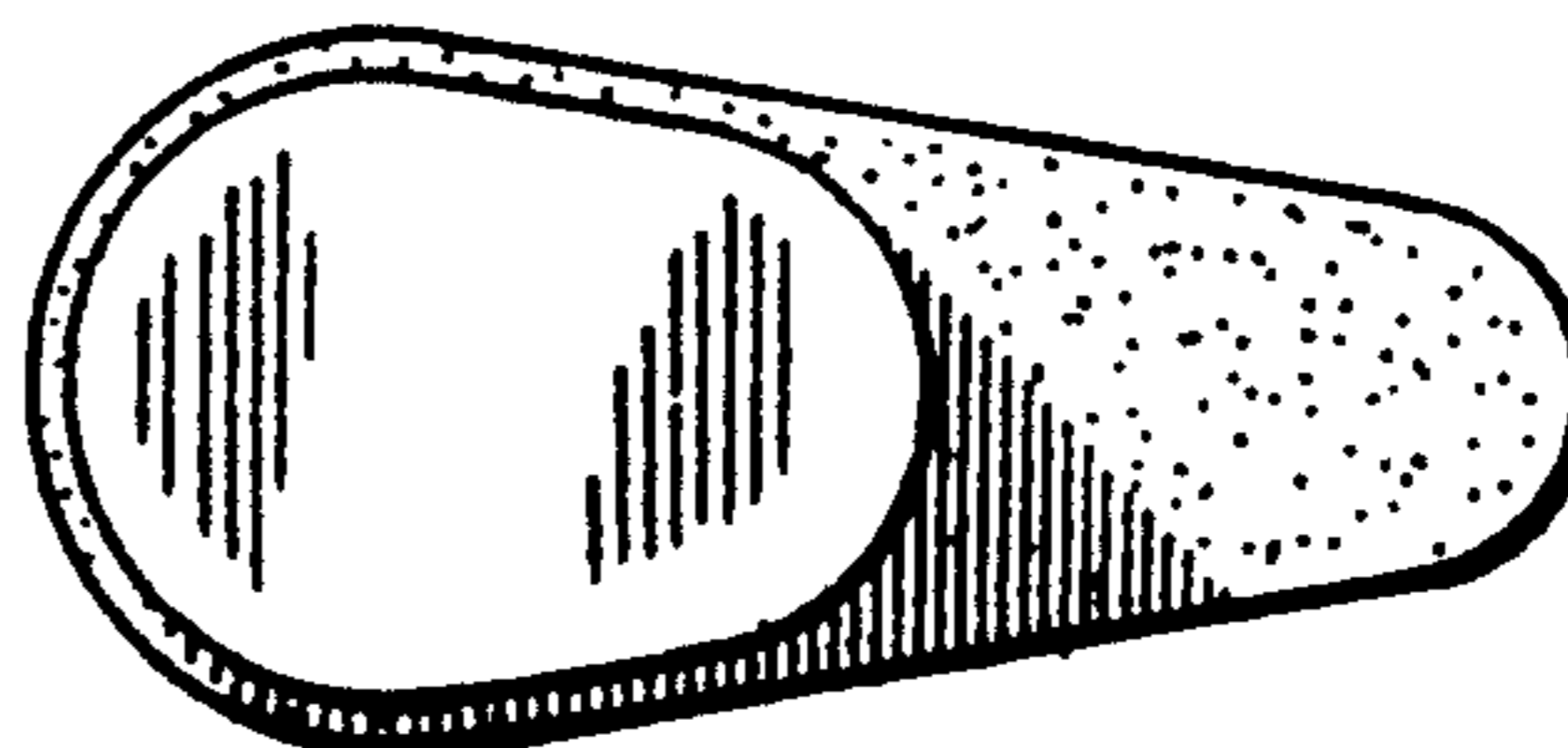

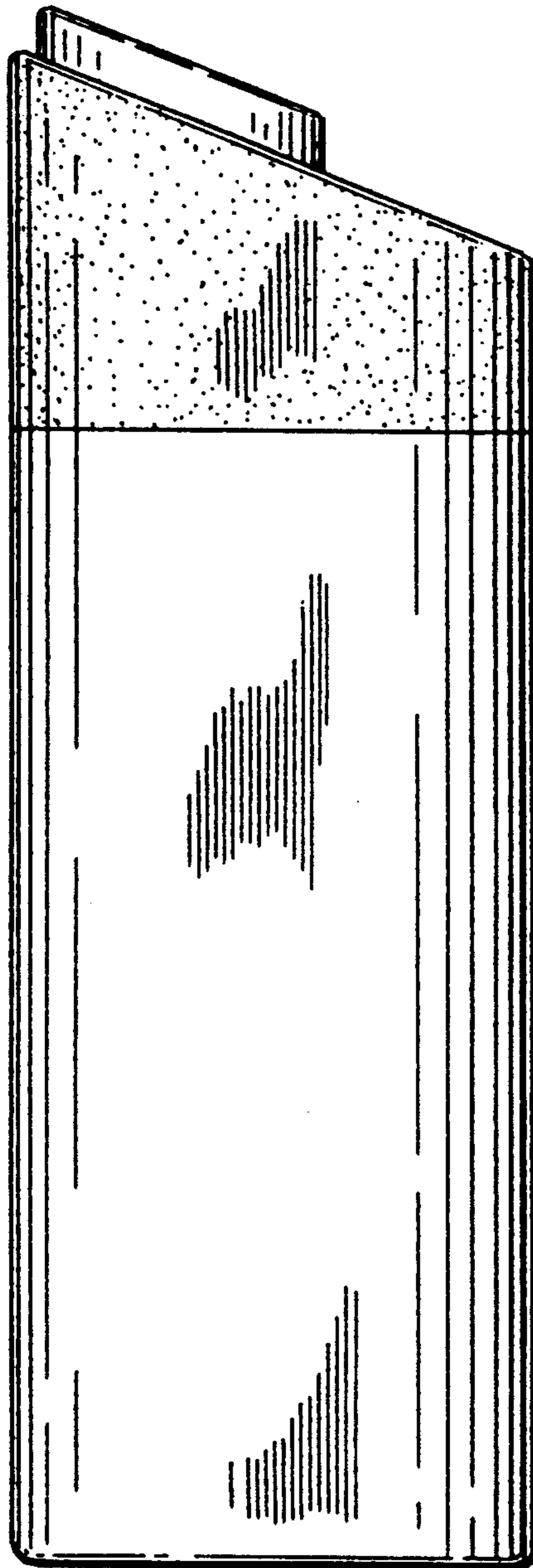

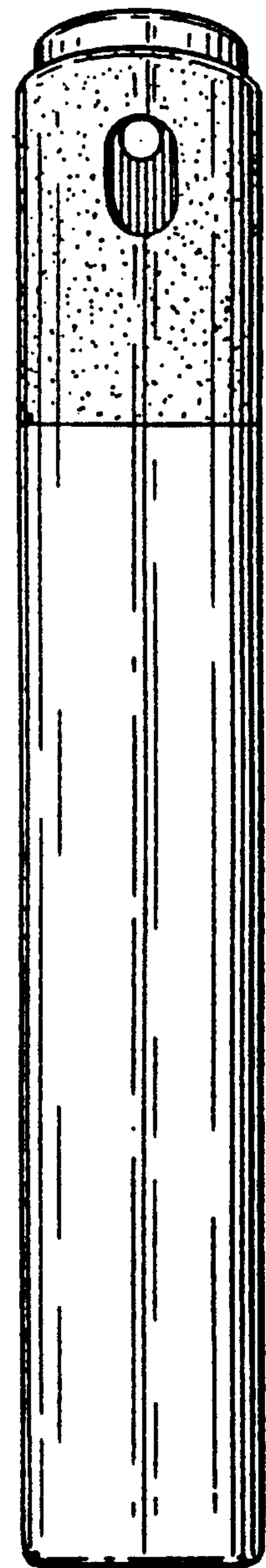

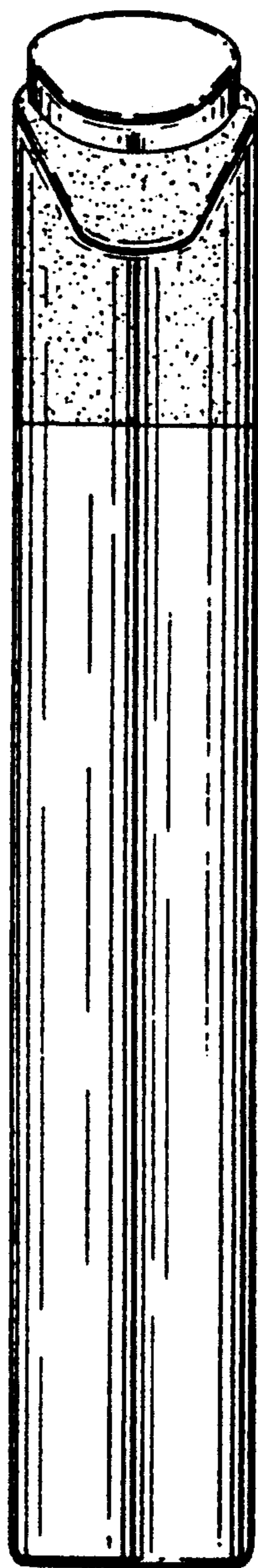

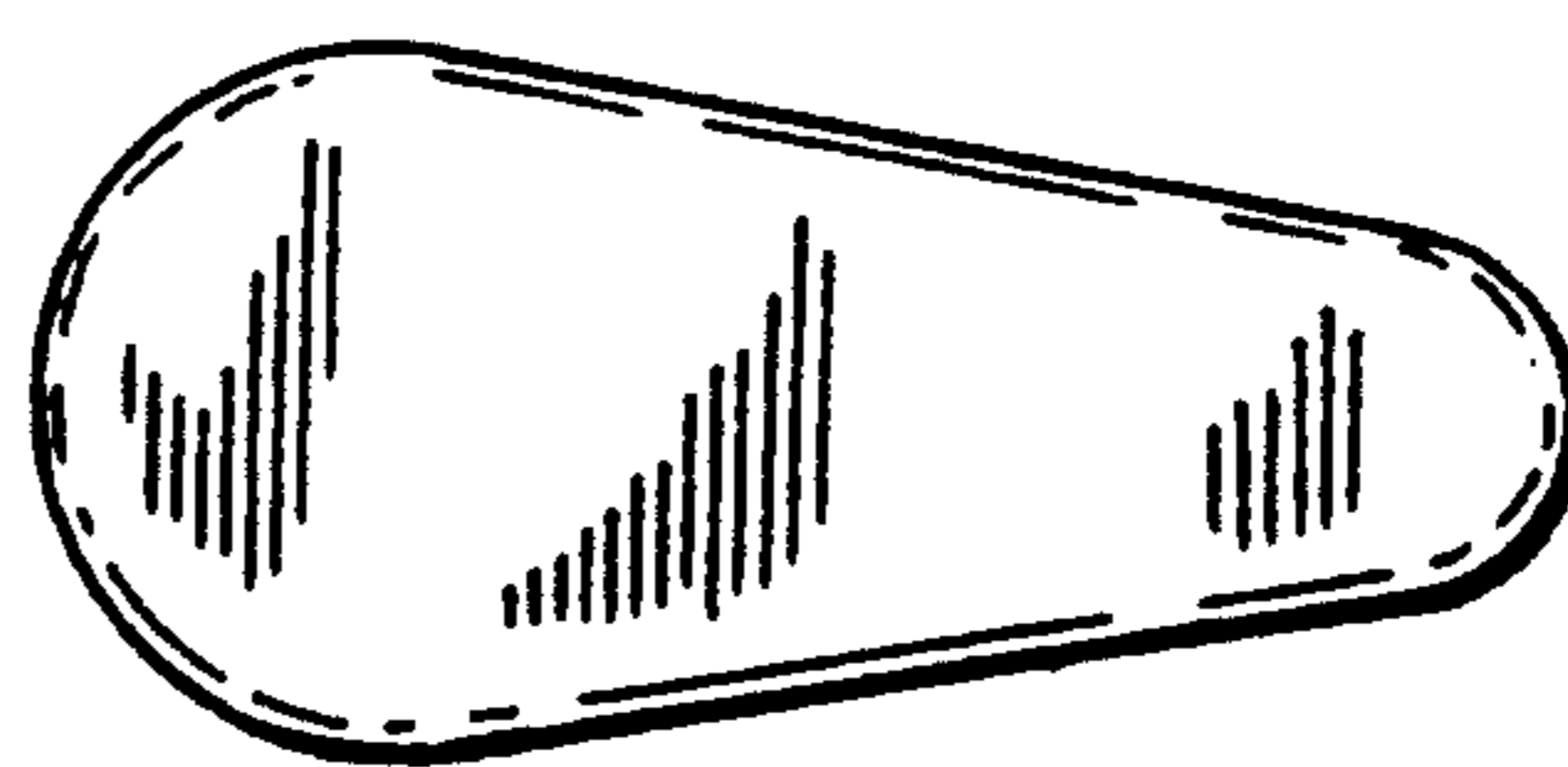

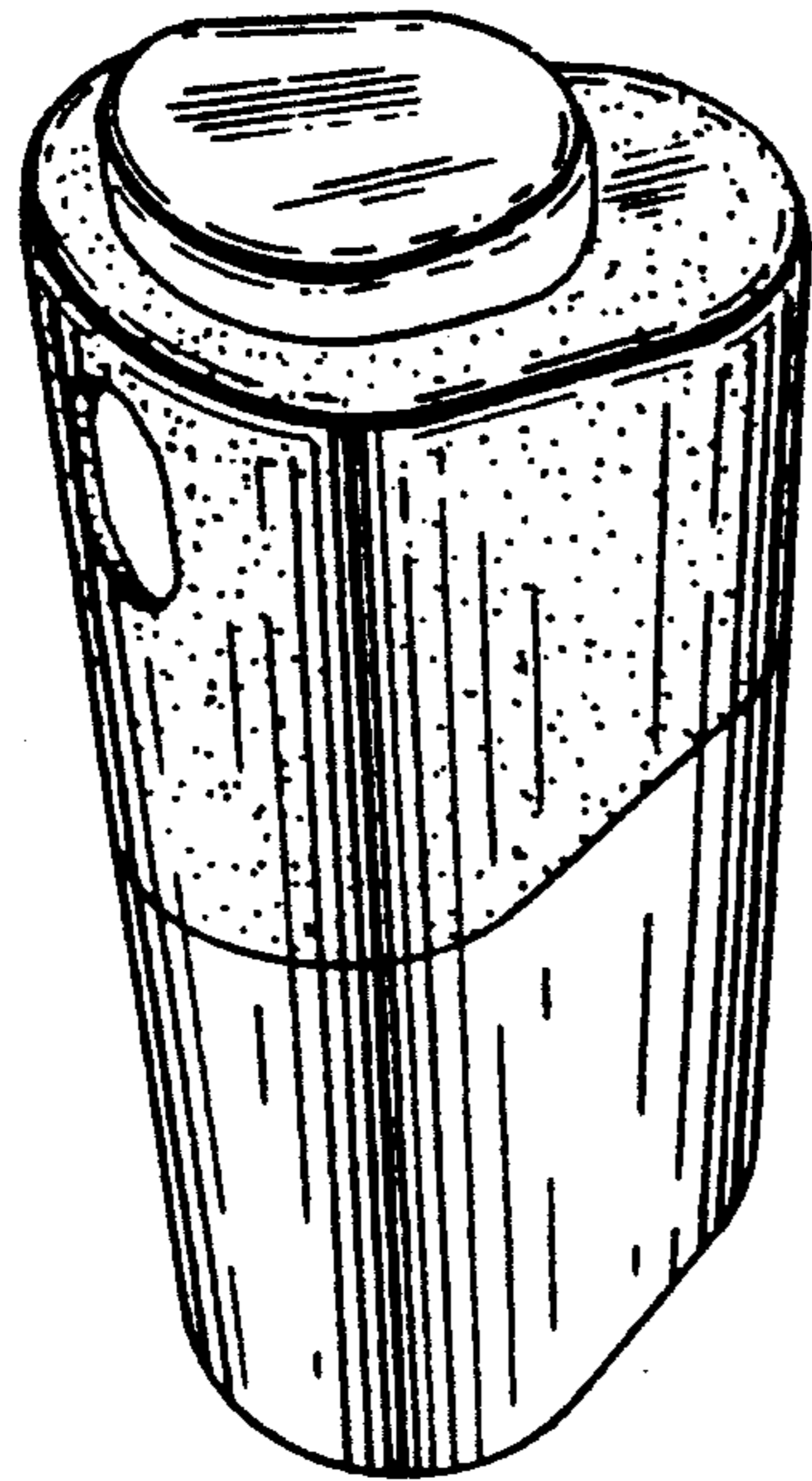

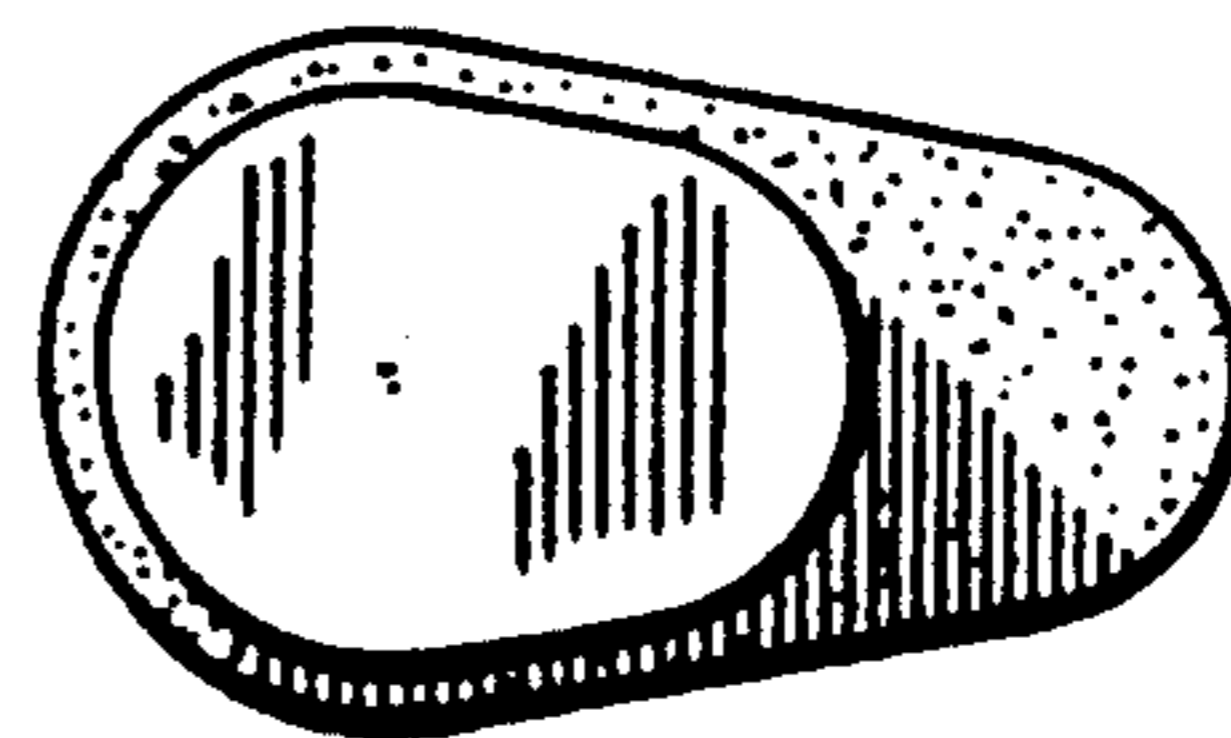

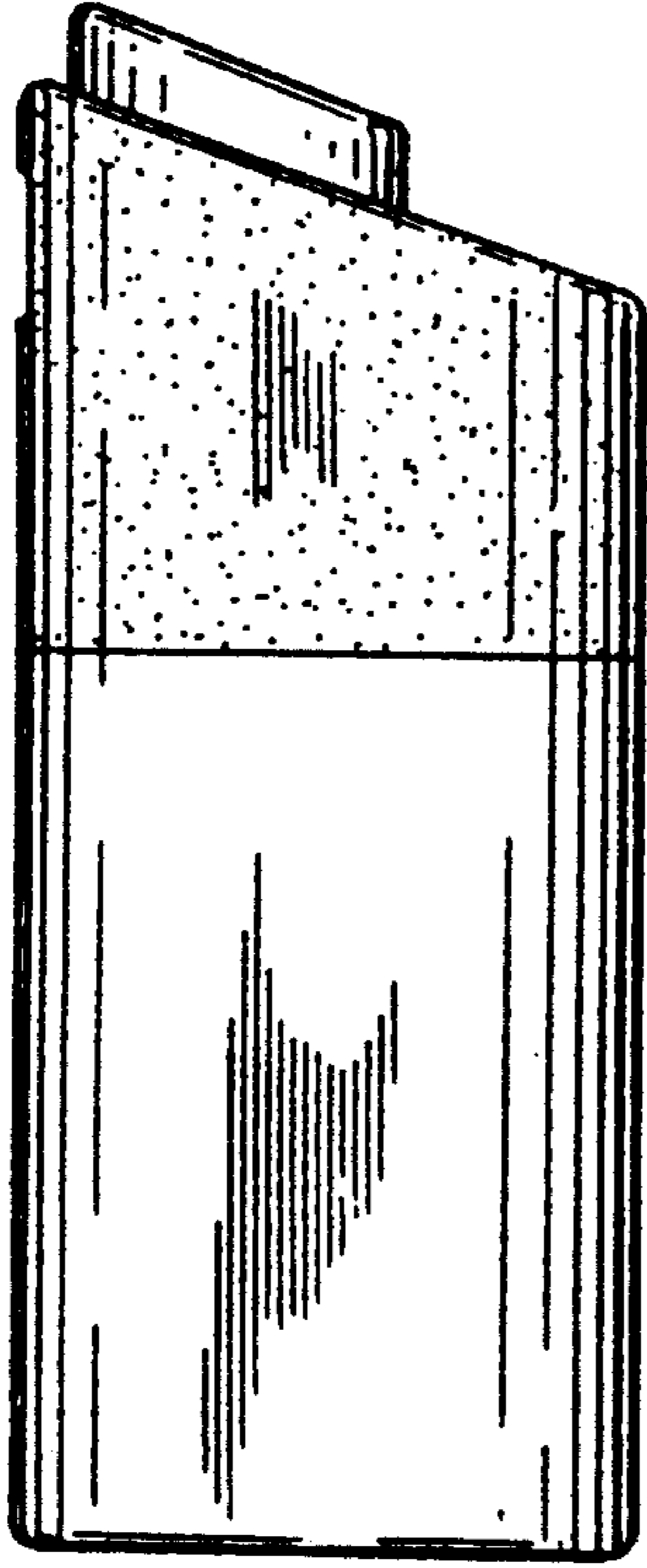

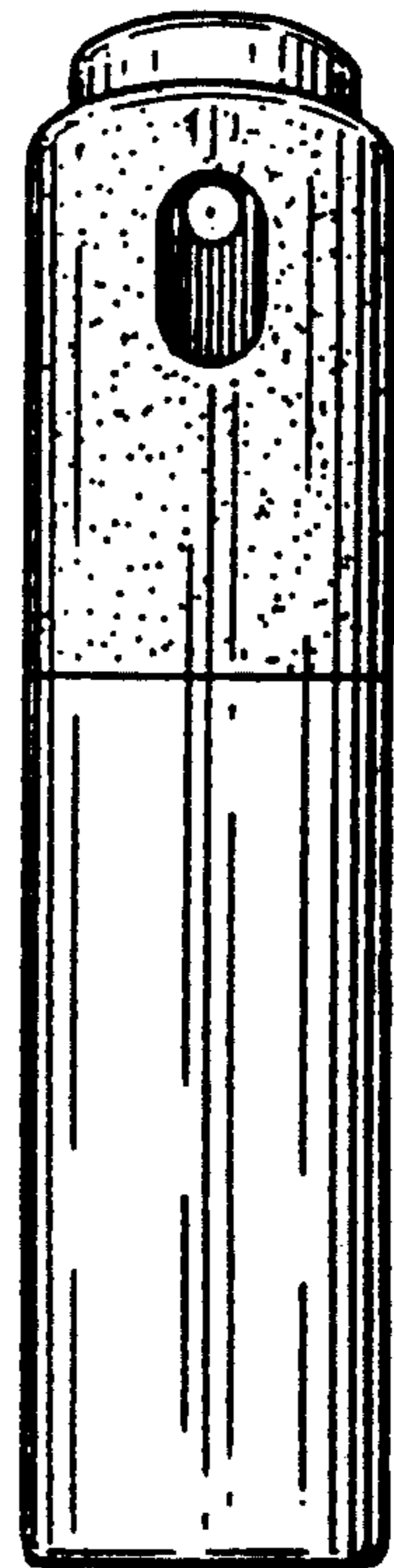

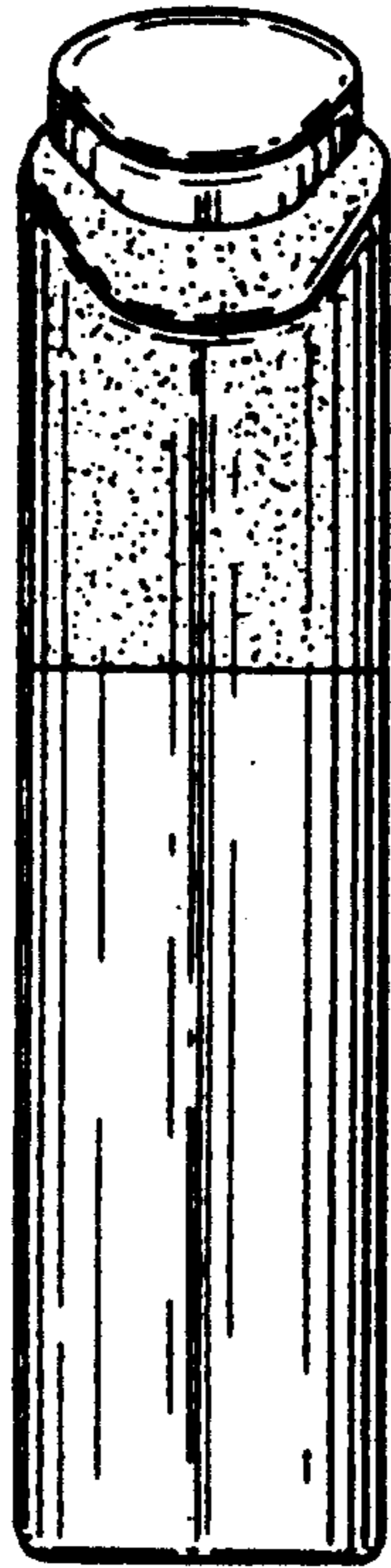

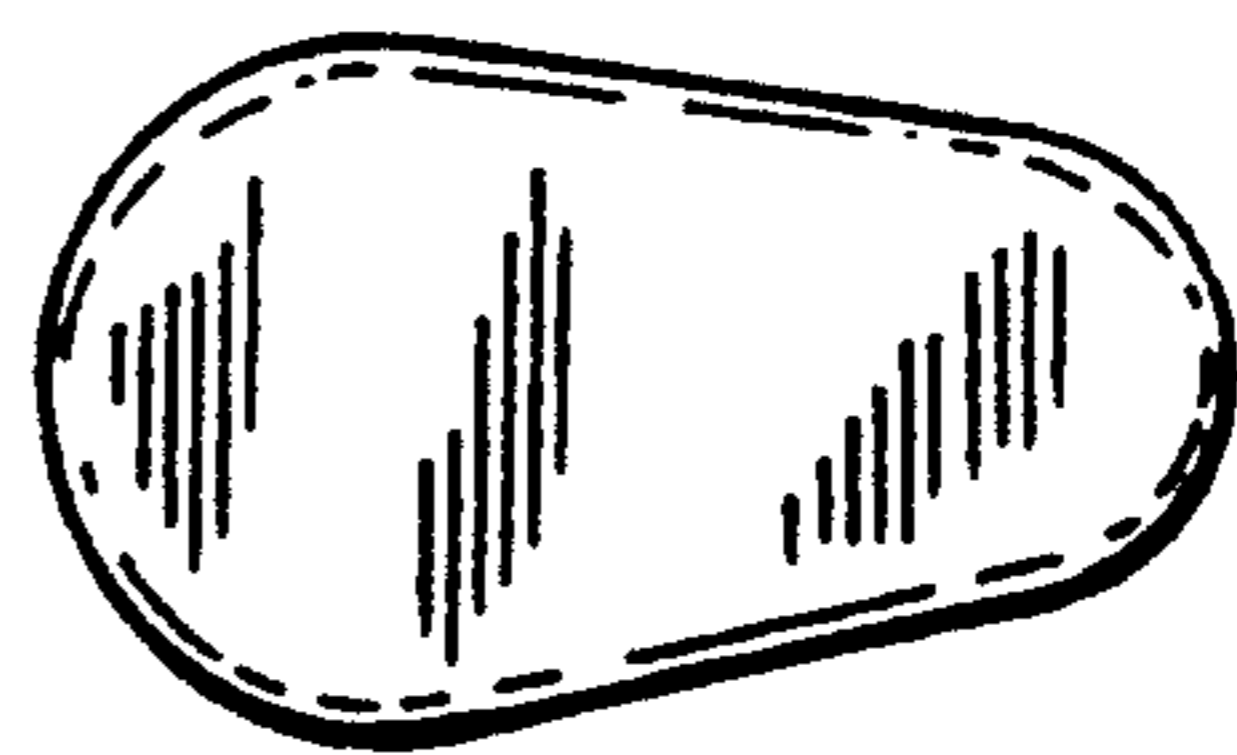
