DESCRIPTION

FIG. 1 is a front-elevational view of eyeglasses of the present invention;
 FIG. 2 is a rear elevational view of the eyeglasses of FIG. 1;
 FIG. 3 is a side view of the eyeglasses of FIG. 1, the opposite side being a mirror image thereof;
 FIG. 4 is a top plan view of the eyeglasses of FIG. 1; and,
 FIG. 5 is a bottom plan view of the eyeglasses of FIG. 1.

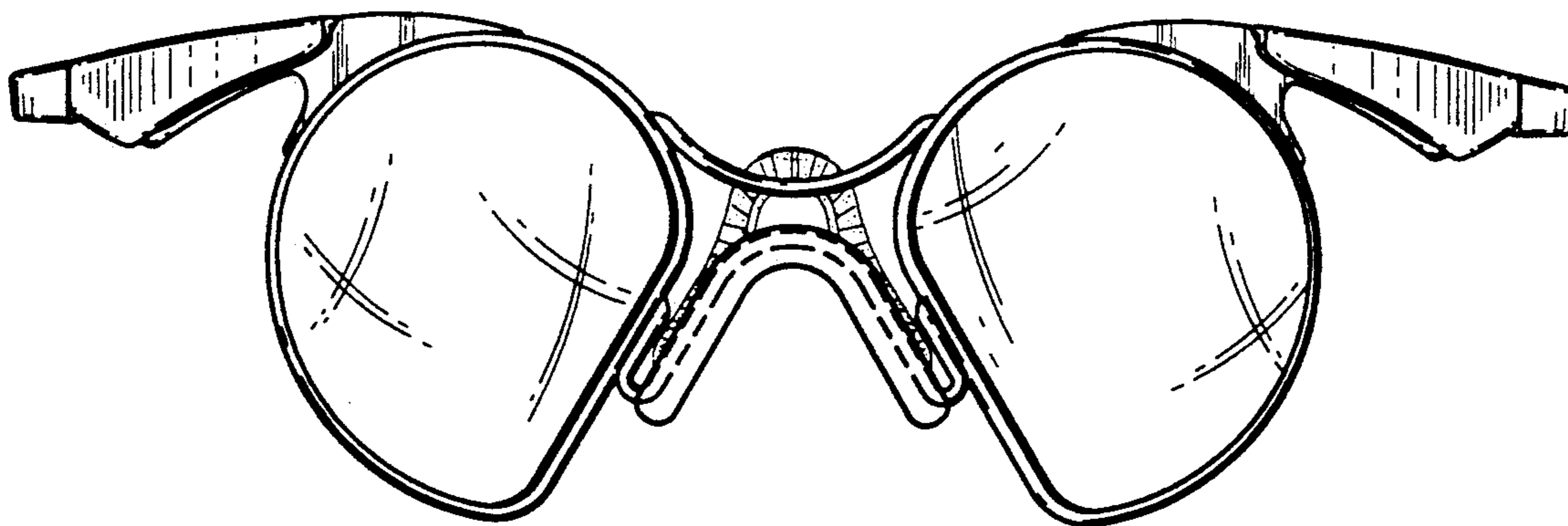

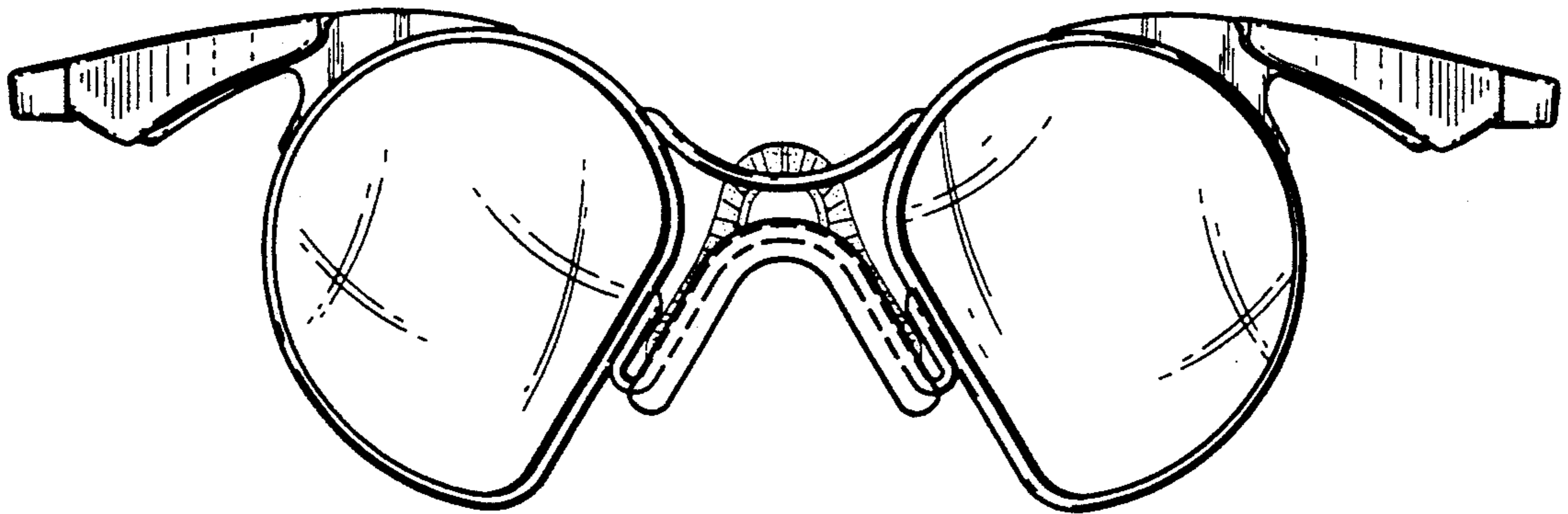

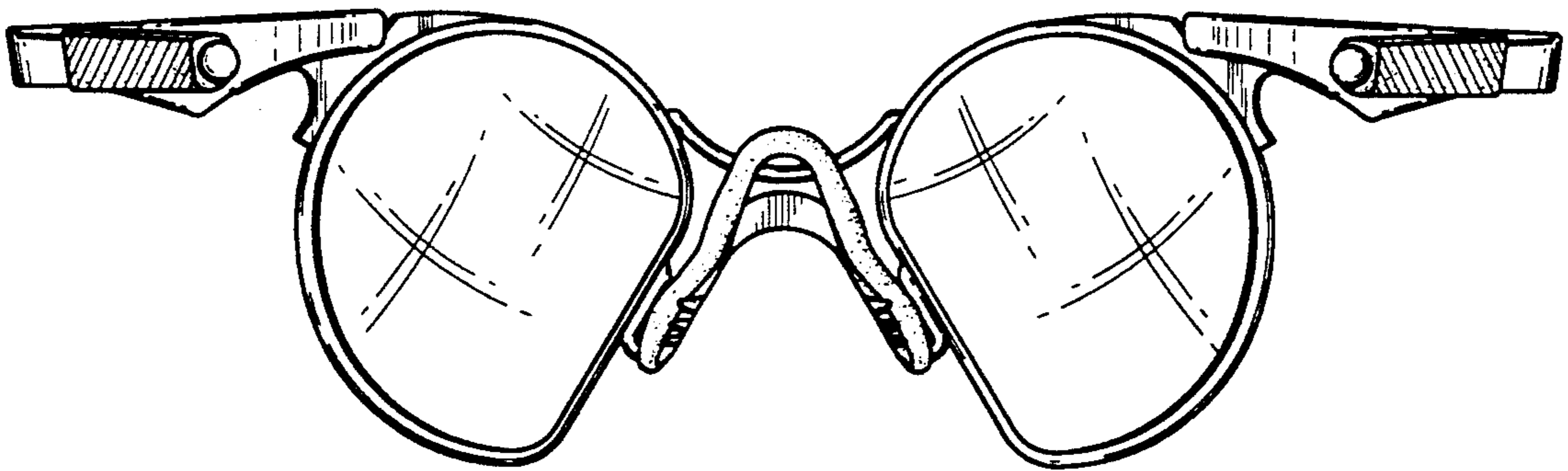
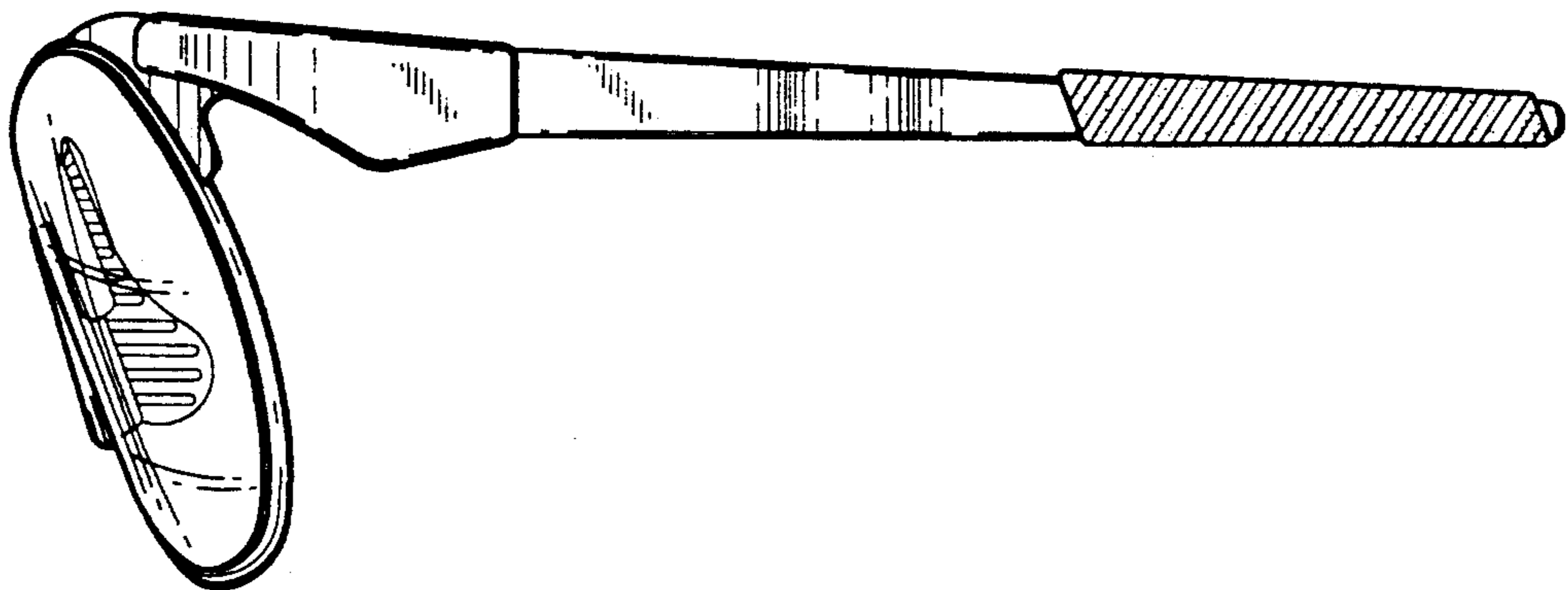

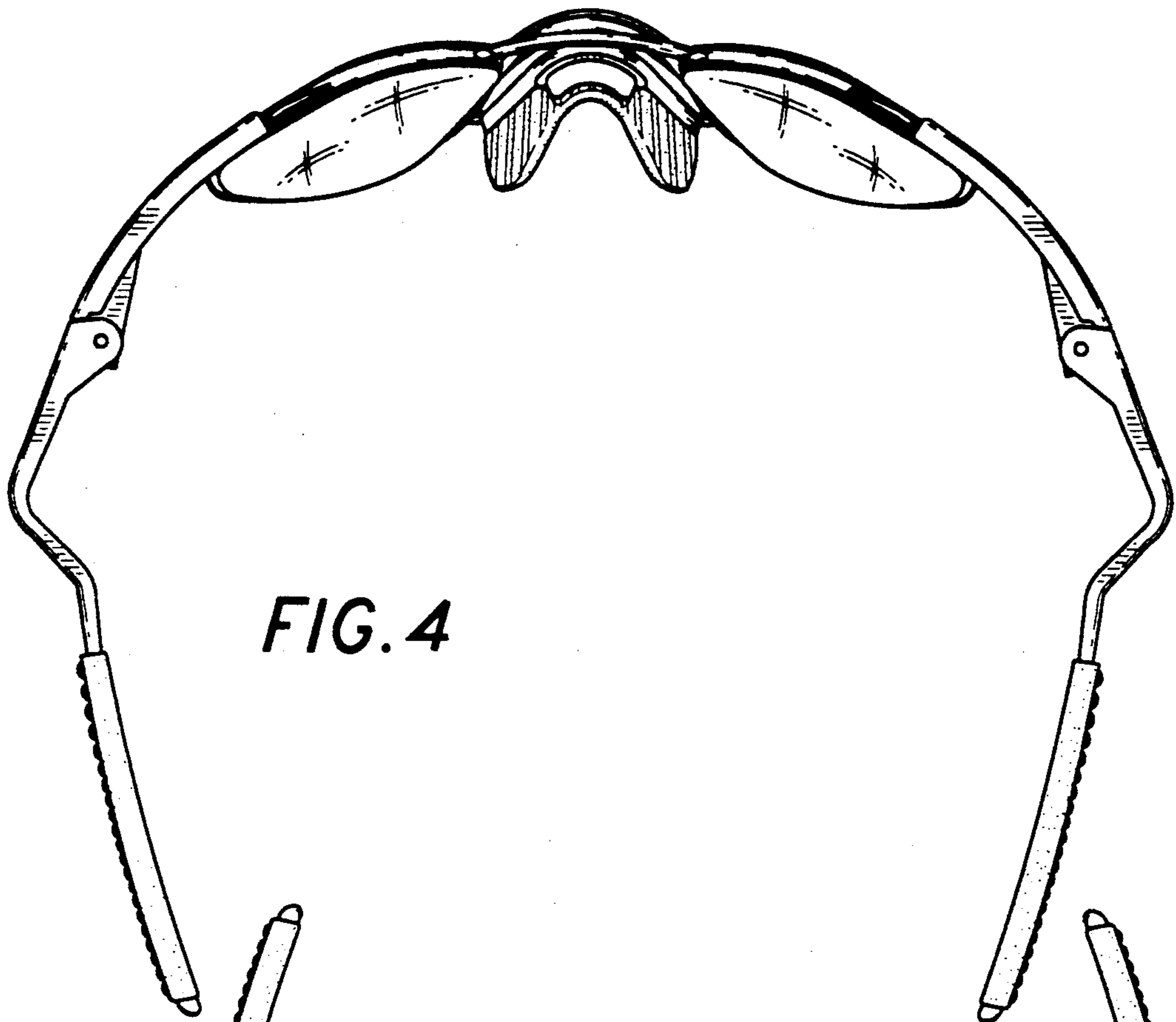

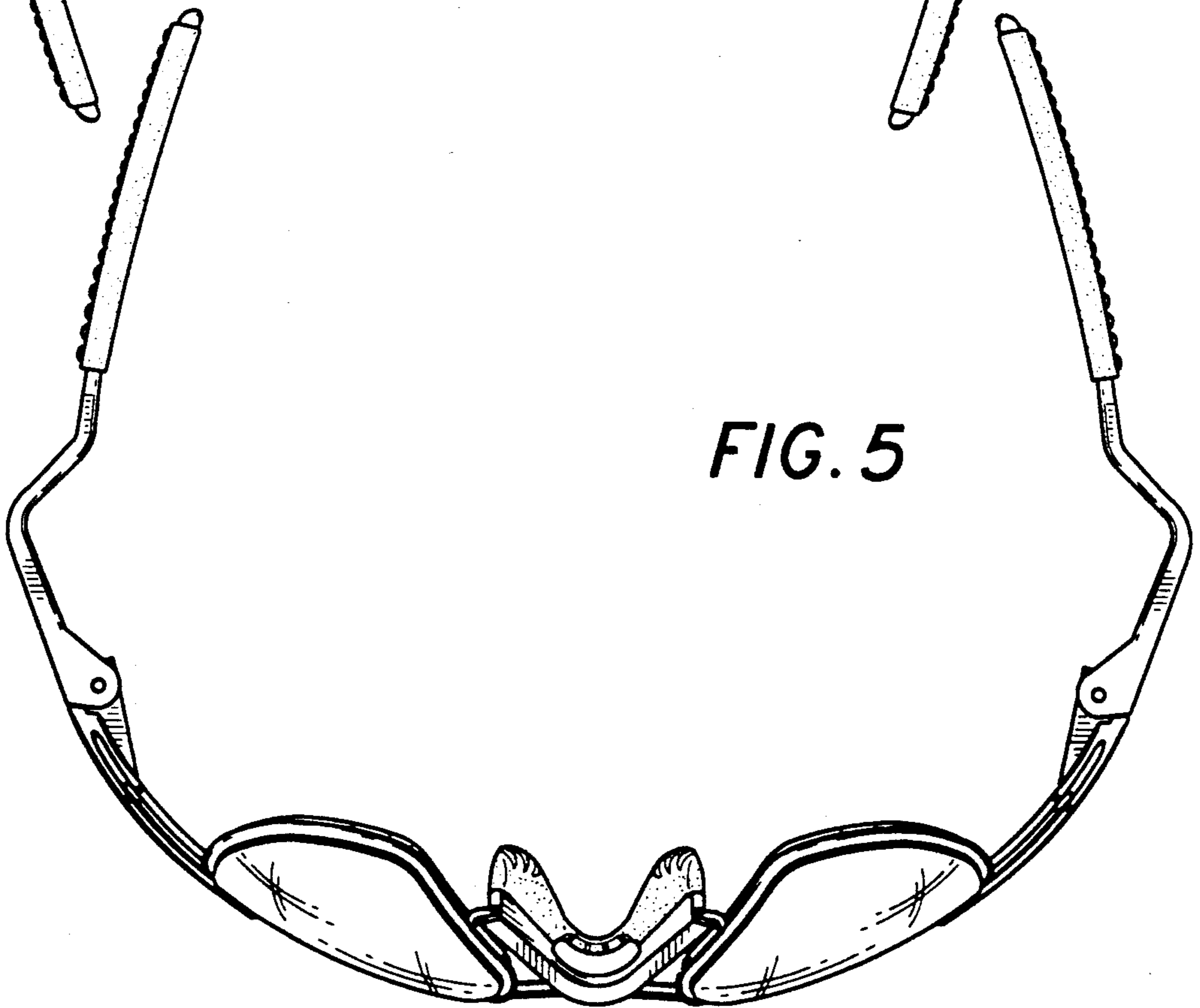
