[57] **CLAIM**

The ornamental design for a combined pen, chain and wall-mountable bracket therefor, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a combined pen, chain and wall-mountable bracket therefor showing my new design with the pen shown separated;

FIG. 2 is a perspective view with the pen in a stored position;

FIG. 3 is a top plan view;

FIG. 4 is a bottom plan view;

FIG. 5 is a front elevational view with the bracket removed for convenience of illustration;

FIG. 6 is a front elevational view of FIG. 5 with the pen shown separated;

FIG. 7 is a side elevational view of FIG. 6;

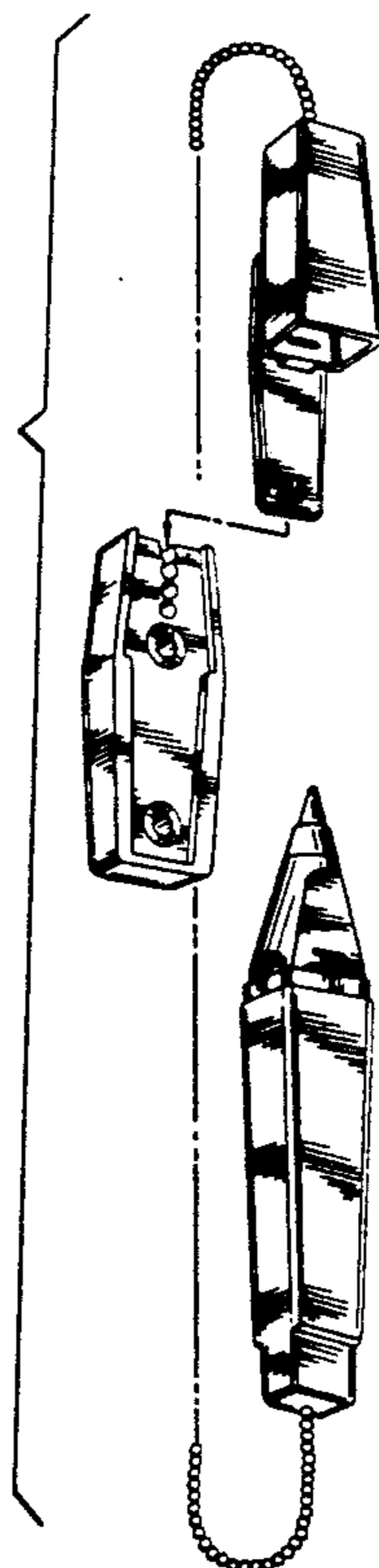
FIG. 8 is a rear elevational view of FIG. 2;

FIG. 12 is a perspective view of FIG. 1 in an exploded condition.



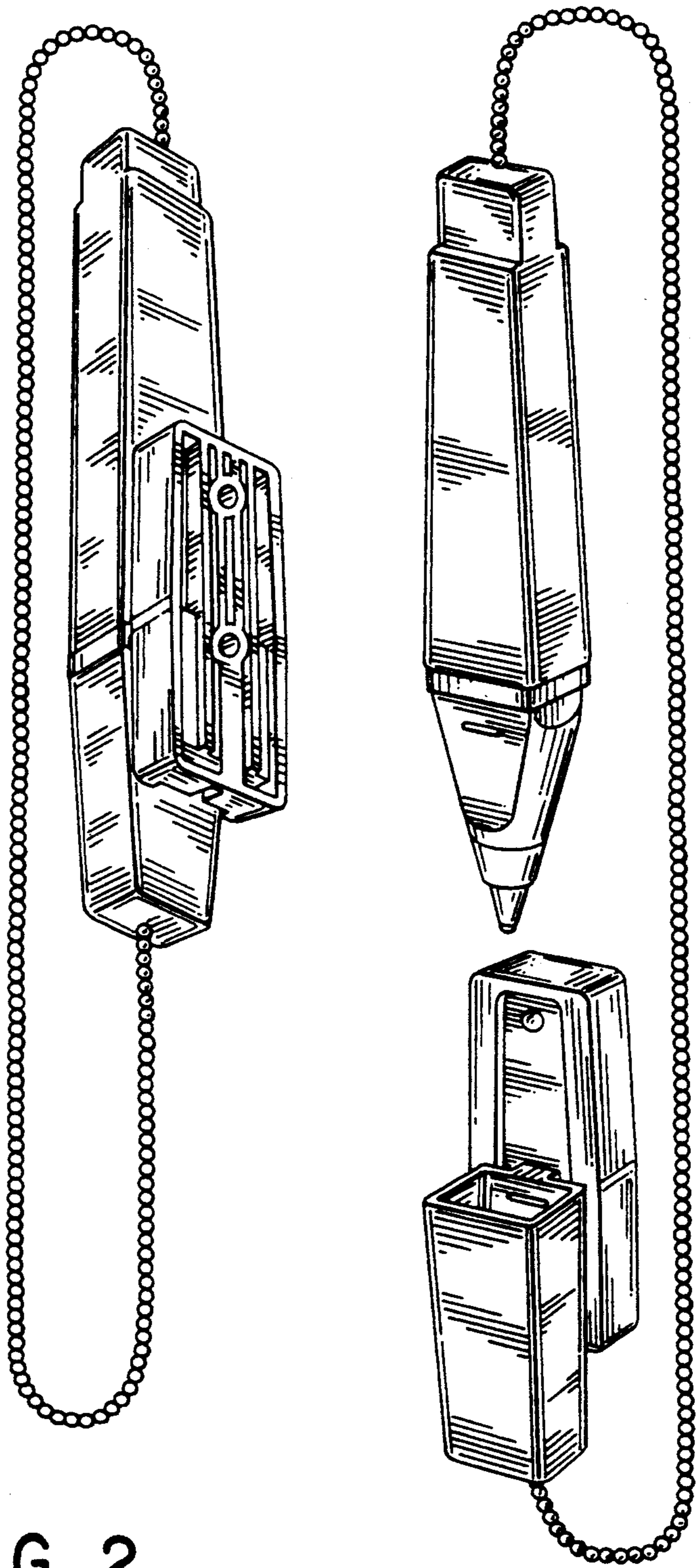

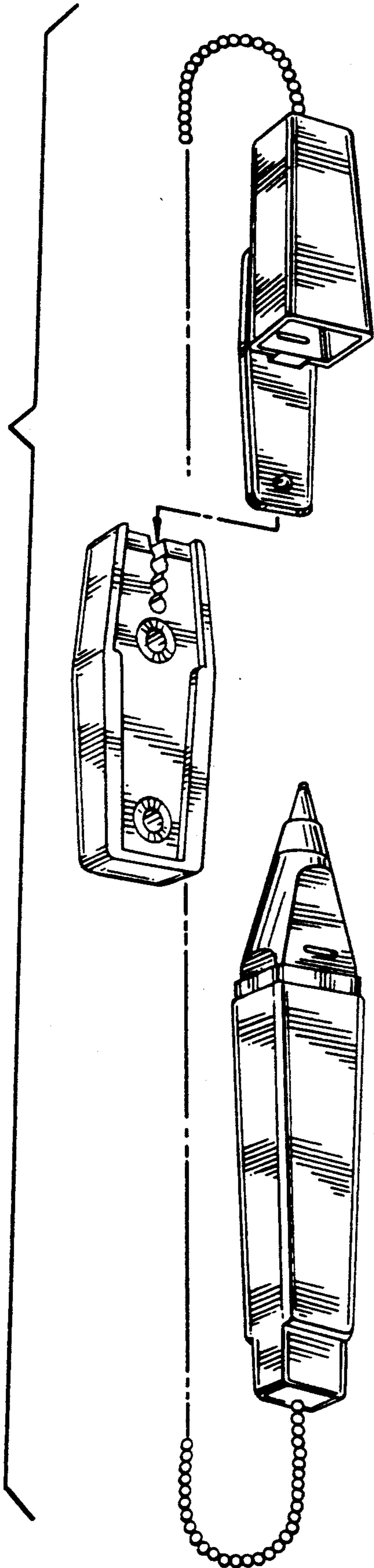

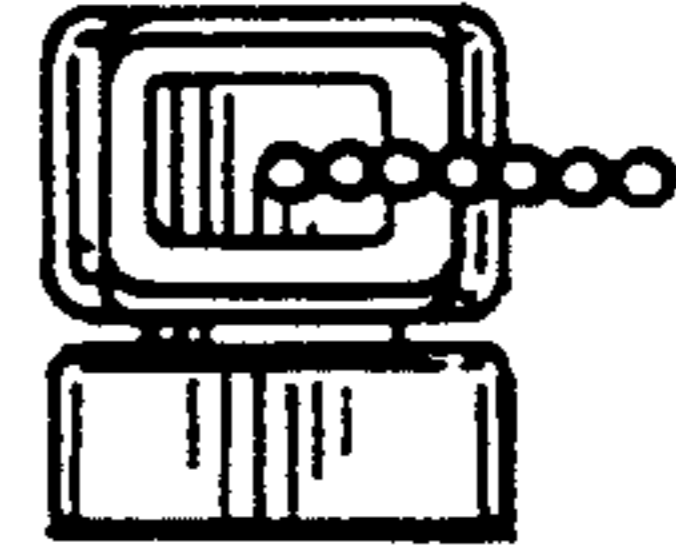

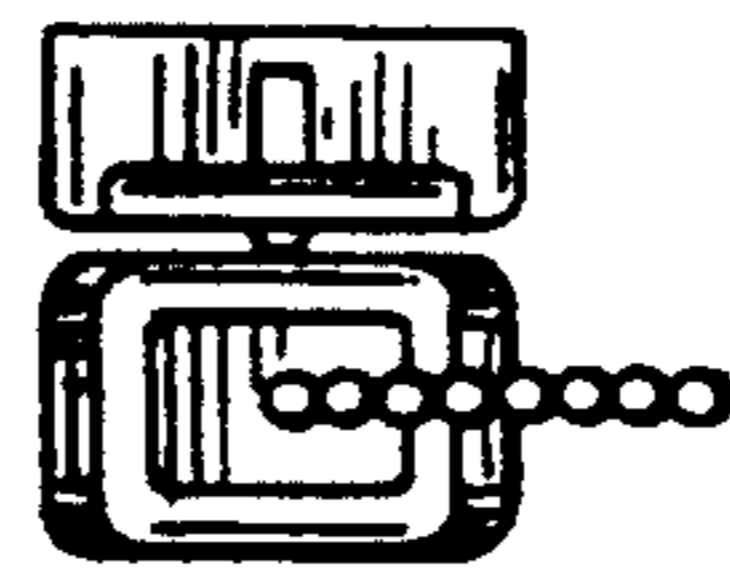

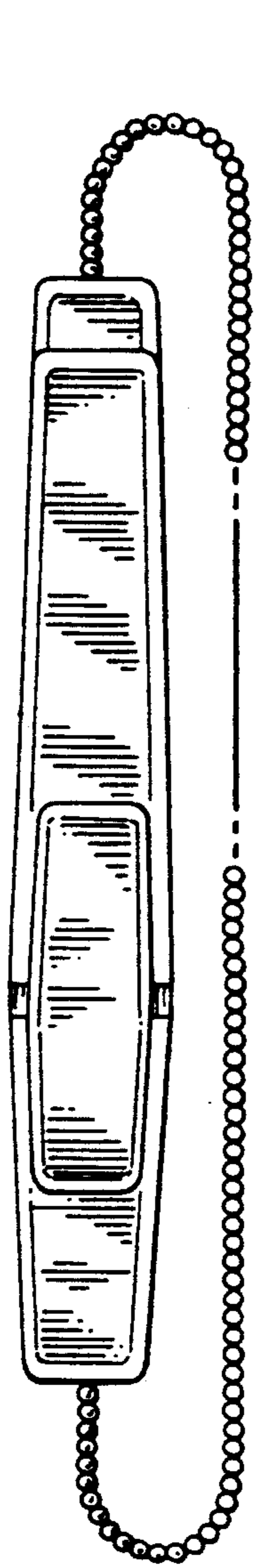

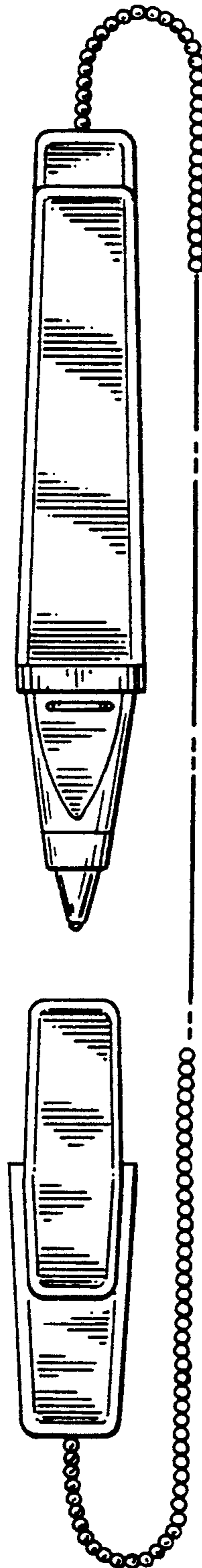

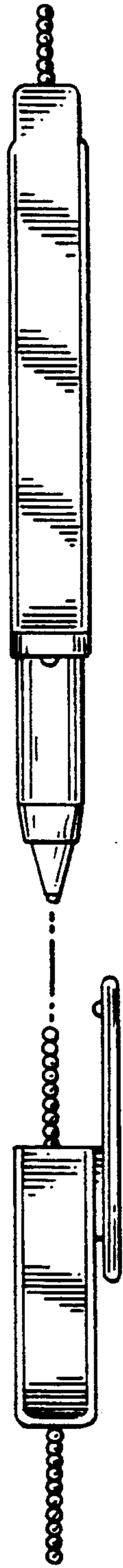

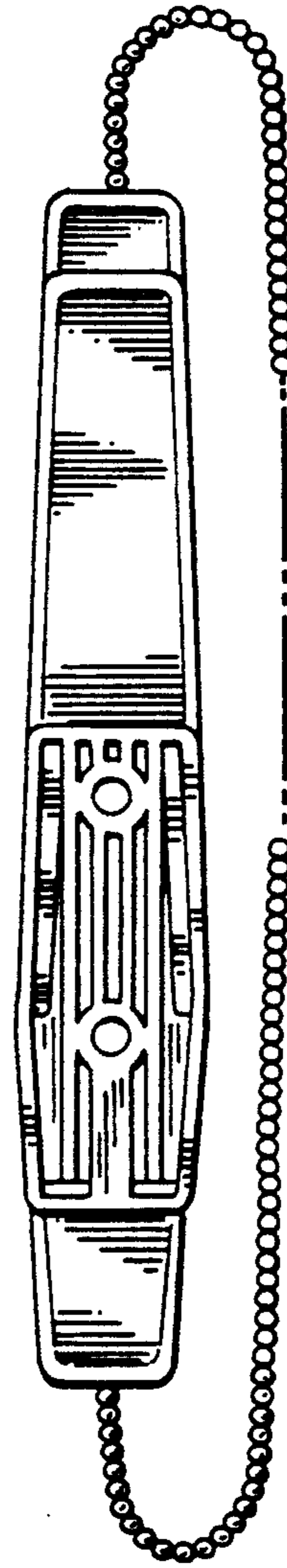

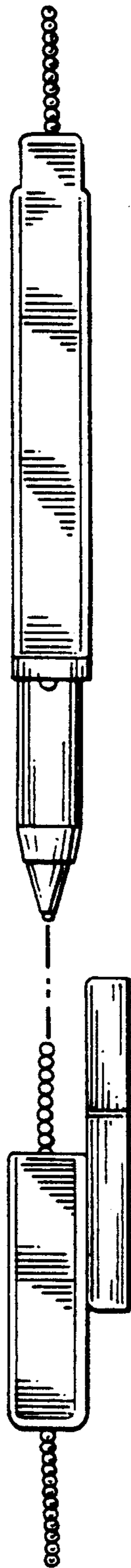

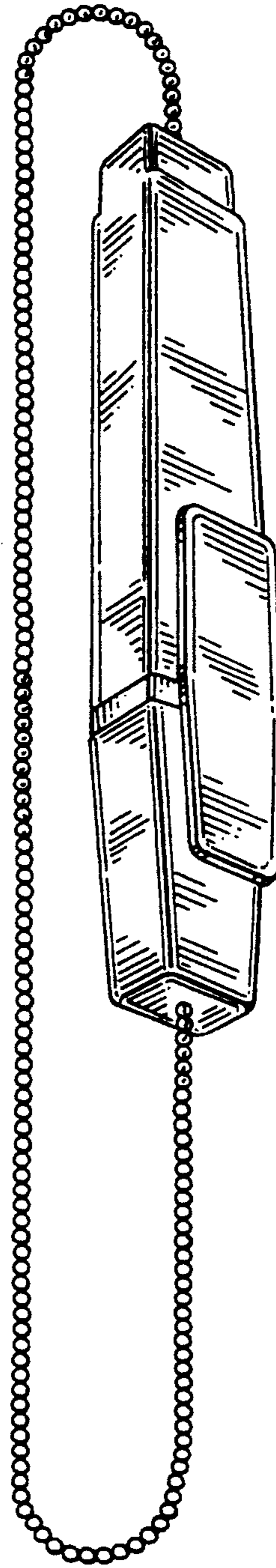

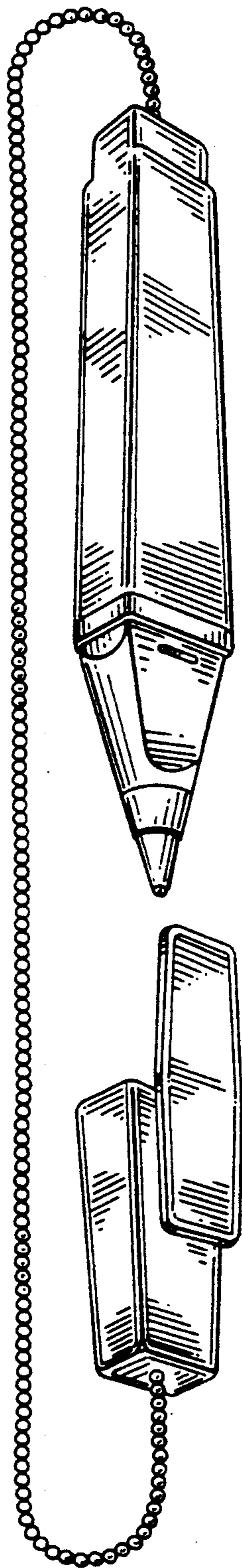
