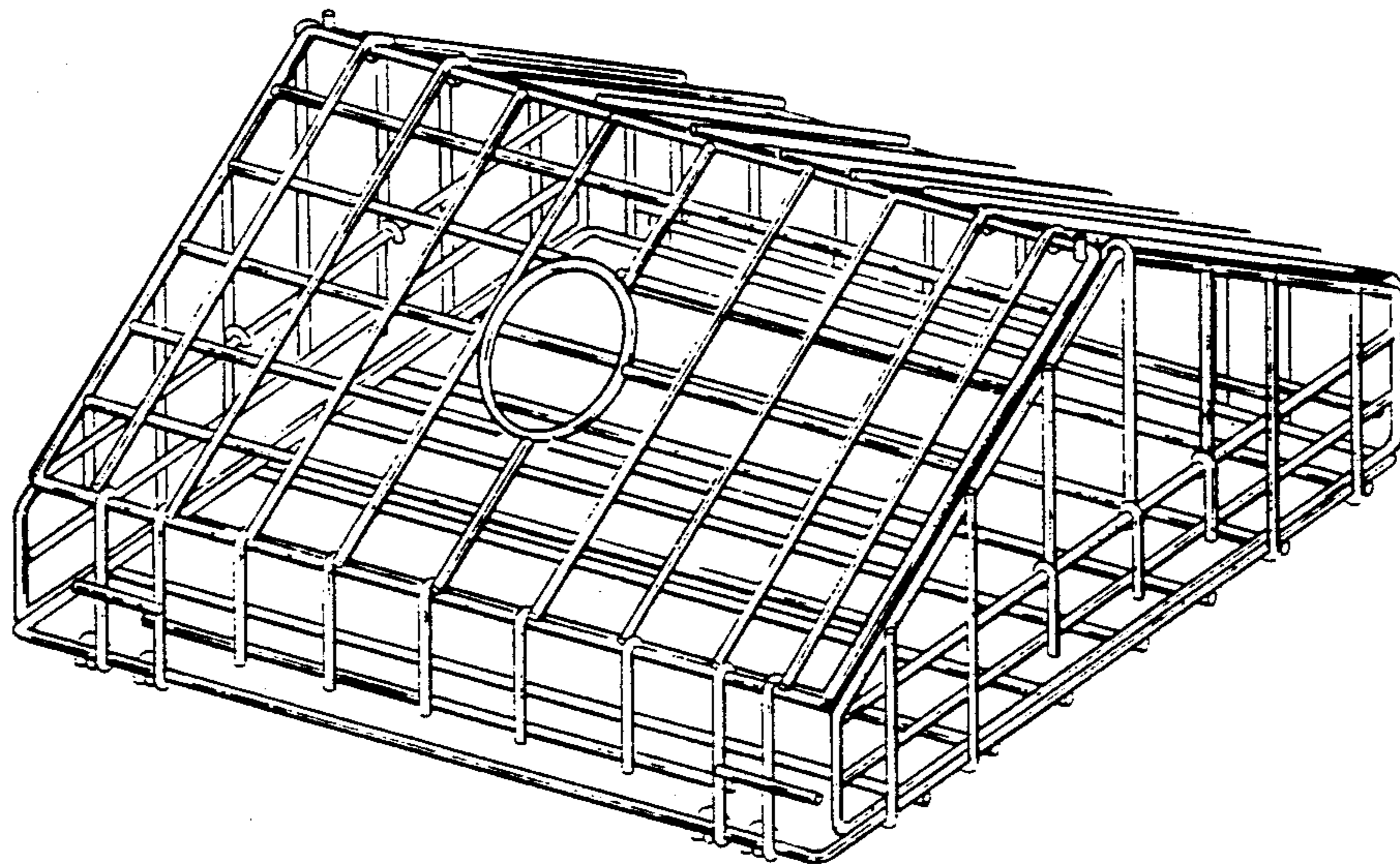

DESCRIPTION

FIG. 1 is a front perspective view of a crab trap showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a side elevational view thereof with the other side elevational view being identical; and,
FIG. 5 is a bottom view thereof.



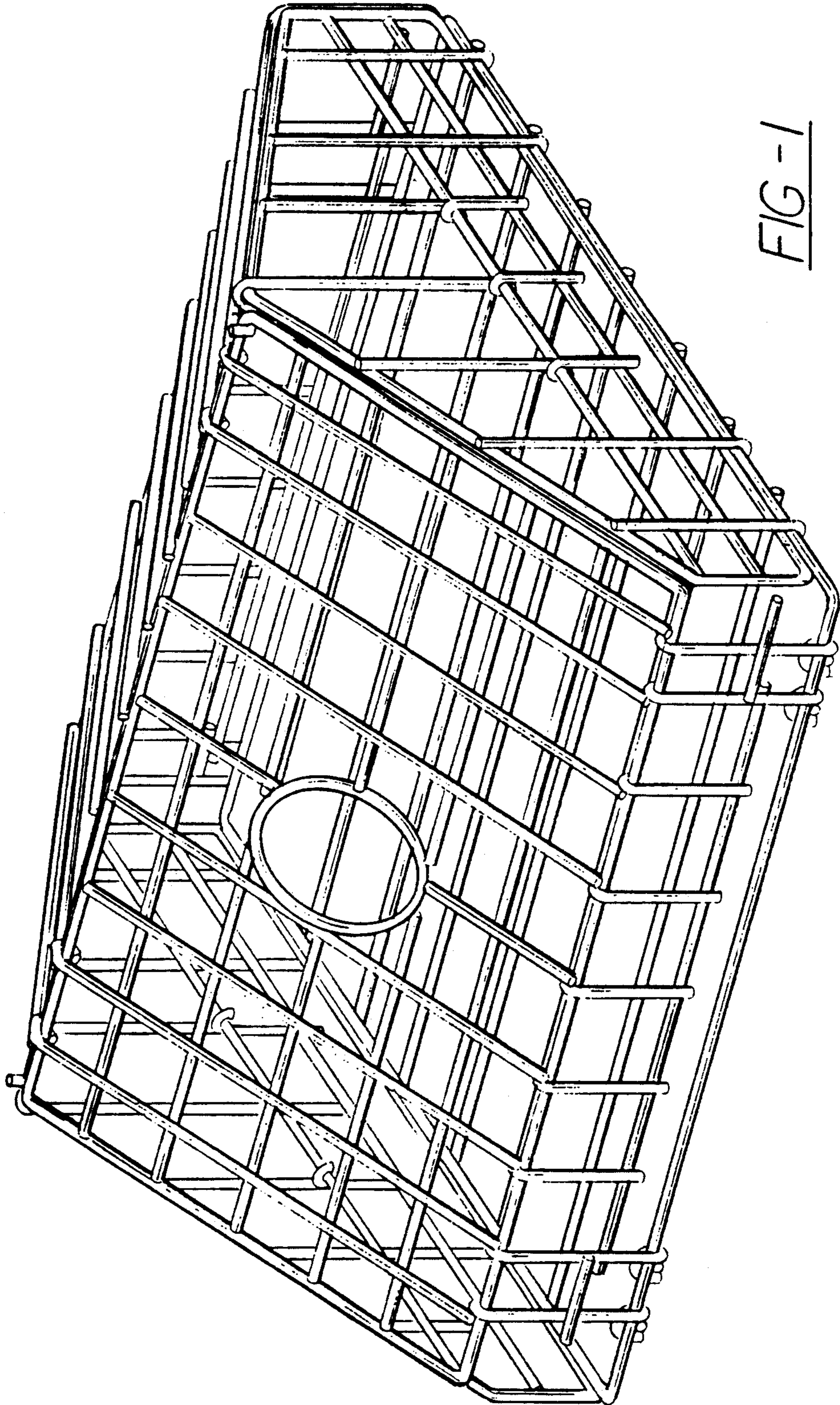

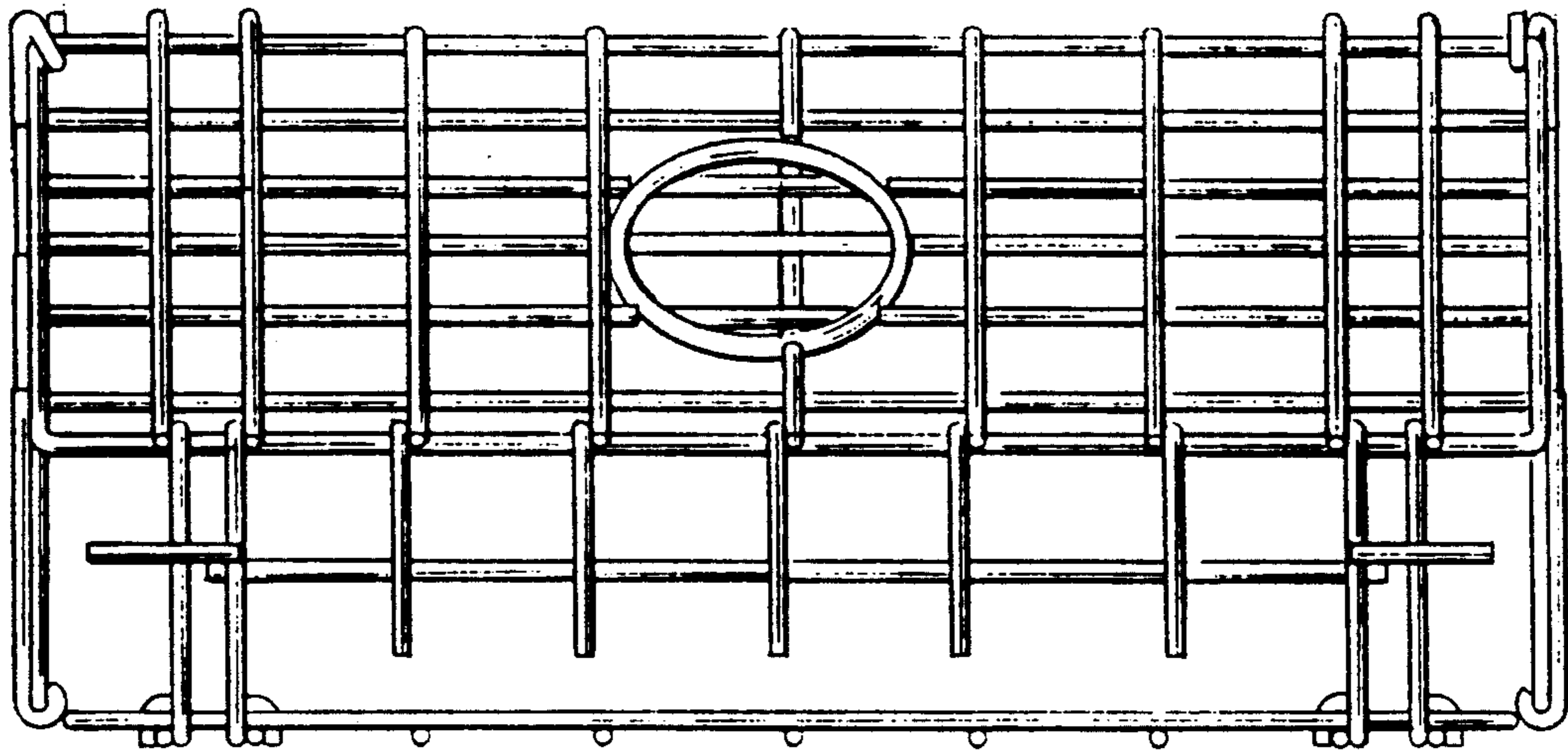

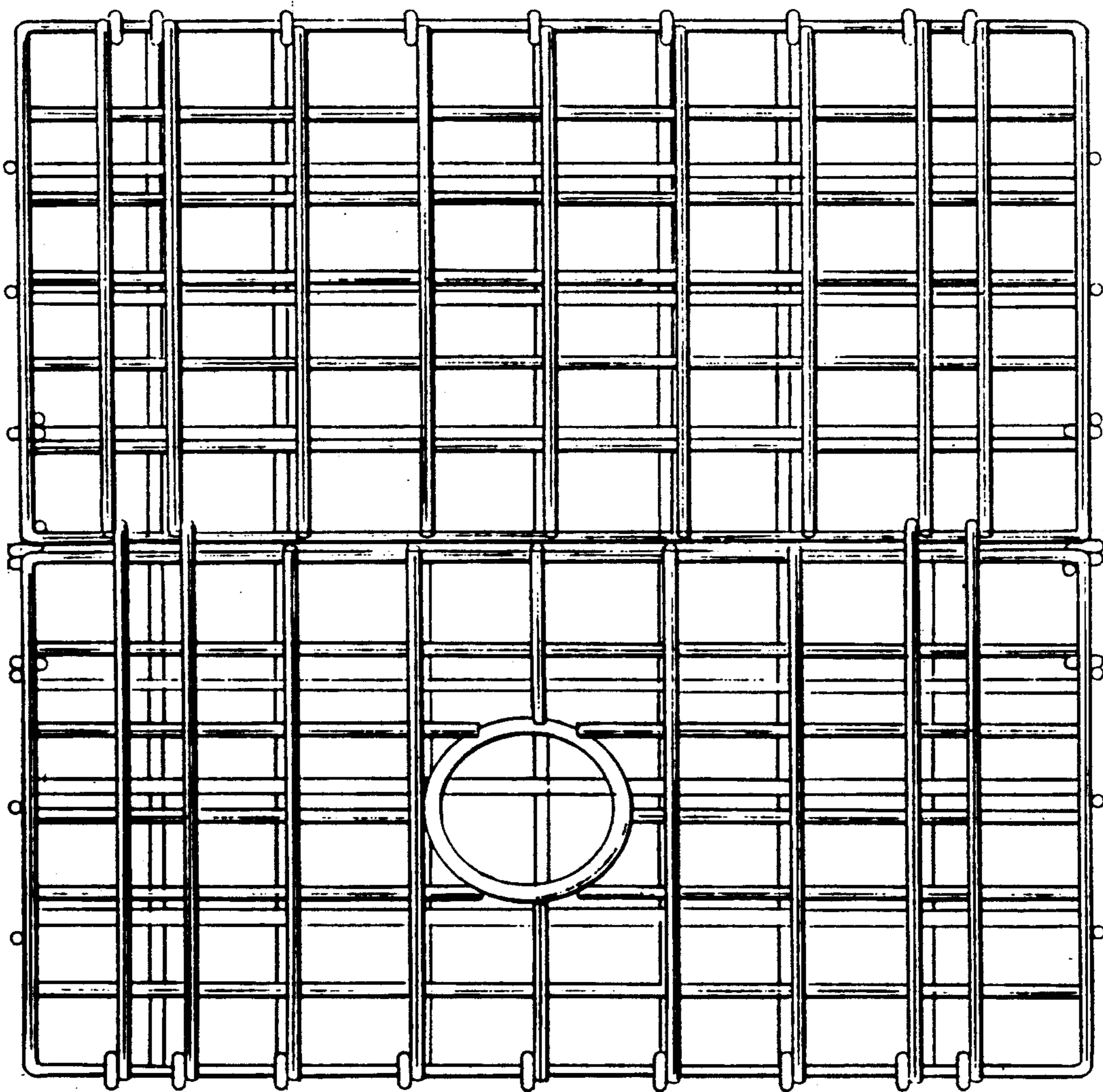

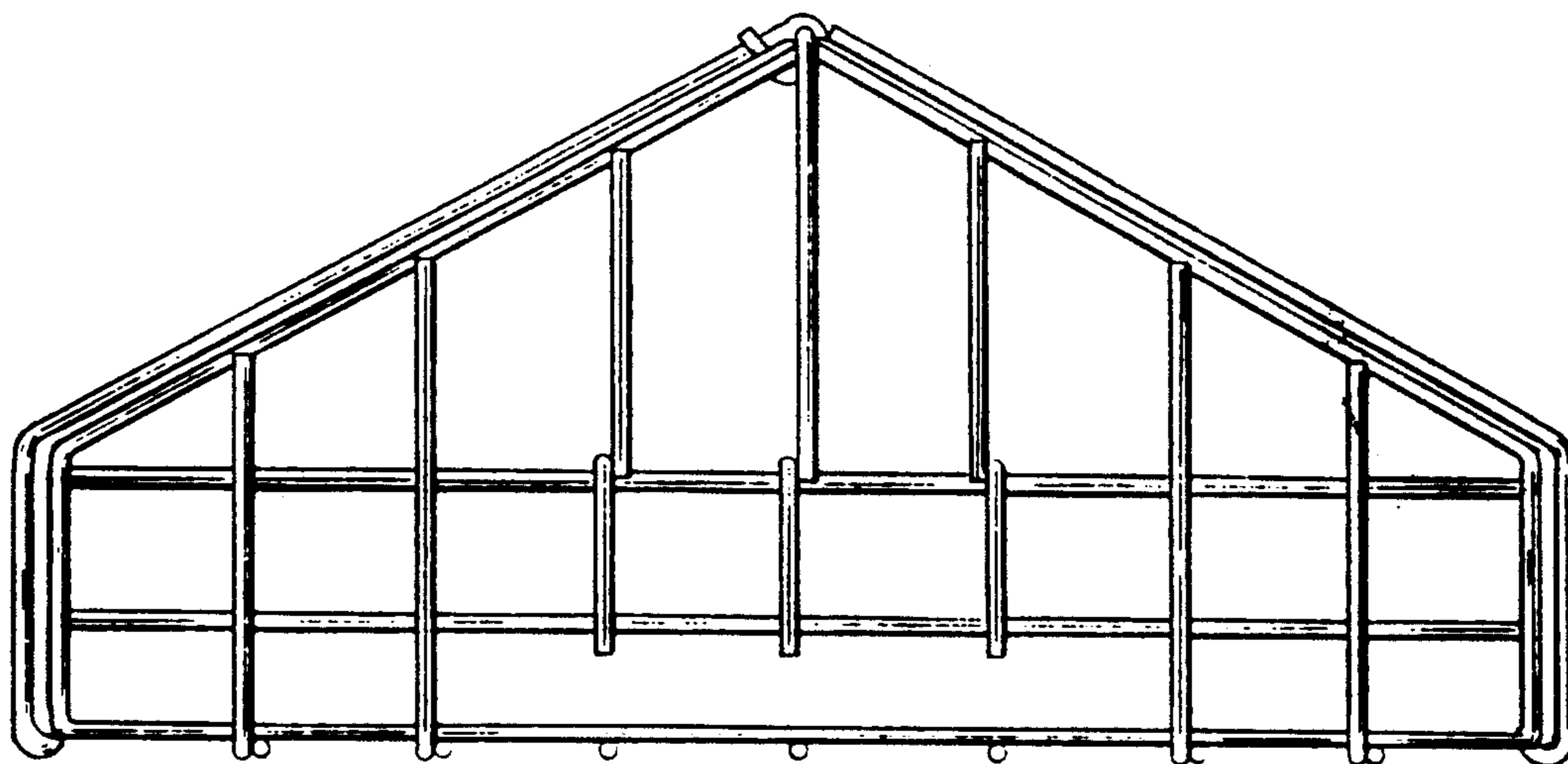

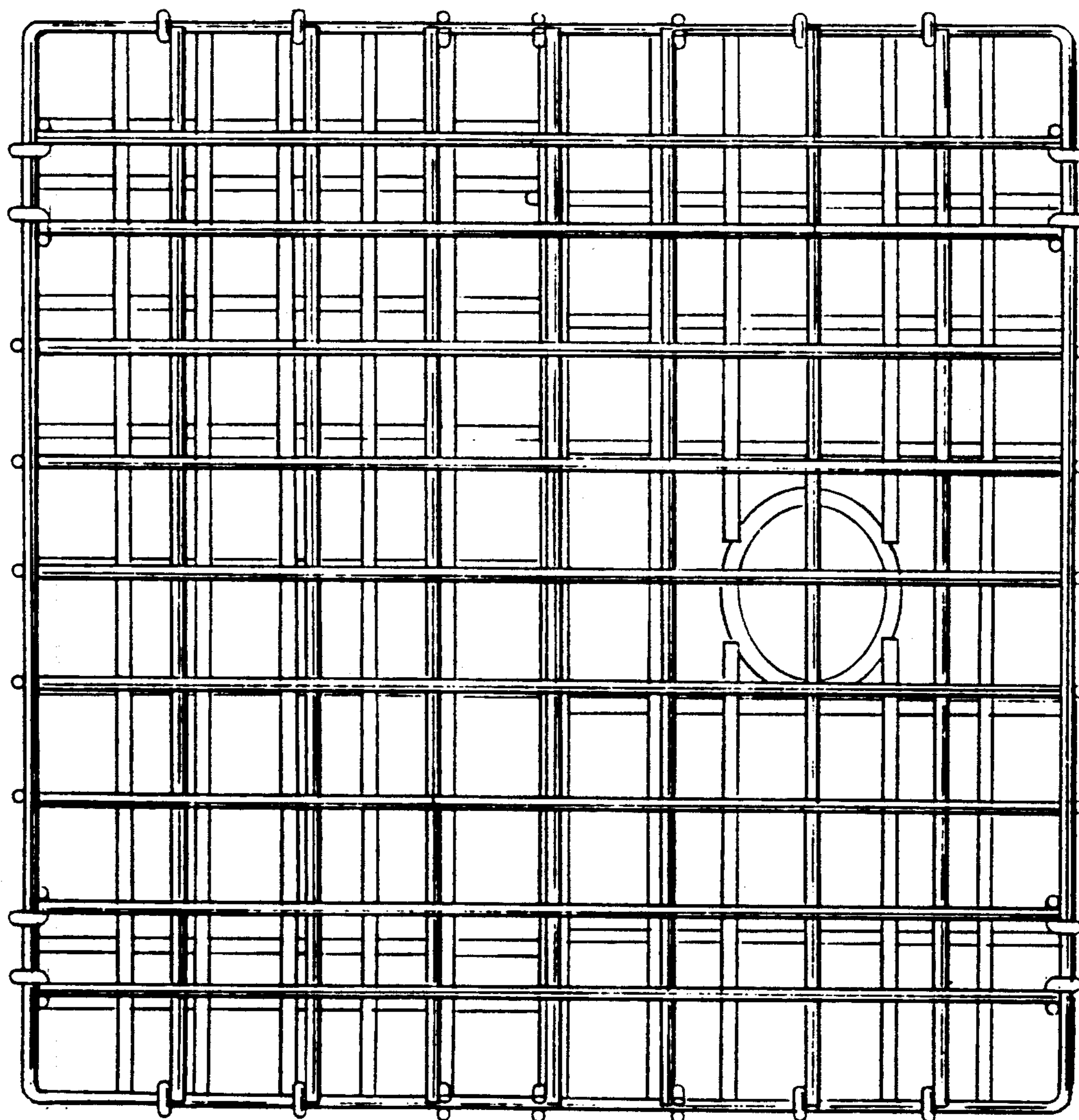
