The ornamental design for a surgical instrument actuator handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a surgical instrument actuator handle showing our new design, the broken line showing of the extension tube and surgical instrument is for illustrative purposes only and forms no part of the claimed design;

FIG. 2 is a side elevational view of FIG. 1;

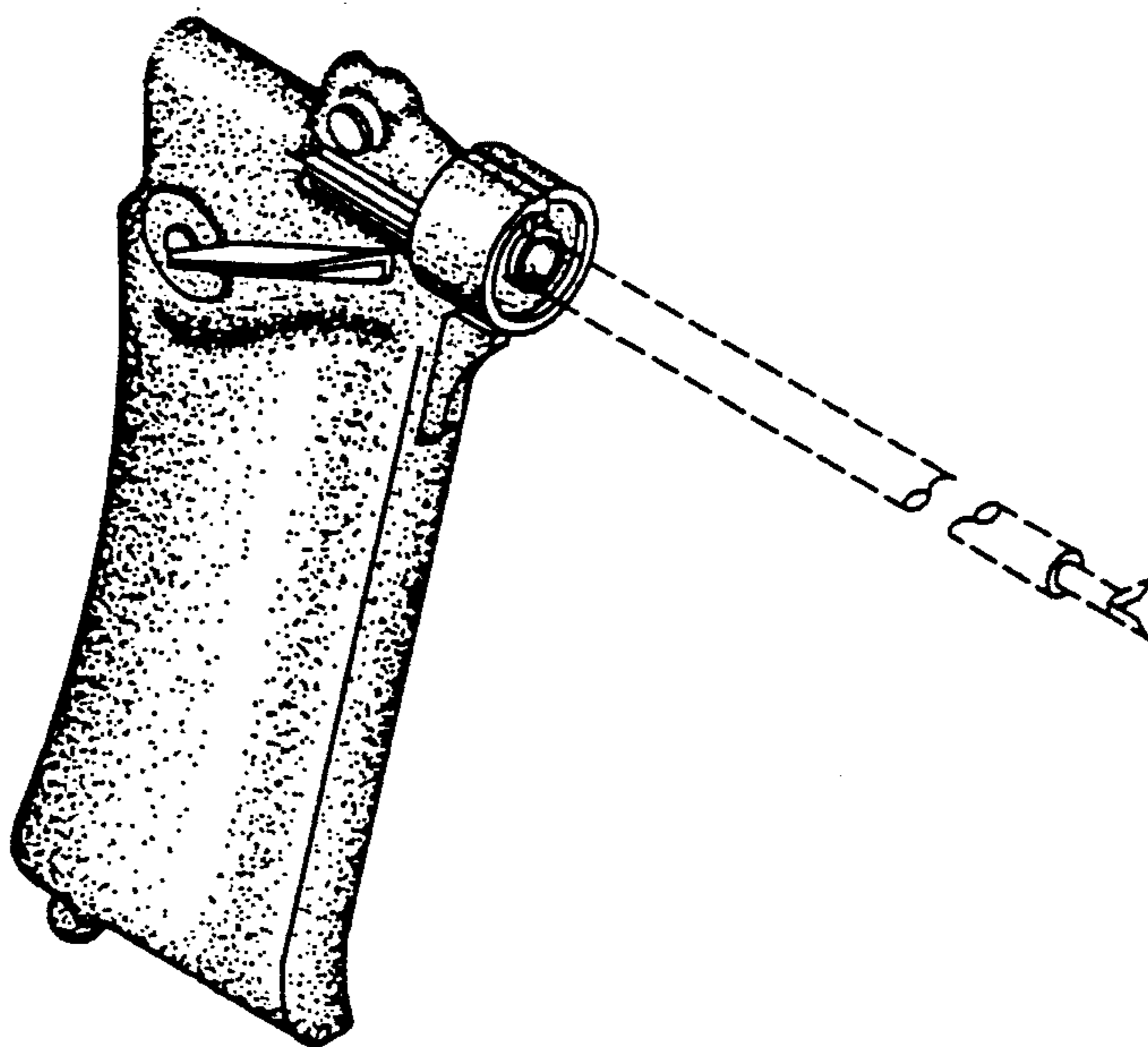
FIG. 3 is an opposite side elevational view of FIG. 1;

FIG. 7 is a bottom plan view of FIG. 1.



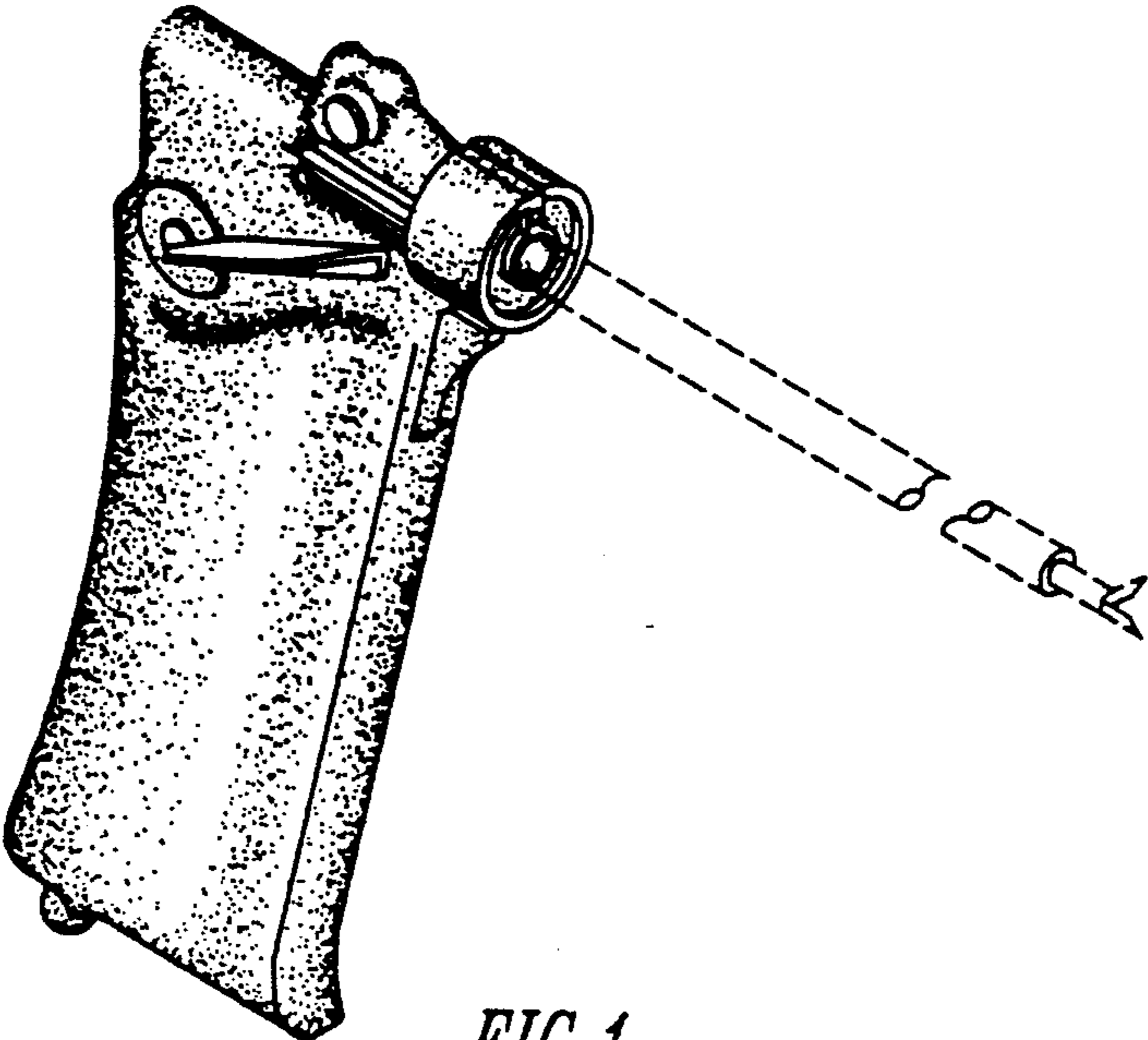

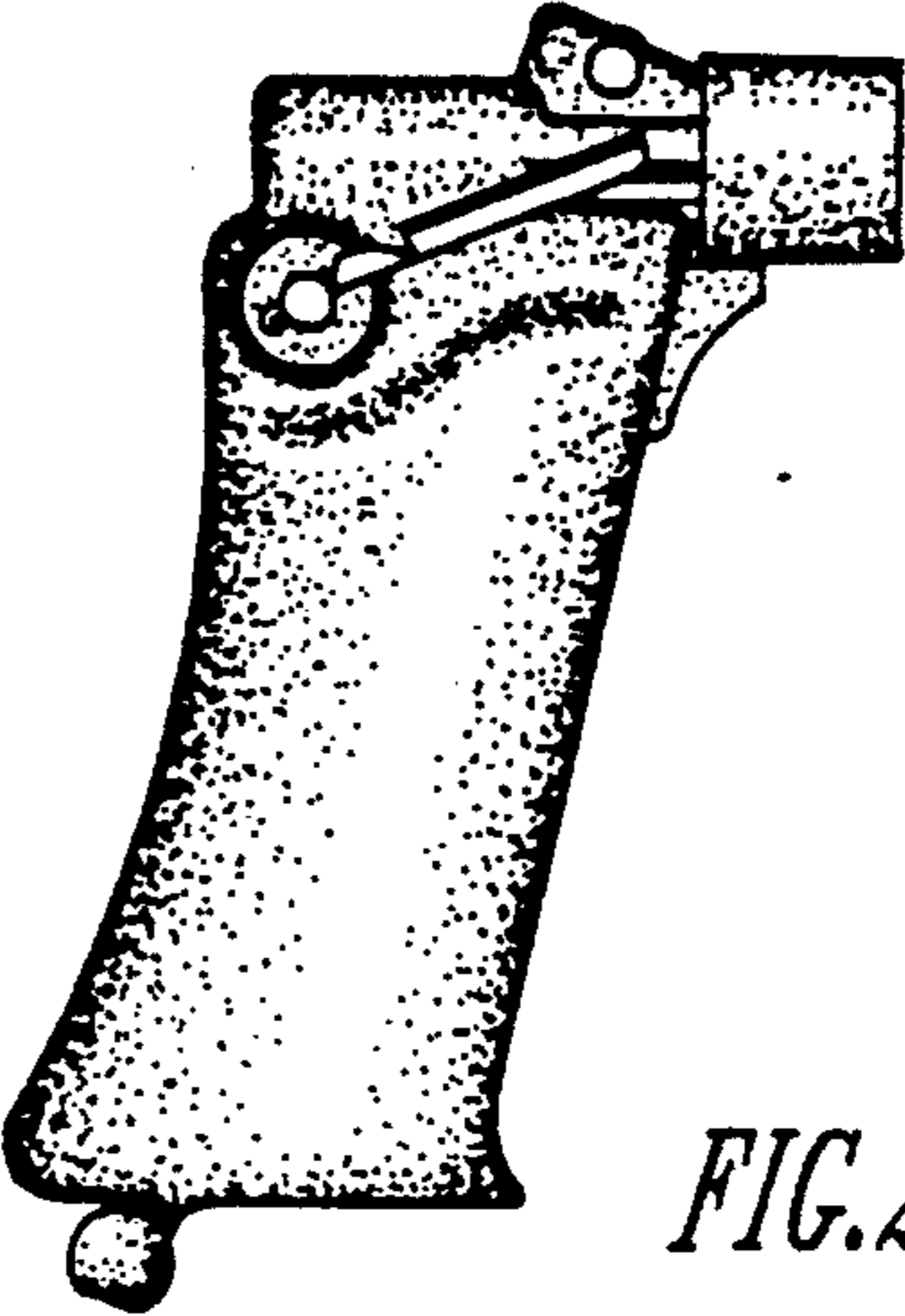

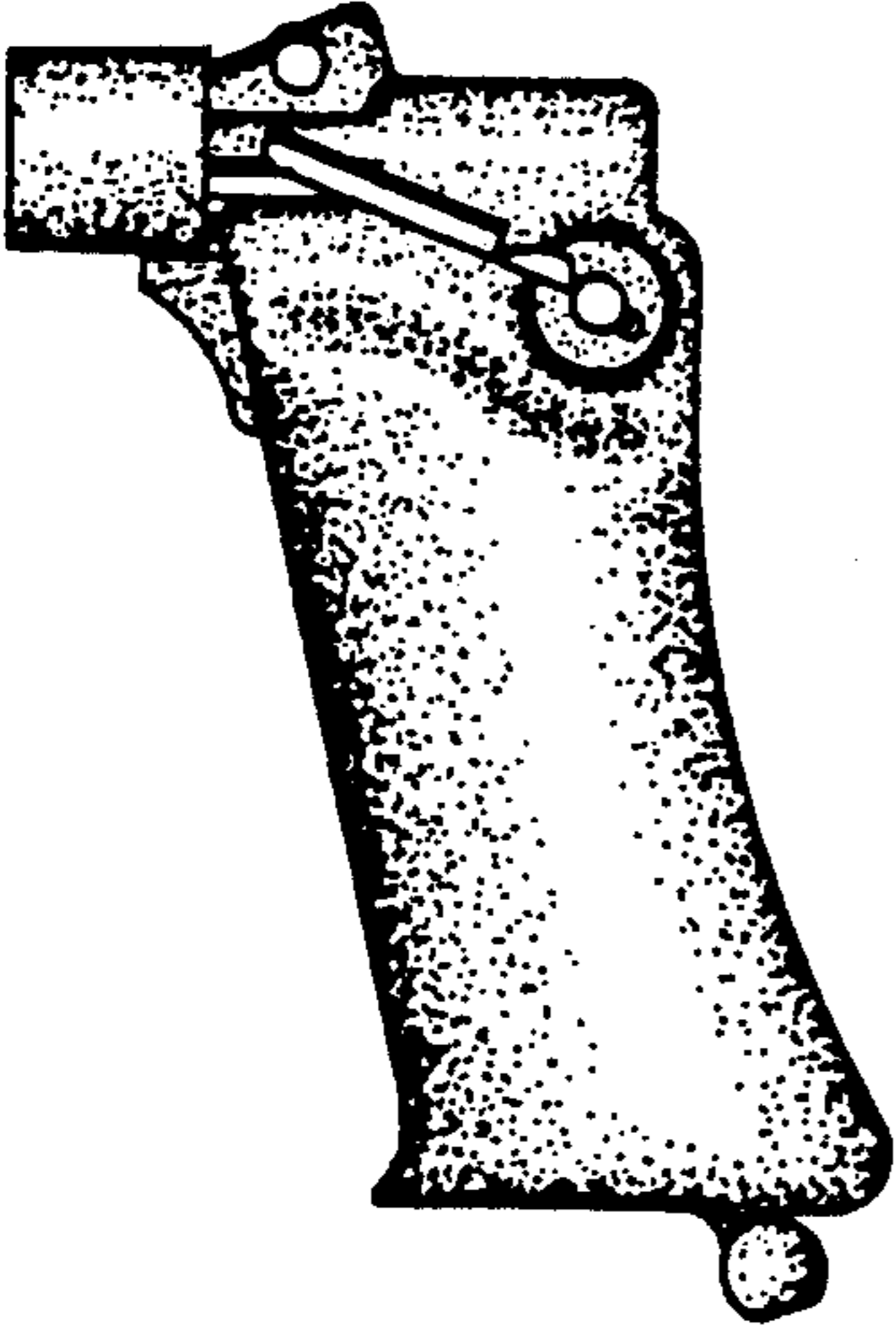

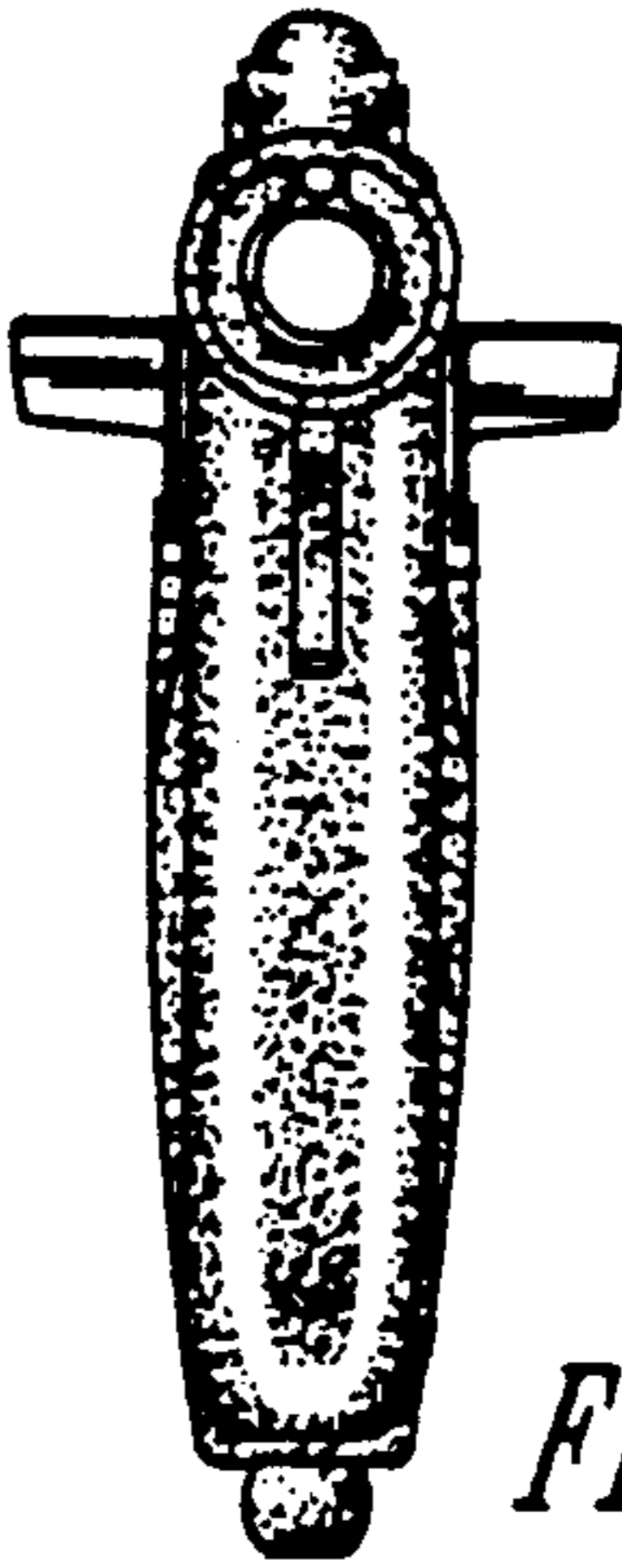

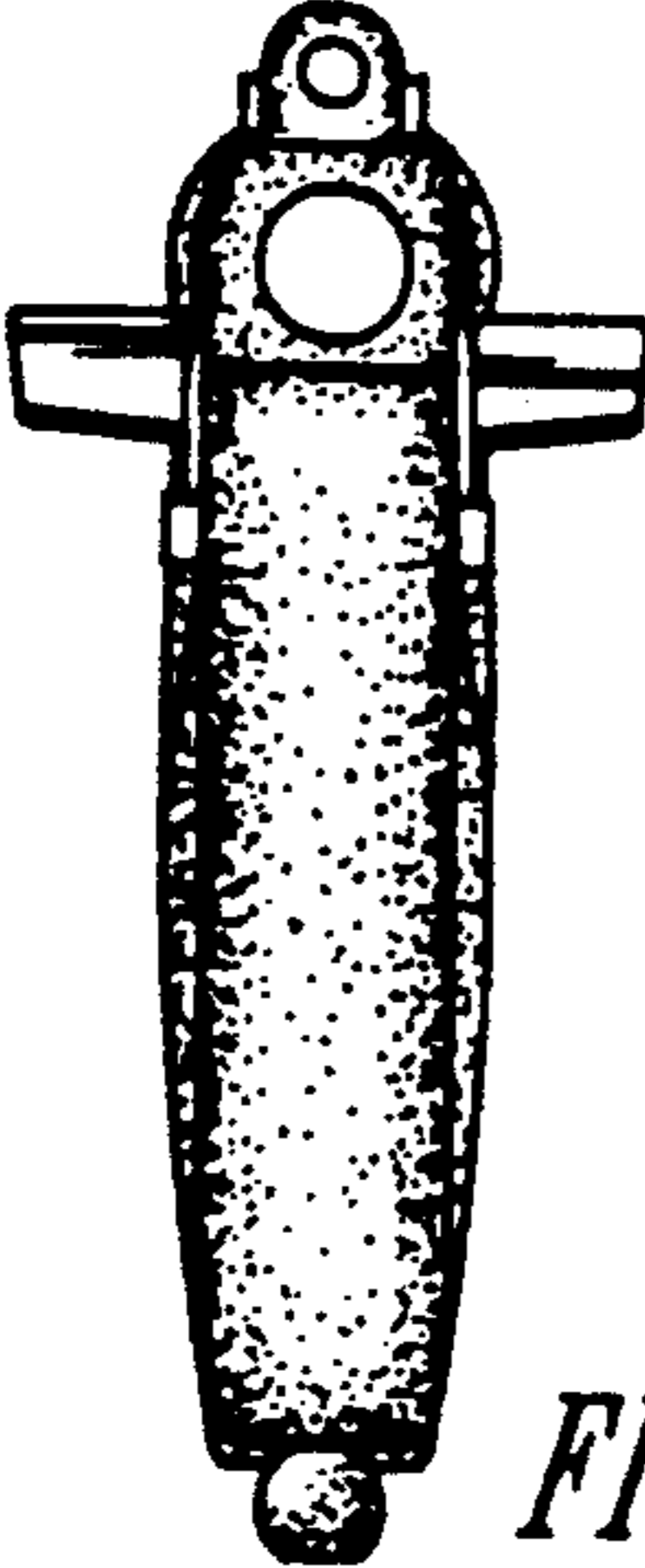

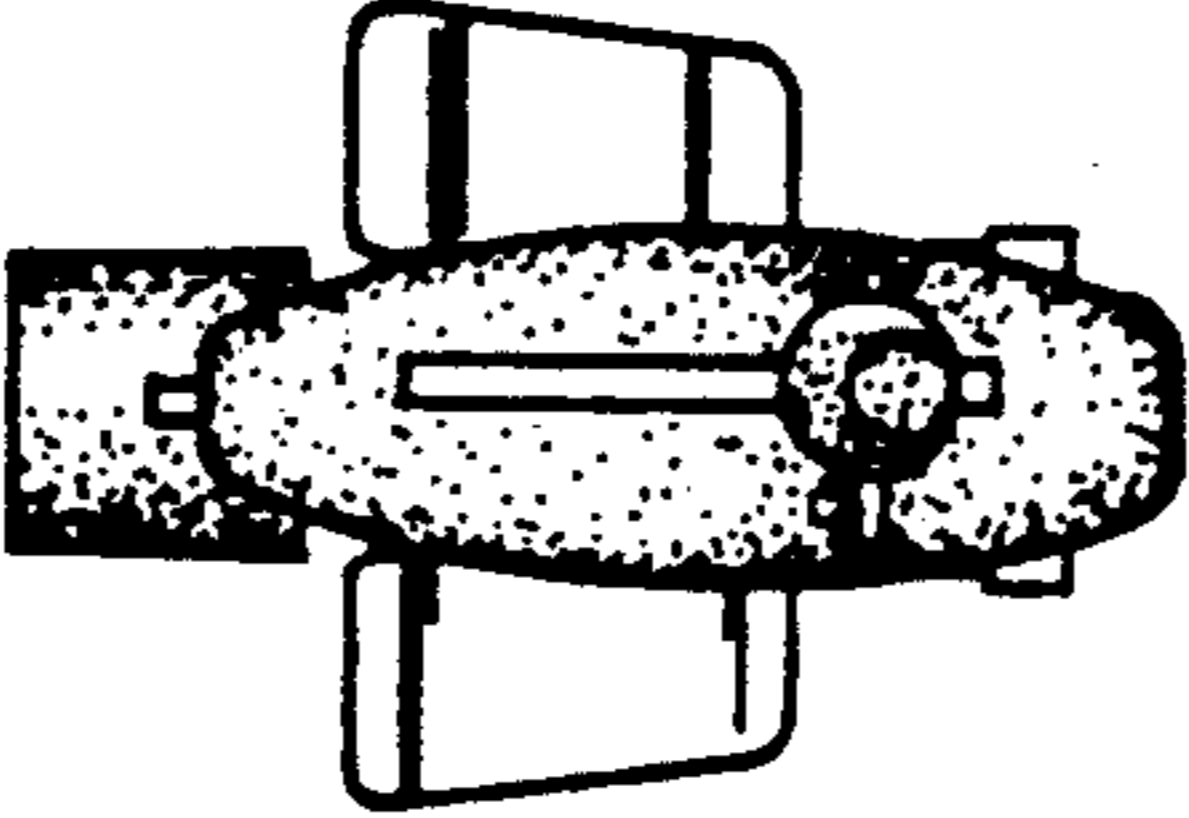

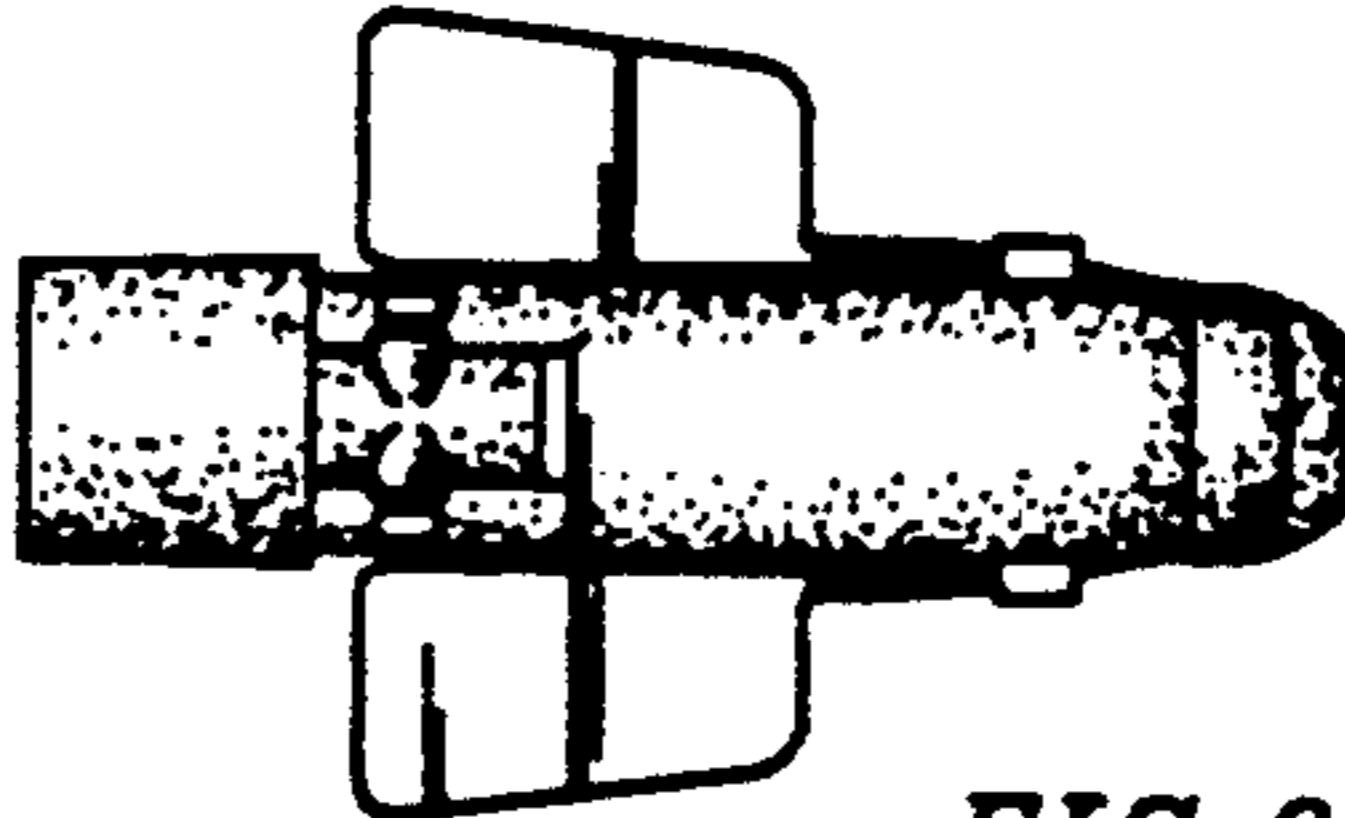
