The ornamental design for a cat carrier bag, as shown and described.

## DESCRIPTION

FIG. 1 is a front elevational view of the cat carrier bag showing my new design;  
FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a left side elevational view thereof;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a slightly enlarged top plan view thereof;  
FIG. 6 is a slightly enlarged bottom plan view thereof;  
and,  
FIG. 7 is a slightly enlarged perspective view showing a use thereof.  
The broken lines are for the purposes of illustration only and form no part of the claimed design.



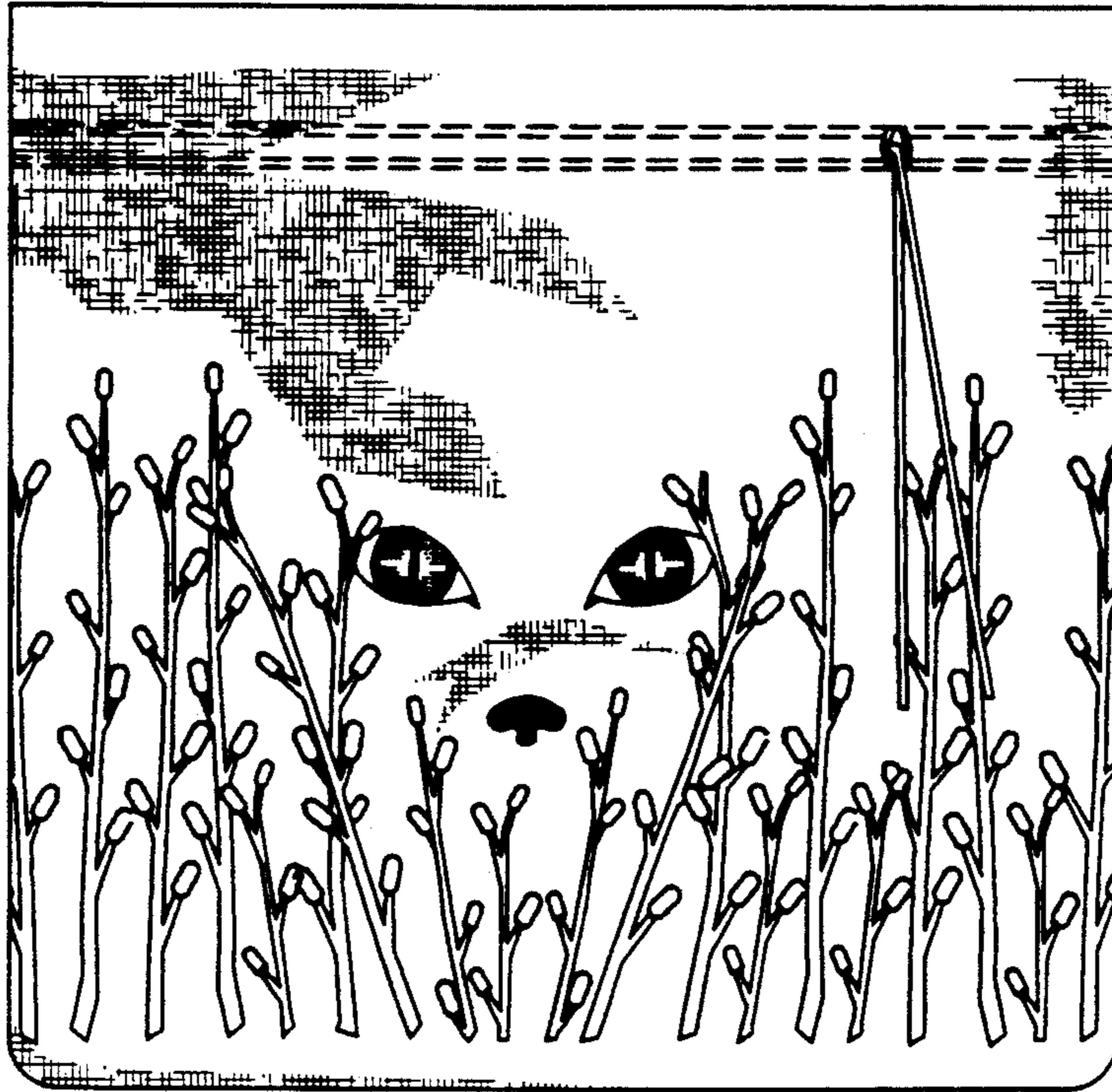

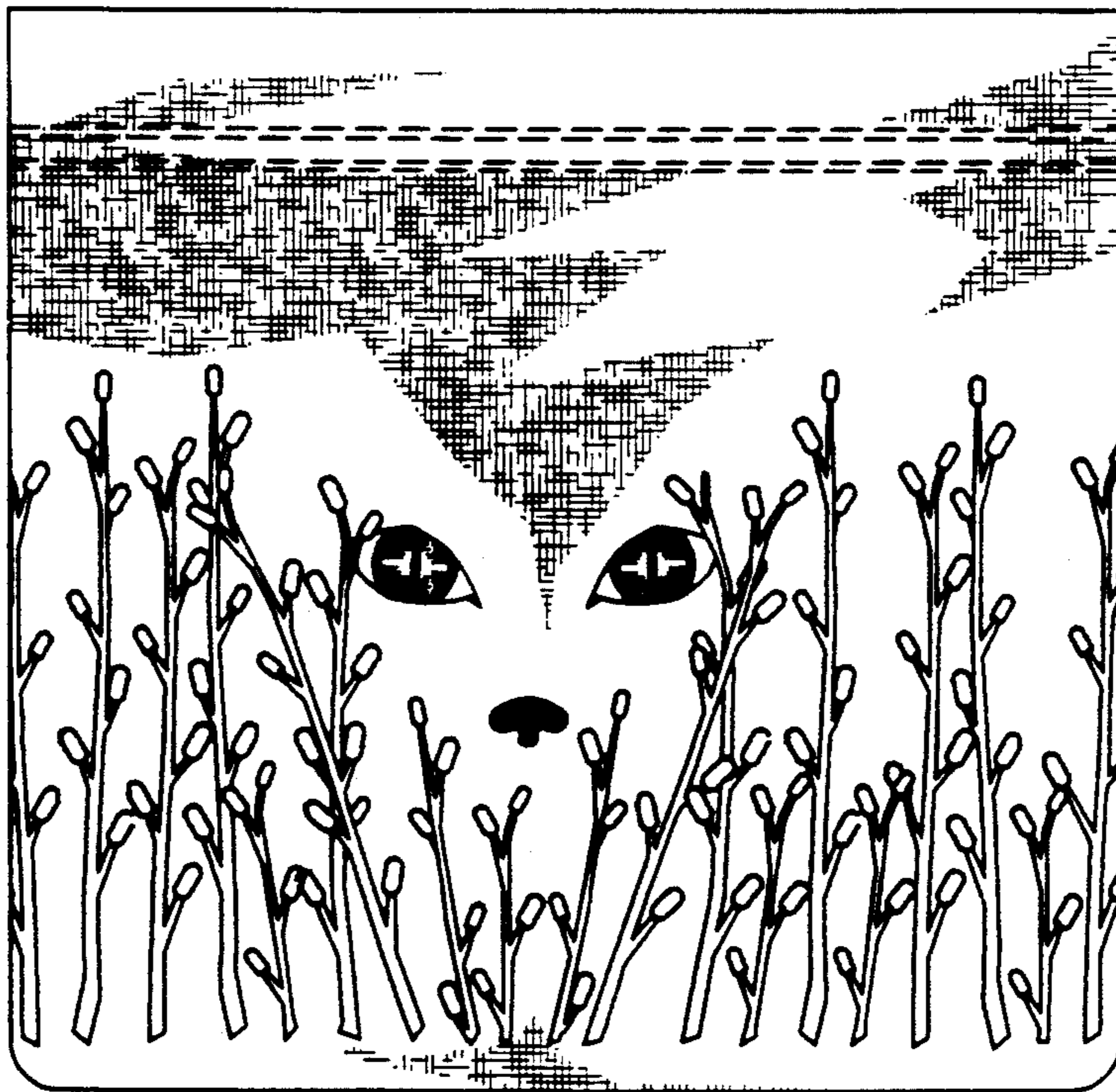

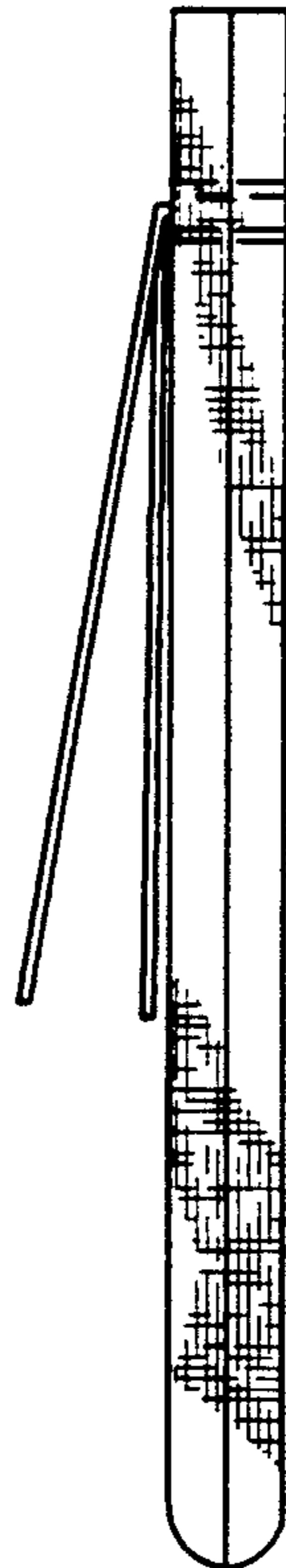
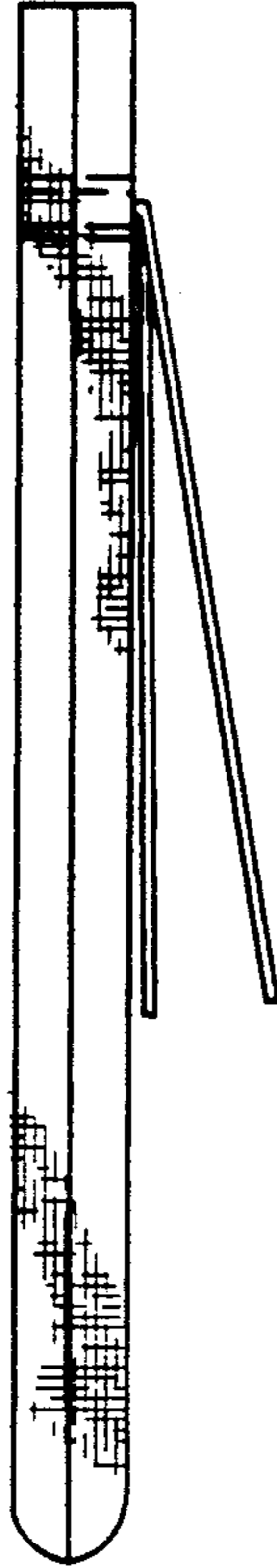
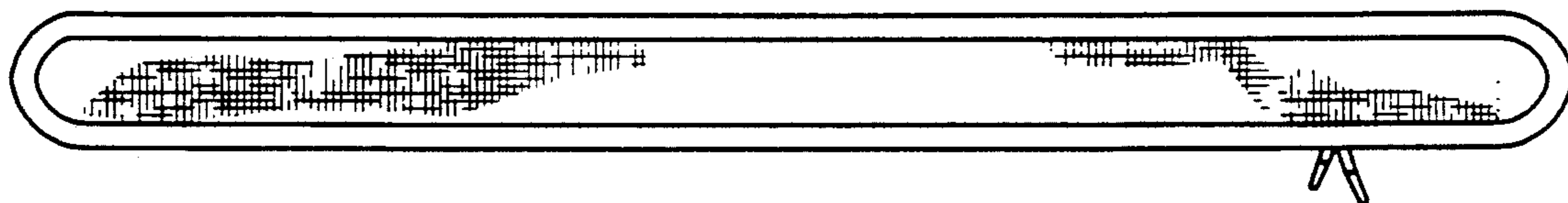
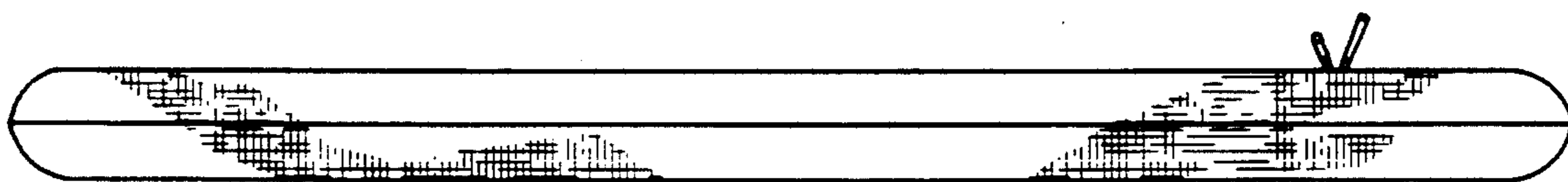
