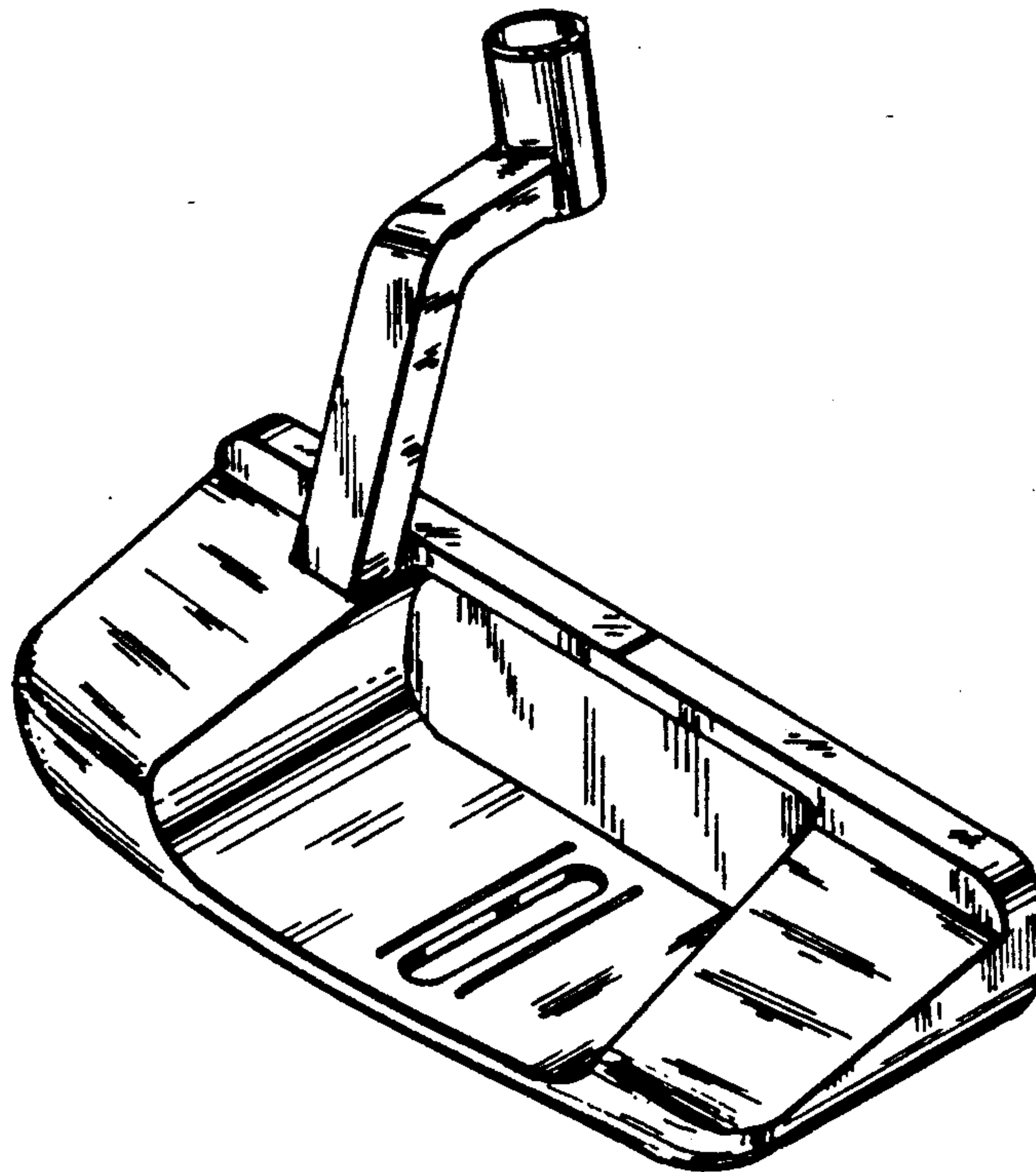

[57] **CLAIM**

The ornamental design for a golf club putter head, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a golf club putter head embodying my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a side elevational view thereof;
 FIG. 6 is a side elevational view thereof of the side opposite of that shown in FIG. 5;
 FIG. 7 is a bottom plan view thereof;
 FIG. 8 is a top plan view of a second embodiment of the golf club putter head embodying my new design;
 FIG. 9 is a bottom plan view of the second embodiment shown in FIG. 8;
 FIG. 10 is a top plan view of a third embodiment of a golf club putter head embodying my new design;
 FIG. 11 is a bottom plan view of the third embodiment shown in FIG. 10;
 FIG. 12 is a top plan view of a fourth embodiment of a golf club putter head embodying my new design;
 FIG. 13 is a bottom plan view of the fourth embodiment shown in FIG. 12;
 FIG. 14 is a top plan view of a fifth embodiment of the golf club putter head embodying my new design; and,
 FIG. 15 is a bottom plan view of the fifth embodiment shown in FIG. 14.



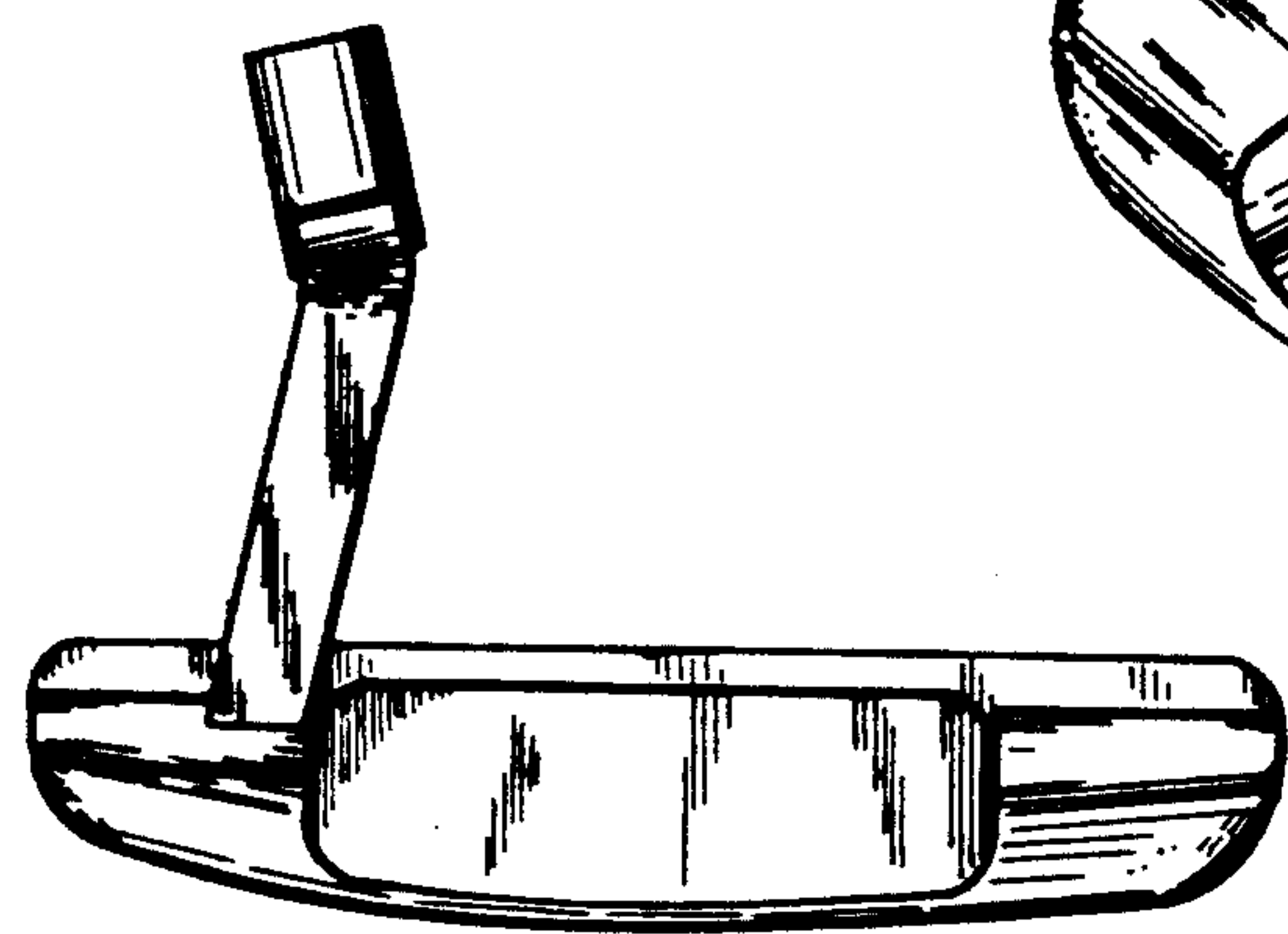
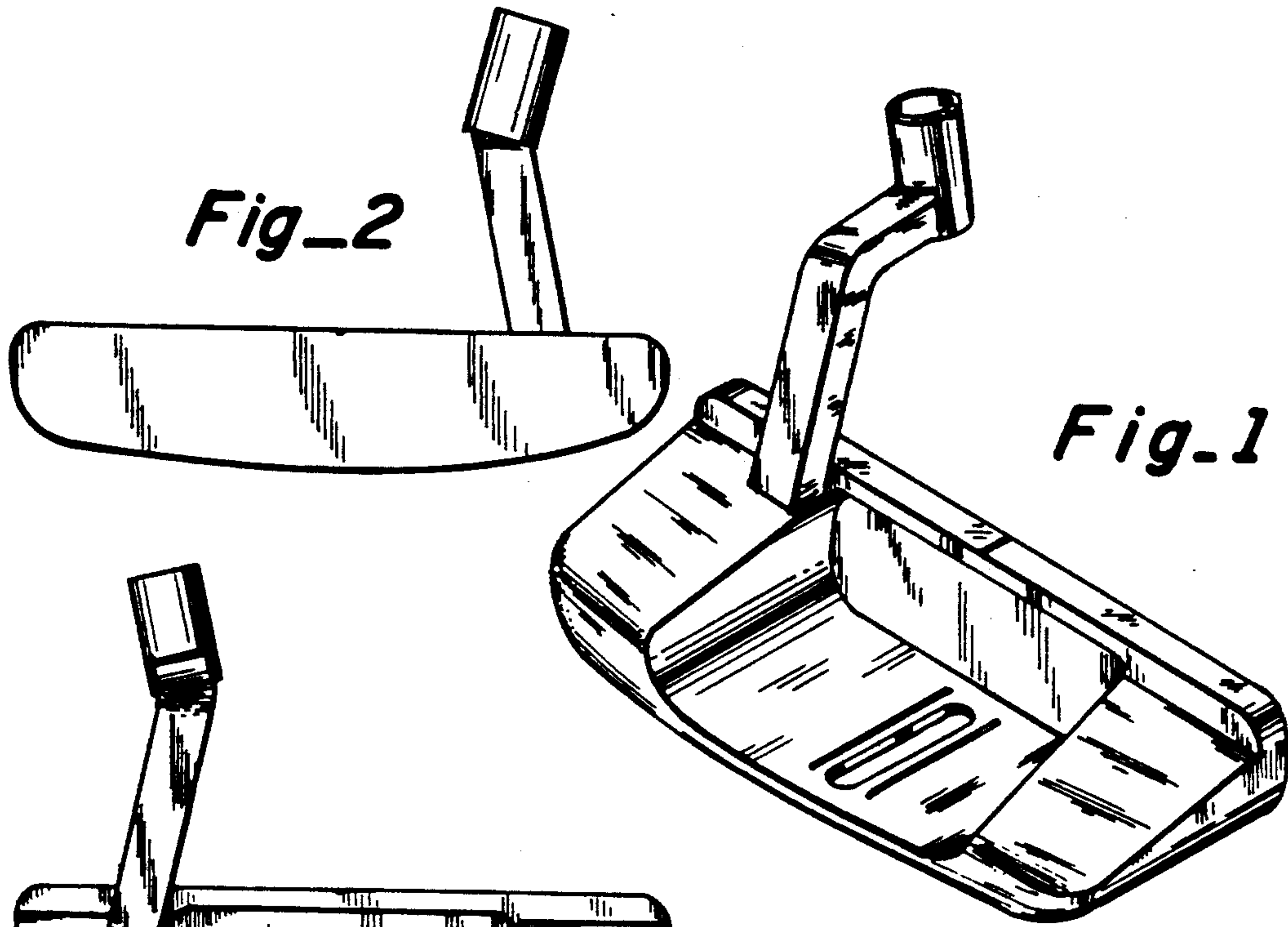

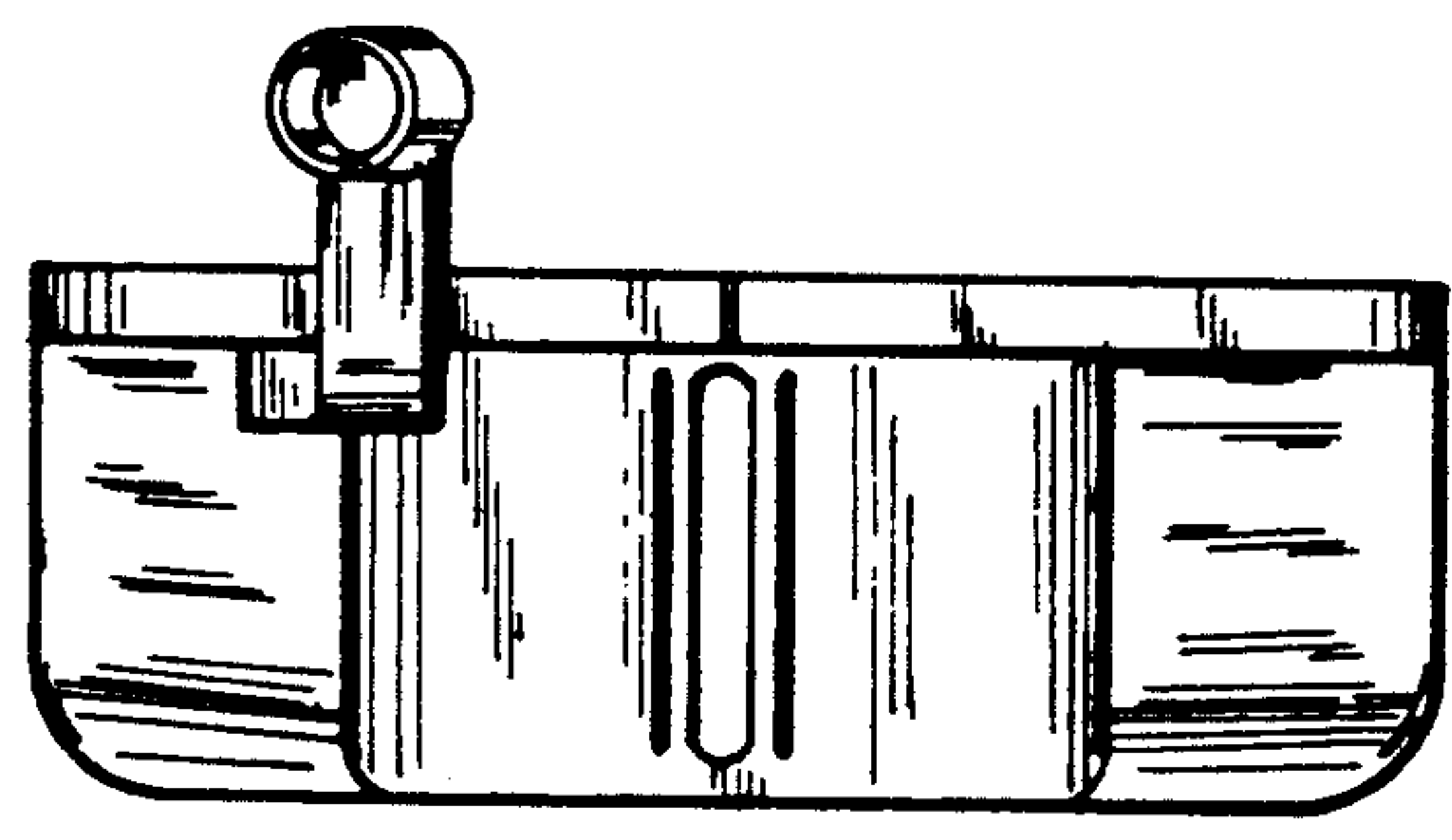

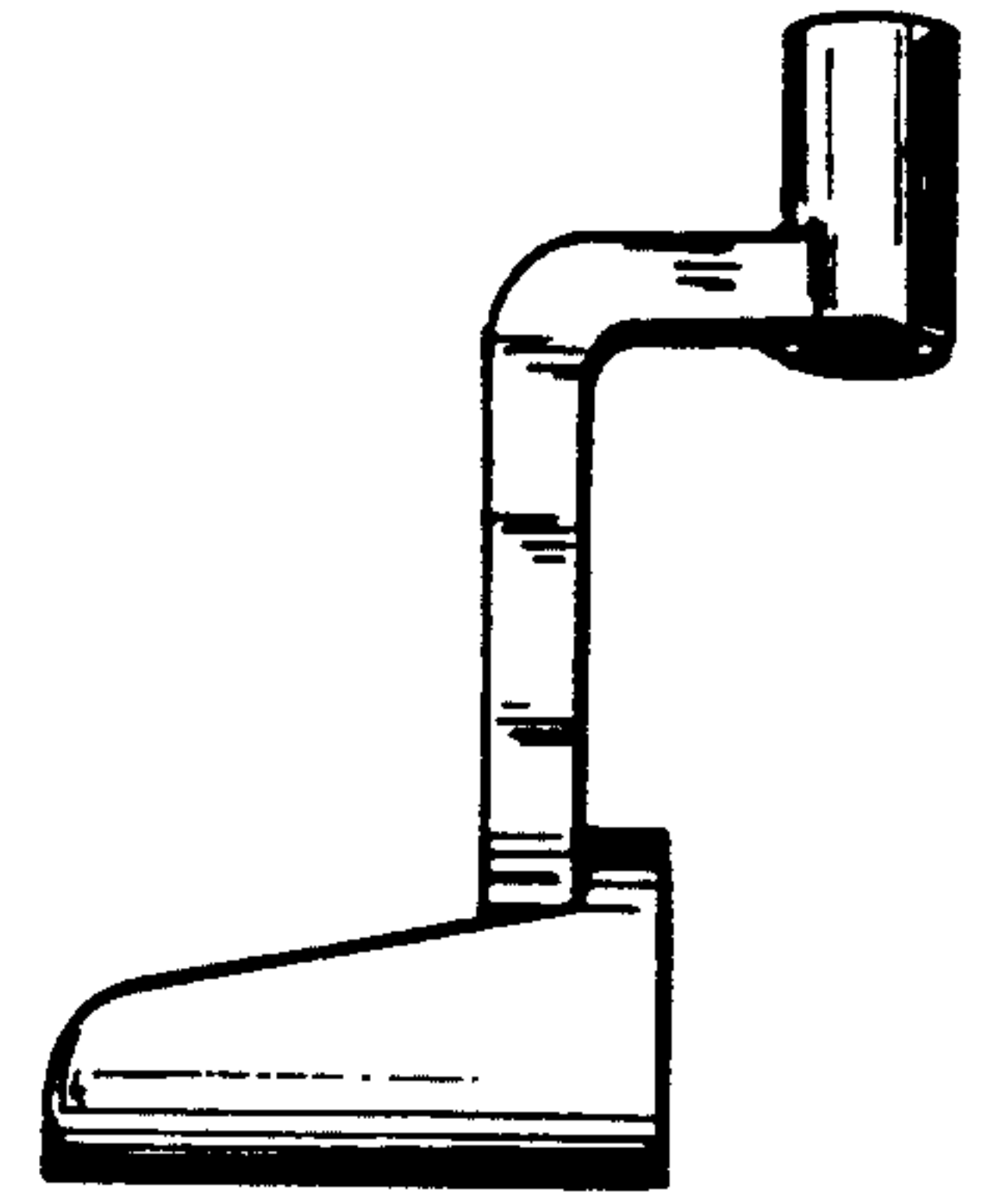

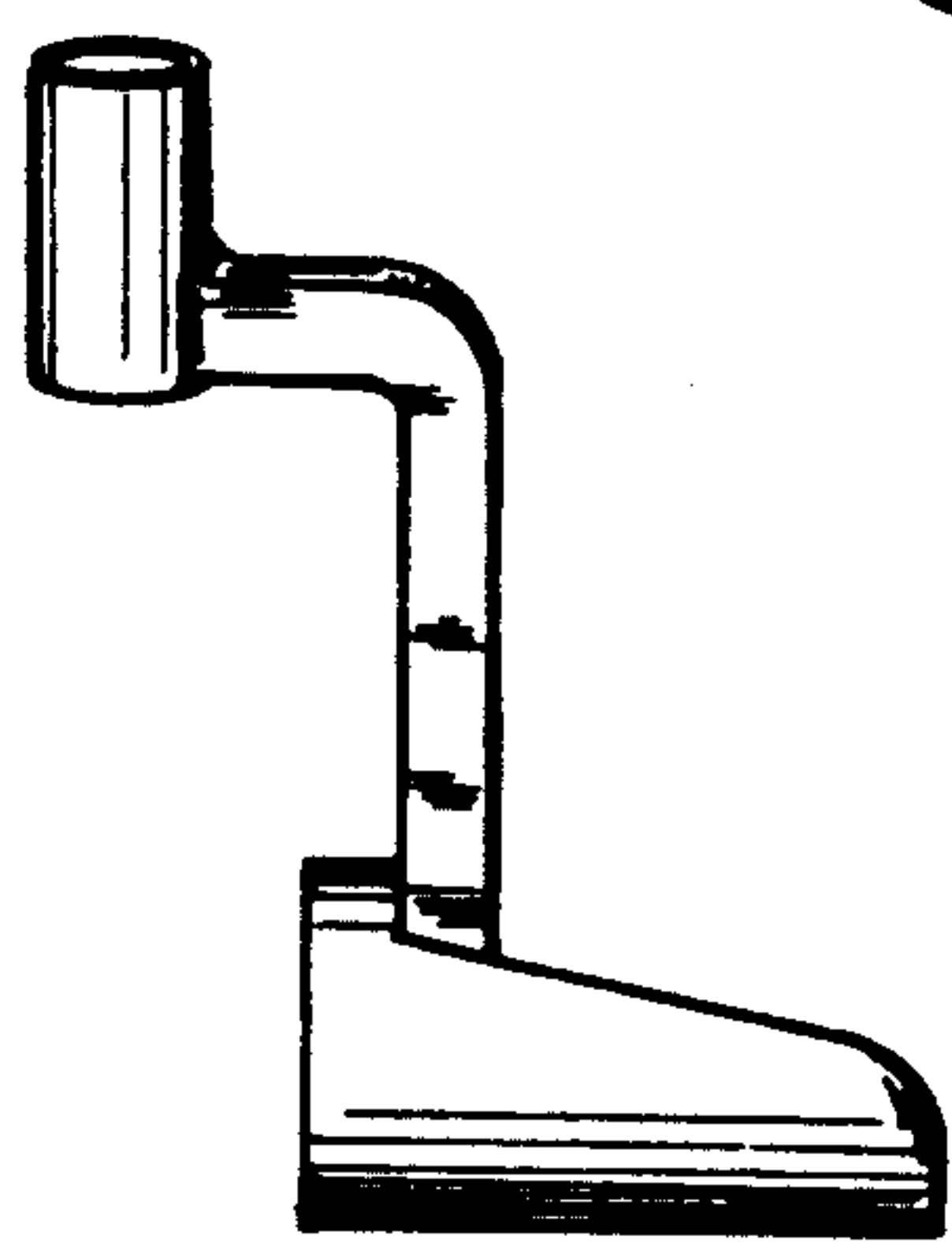

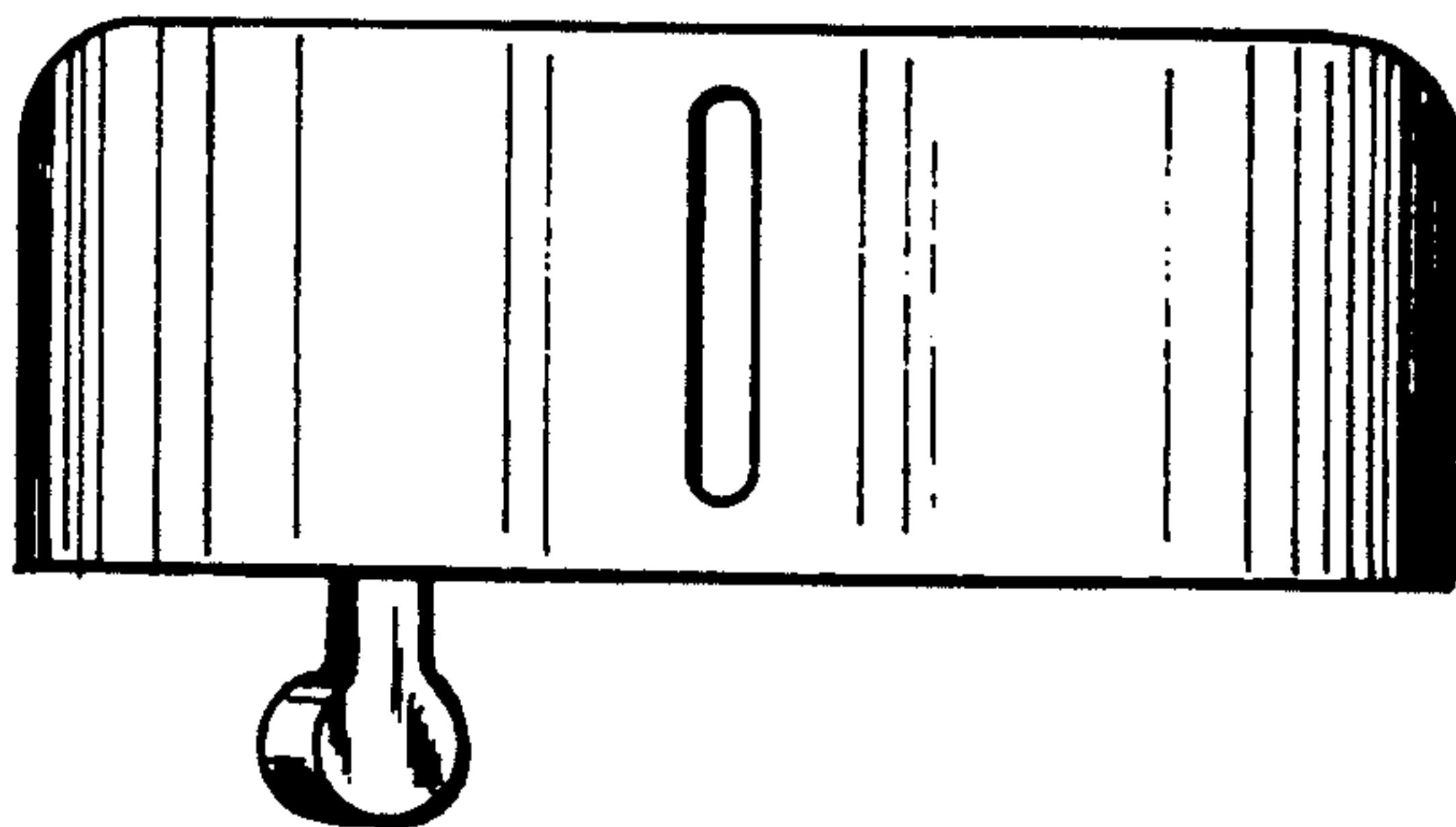
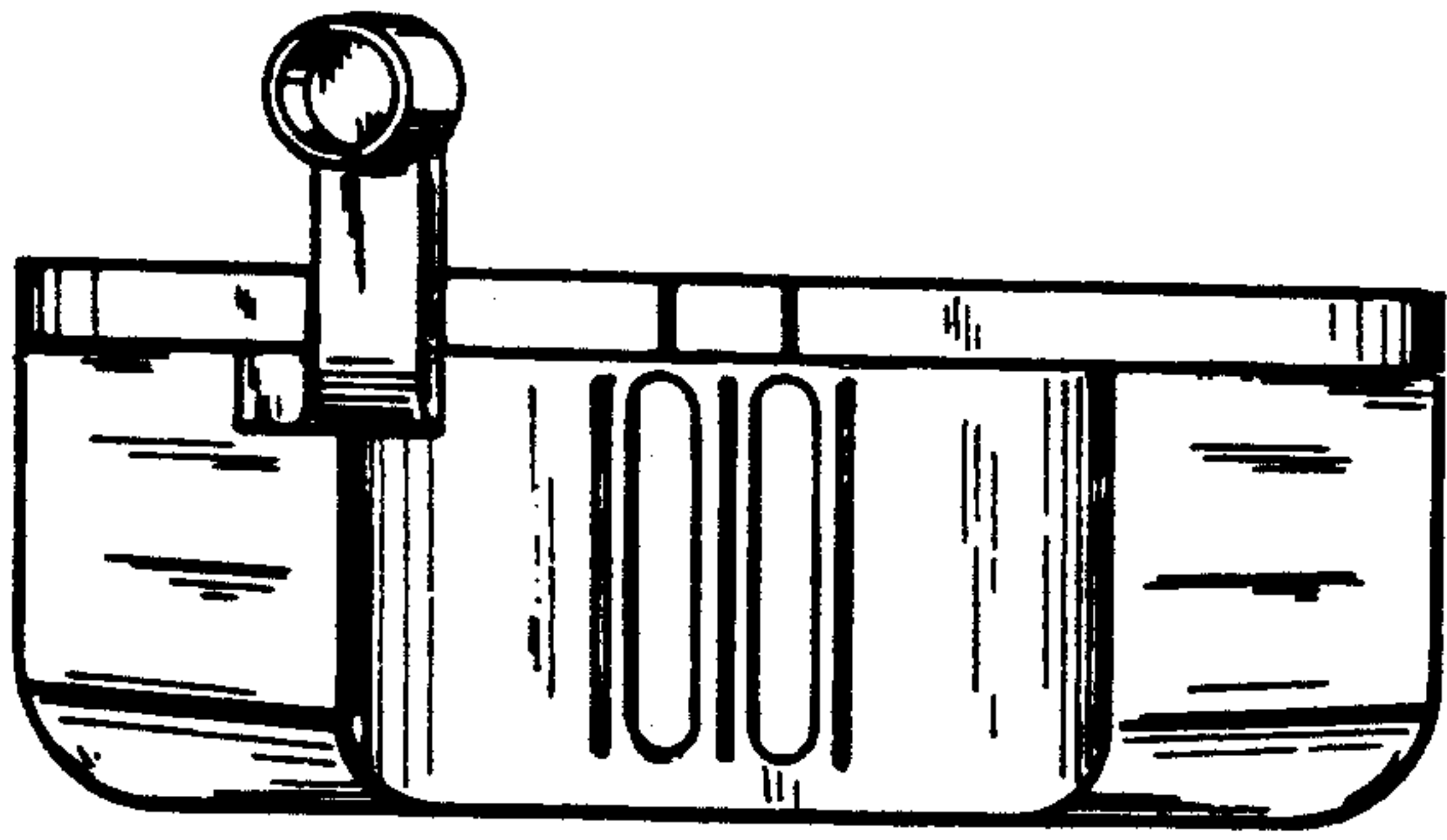
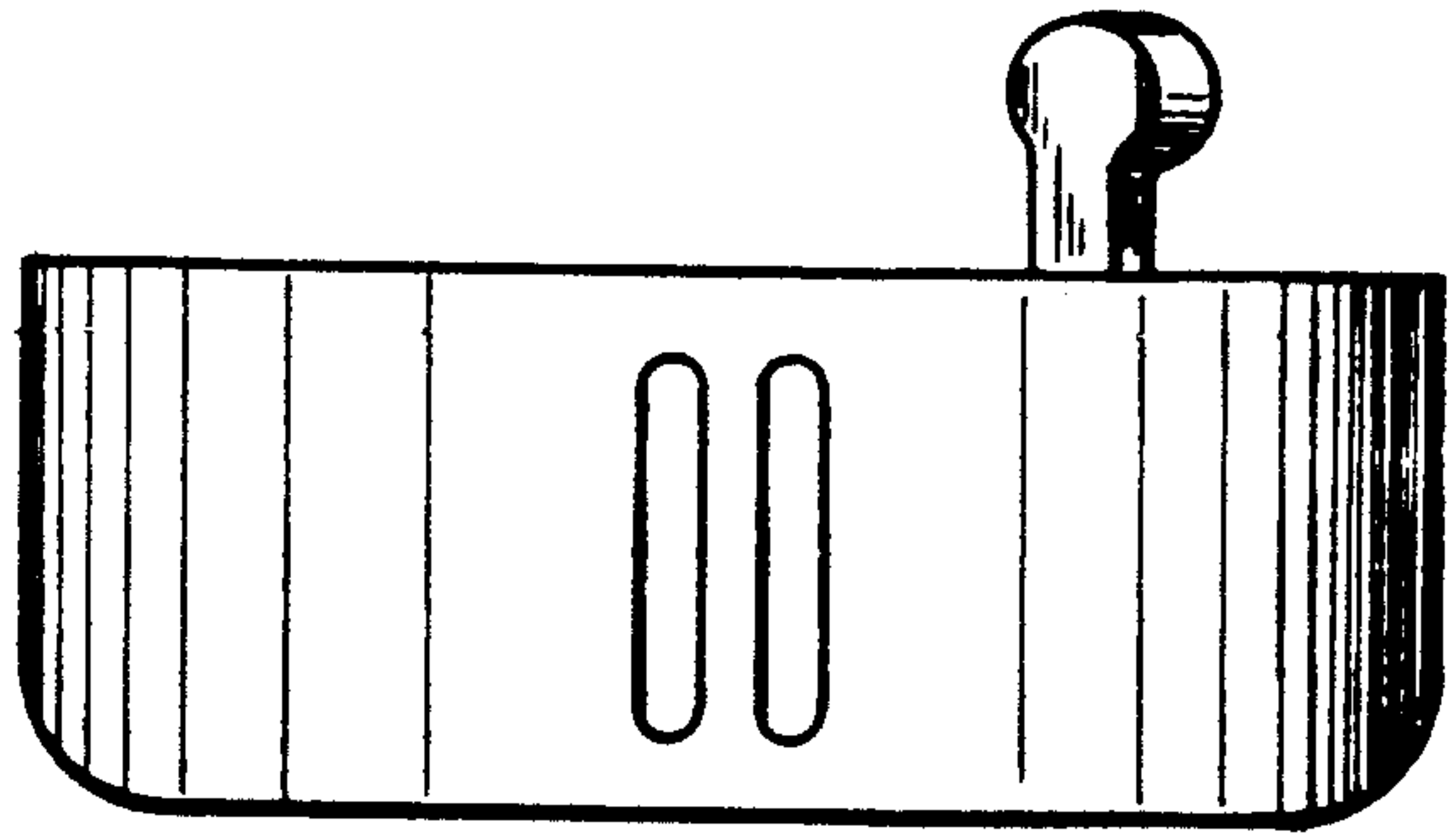


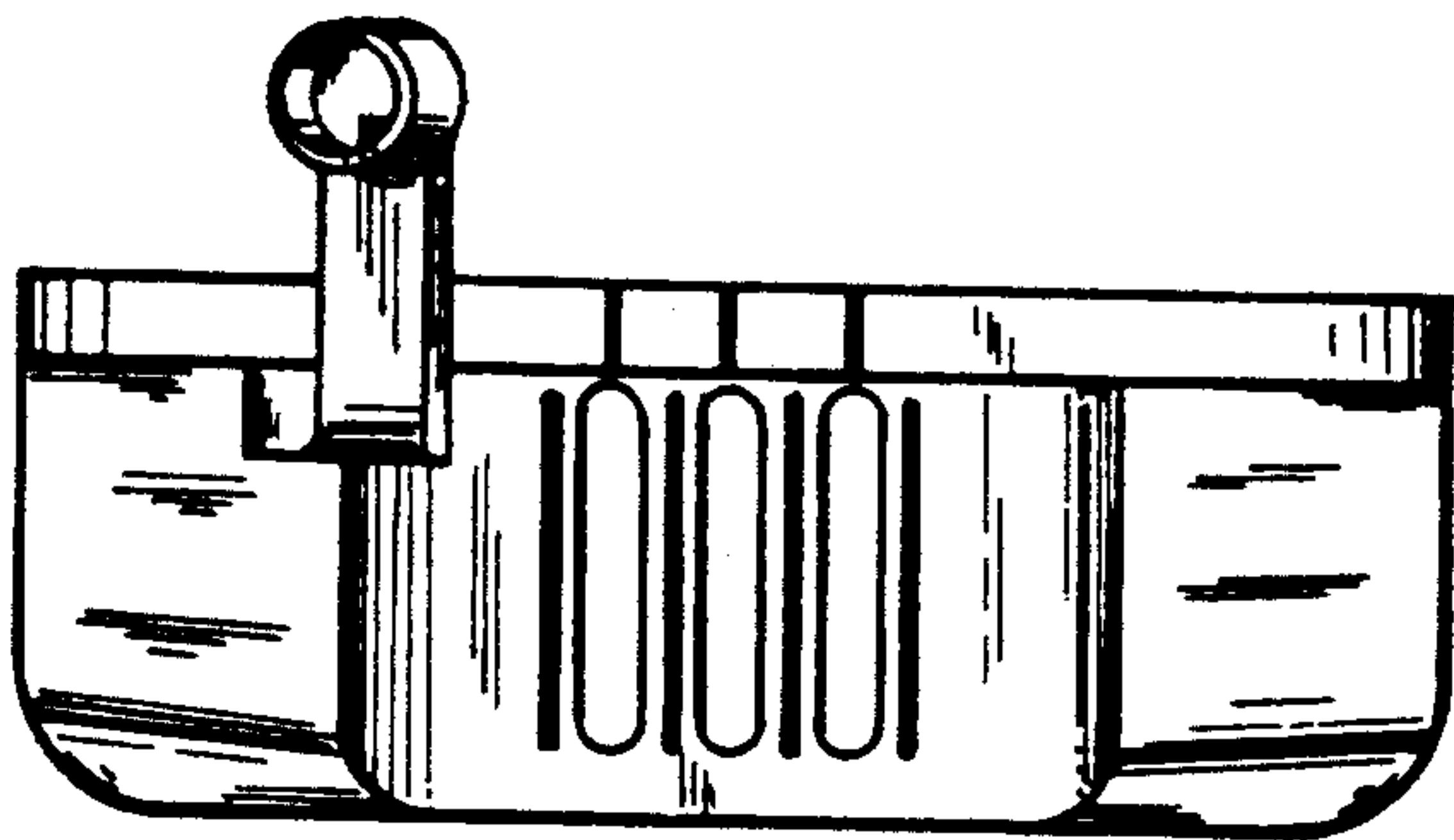

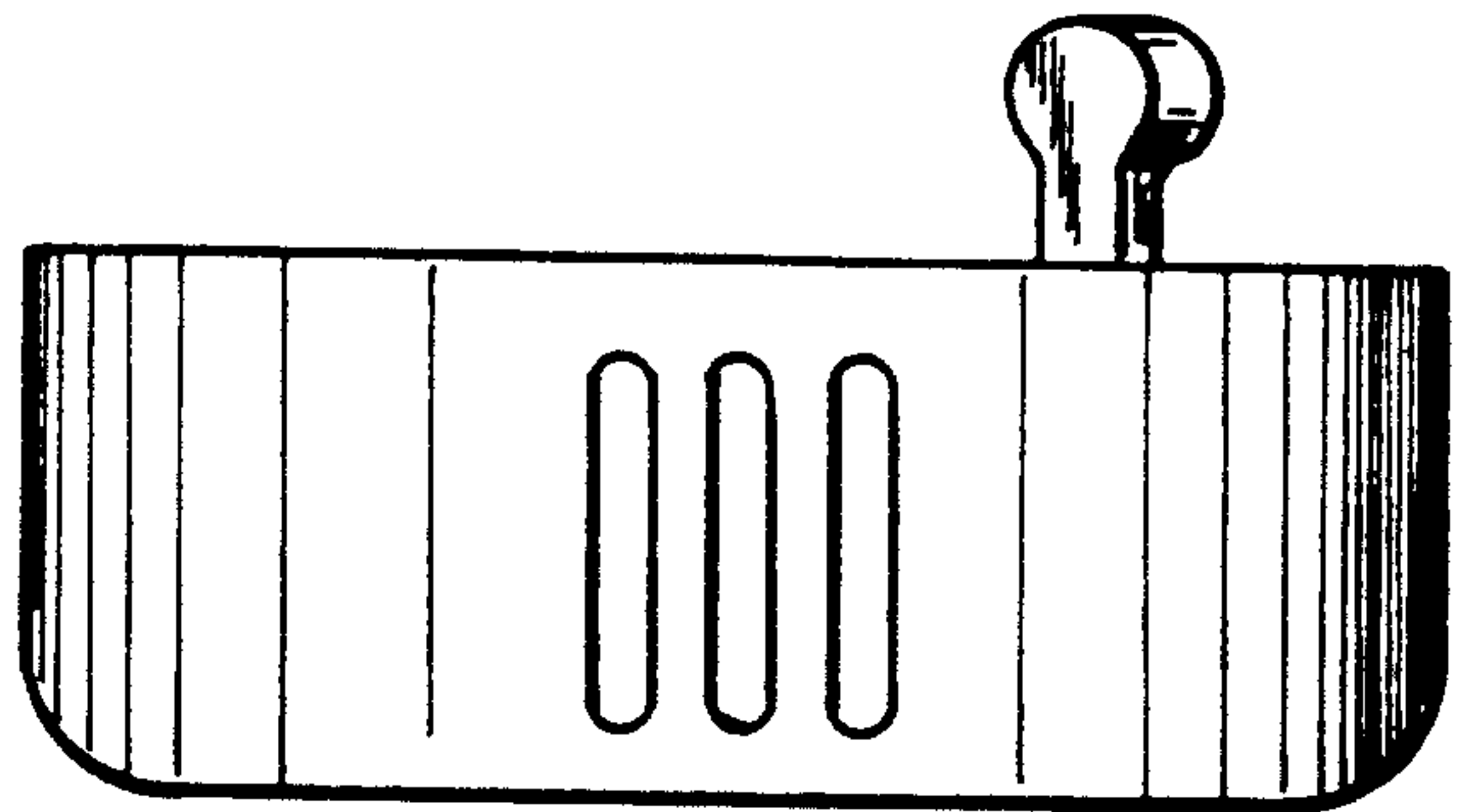

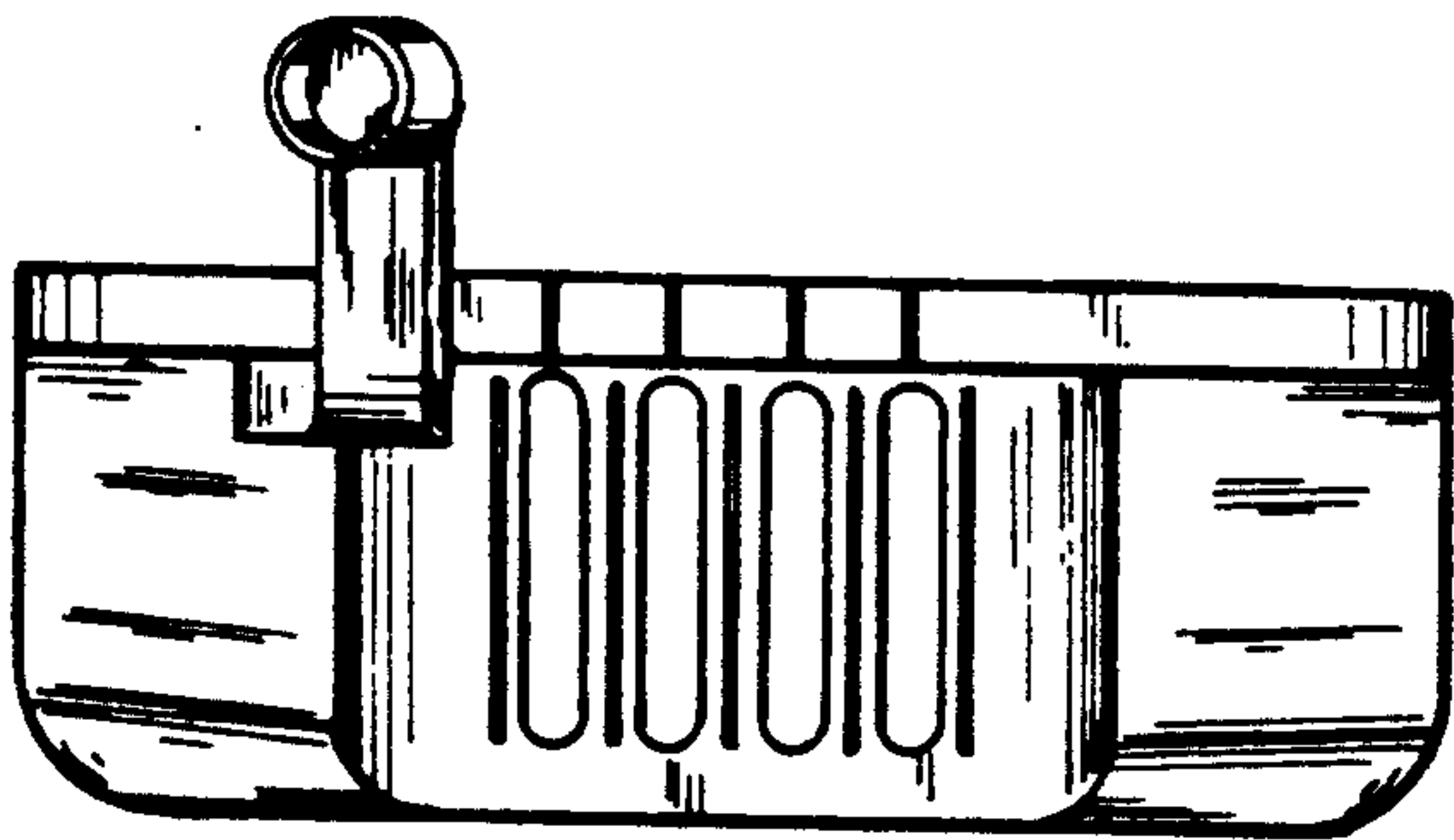

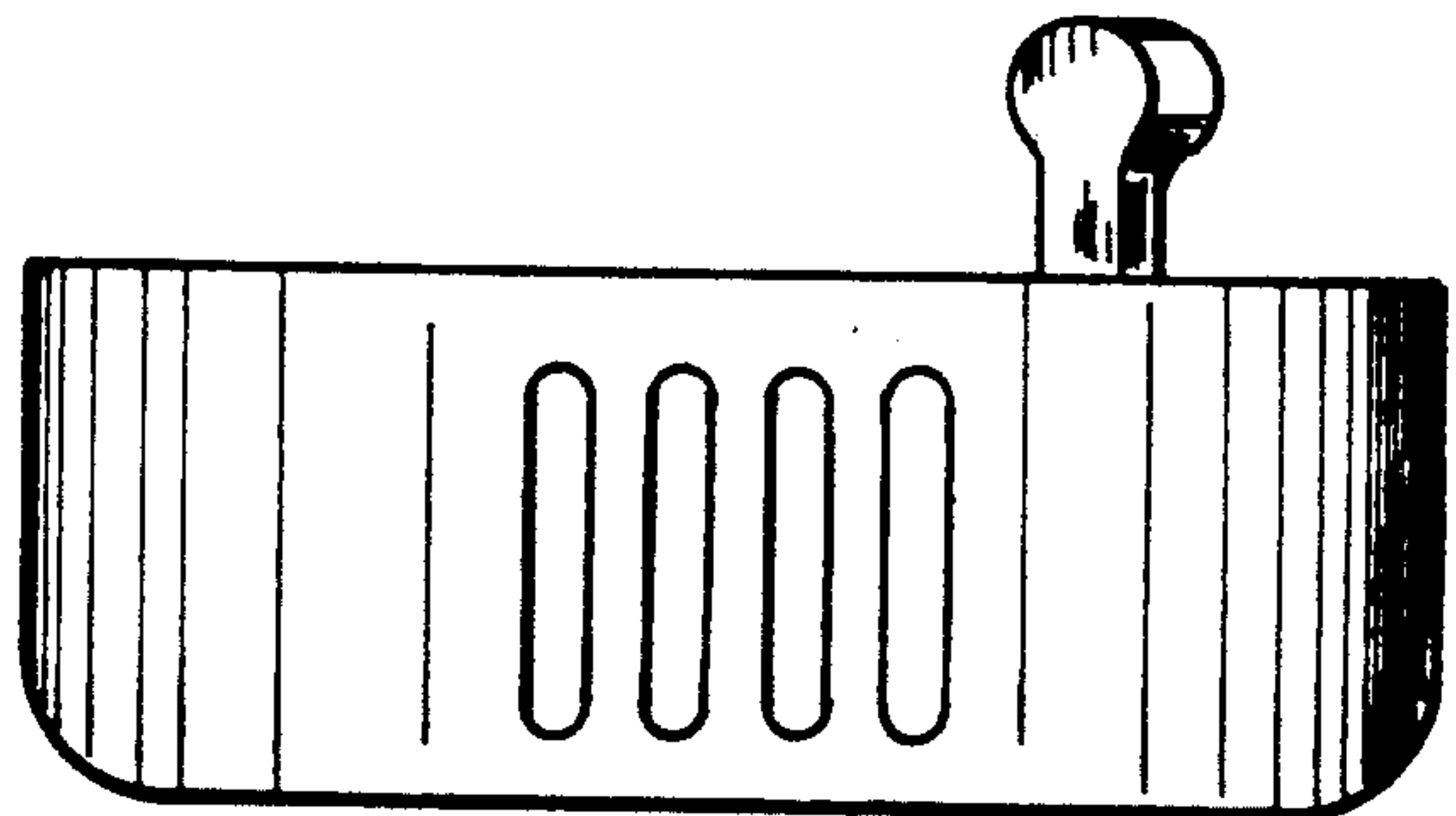

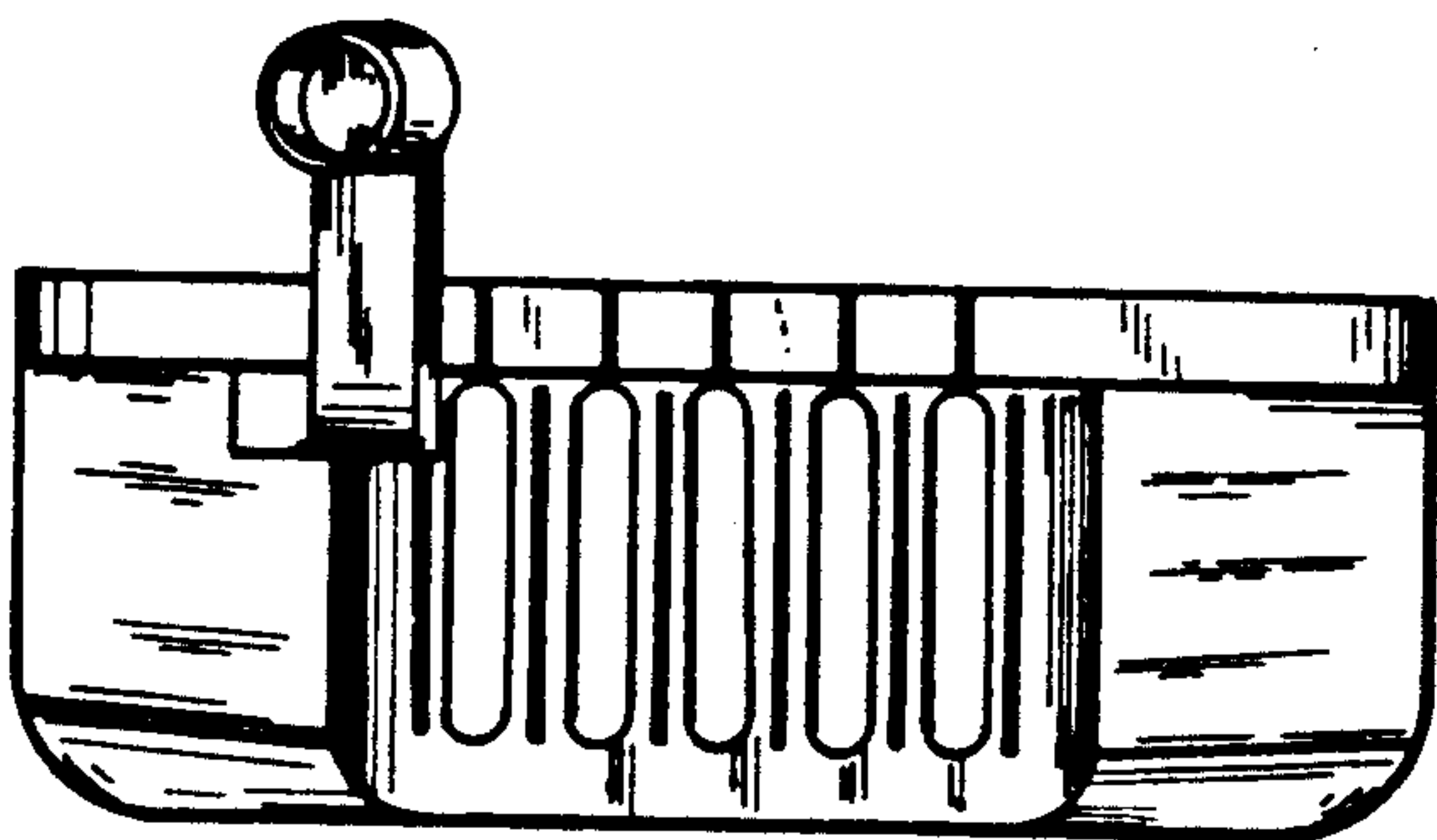

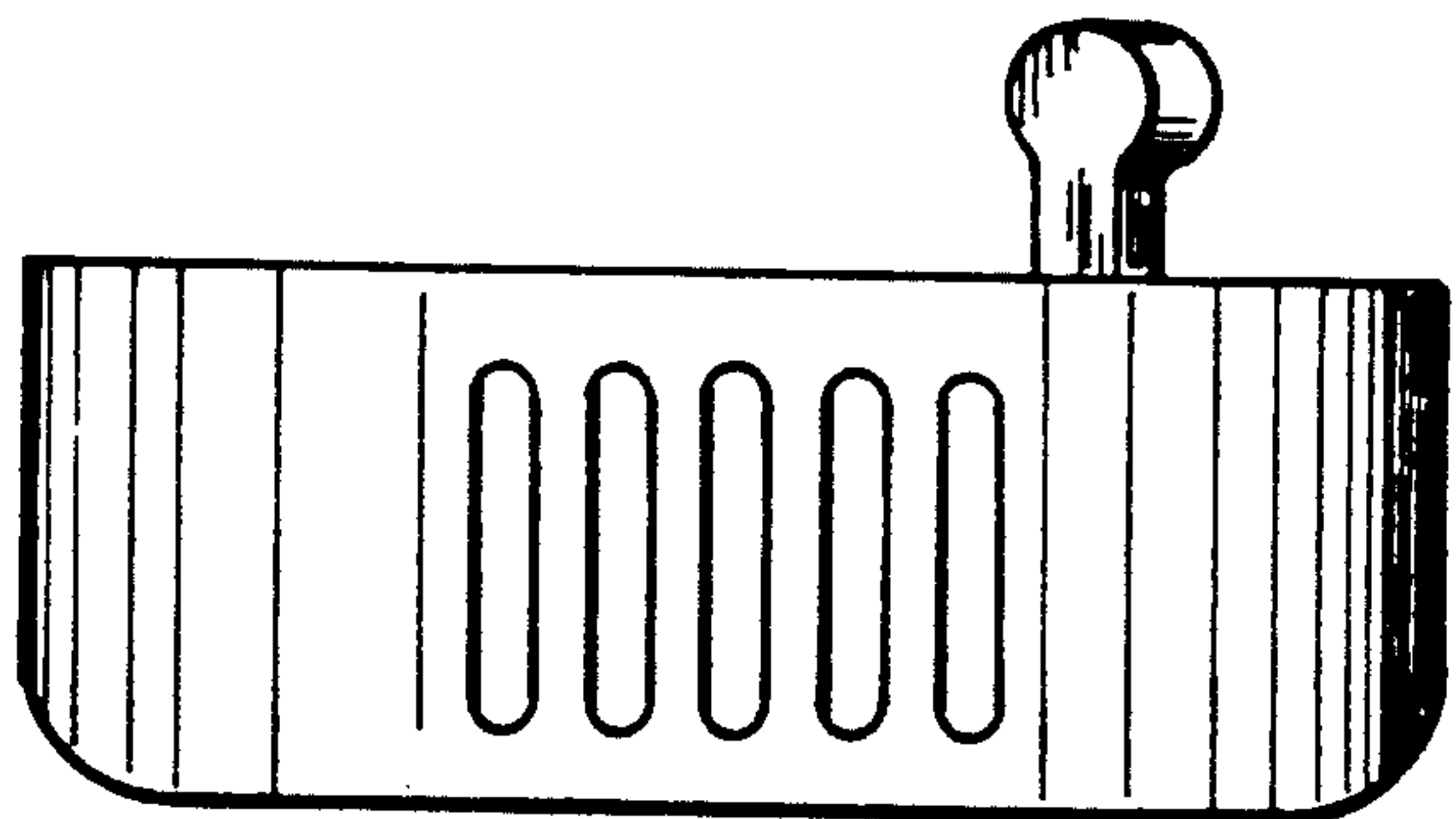
