FIG. 13 is a right side view of the child's carriage with a different body according to another embodiment of my design, the left side view being mirror symmetrical thereto; and,

FIG. 14 is a right side view of the child's carriage with still another different body according to a further embodiment of my design, the left side view being mirror symmetrical thereto.

The sole difference among the first, second (FIG. 13), and third (FIG. 14) embodiment being in the different configuration of the carriage body.

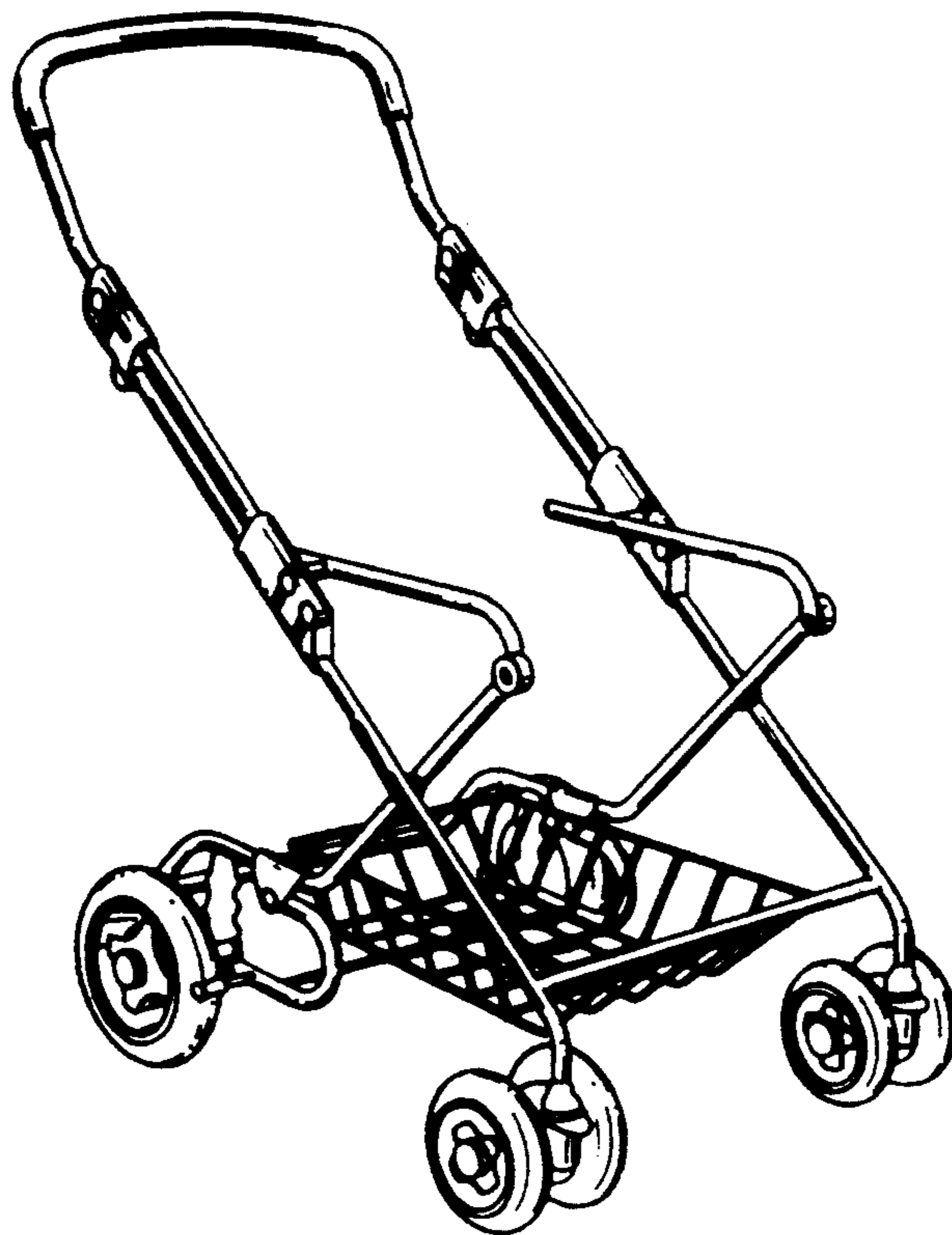

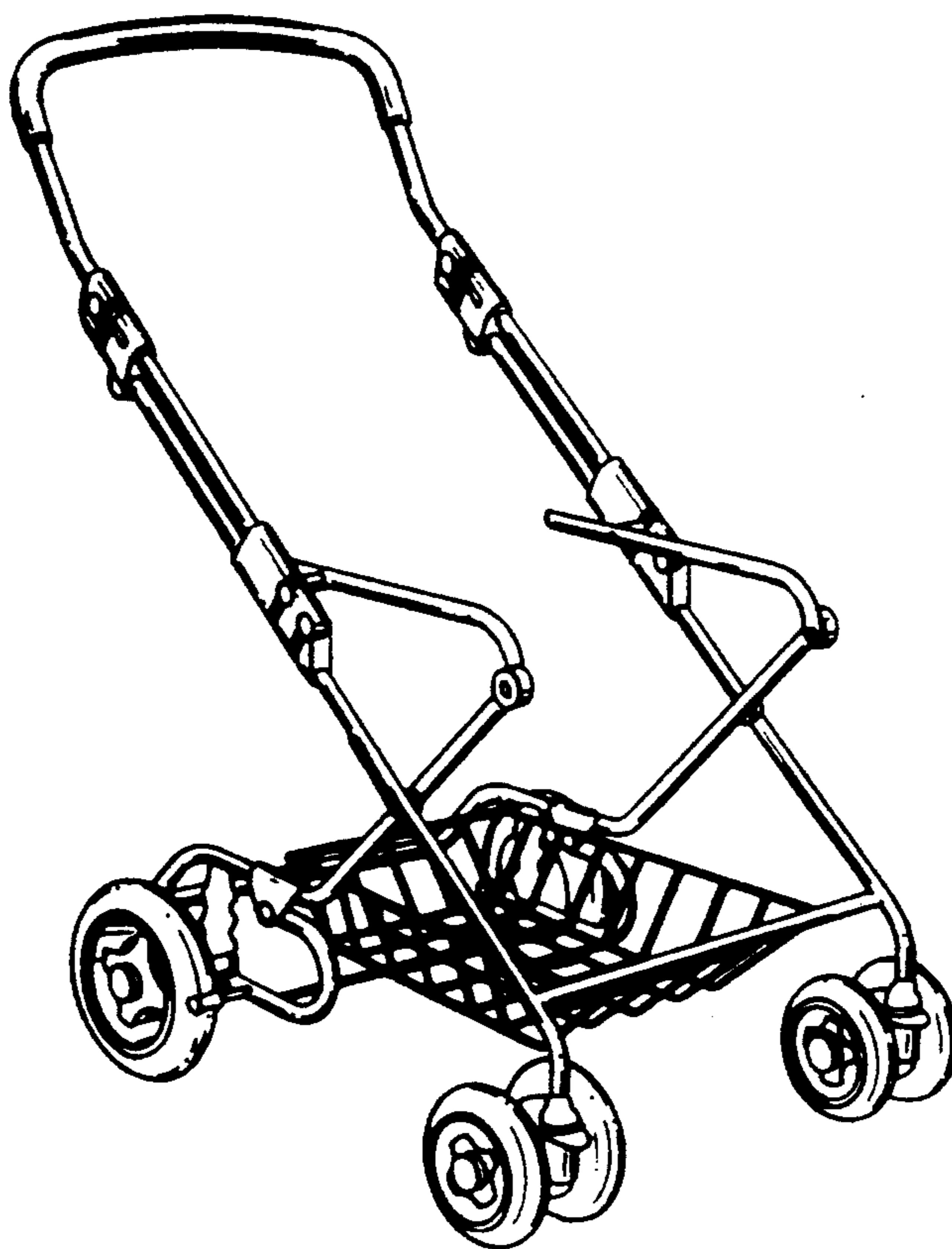

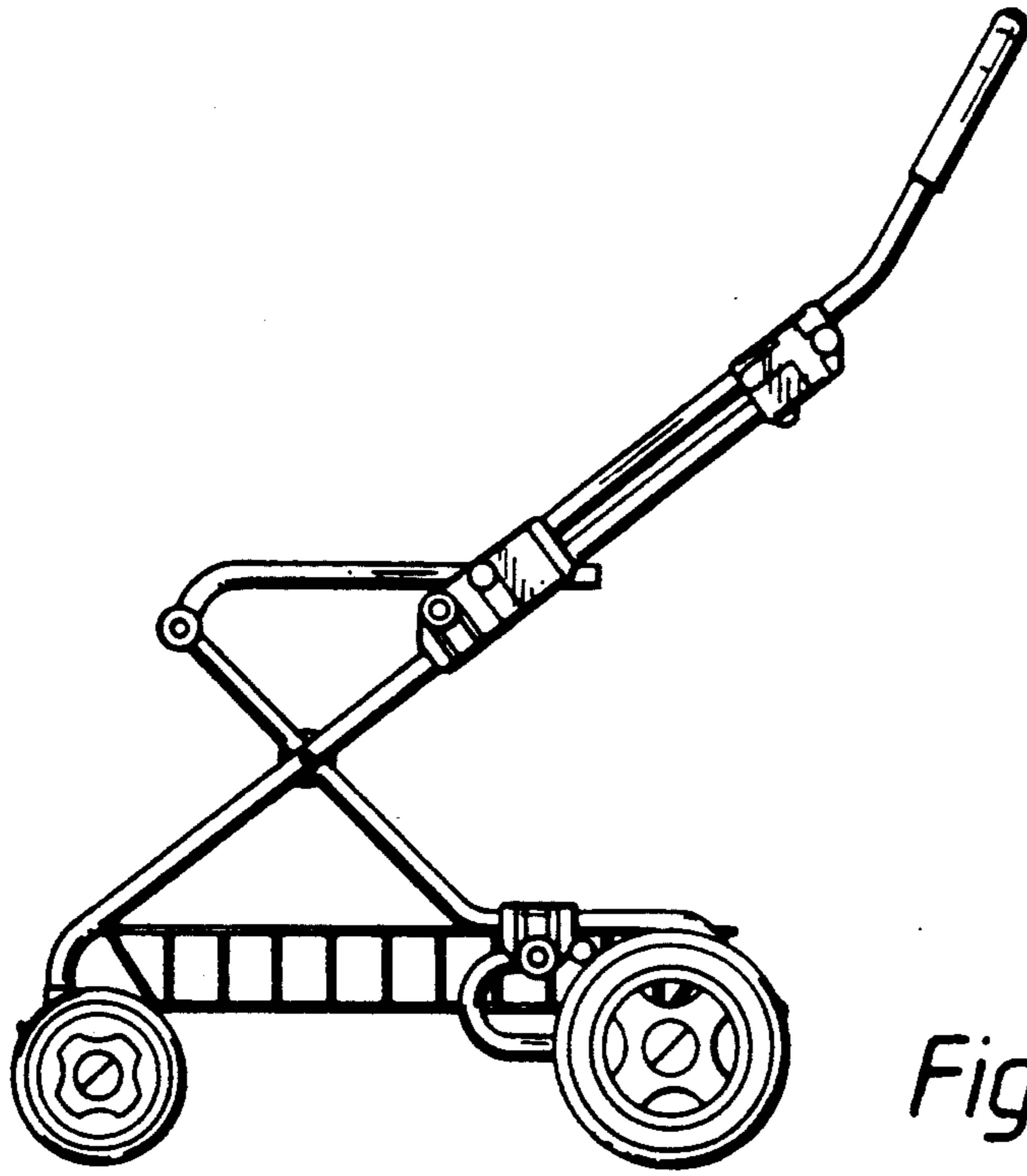

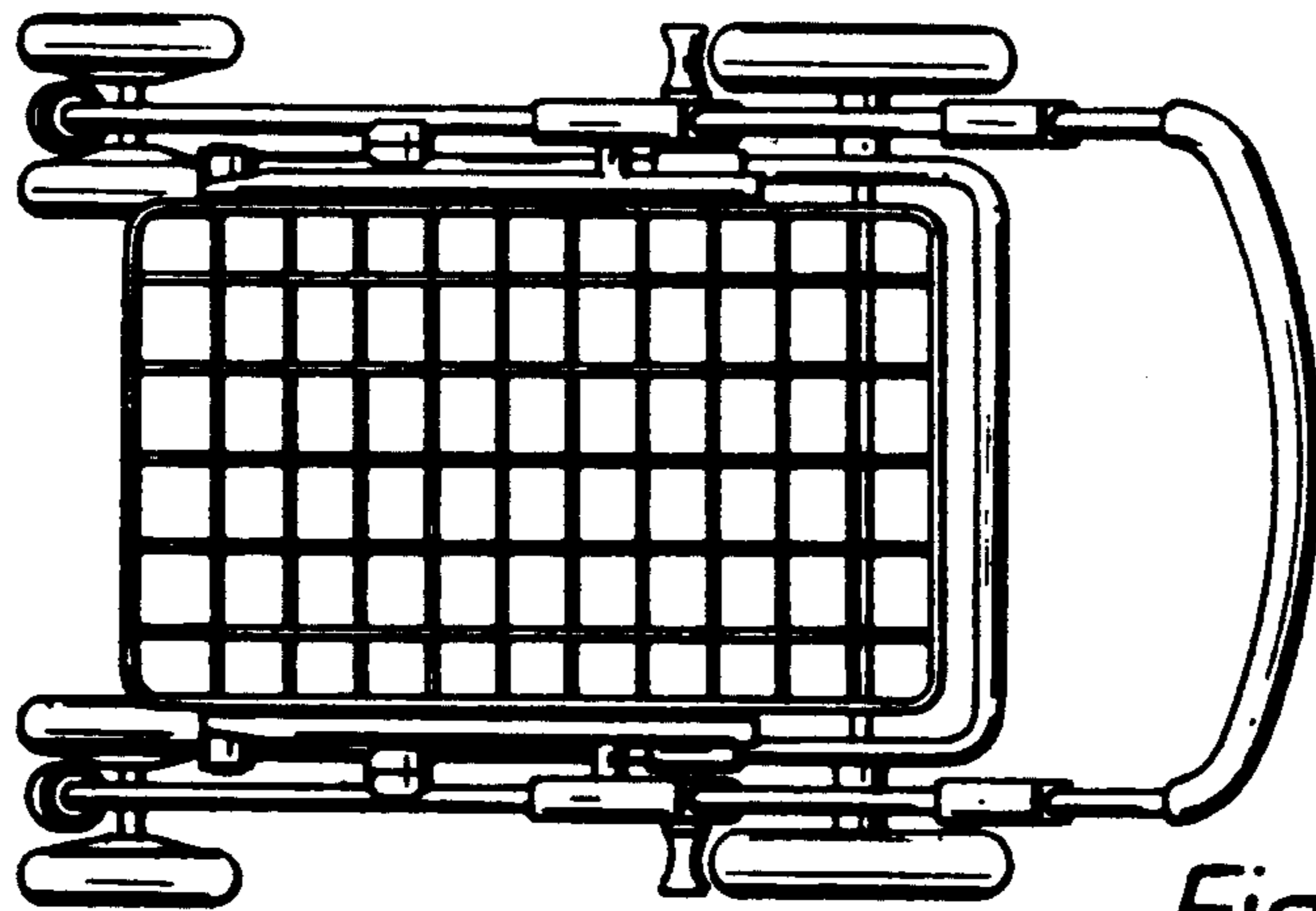

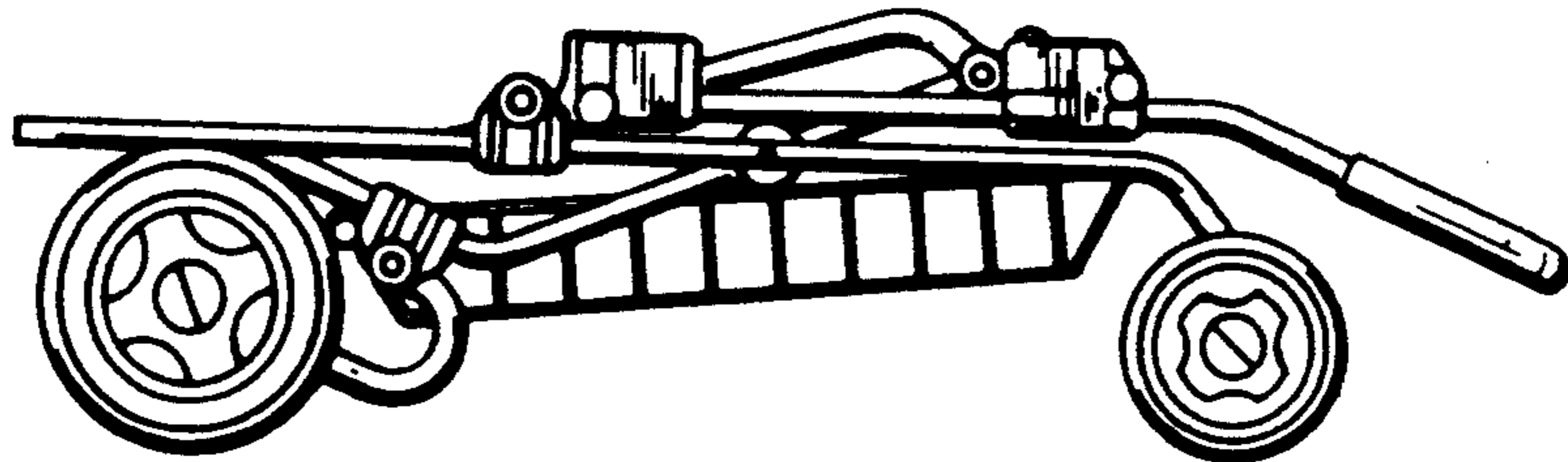
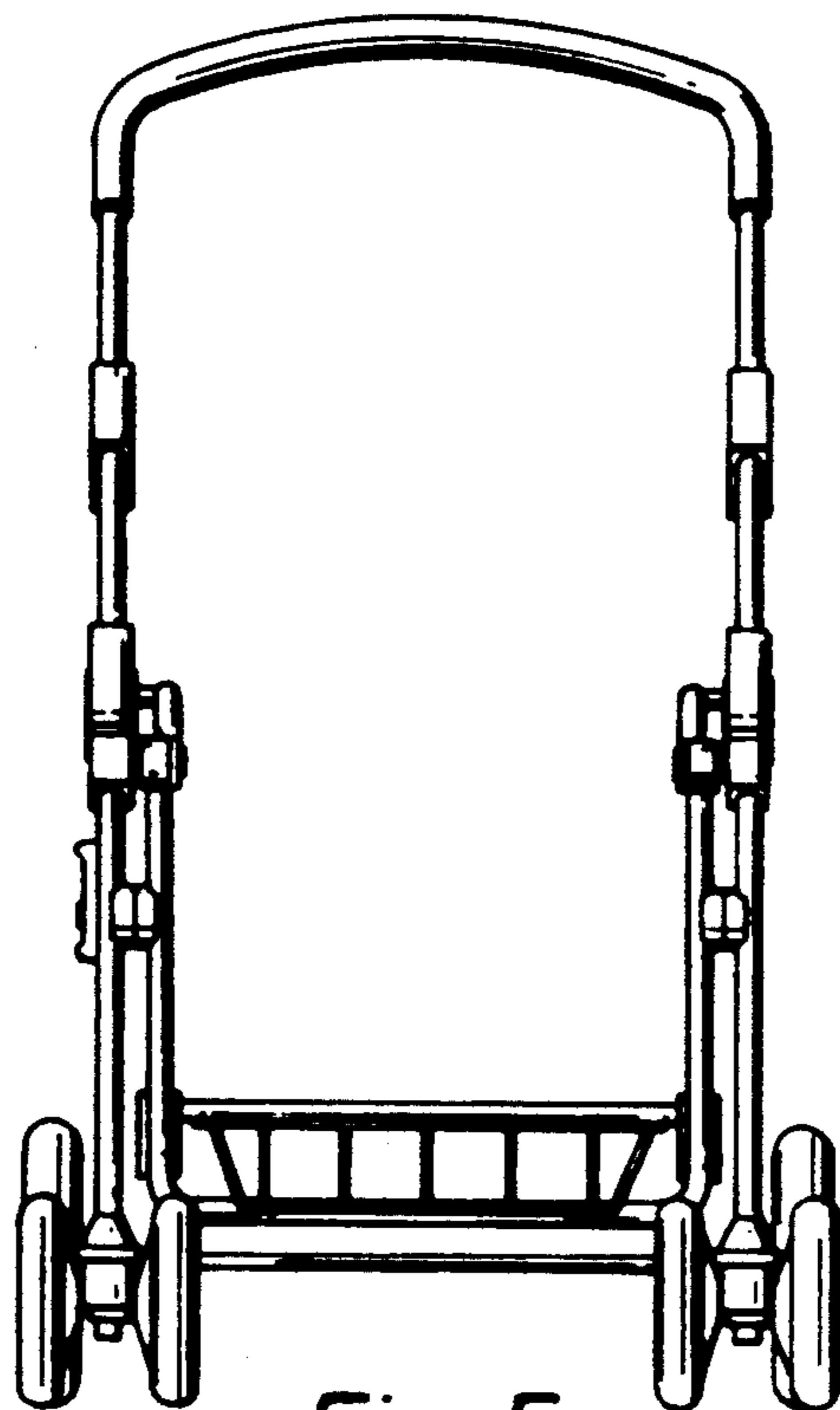
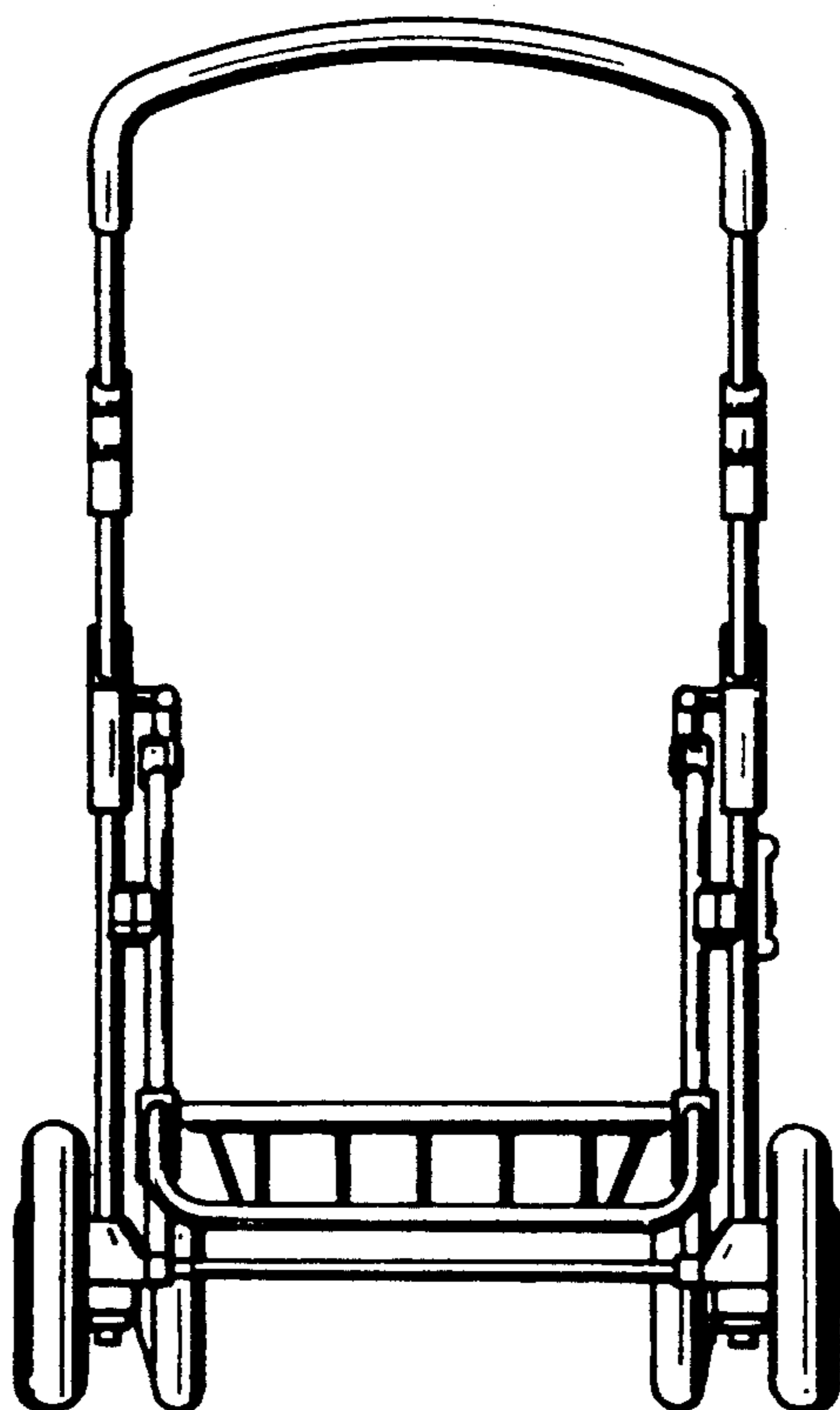


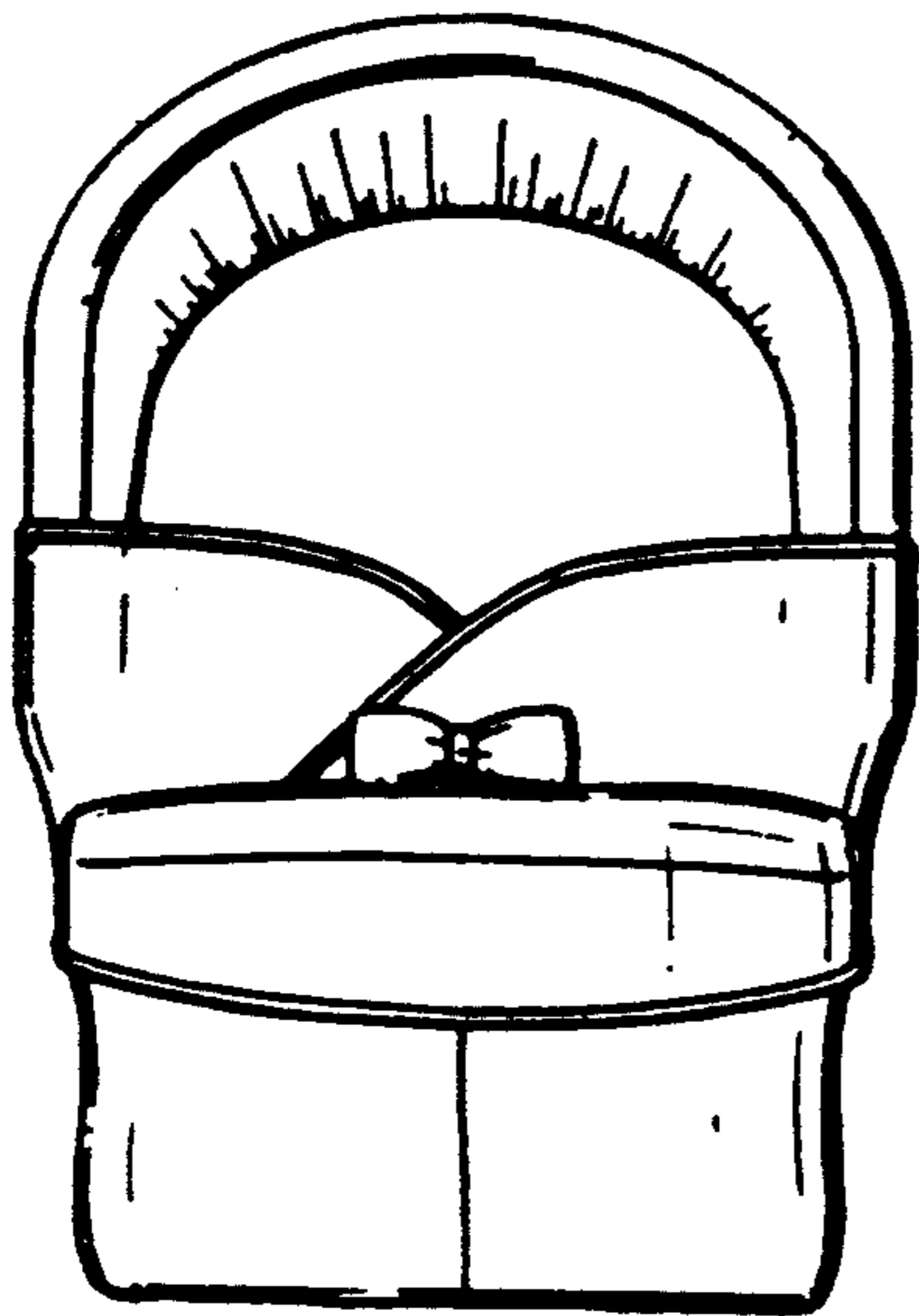

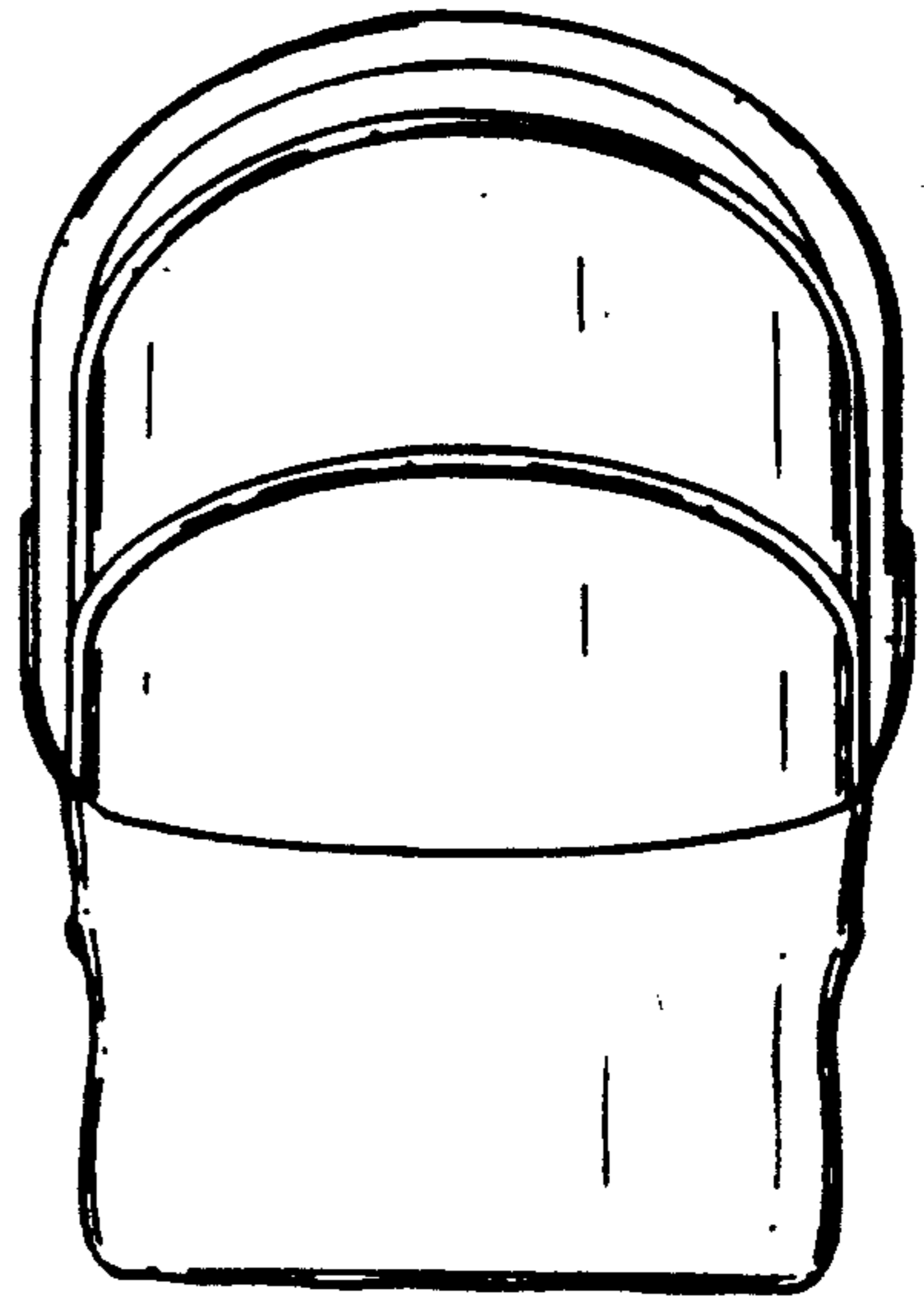

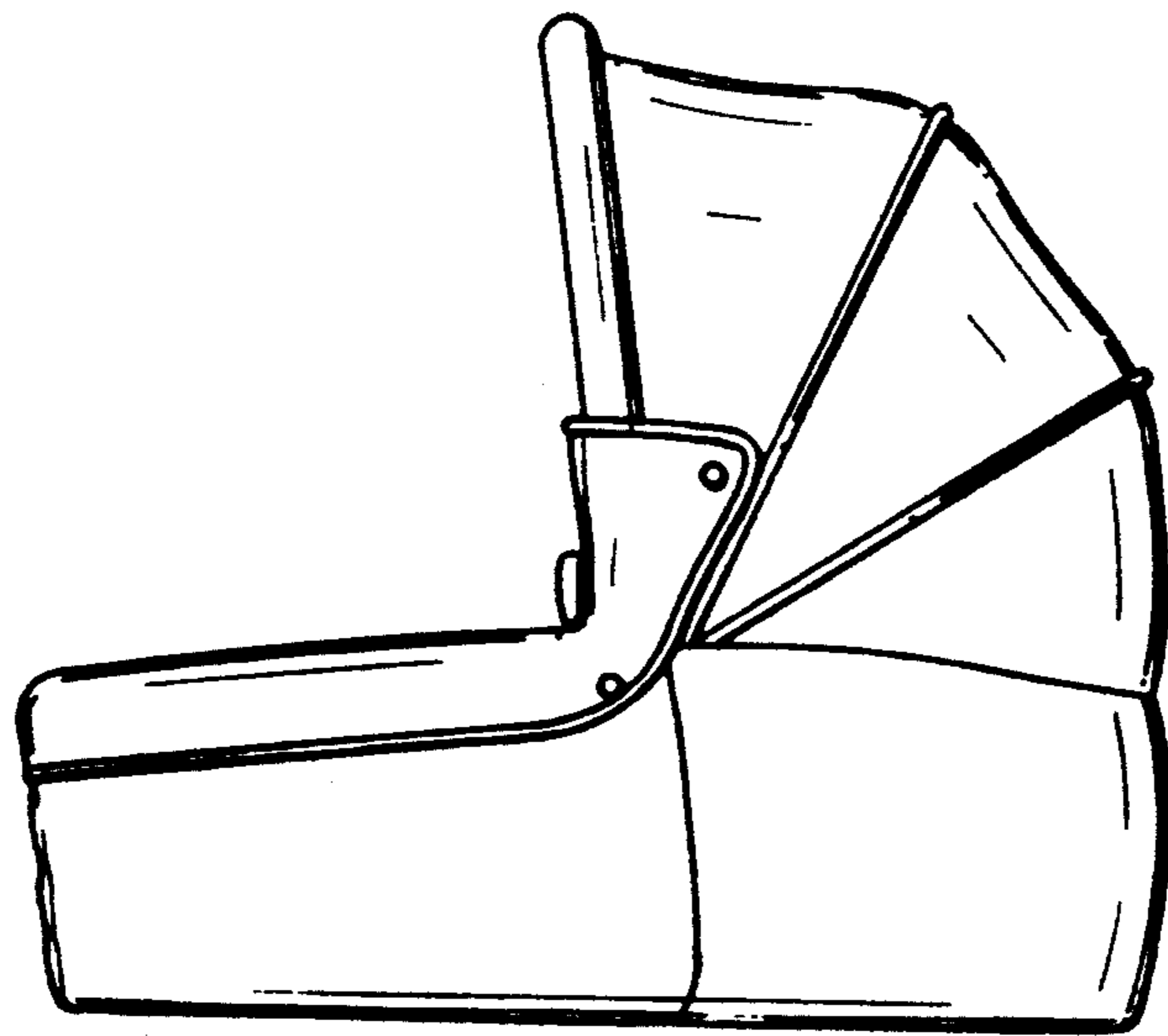

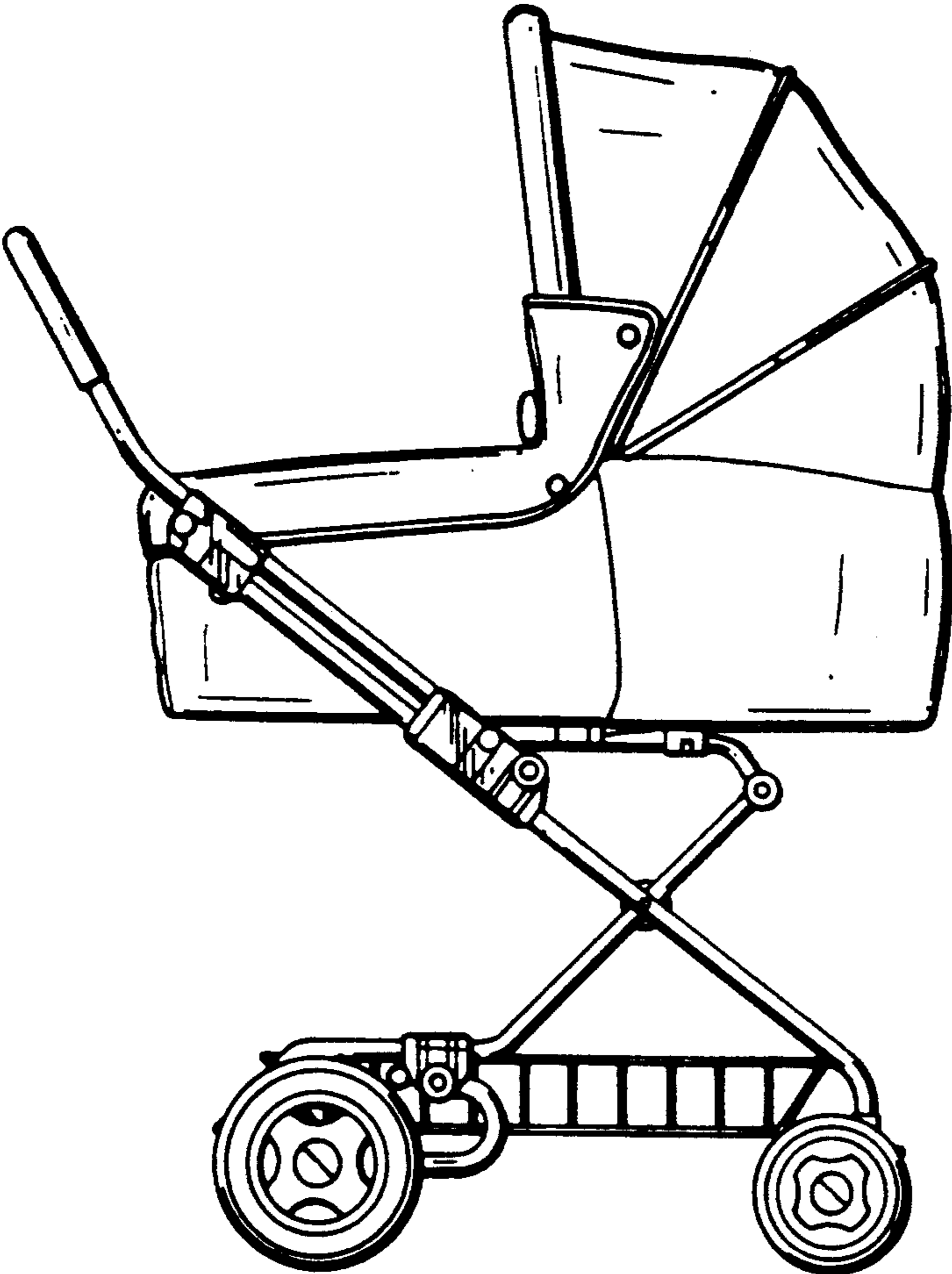

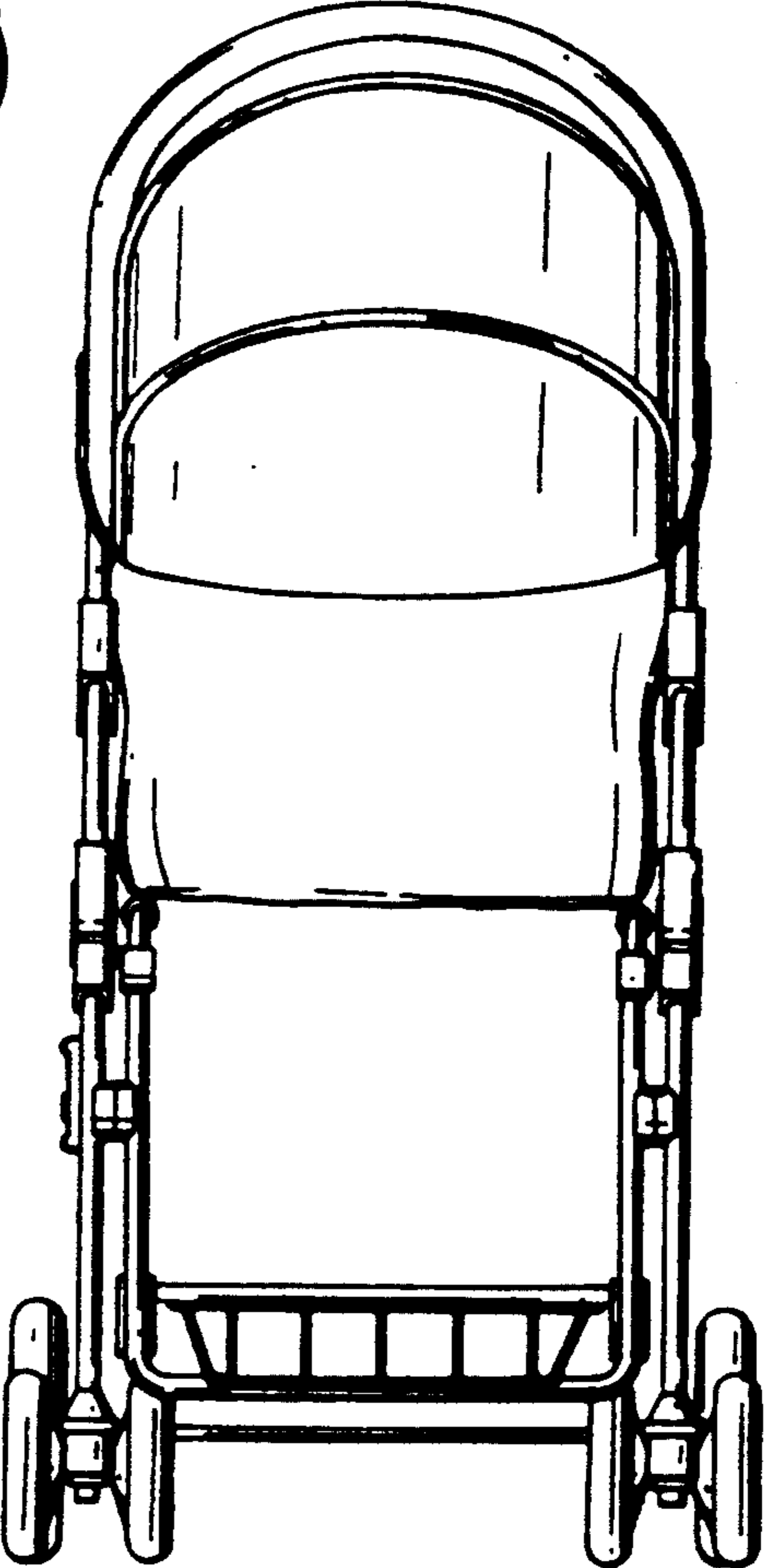

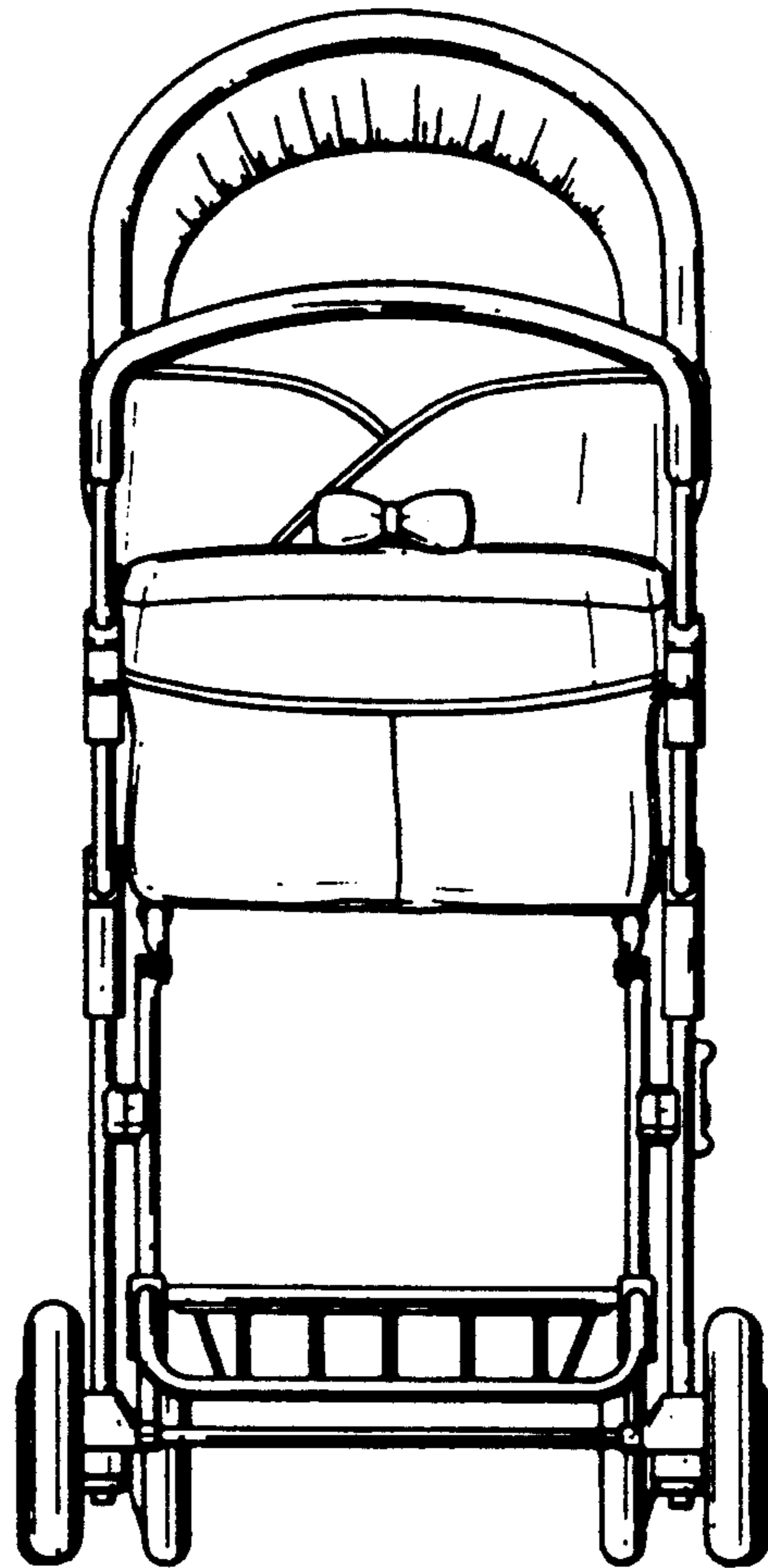

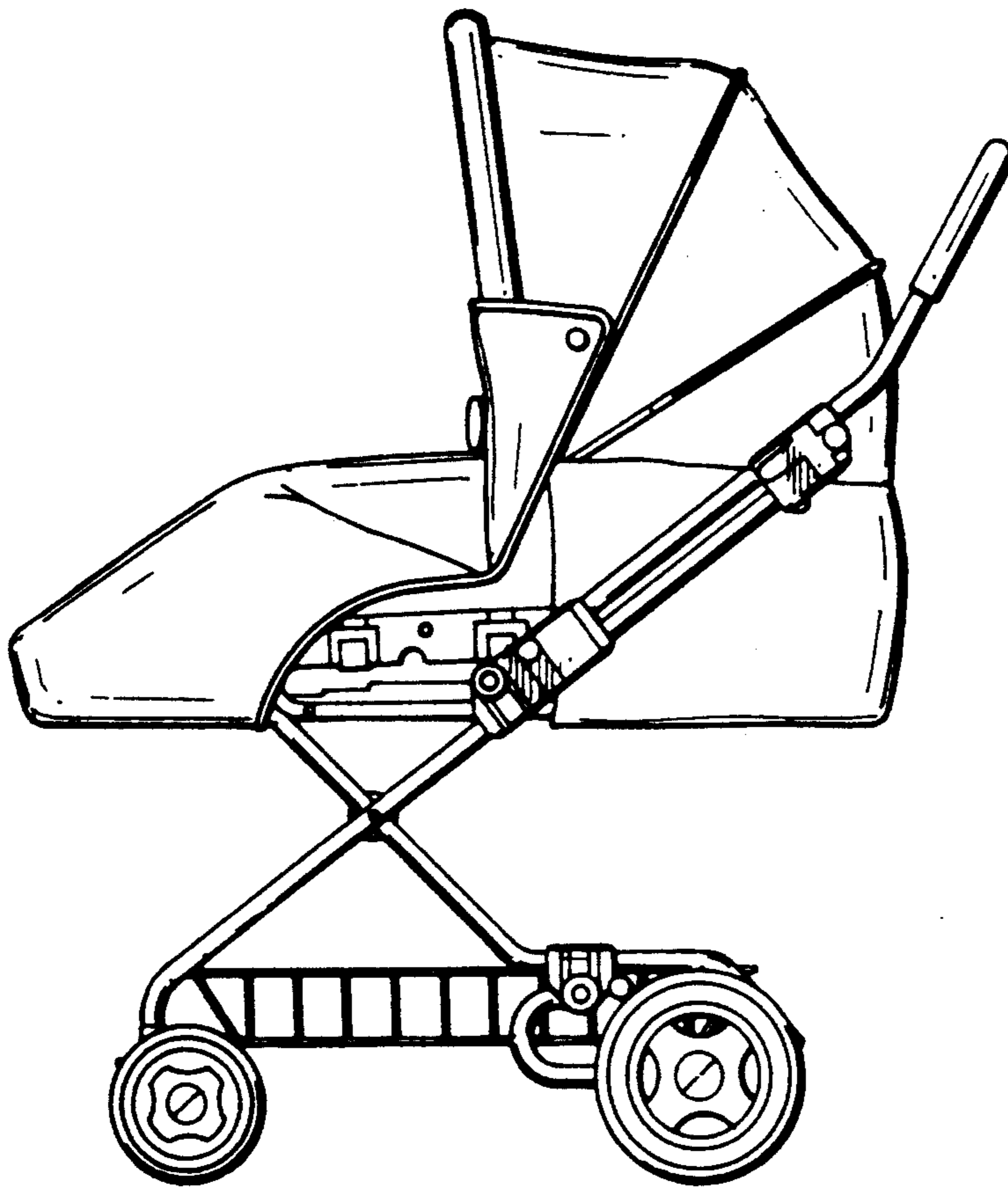

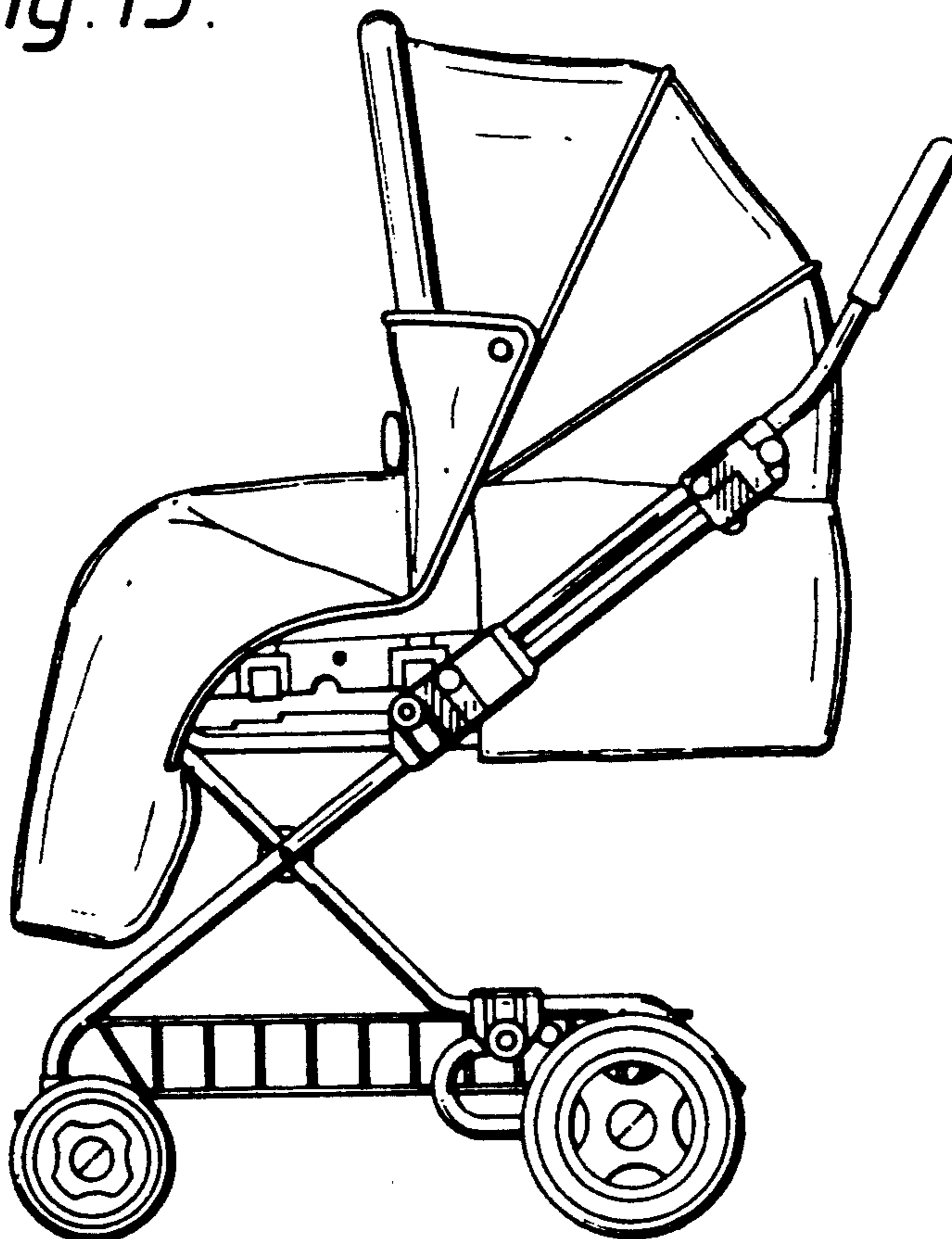
