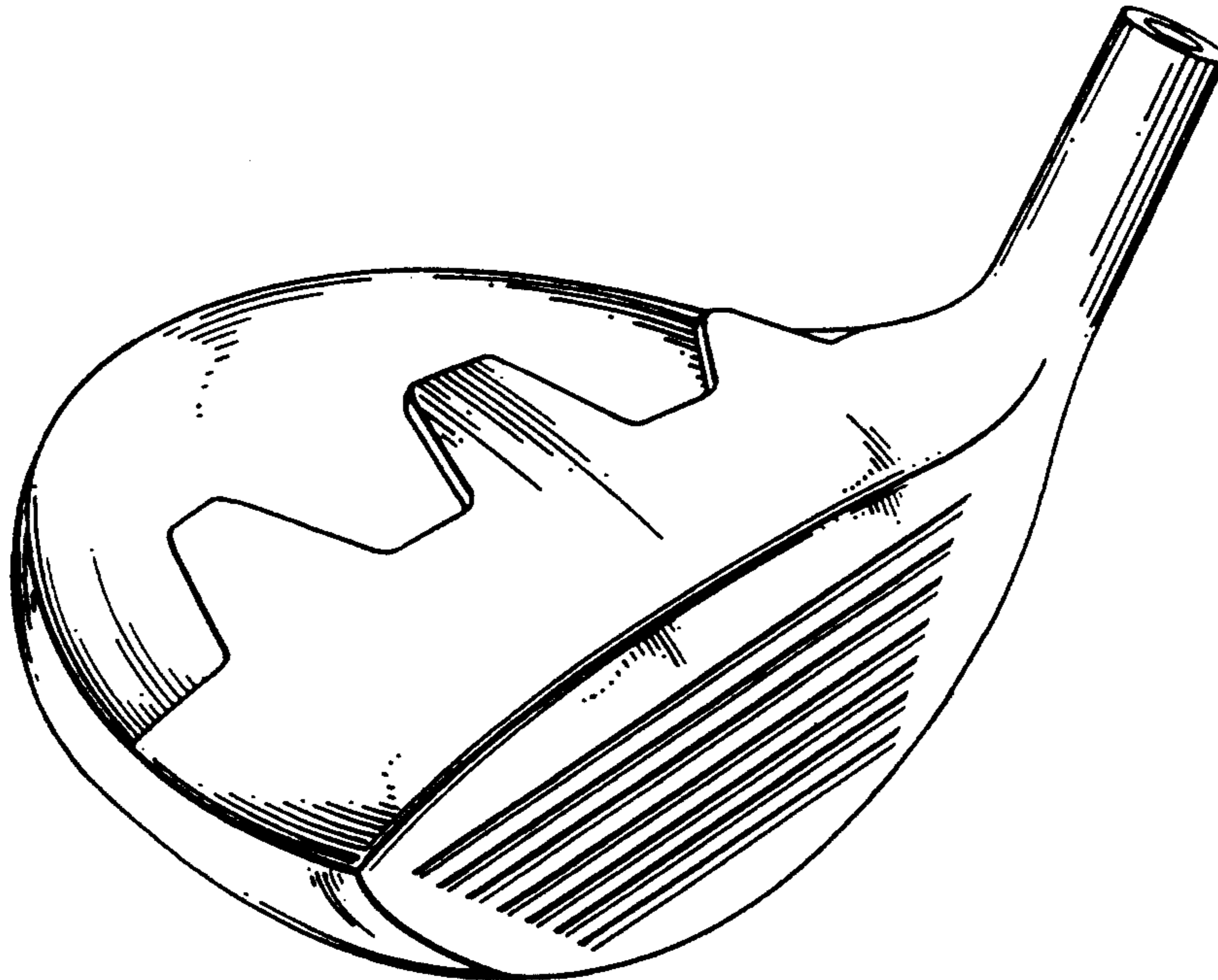

DESCRIPTION

FIG. 1 is a perspective view of a reinforced golf club head, showing my new design;

FIG. 7 is a back view thereof.



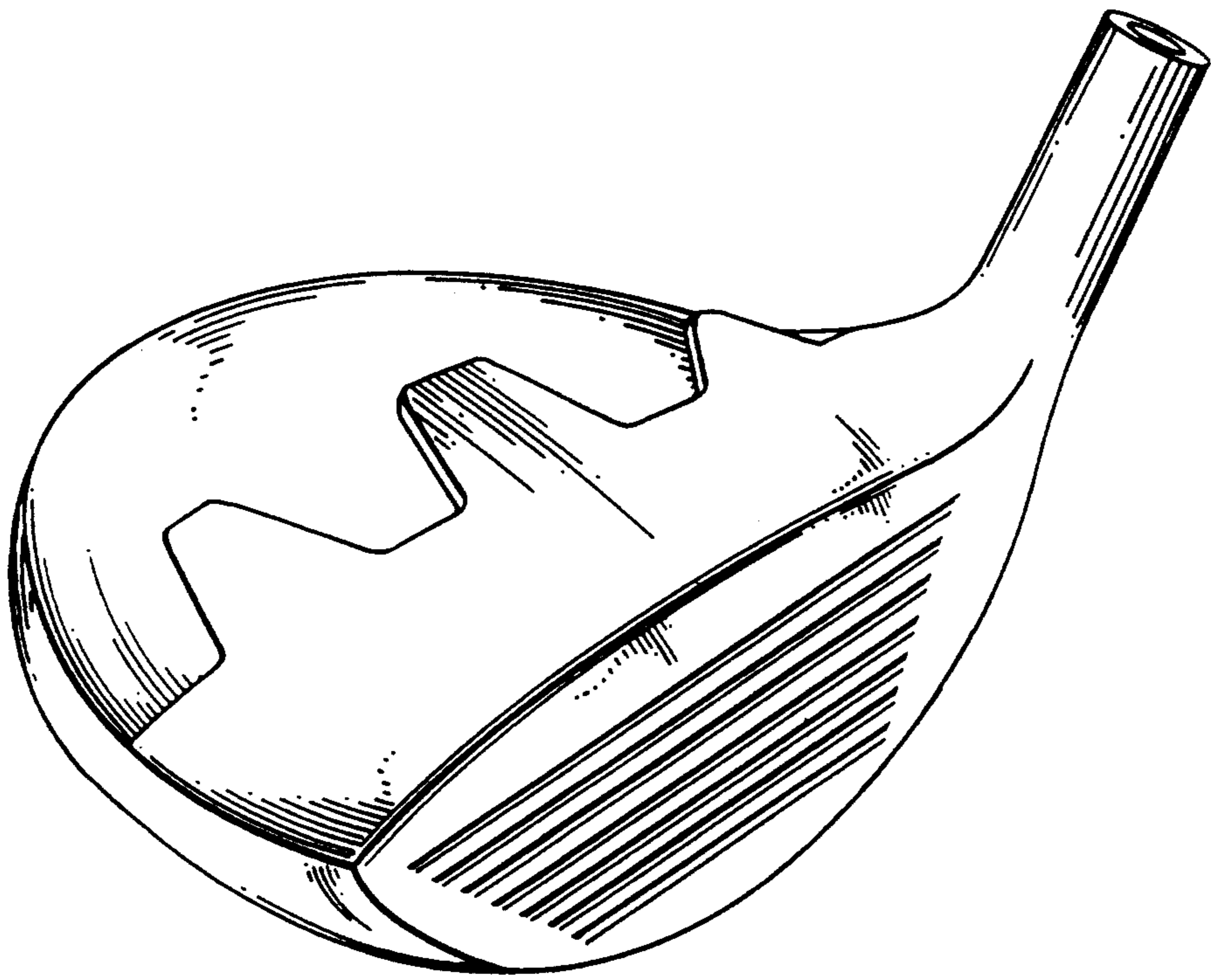

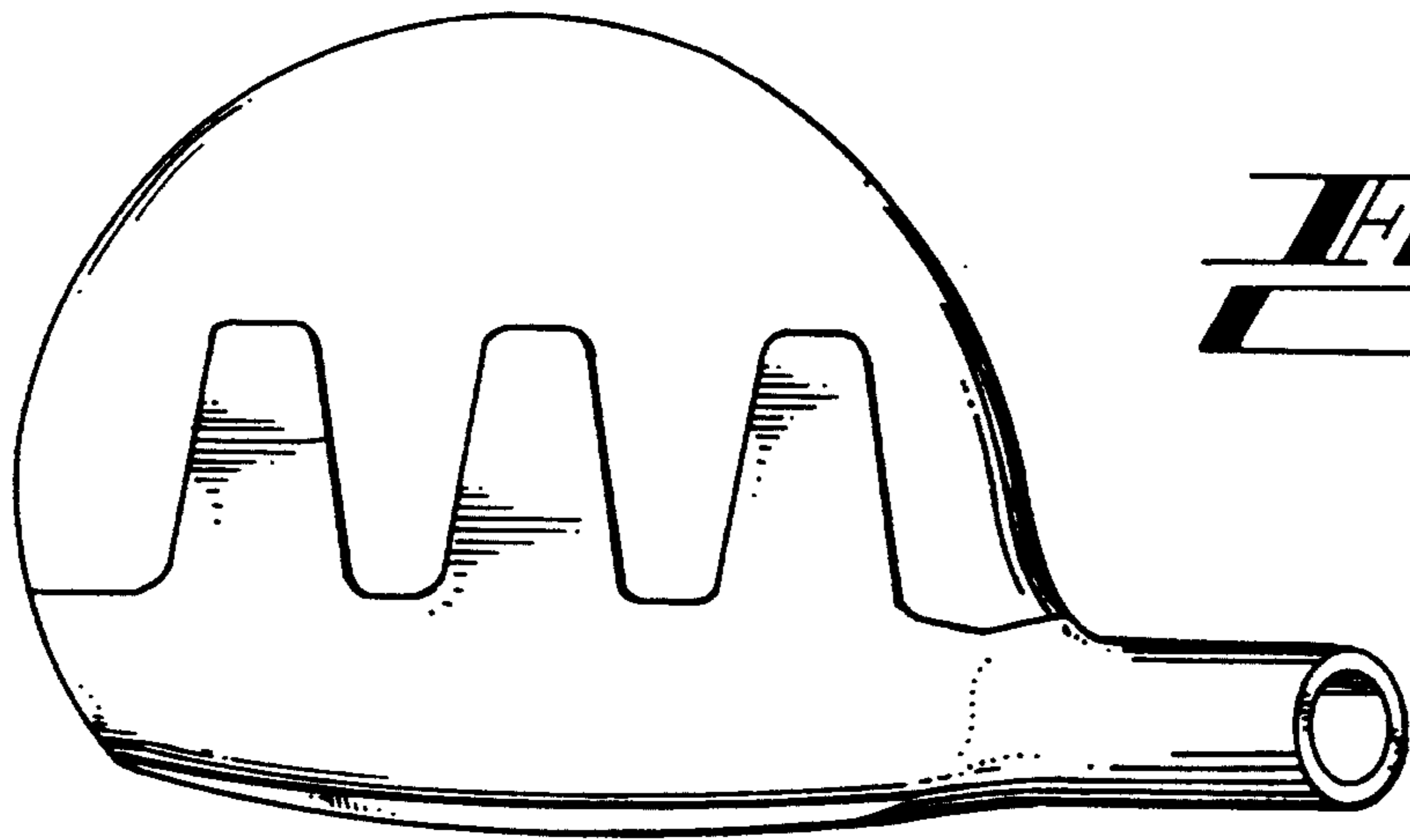

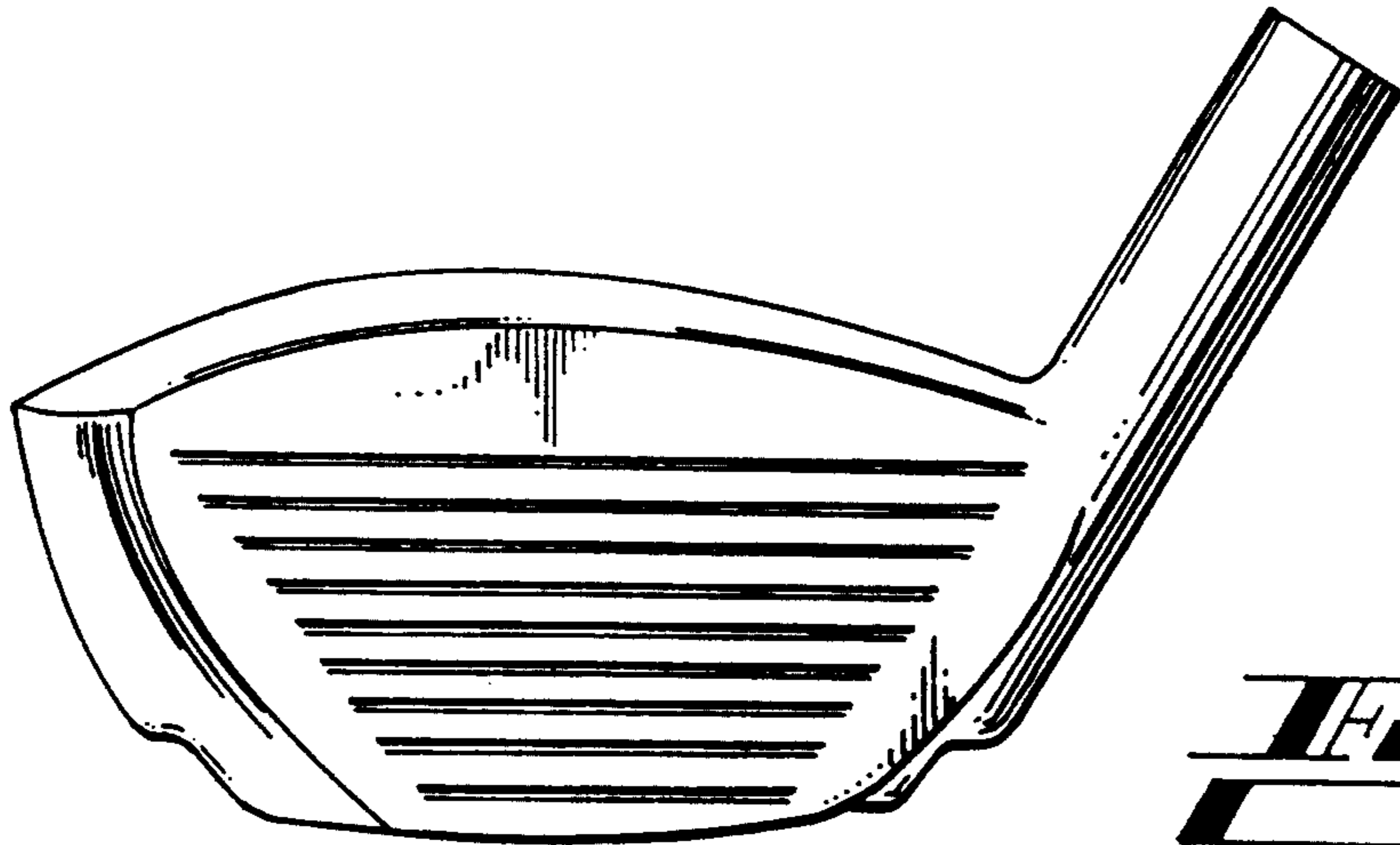

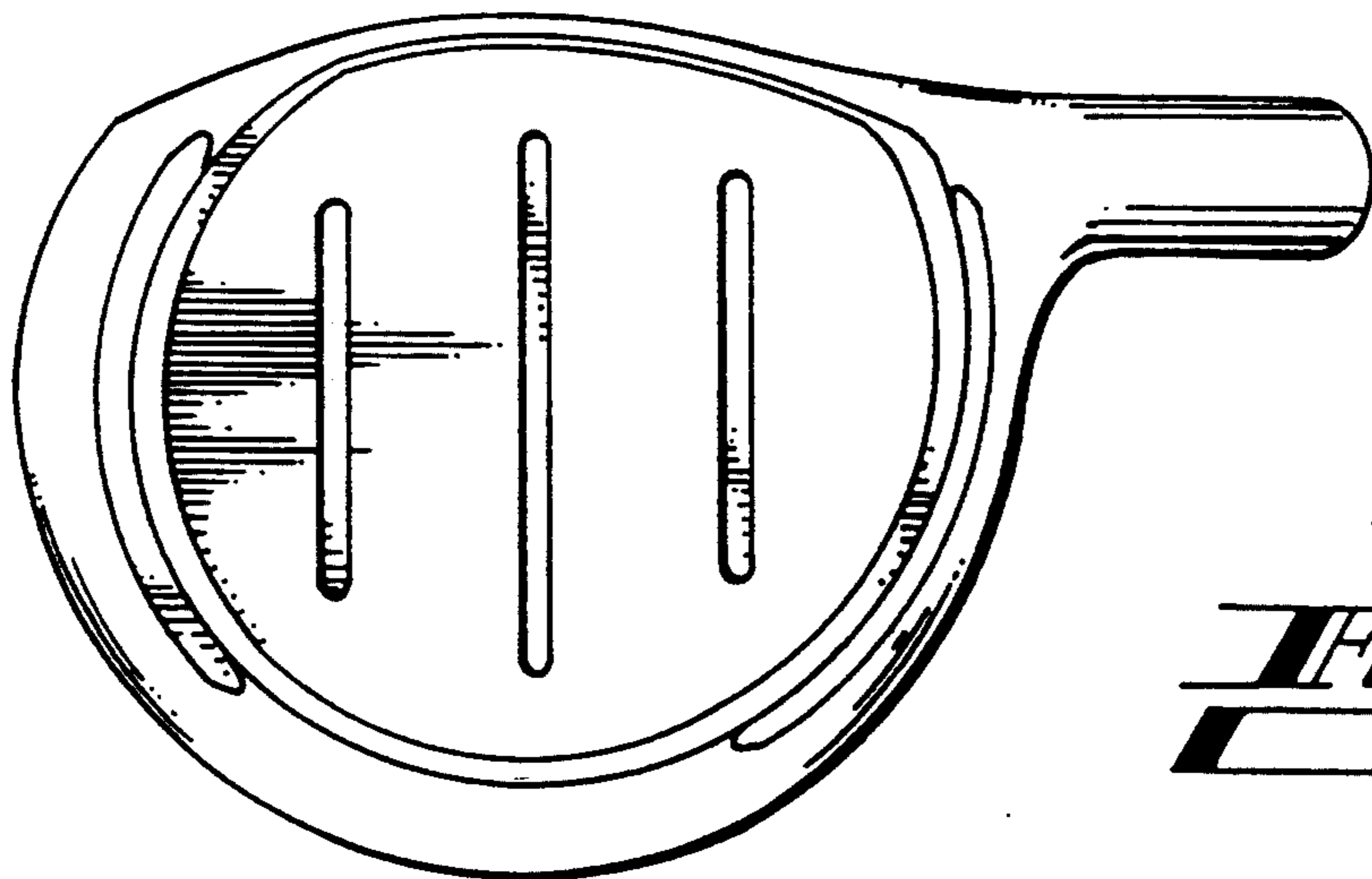

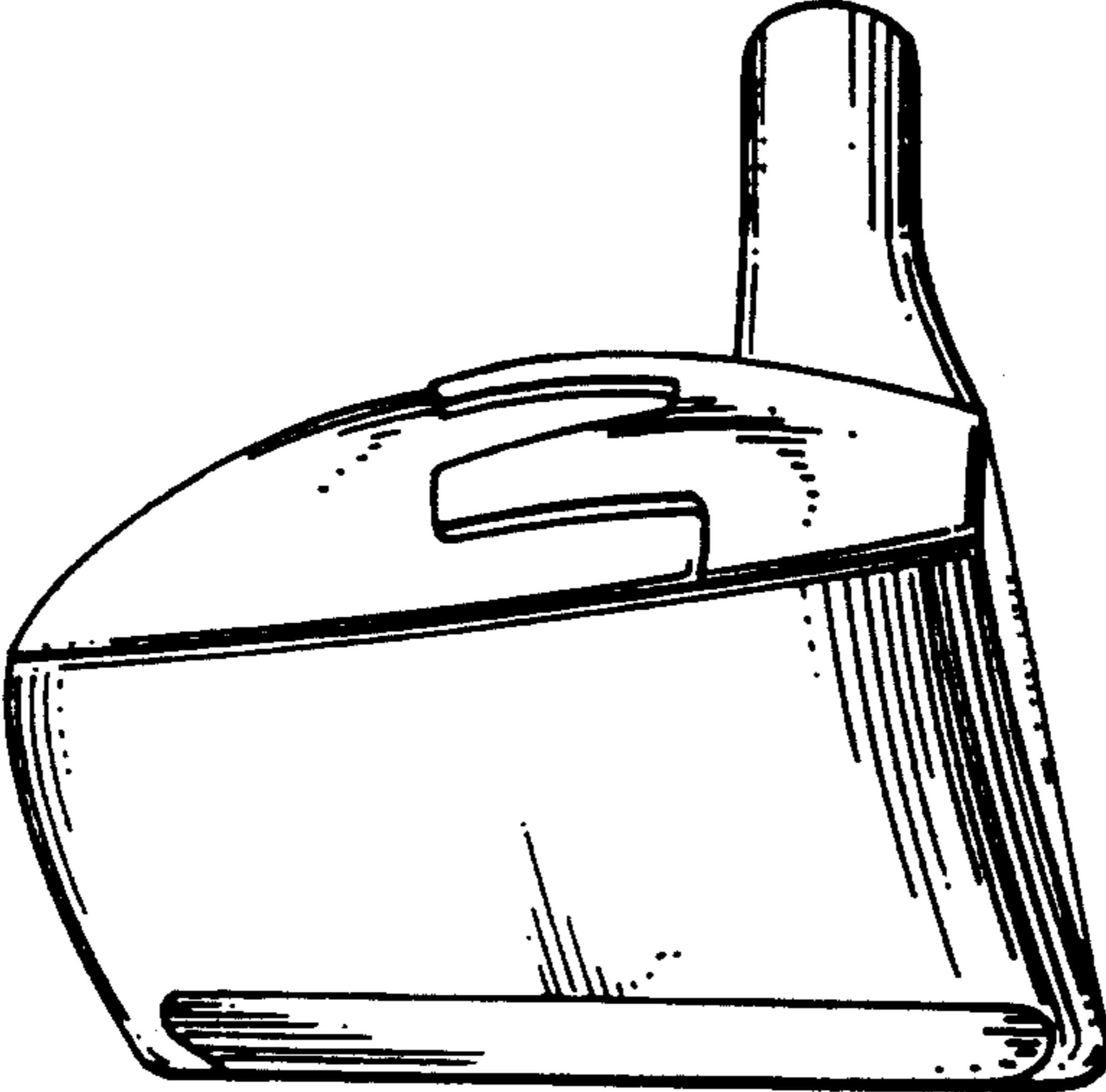

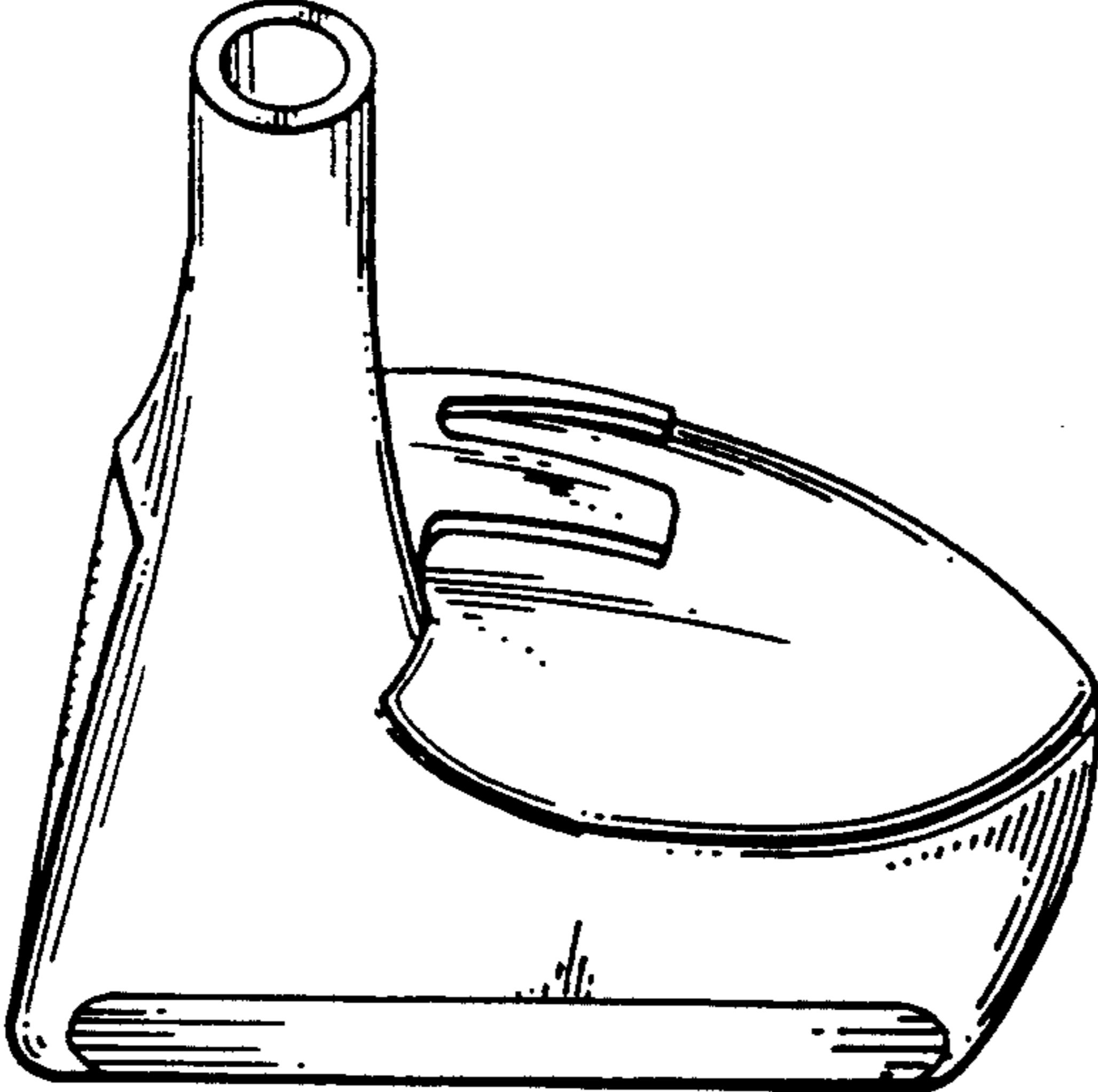

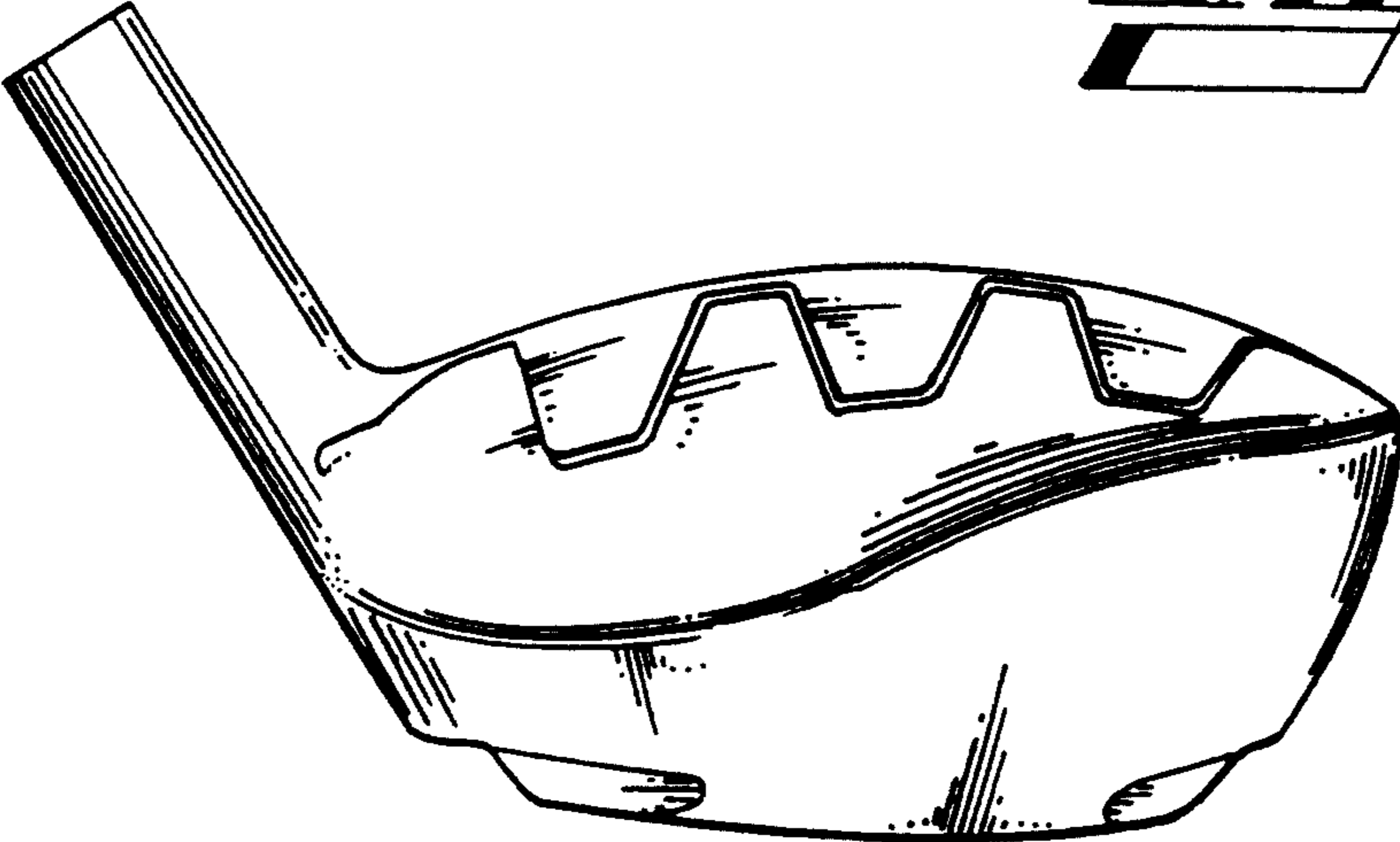
