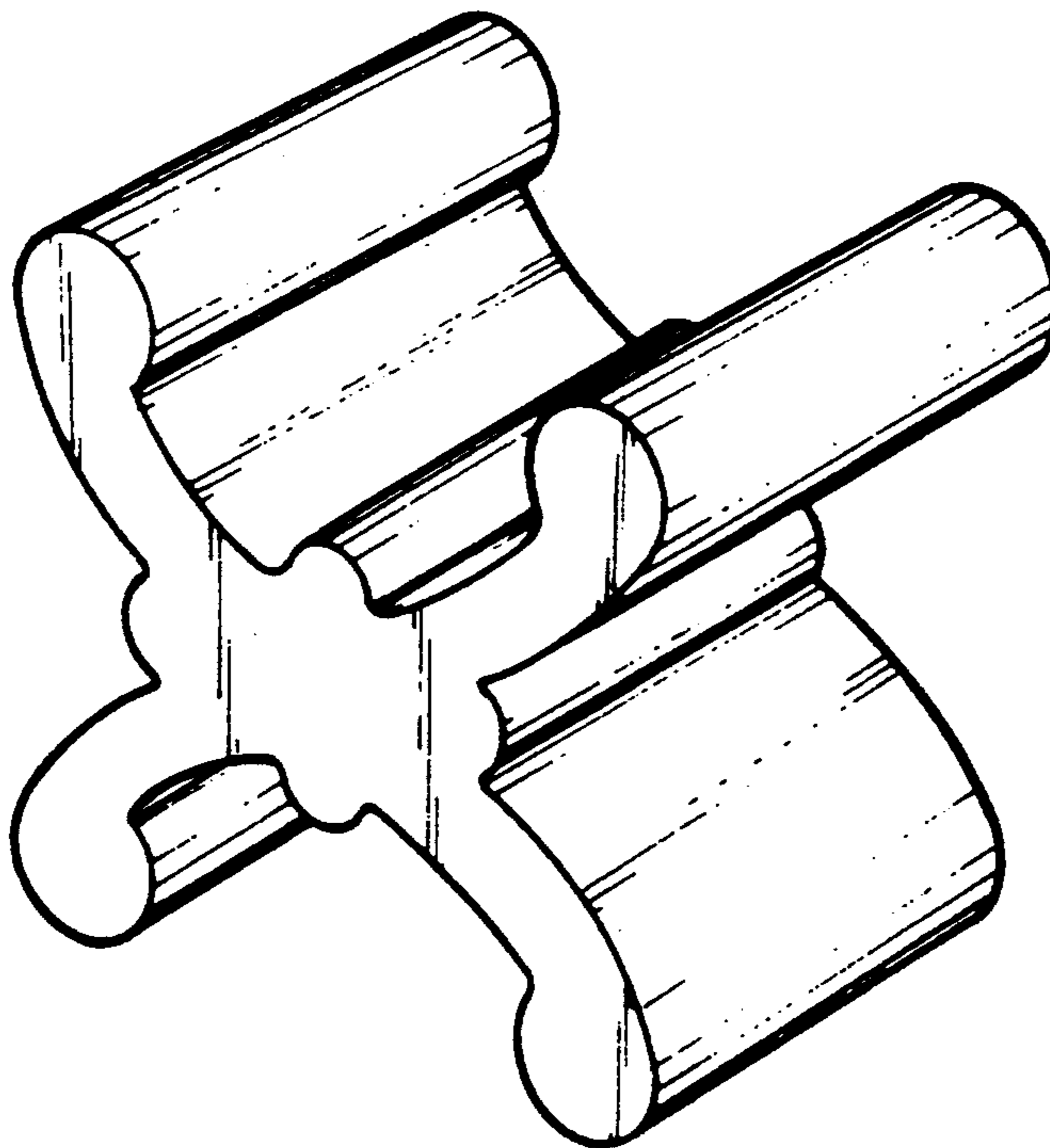

### DESCRIPTION

FIG. 1 is a perspective view showing my new design of a saddle packing element;  
 FIG. 2 is a front elevational view thereof, the rear view being identical;  
 FIG. 3 is a top plan view thereof, the bottom view being identical; and,  
 FIG. 4 is a side elevational view thereof, the opposite side being identical.



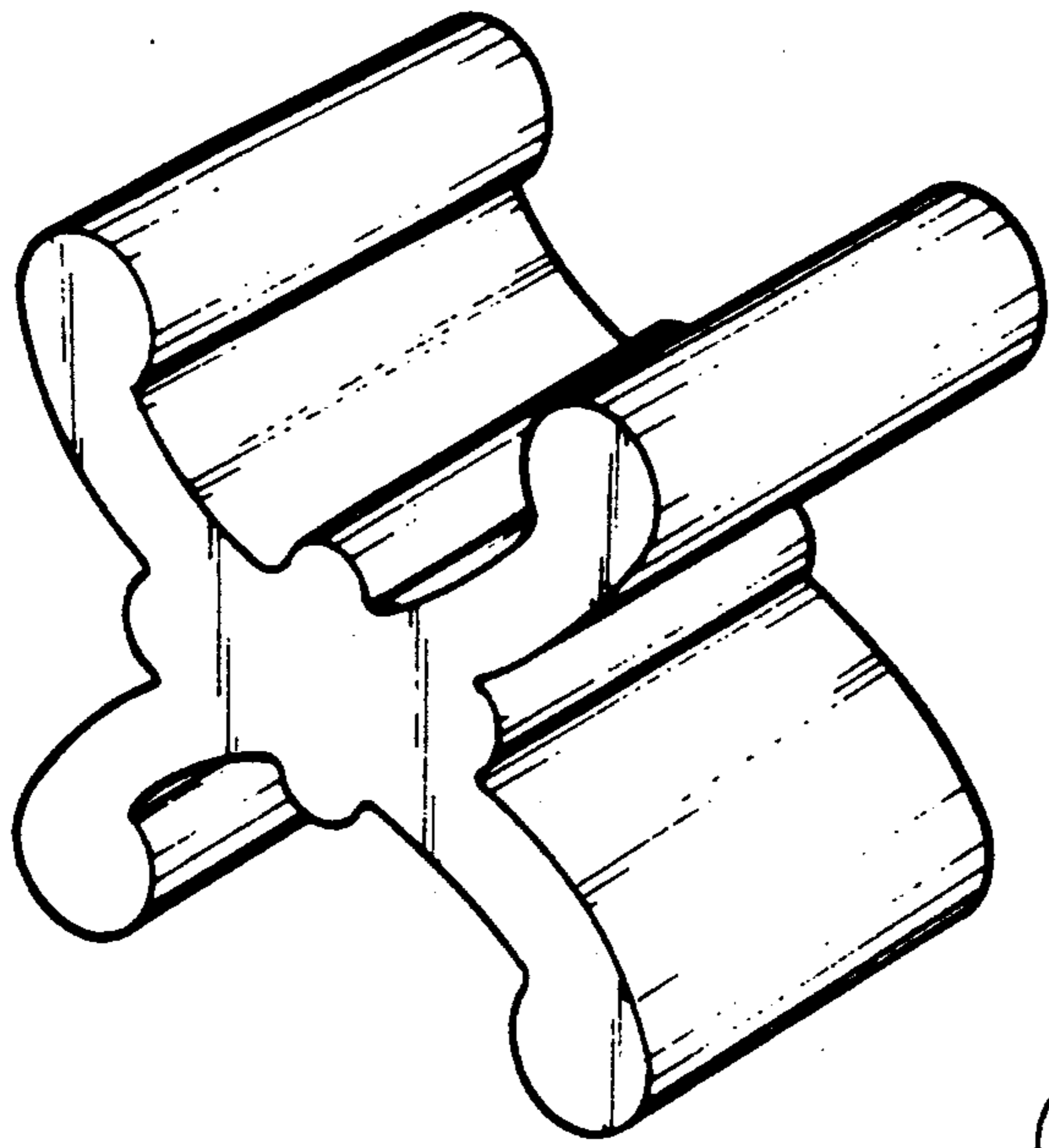

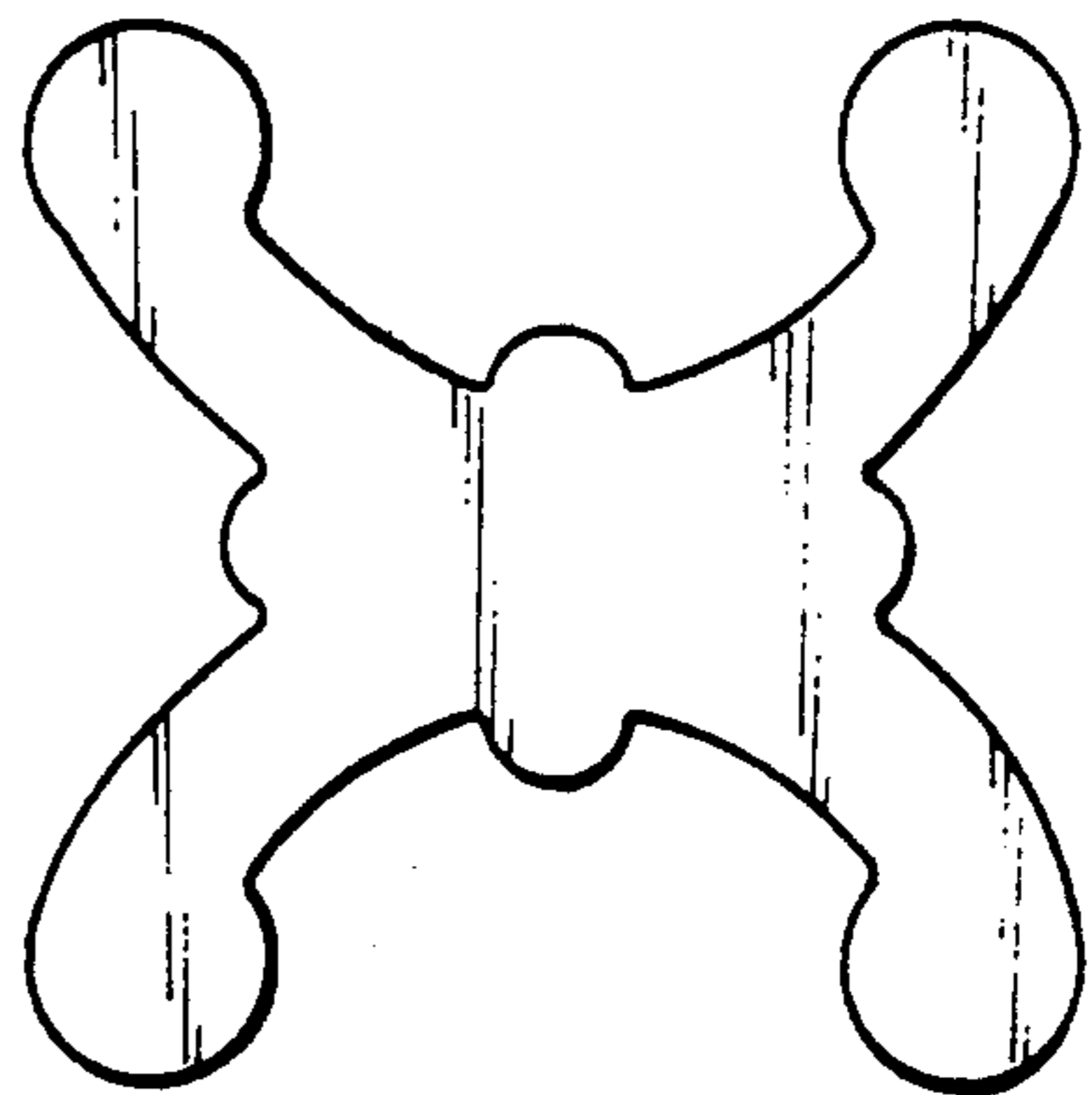

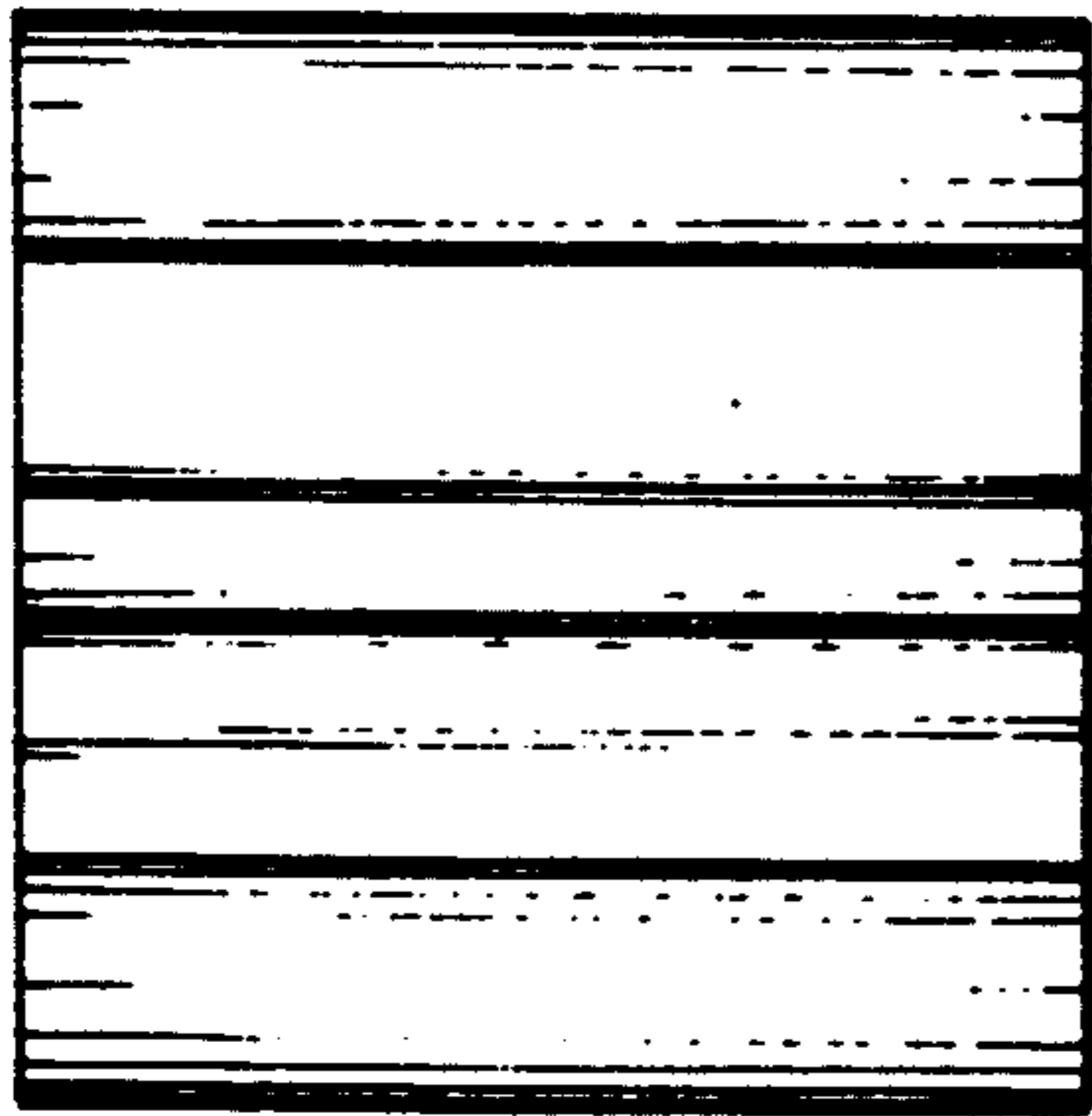

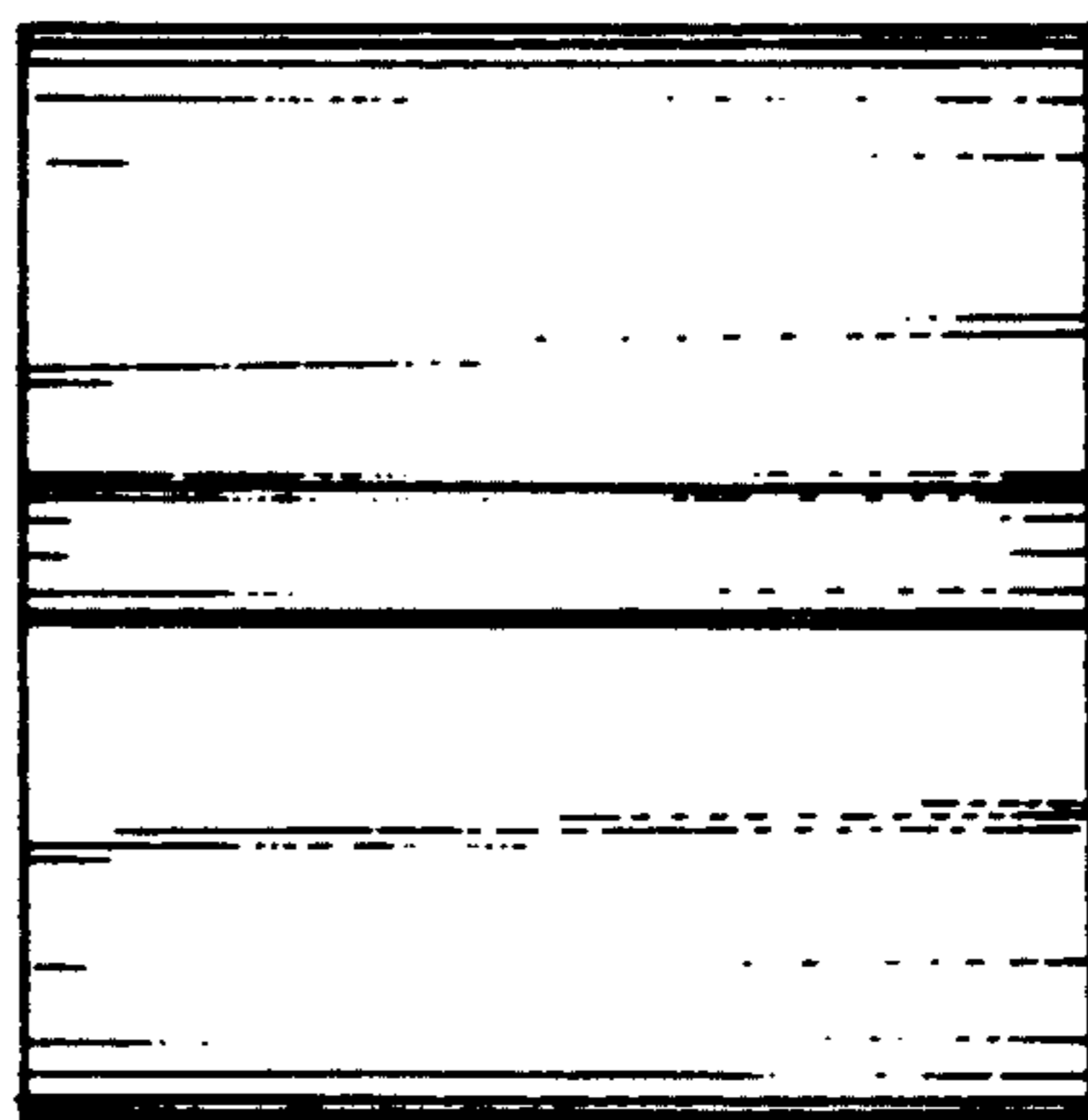
