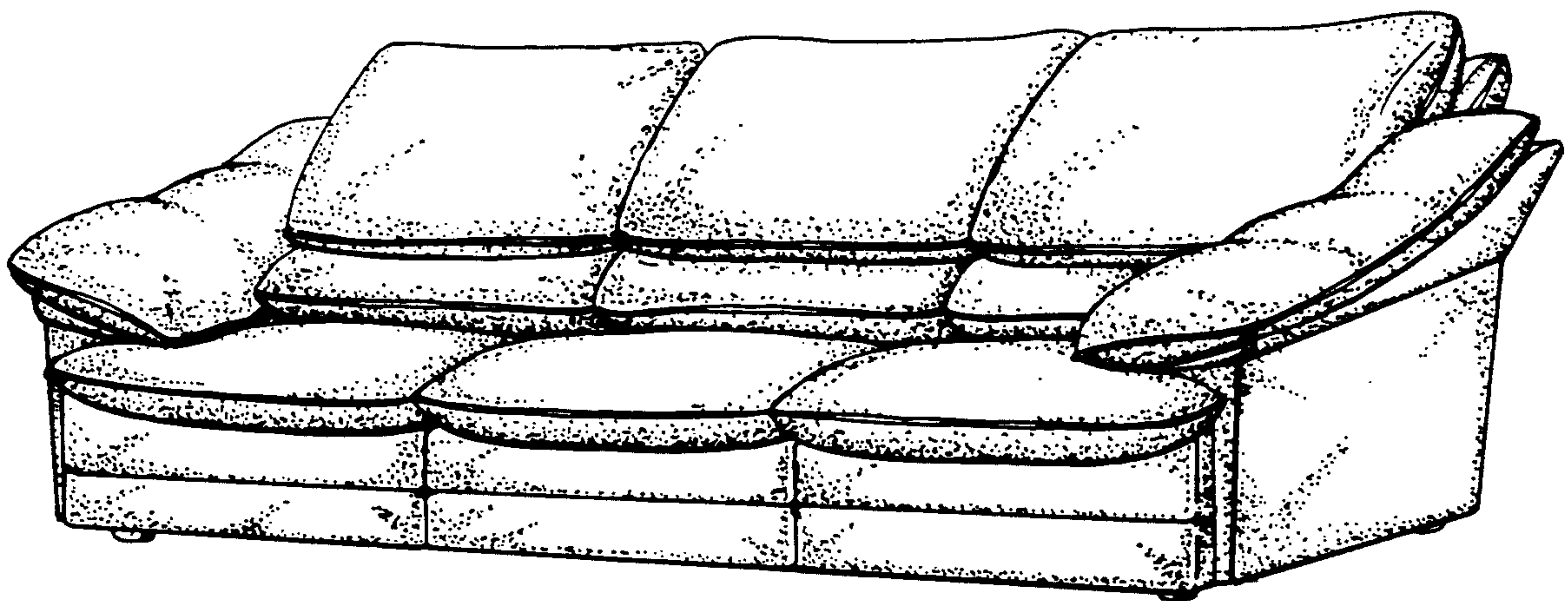

[57] CLAIM

The ornamental design for a seat, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a seat showing our new design in the form of a sofa;
FIG. 2 is a front elevational view;
FIG. 3 is a left side elevational view;
FIG. 4 is a left side elevational view showing the seat in an alternative position;
FIG. 5 is a rear perspective view of FIG. 4;
FIG. 6 is a front elevational view of a seat showing a second embodiment of our new design in the form of an armchair;
FIG. 7 is a left side elevational view of FIG. 6; and,
FIG. 8 is a left side elevational view of FIG. 6 showing the seat in an alternative position.



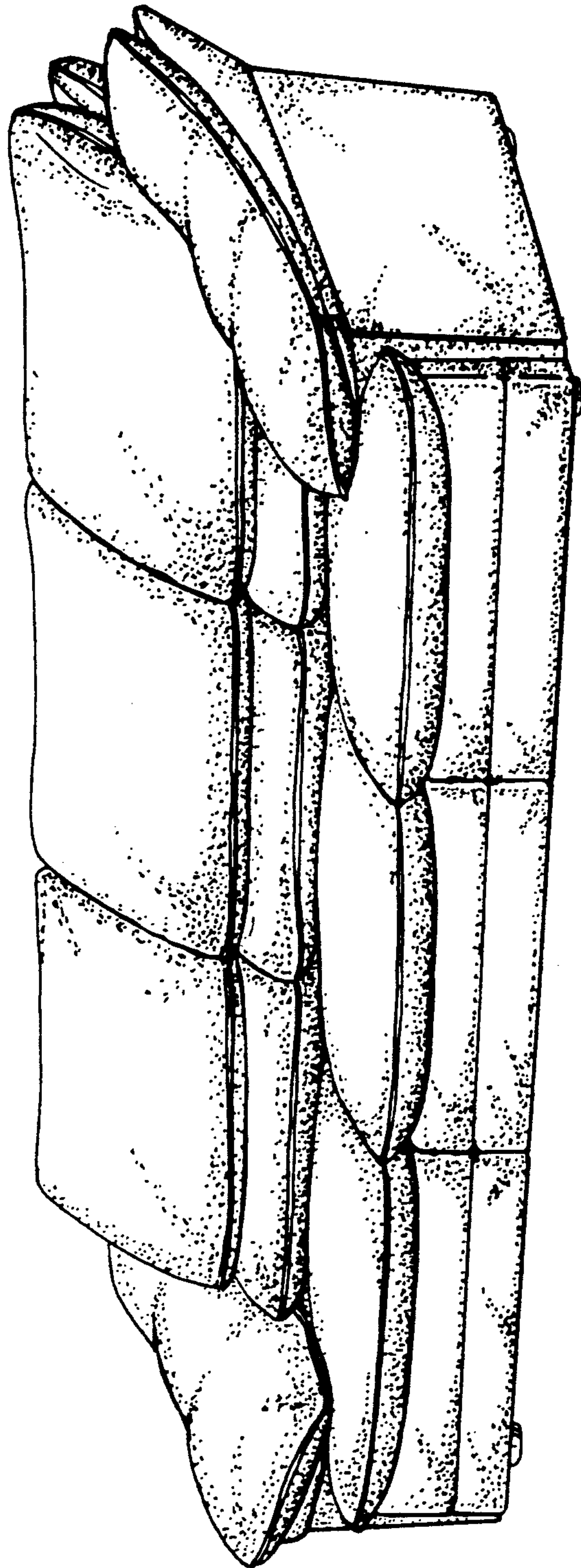

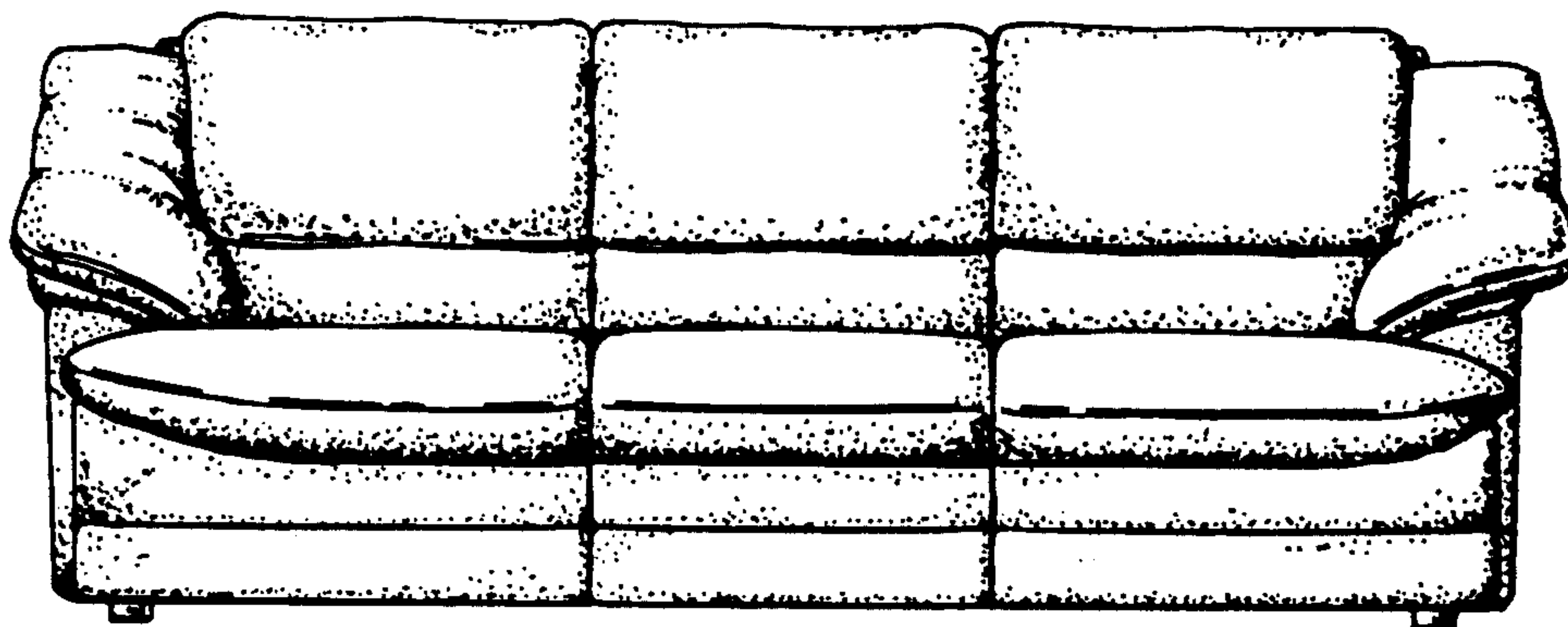

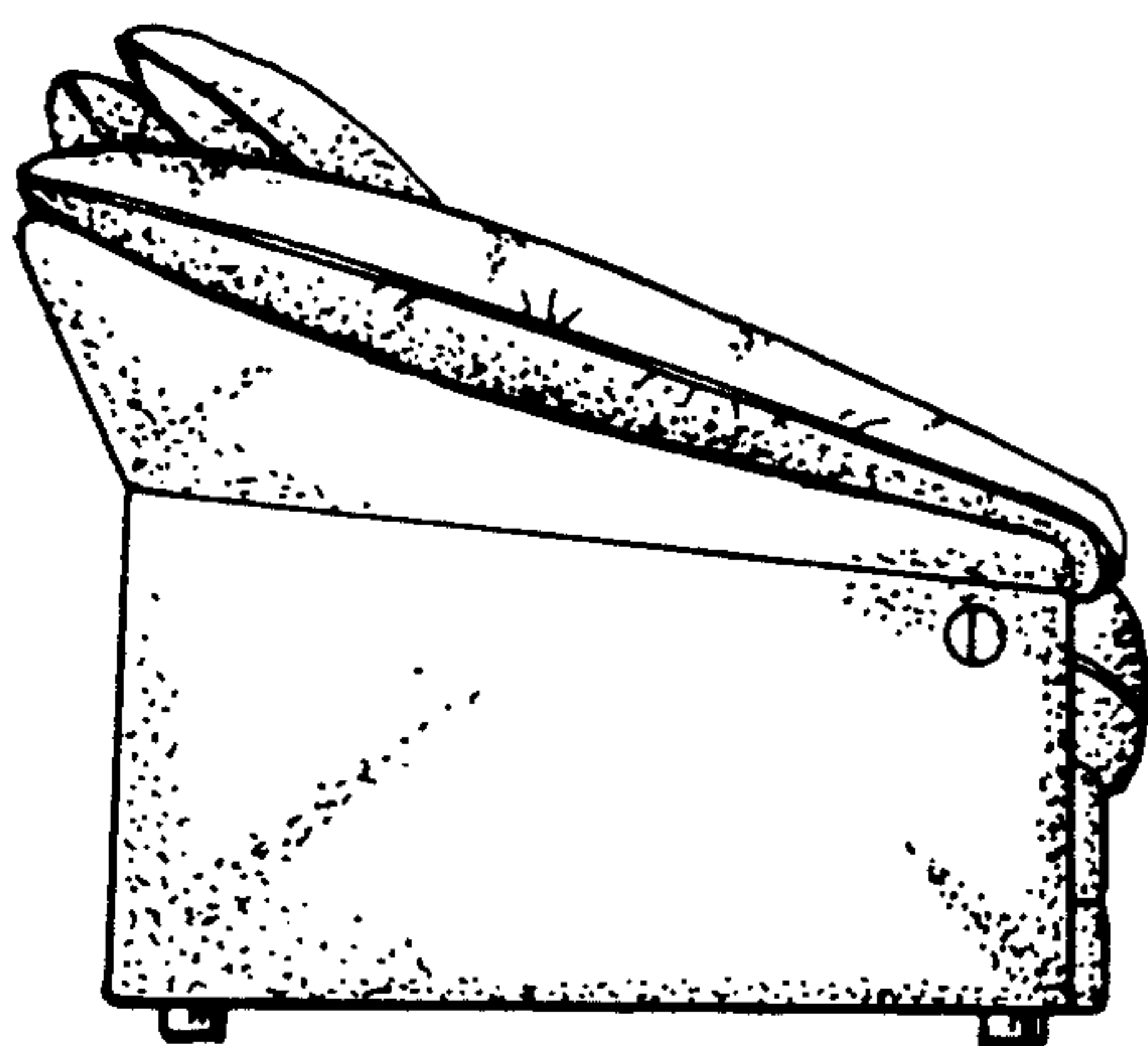

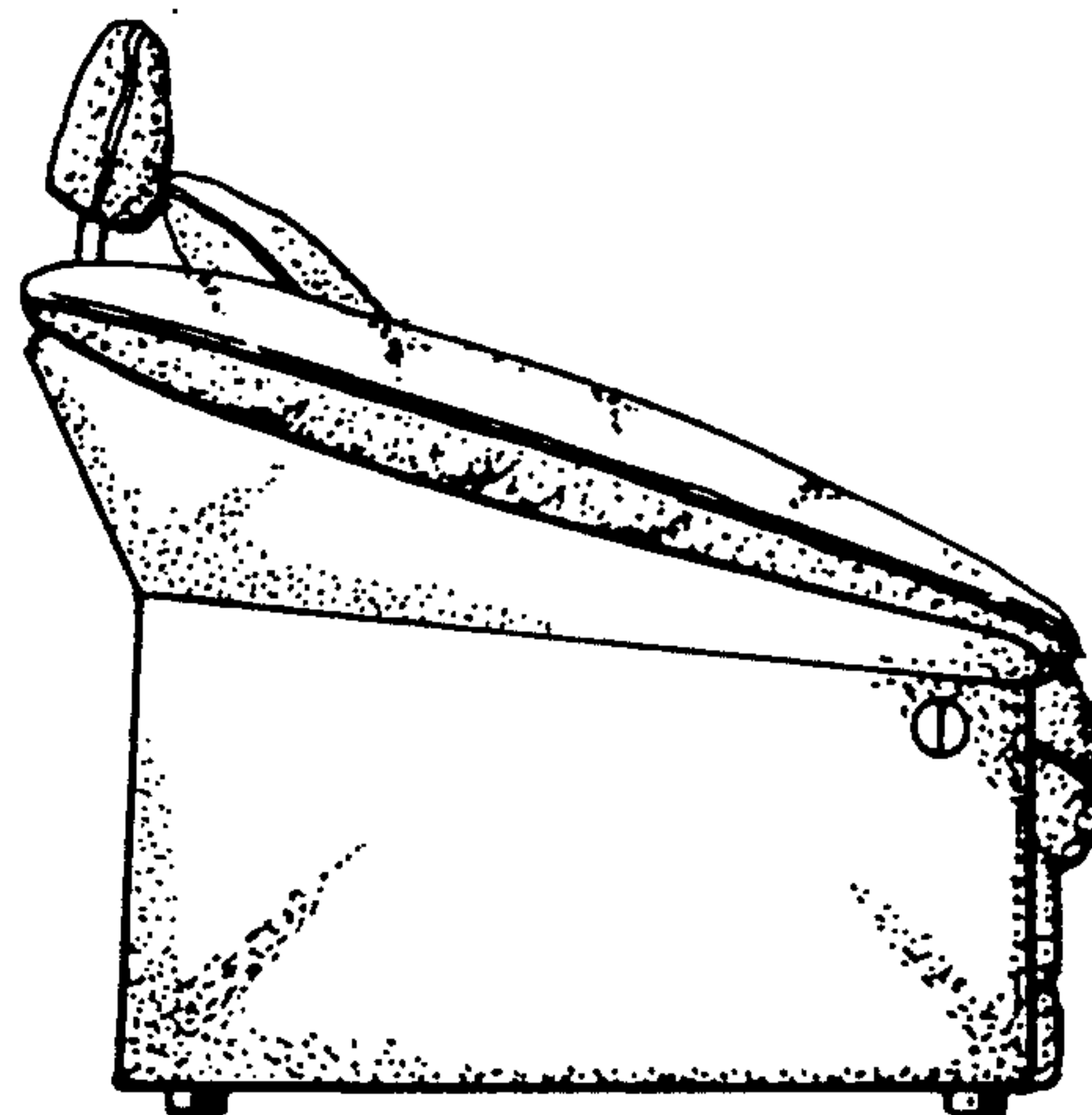

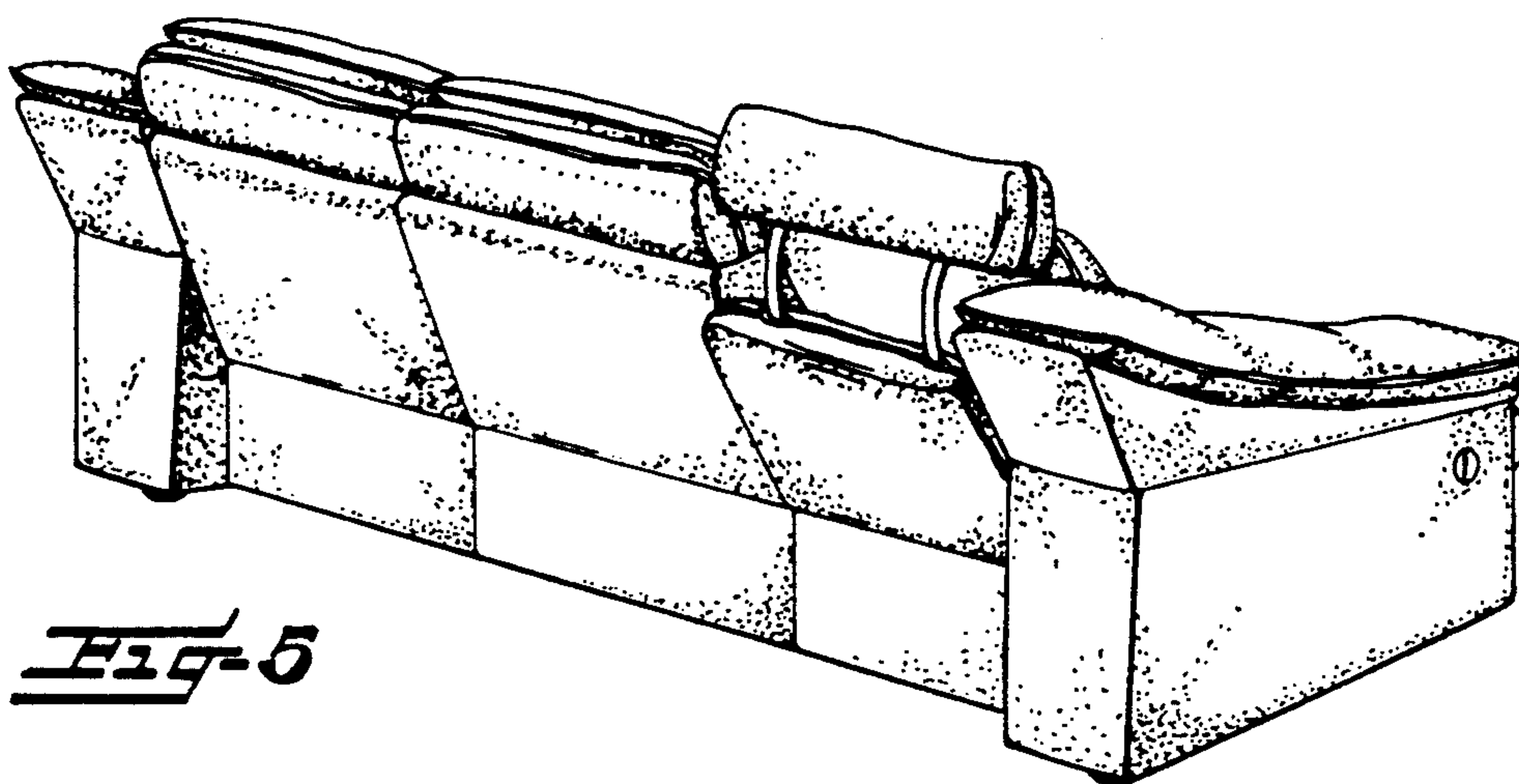

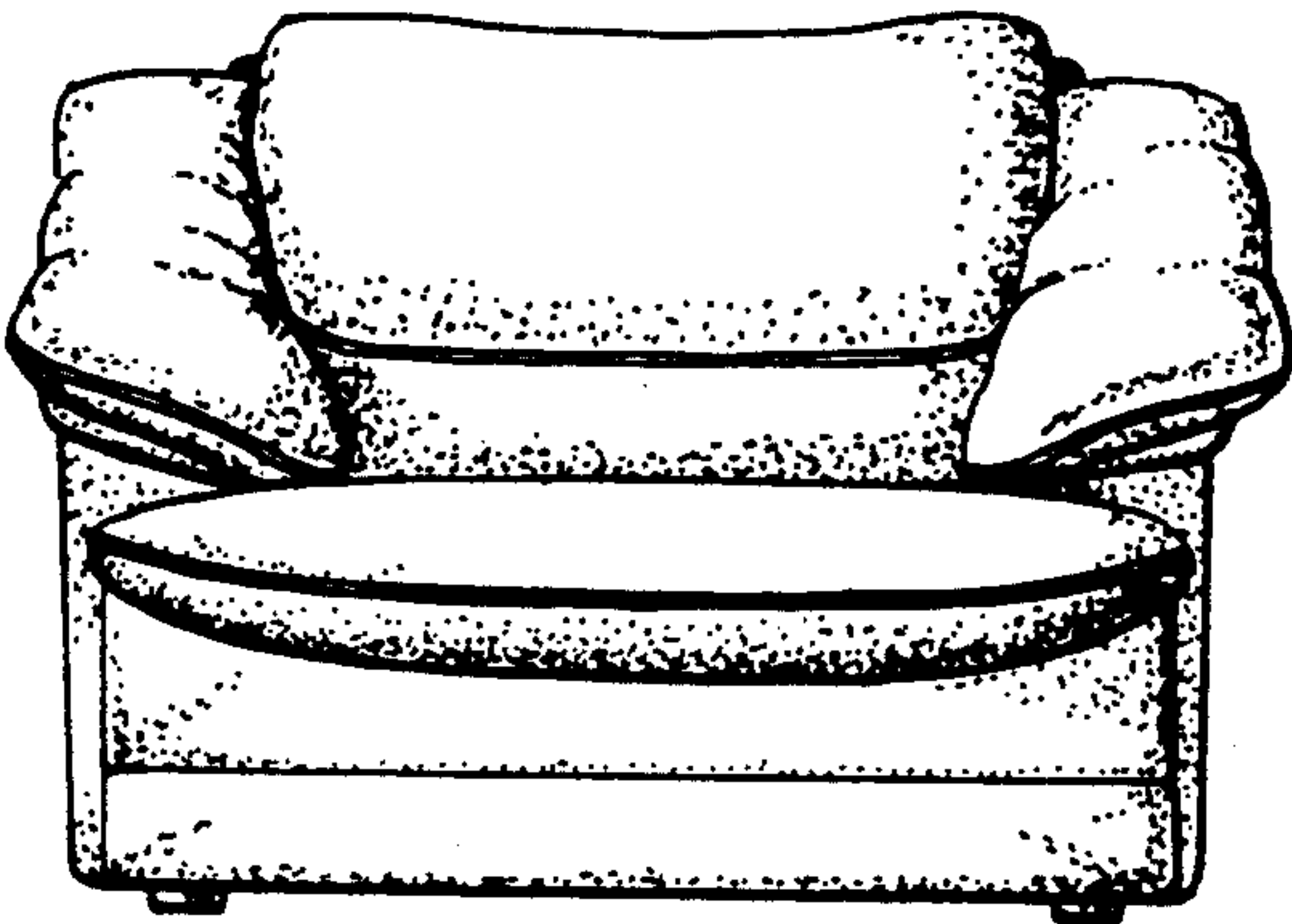

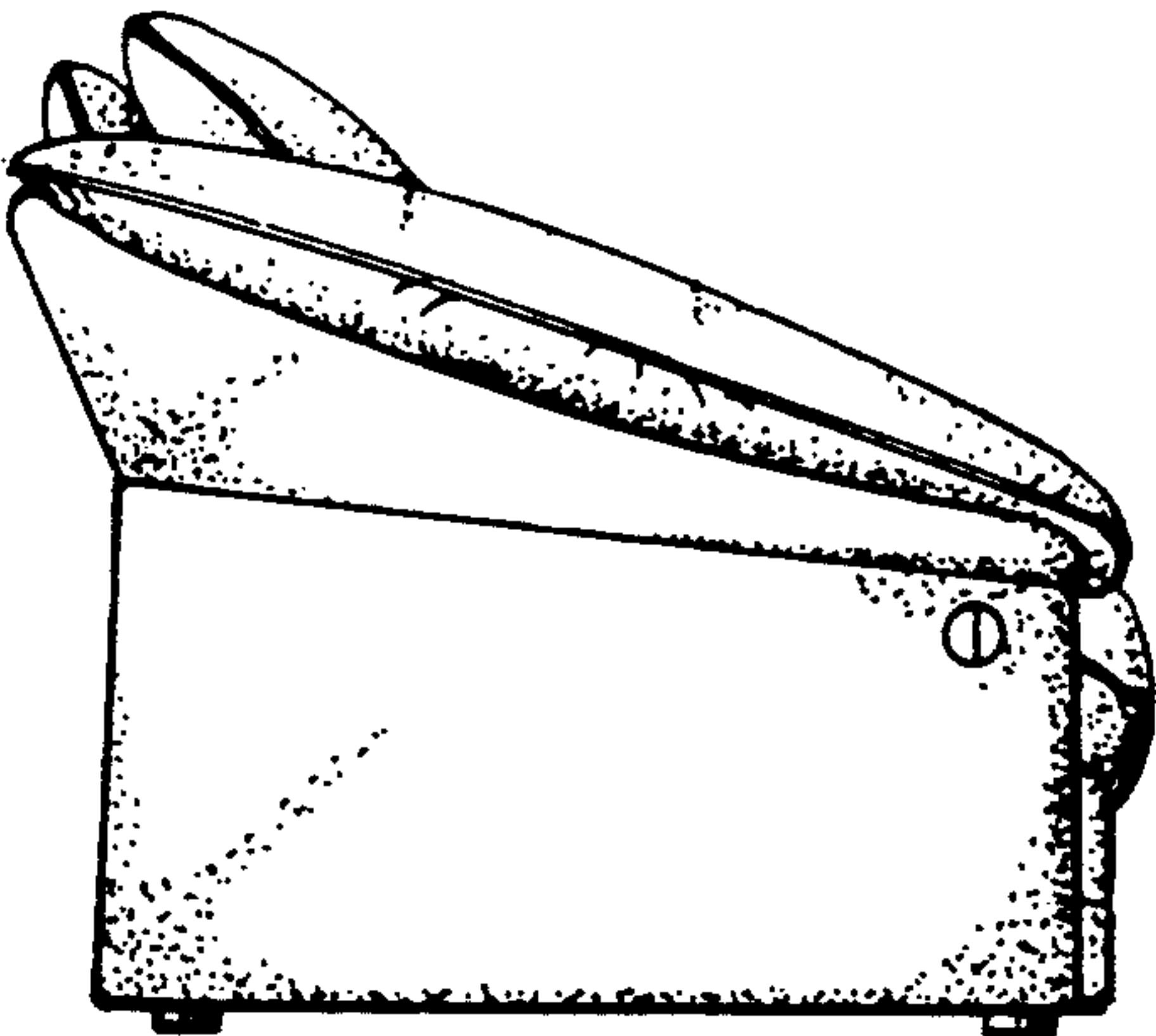

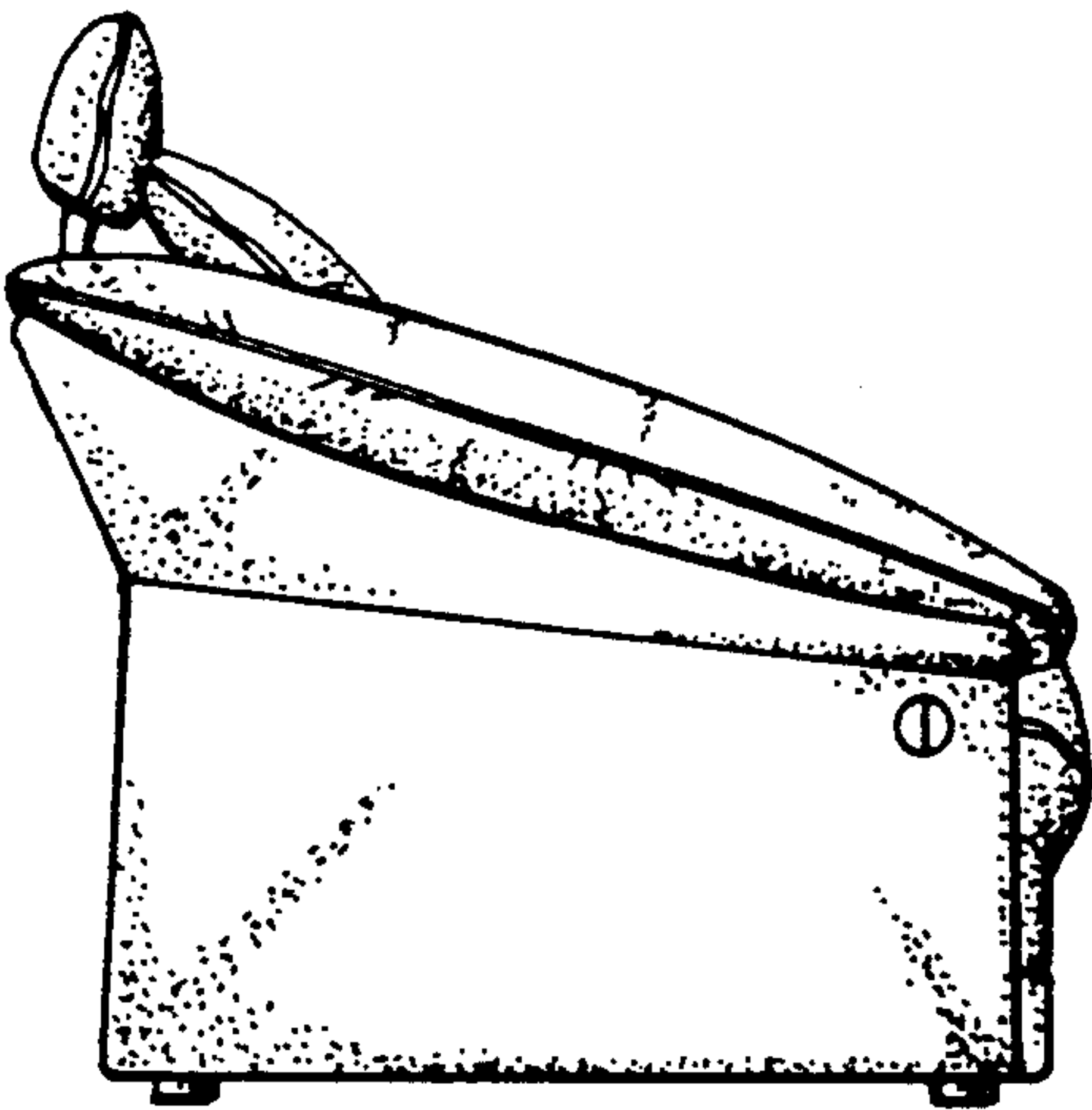
