The ornamental design for a bottle, as shown and described.

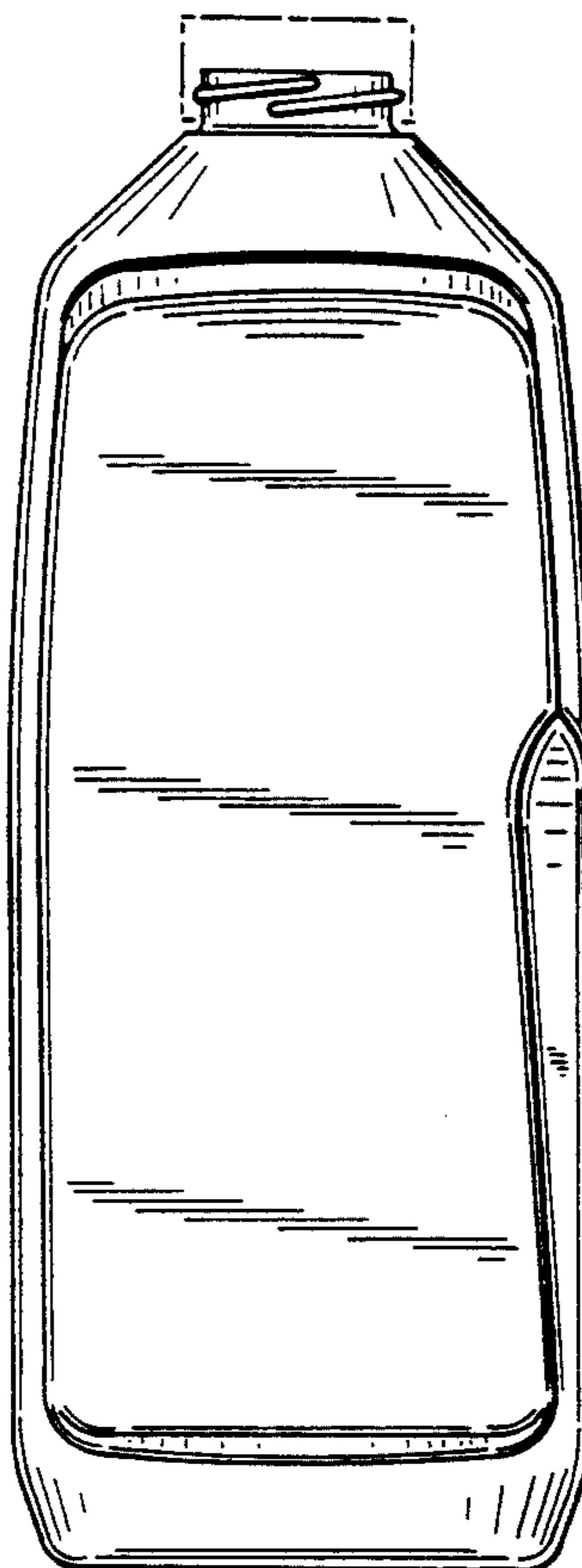
### DESCRIPTION

FIG. 1 is a front elevational view of a bottle showing our new design;  
FIG. 2 is a side elevational view thereof, rotated 90° from FIG. 1;  
FIG. 3 is a rear elevational view thereof, rotated 180° from FIG. 1;  
FIG. 4 is a side elevational view rotated 270° from FIG. 1;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom plan view thereof; and,  
FIG. 7 is a perspective view thereof.

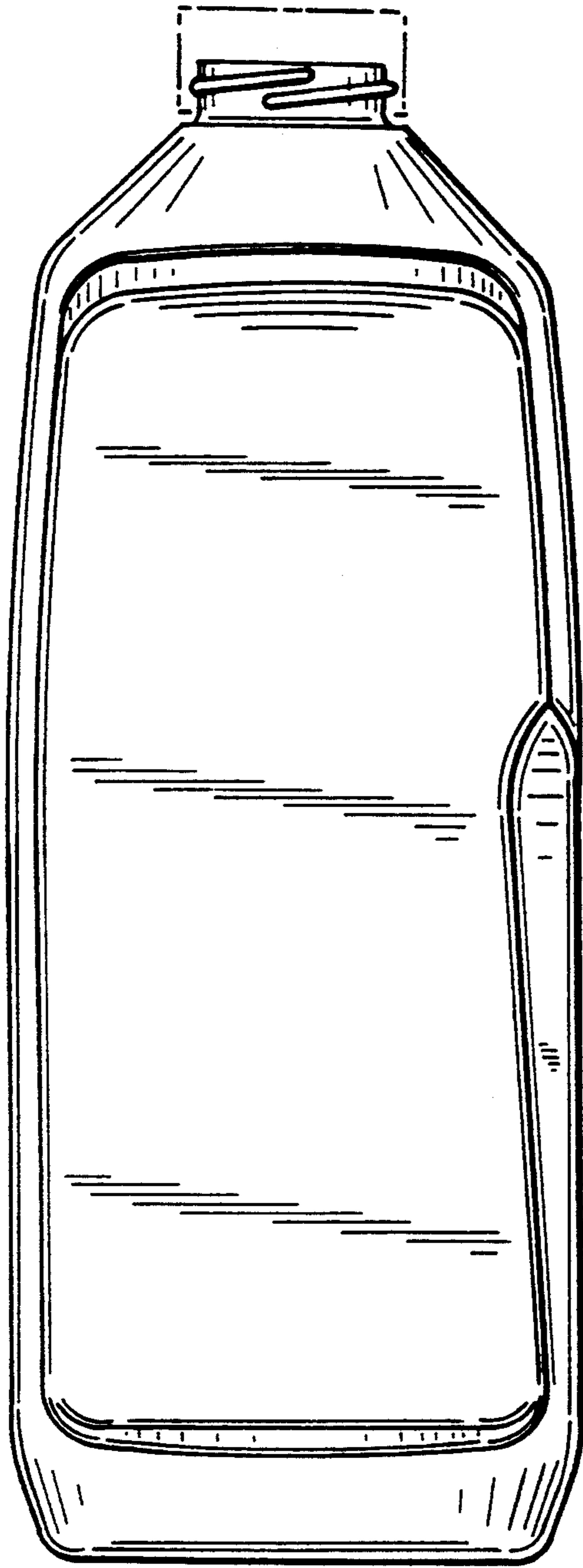

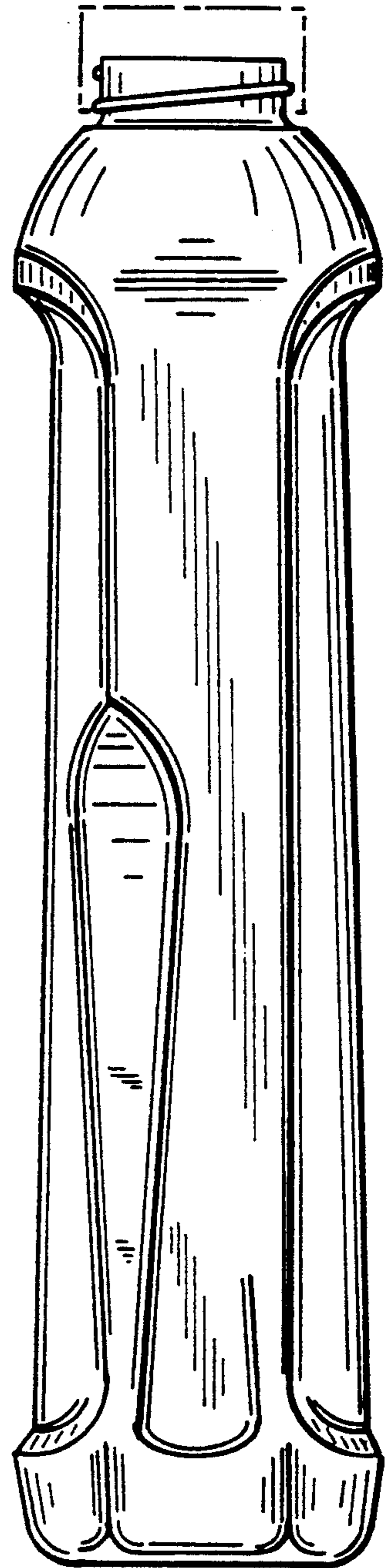

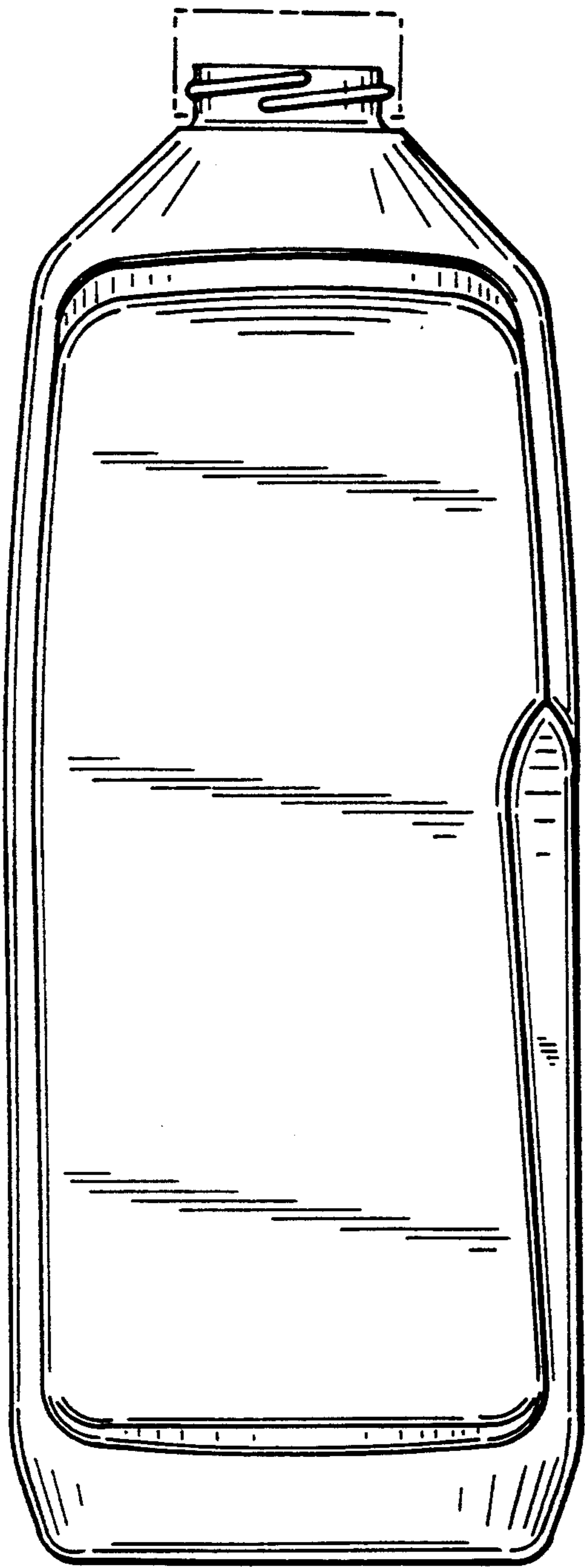

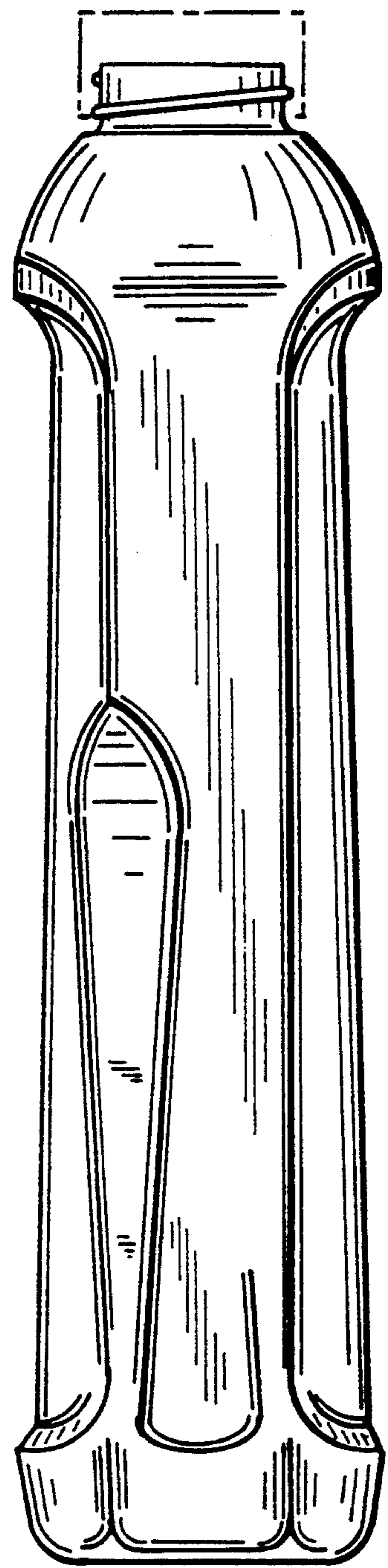

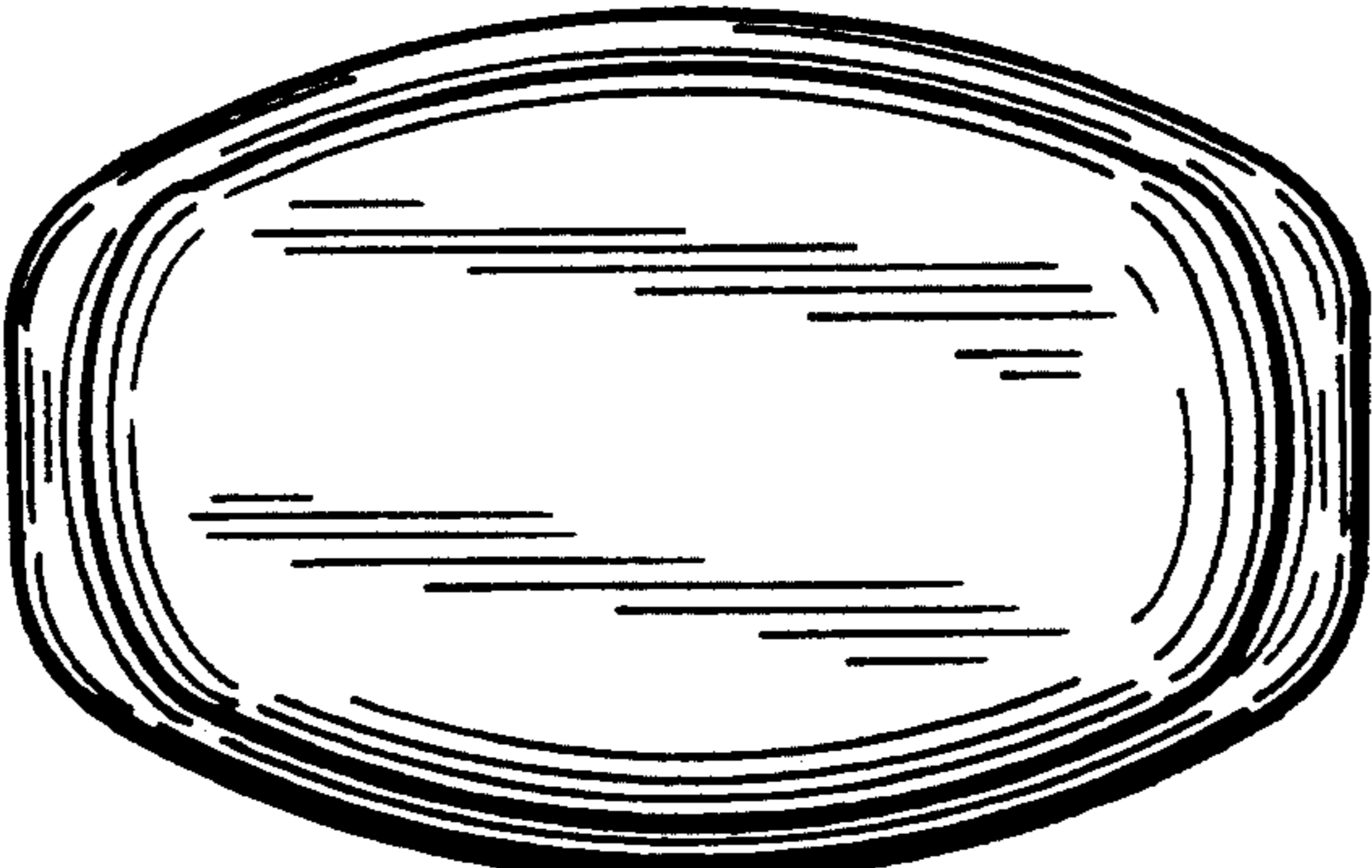
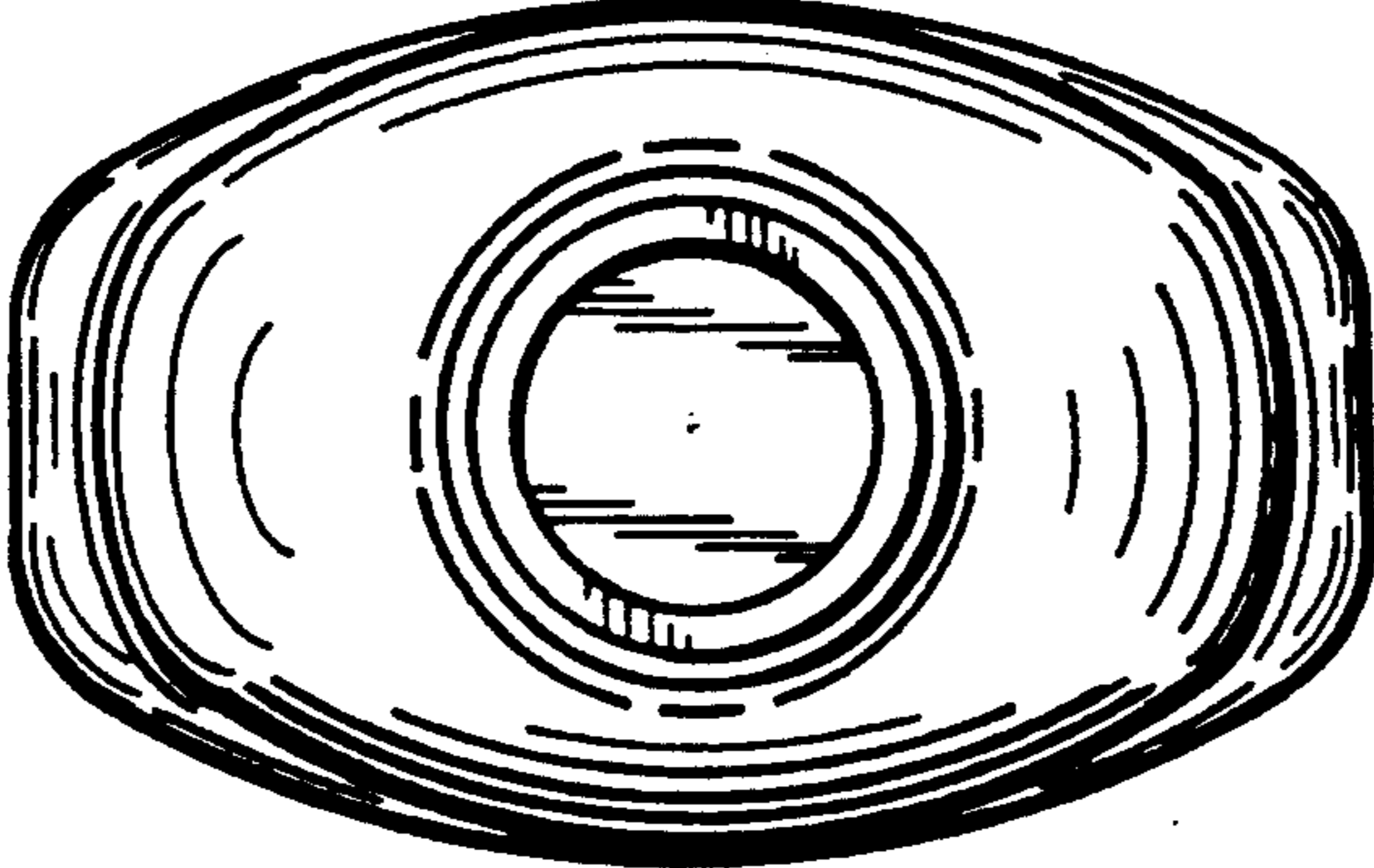
