## [57] CLAIM

The ornamental design for the outsole of a shoe, as shown and described.

## DESCRIPTION

FIG. 1 is a bottom plan view of a shoe outsole showing my new design;

FIG. 2 is a side elevational view of a shoe outsole as shown in FIG. 1;

FIG. 3 is a side elevational view of the other side of a shoe outsole shown in FIG. 1;

FIG. 4 is a cross section taken through line 4—4 of FIG. 1;

FIG. 5 is a cross section taken through line 5—5 of FIG. 1;

FIG. 6 is a cross section taken through line 6—6 of FIG. 1; and,

FIG. 7 is a cross section taken through line 7—7 of FIG. 1.

The broken line showing the shoe upper in FIGS. 2 and 3 is for illustrative purposes and forms no part of the claimed design.

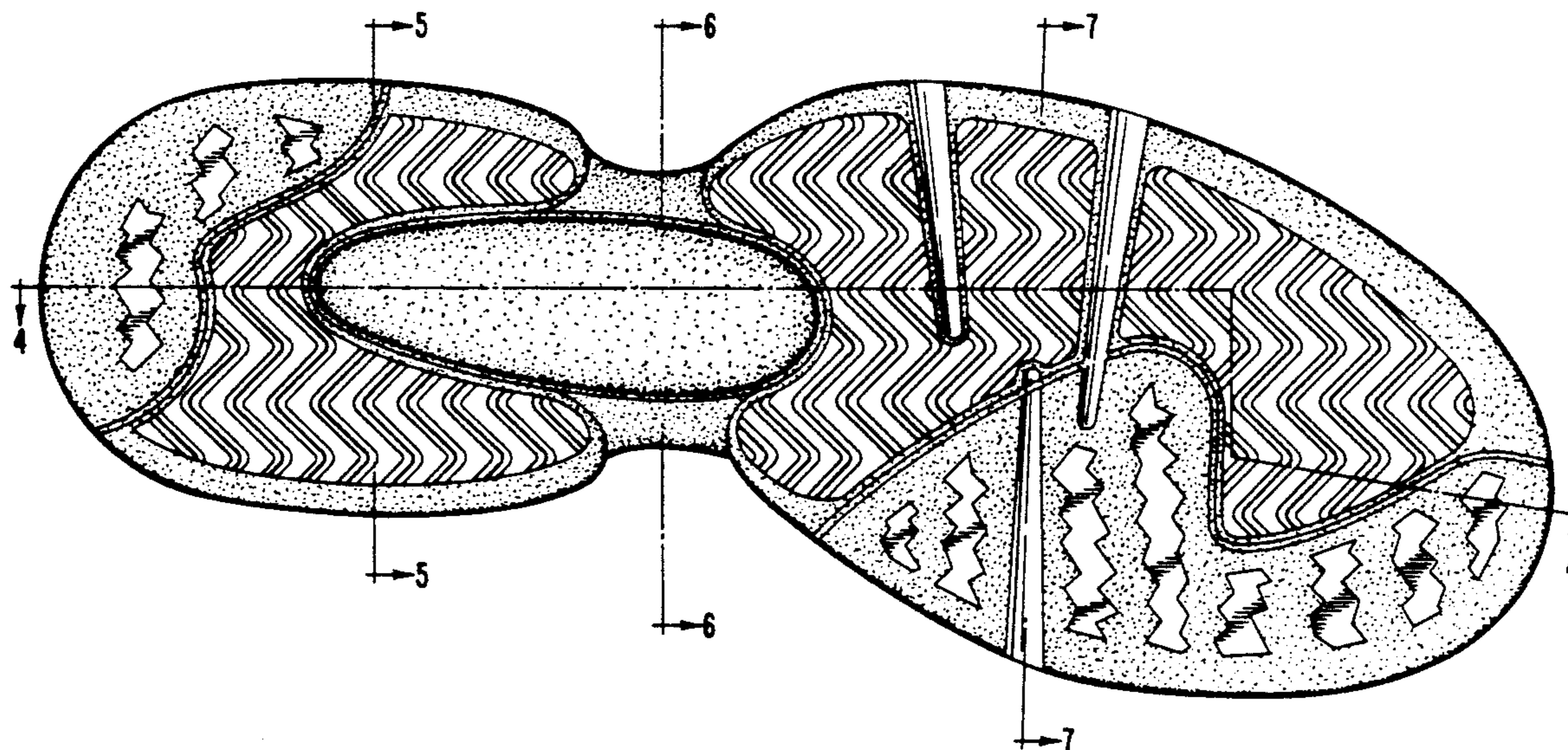
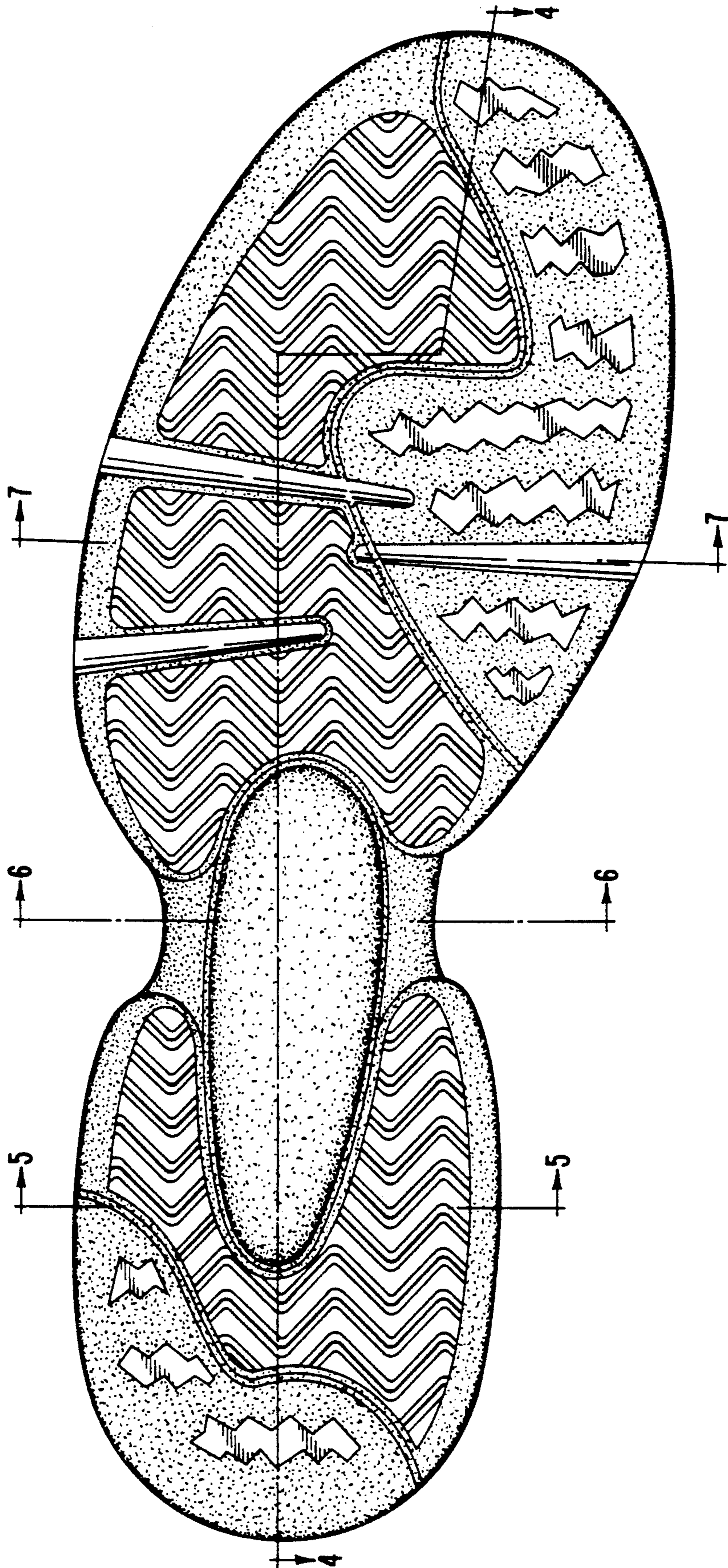

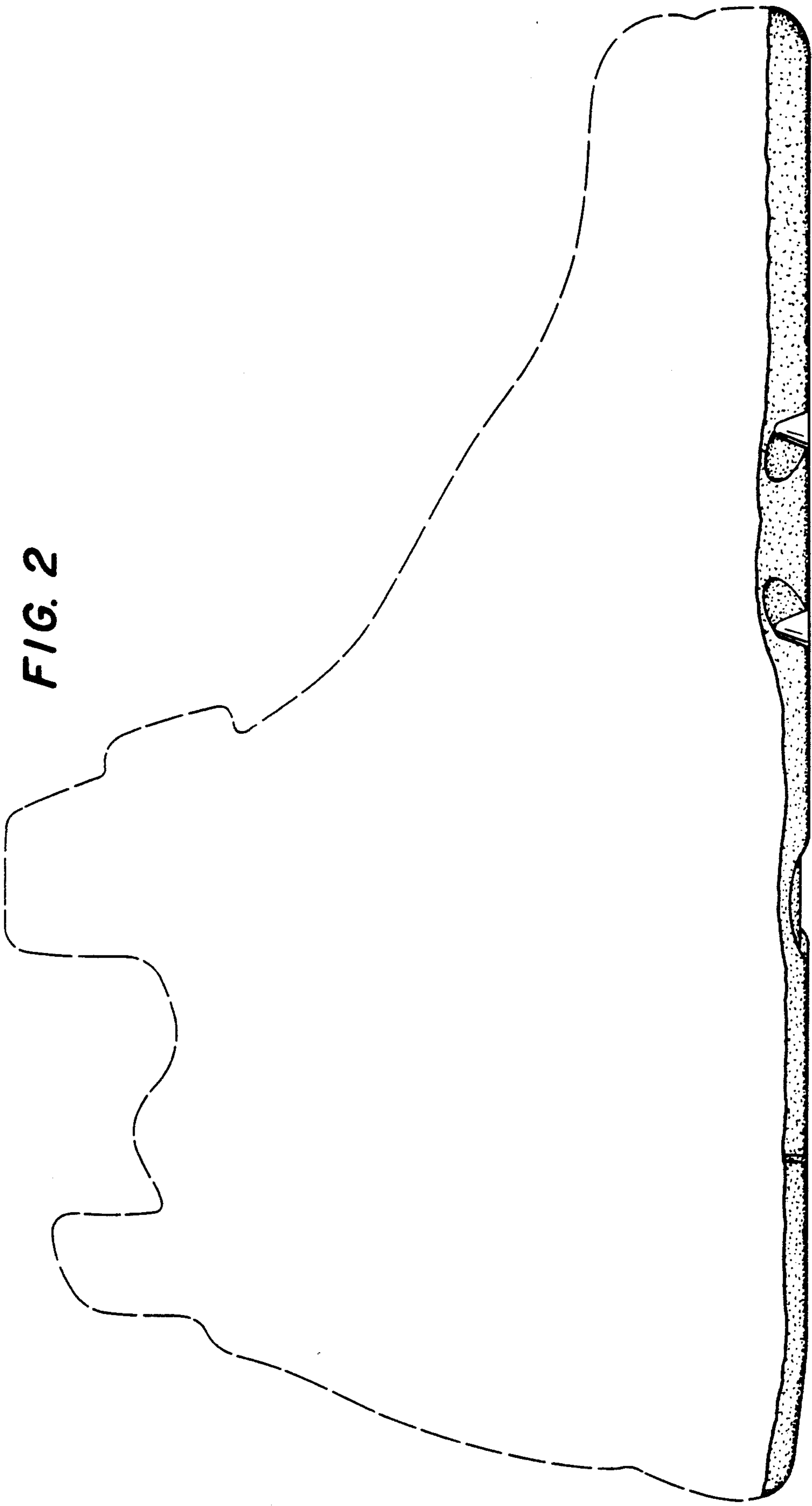

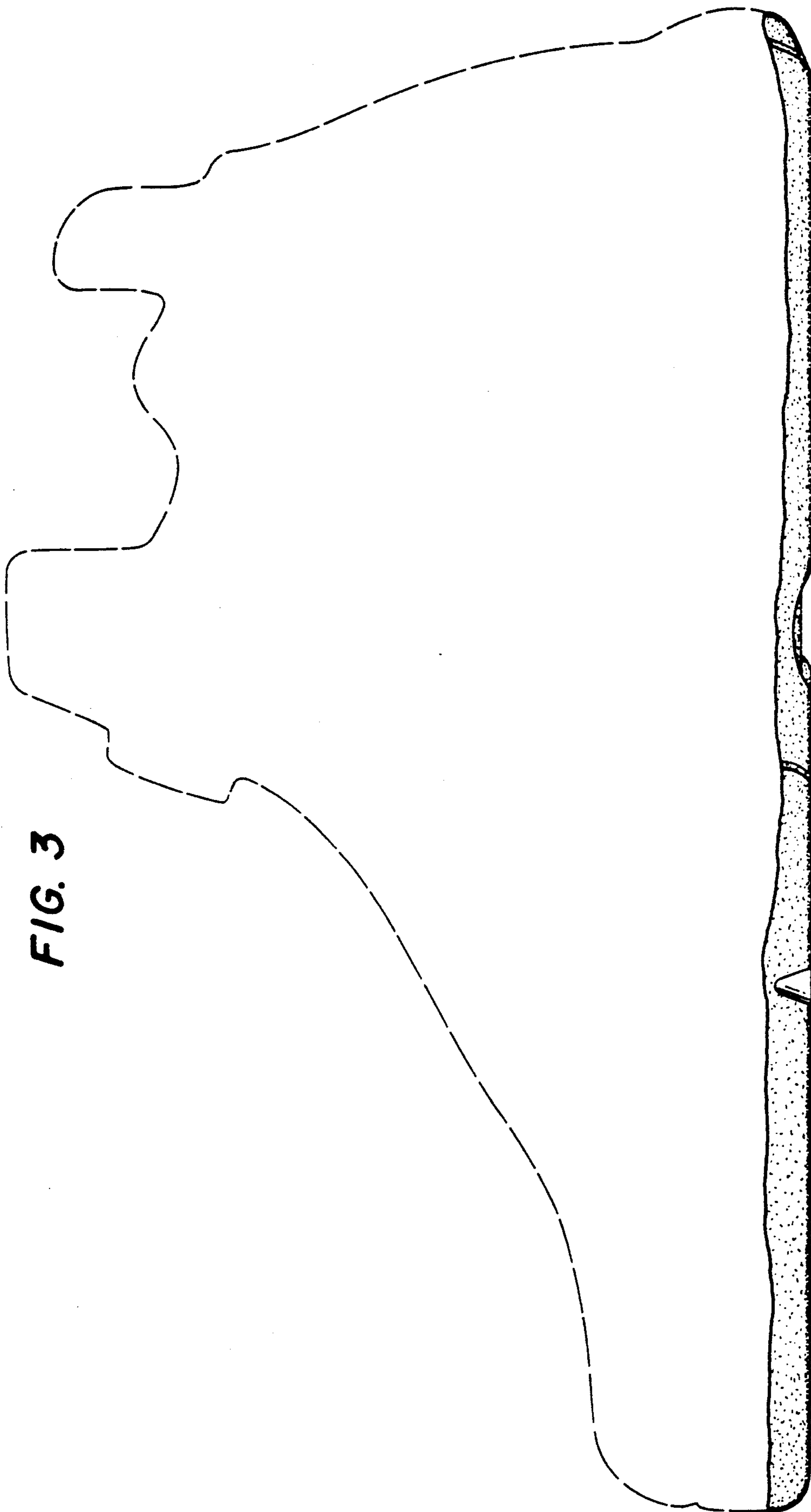
