**DESCRIPTION**

FIG. 10 is a top plan view thereof;

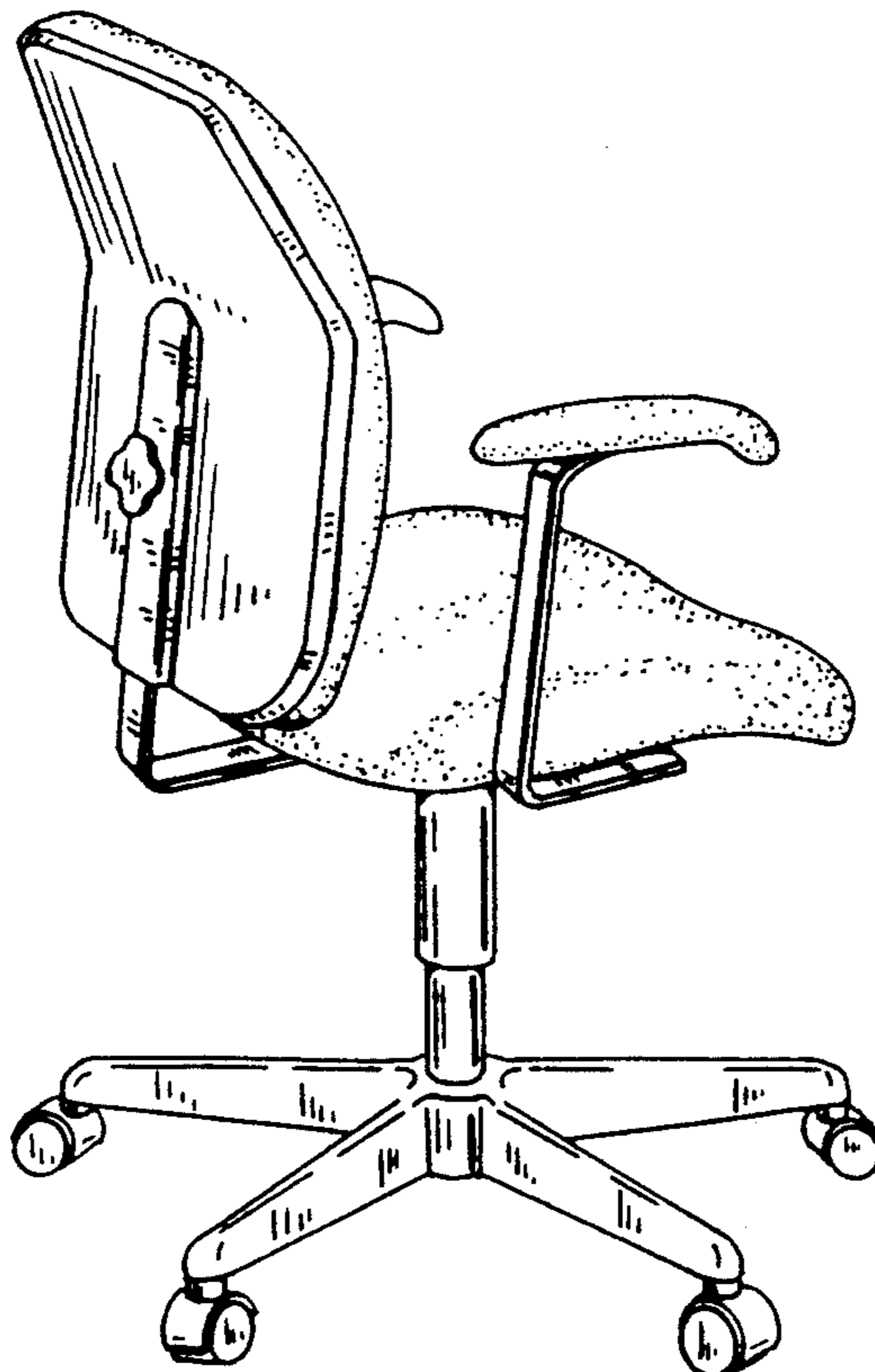
FIG. 11 is a perspective view of a second alternative embodiment of the chair design of the present invention;

FIG. 15 is a top plan view thereof.



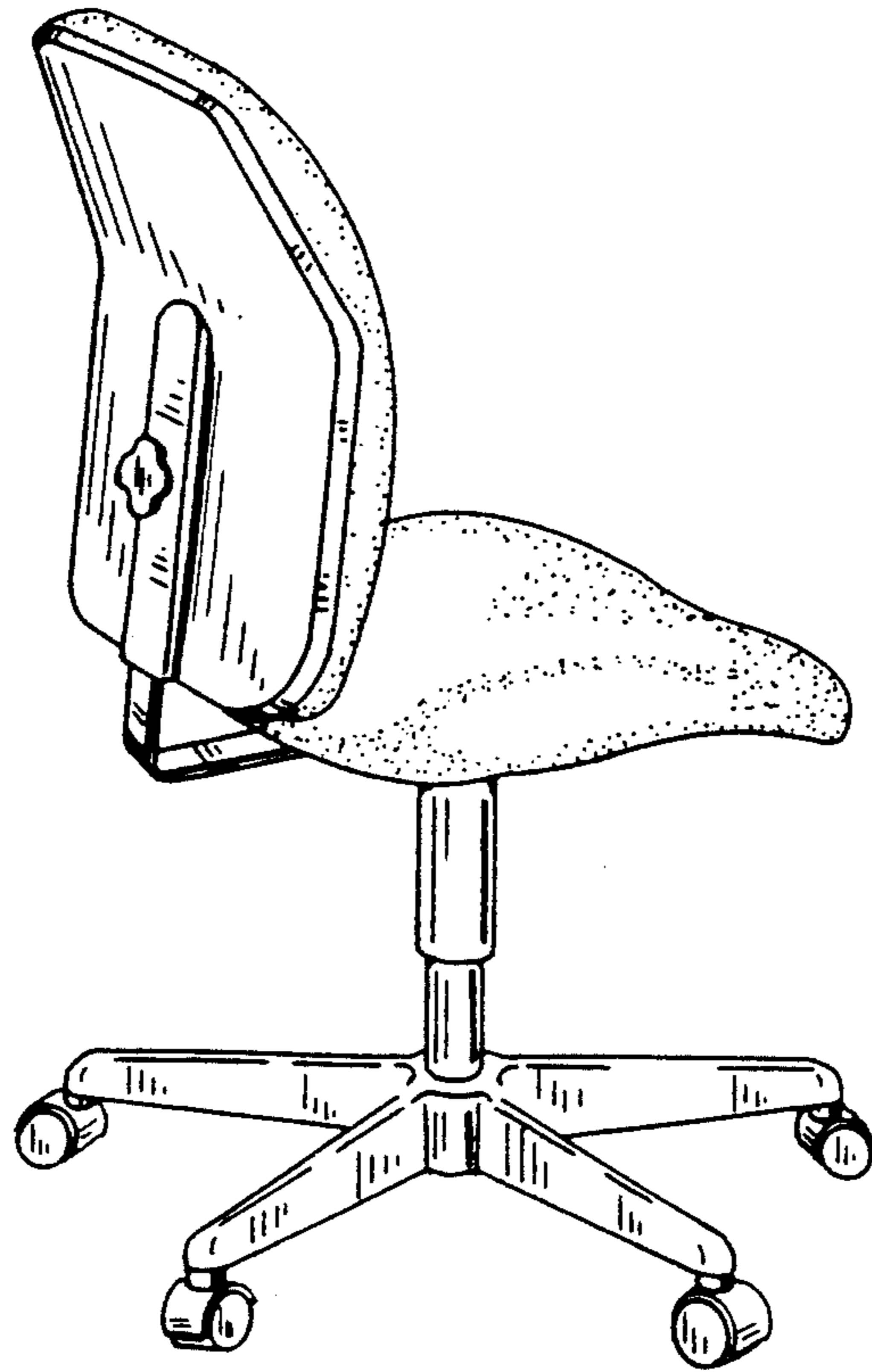

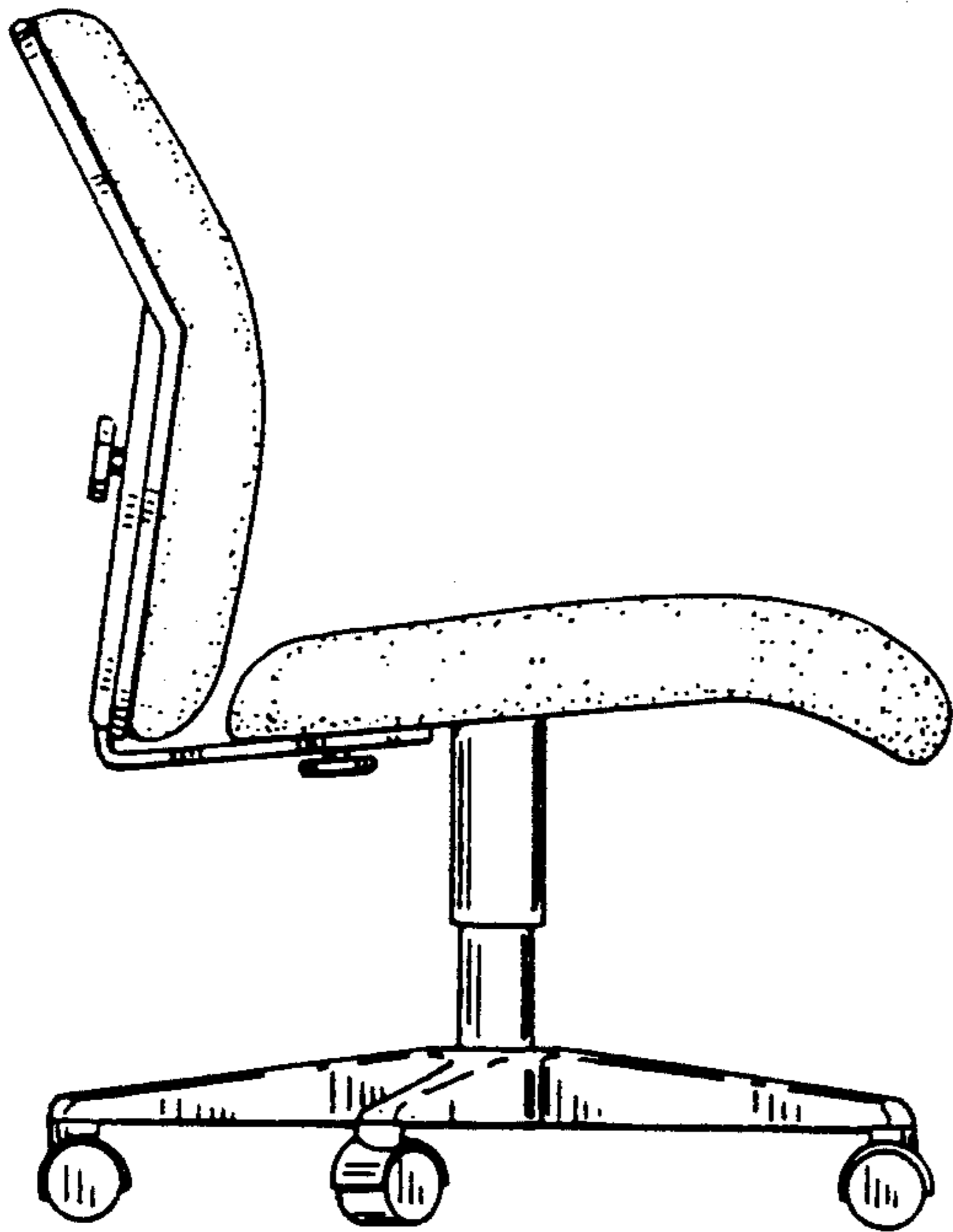

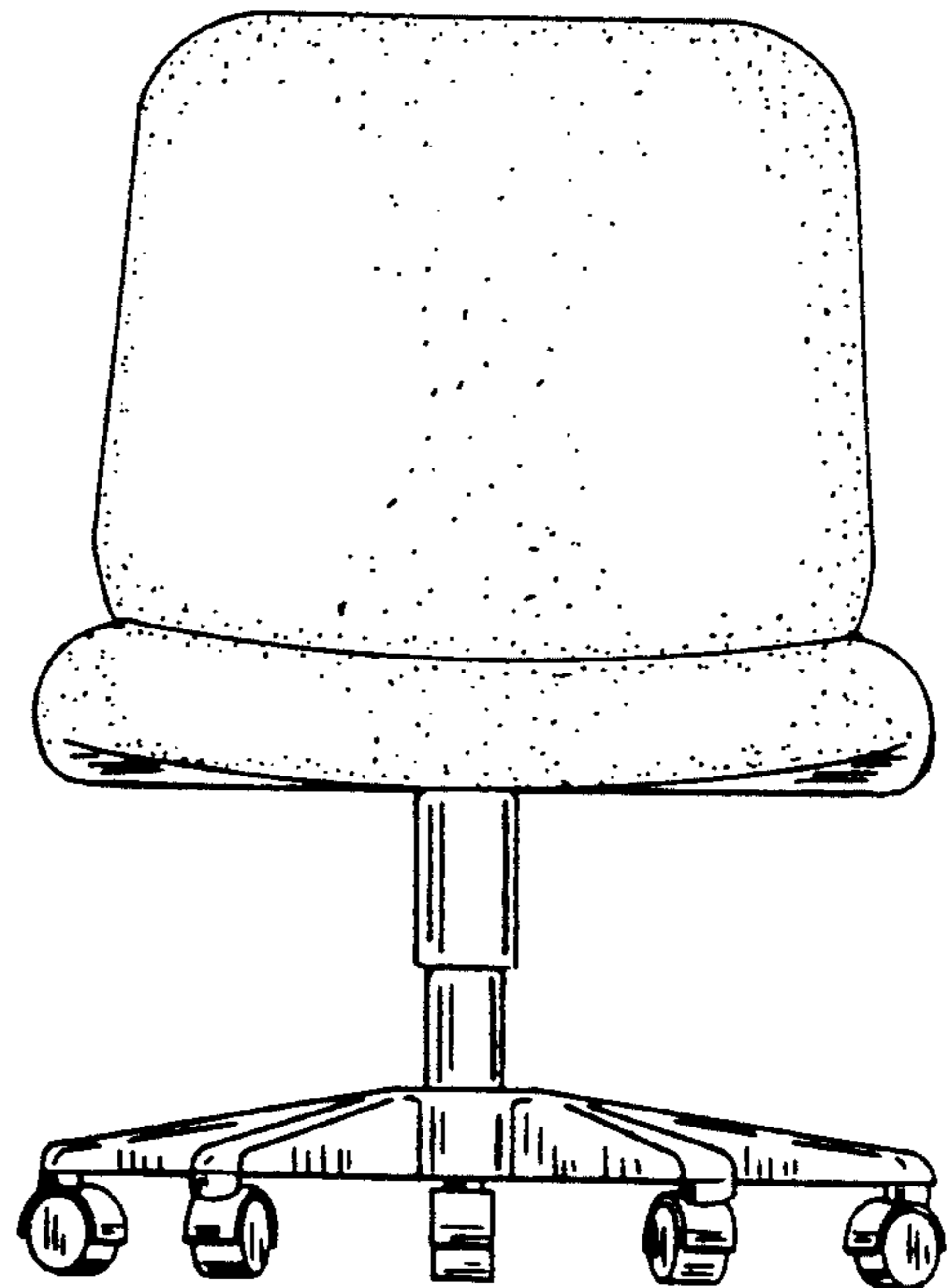

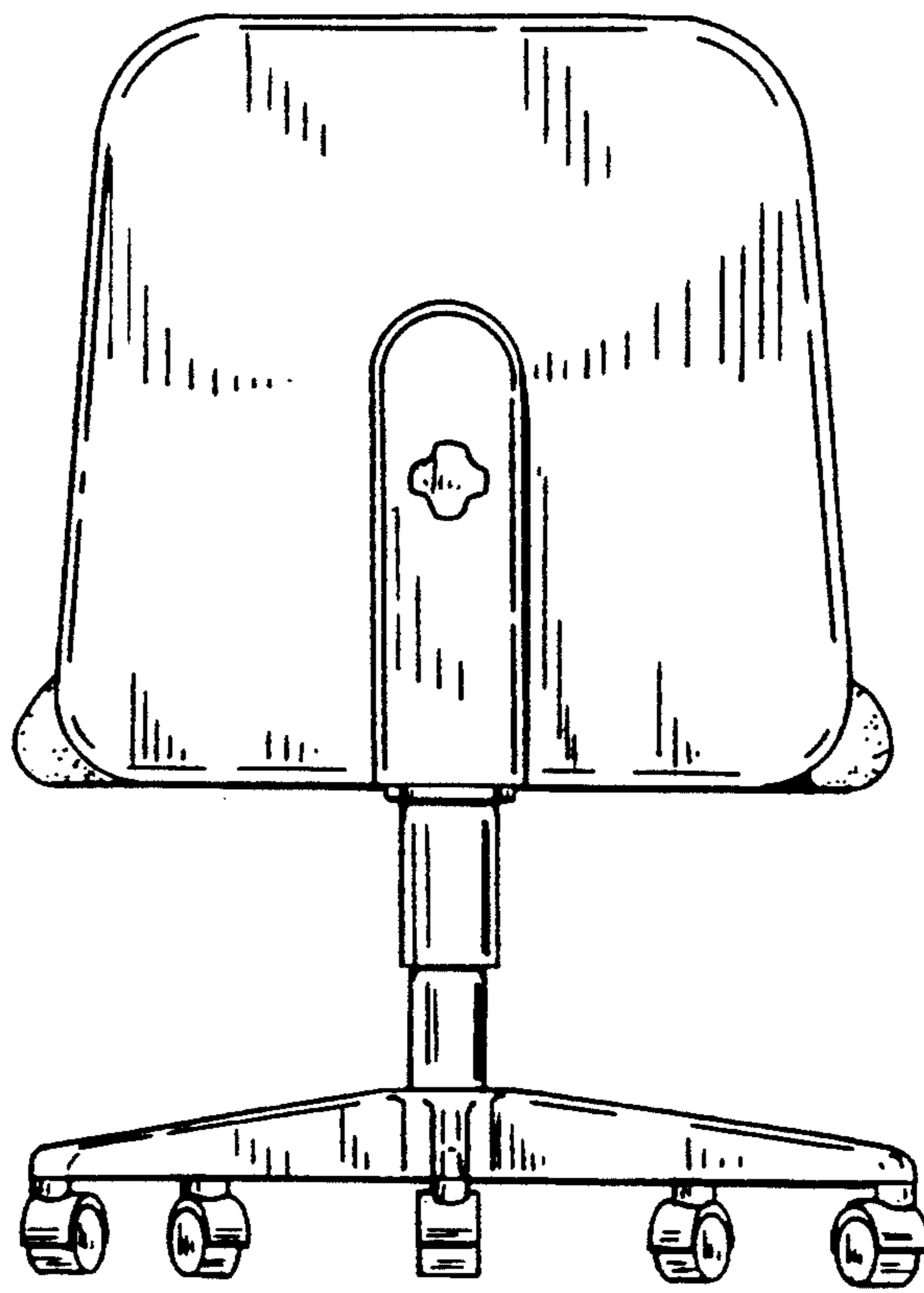

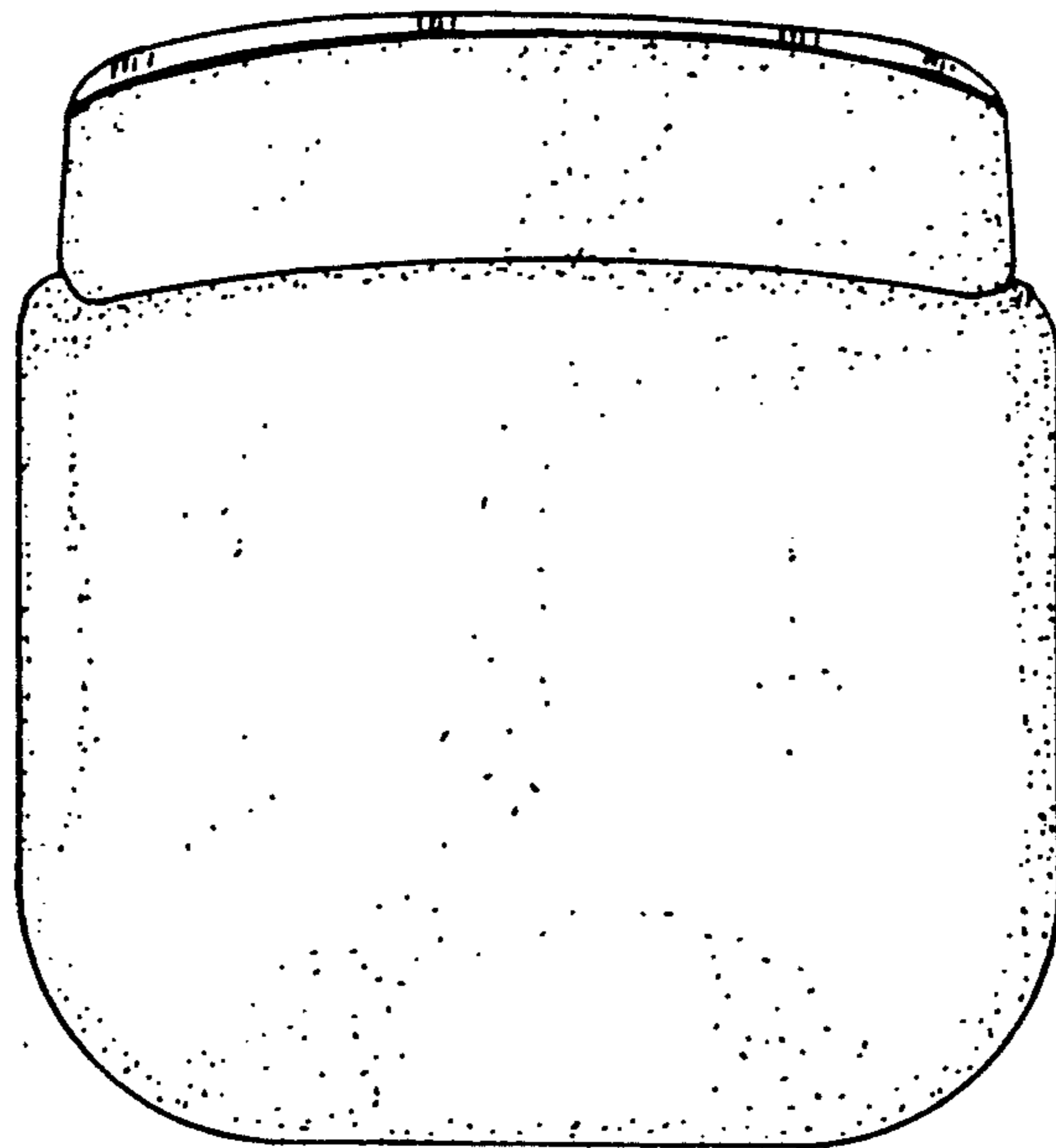

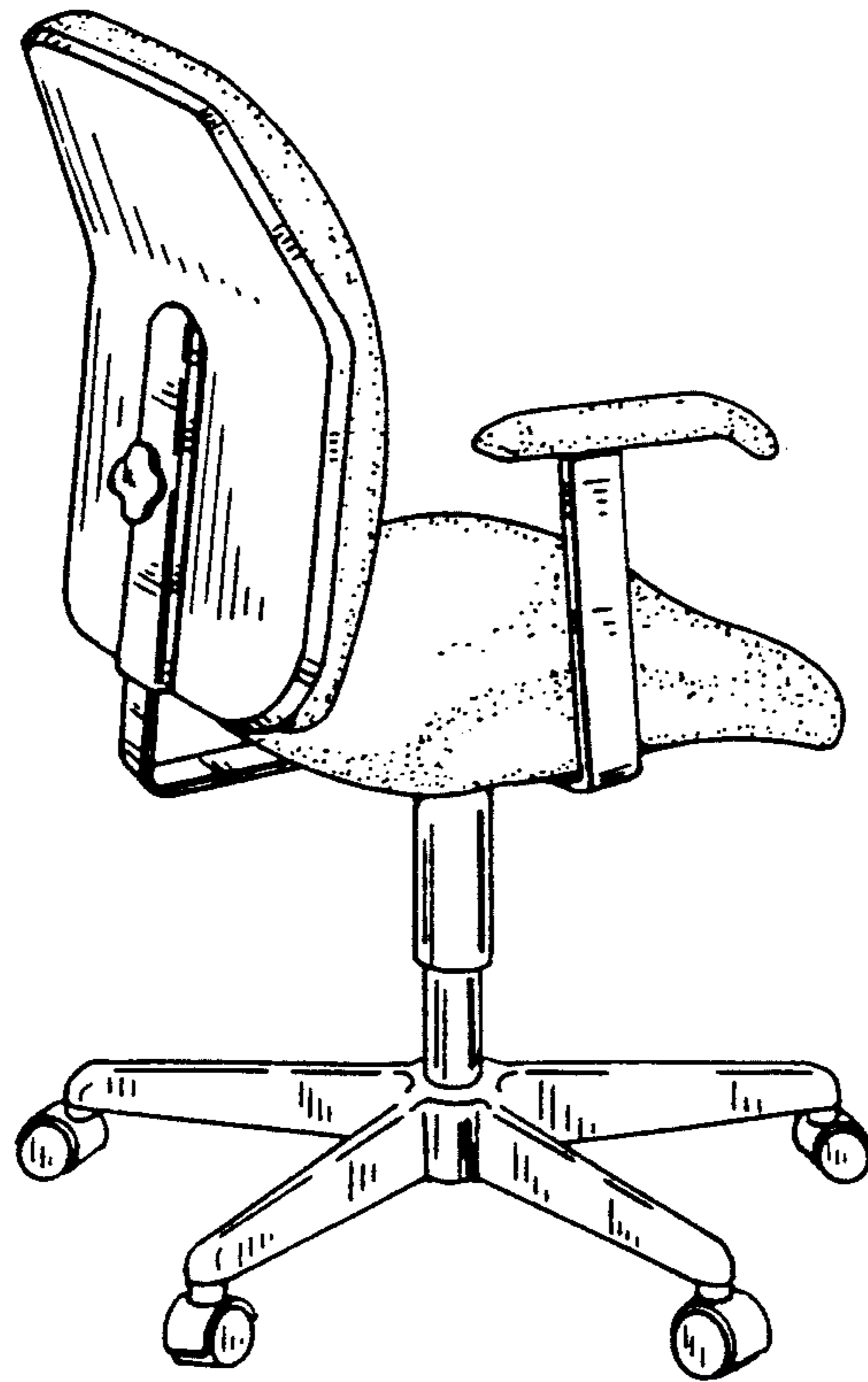

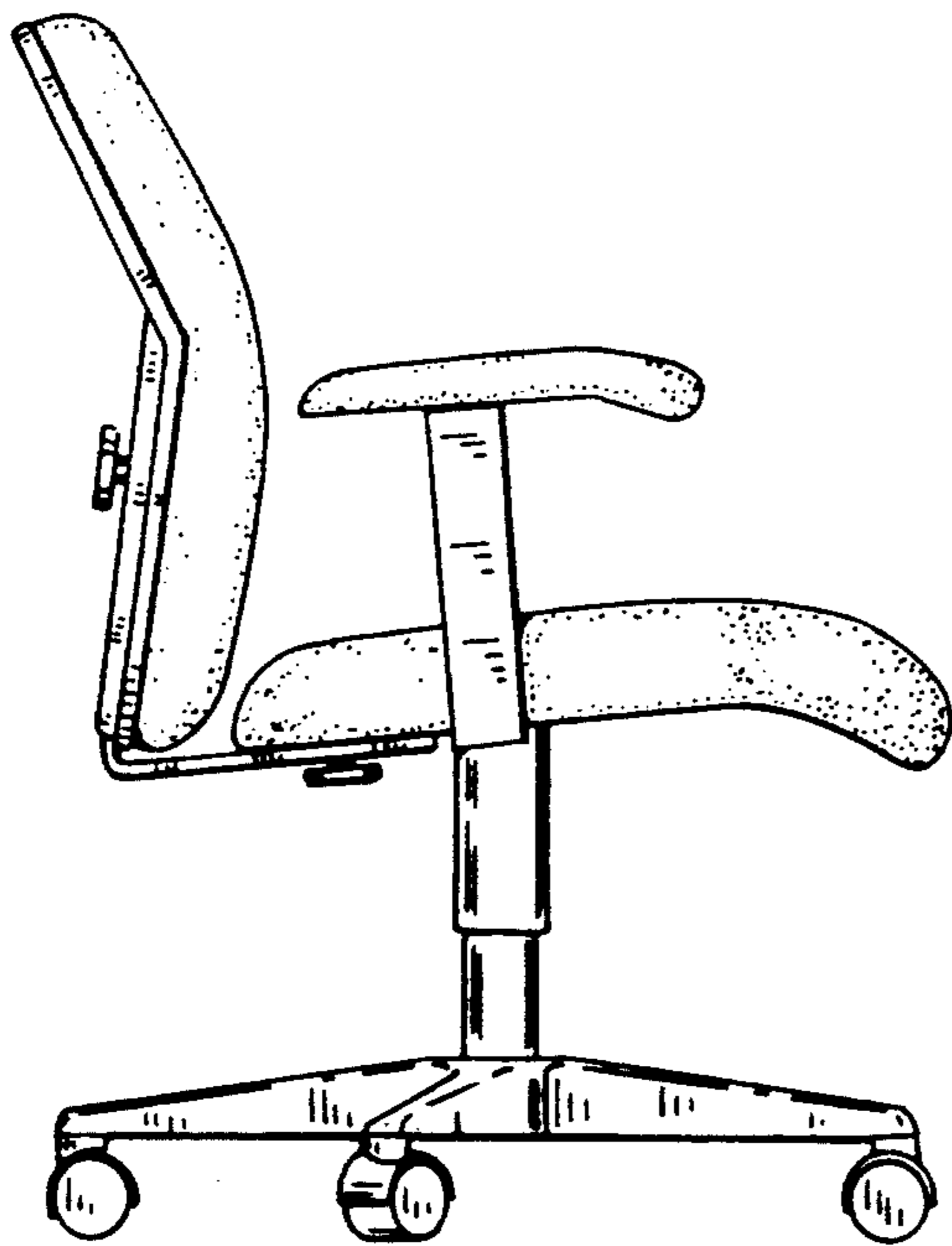

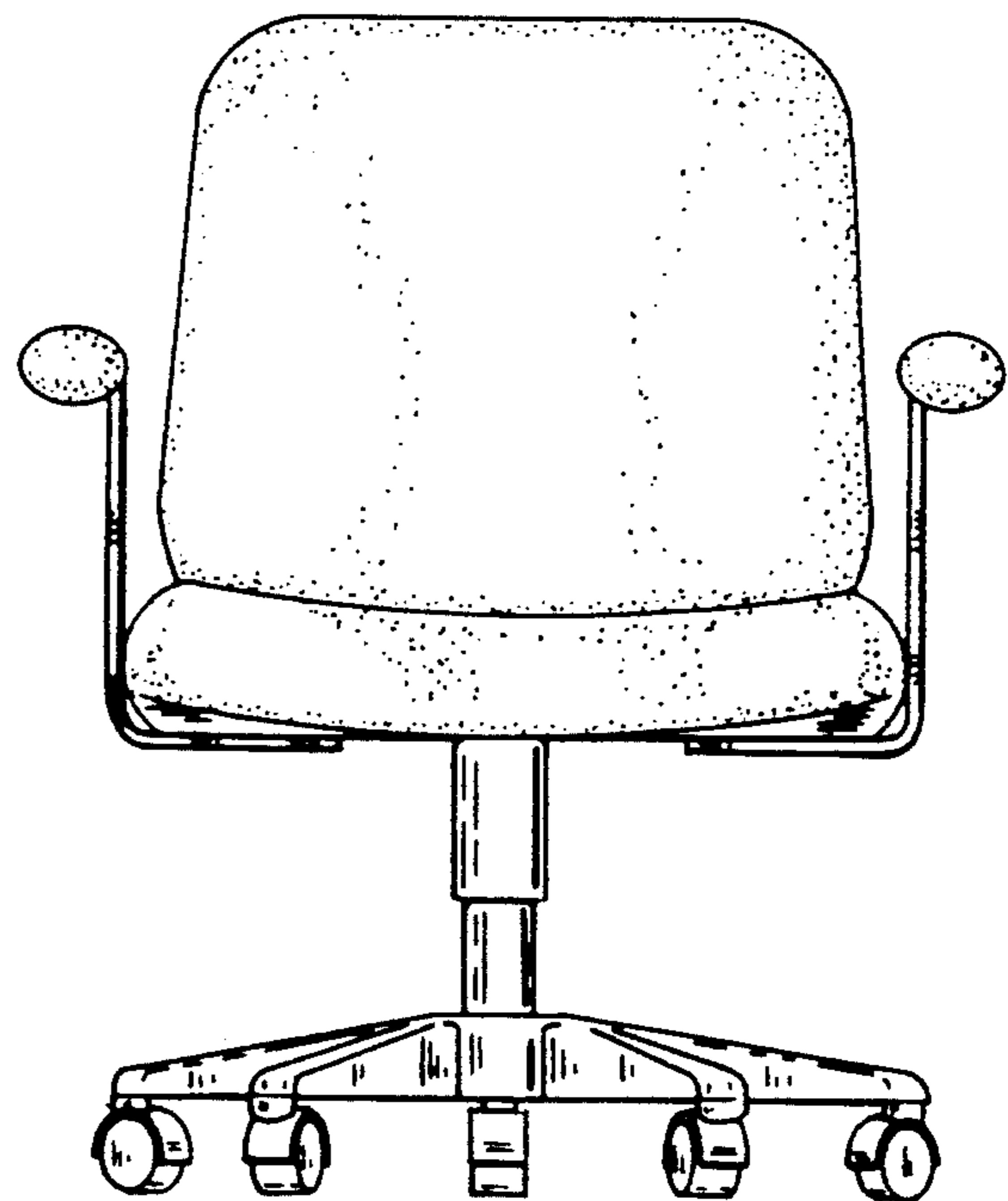

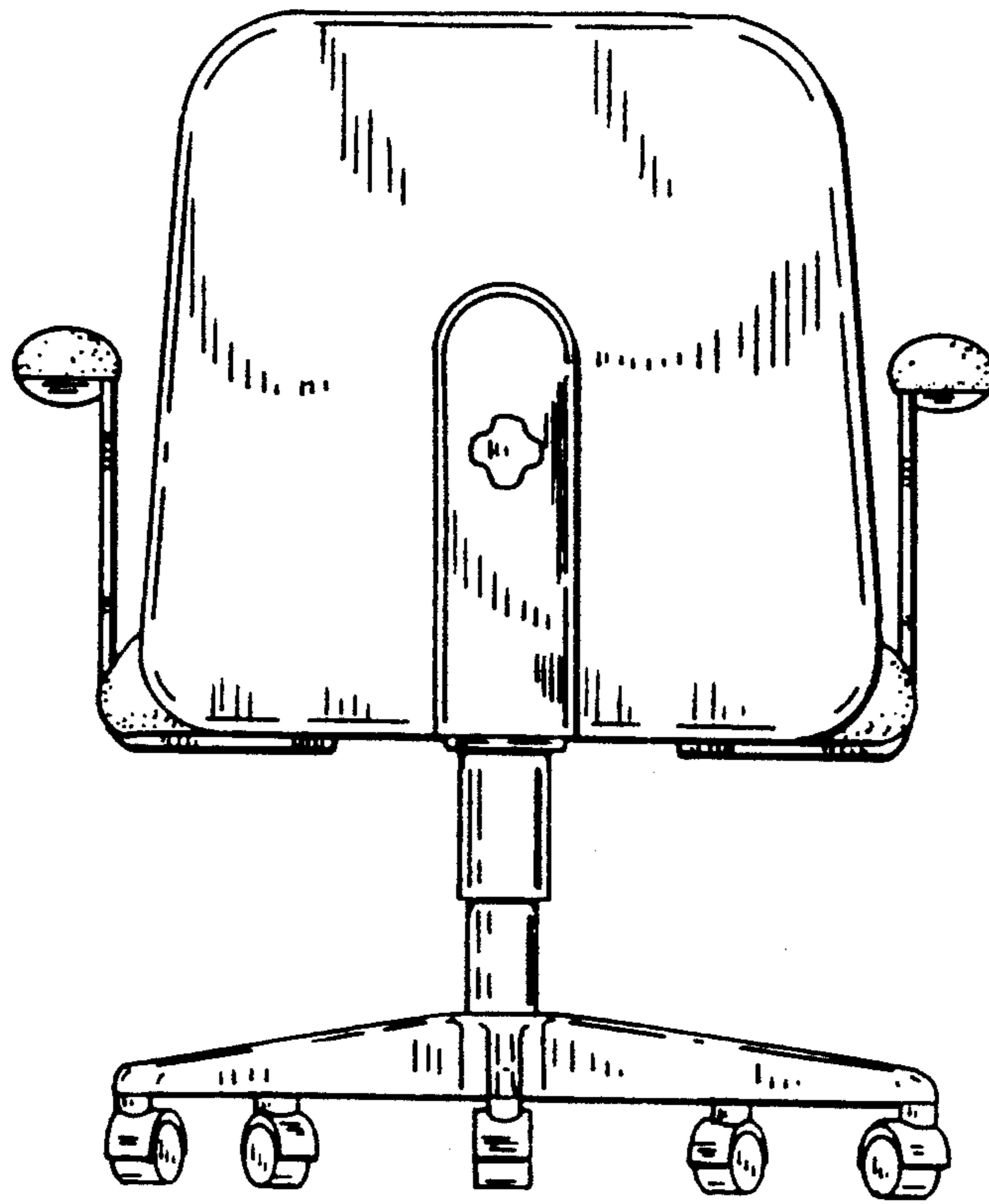

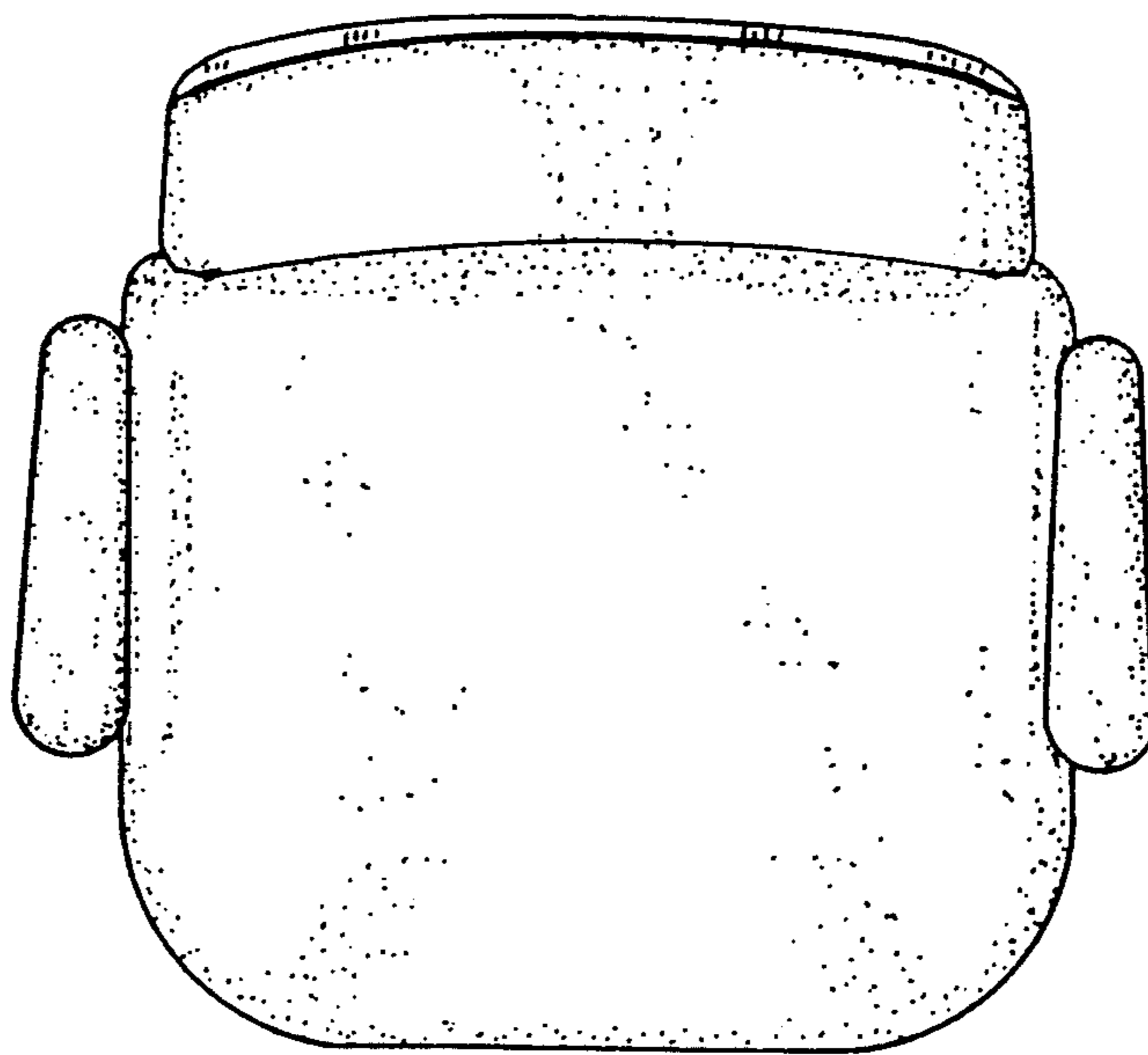

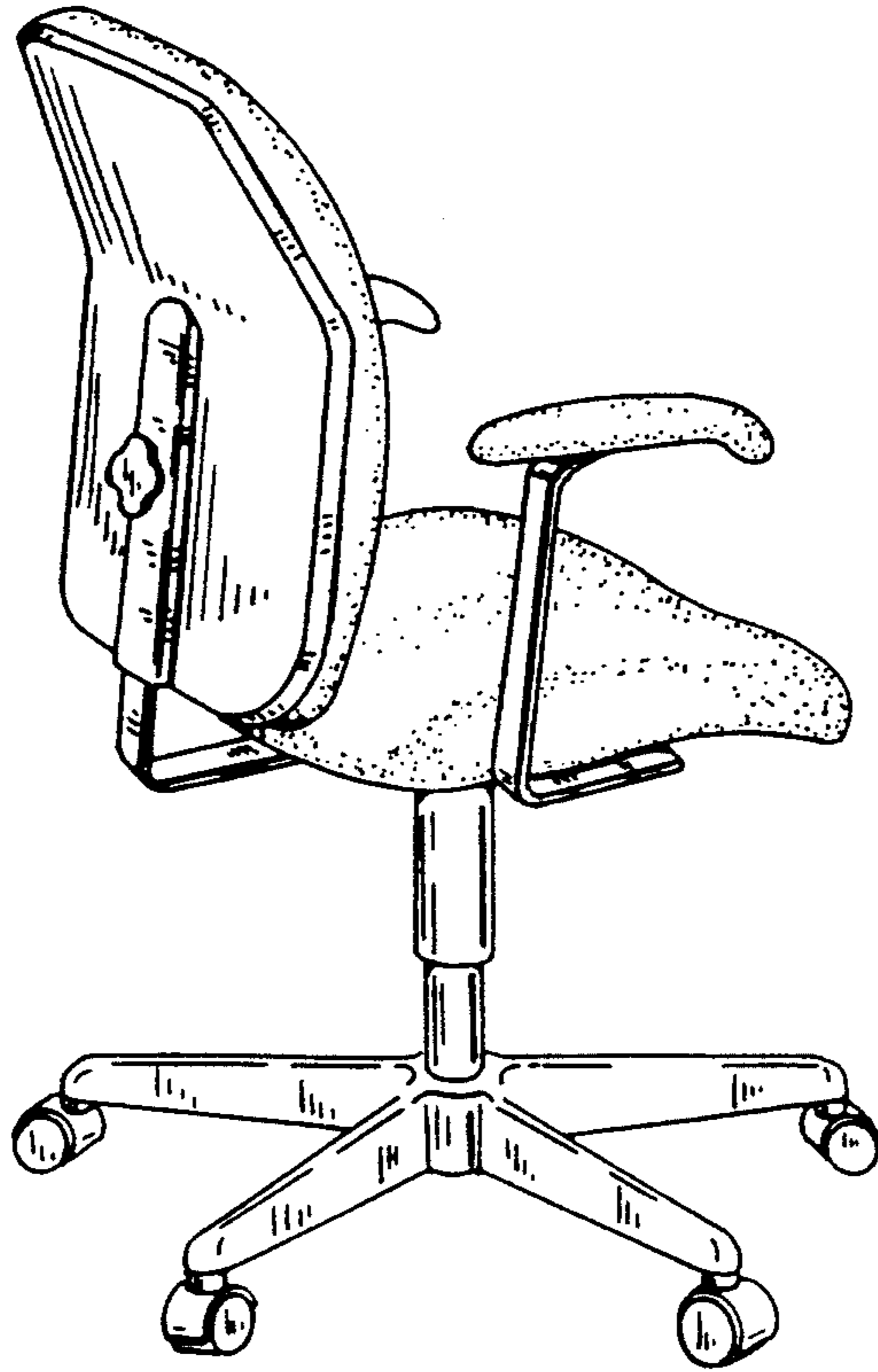

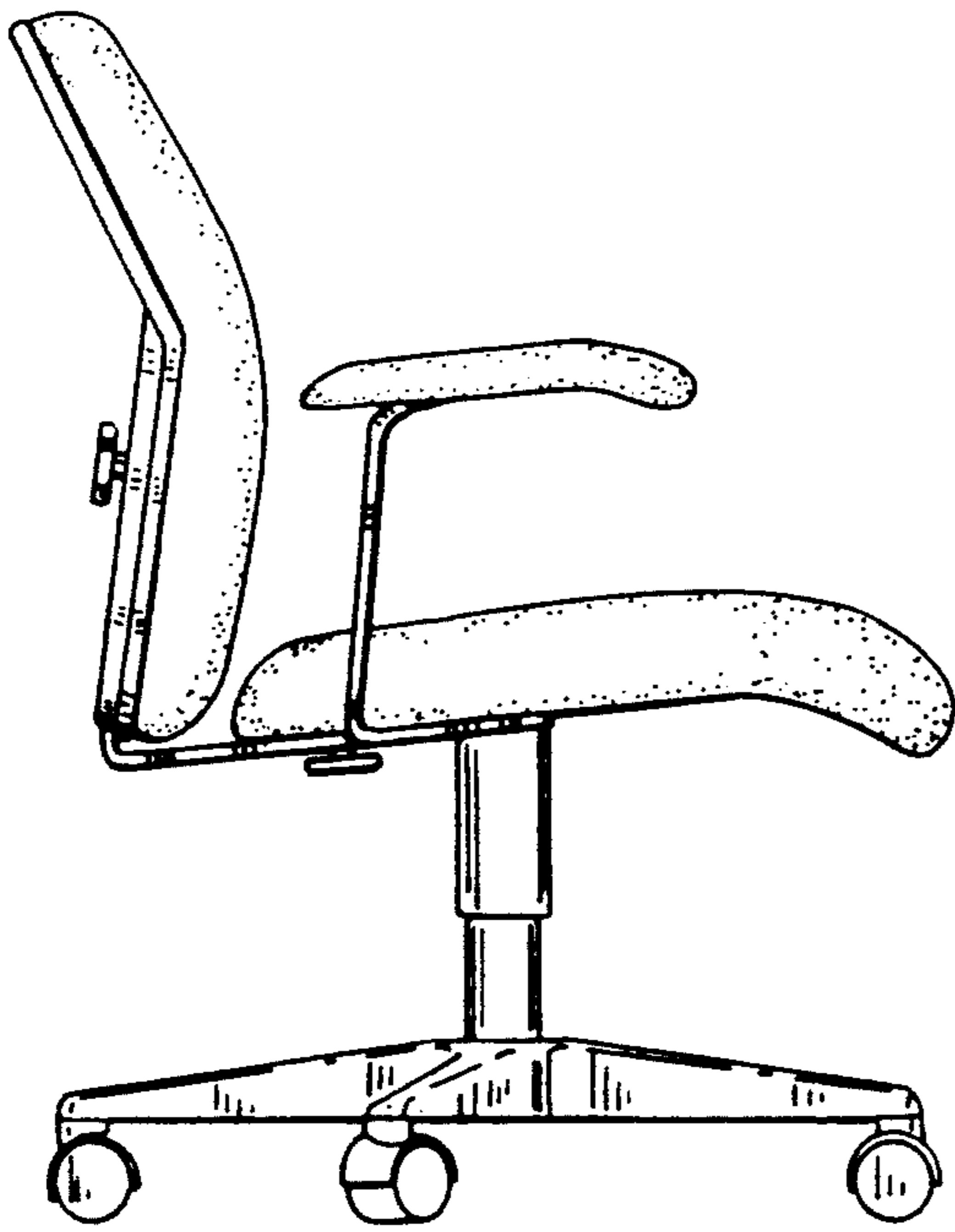

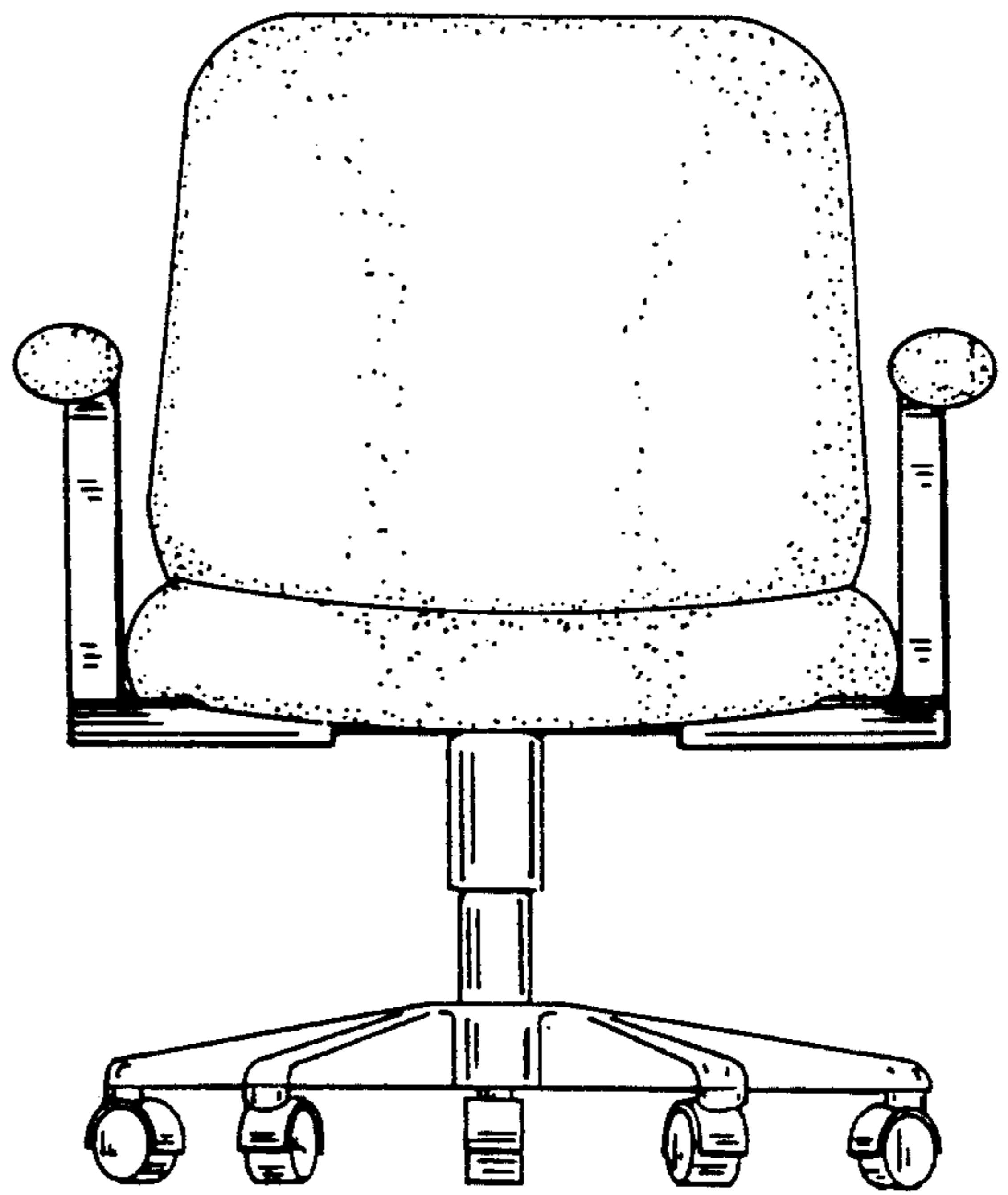

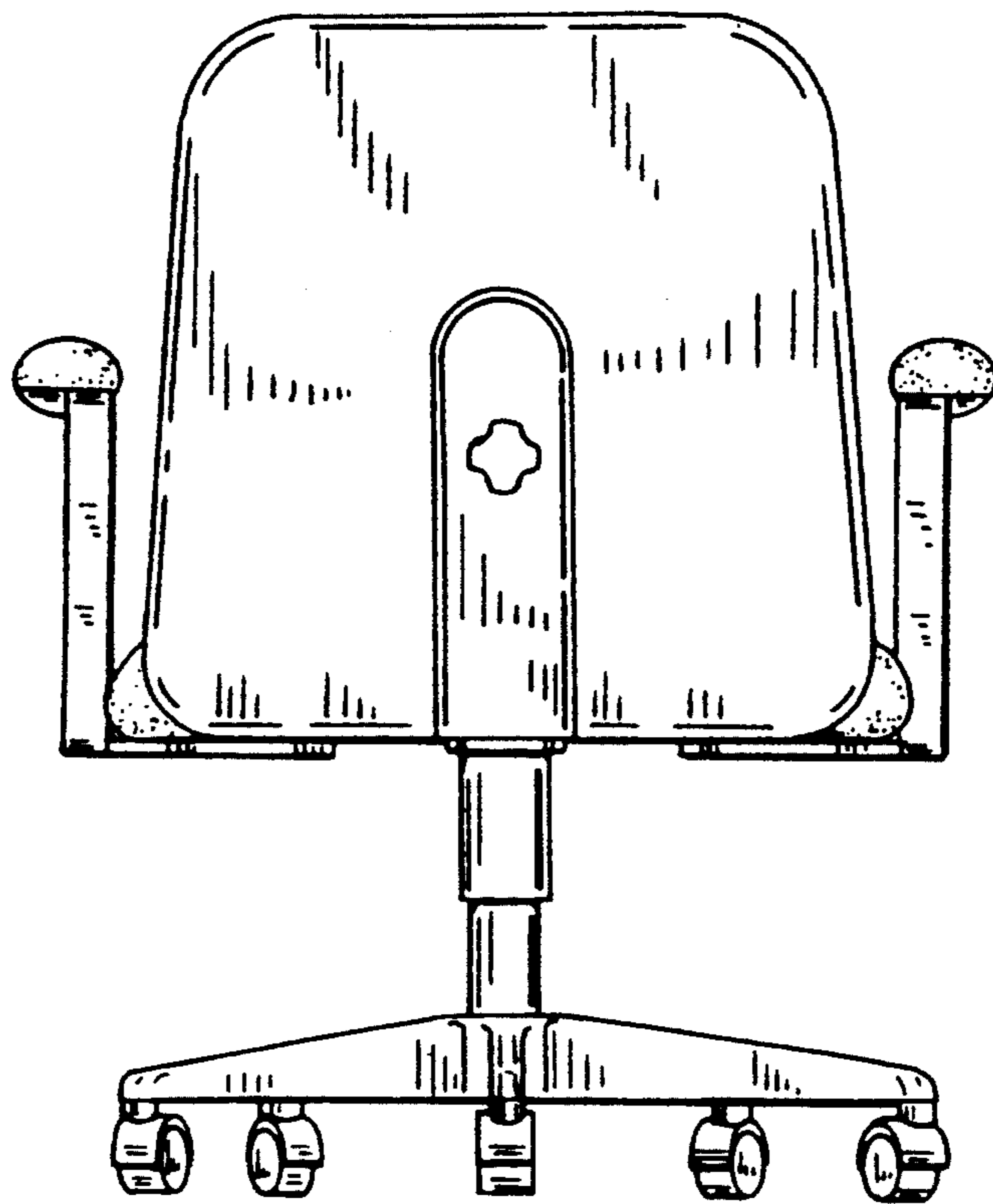

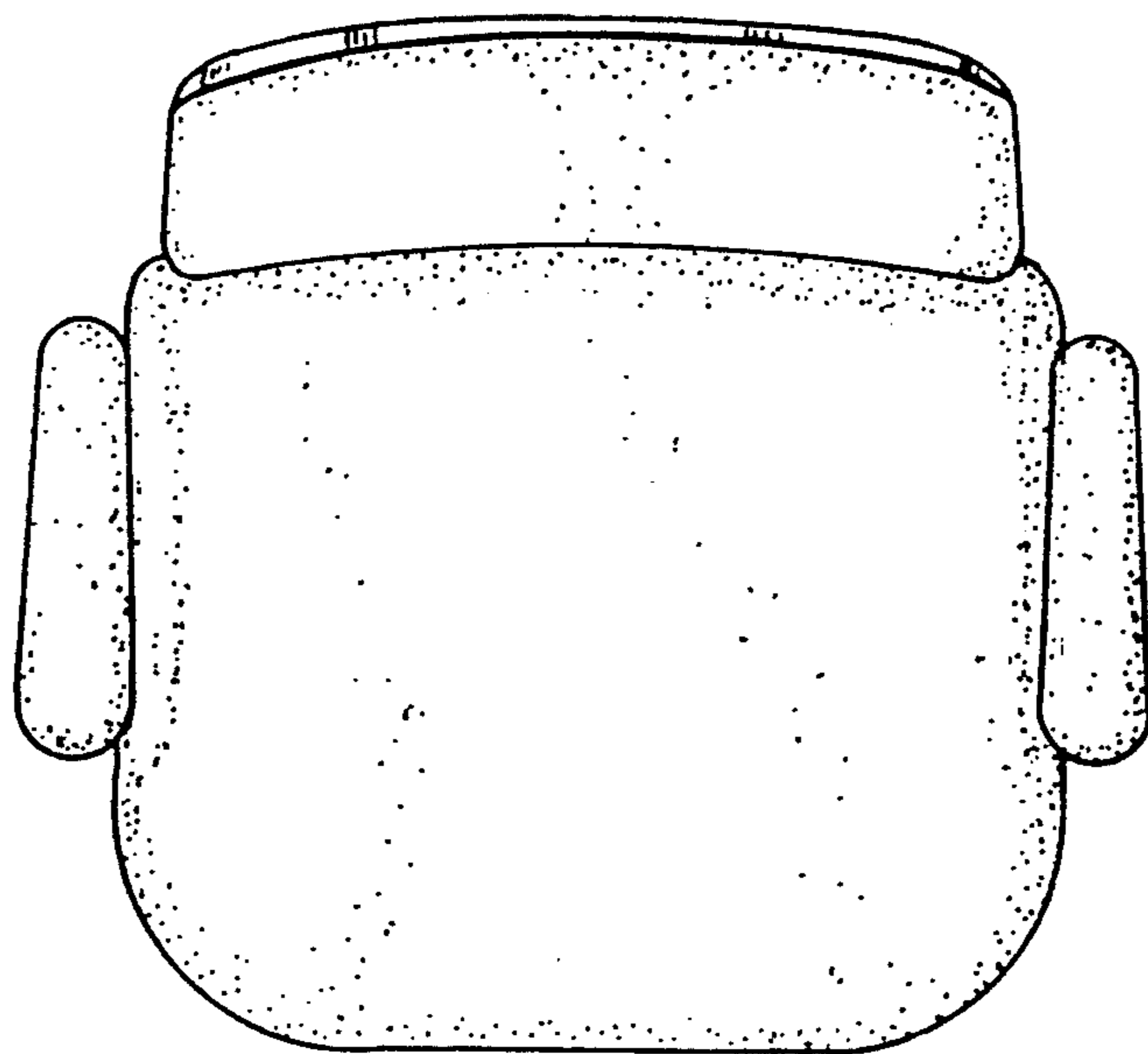
