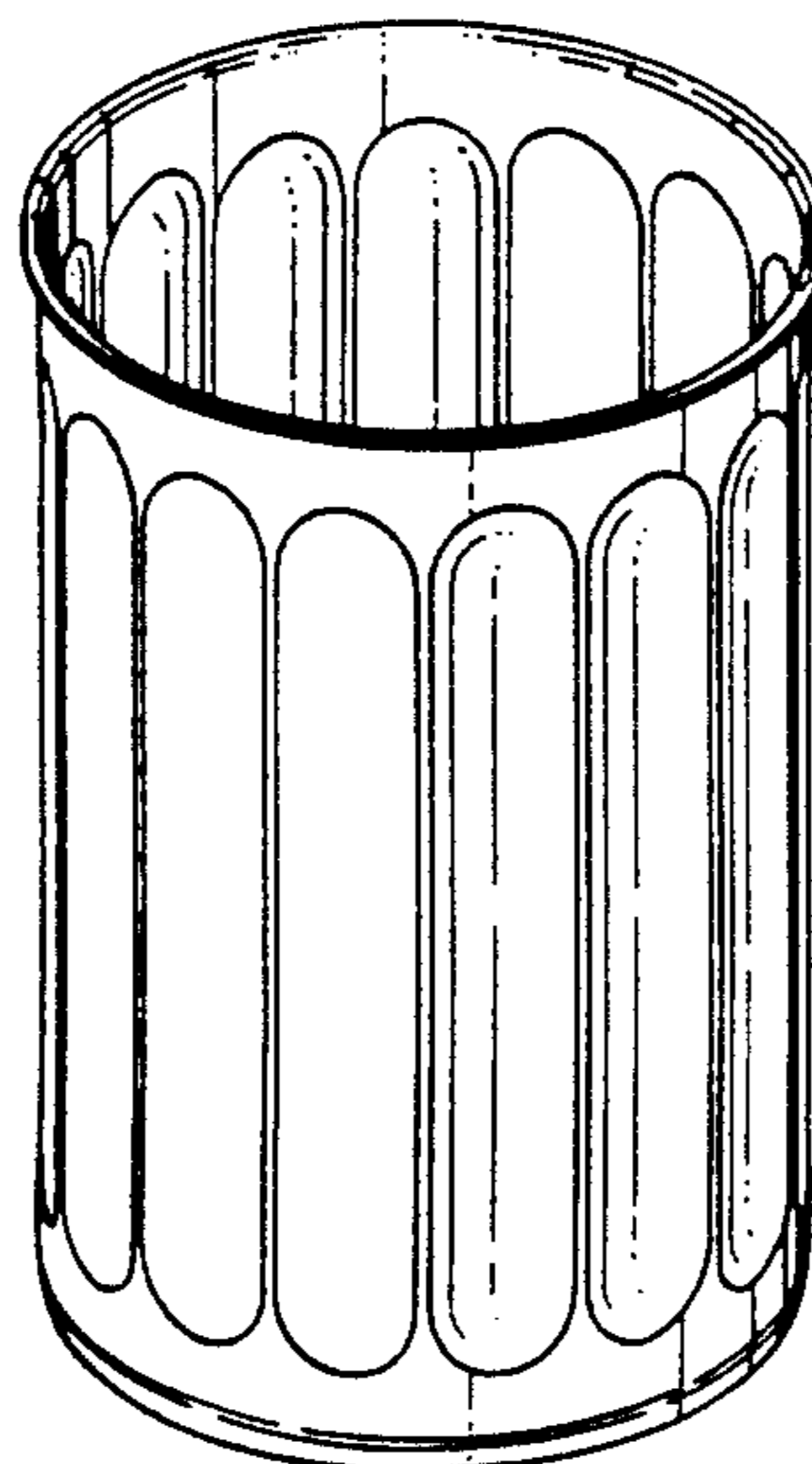

DESCRIPTION

FIG. 1 is a perspective view of a can body showing my new design;
FIG. 2 is a front elevation, the rear and side elevations are the same;
FIG. 3 is a top plan view; and,
FIG. 4 is a sectional view along the line 4—4 of FIG. 3.



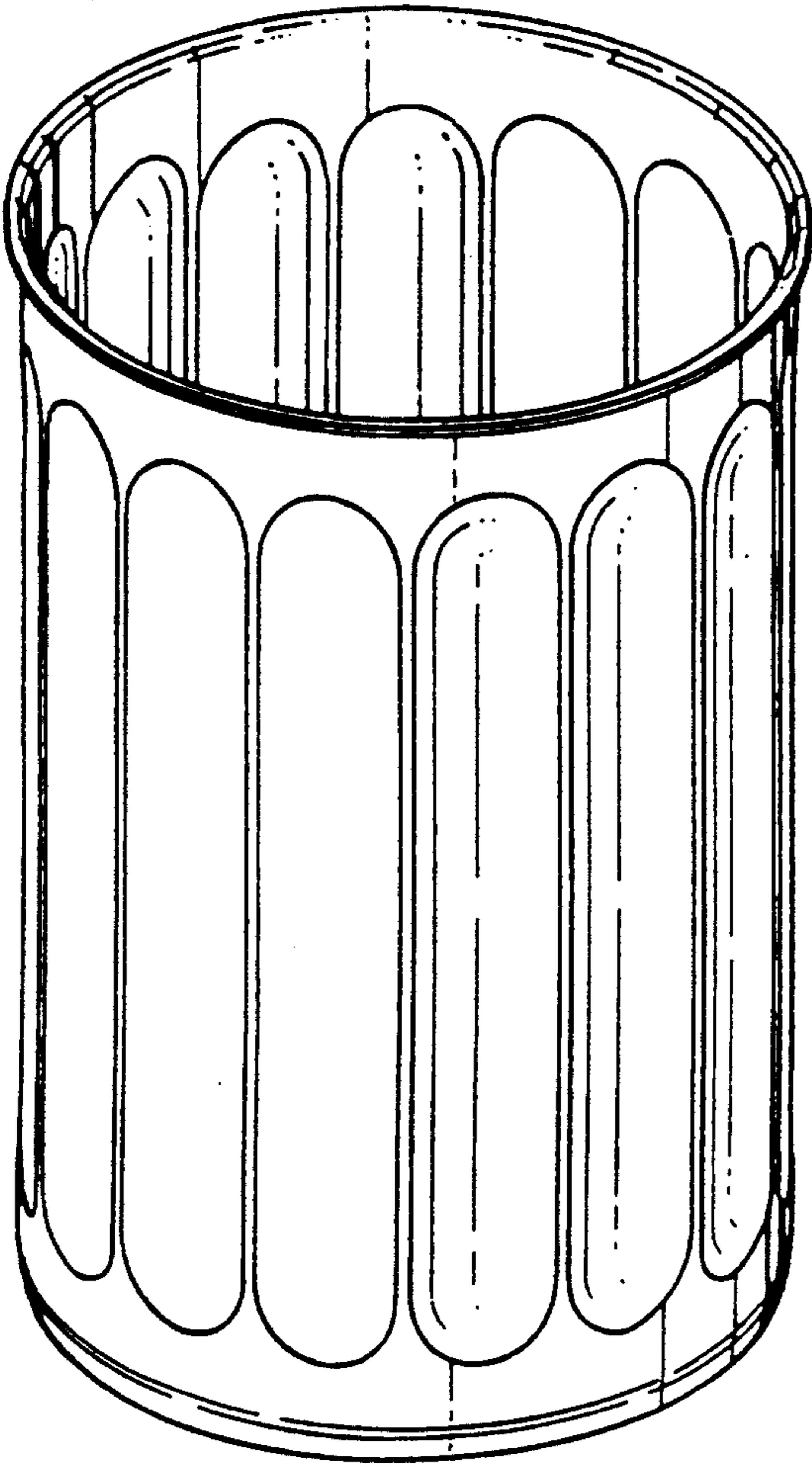

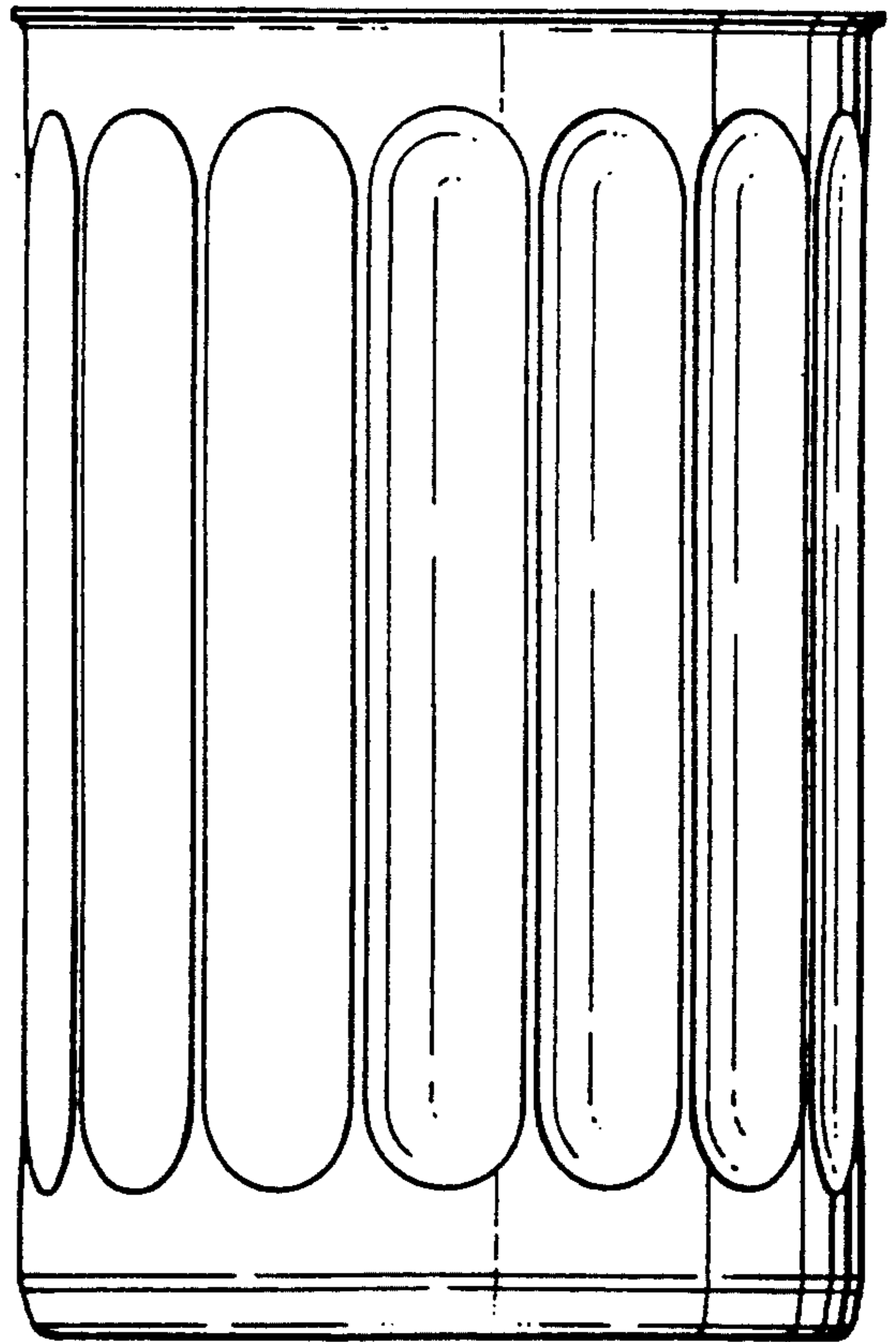

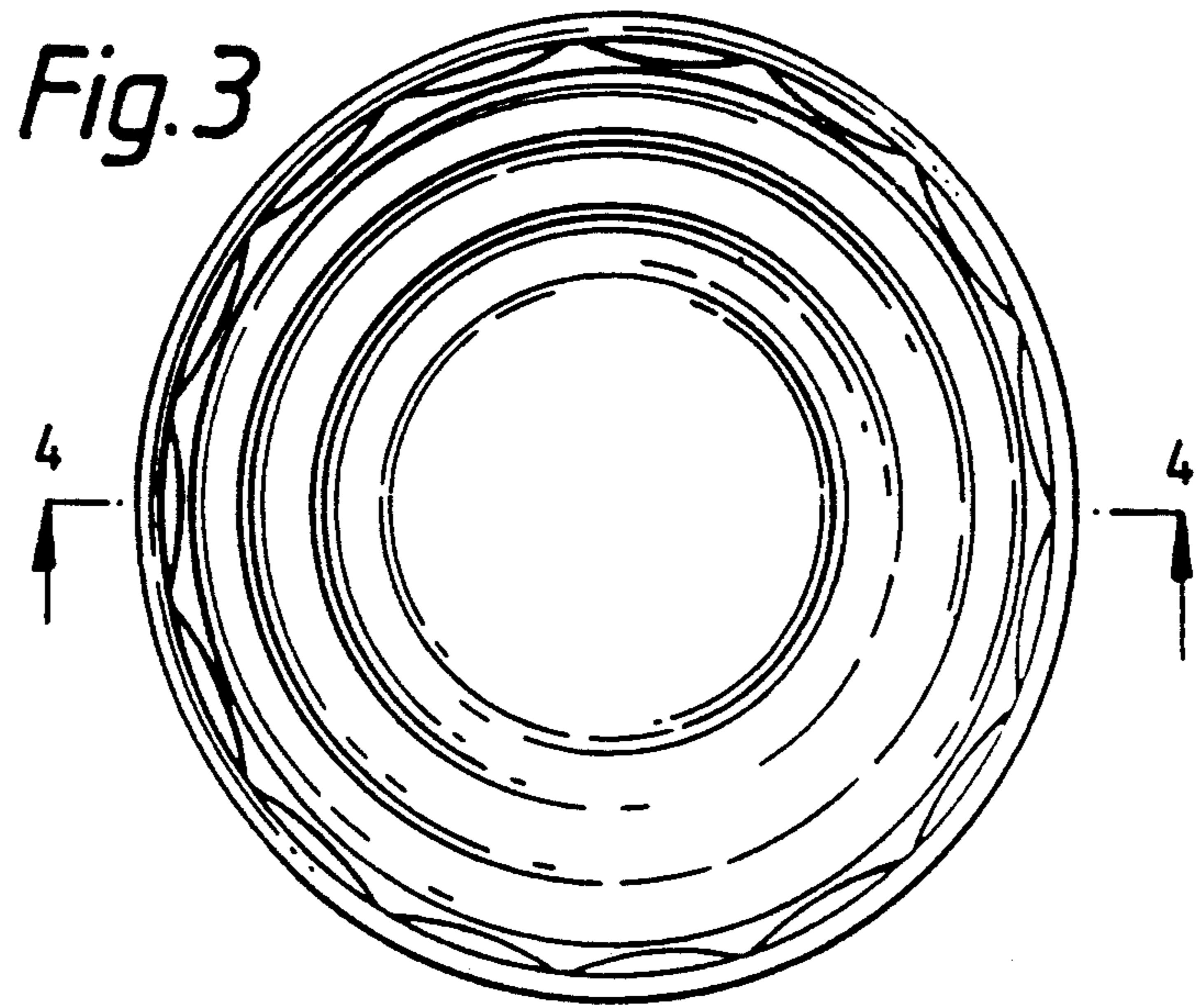
