[57] CLAIM

The ornamental design for a lockable latch assembly for a video cassette case, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and left side perspective view of a lockable latch assembly for a video cassette case showing our new design;

FIG. 2 is a top plan view of the clasp portion thereof;

FIG. 3 is a rear elevational view of the clasp portion thereof;

FIG. 4 is a front elevational view of the clasp portion thereof;

FIG. 5 is a right side elevational view of the clasp portion thereof;

FIG. 6 is a left side elevational view of the clasp portion thereof;

FIG. 7 is a bottom plan view of the clasp portion thereof;

FIG. 8 is a top plan view of the receptacle portion thereof;

FIG. 9 is a front elevational view of the receptacle portion thereof;

FIG. 10 is a rear elevational view of the receptacle portion thereof;

FIG. 11 is a left side elevational view of the receptacle portion thereof;

FIG. 12 is a right side elevational view of the receptacle portion thereof; and,

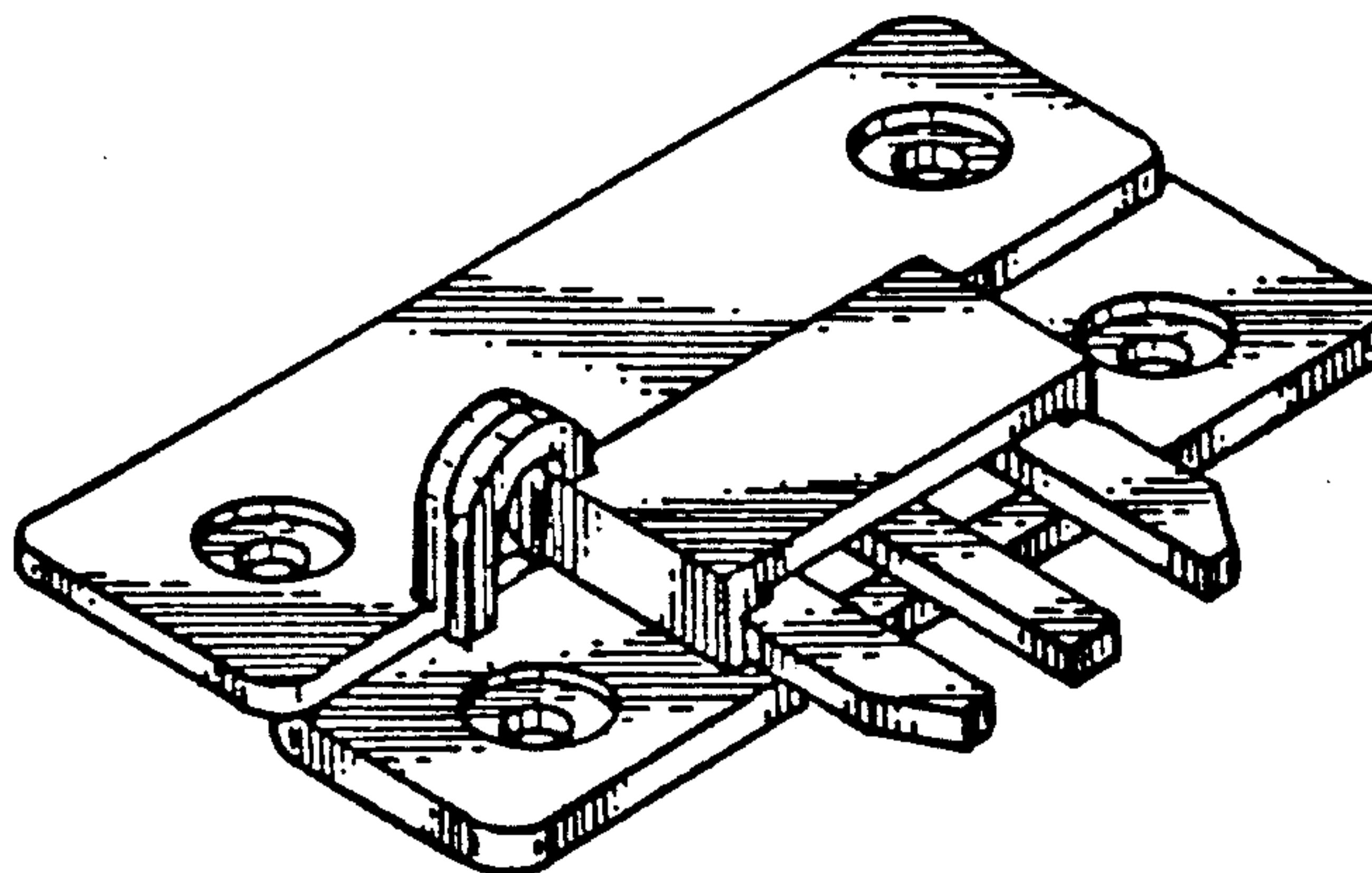
FIG. 13 is a bottom plan view of the receptacle portion thereof. Portions of the assembly are omitted in the views for clarity of illustration.

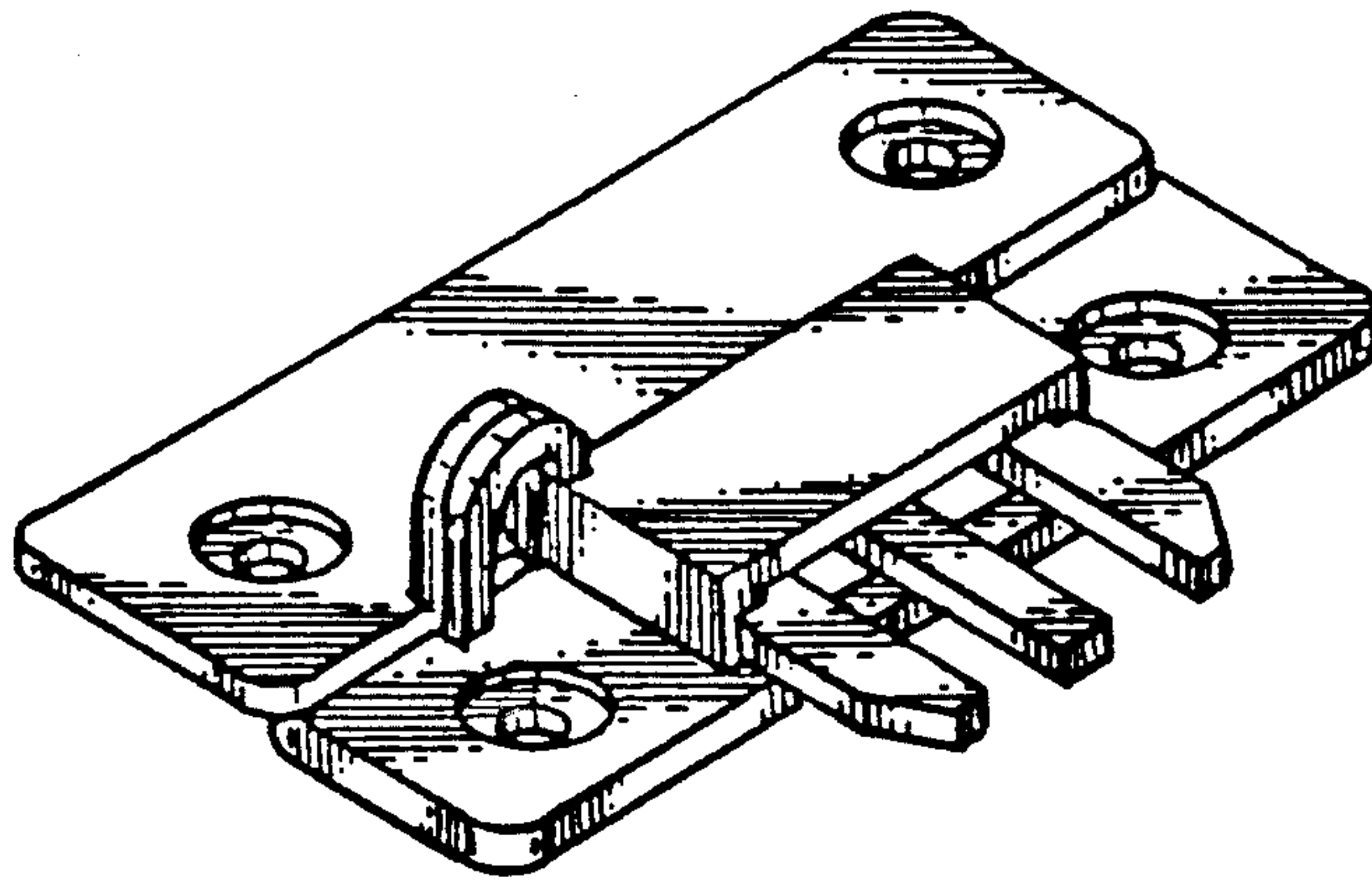

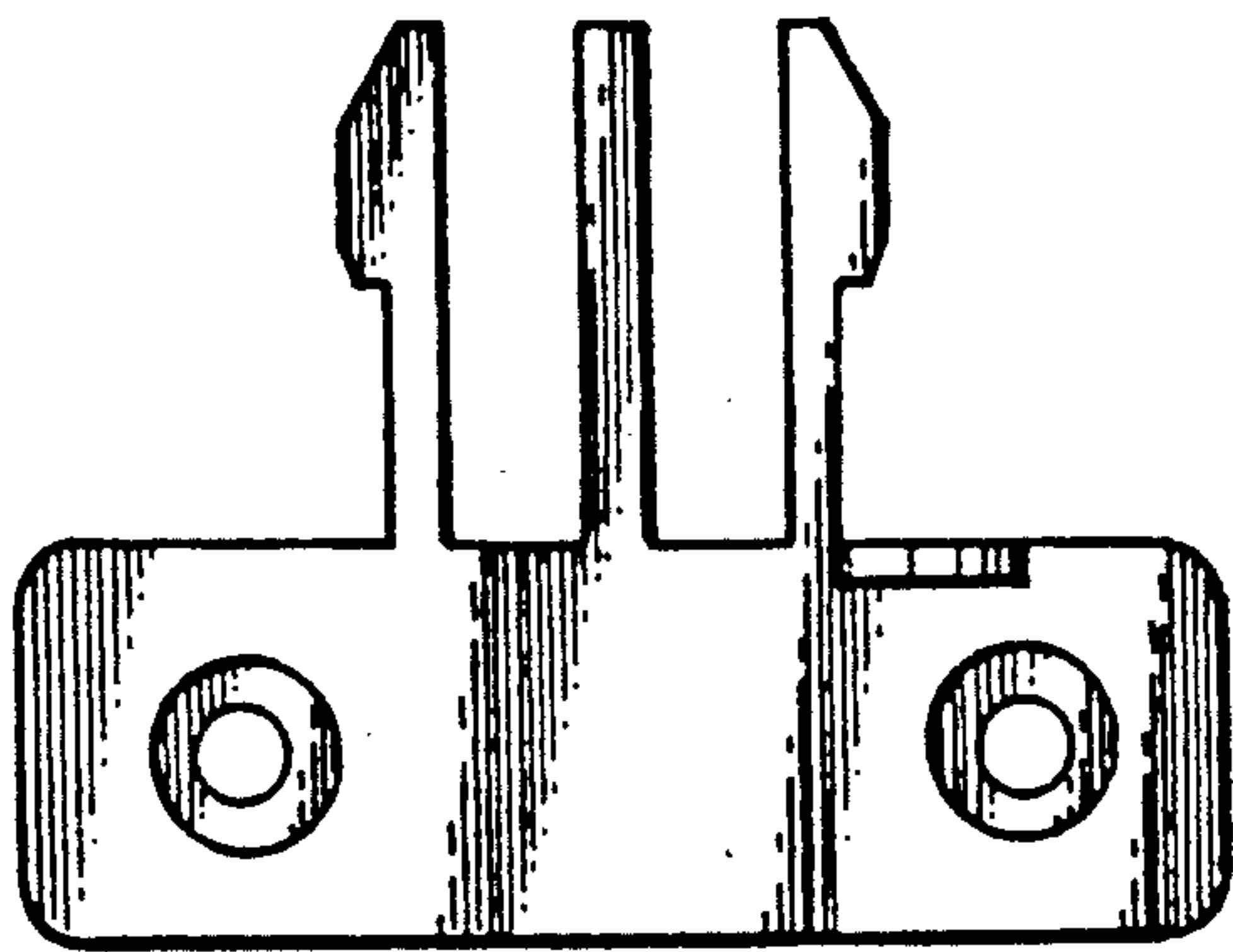

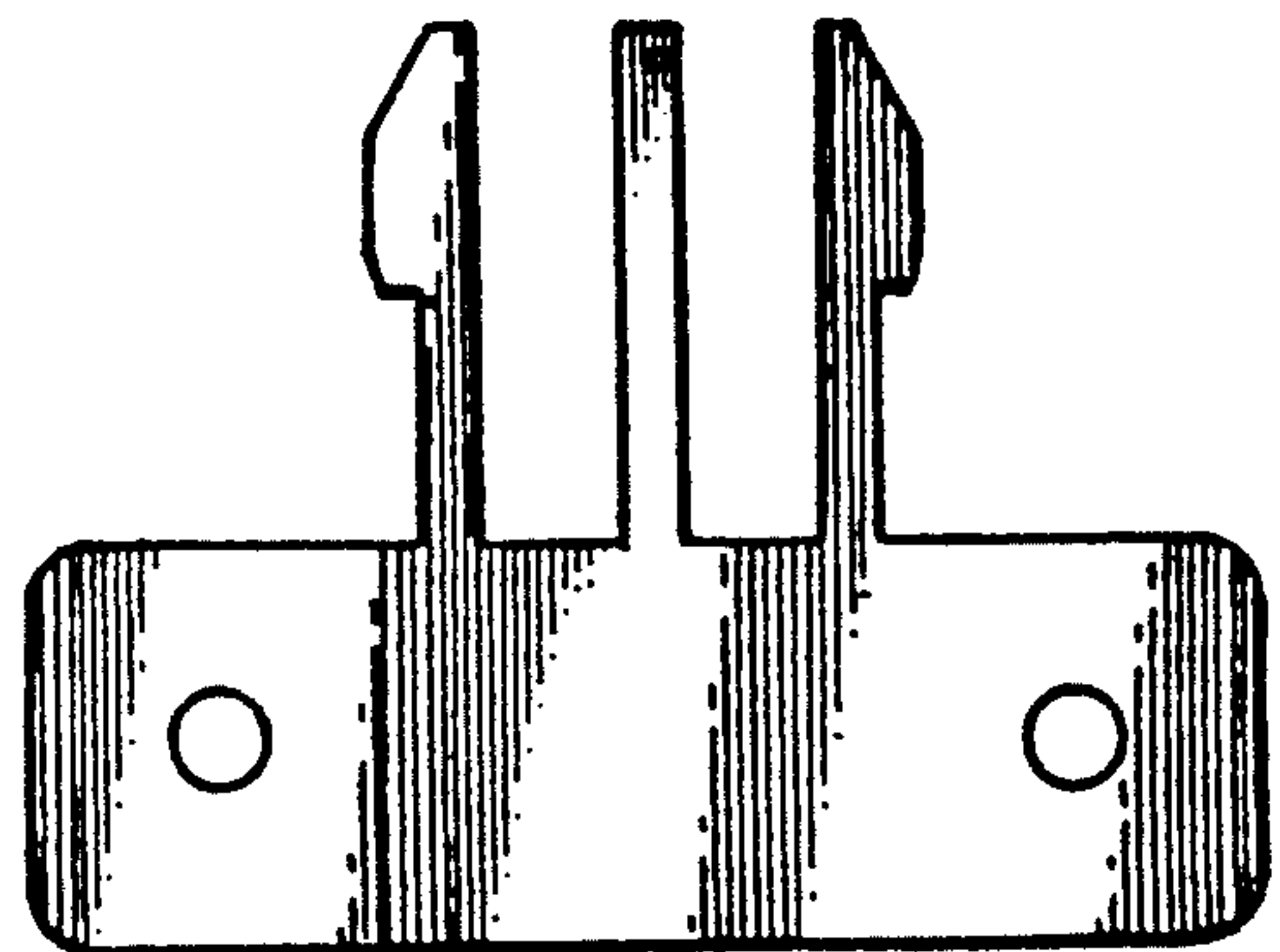

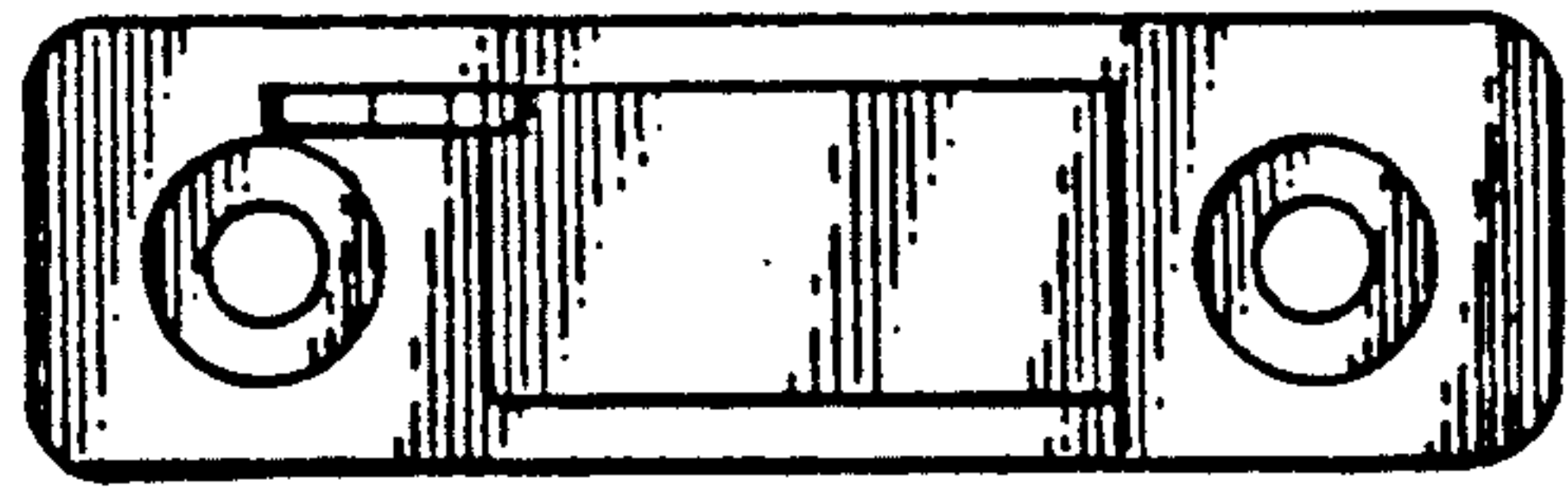

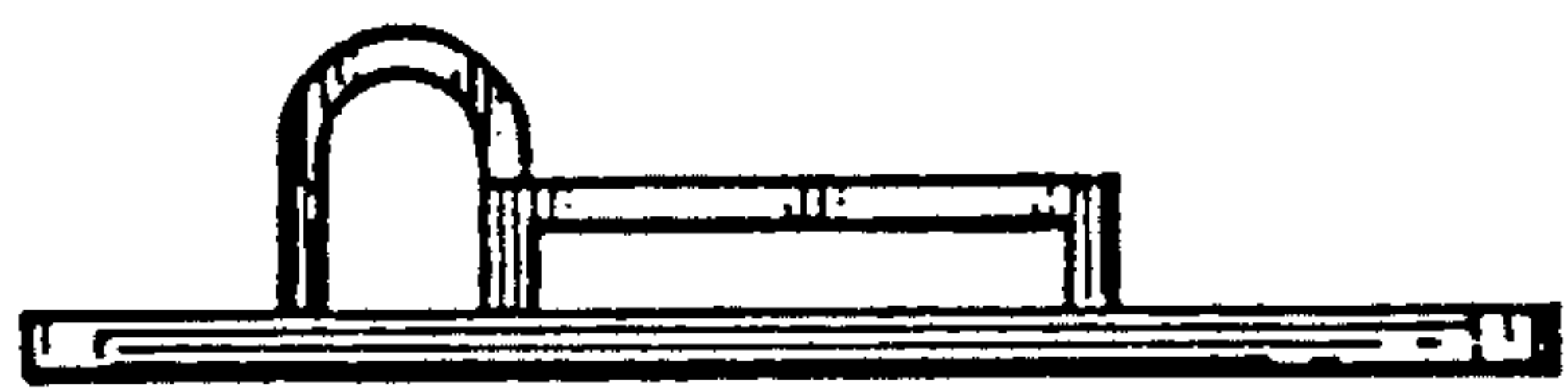

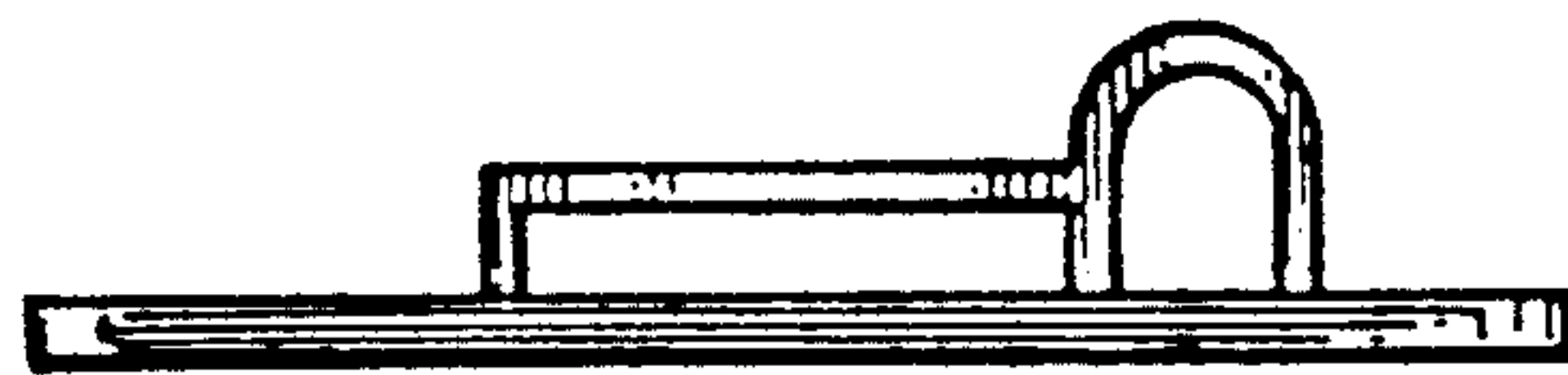

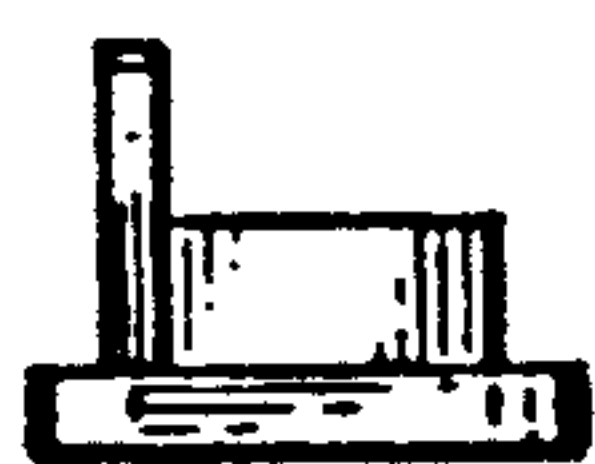

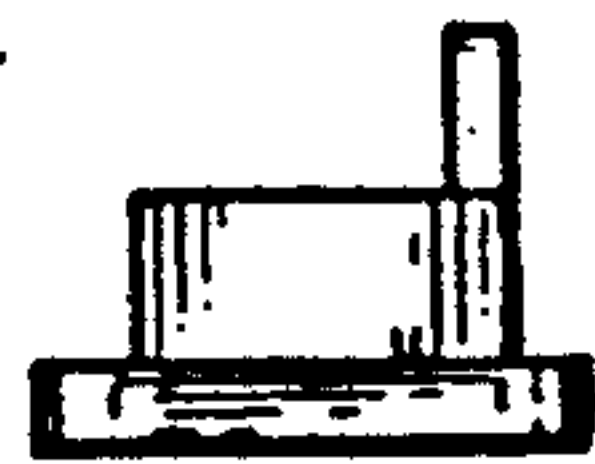

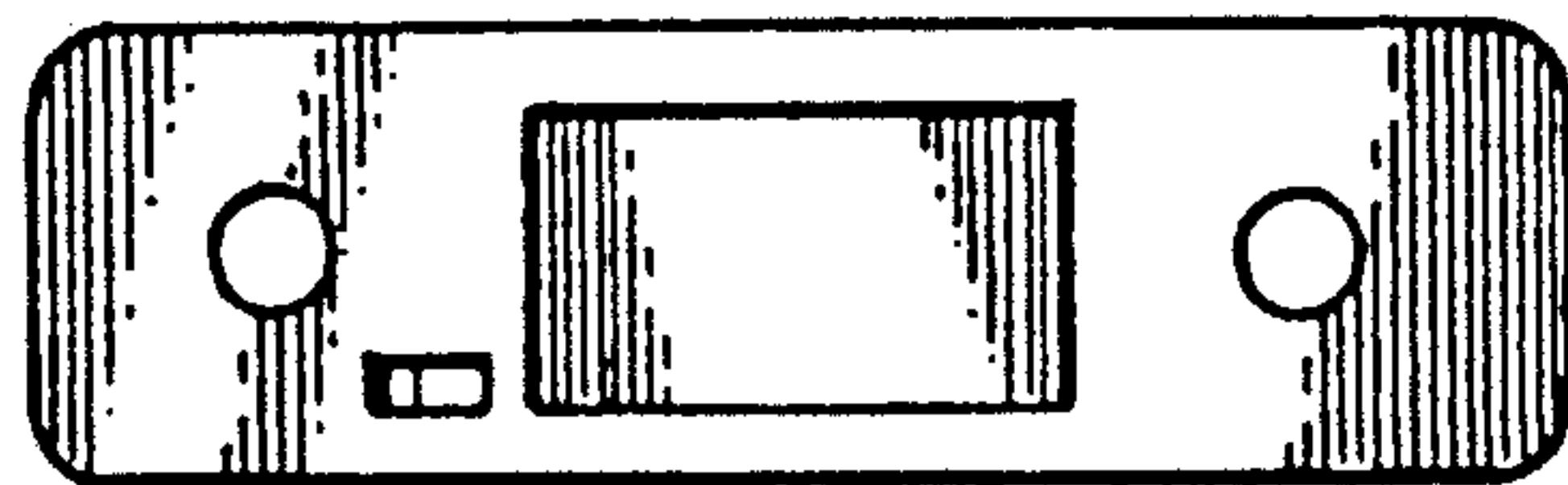
