The ornamental design for a razor handle, as shown and described.

## DESCRIPTION

FIG. 1 is a perspective view of a razor handle showing my new design (unclaimed environmental structure being shown in broken lines);

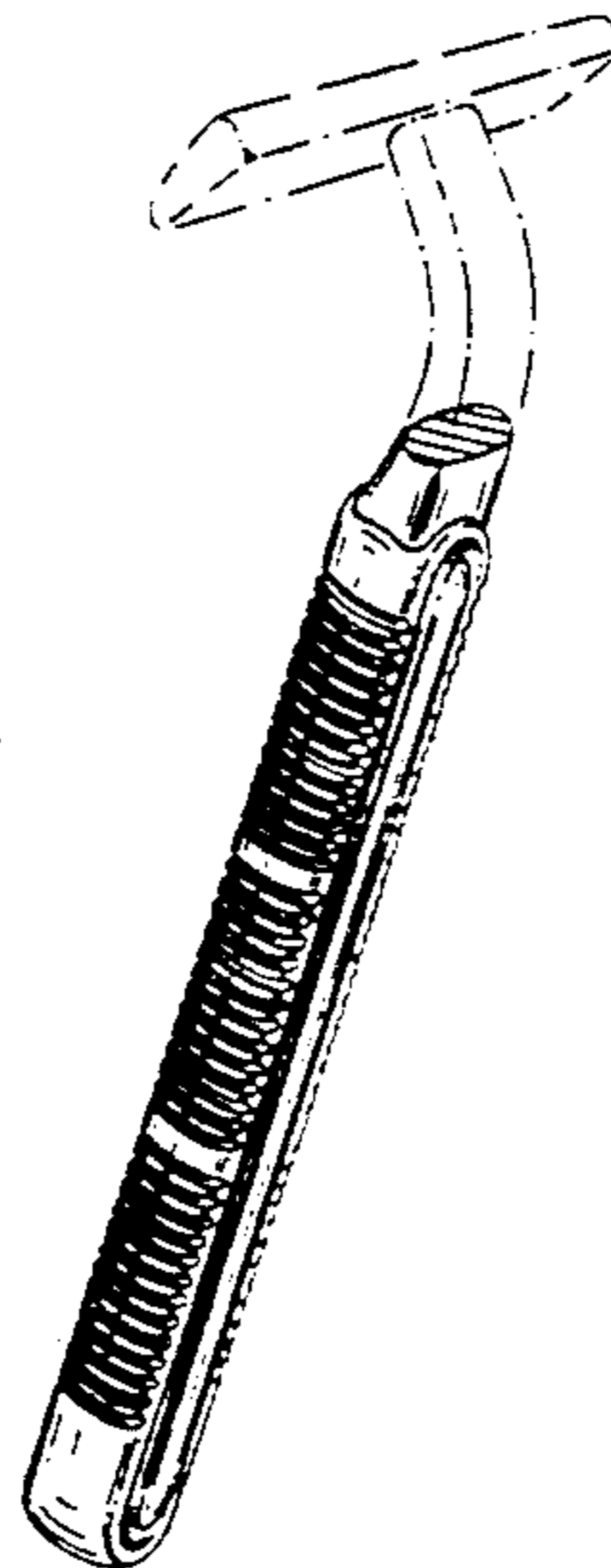
FIG. 2 is a top plan view thereof (unclaimed environmental structure being shown in broken lines);

FIG. 3 is a front elevational view thereof (unclaimed environmental structure being shown in broken lines);

FIG. 4 is a right side elevational view thereof, the left side being a mirror image (unclaimed environmental structure being shown in broken lines);

FIG. 5 is a rear elevational view thereof (unclaimed environmental structure being shown in broken lines); and,

FIG. 6 is a bottom plan view thereof, (unclaimed environmental structure being shown in broken lines).



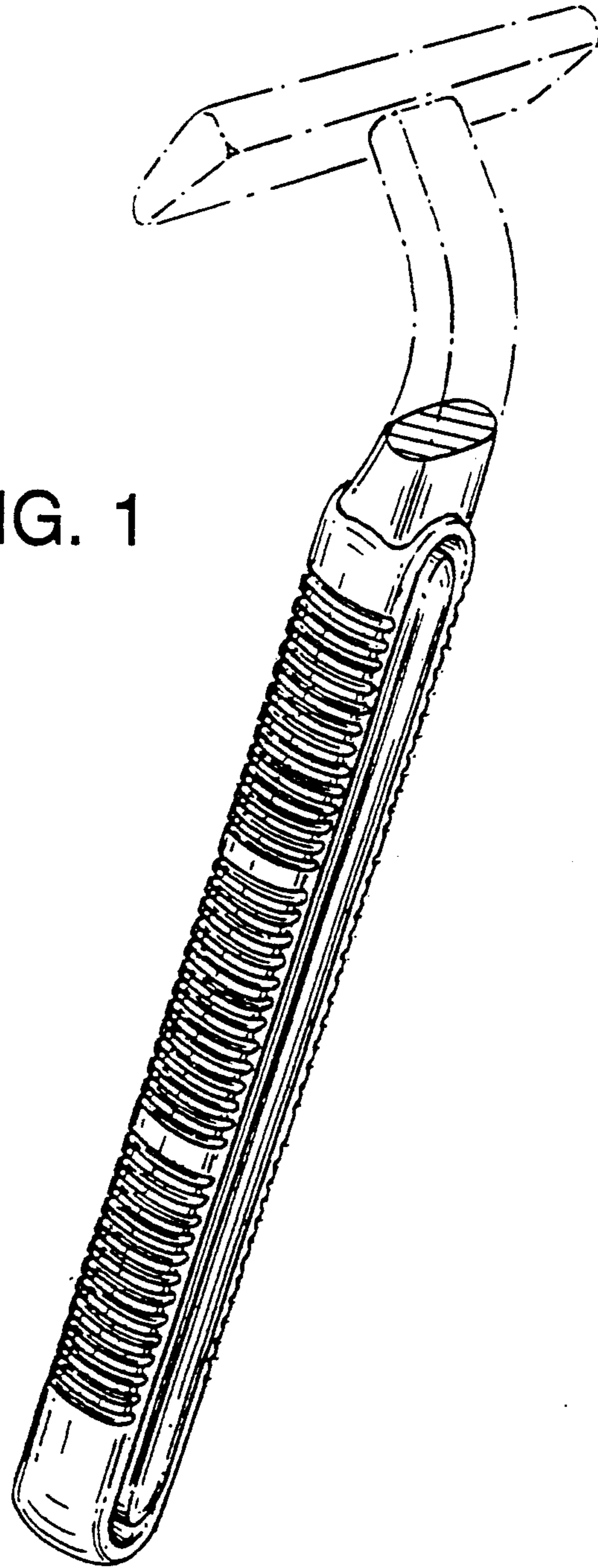

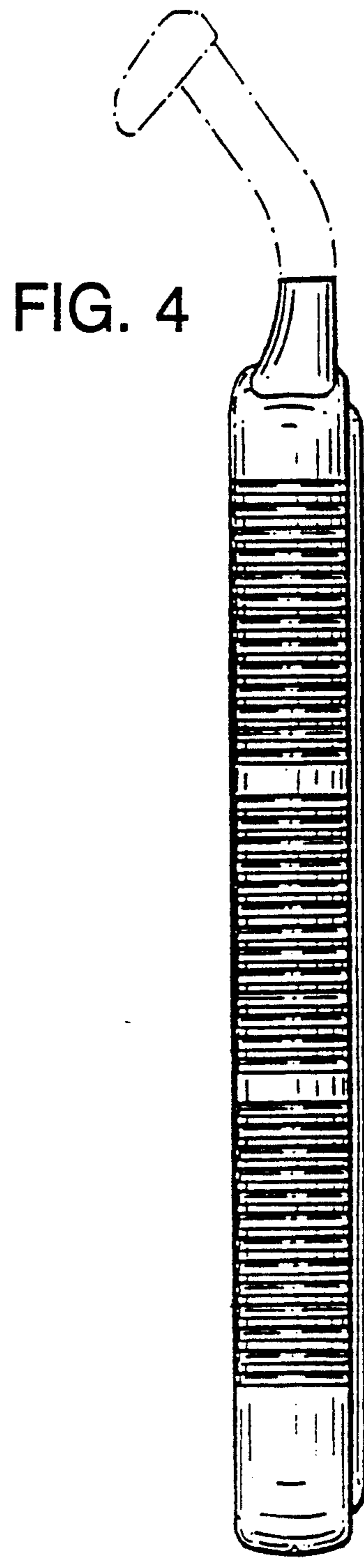
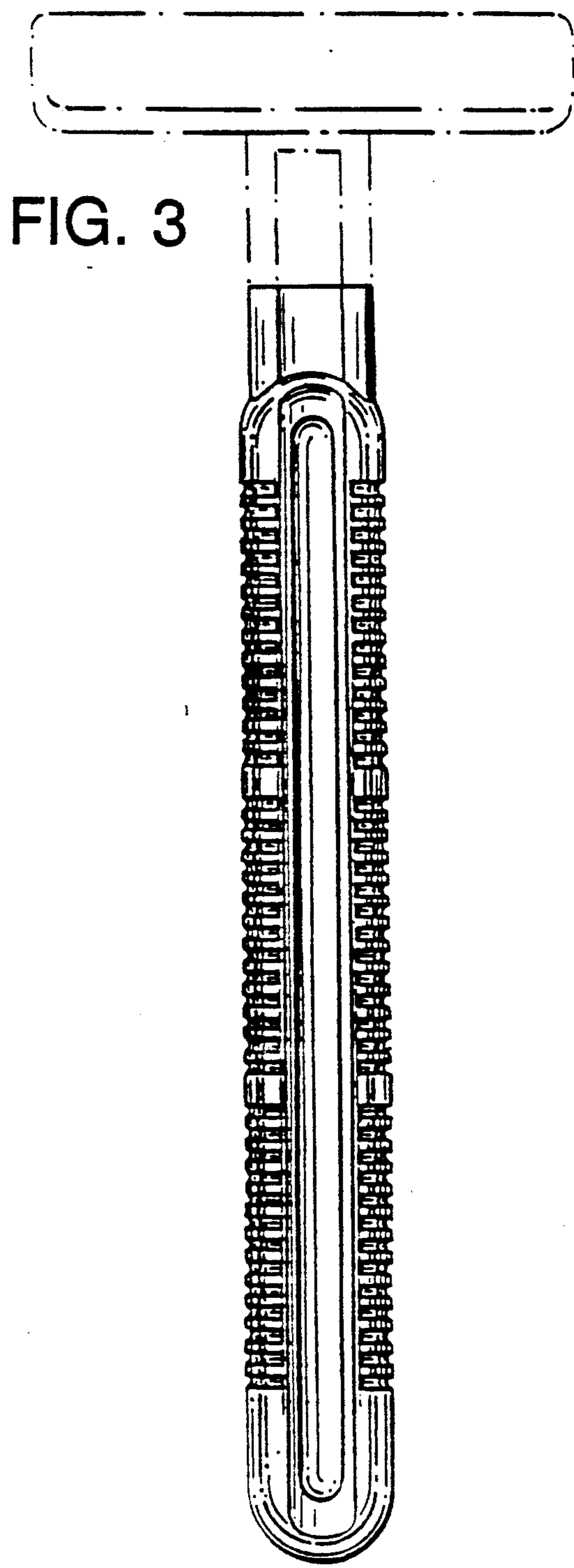
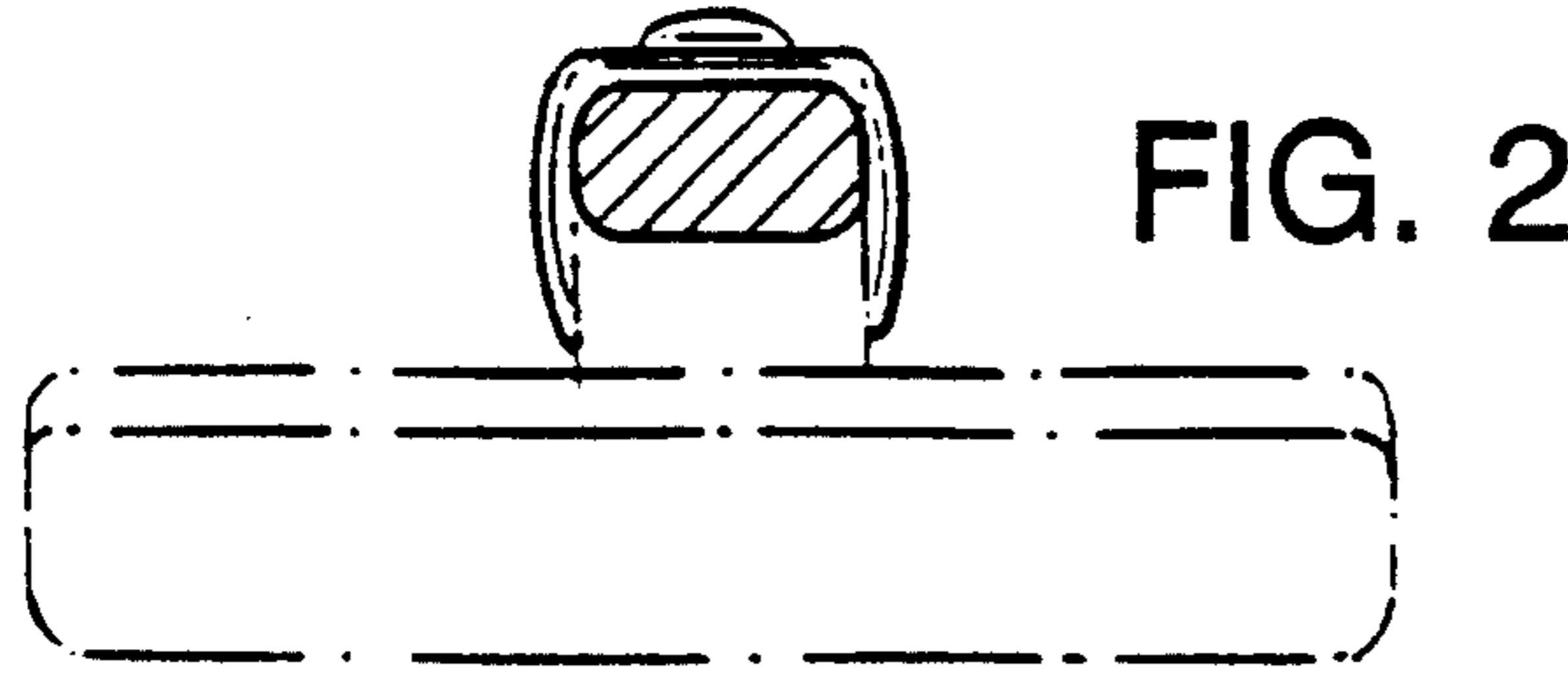

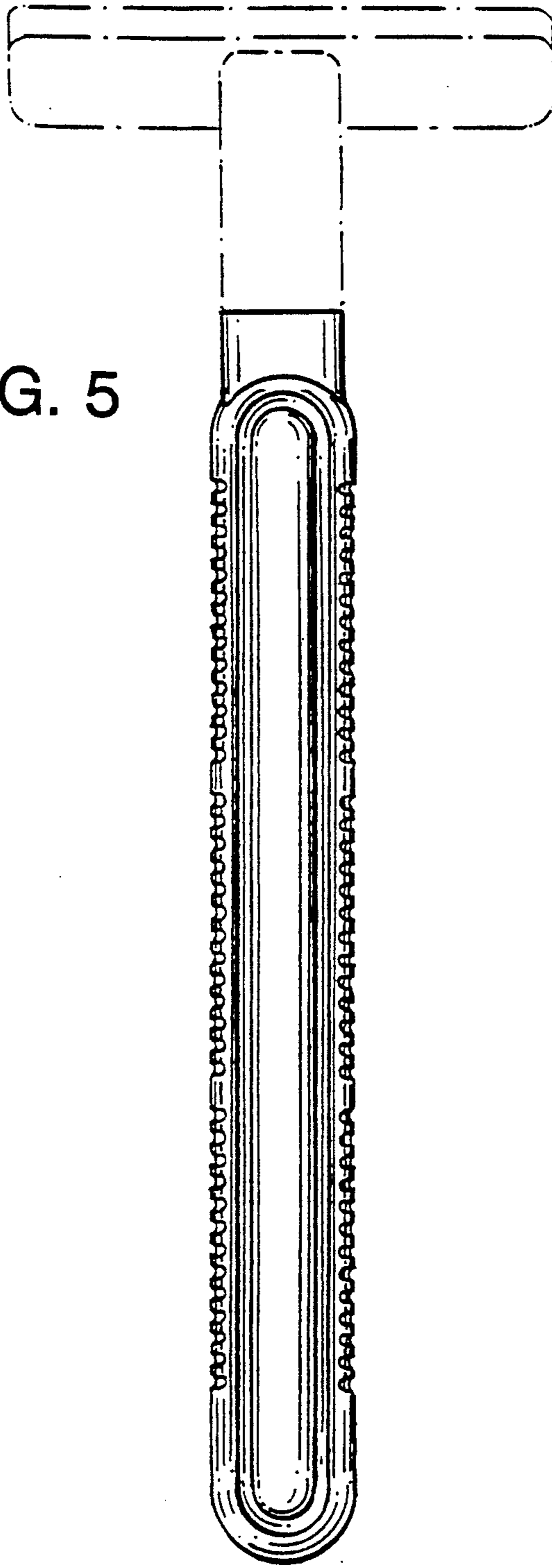
