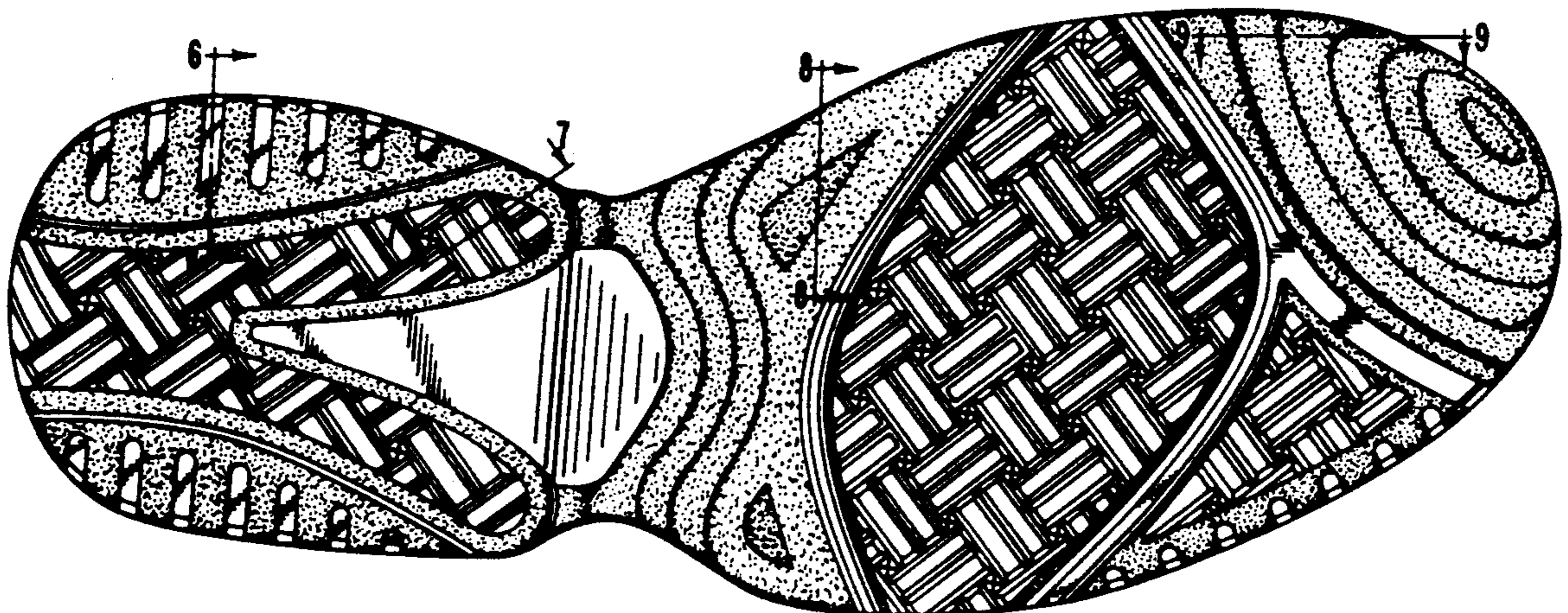

[57] **CLAIM**
 The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of one side of a shoe outsole showing my new design;
 FIG. 2 is a side elevational view of the other side of the shoe outsole shown in FIG. 1;
 FIG. 3 is a front elevational view of the shoe outsole shown in FIG. 1;
 FIG. 4 is a rear elevational view of the shoe outsole shown in FIG. 1;
 FIG. 5 is a bottom plan view of the shoe outsole shown in FIG. 1;
 FIG. 6 is a cross sectional view taken along line 6—6 in FIG. 5;
 FIG. 7 is a cross sectional view taken along line 7—7 in FIG. 5;
 FIG. 8 is a cross sectional view taken along line 8—8 in FIG. 5; and,
 FIG. 9 is a cross sectional view taken along line 9—9 in FIG. 5.
 The broken line showing of a shoe upper is for illustrative purposes and forms no part of the claimed design.



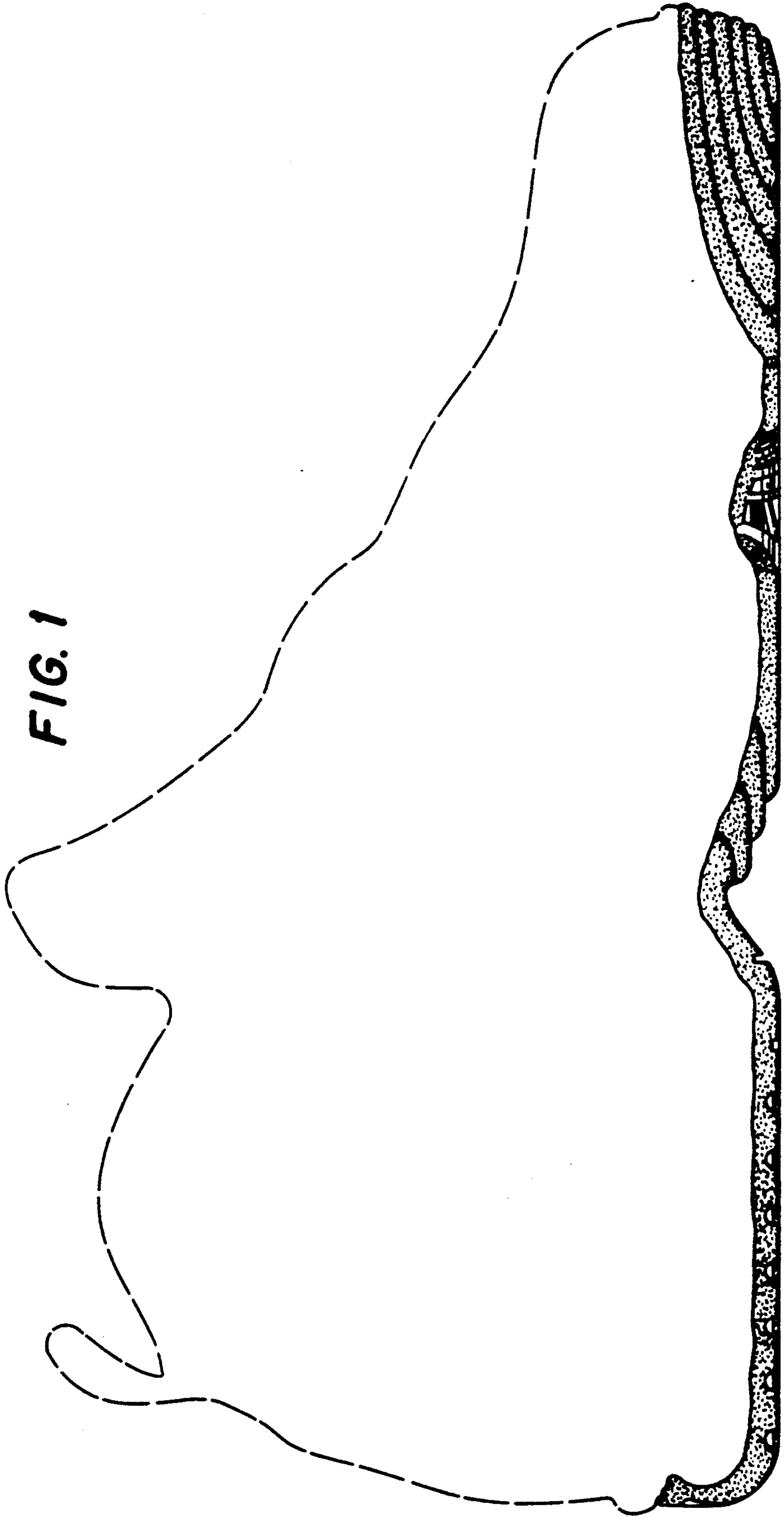

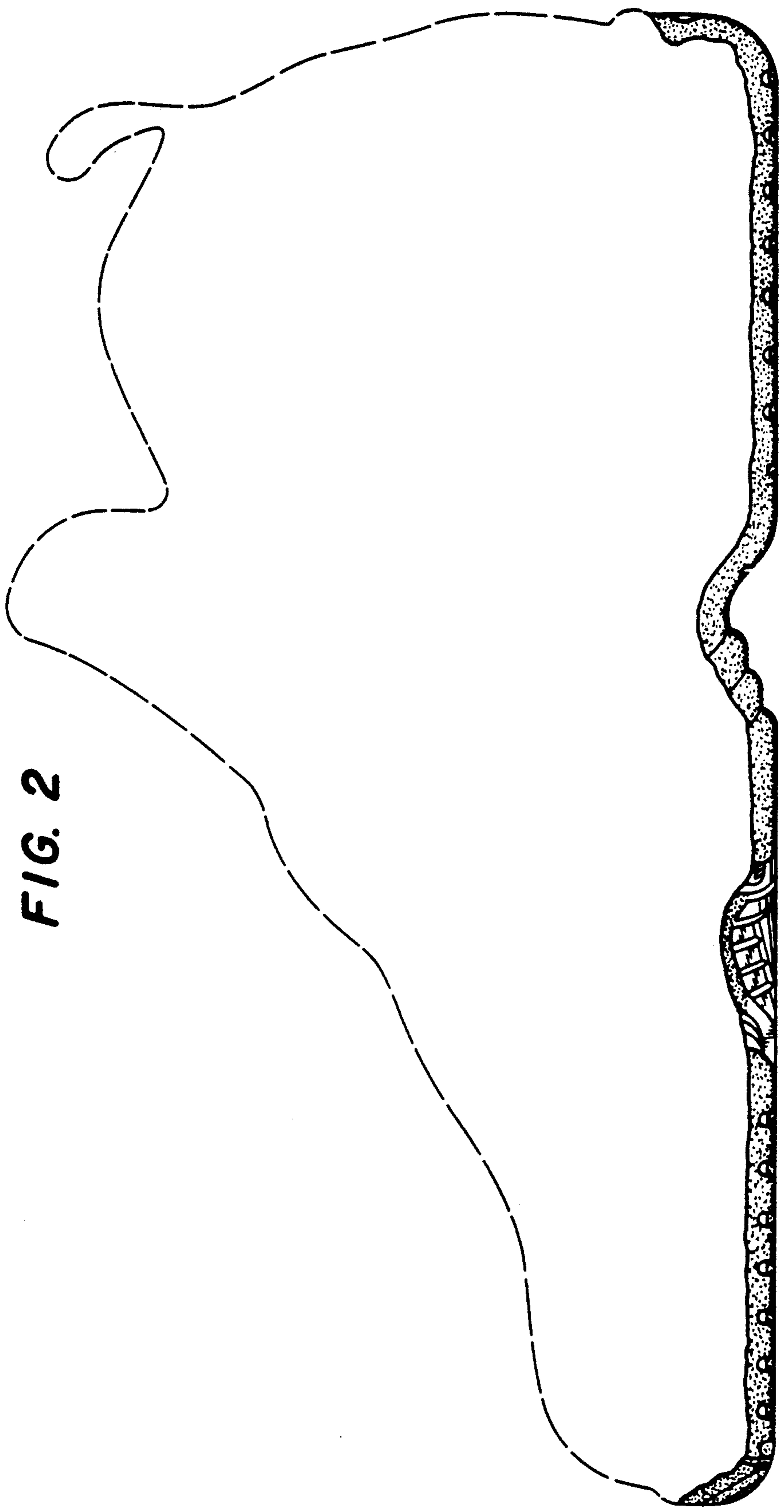

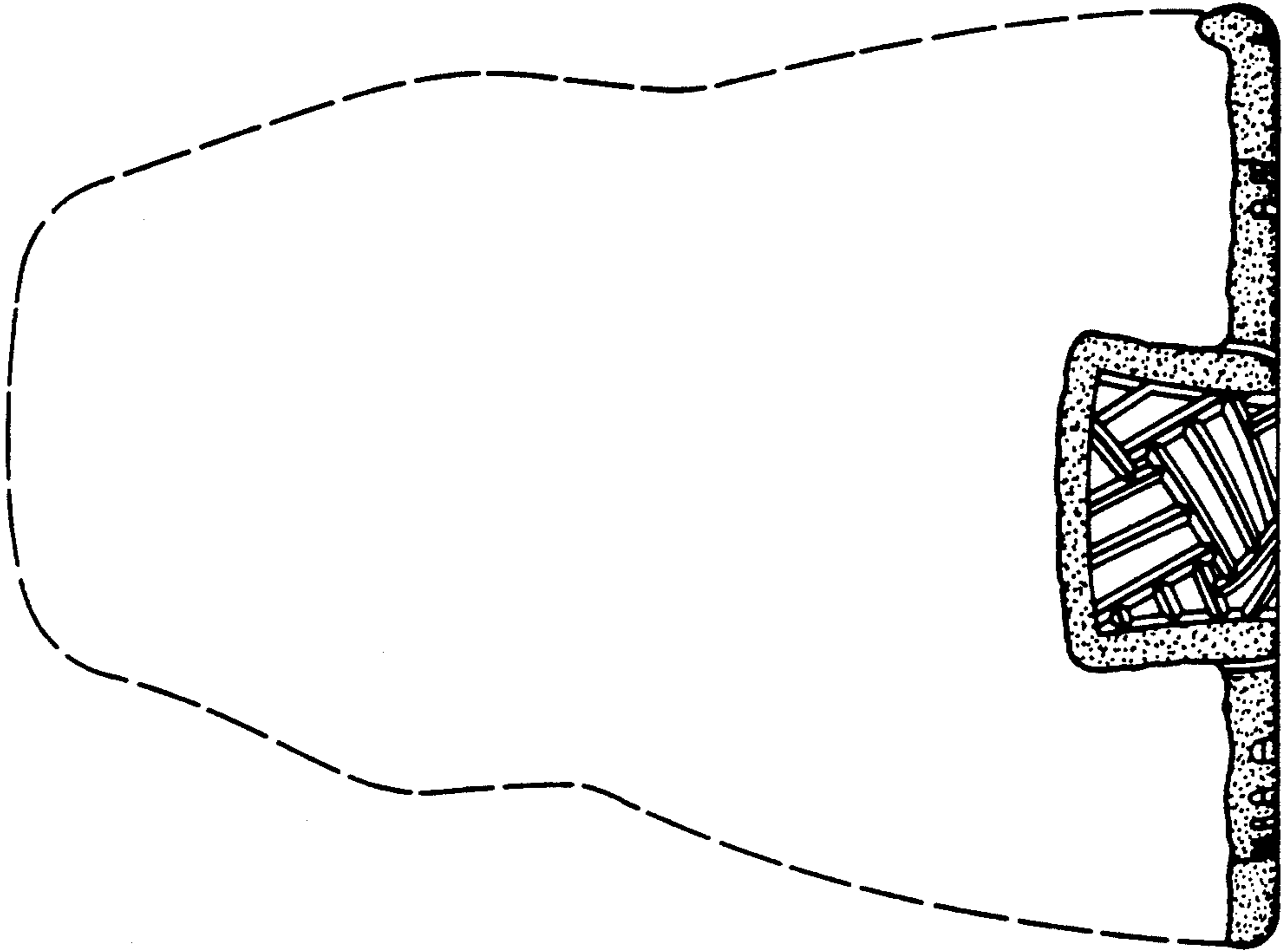
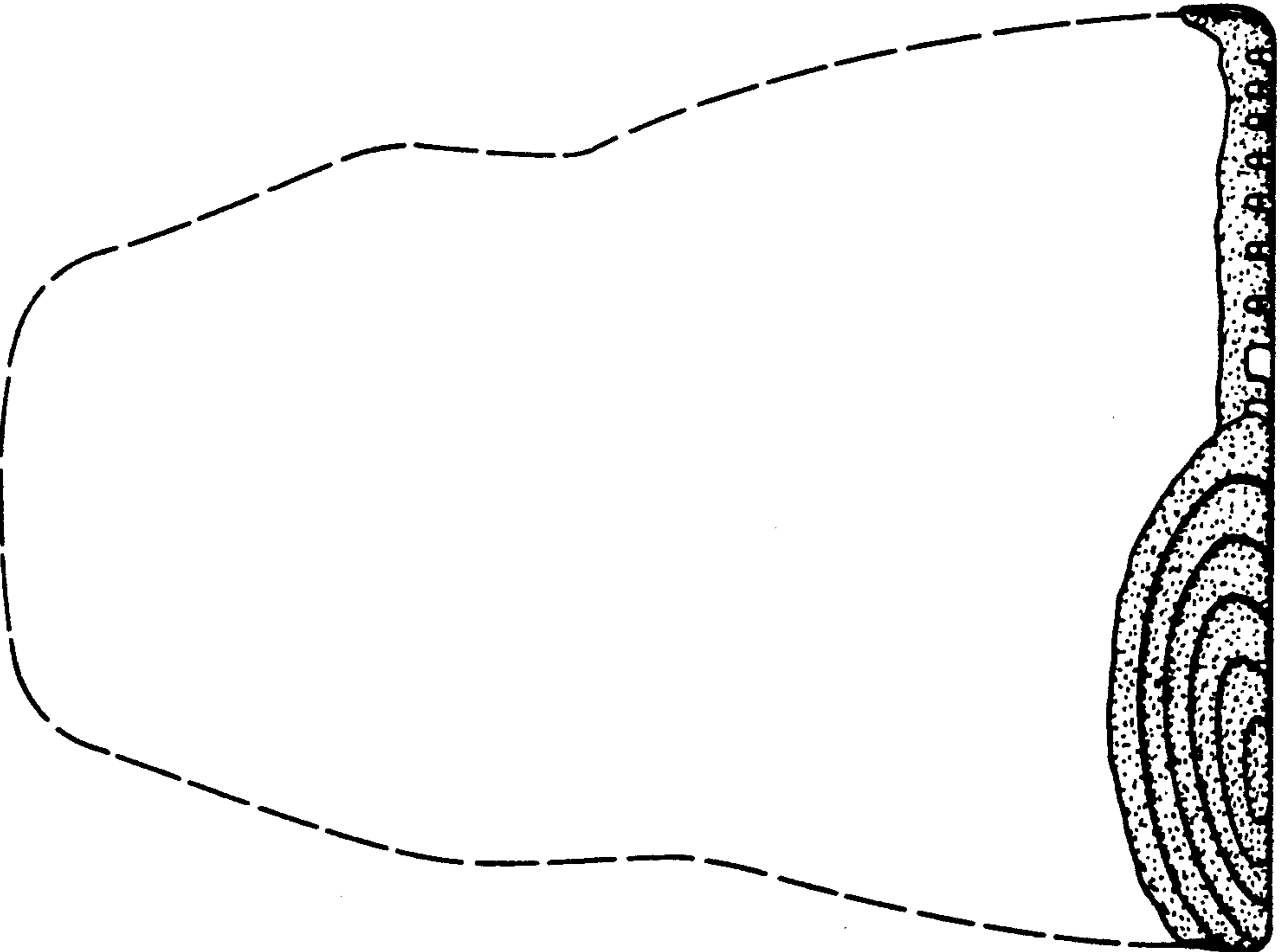

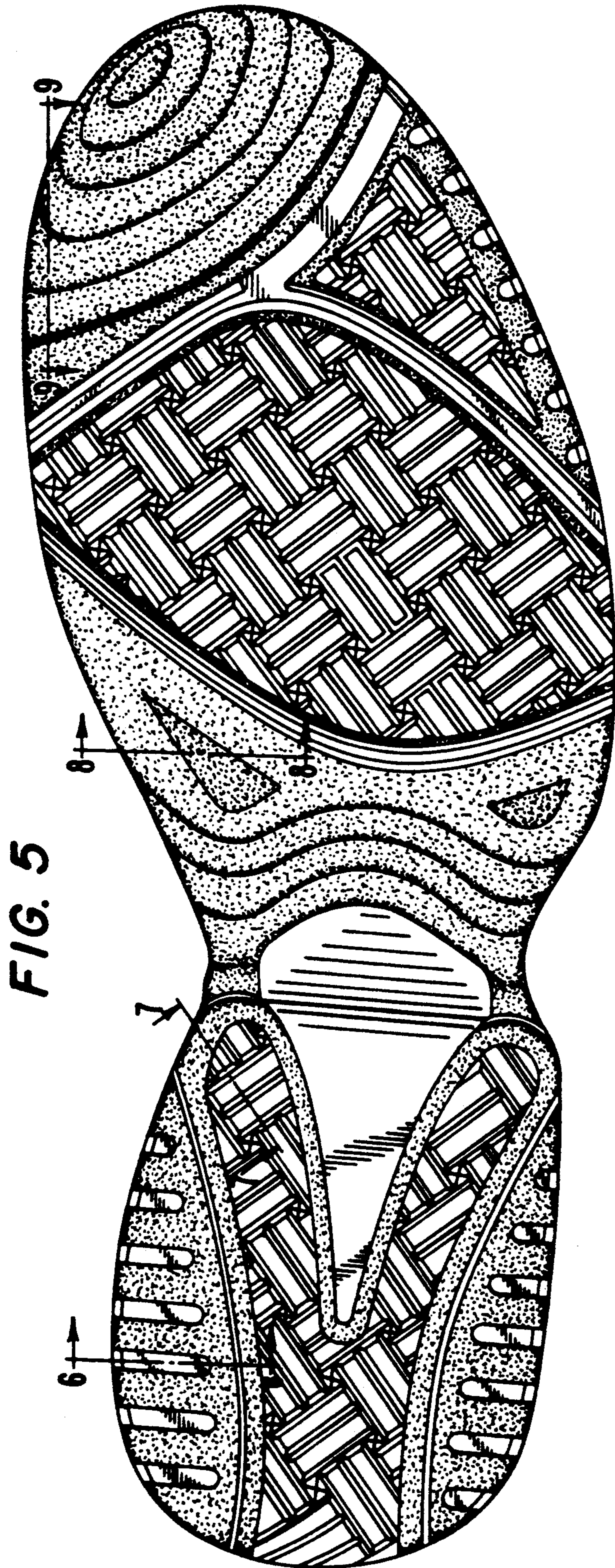
