FIG. 25 is a rear elevational view thereof.

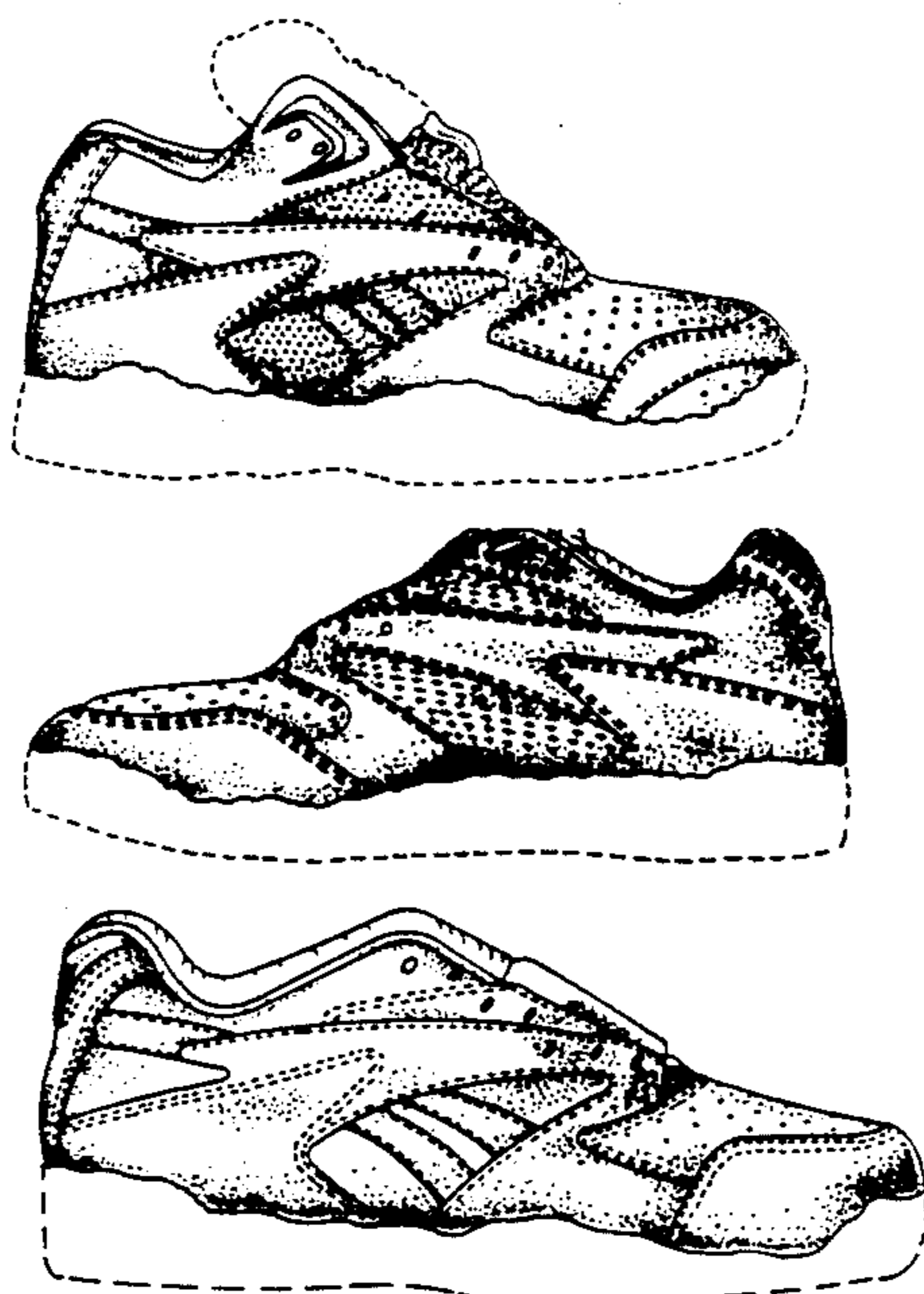
The broken line showing of a shoed sole and tongue top in FIGS. 1-25 is for illustrative purposes only and forms no part of the claimed design.

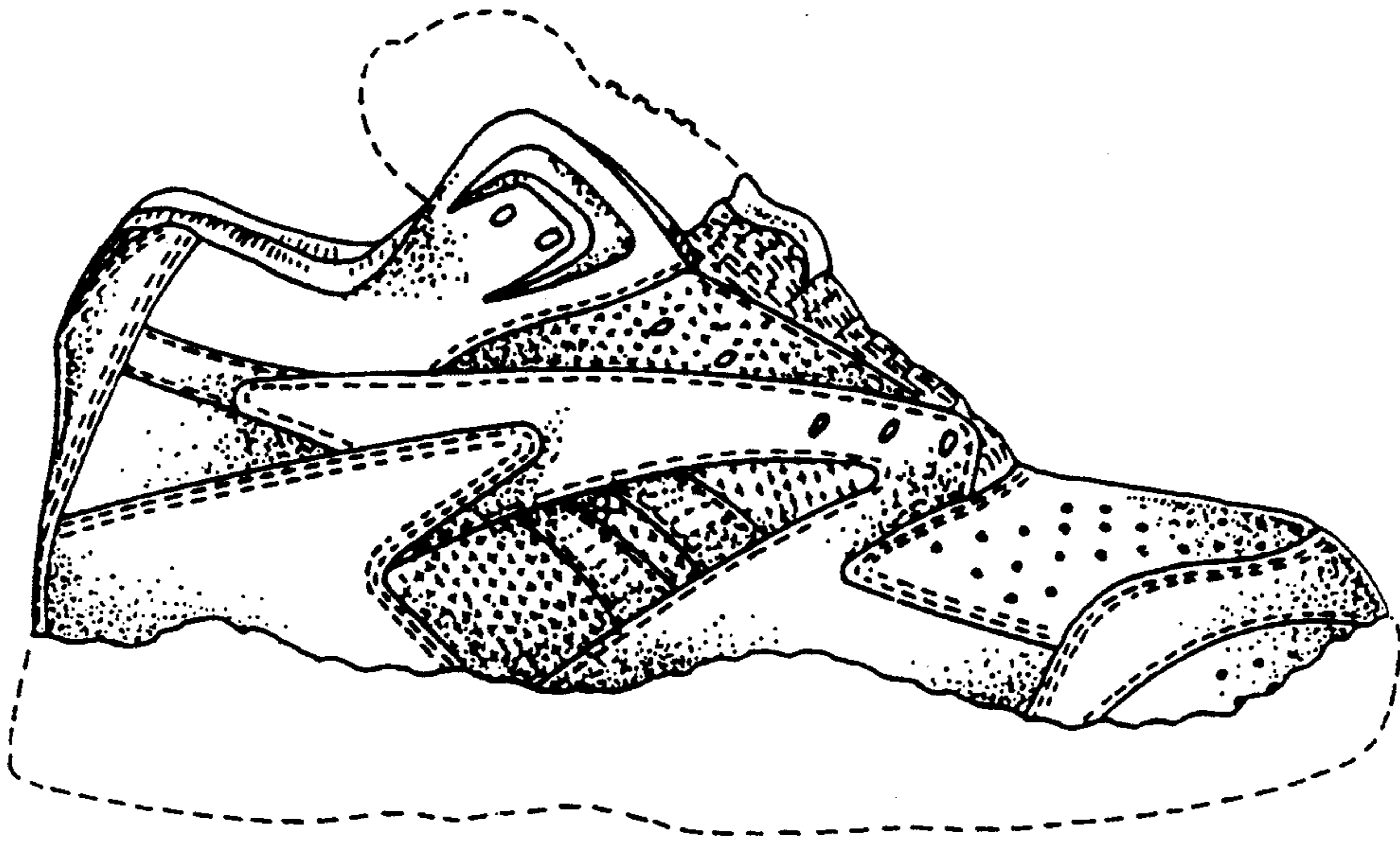

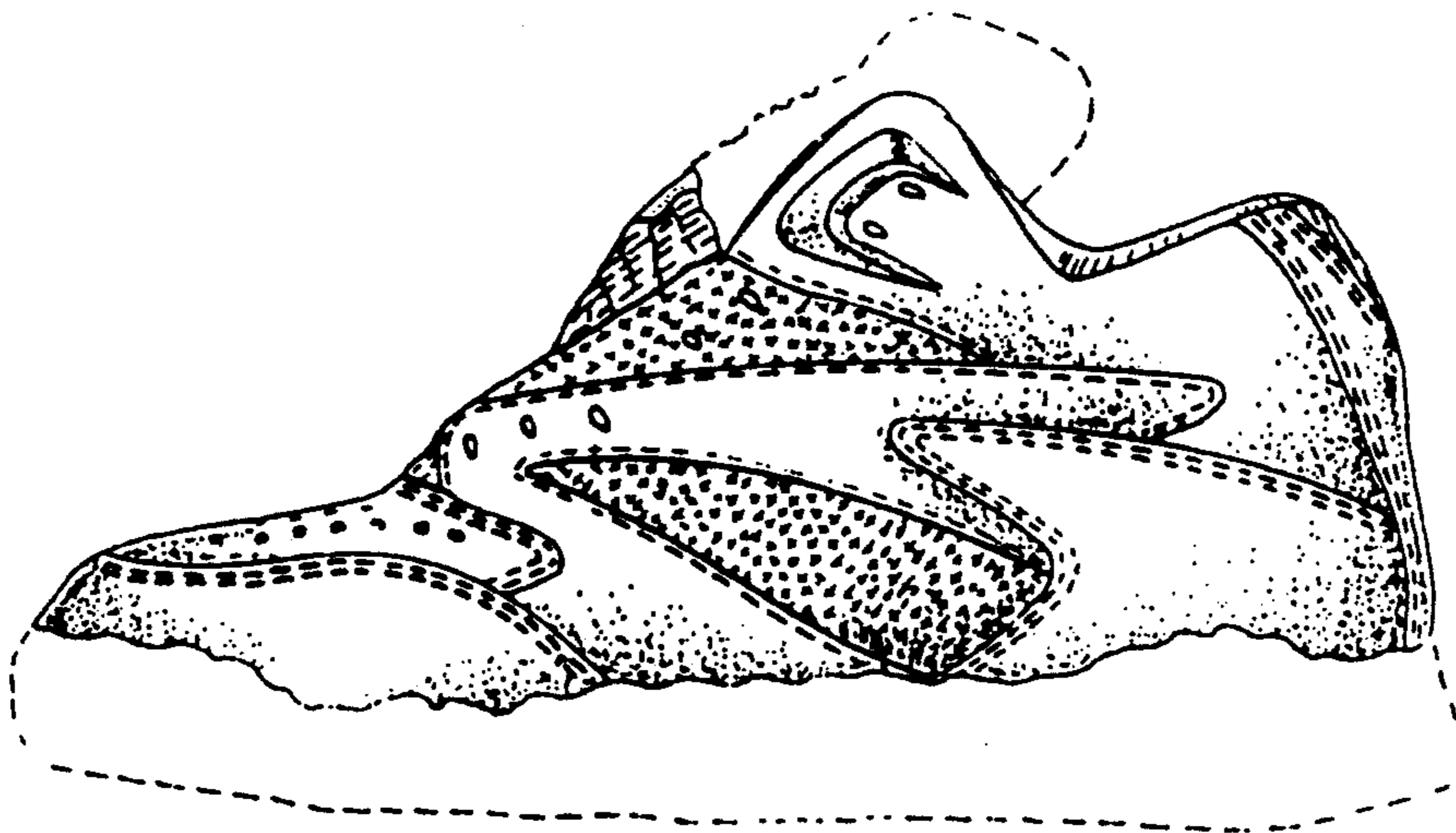

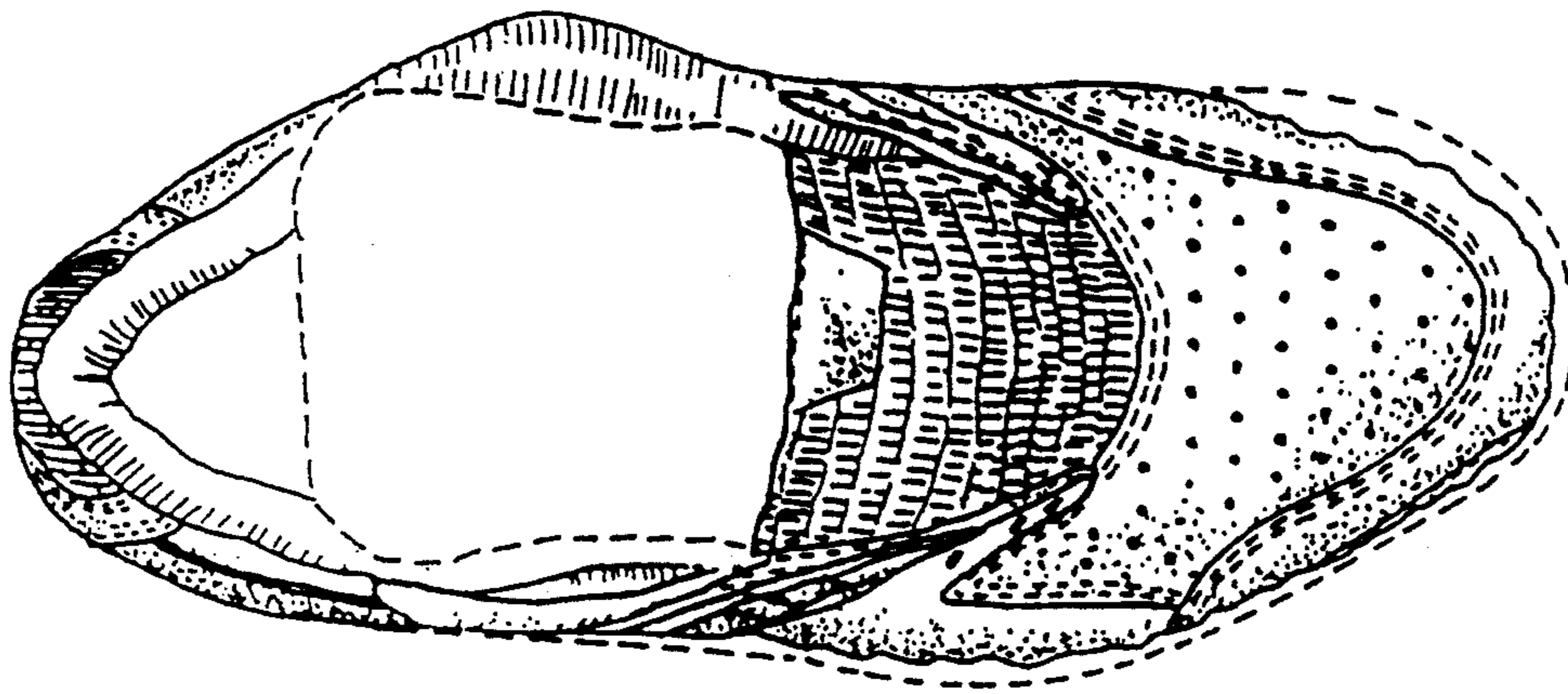

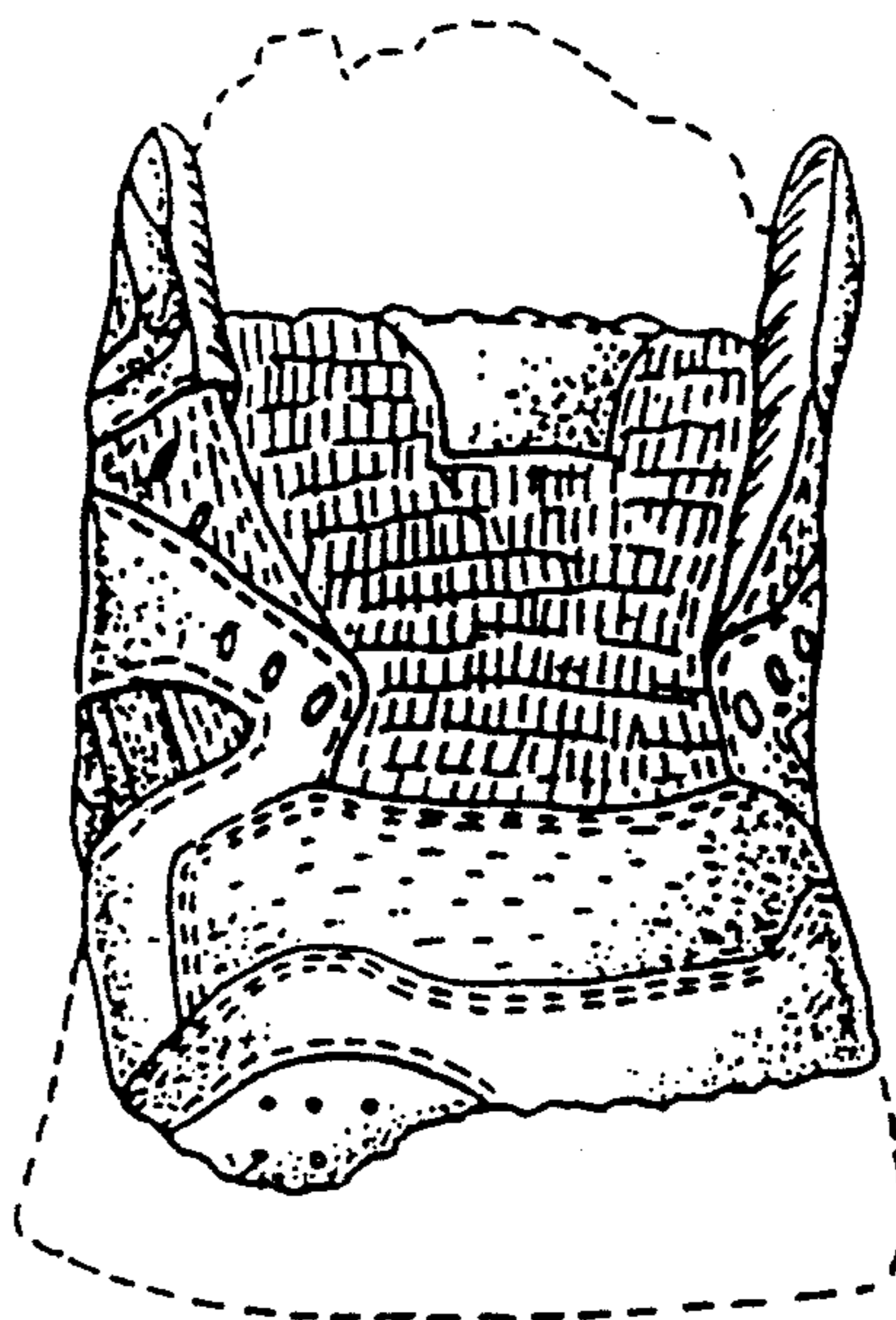

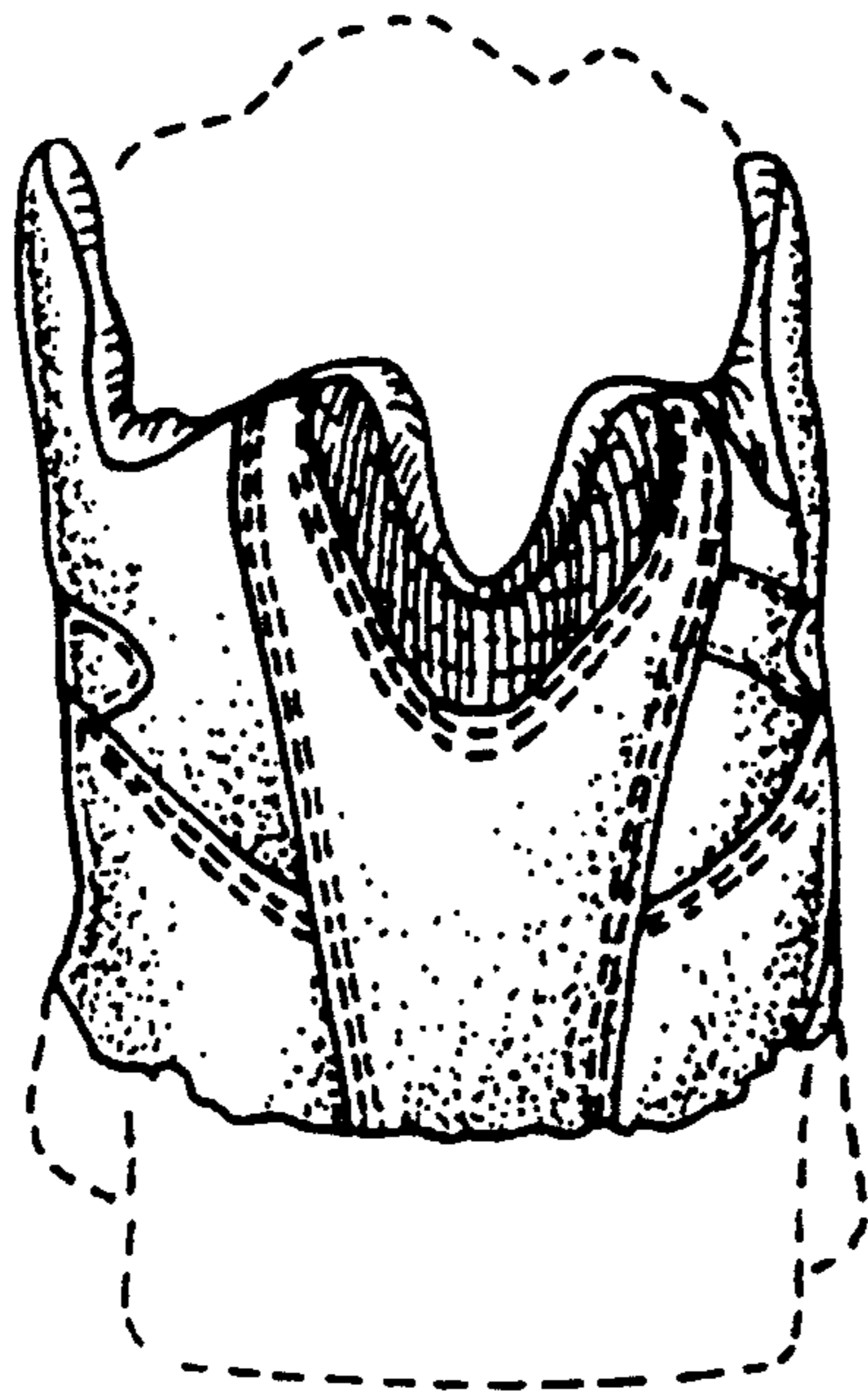

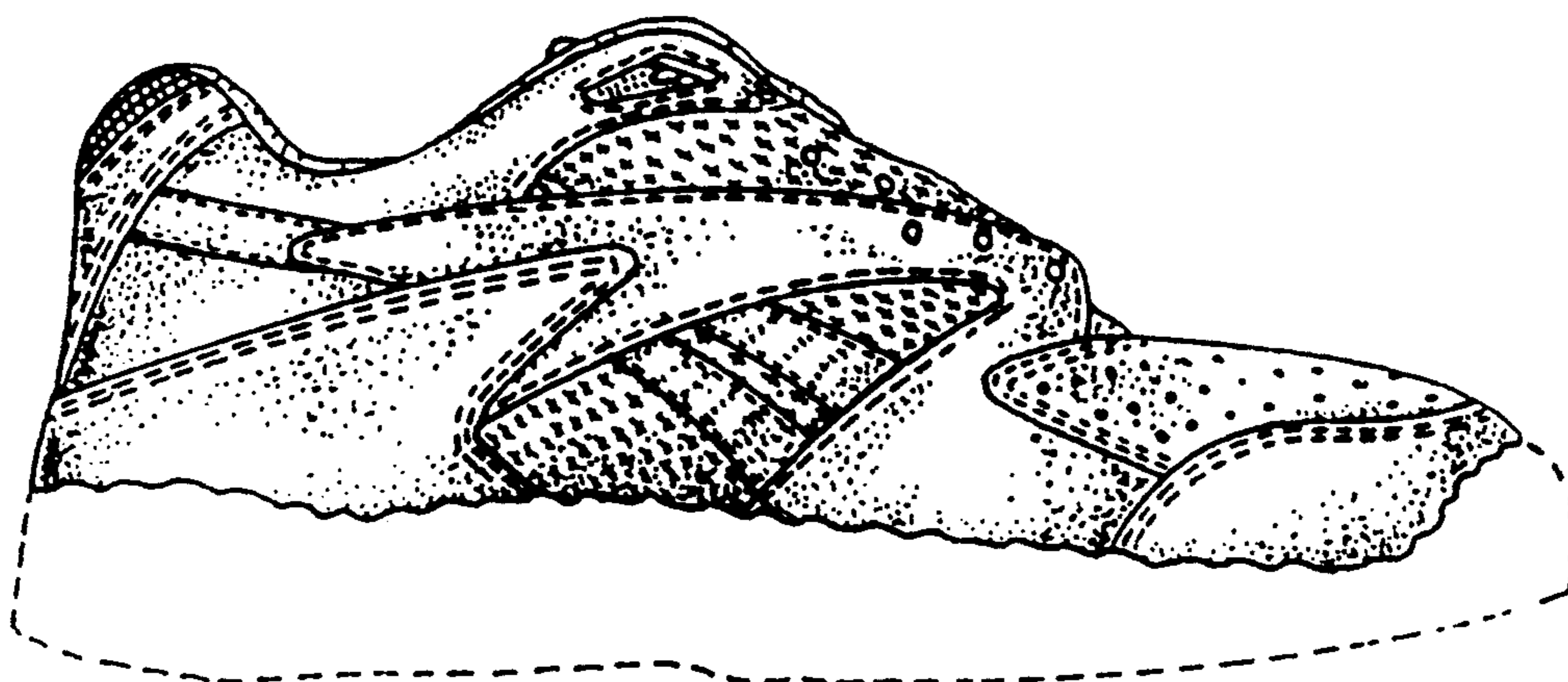

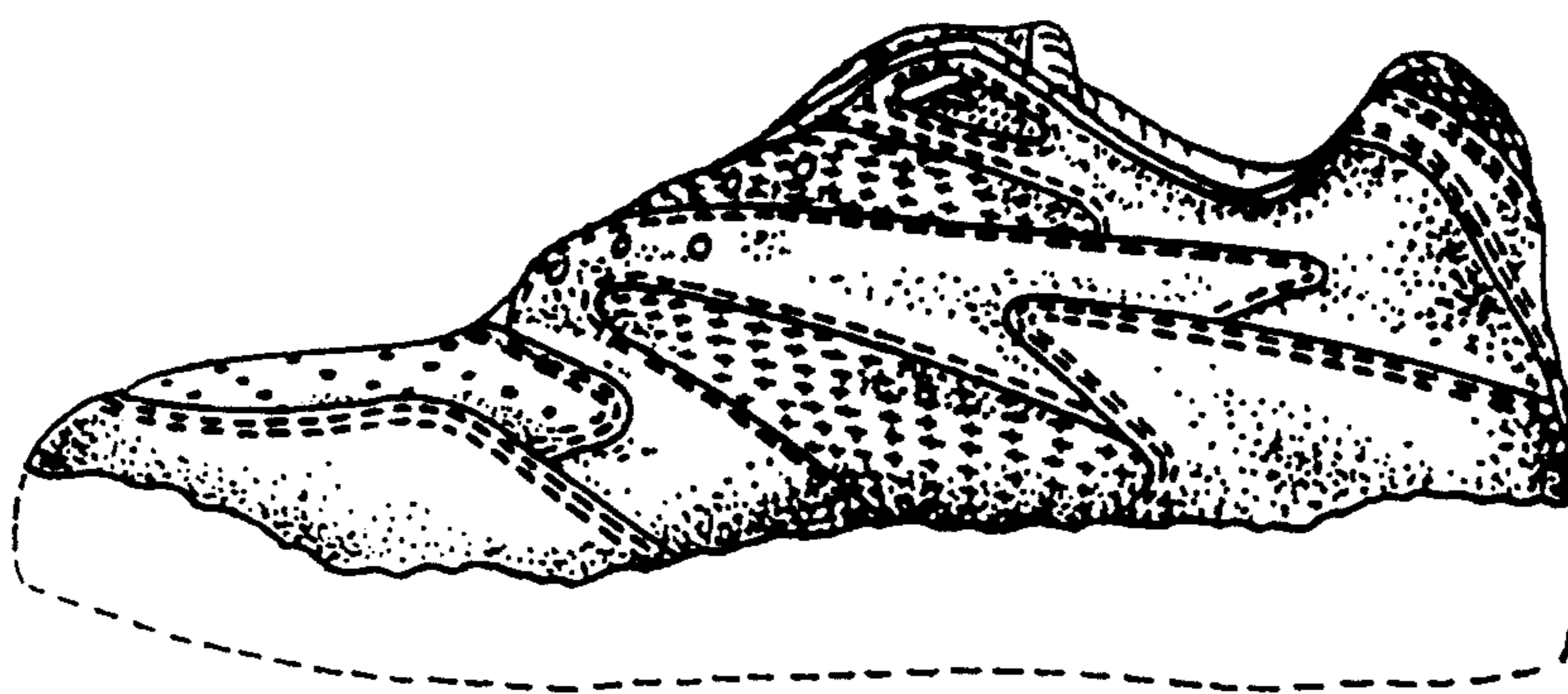

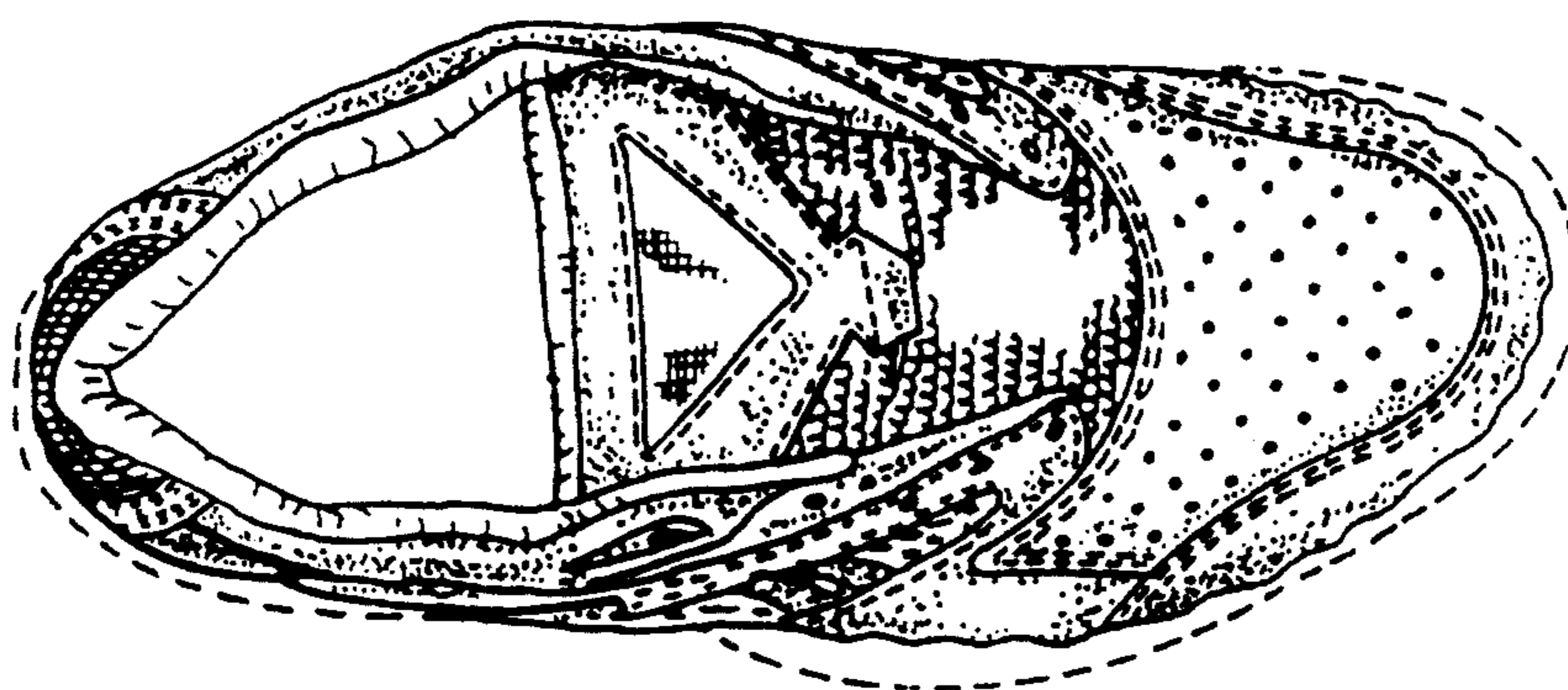

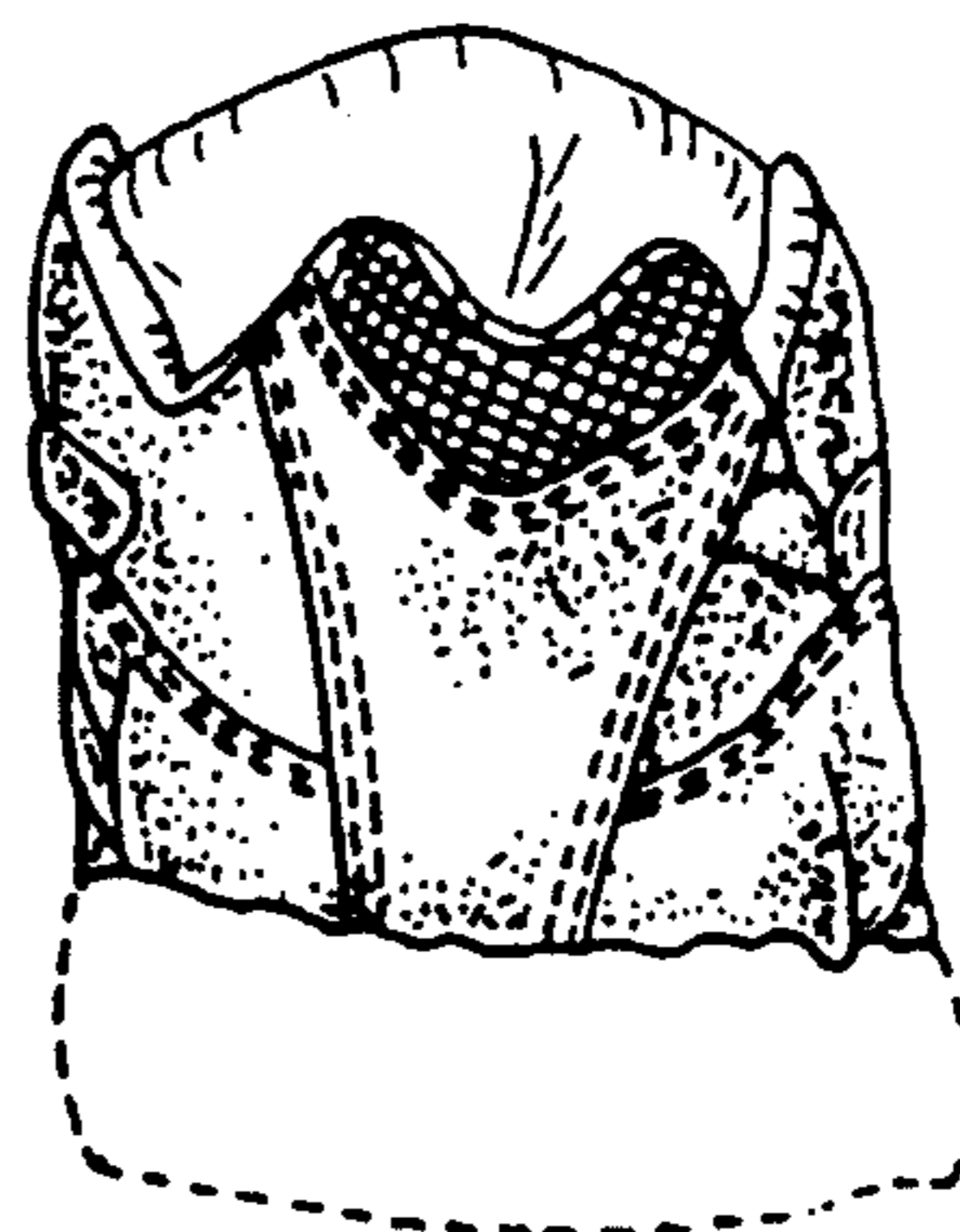

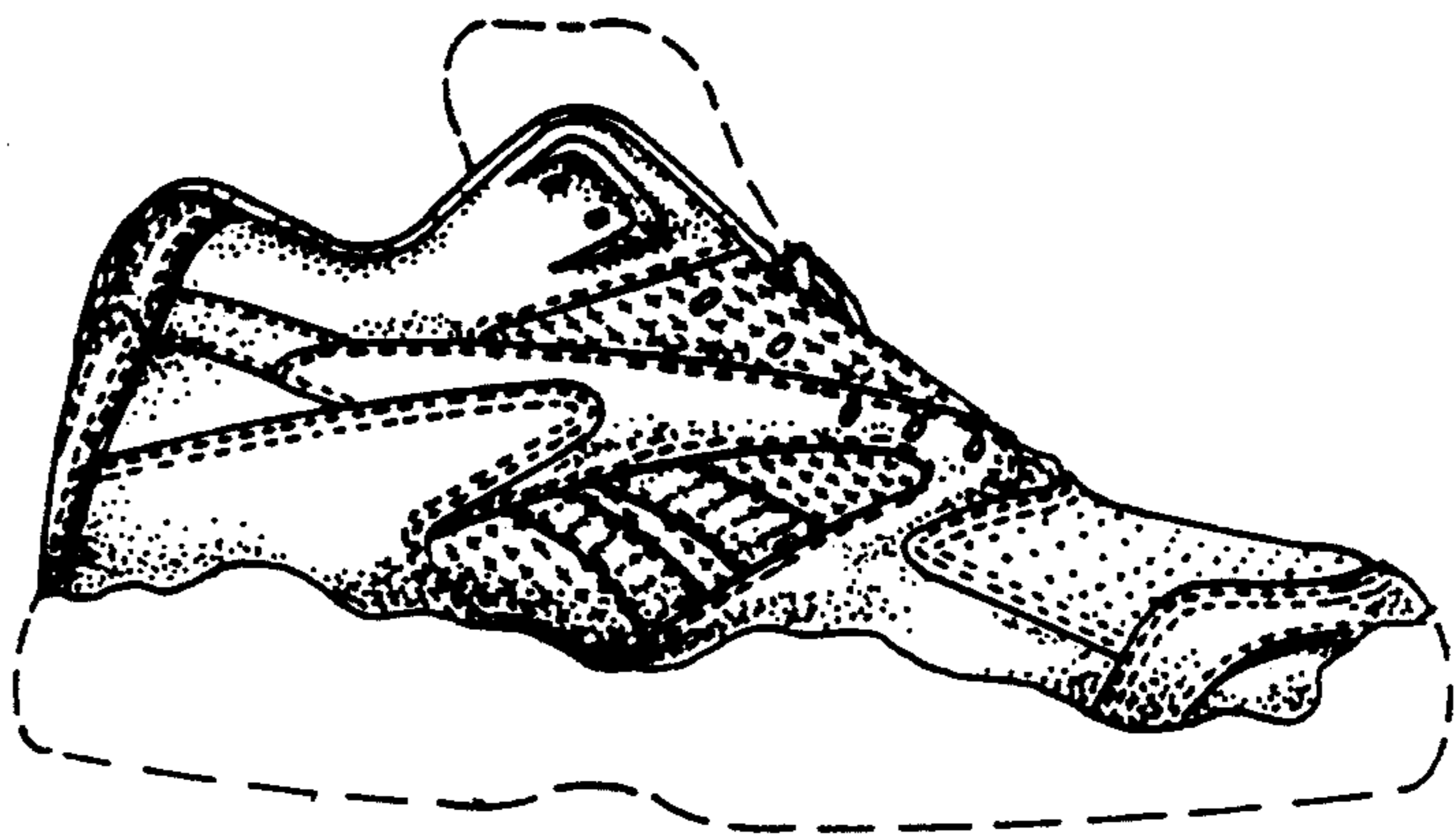

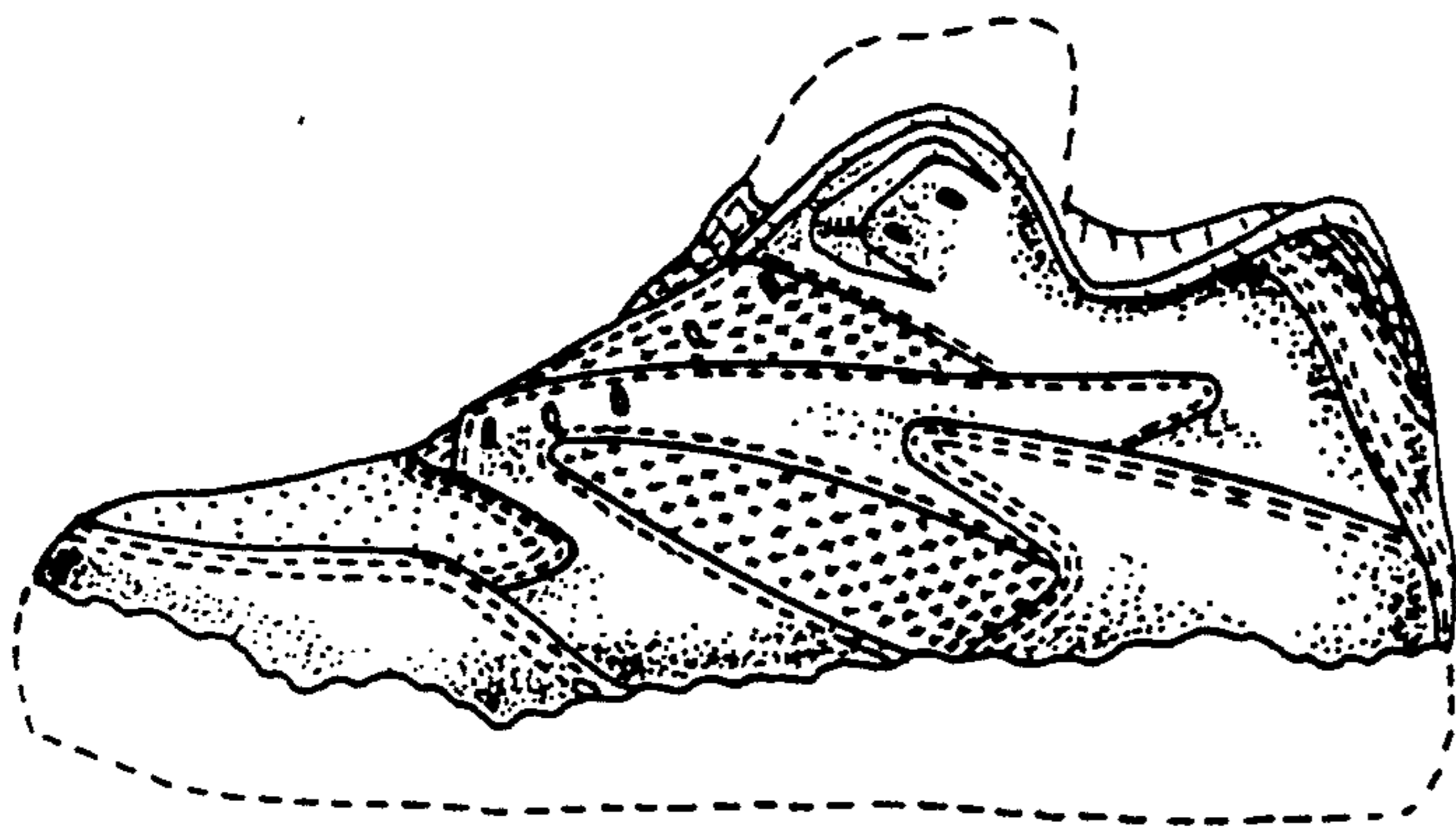

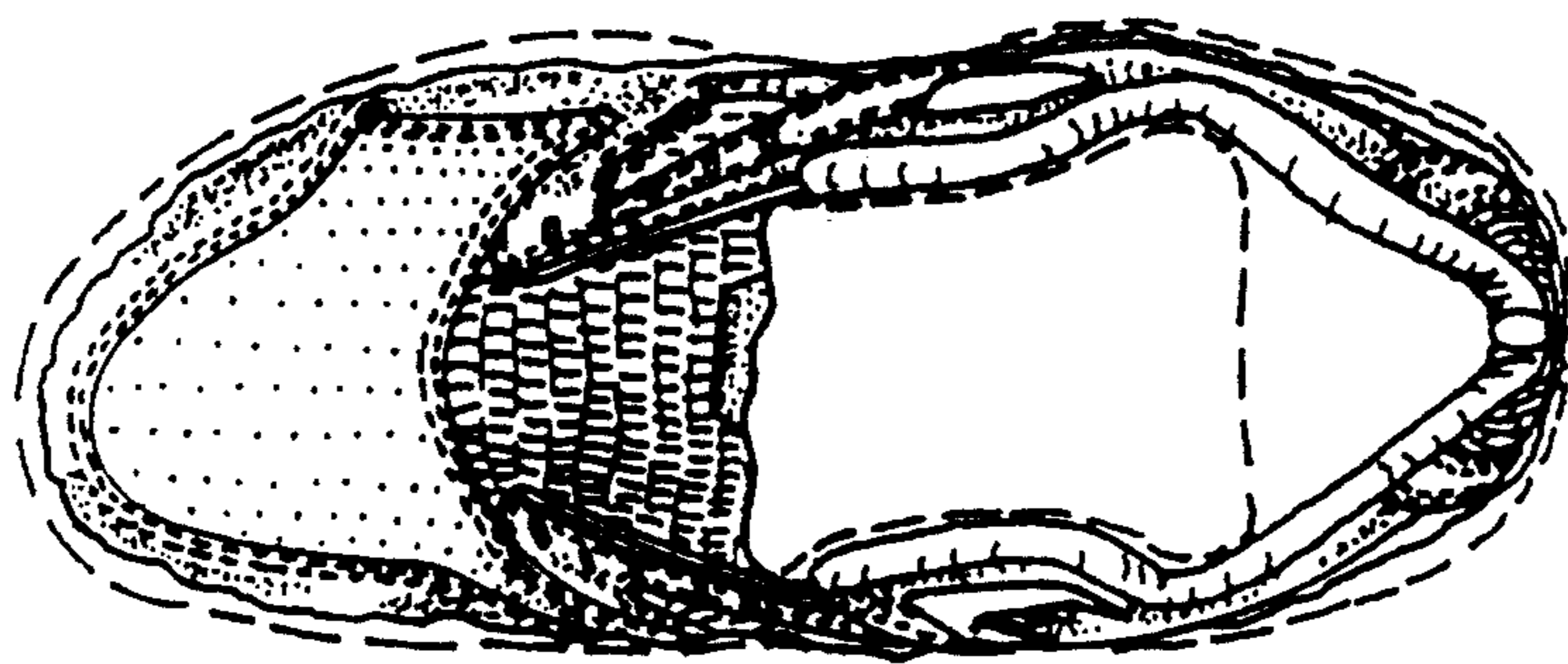

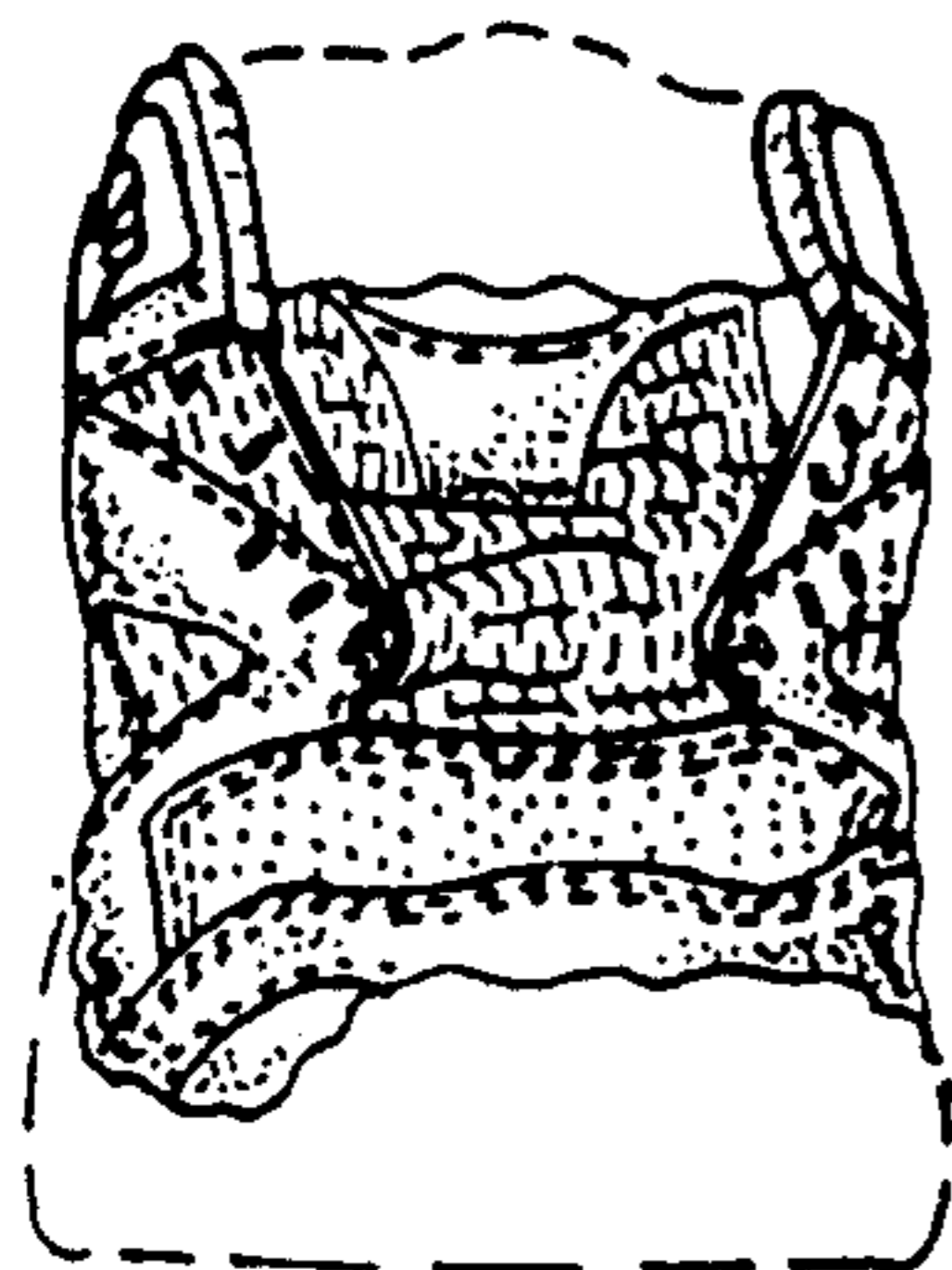

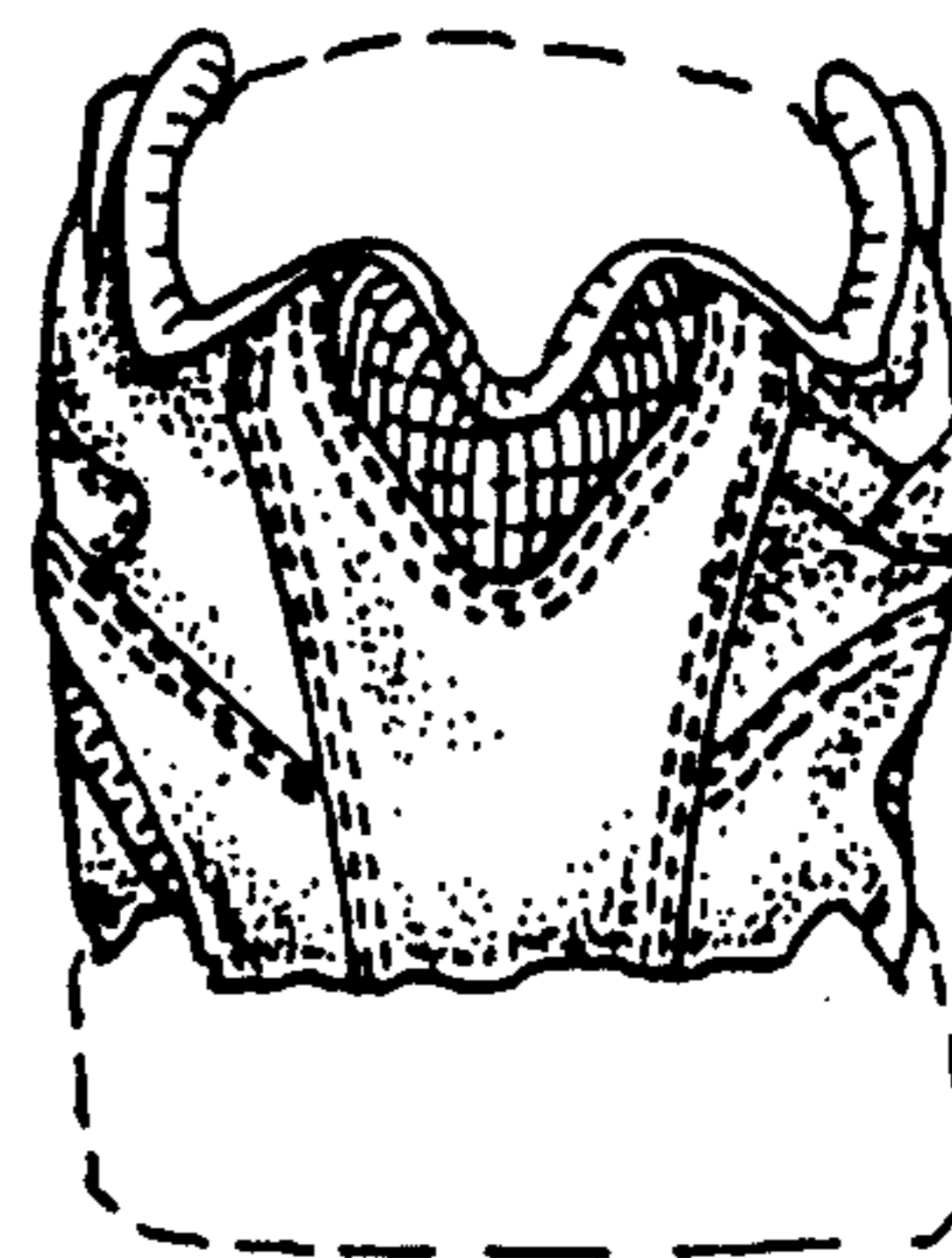

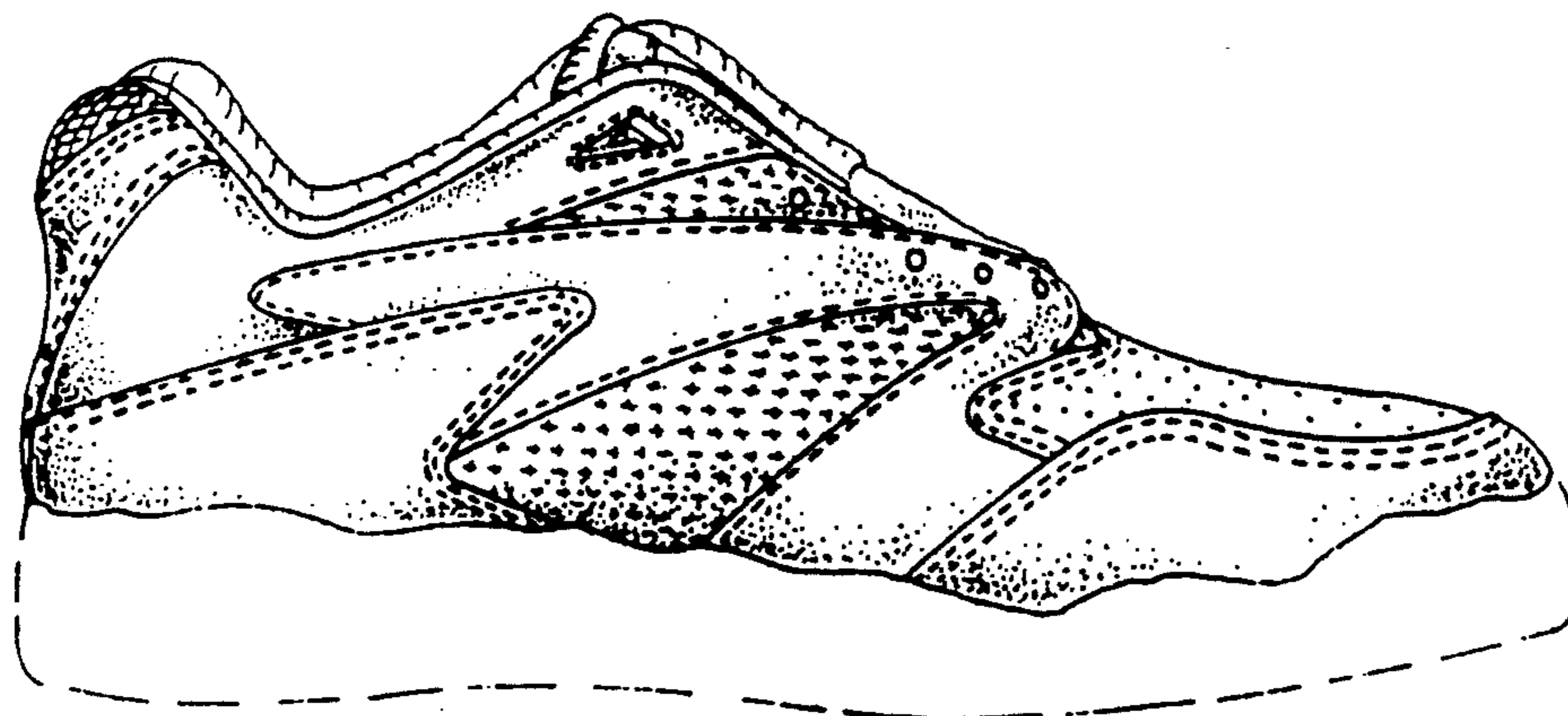

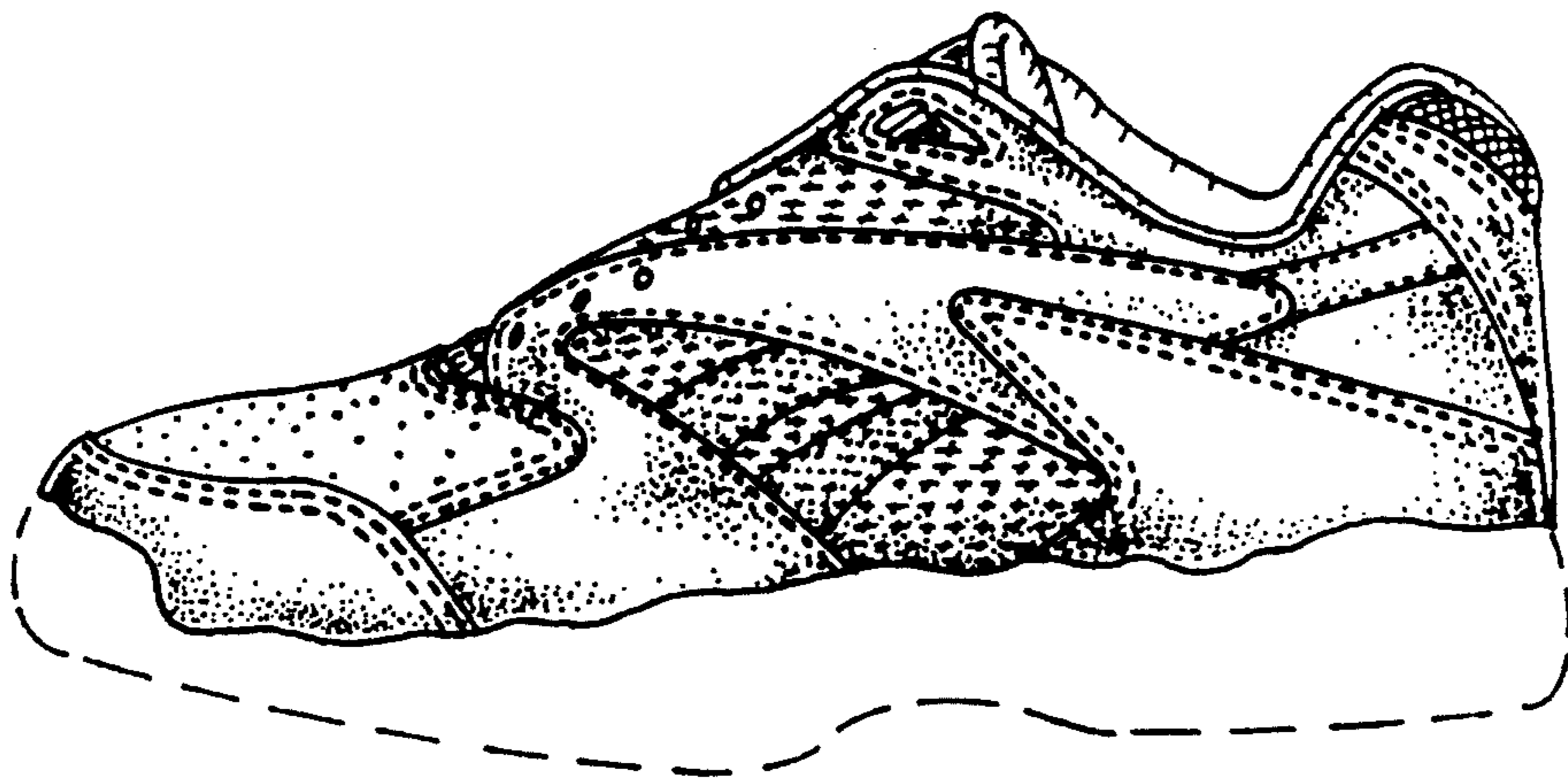

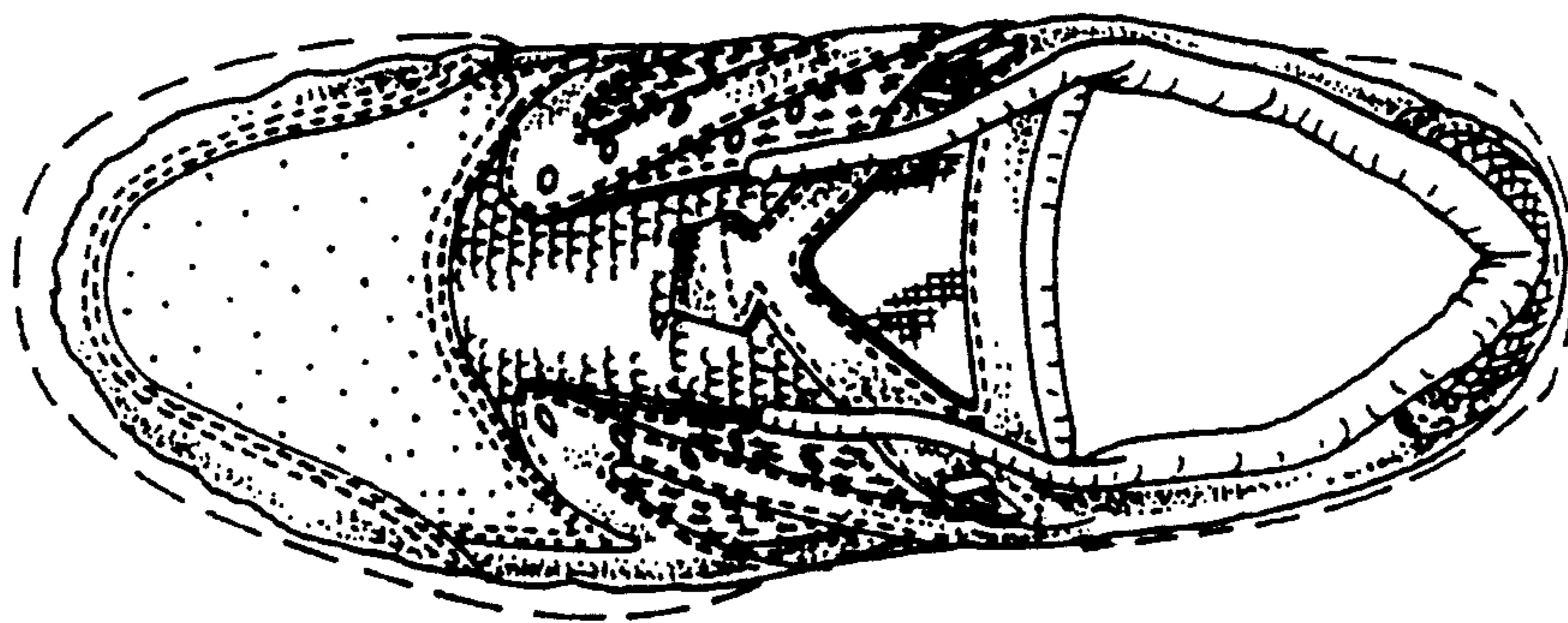

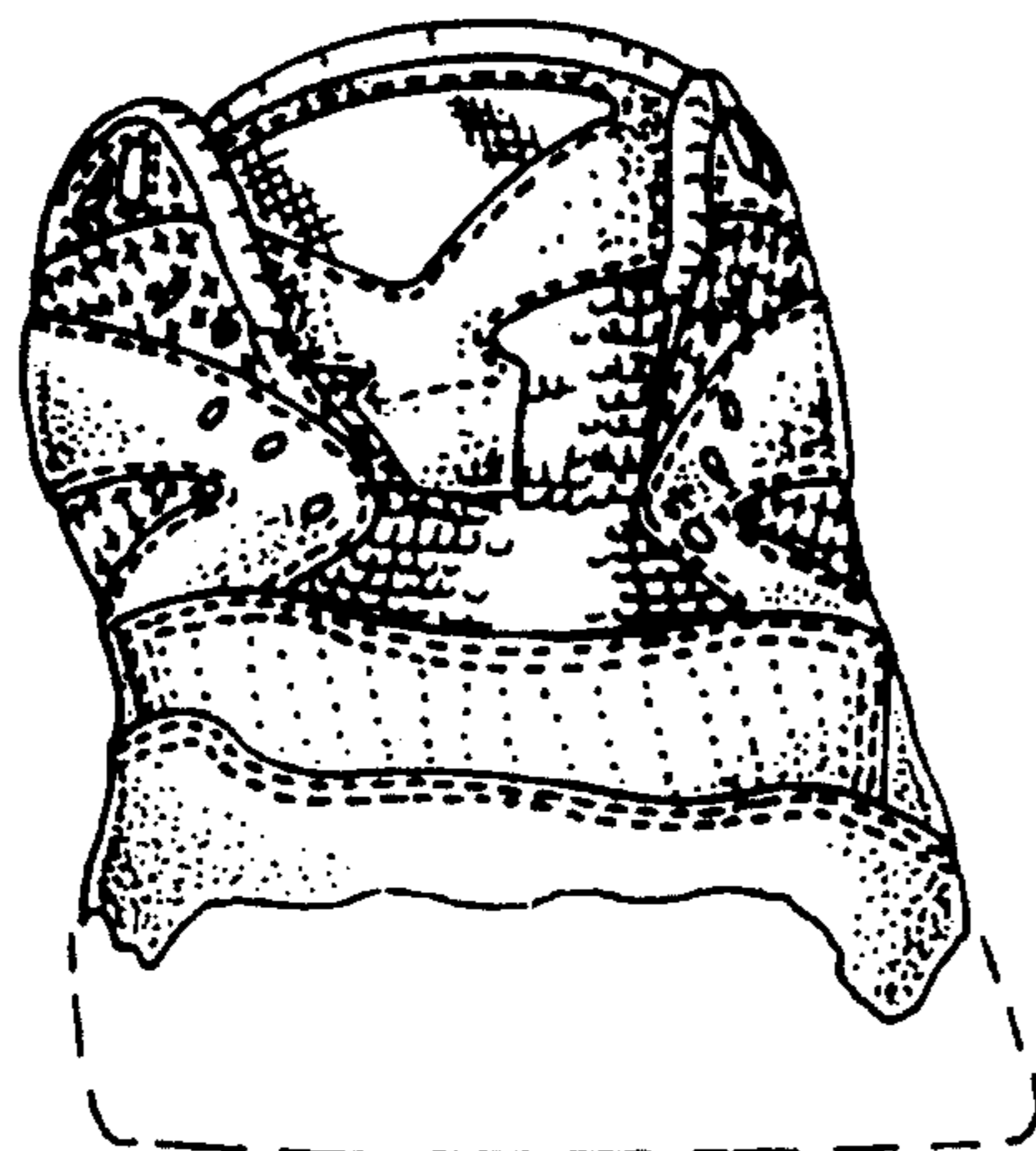

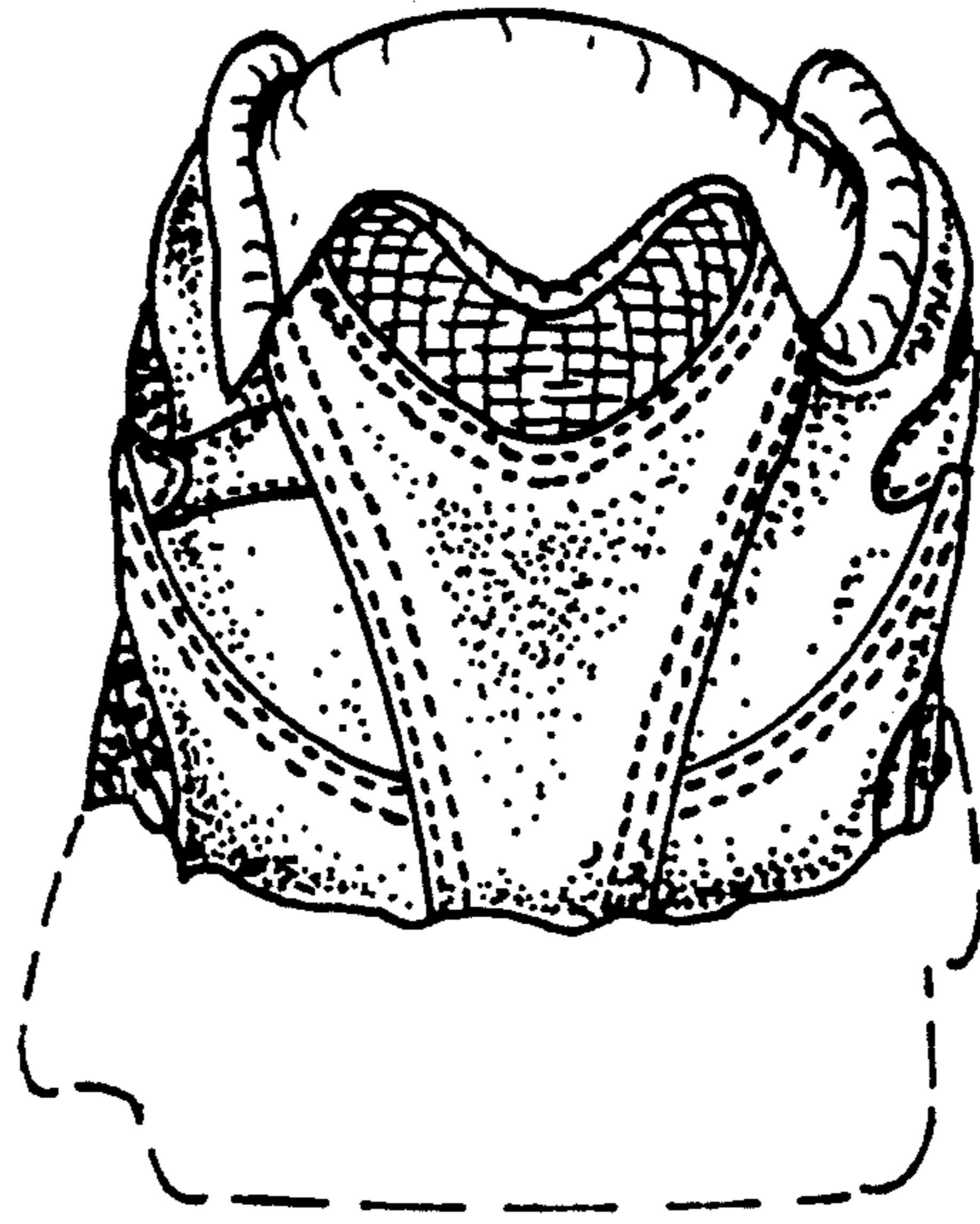

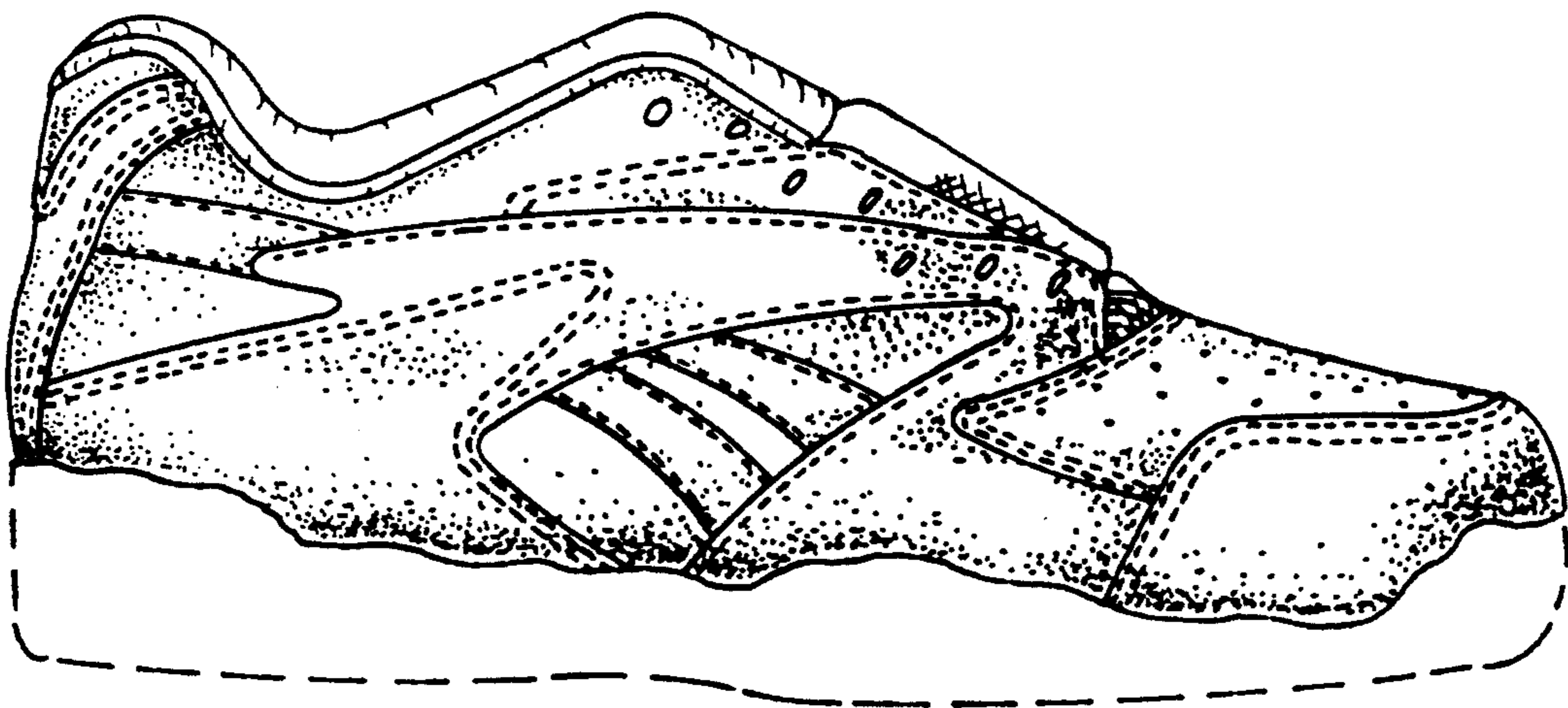

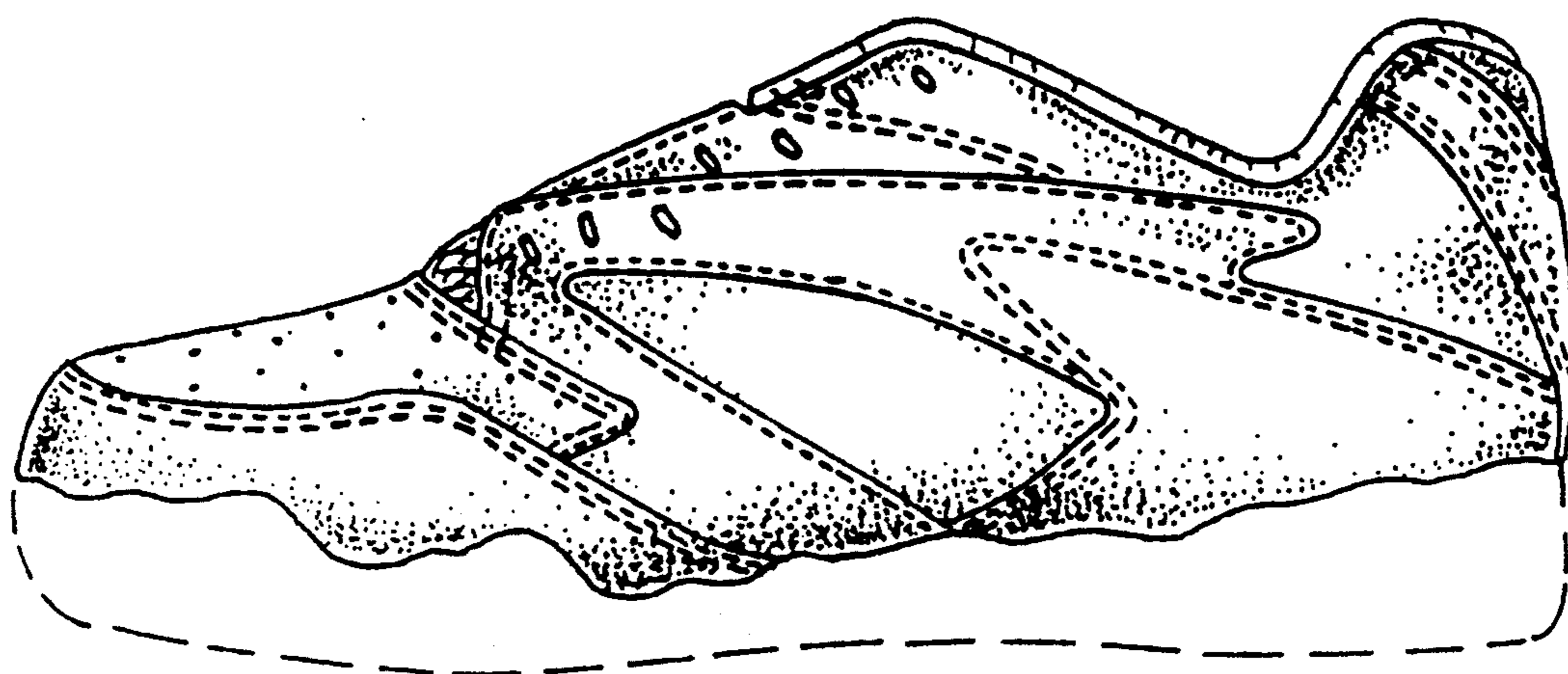

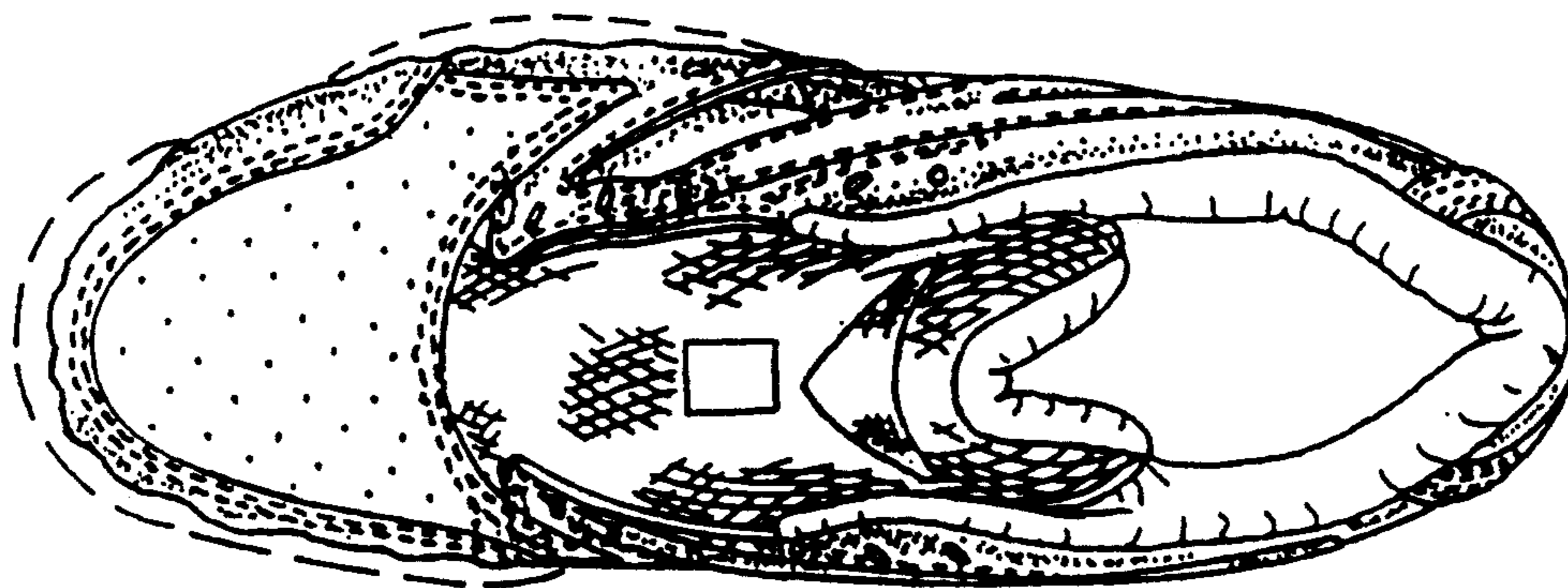

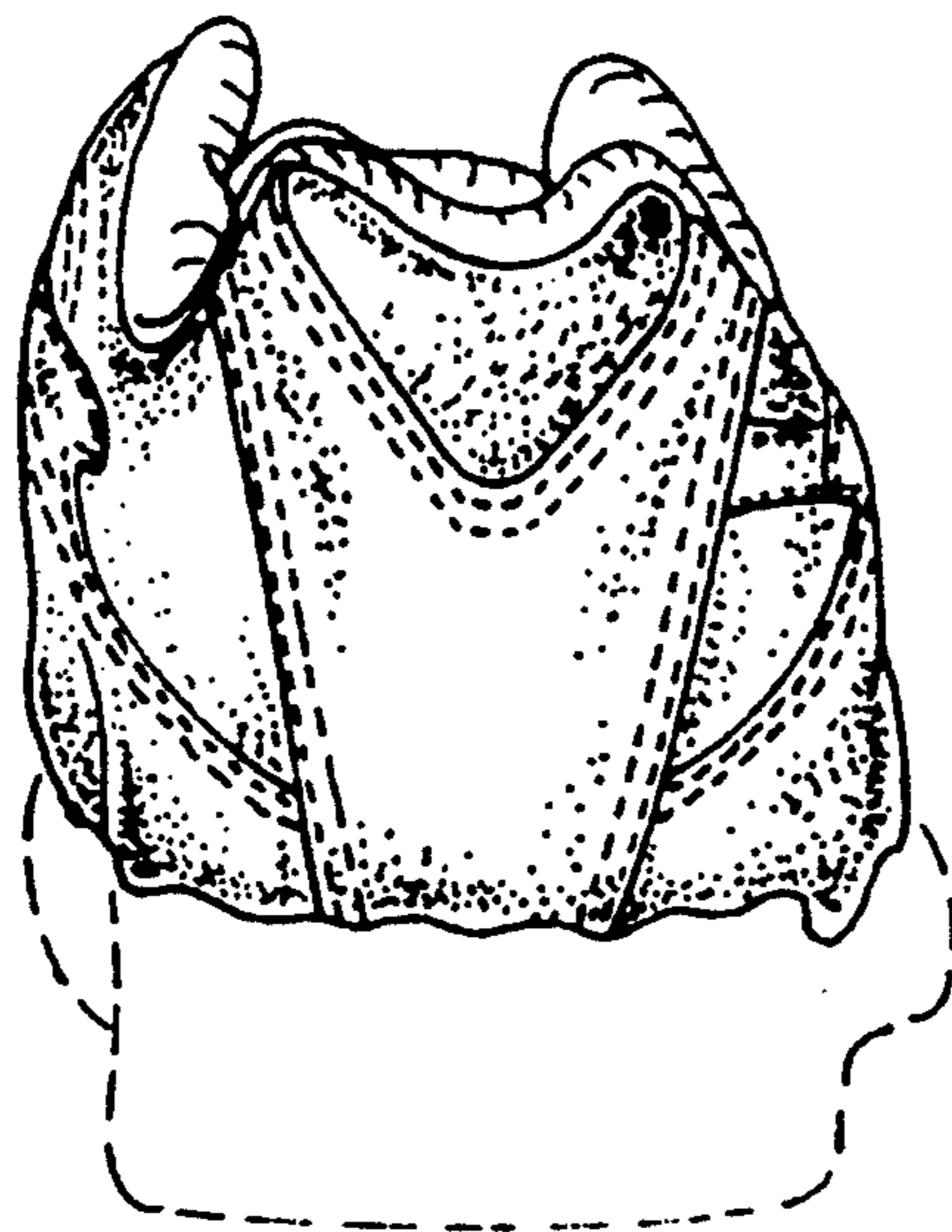
