[57] CLAIM

The ornamental design for a combined spray container and cap, as shown and described.

DESCRIPTION

FIG. 1 is an exploded perspective view of a combined spray container and cap showing my new design;

FIG. 2 is a perspective view with the cap in a closed position;

FIG. 3 is a front elevational view of FIG. 1;

FIG. 4 is a top plan view shown without the cap for clarity of illustration;

FIG. 5 is a rear elevational view of FIG. 1;

FIG. 6 is a bottom plan view of FIG. 1;

FIG. 7 is a right side elevational view of FIG. 1;

FIG. 8 is a top plan view of FIG. 2;

FIG. 9 is a front elevational view of FIG. 2, the undisclosed opposite side being a mirror image; and,

FIG. 10 is a side elevational view of FIG. 2, the undisclosed opposite side being identical.

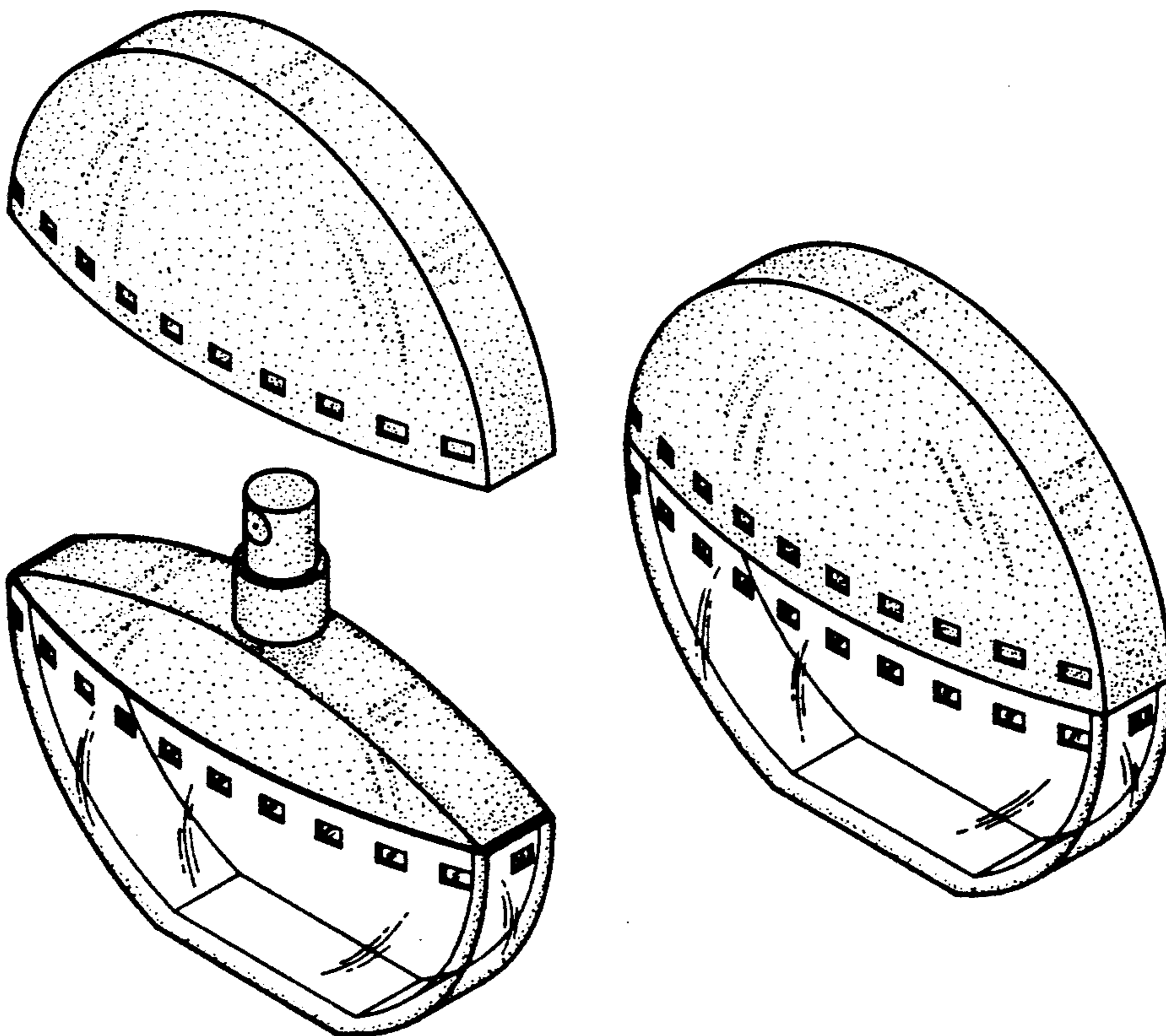

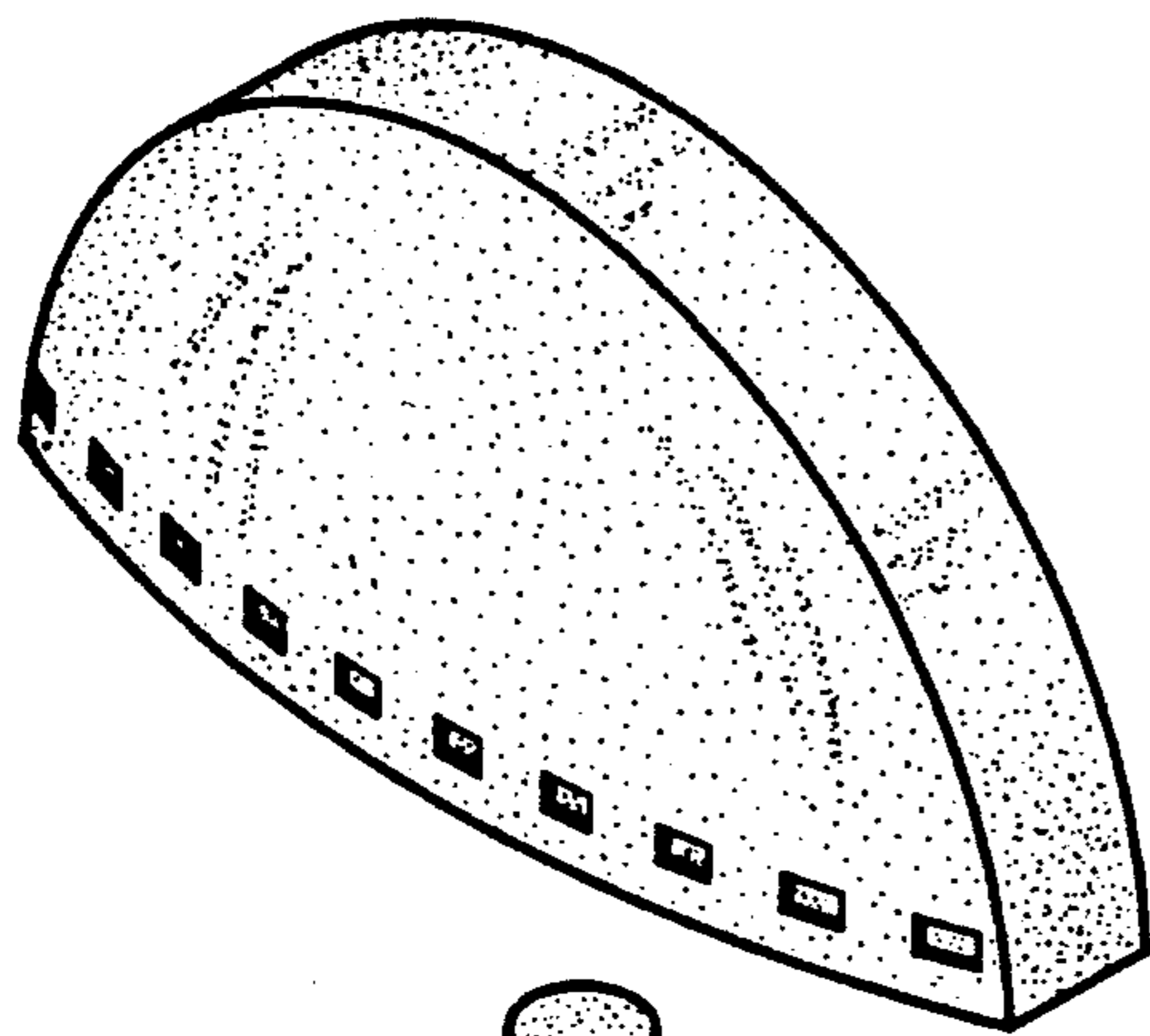

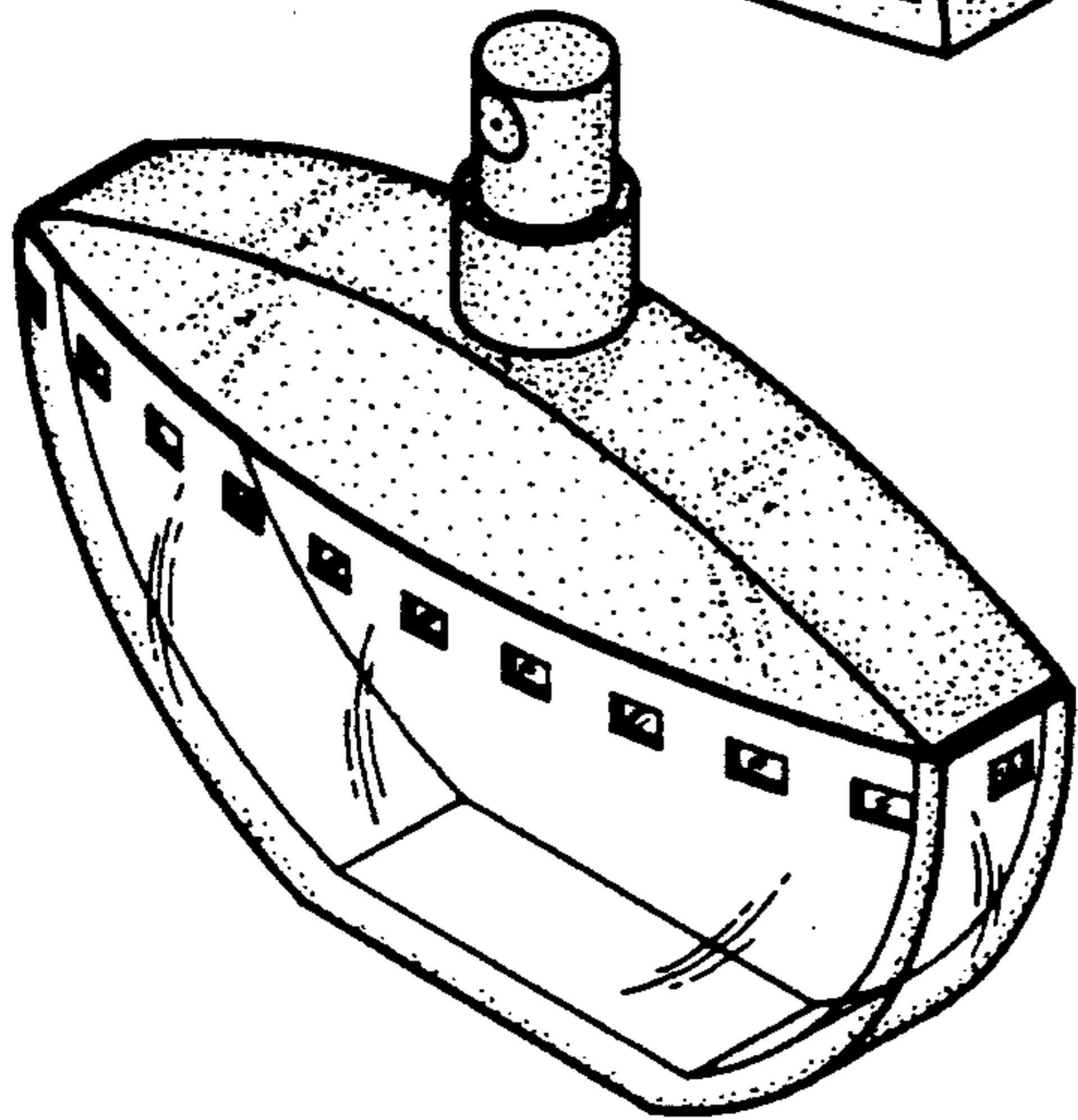

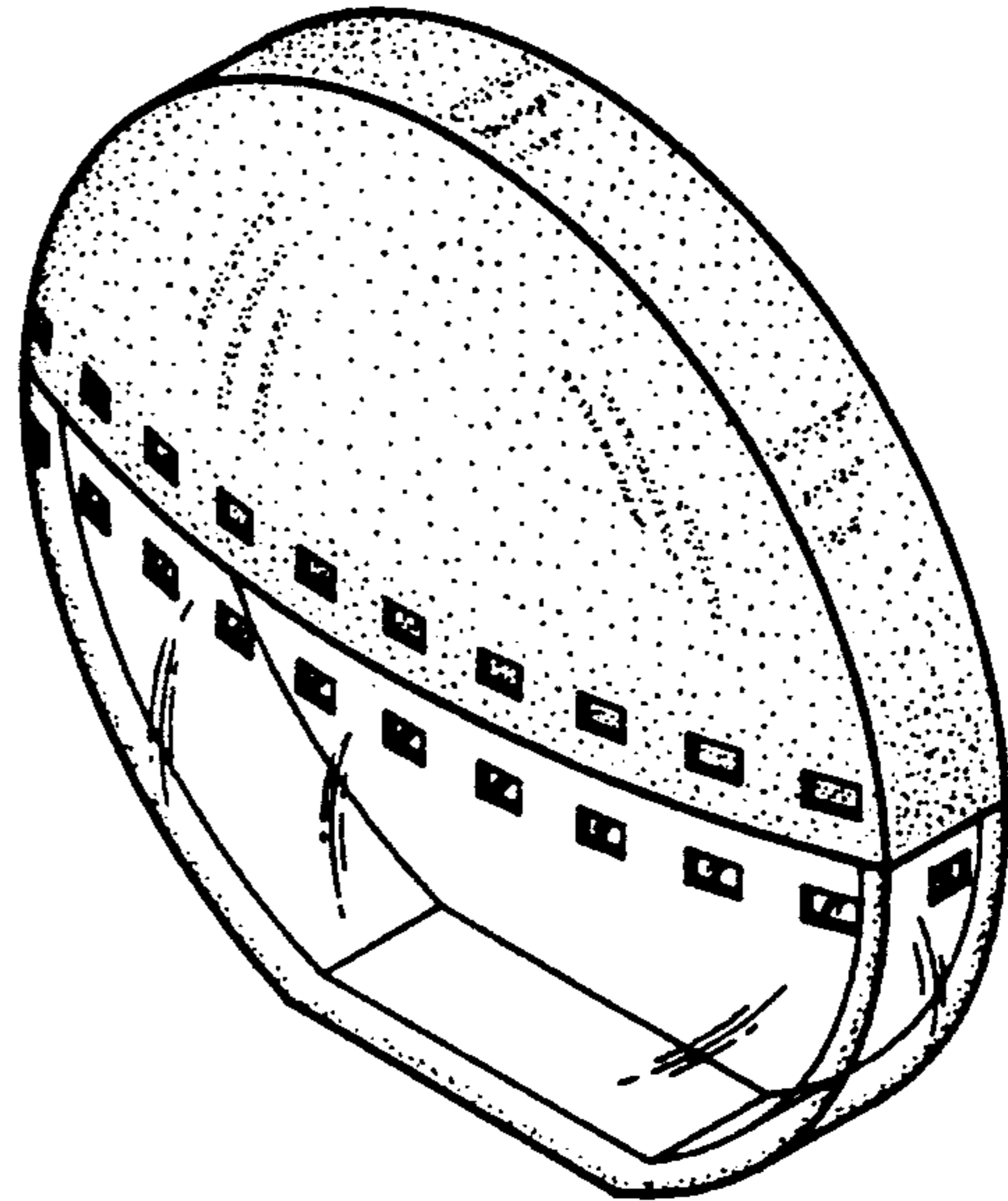

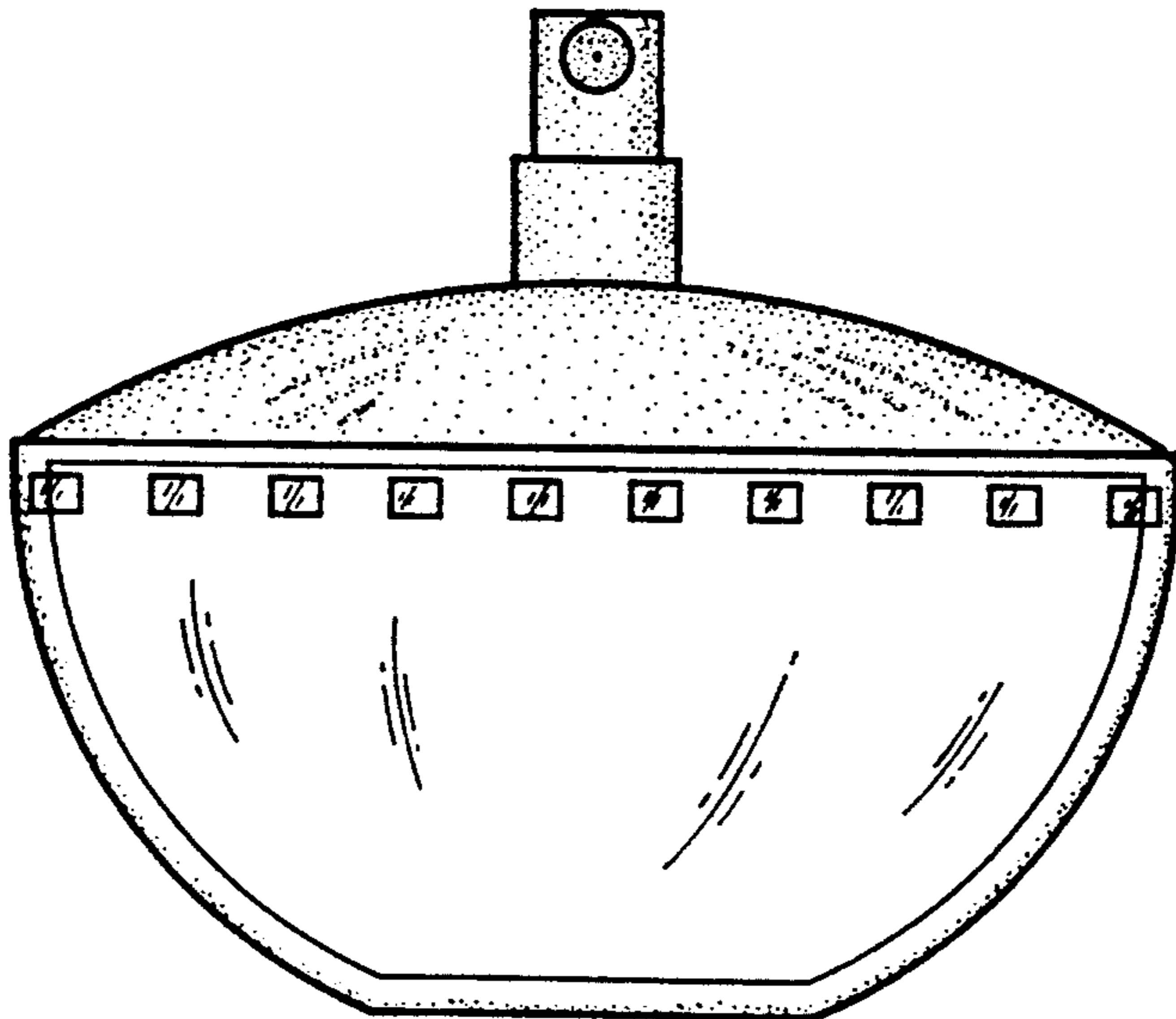
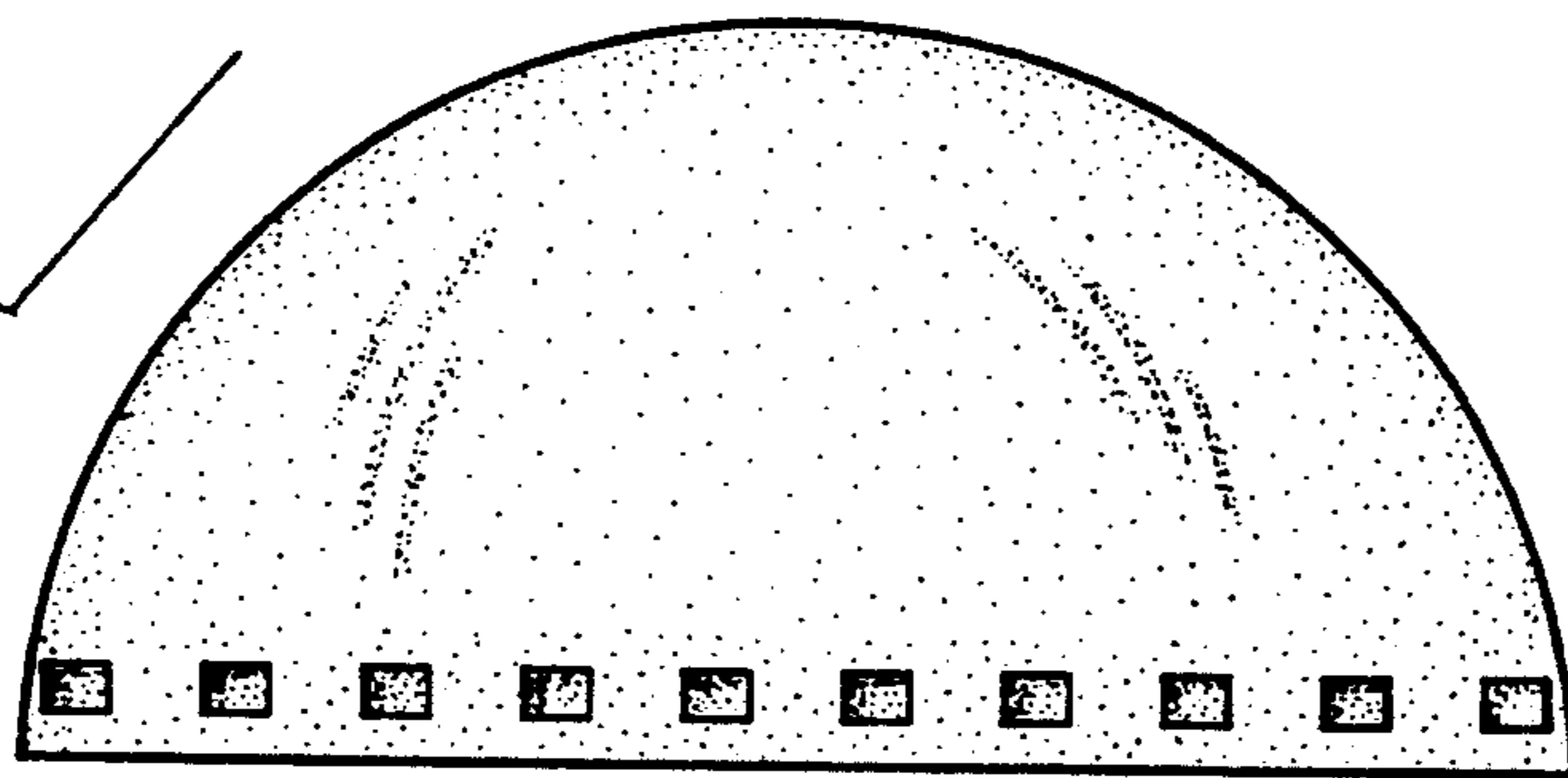

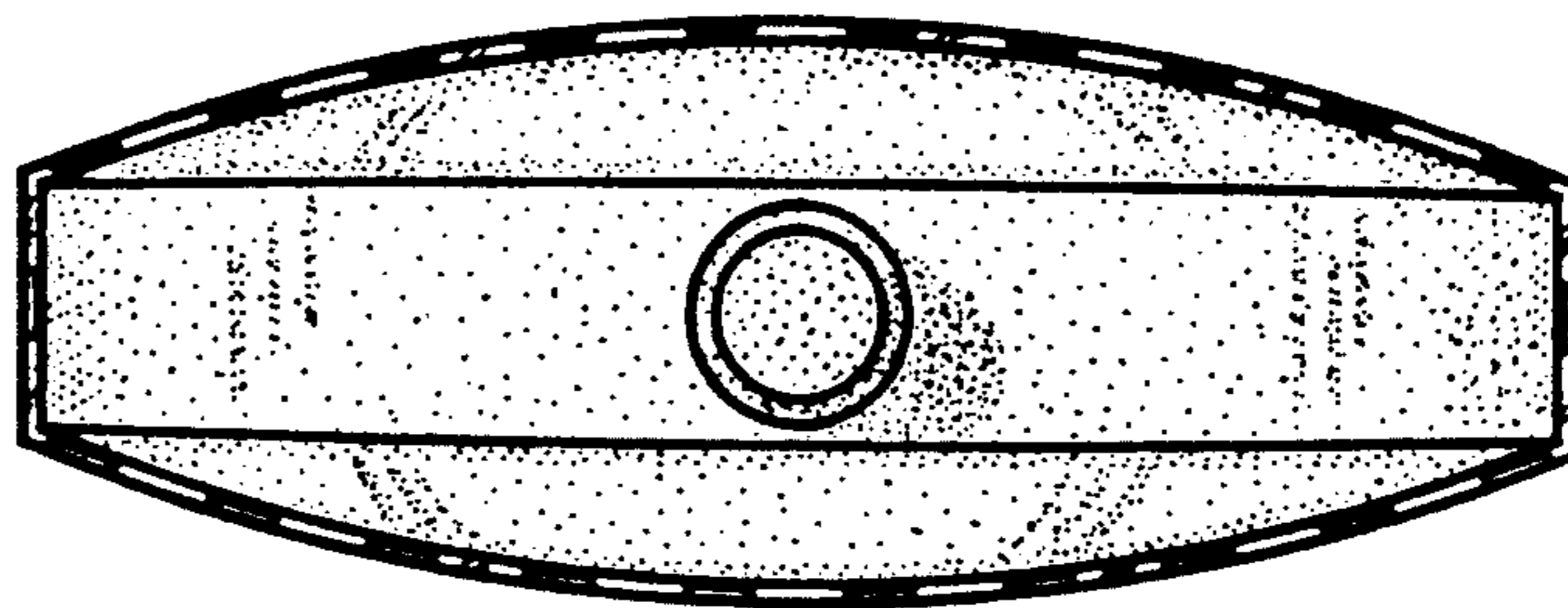

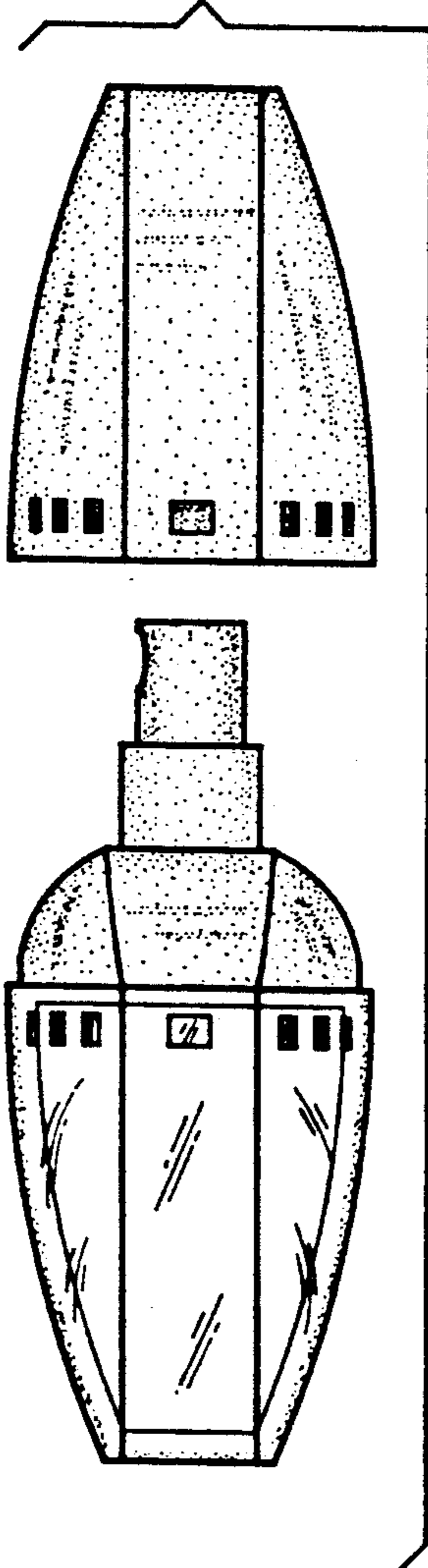

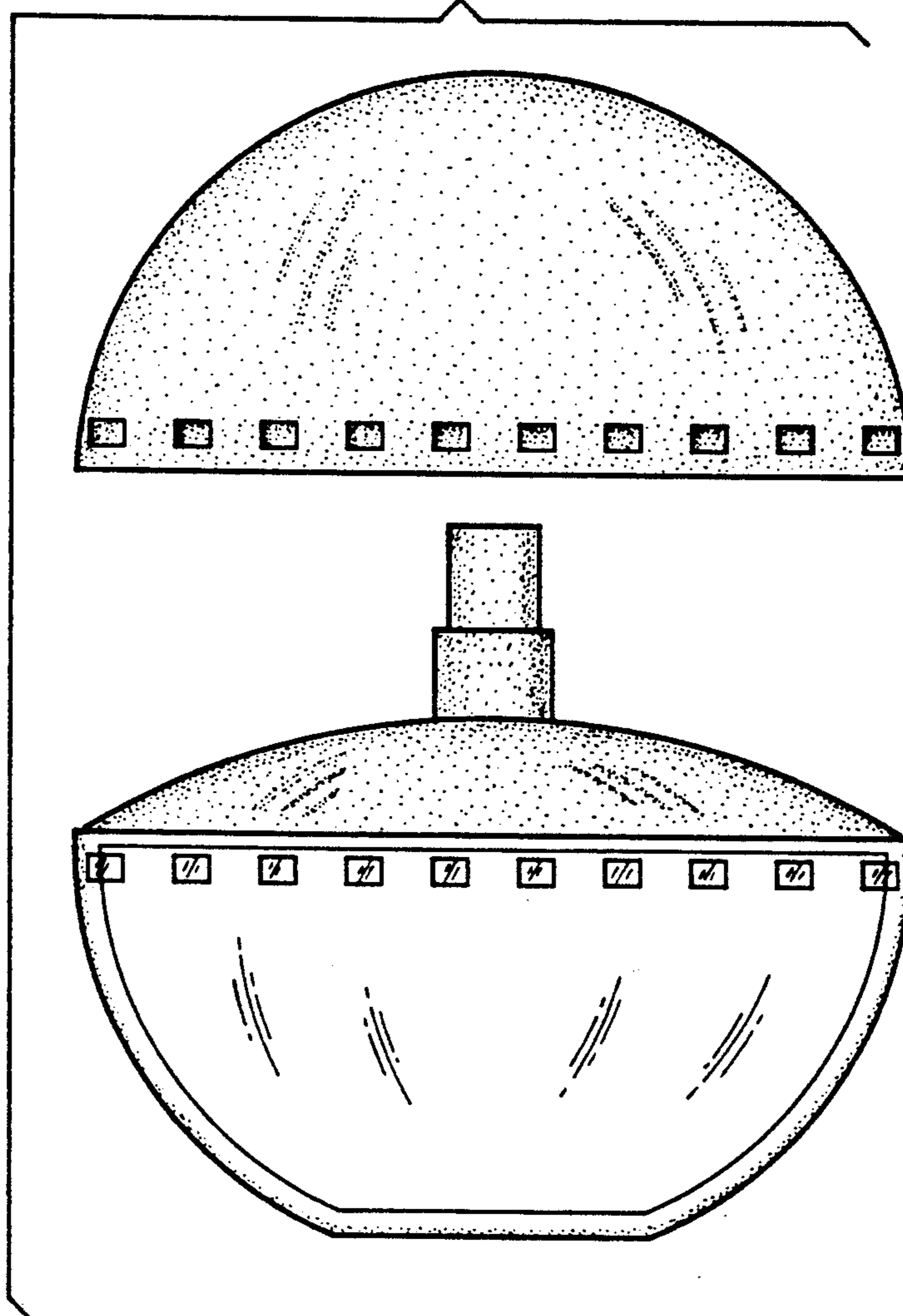

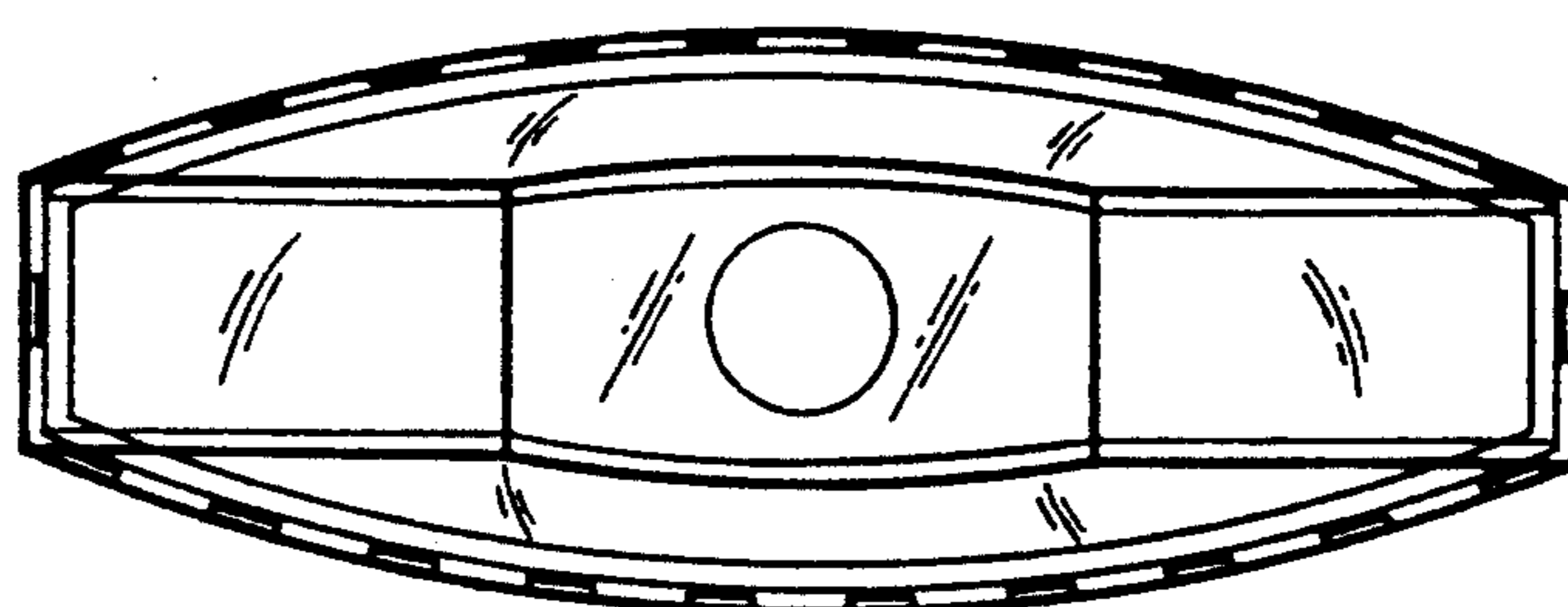

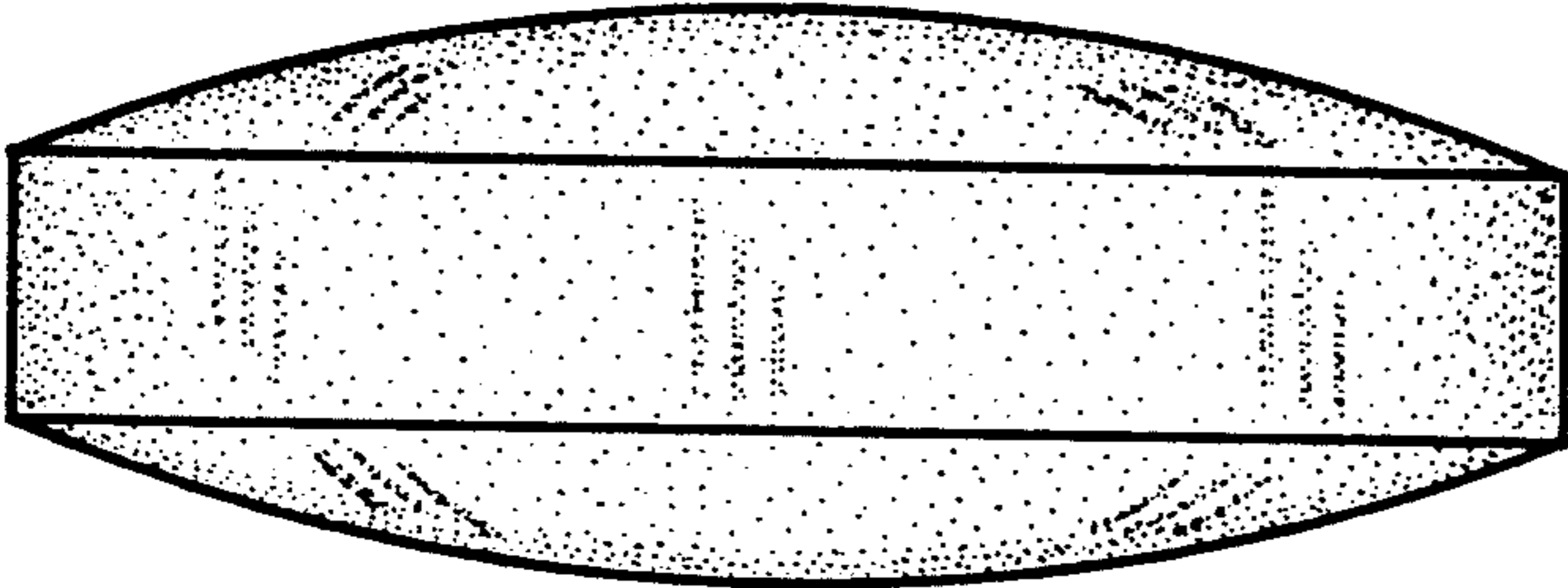

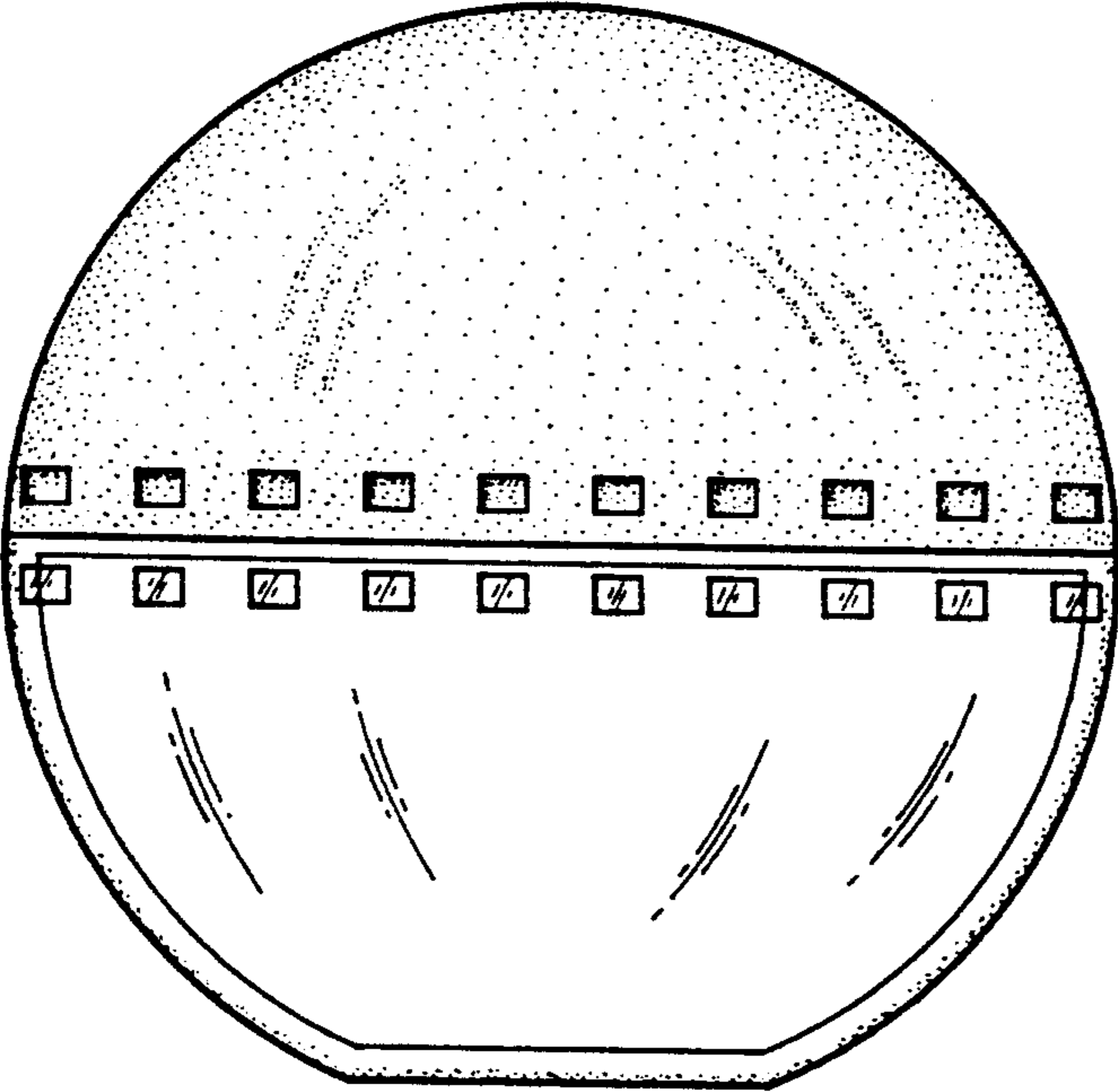
