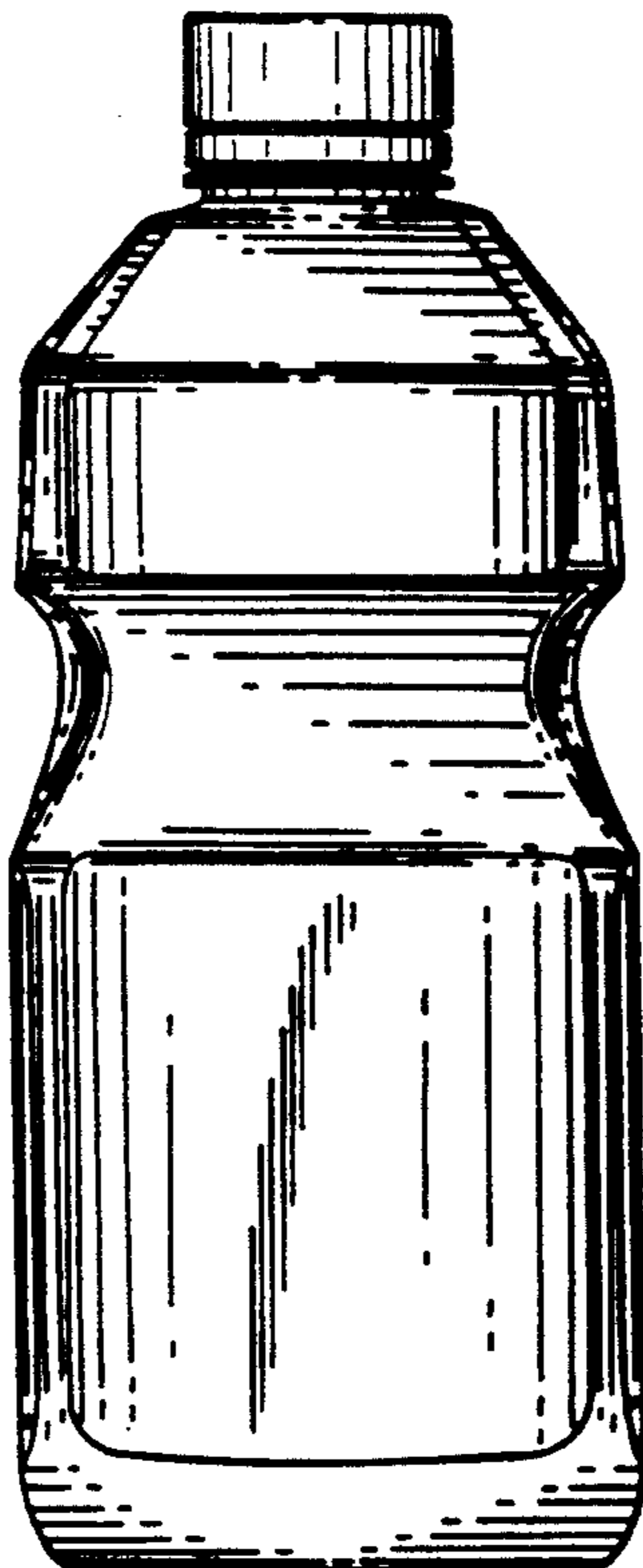

DESCRIPTION

FIG. 1 is a front elevational view of a beverage bottle showing our new design;

FIG. 7 shows an orthogonal view of the bottle of FIG. 1.



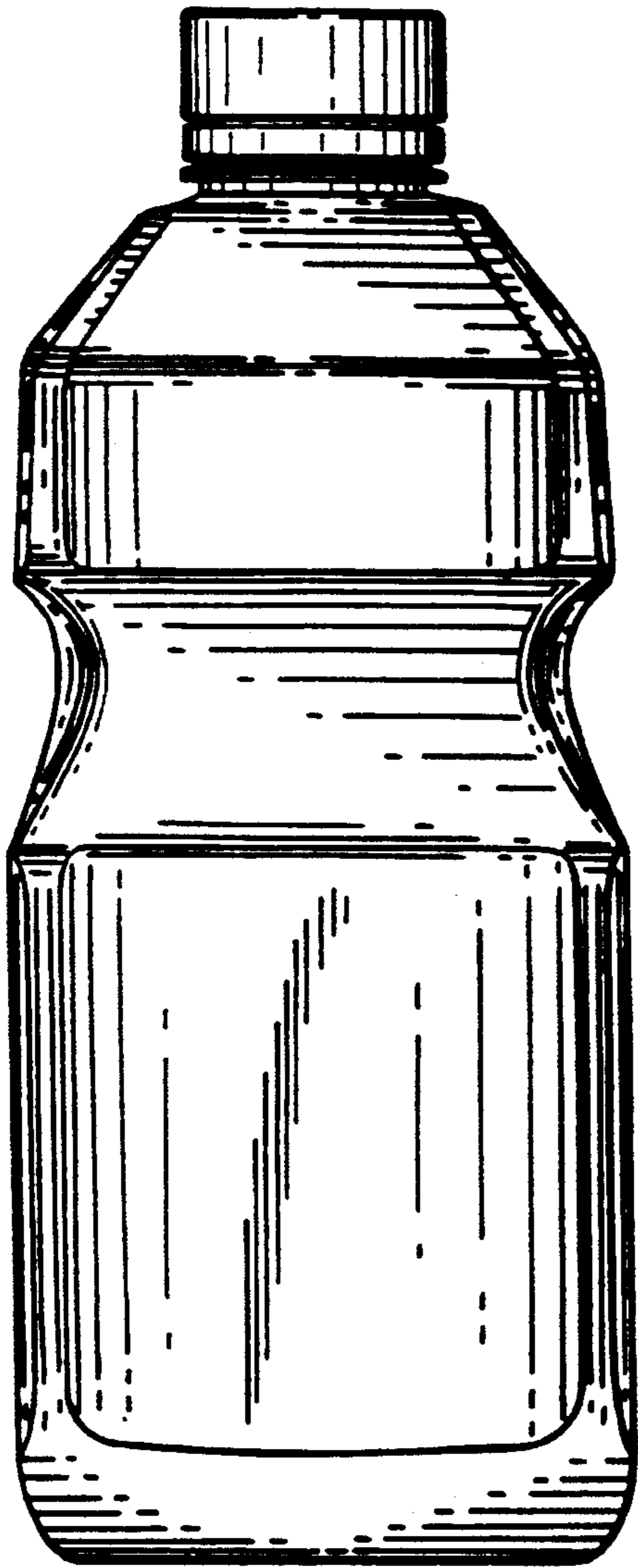

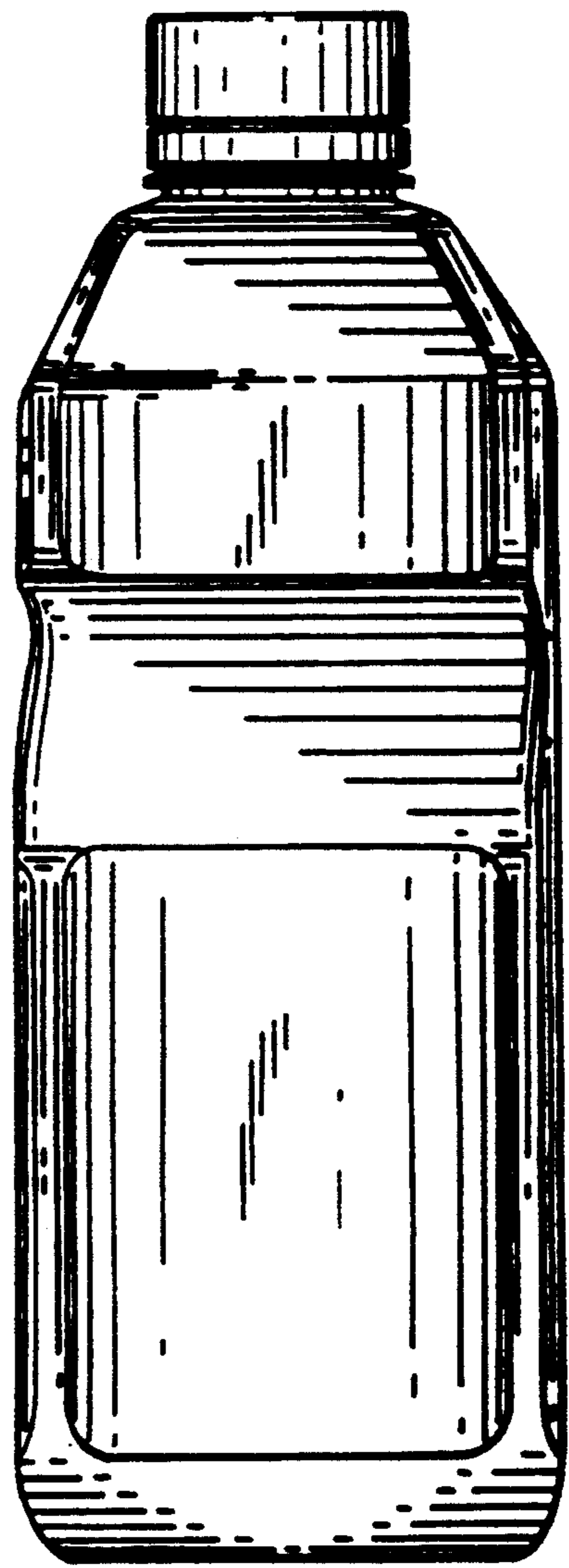

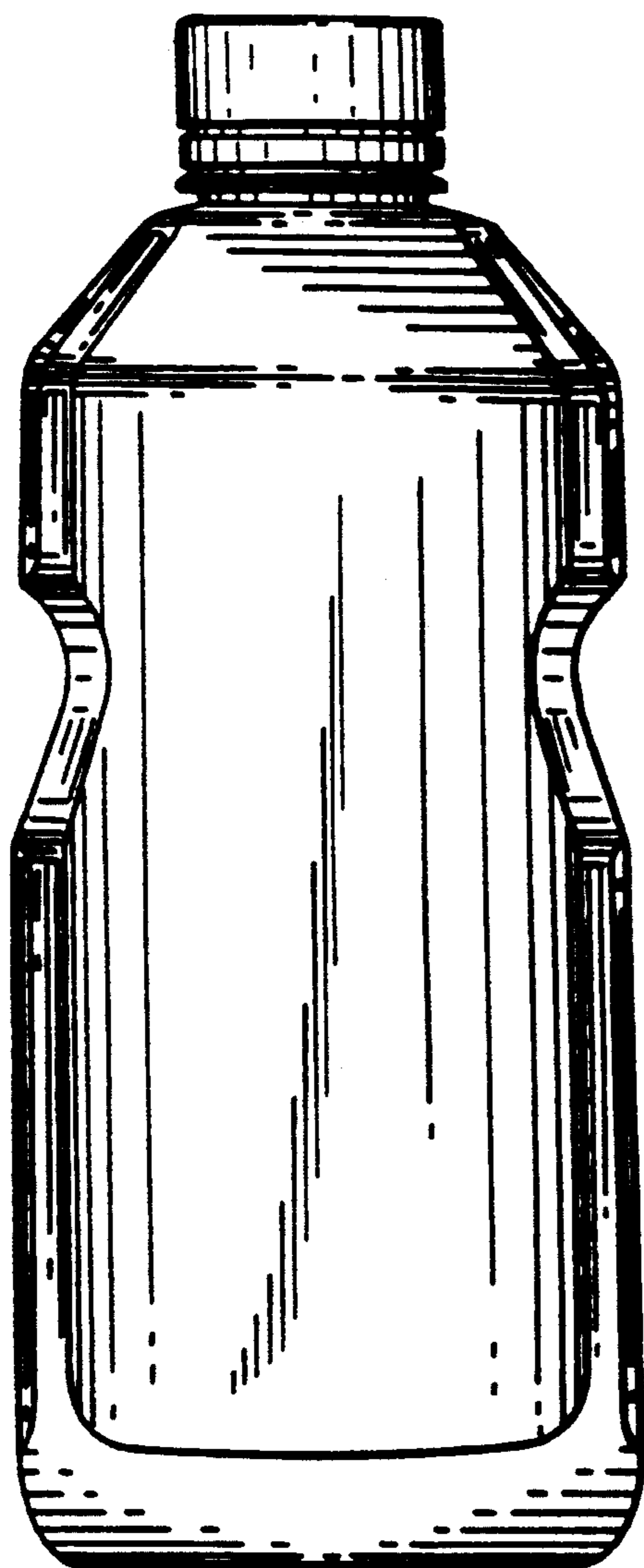

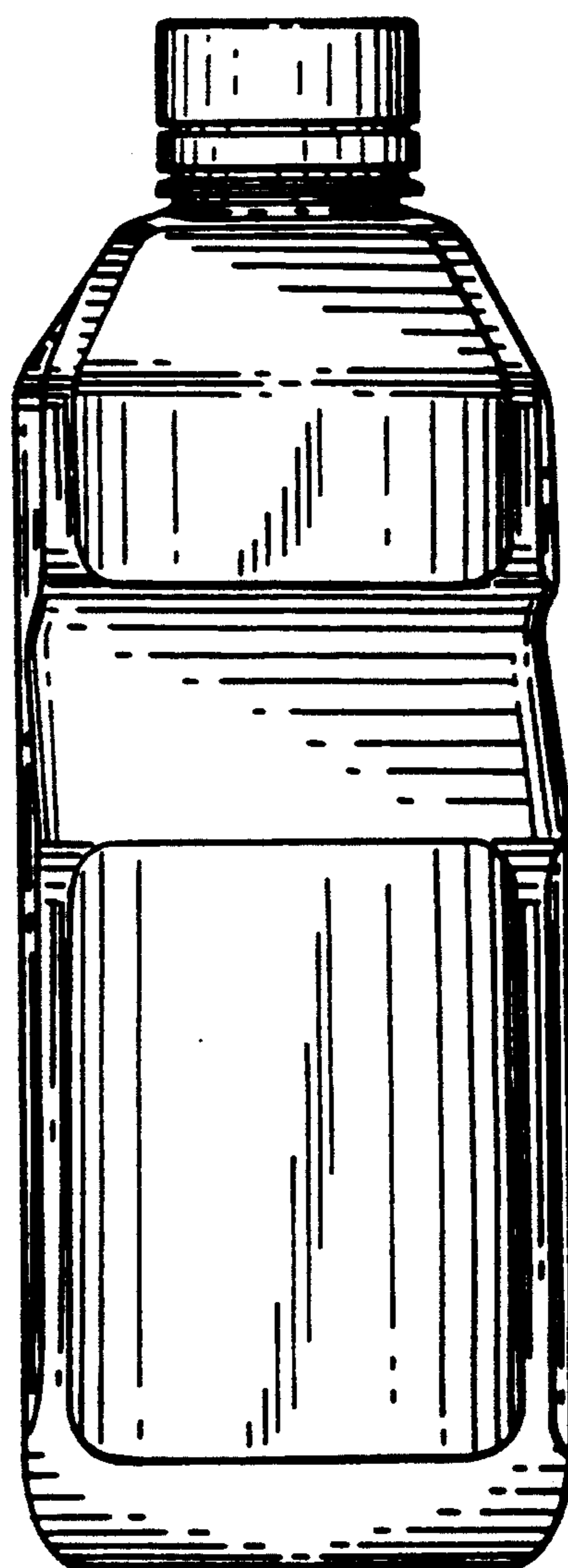

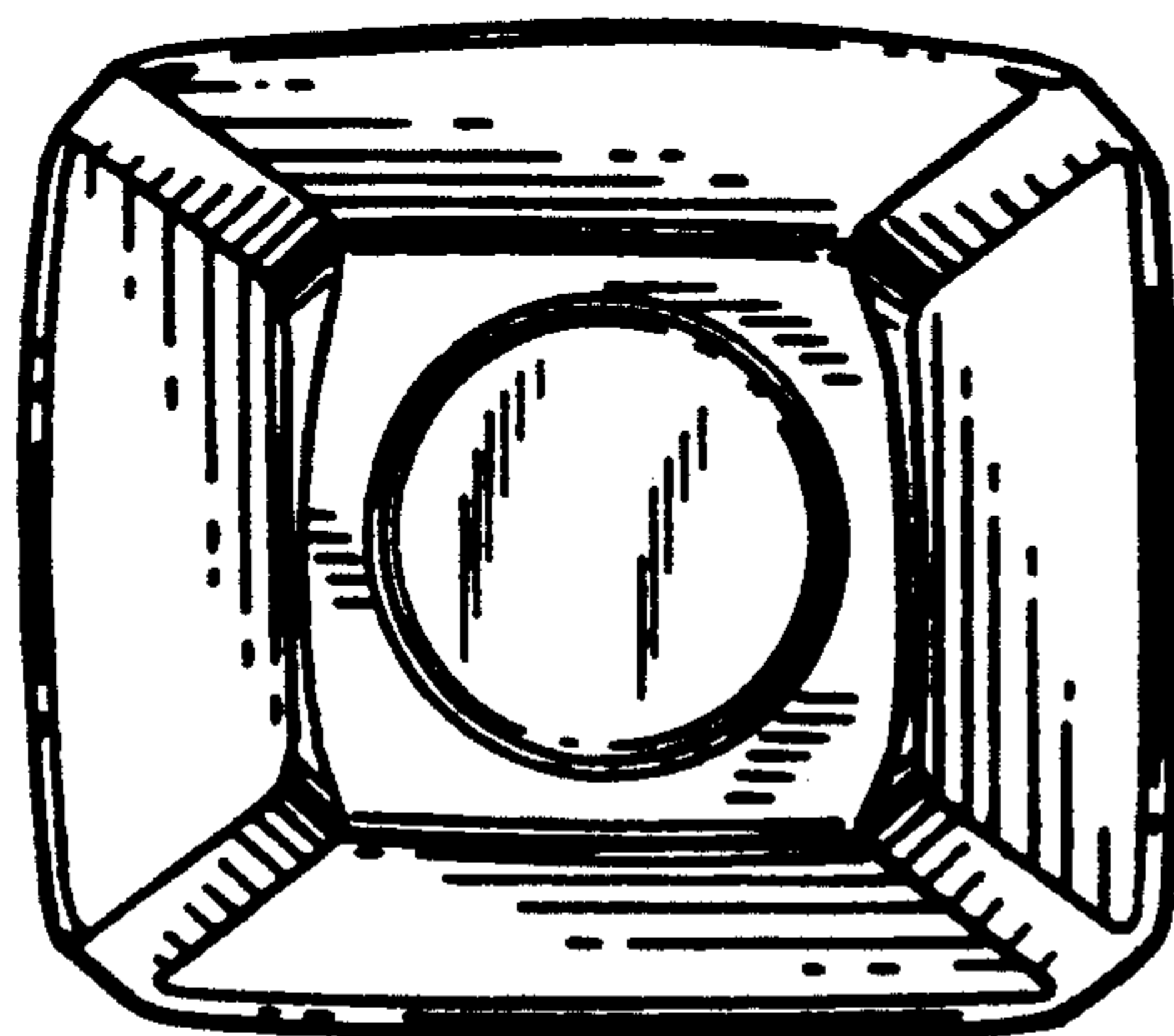

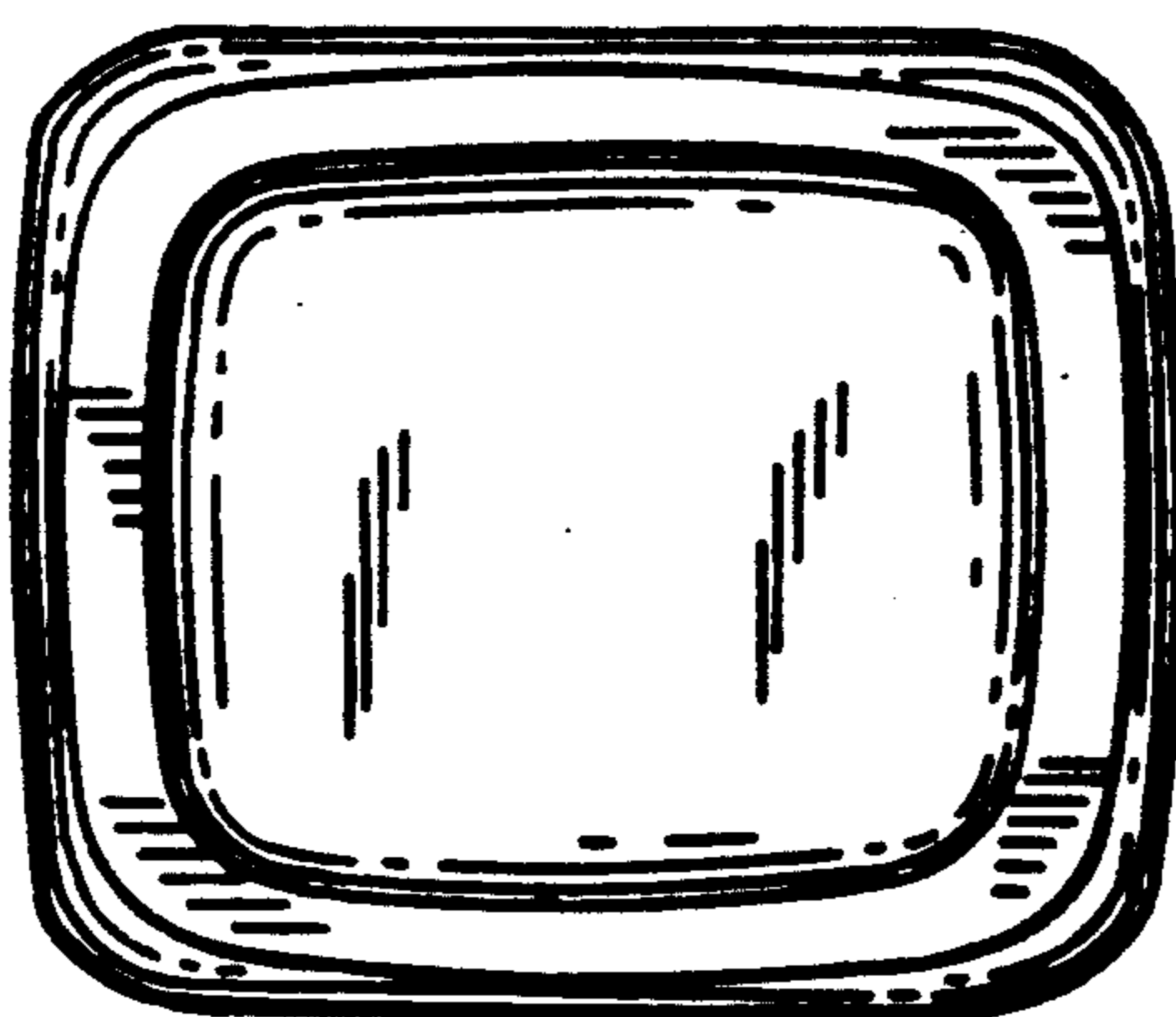

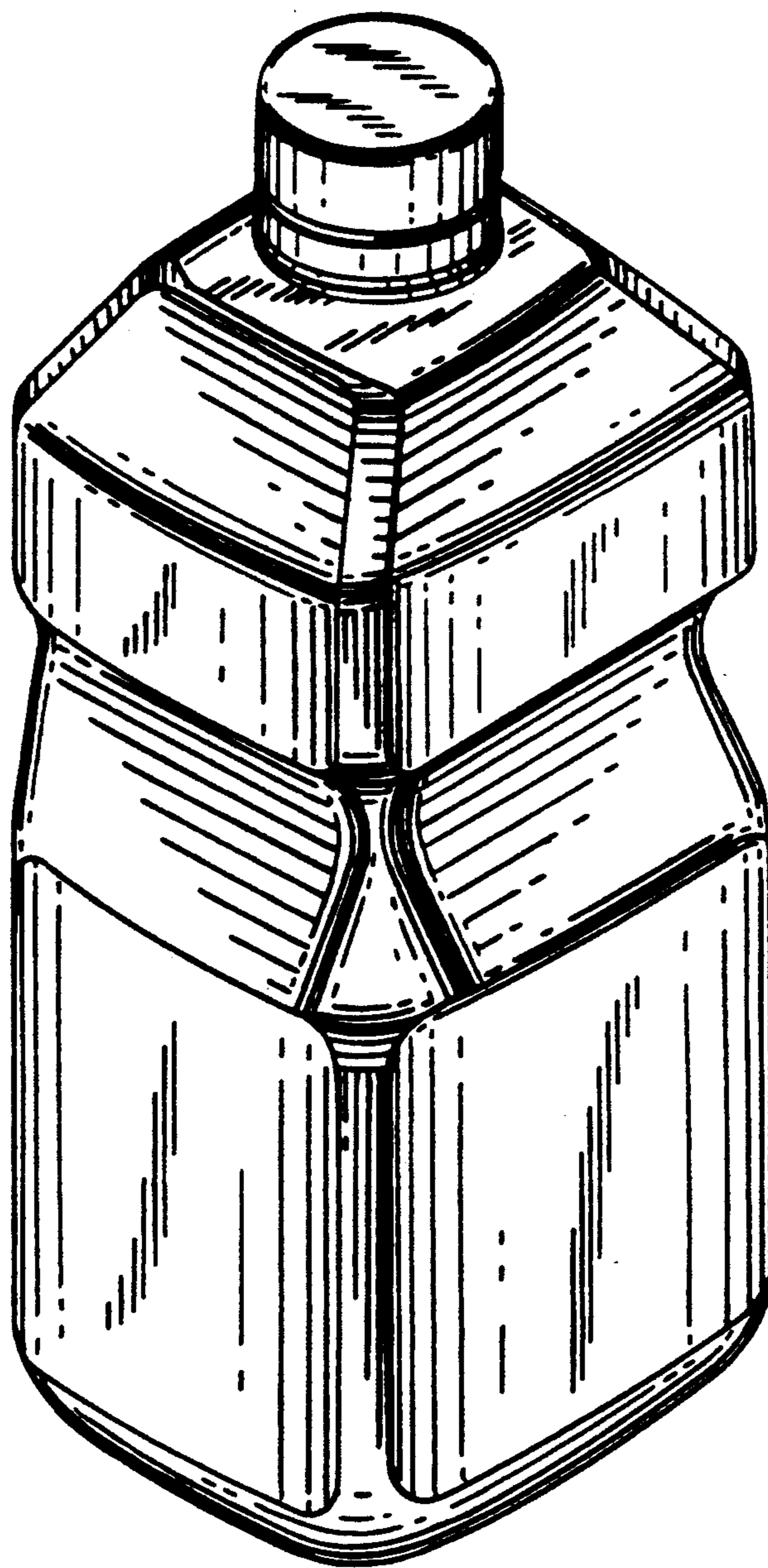
