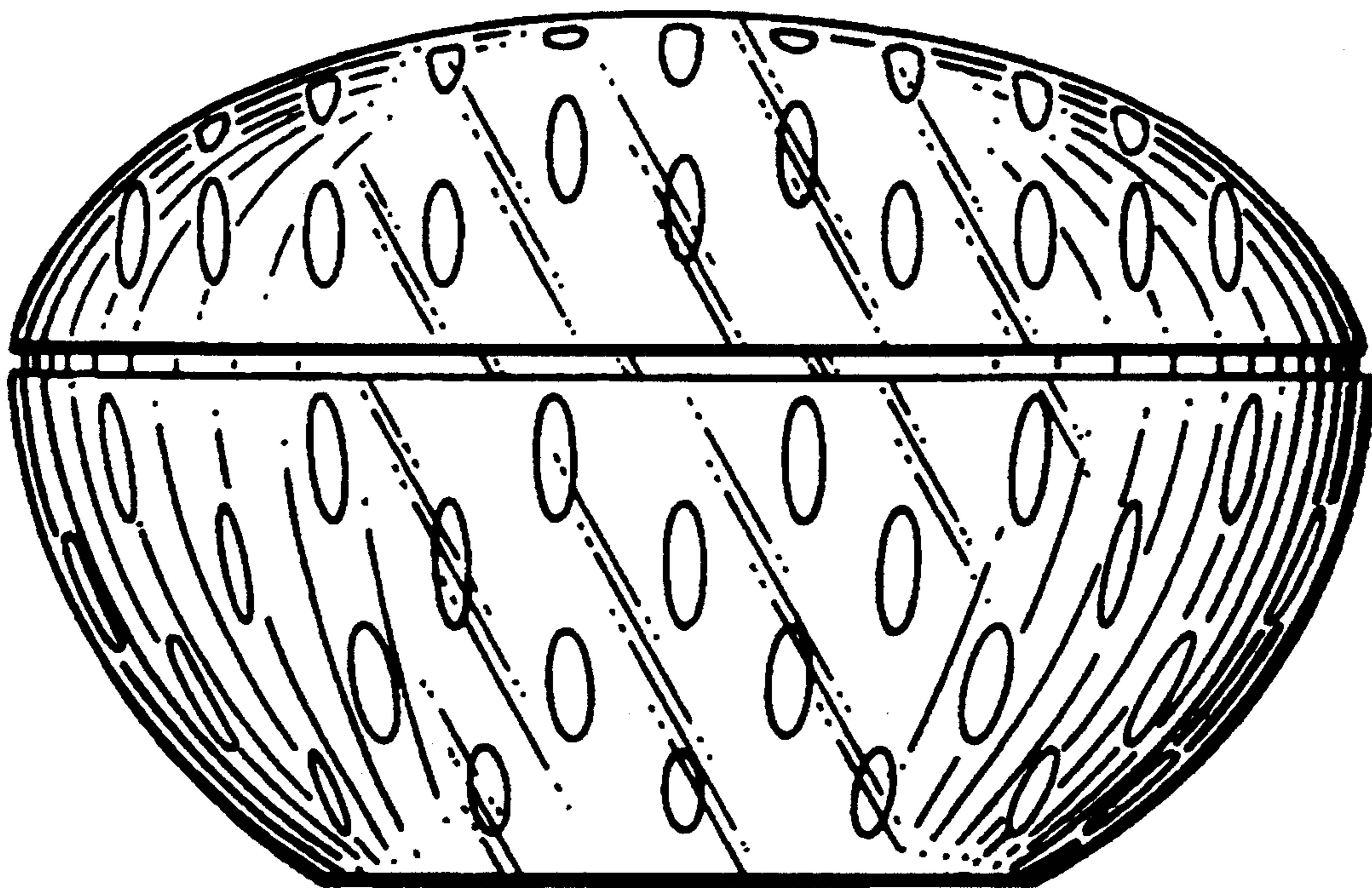

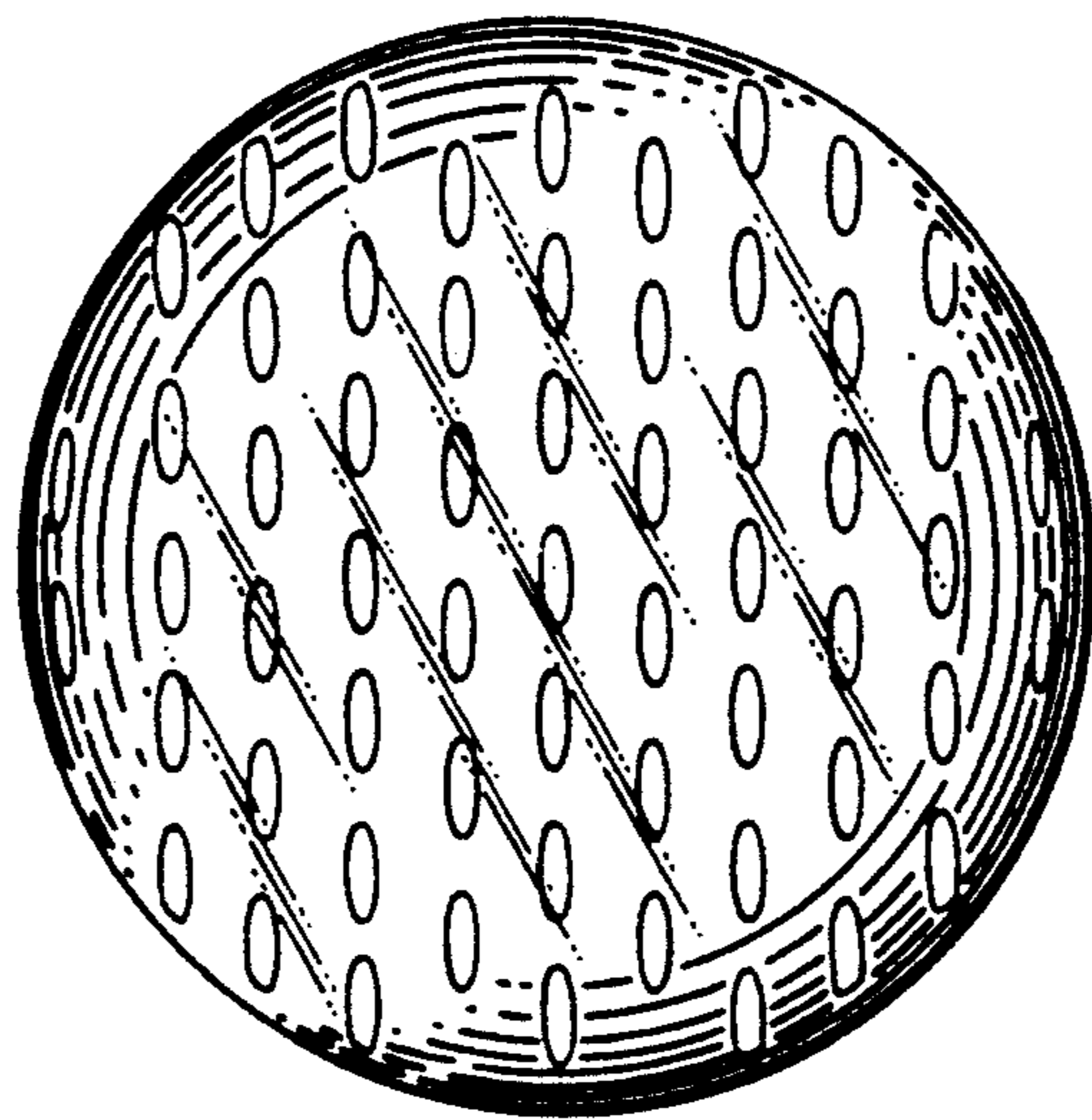
[57] **CLAIM**

The ornamental design for a creme container, as shown and described.

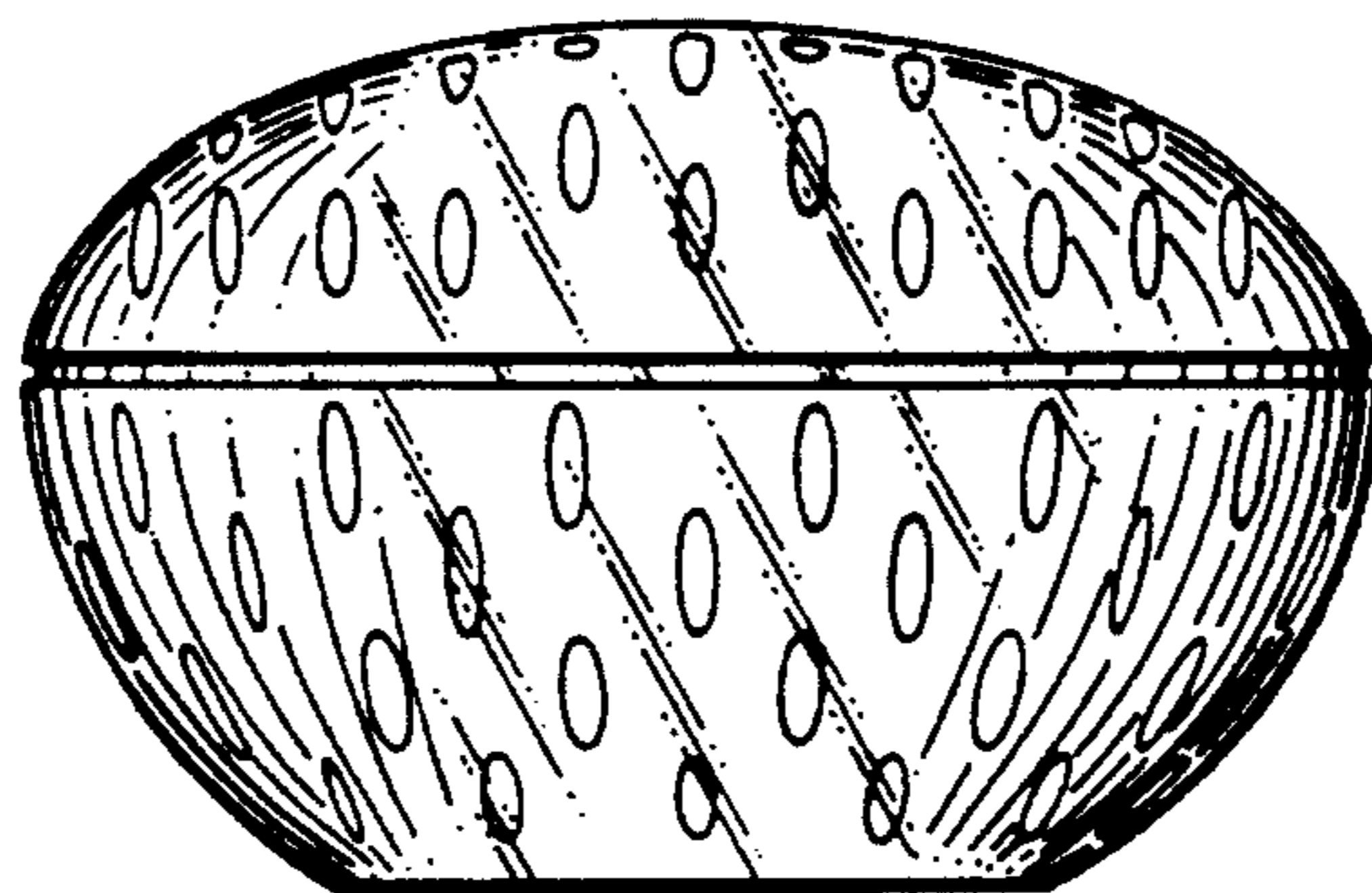
**DESCRIPTION**

FIG. 3 is a bottom plan view.

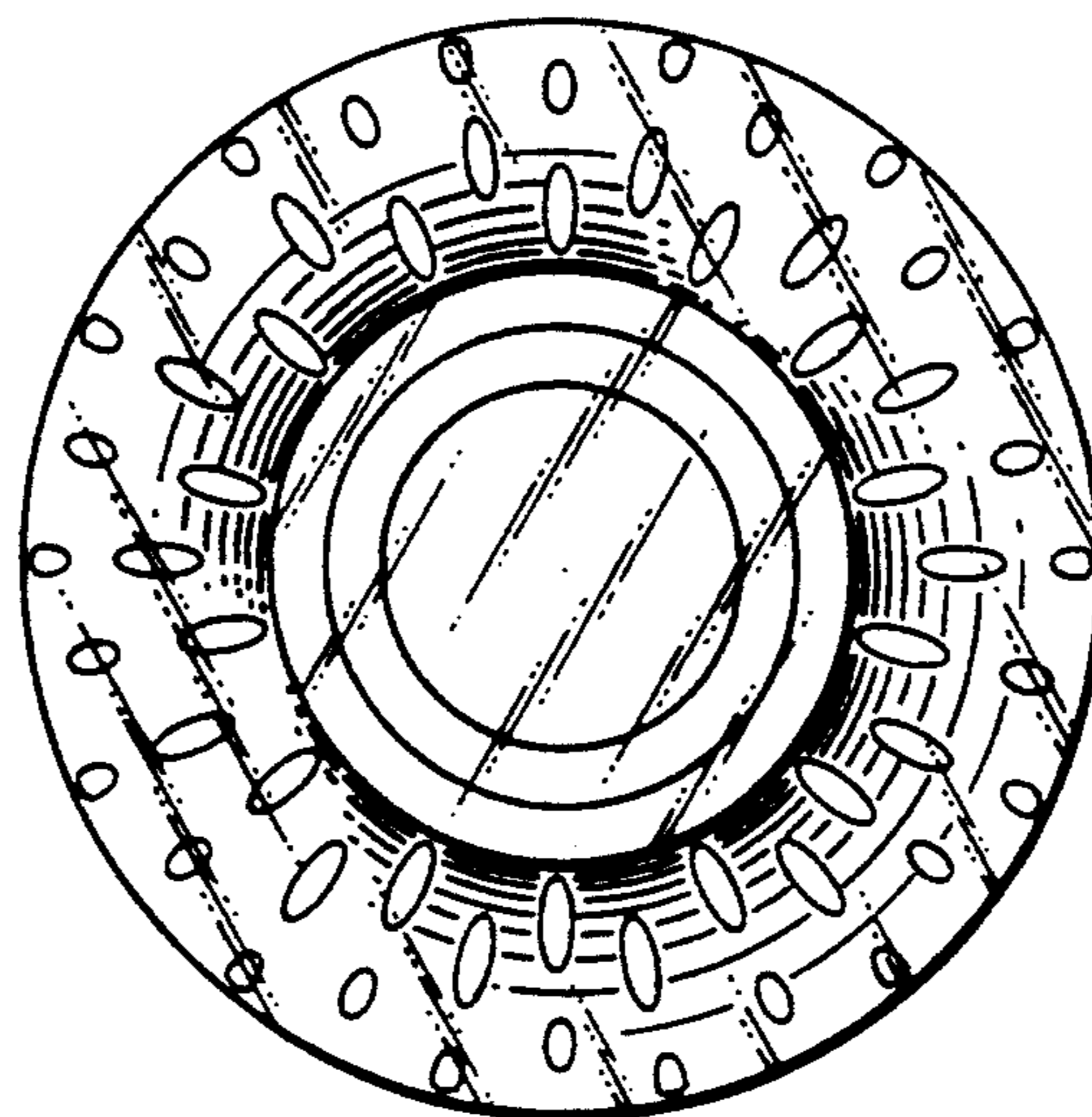
