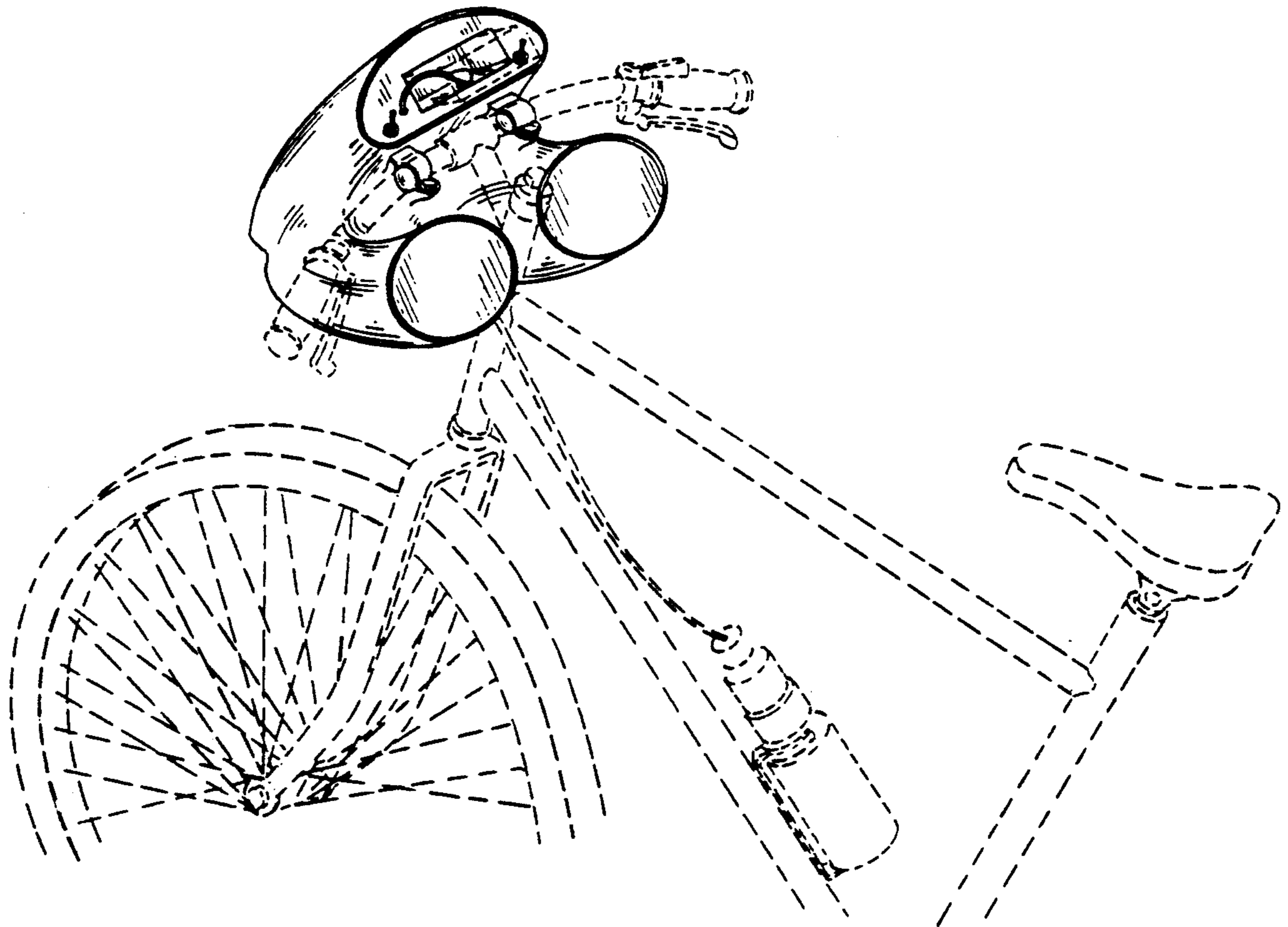

[57] **CLAIM**

The ornamental design for an audio housing attachment for a bicycle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an audio housing attachment showing our new design, mounted on a bicycle; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is an elevational view taken from the right side of FIG. 3, the left side elevational view being a mirror image thereof; FIG. 5 is a rear elevational view thereof; and, FIG. 6 is a bottom plan view thereof.



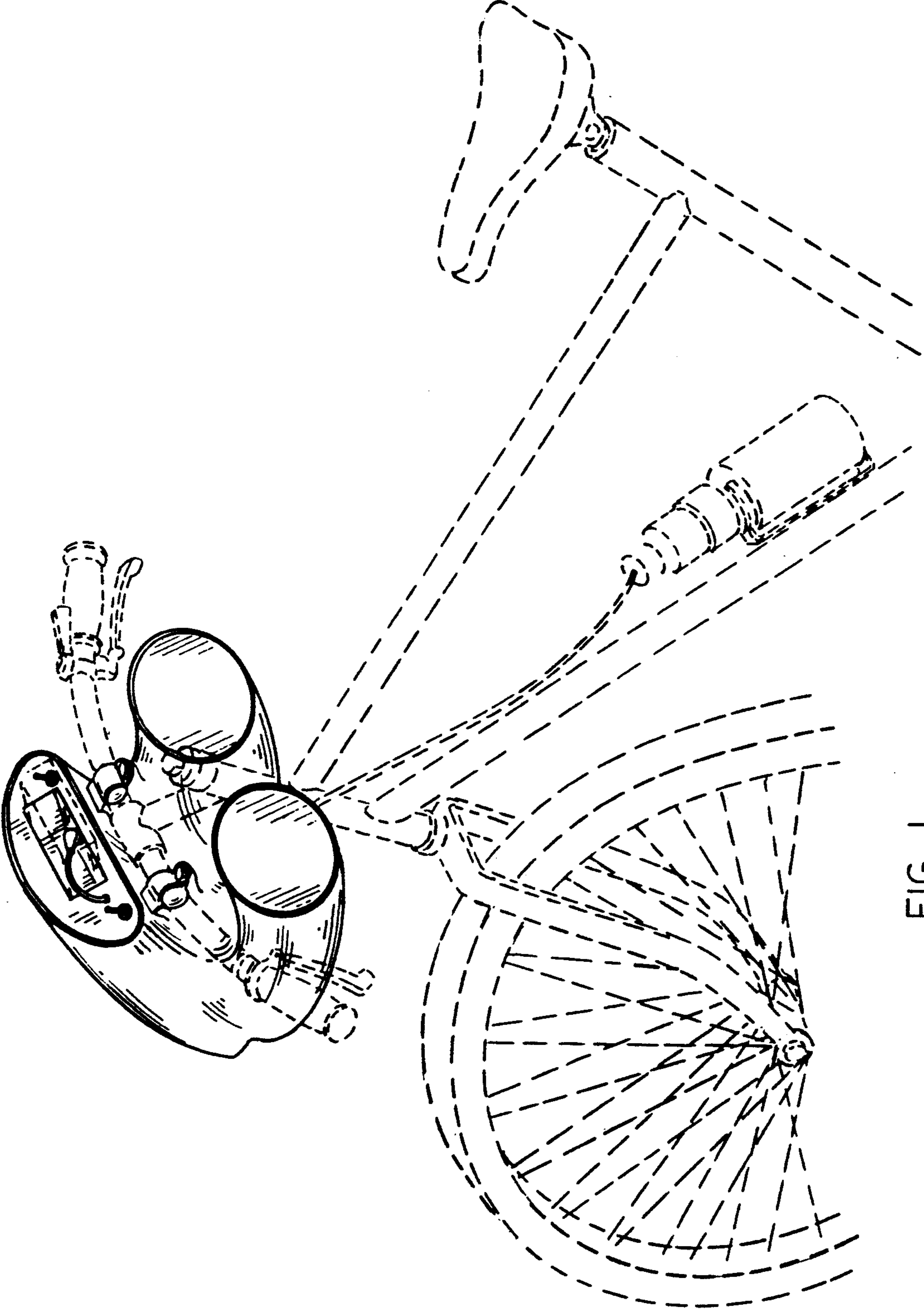

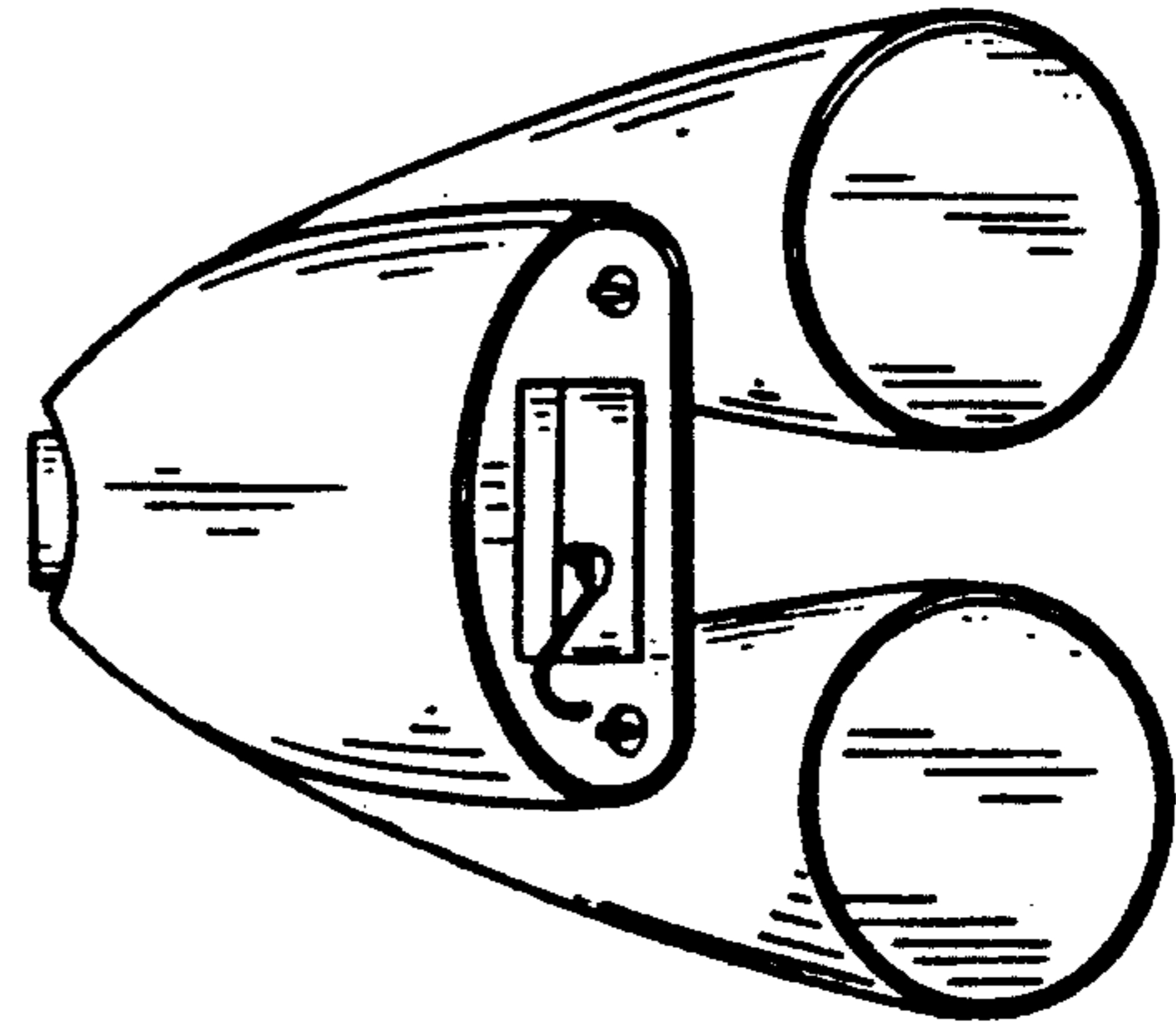

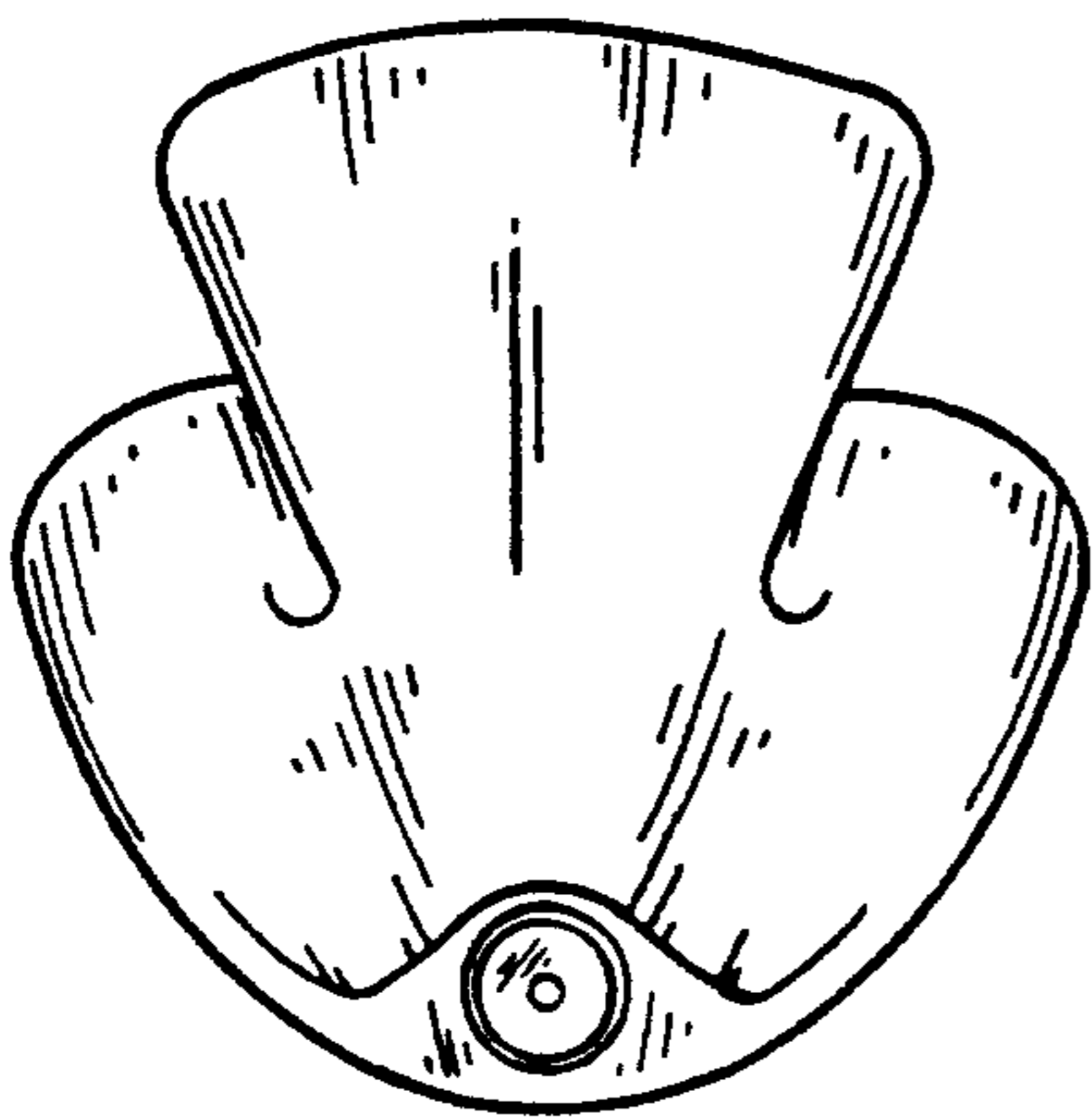

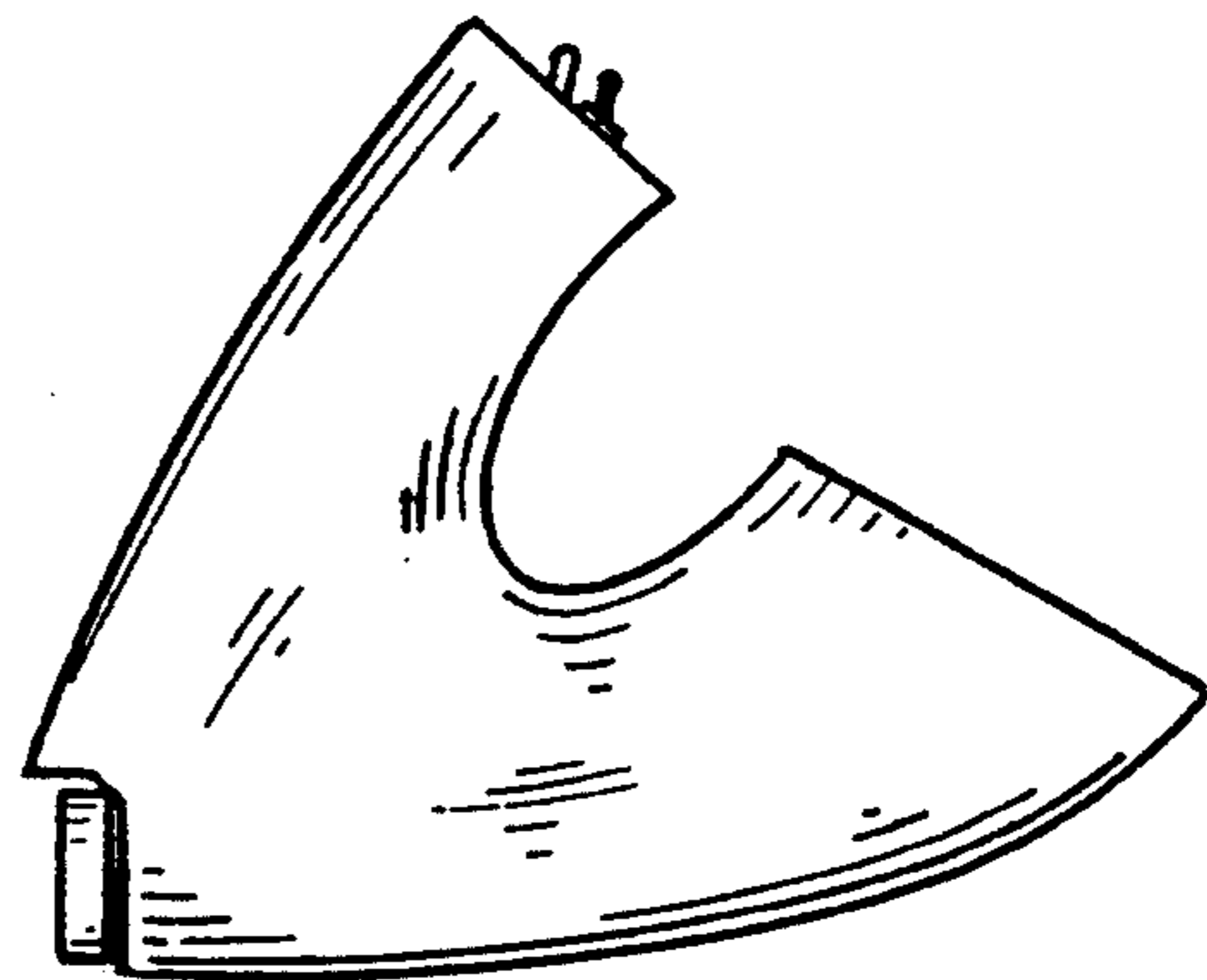

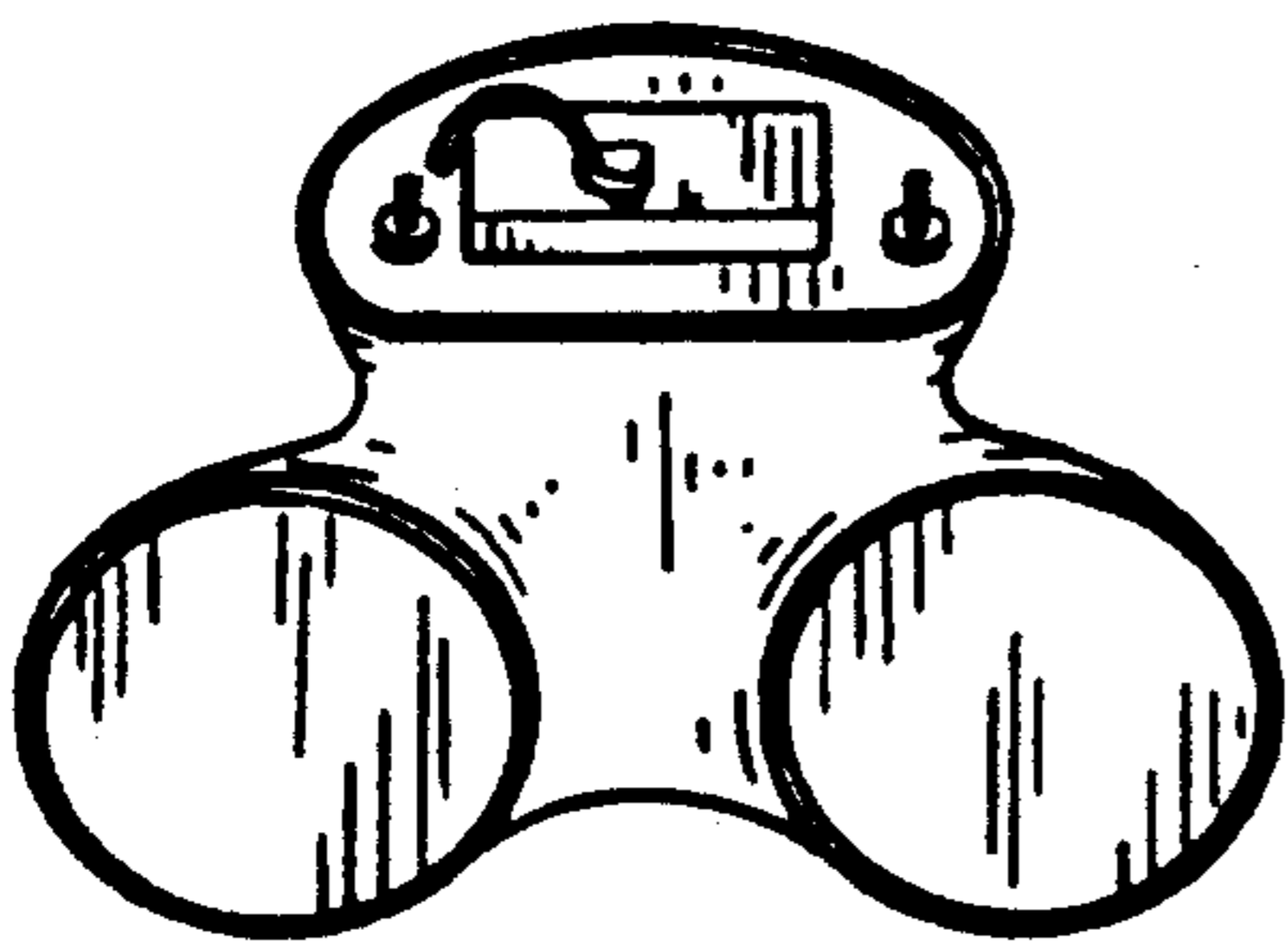

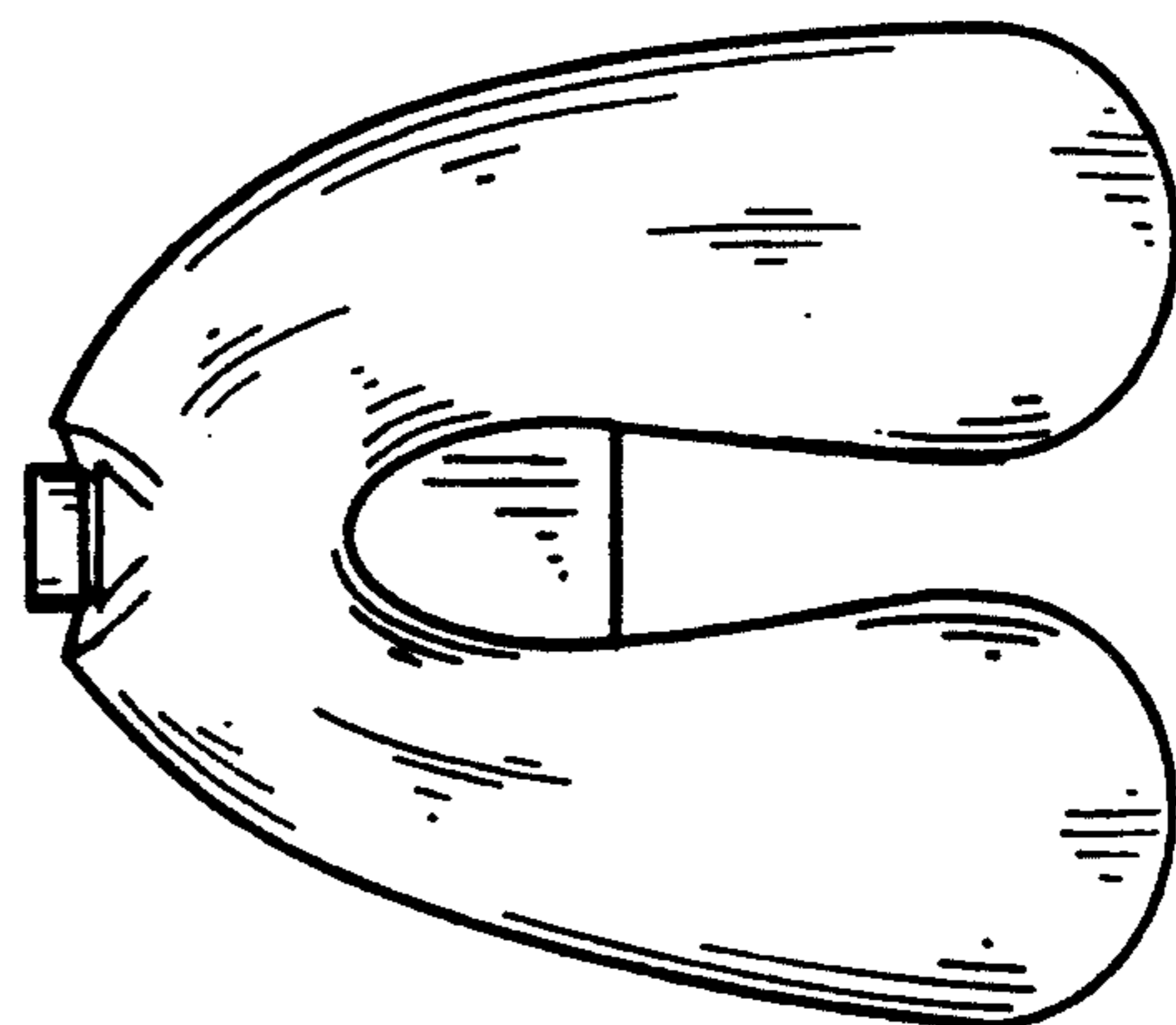
