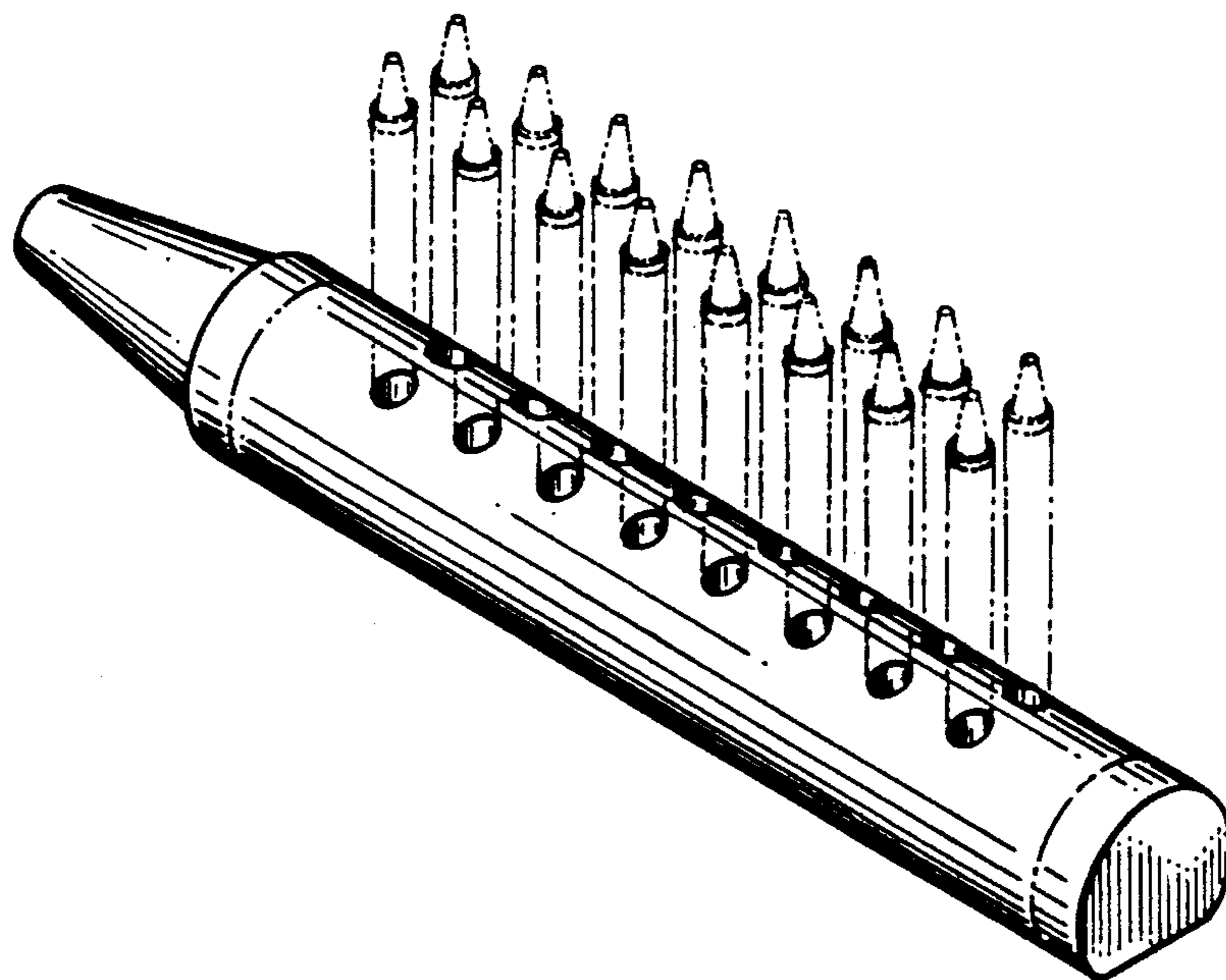
[57] **CLAIM**

The ornamental design for a crayon holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a crayon holder showing my new design;  
FIG. 2 is a side elevation view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom view thereof;  
FIG. 5 is a front view thereof; and,  
FIG. 6 is an end view thereof.

The broken lines showing the crayons, as placed in my crayon holder, are for illustrative purposes only and form no part of the design claimed.



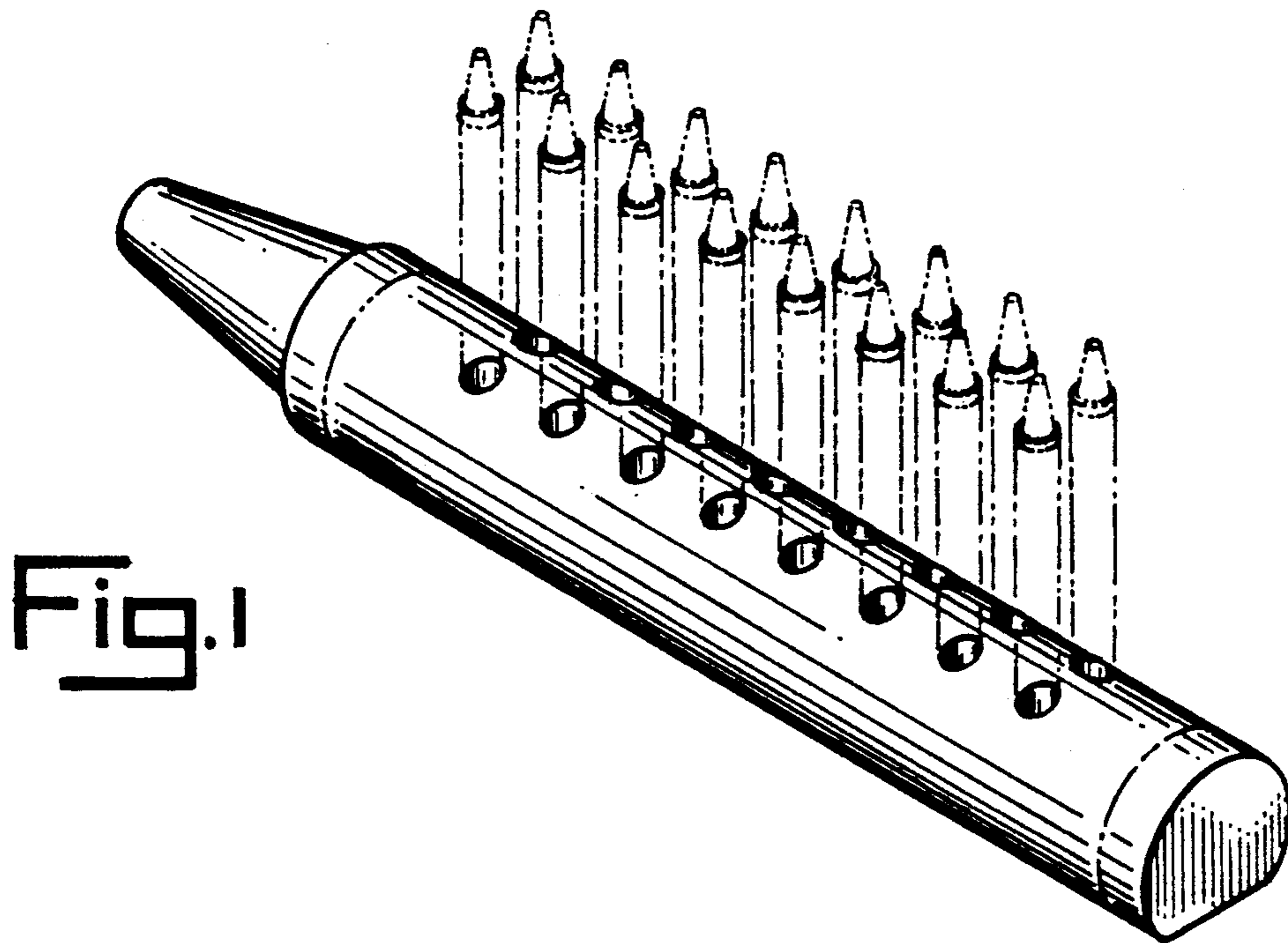

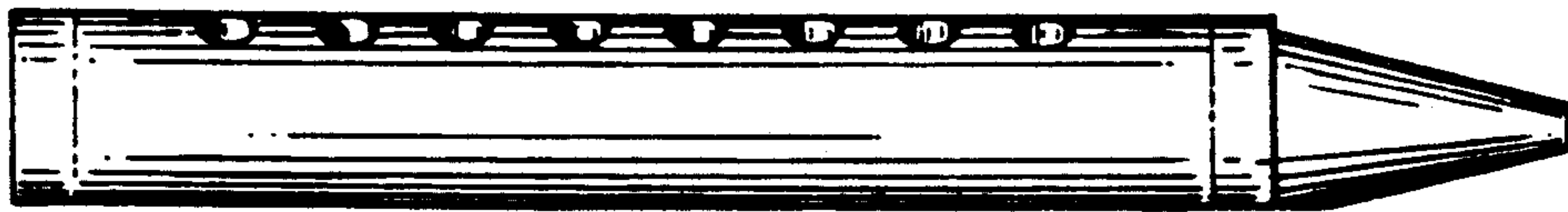

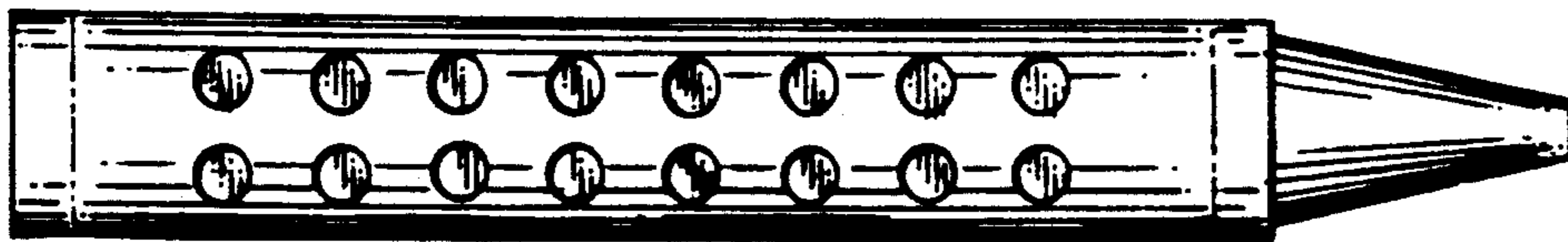

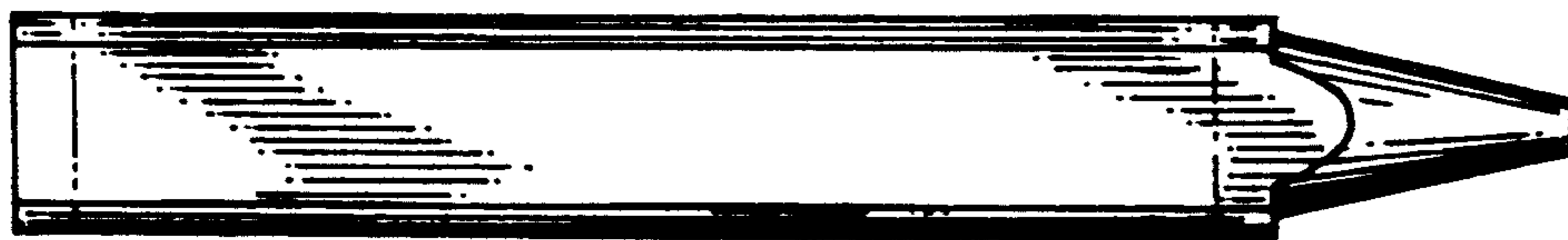
