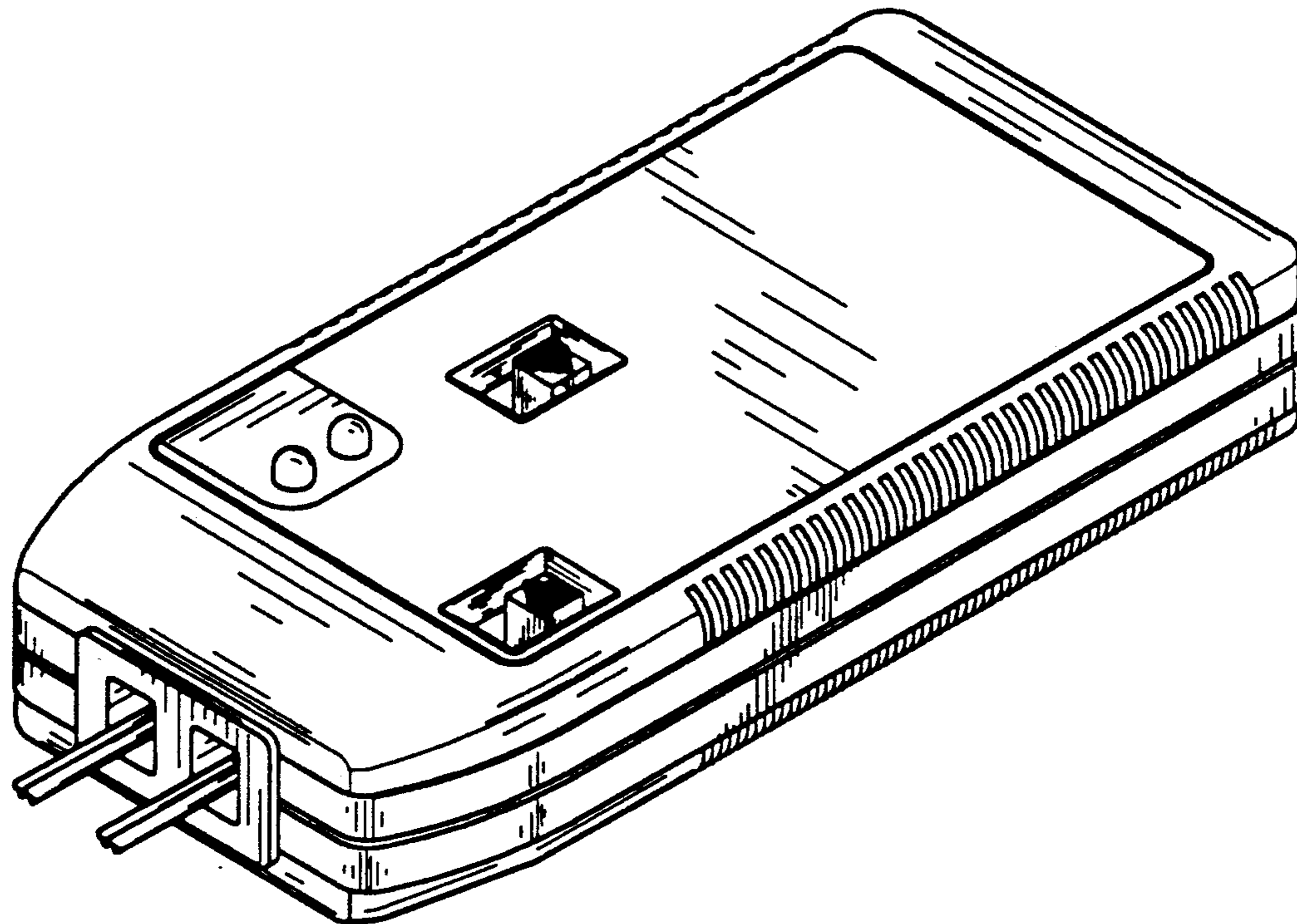

[57] **CLAIM**

The ornamental design for a tester for engine sensors and ignition modules, as shown.

DESCRIPTION

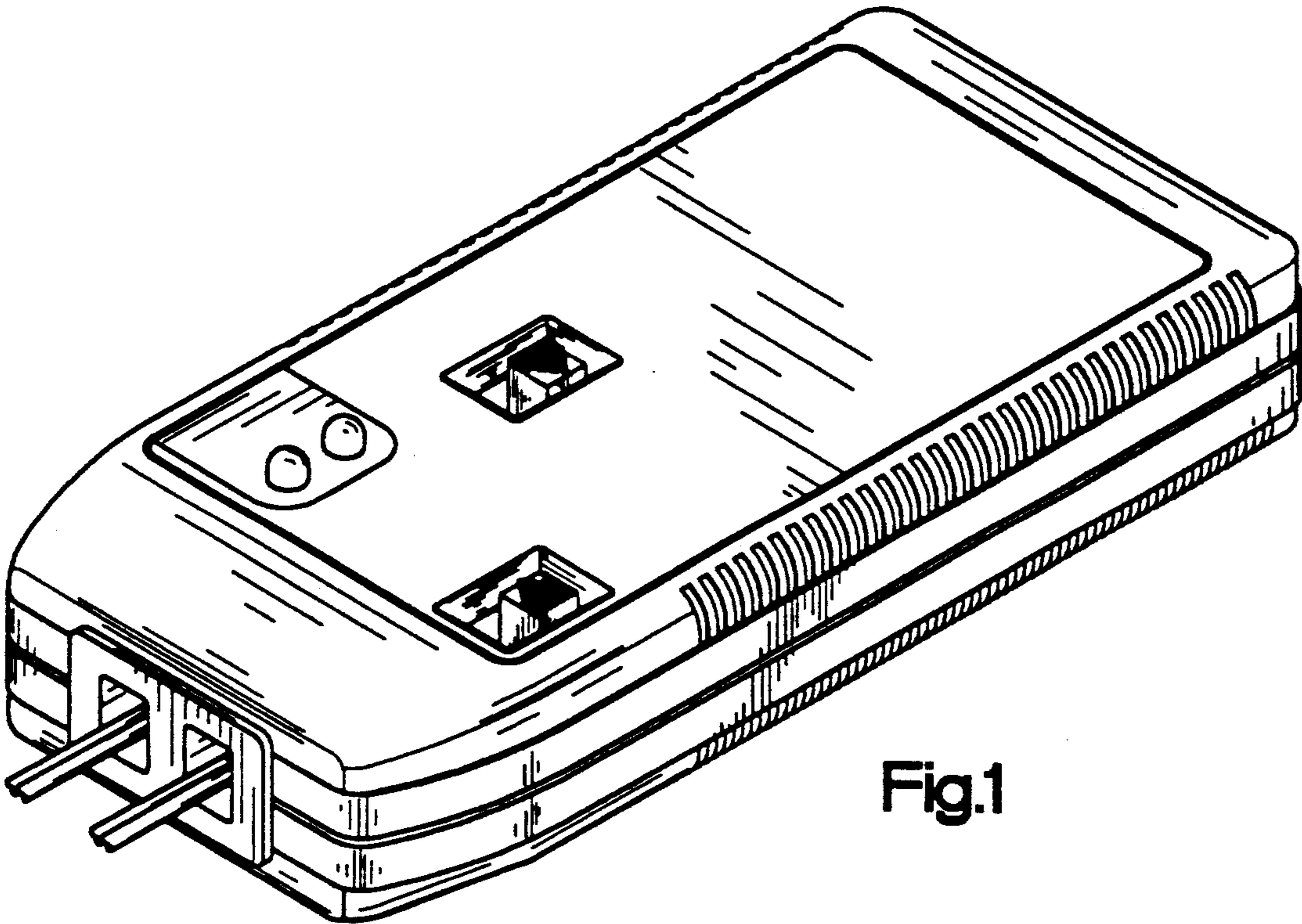

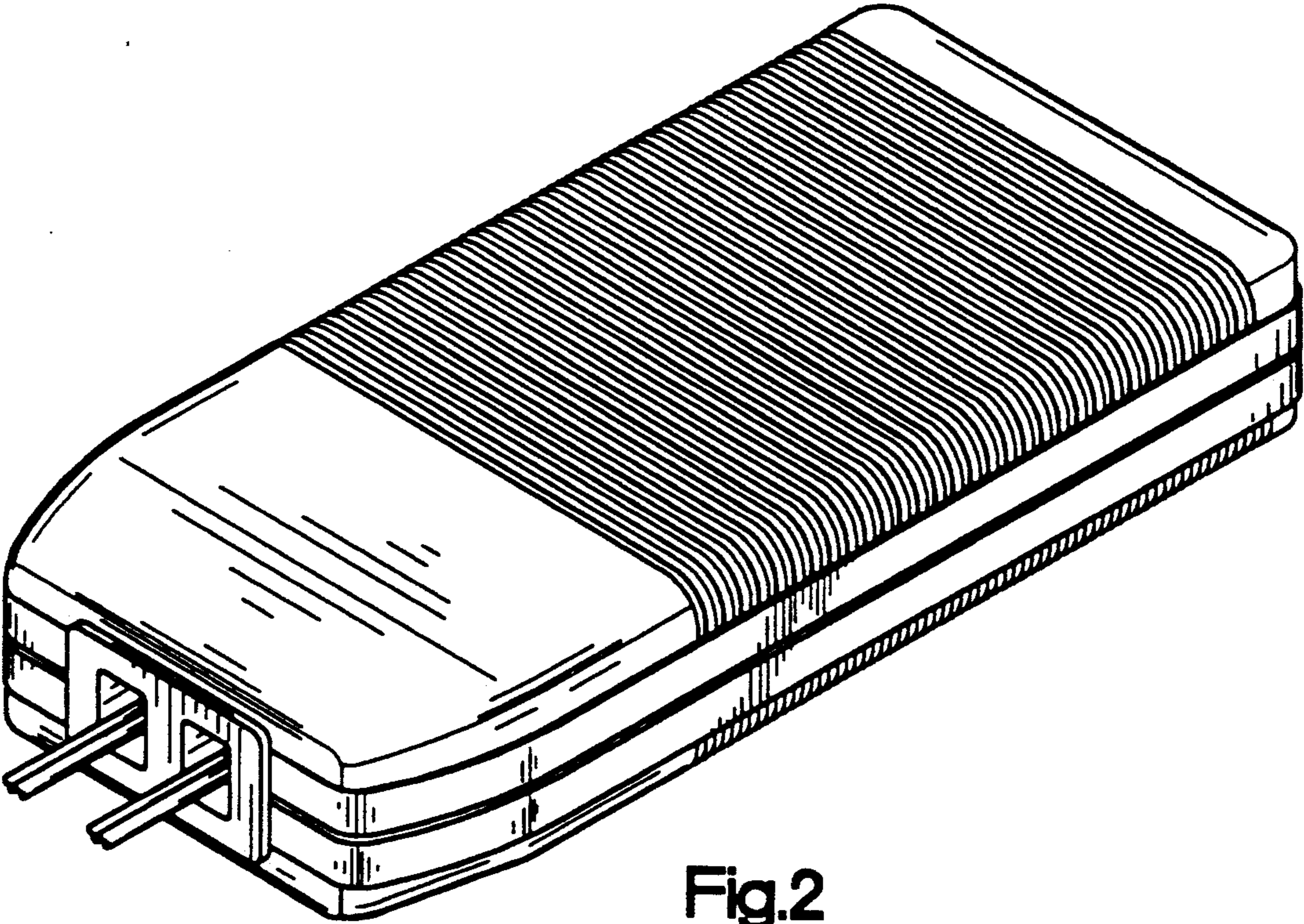

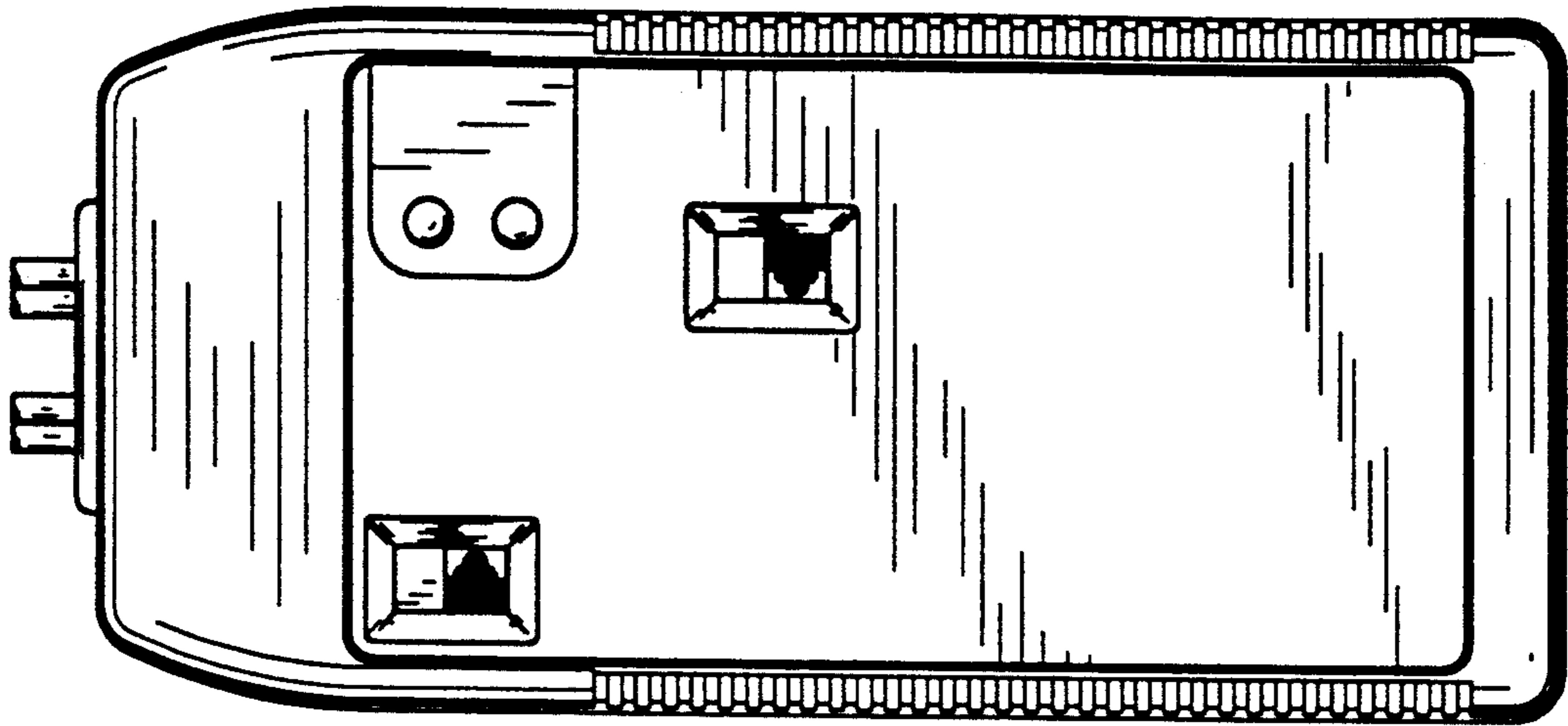

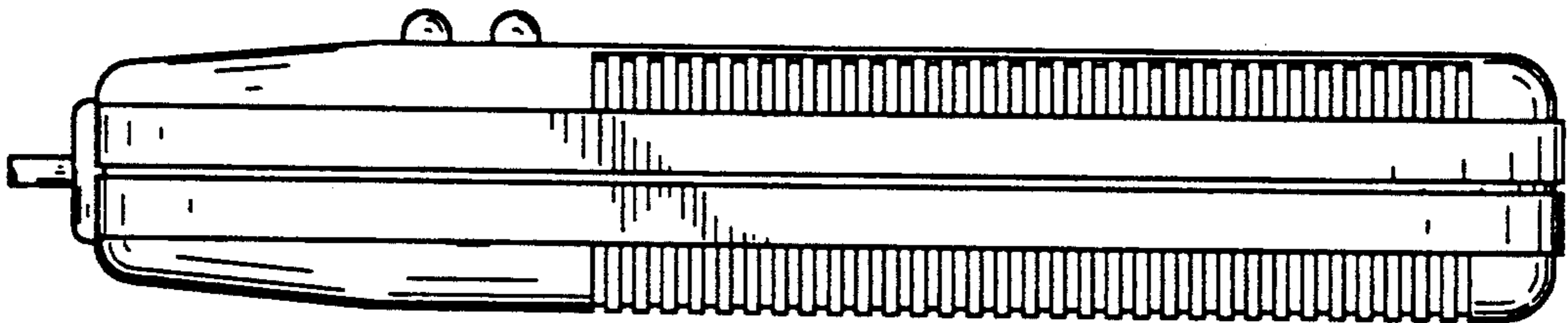

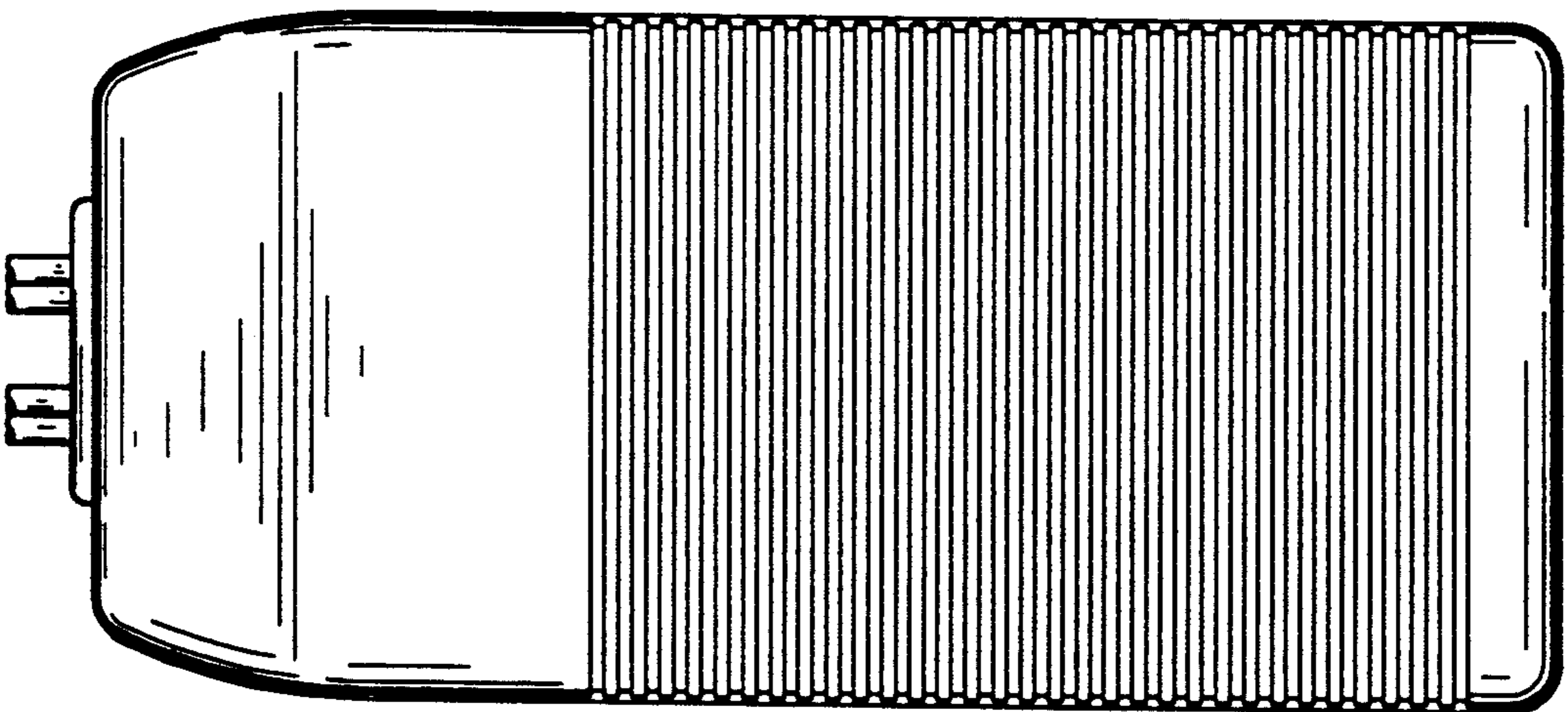

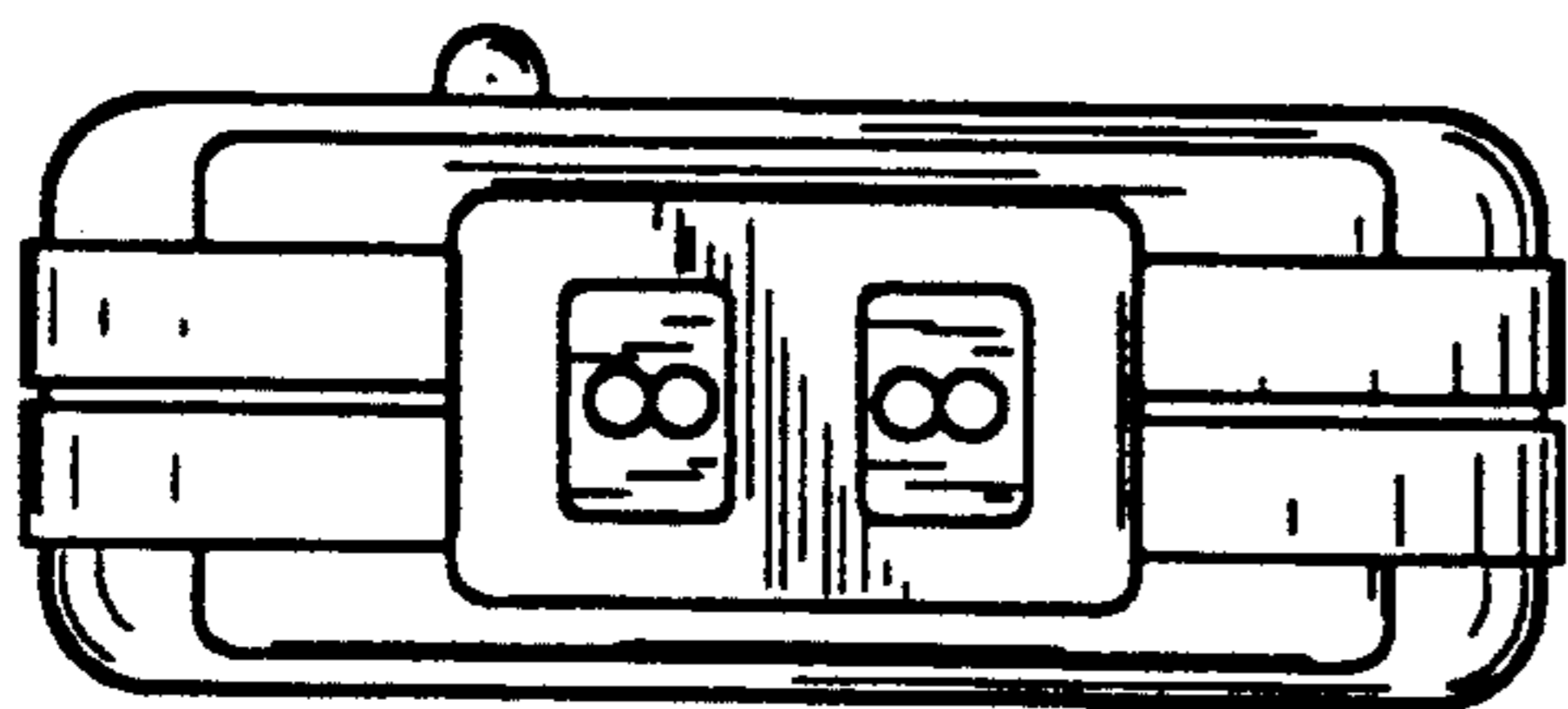

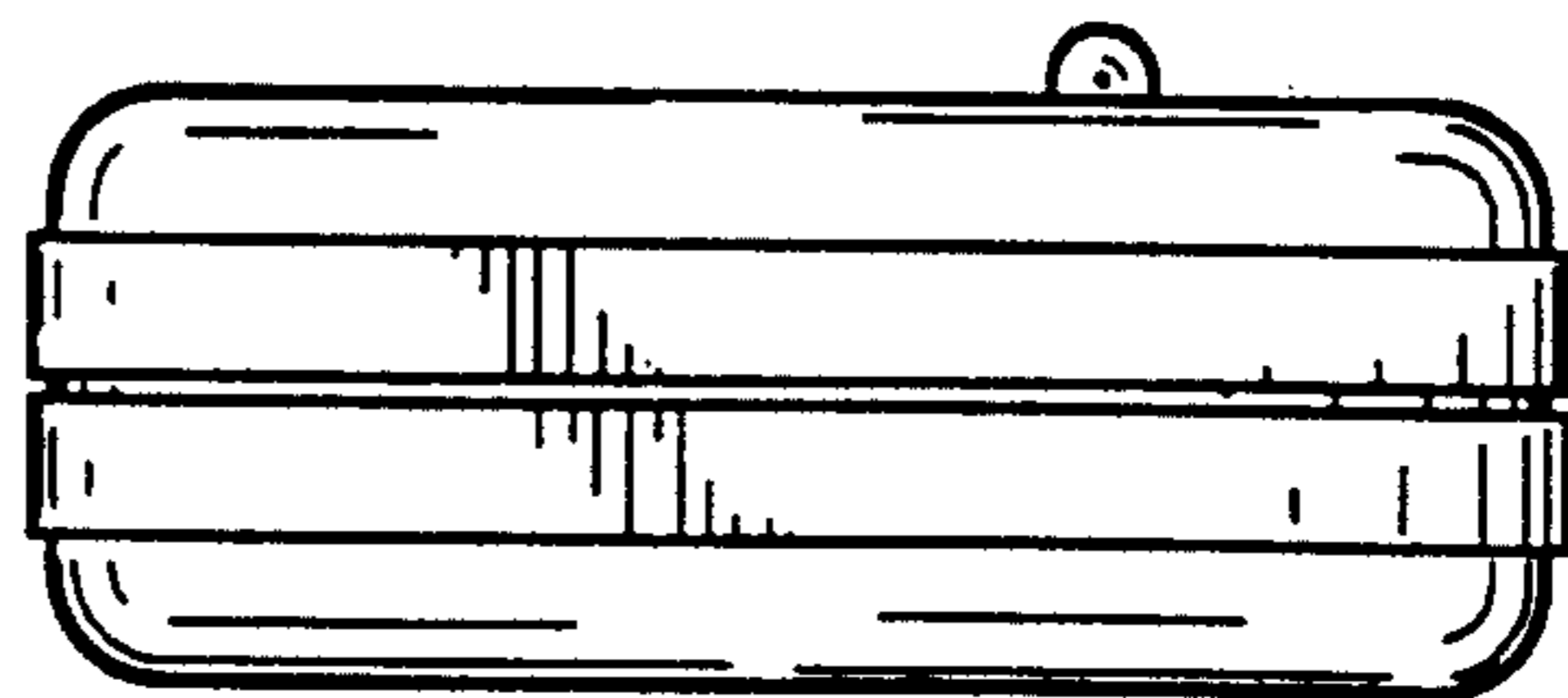
