FIG. 7 is a right side elevation thereof.

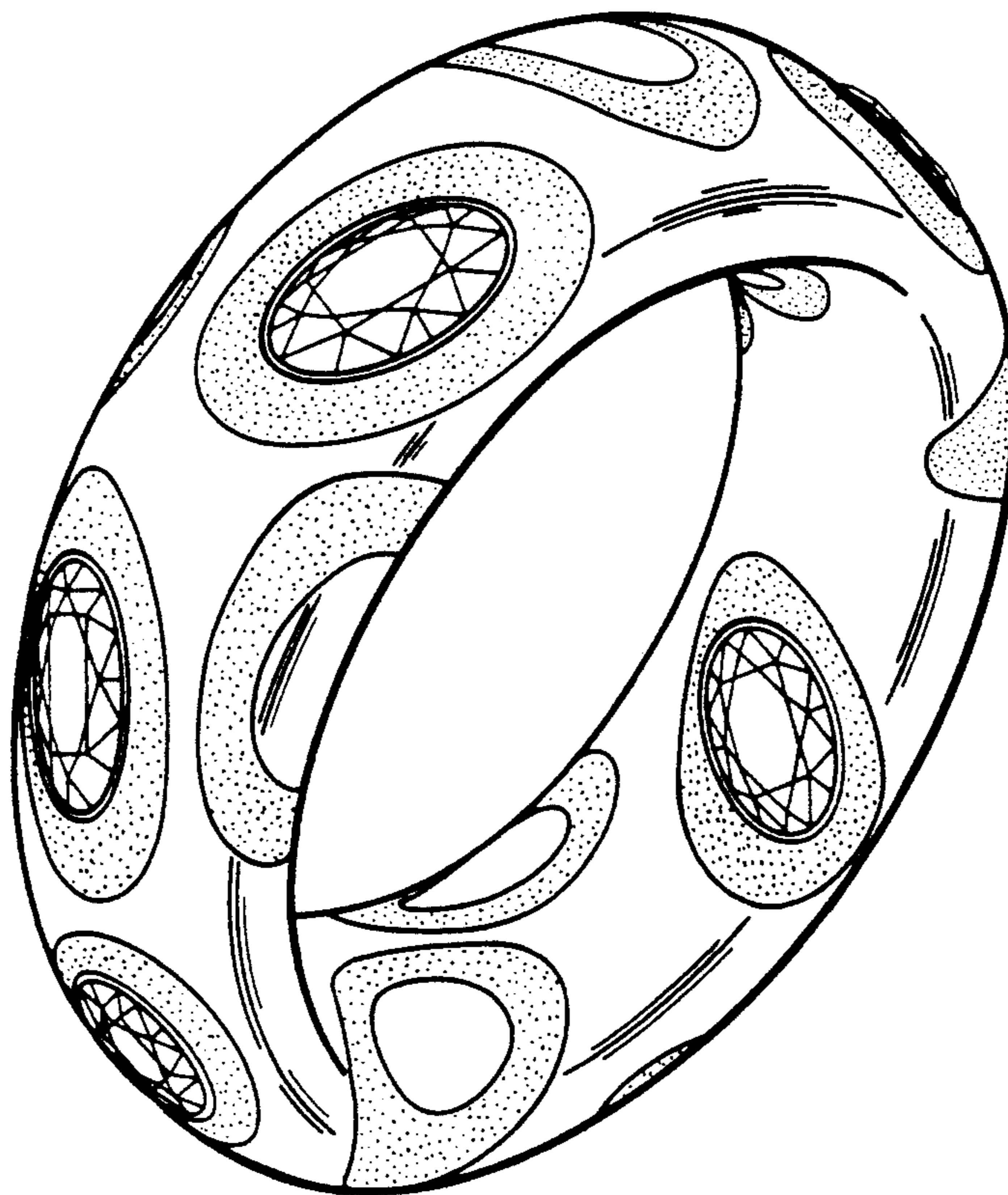

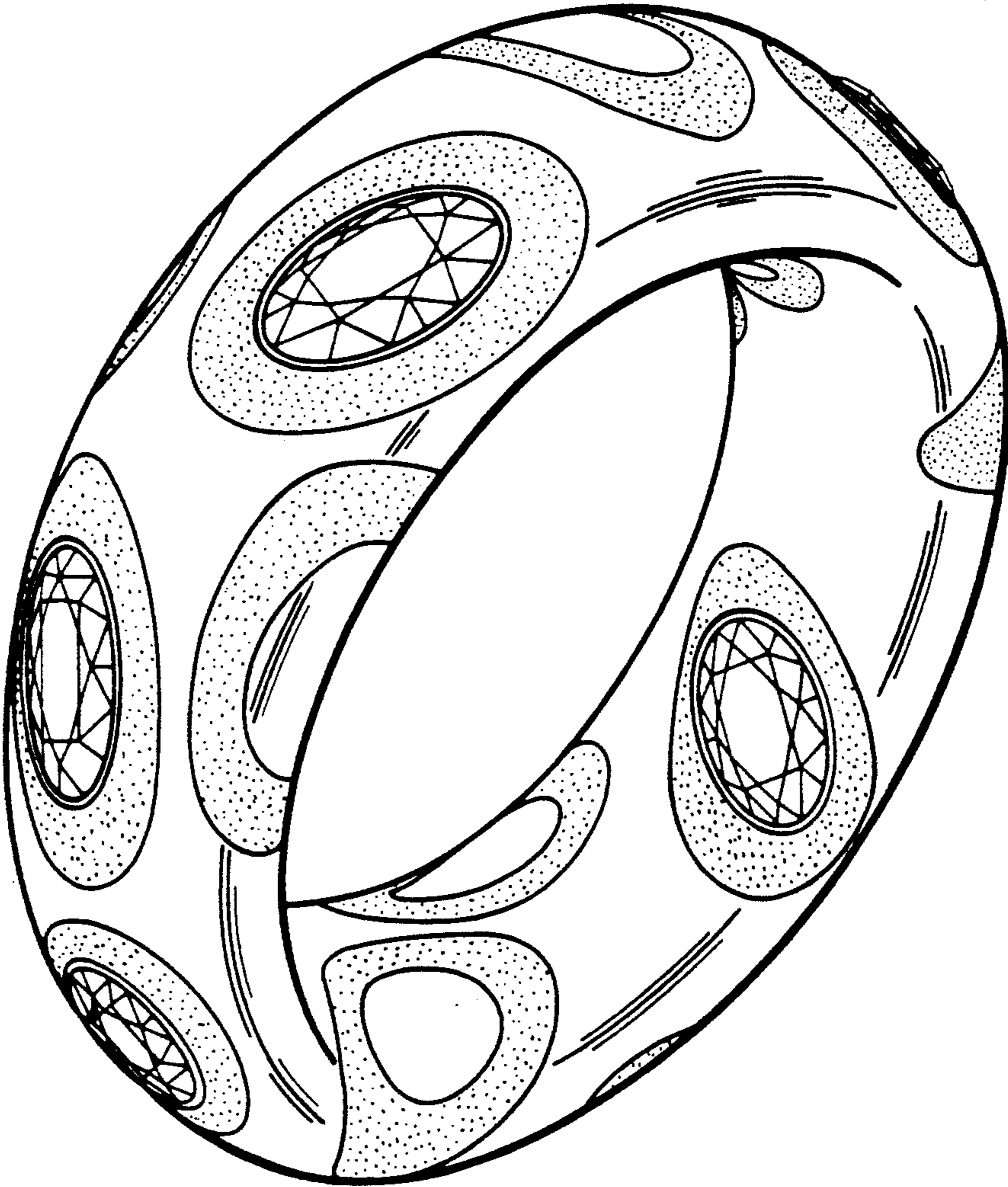

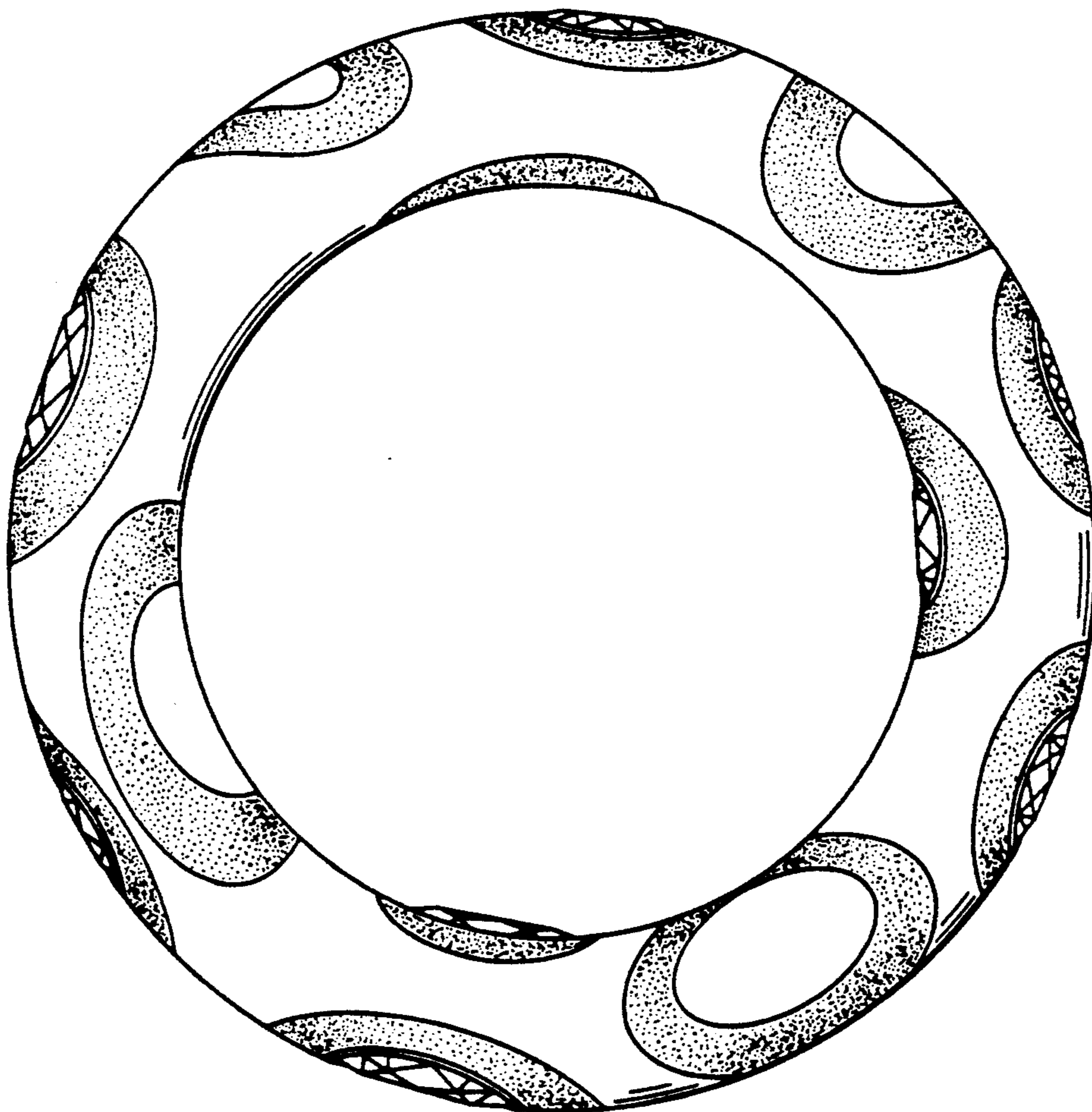

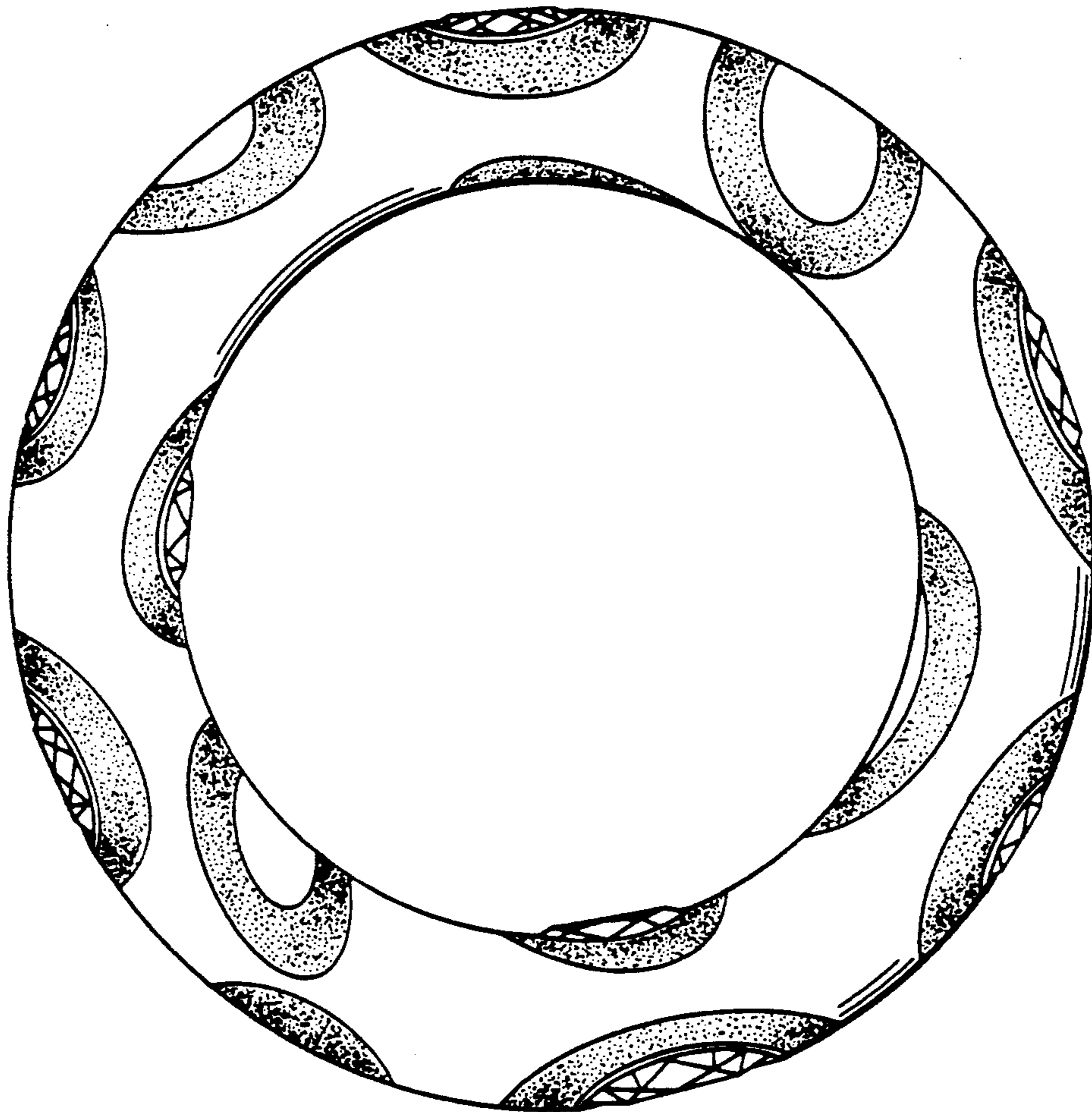

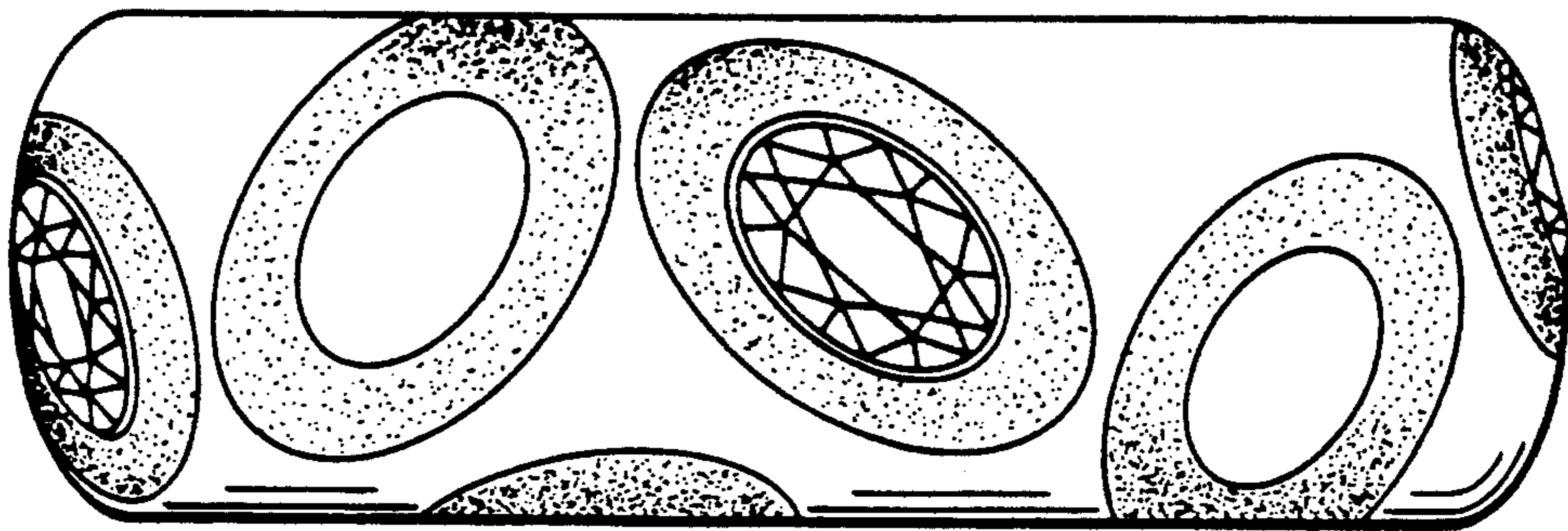

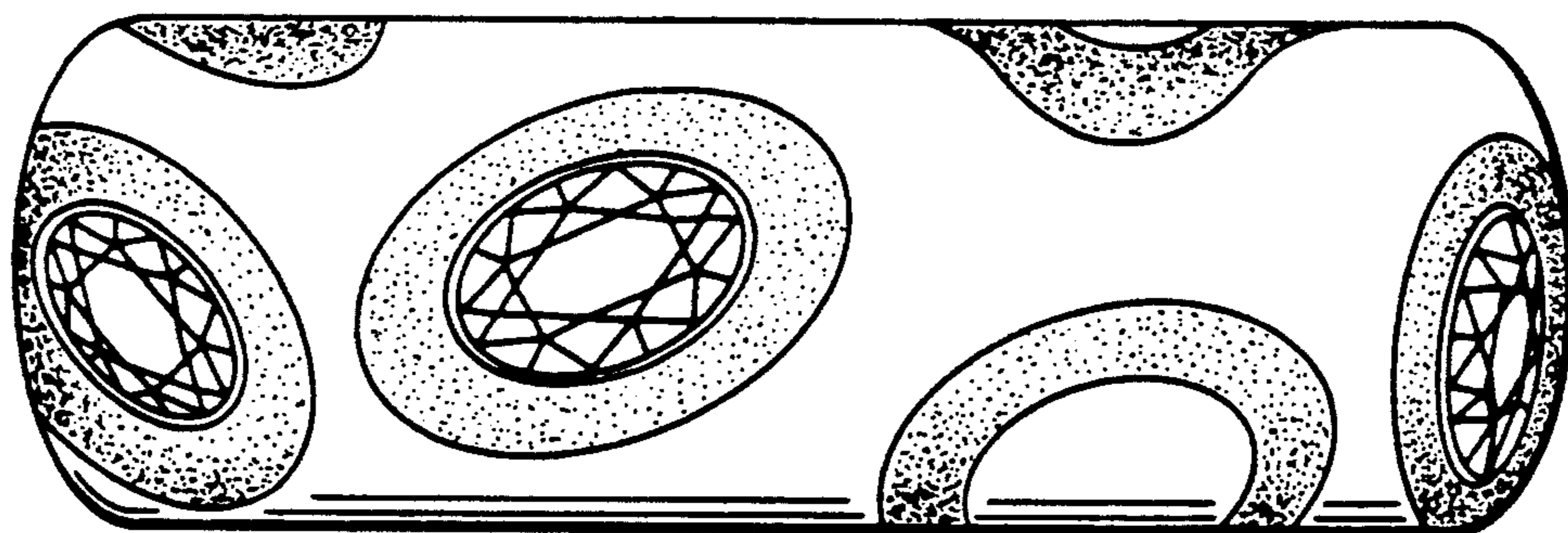

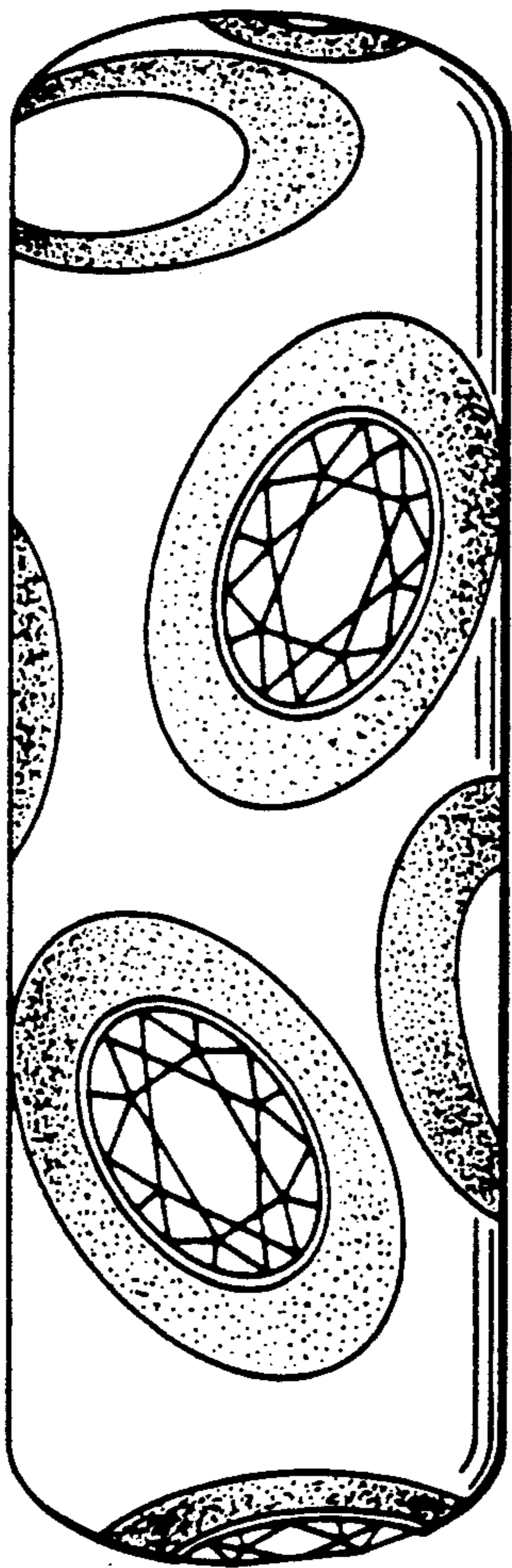
