FIG. 1 is a front elevational view of the clear path carpet showing my new design;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 6 is a bottom plan view thereof; and,

The broken line disclosure in FIG. 7 is for environmental purposes only.

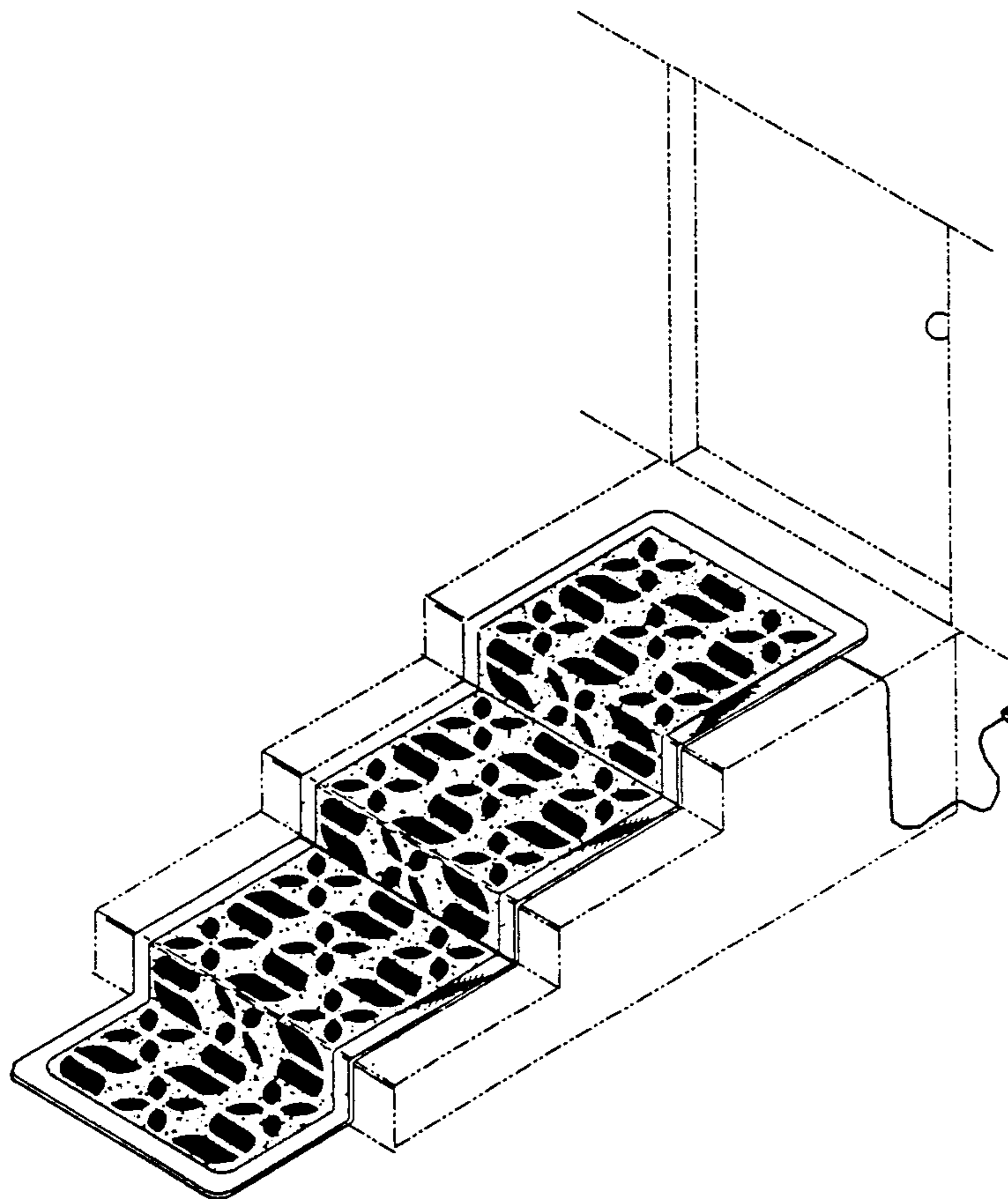

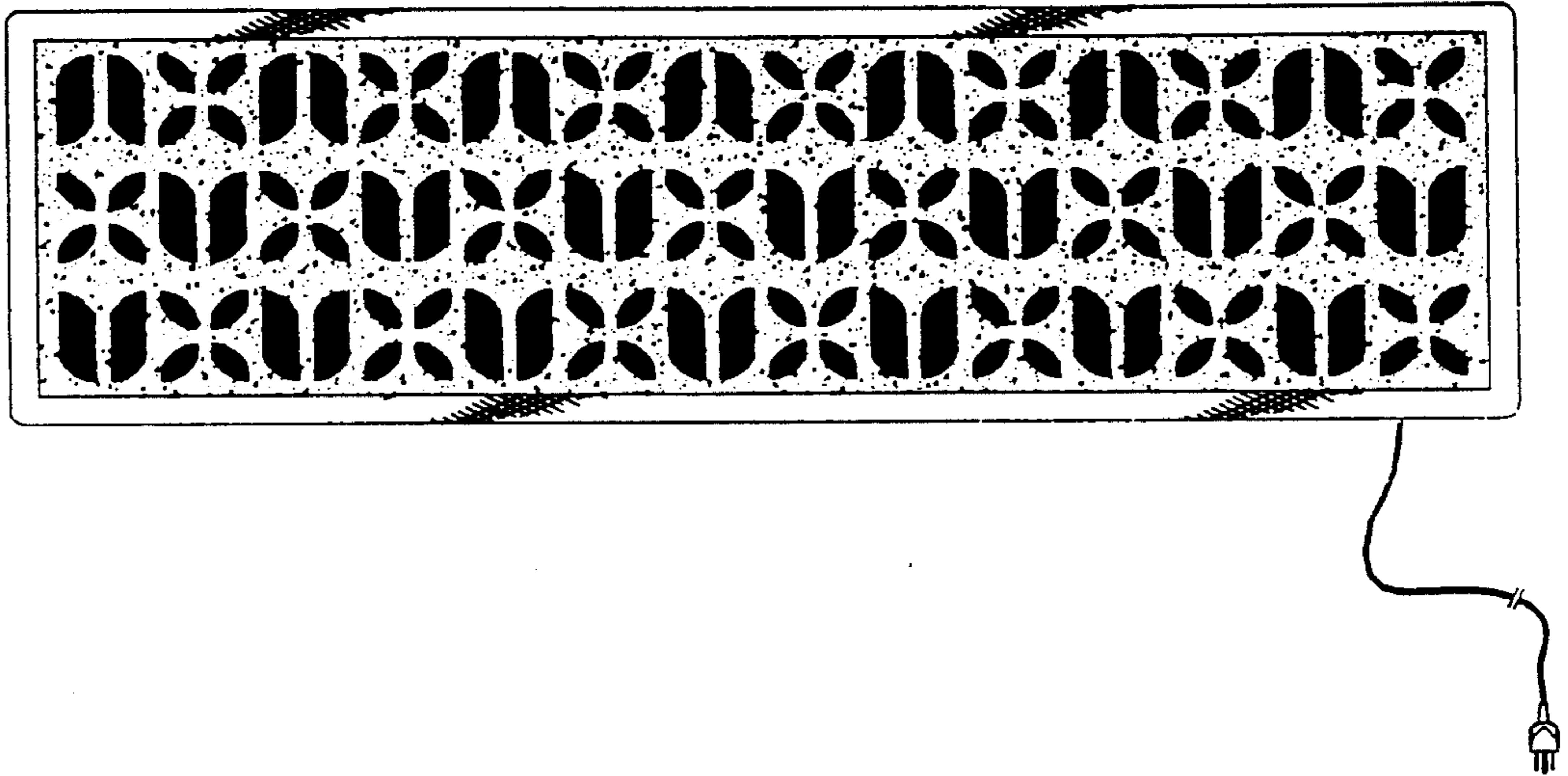
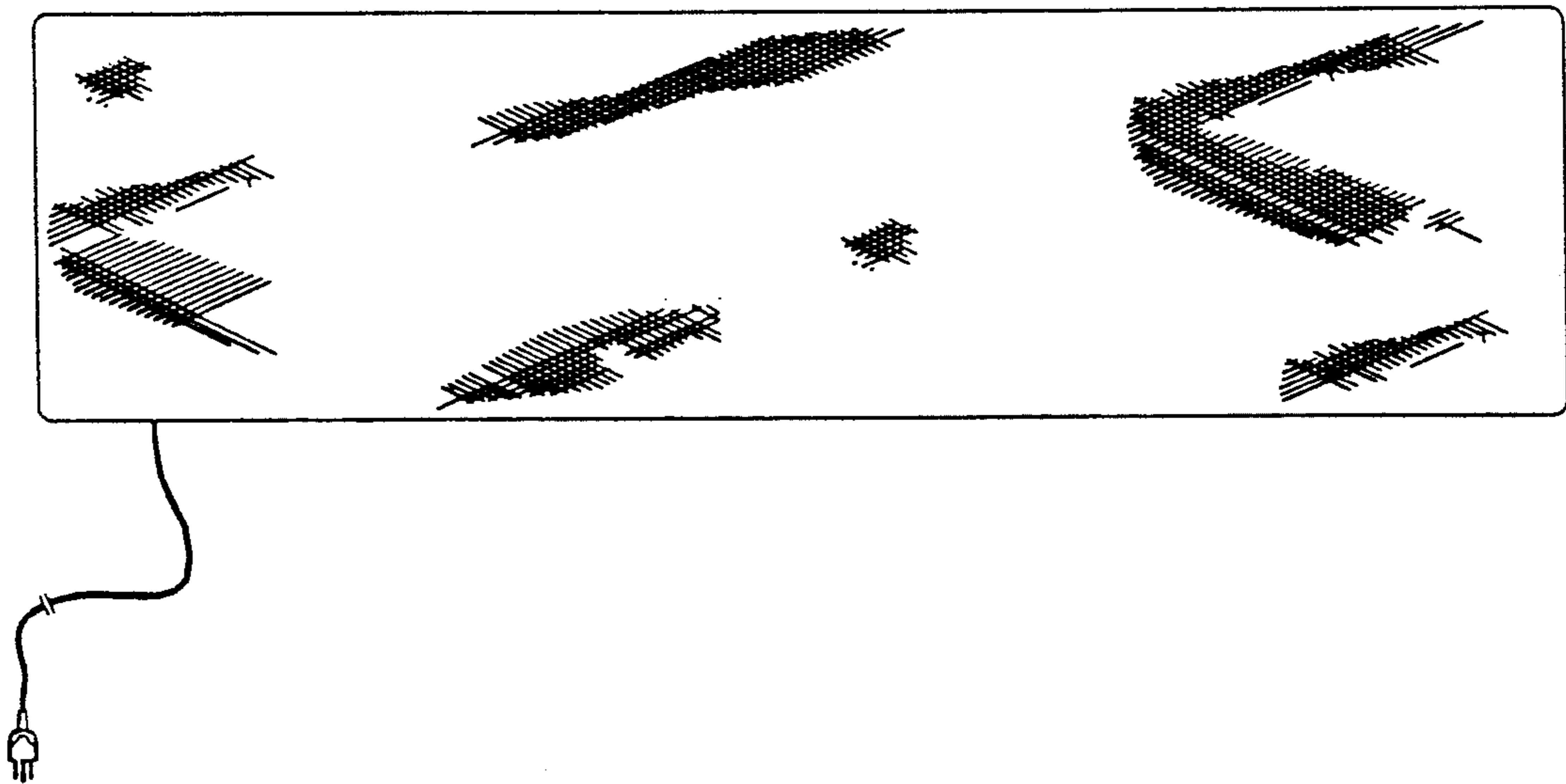

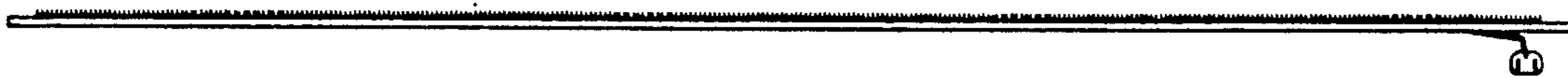
