CLAIM

[57] The ornamental design for a mixing bowl, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a mixing bowl showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is an elevational view thereof, the side opposite being a duplicate image thereof;
FIG. 4 is an elevational view thereof at a right angle to FIG. 3, the side opposite being a duplicate image thereof;
FIG. 5 is a bottom plan view thereof; and,
FIG. 6 is an enlarged cross-section thereof taken on line 6—6 in FIG. 5.

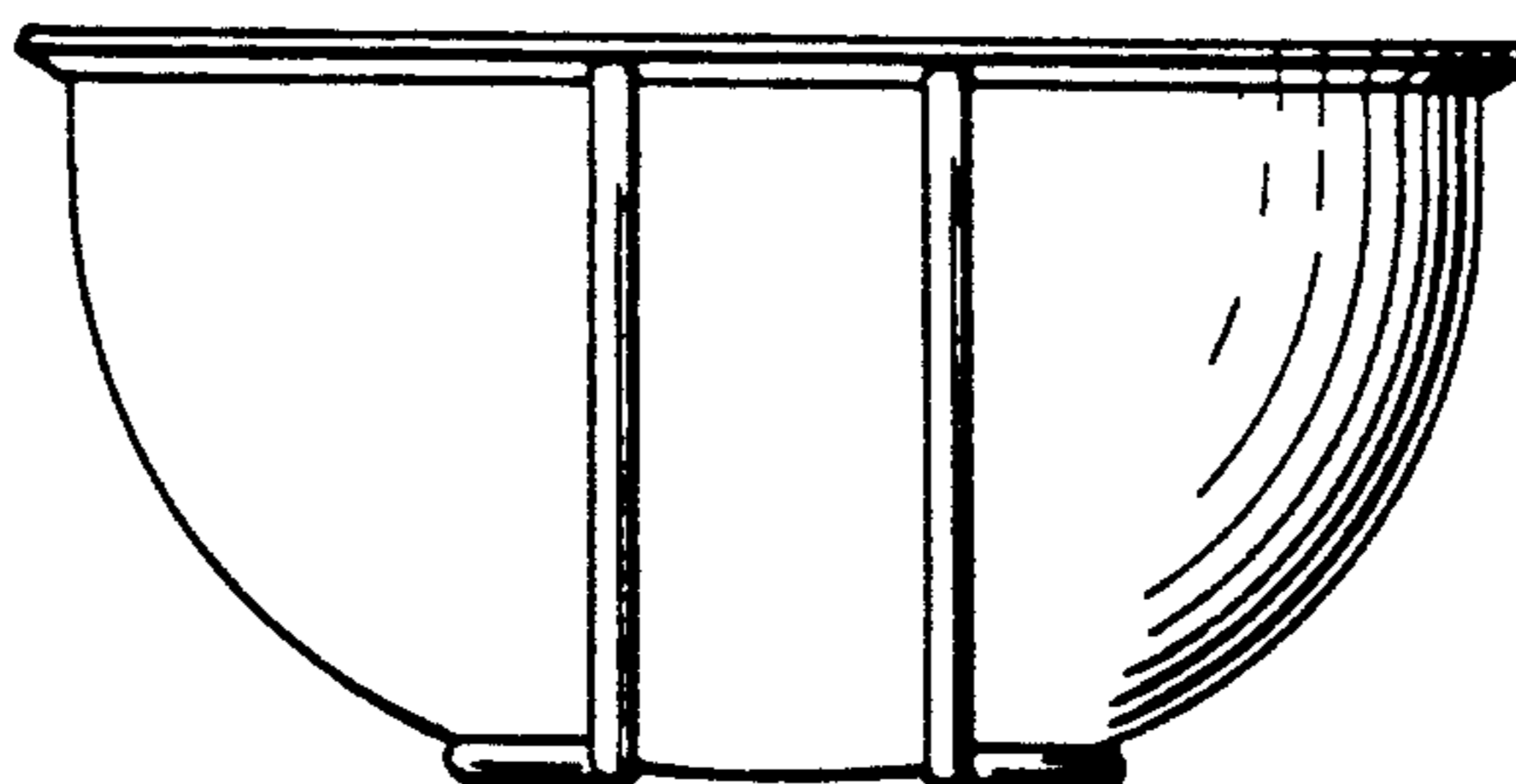
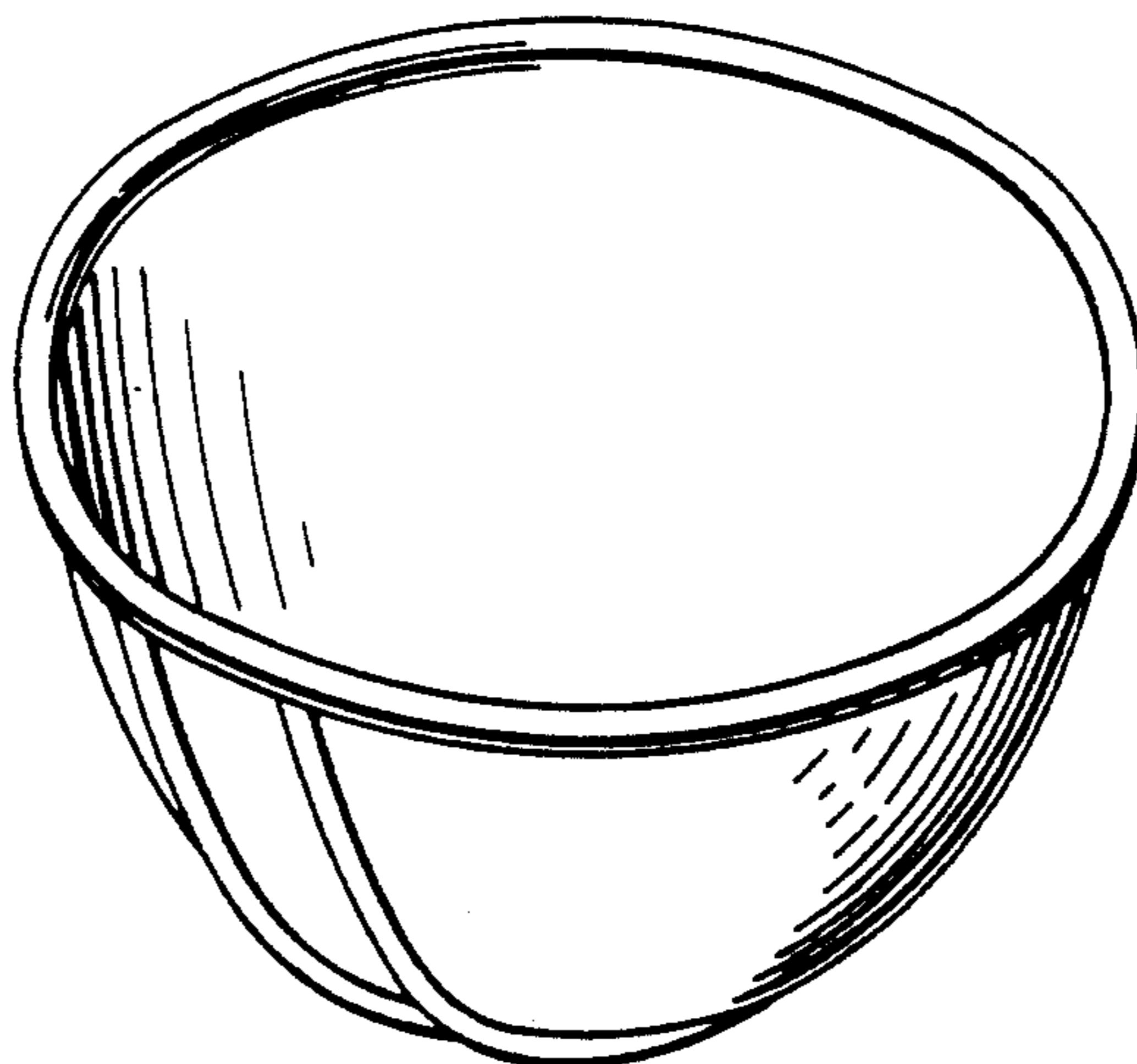

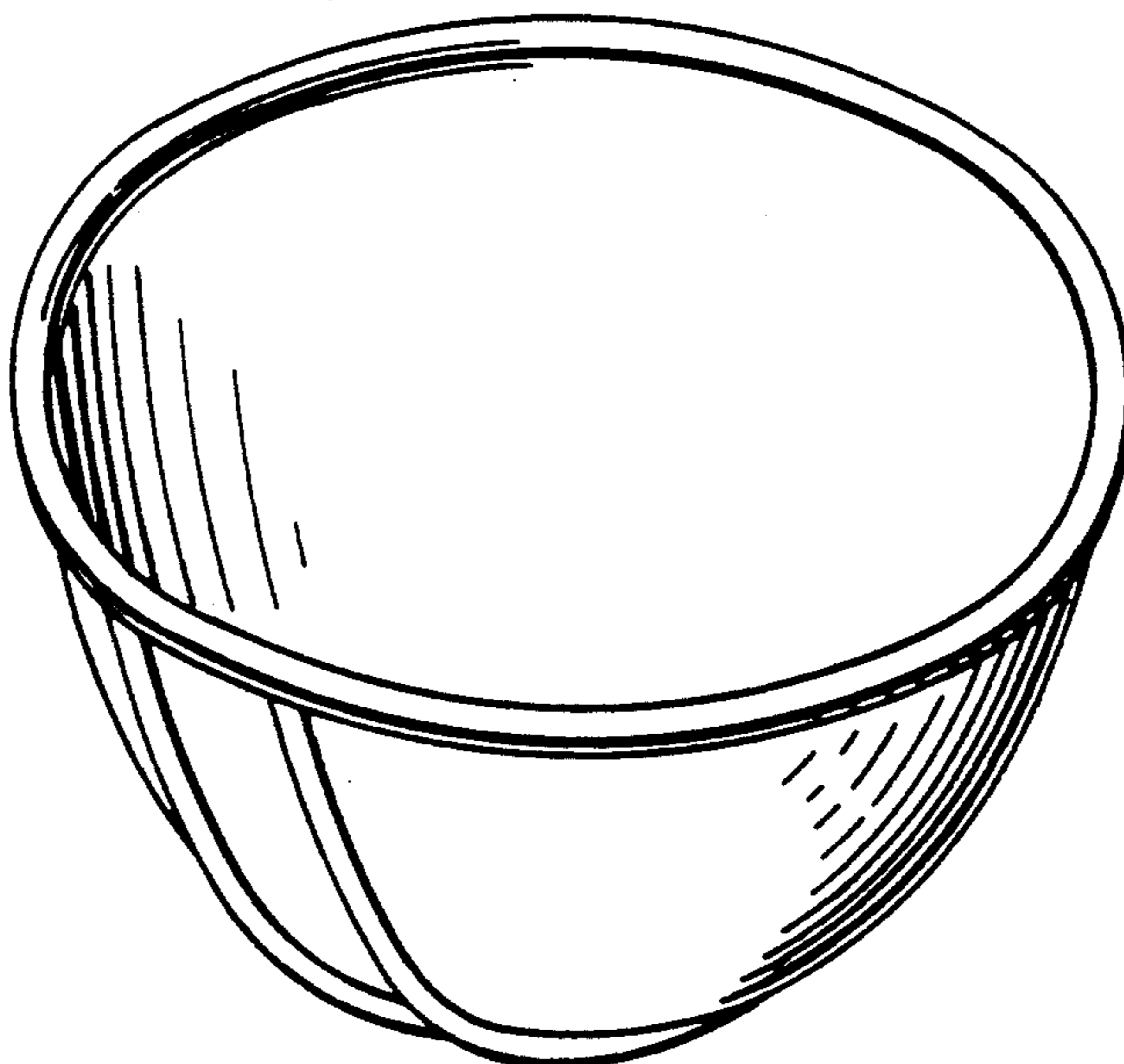

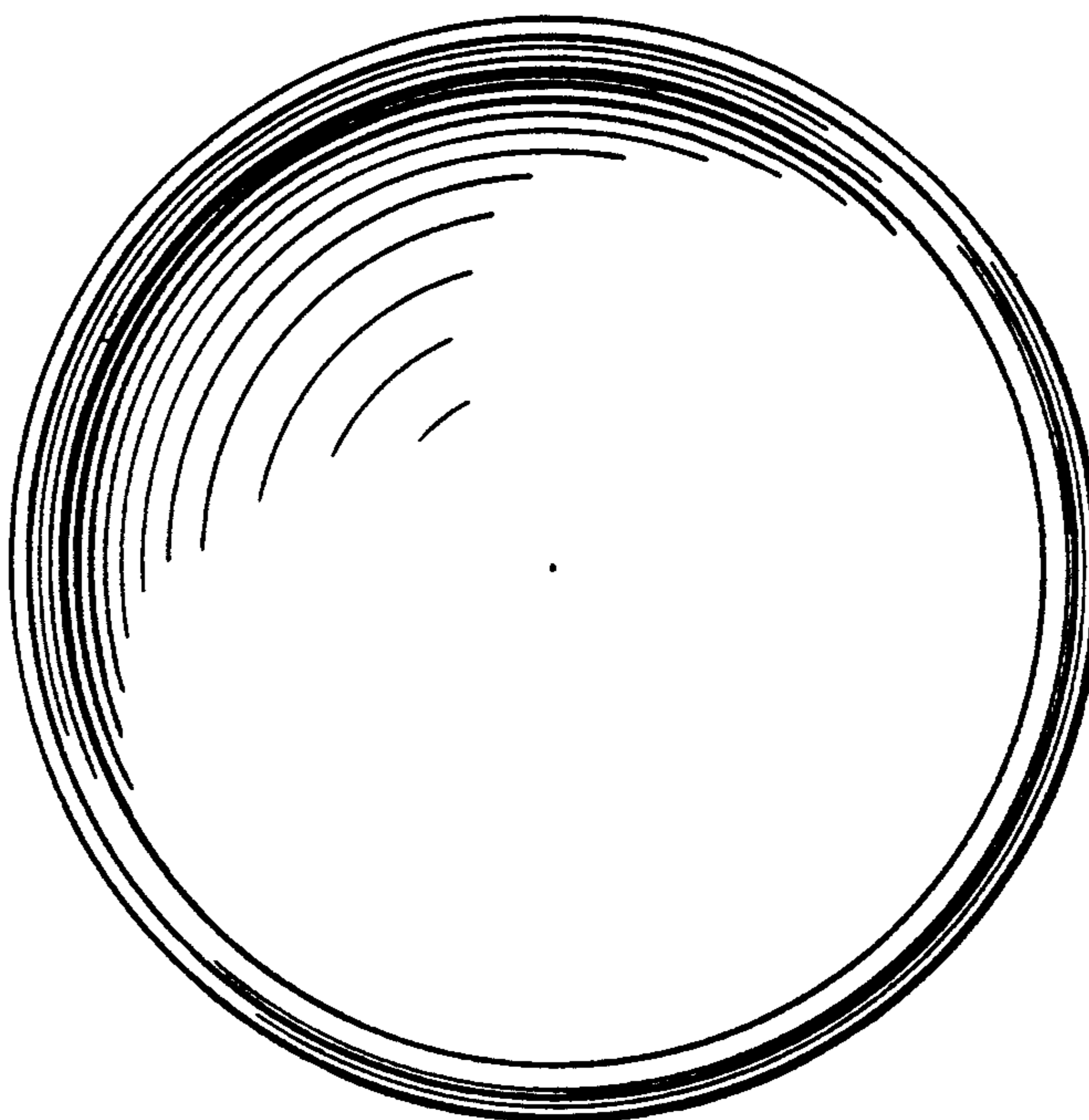

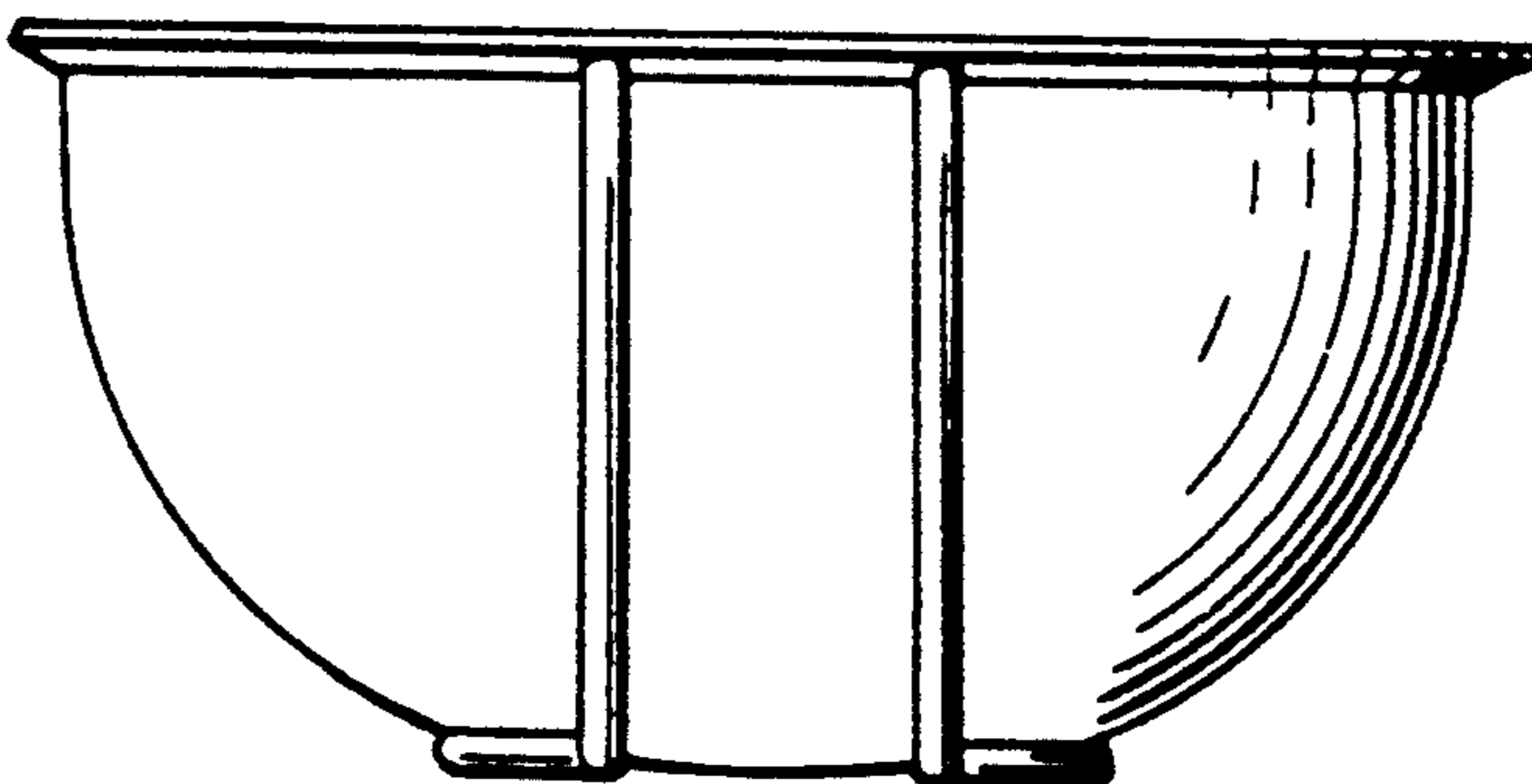

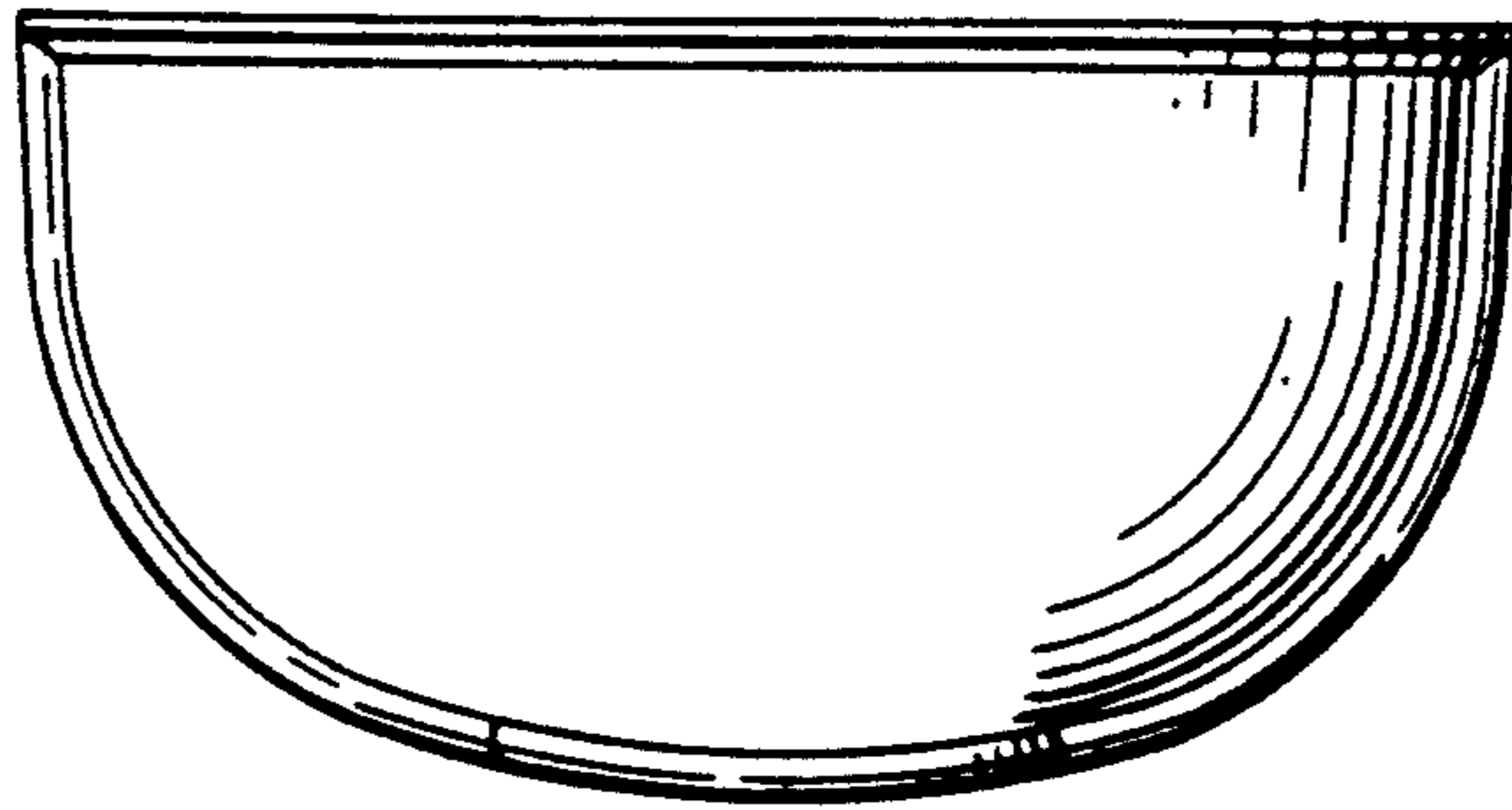

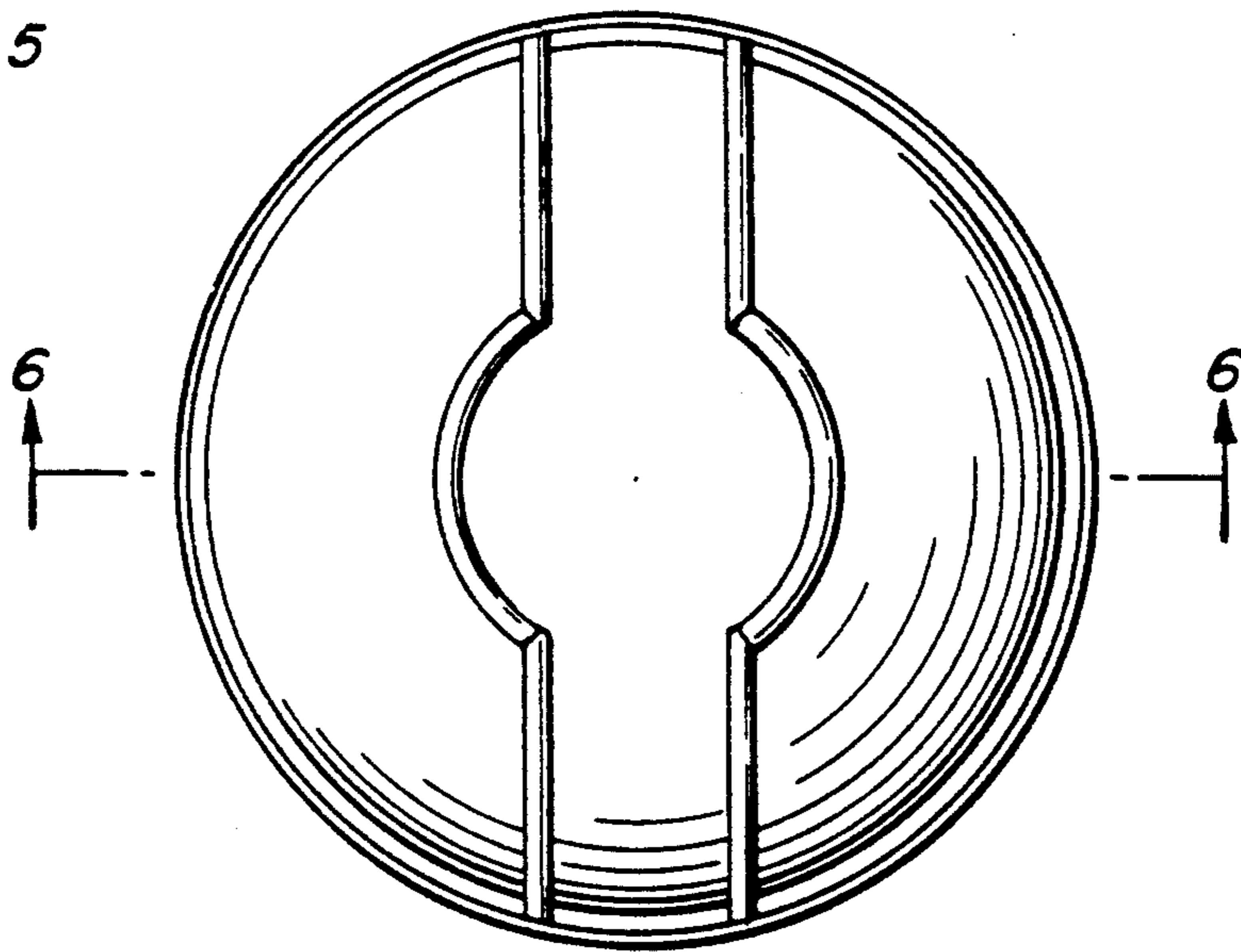
