The ornamental design for a dog chew bone toy with edible bone, as shown and described.

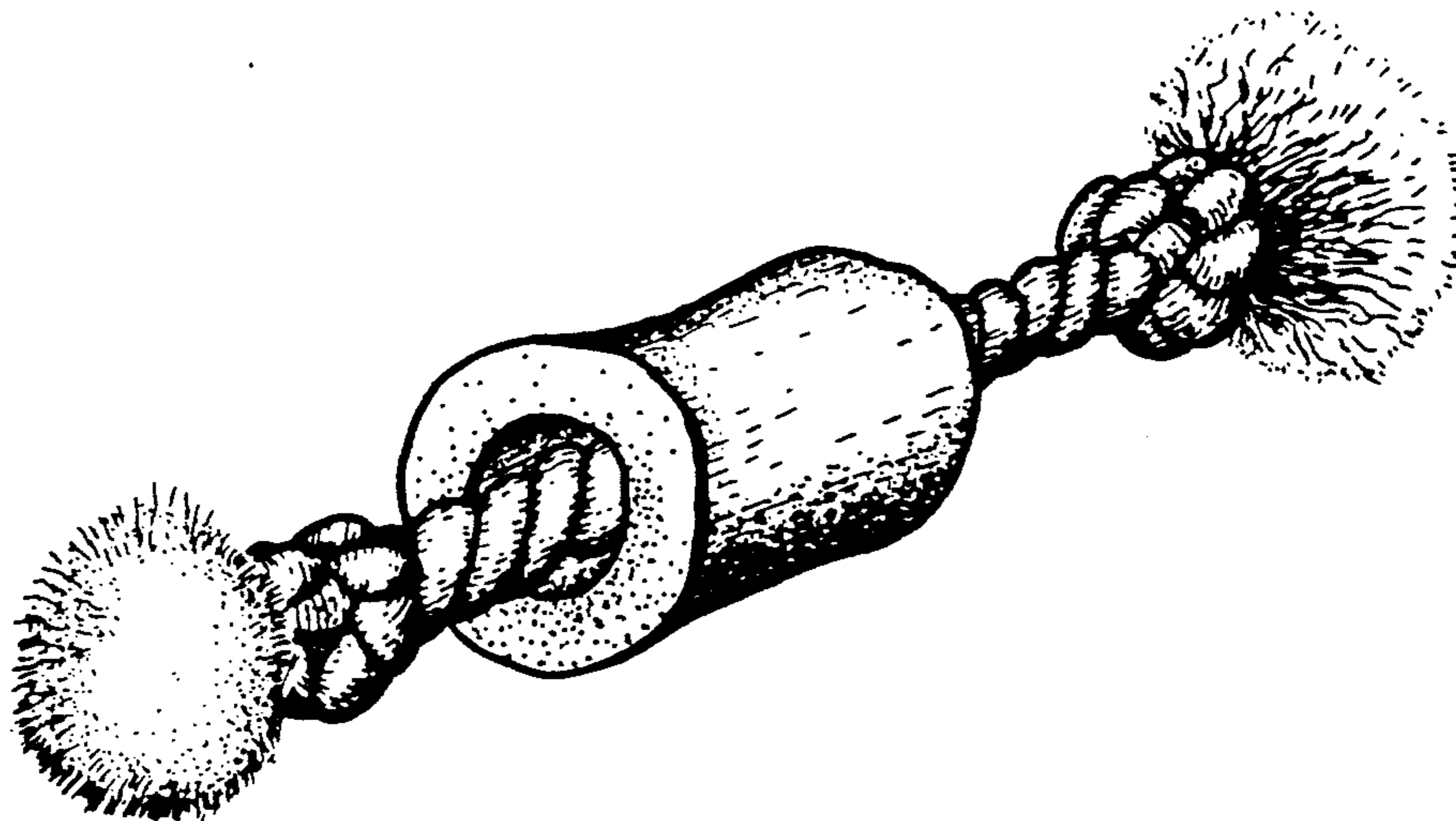
## DESCRIPTION

FIG. 1 is a perspective view showing our new design for a dog chew toy with edible bone;

FIG. 2 is a top plan view thereof, the bottom view being a mirror image thereof;

FIG. 3 is a side elevational view thereof, the view from the opposite side being a mirror image thereof; and,

FIG. 4 is an end elevational view, the view from the opposite end being a mirror image thereof.



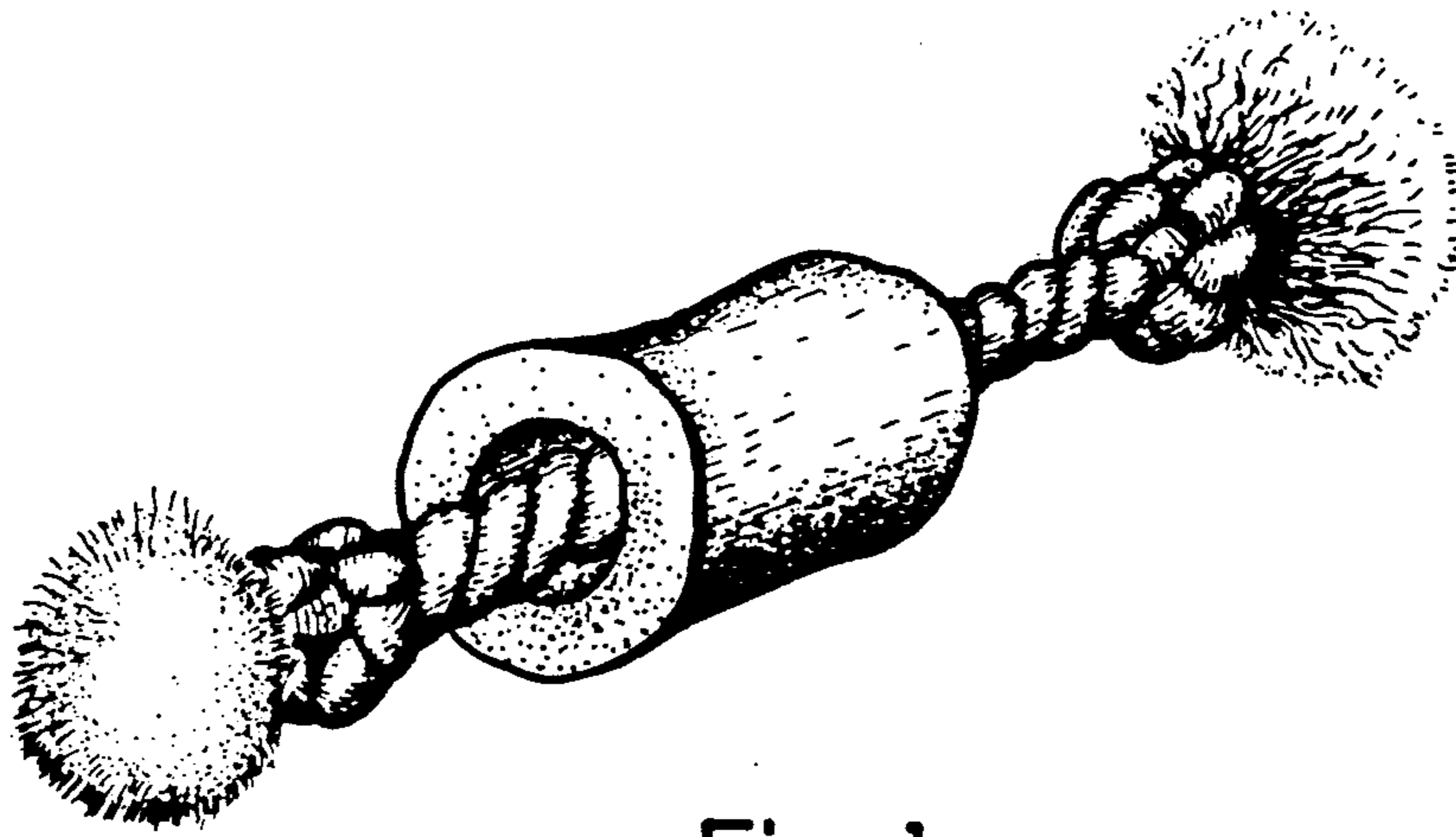

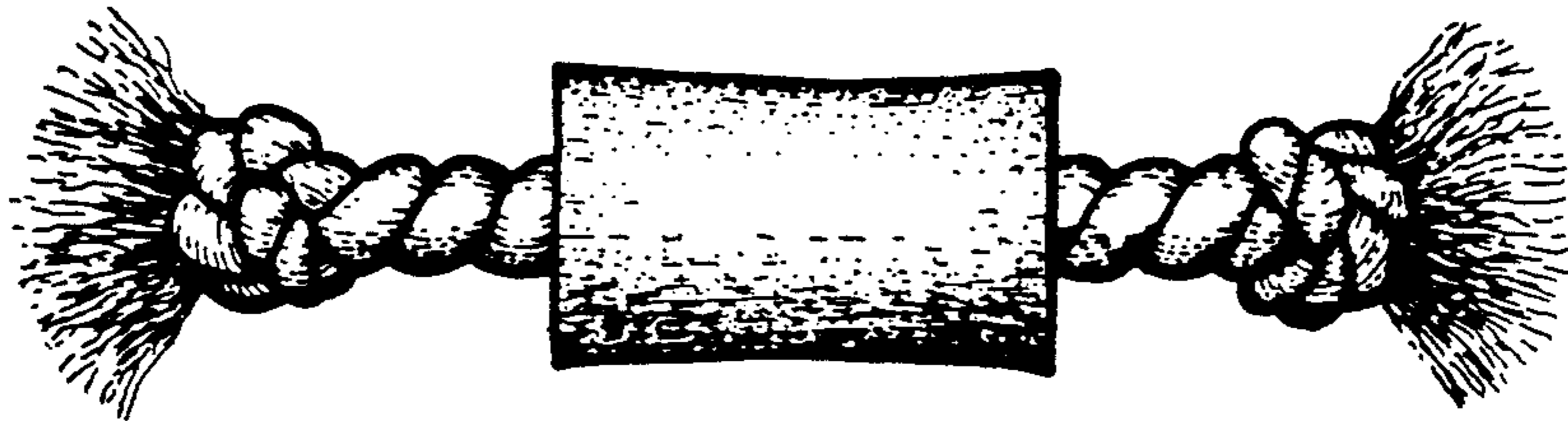

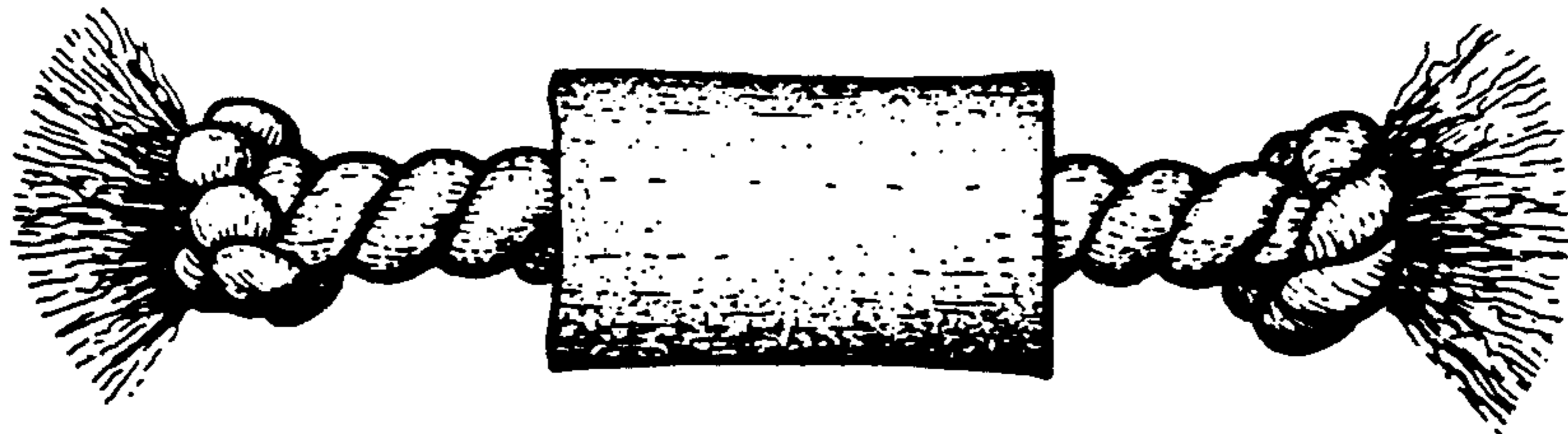
