The ornamental design for an inflated shoe stuffing, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view on a reduced scale of a first embodiment of an inflated shoe stuffing showing my new design;

FIG. 2 is a right side elevational view thereof, the left side elevational view being a mirror image;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a perspective view on a reduced scale of a second embodiment of an inflated shoe stuffing showing my new design;

FIG. 8 is a right side elevational view thereof, the left side elevational view being a mirror image;

FIG. 9 is a front elevational view thereof;

FIG. 10 is a top plan view thereof;

FIG. 11 is a rear elevational view thereof;

FIG. 12 is a bottom plan view thereof;

FIG. 13 is a perspective view on a reduced scale of a third embodiment of an inflated shoe stuffing showing my new design;

FIG. 14 is a right side elevational view thereof, the left side elevational view being a mirror image;

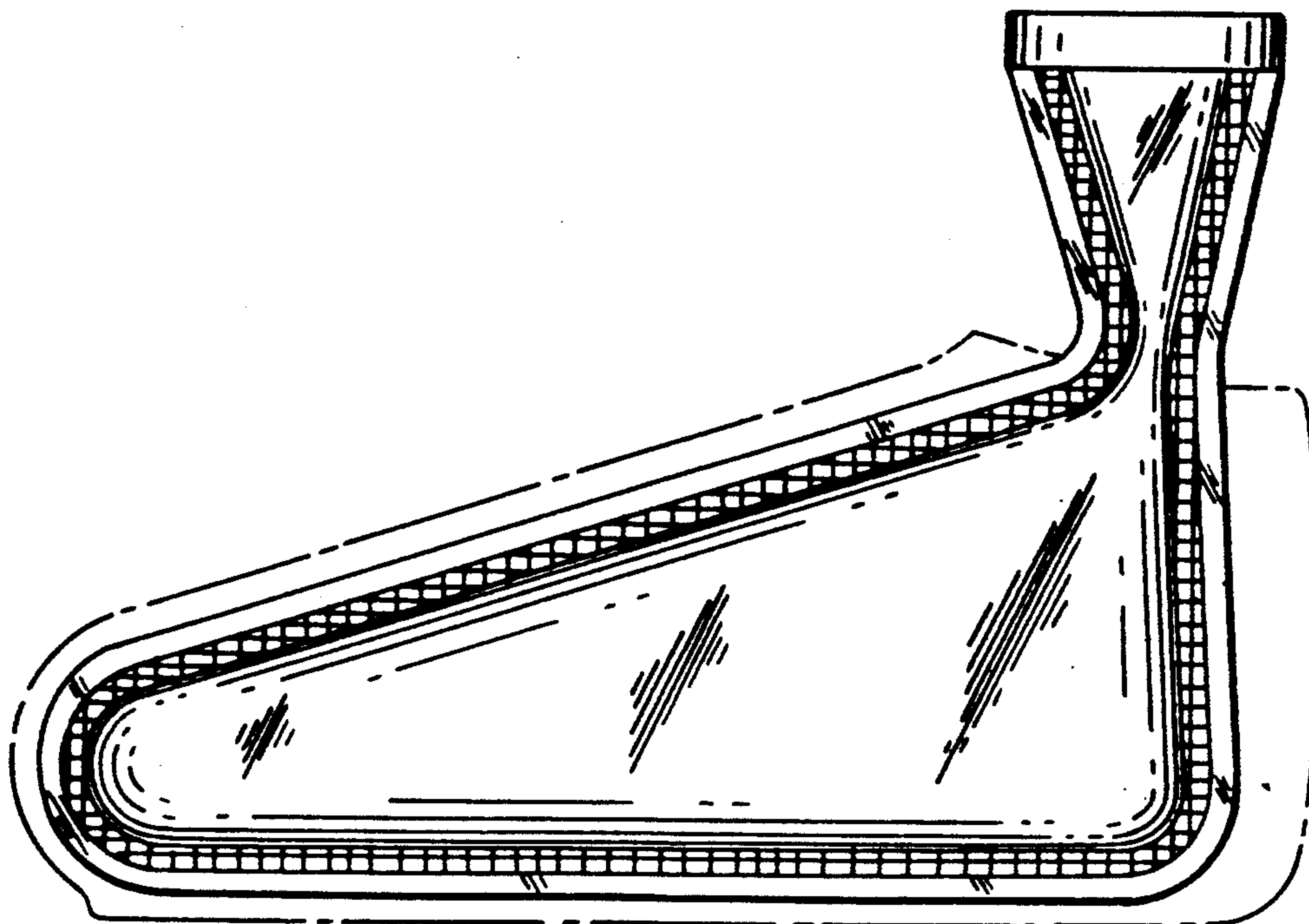
FIG. 15 is a front elevational view thereof;

The broken line showing of a shoe in FIGs. 2, 8 and 14 is for illustrative purposes only and forms no part of the claimed design.



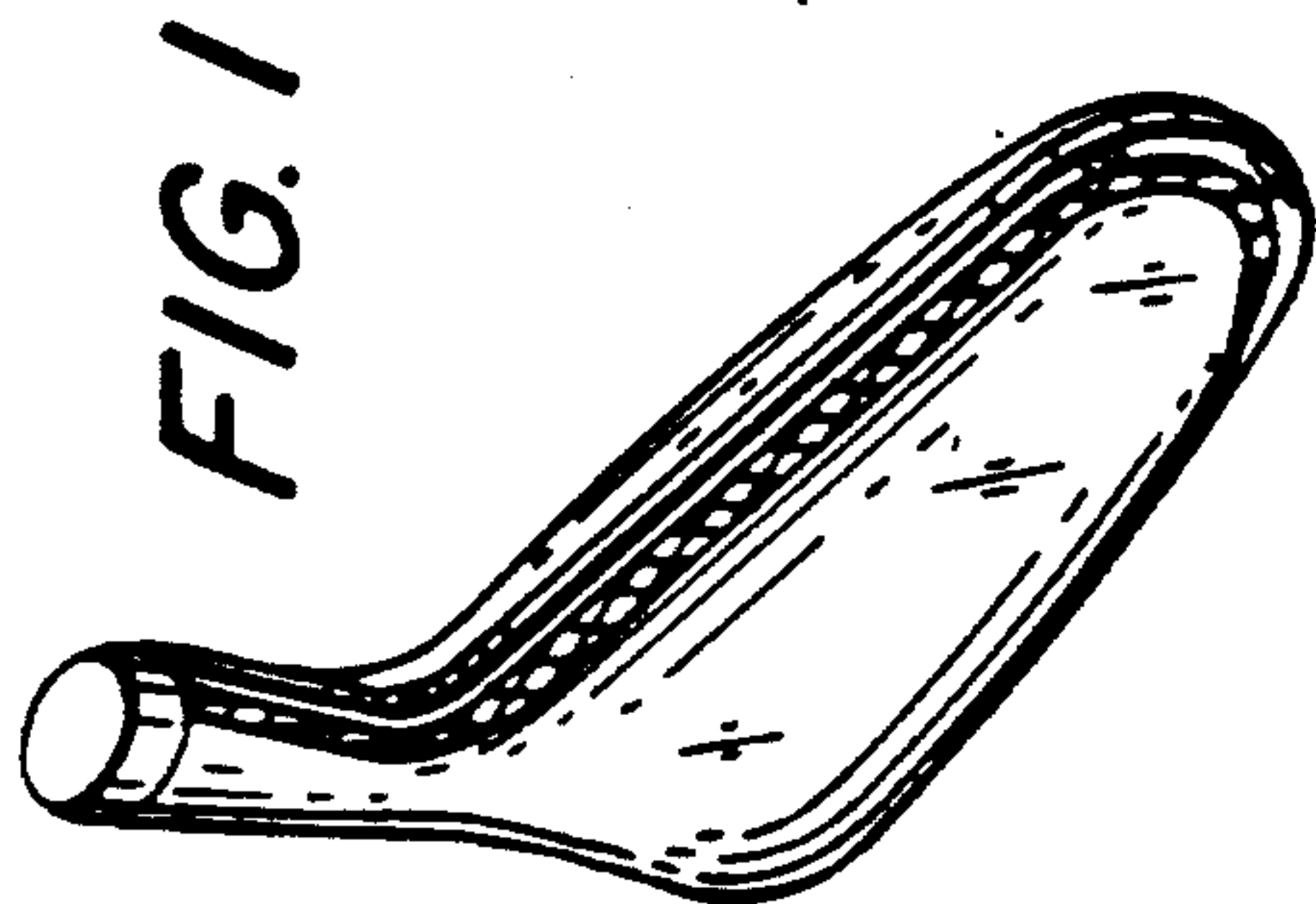
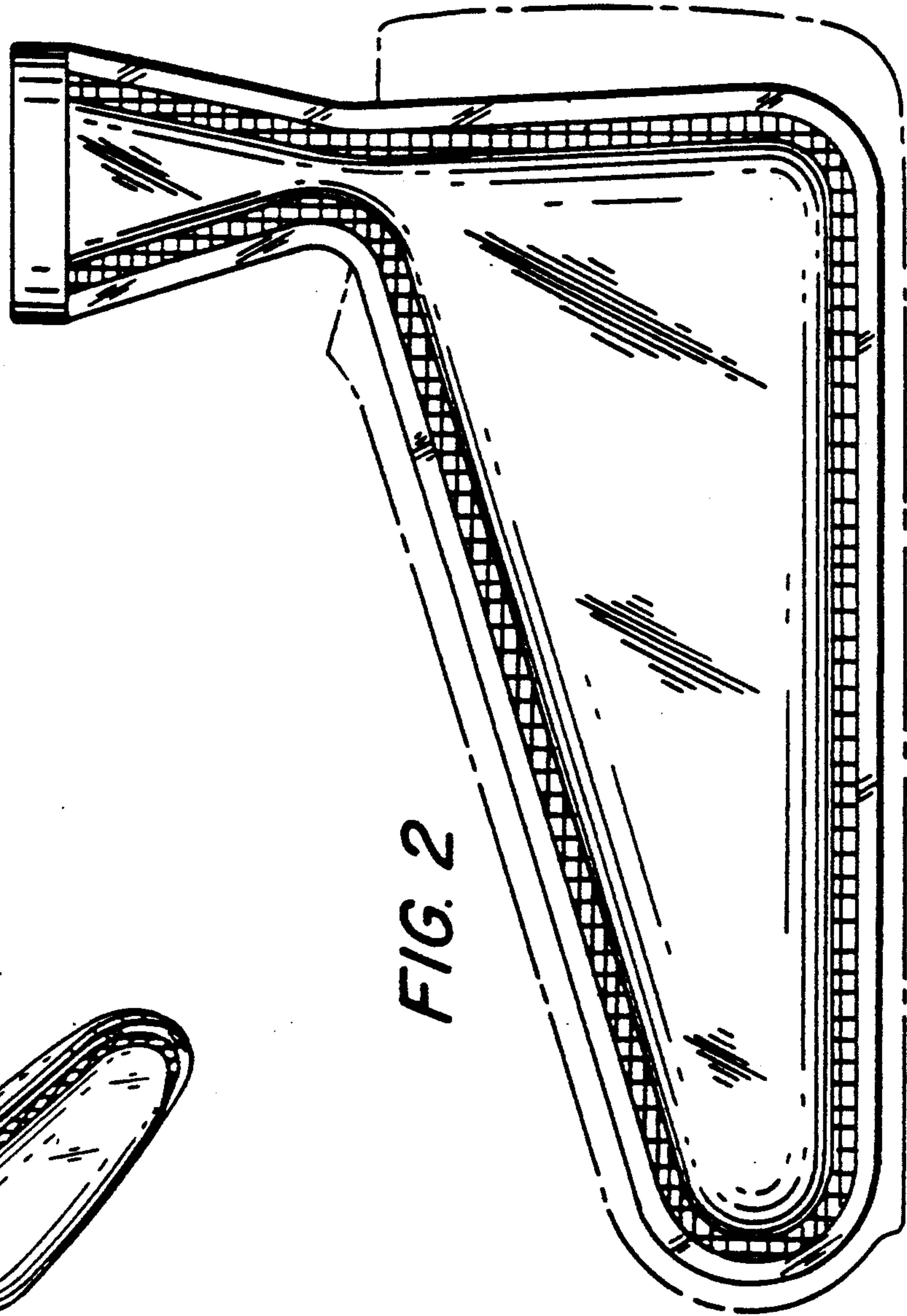
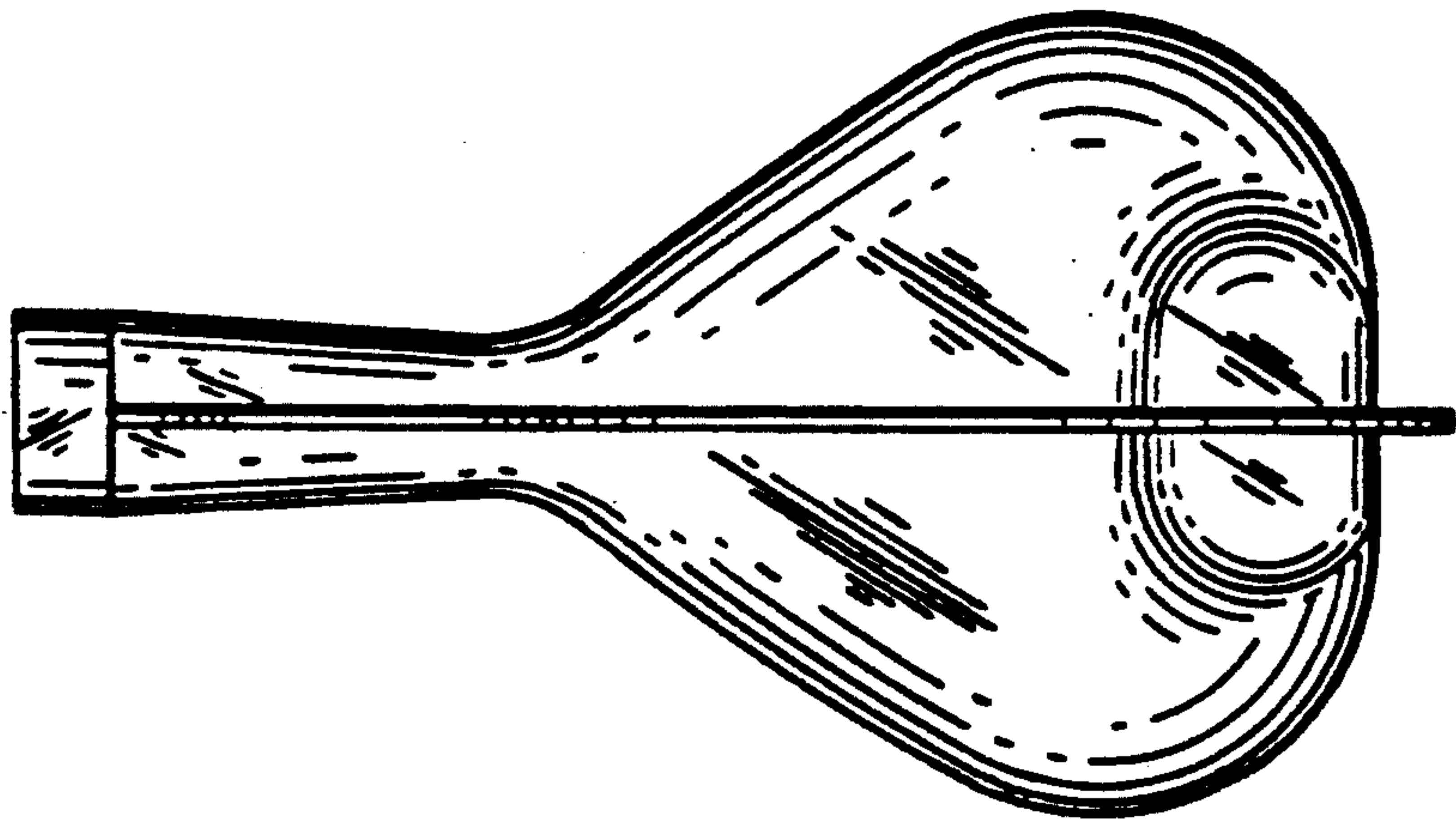

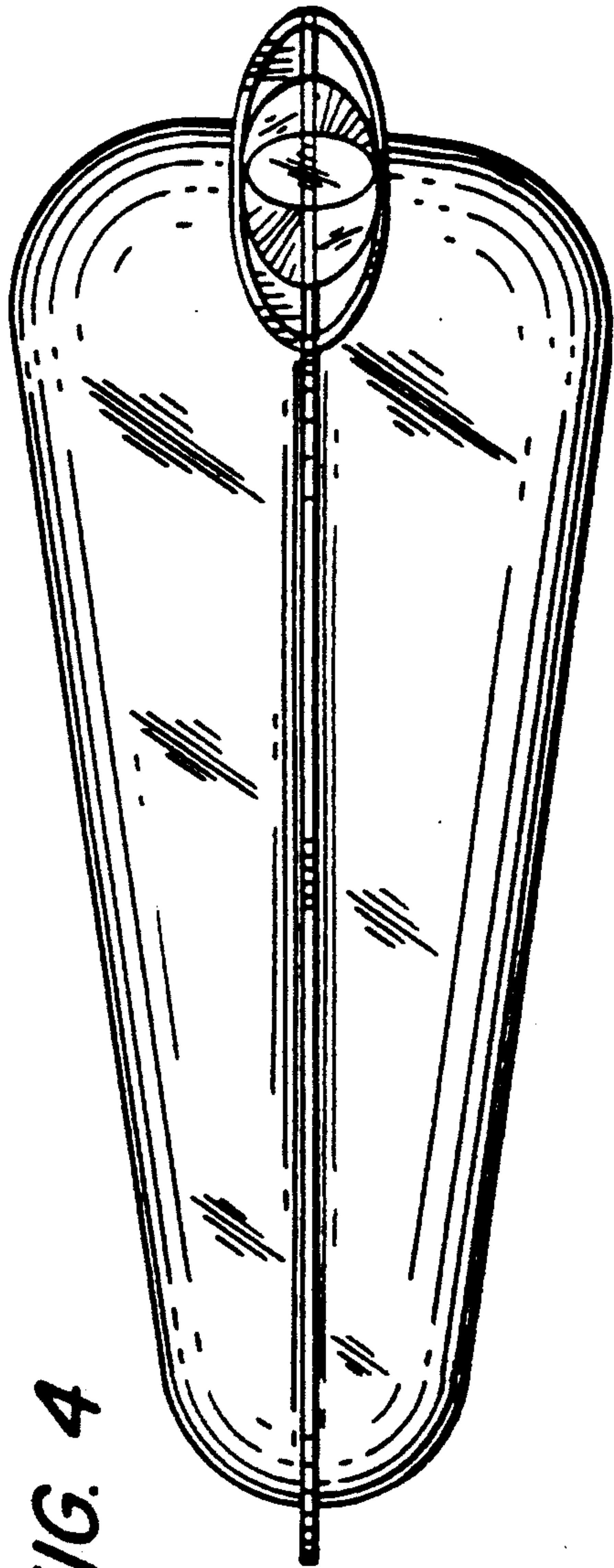

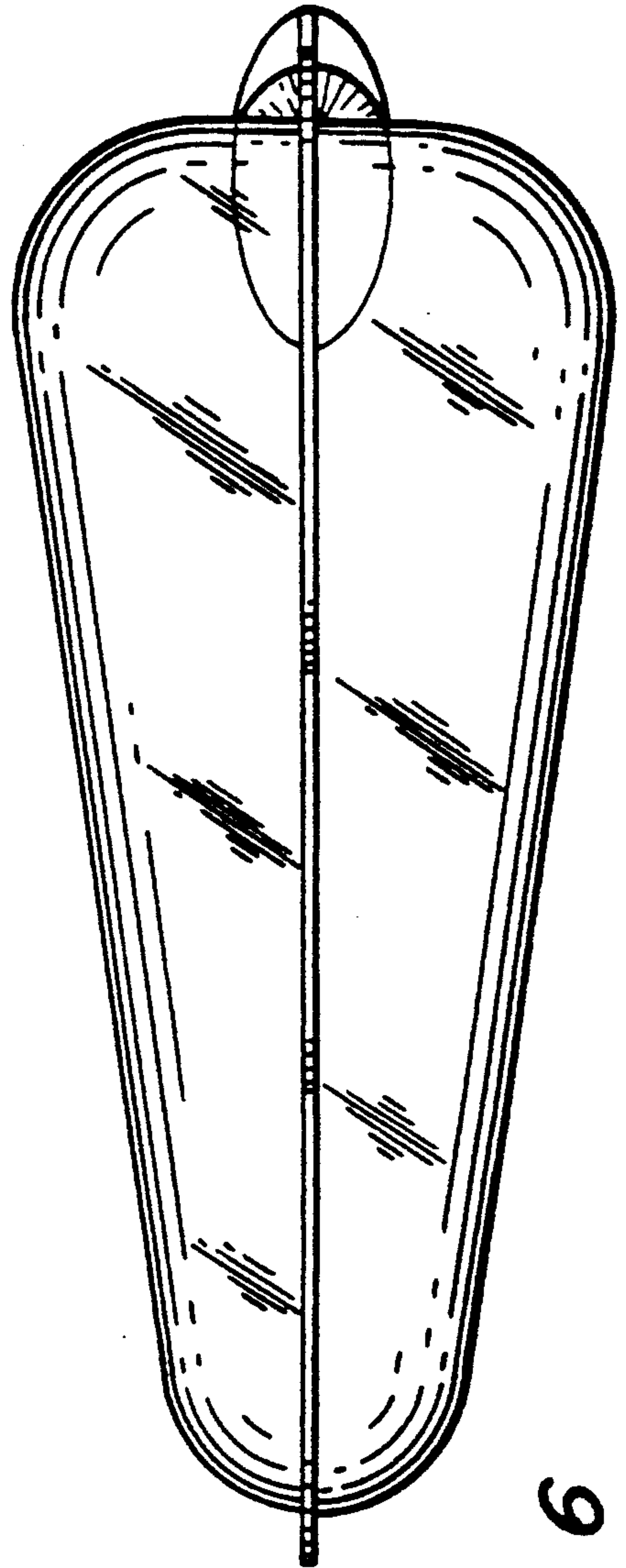

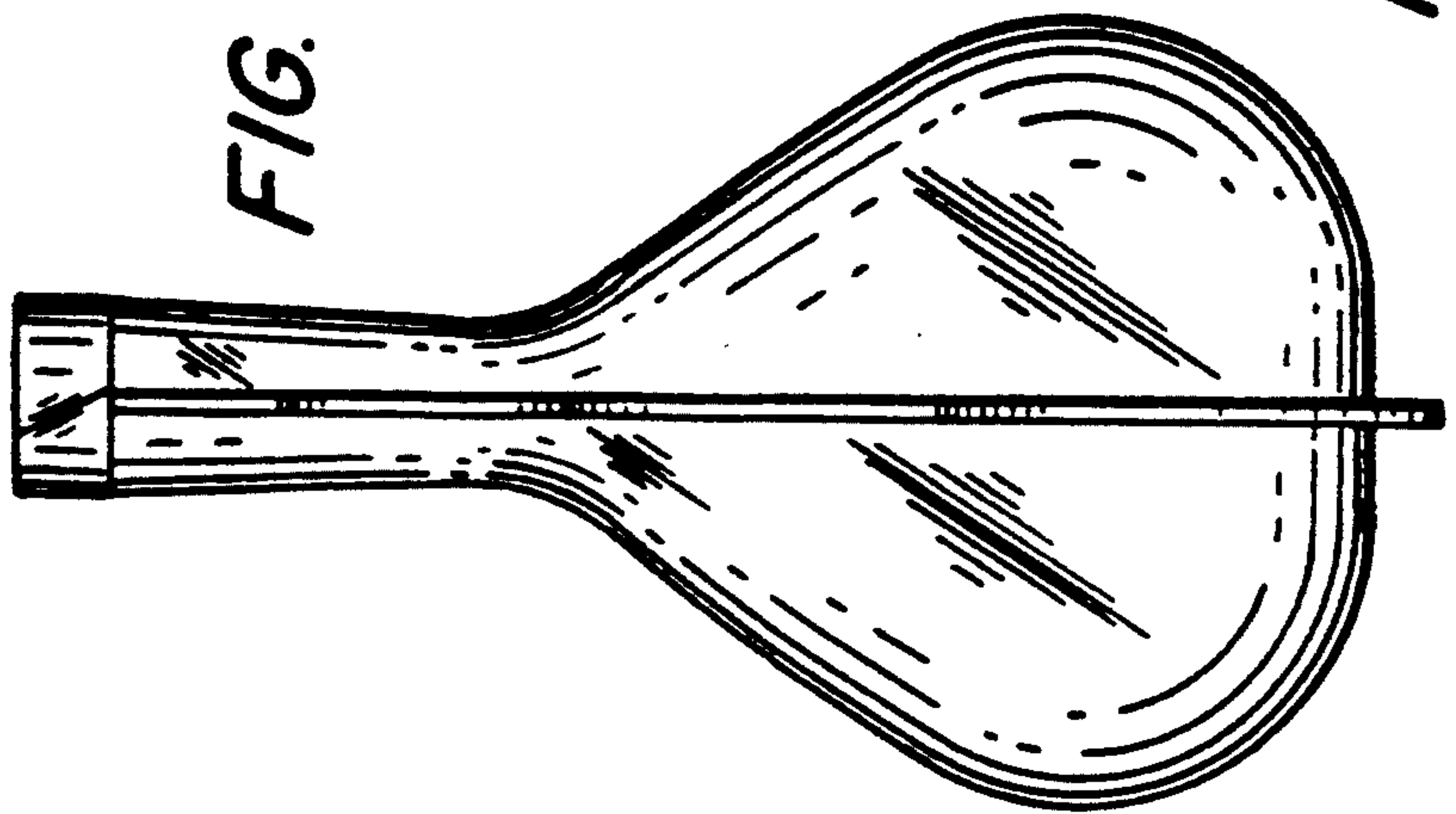

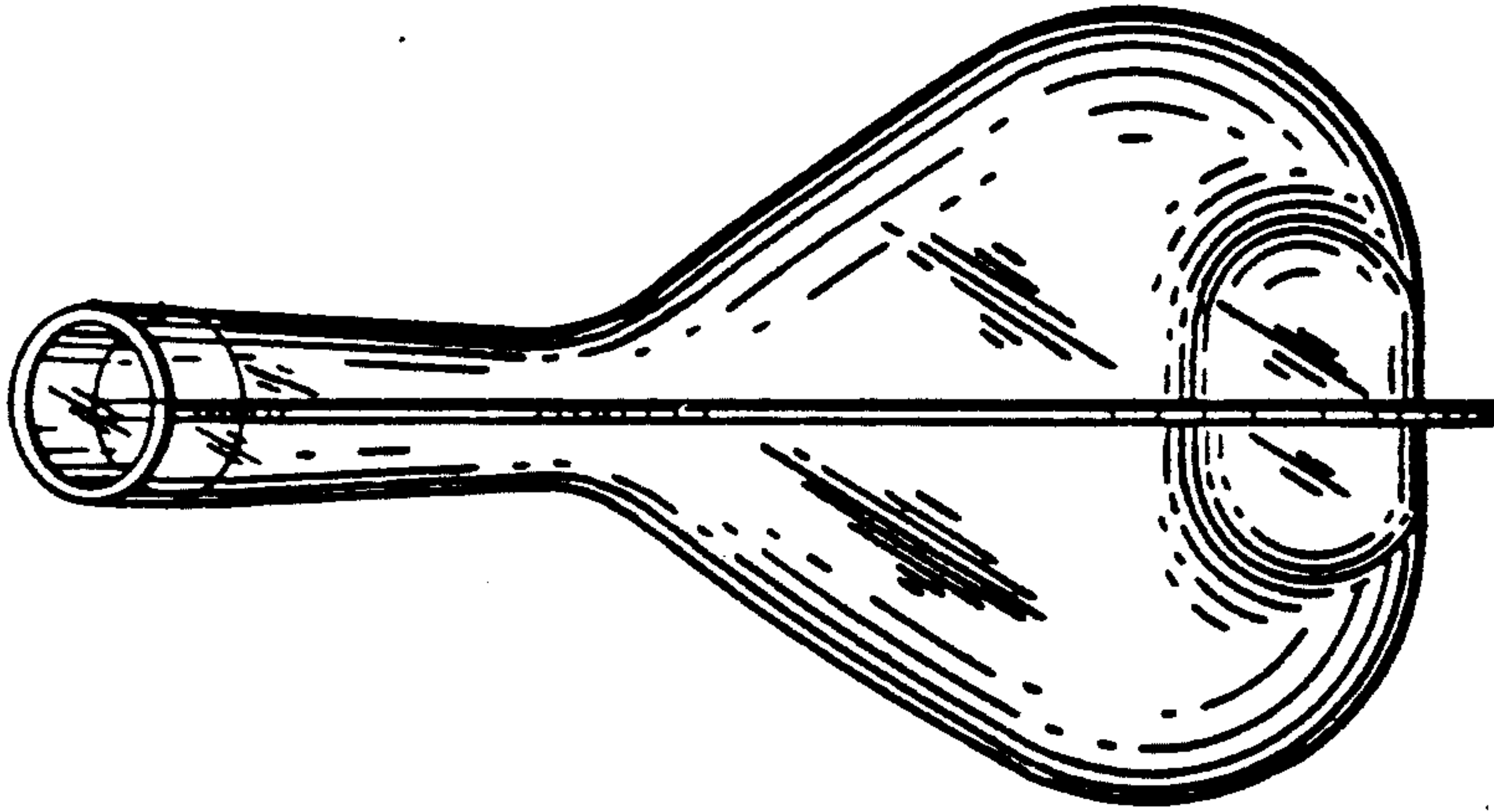

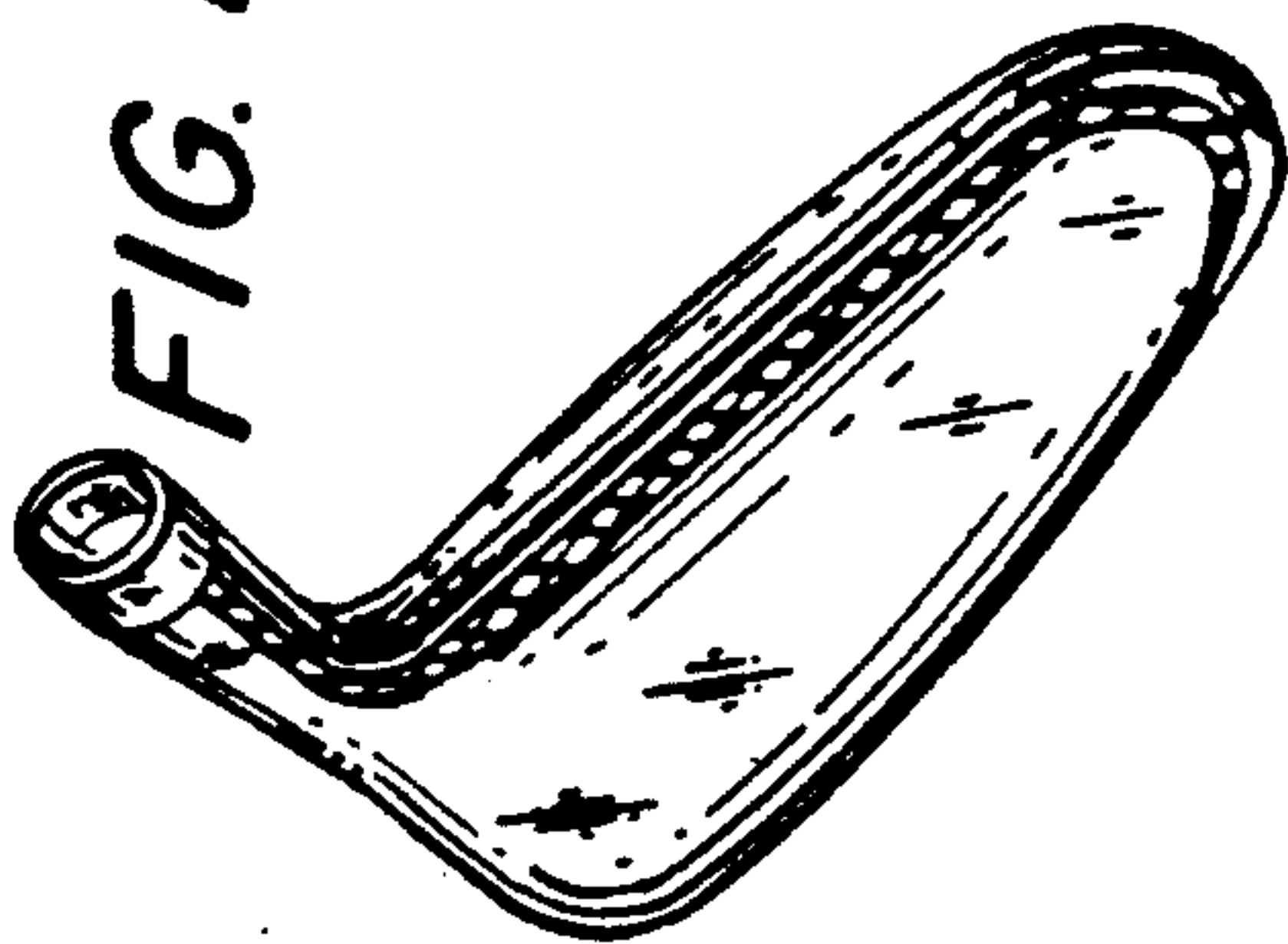
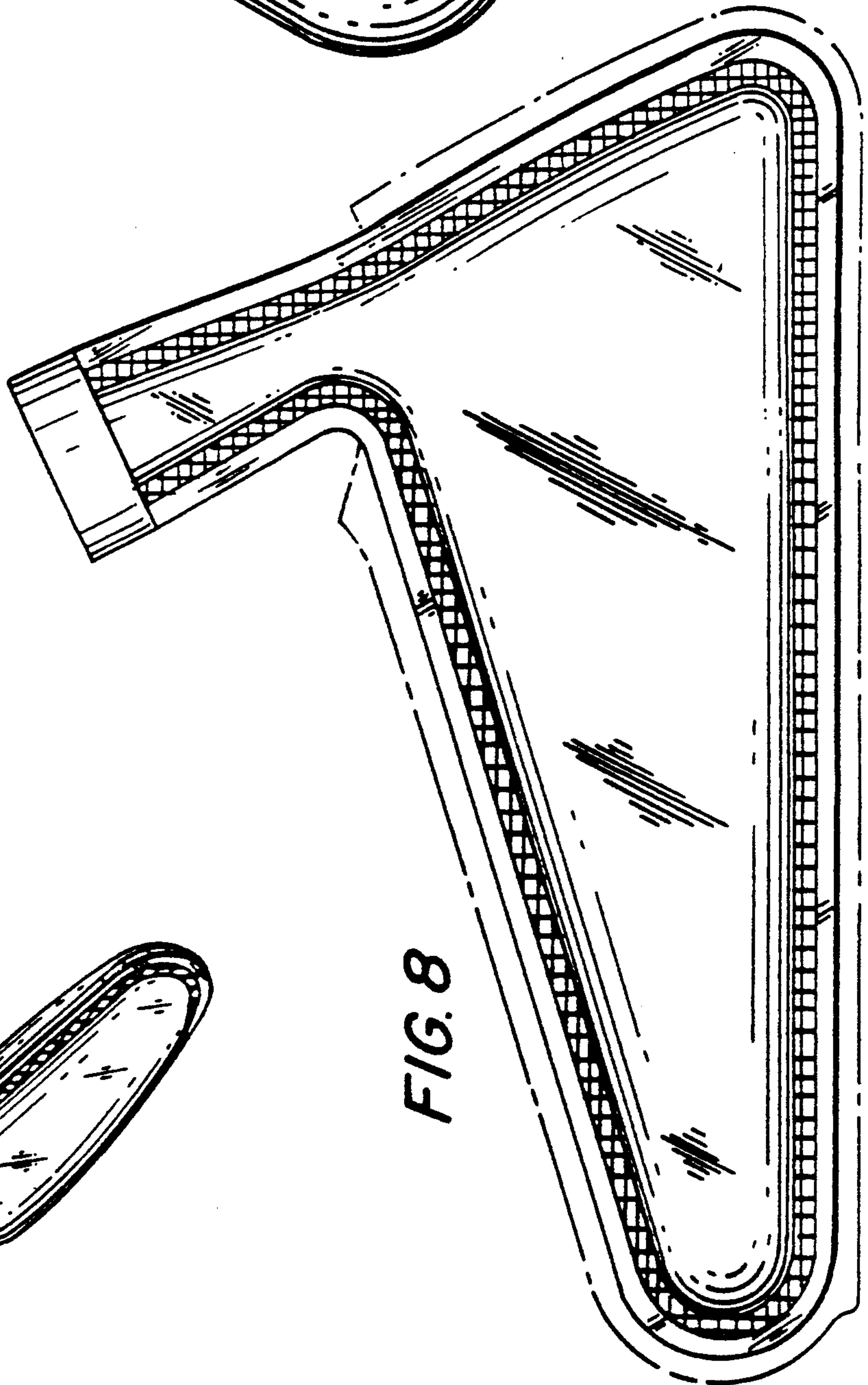

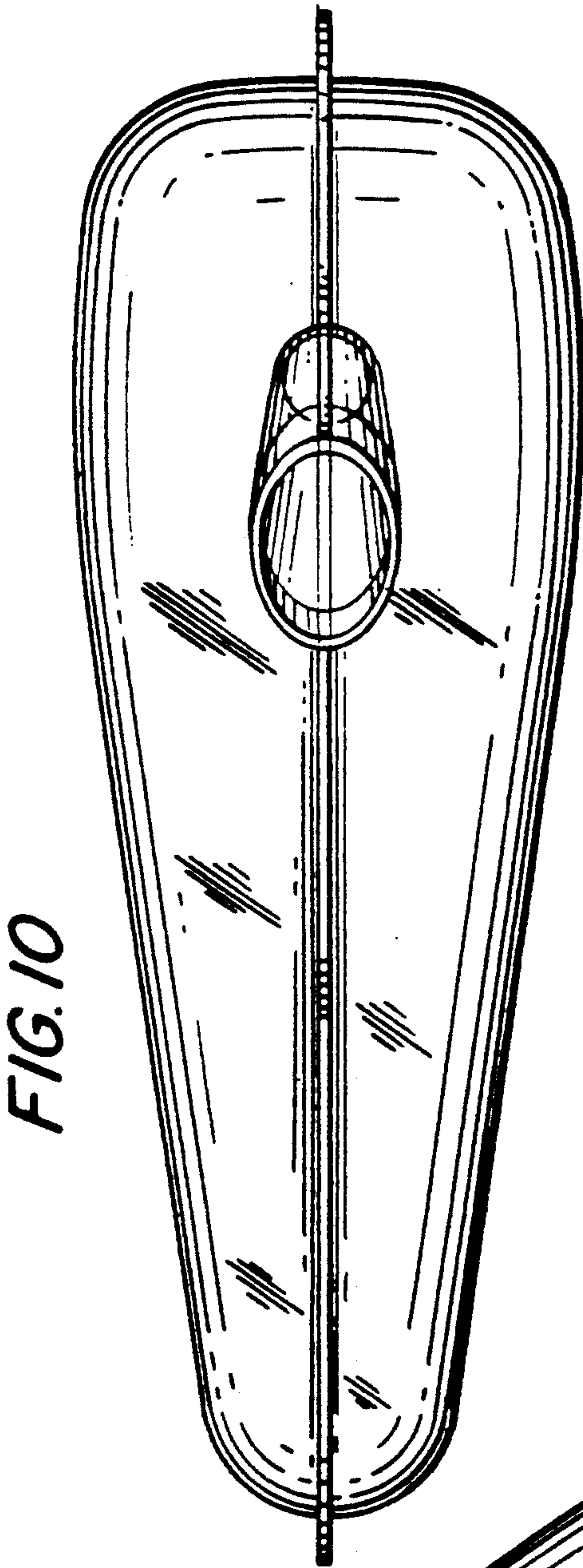

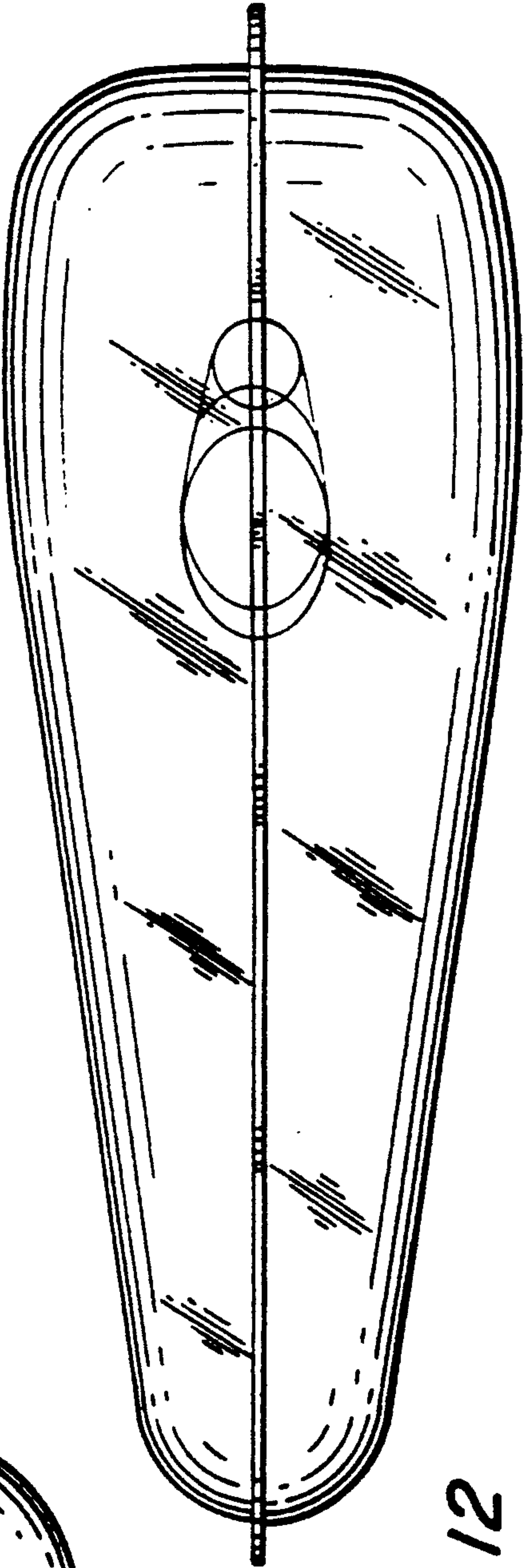

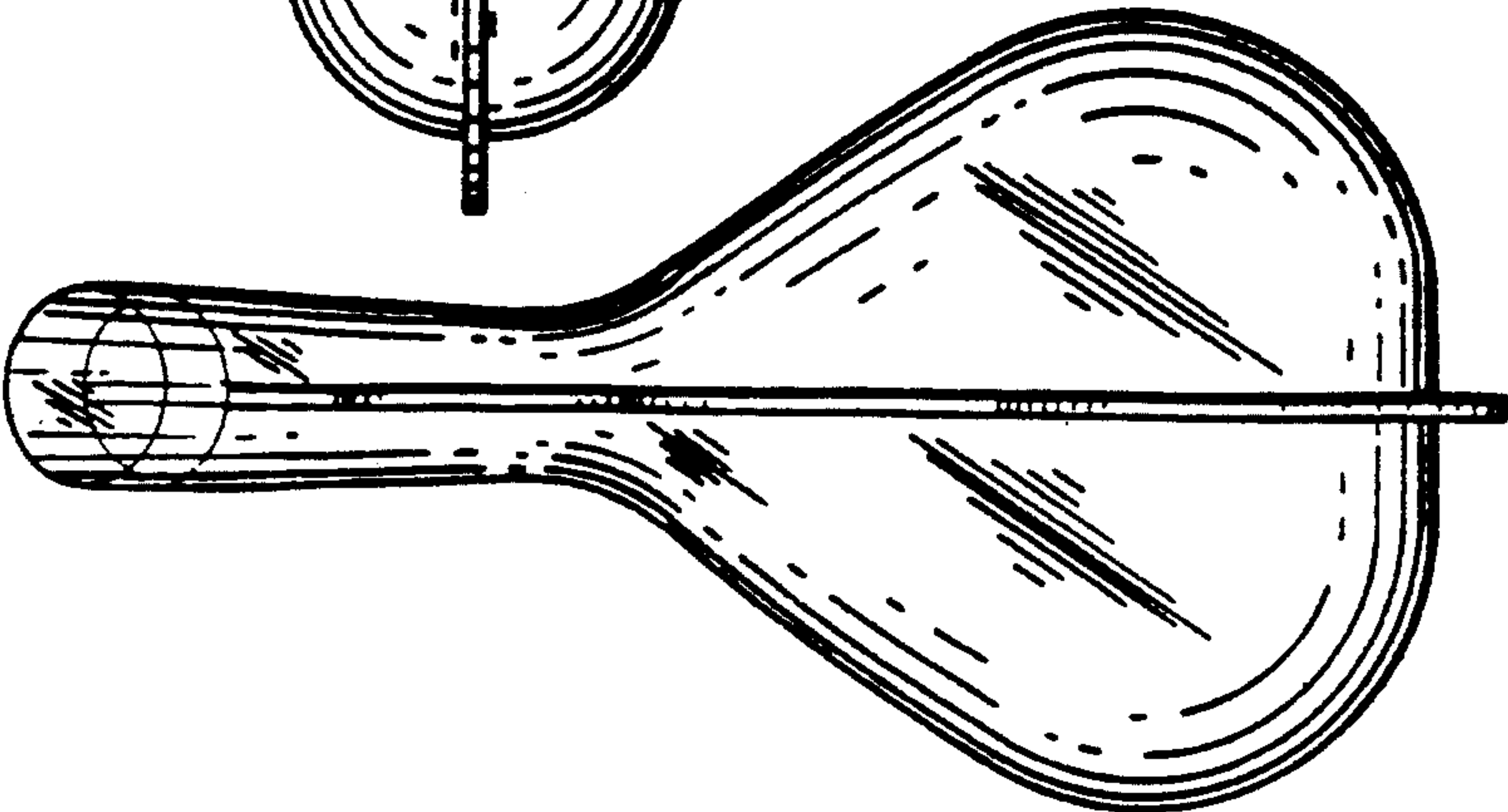

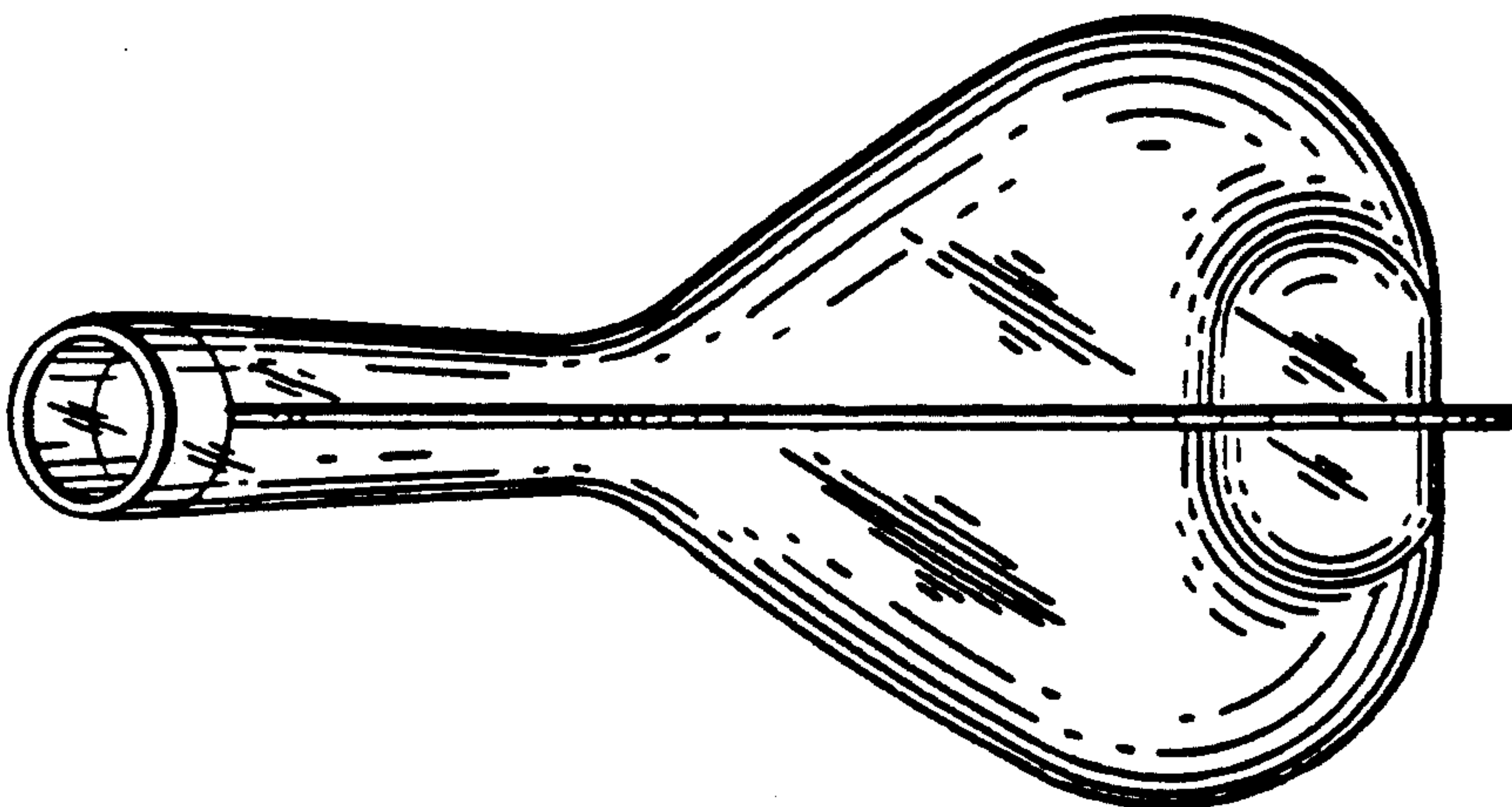

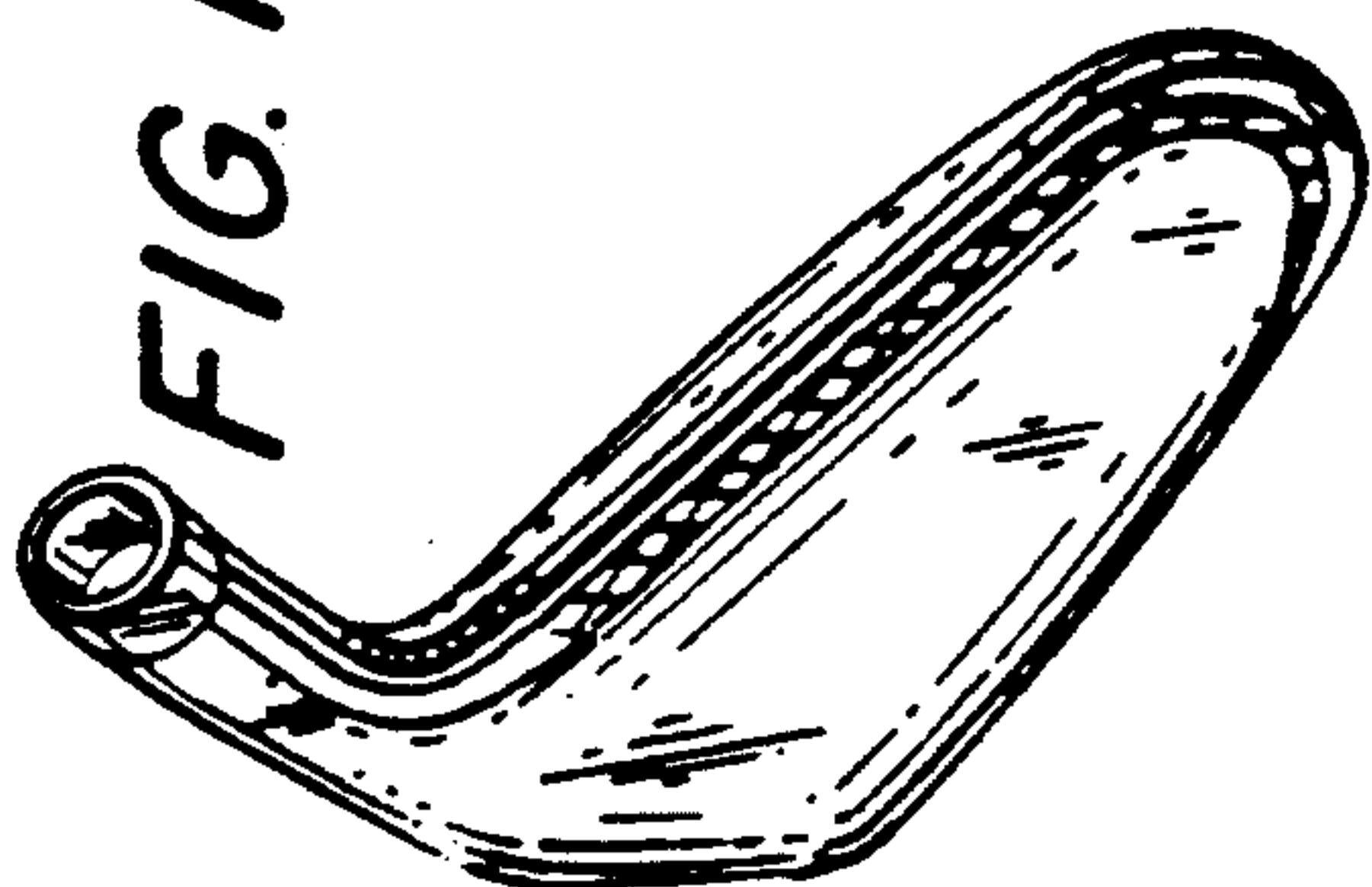
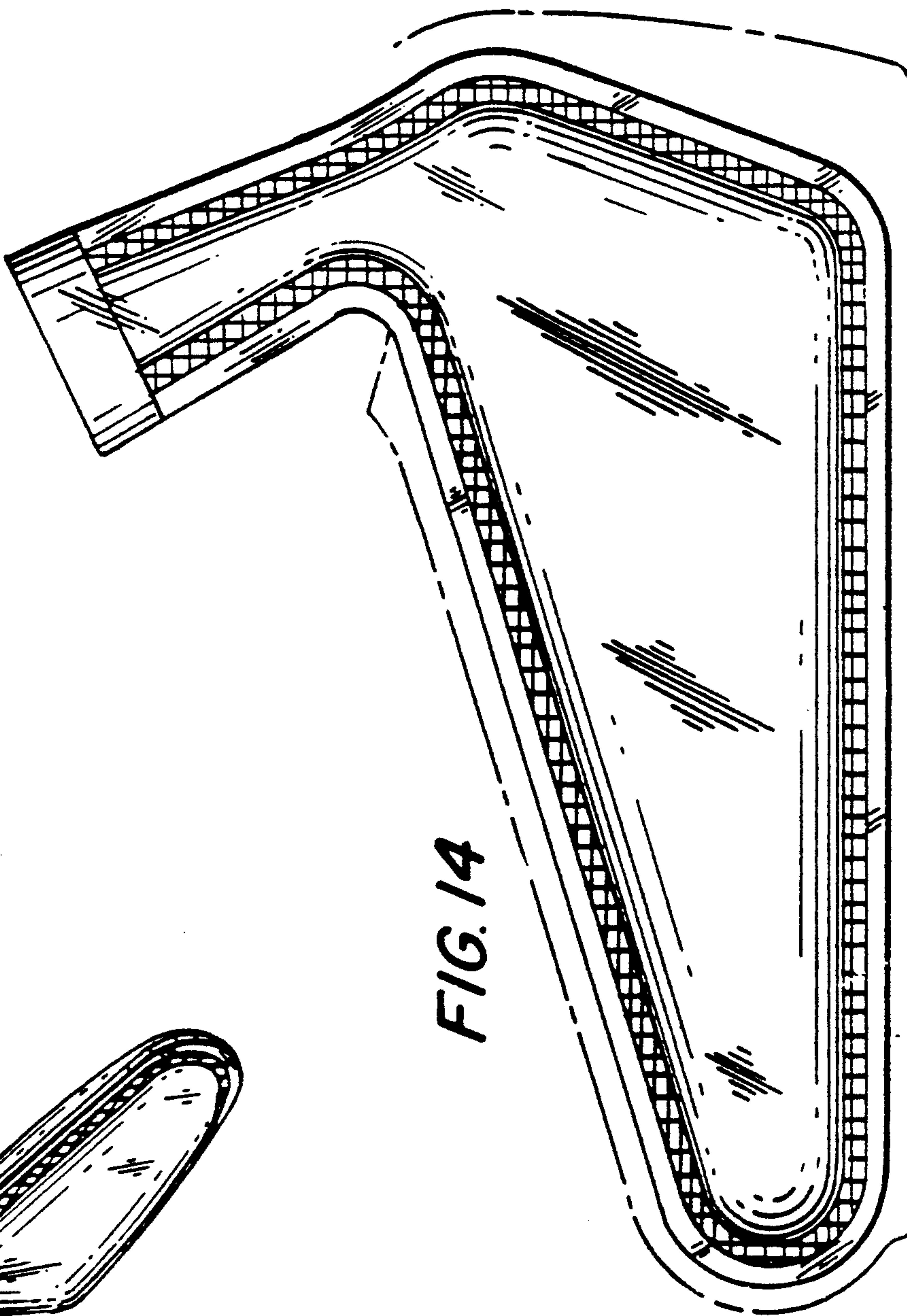

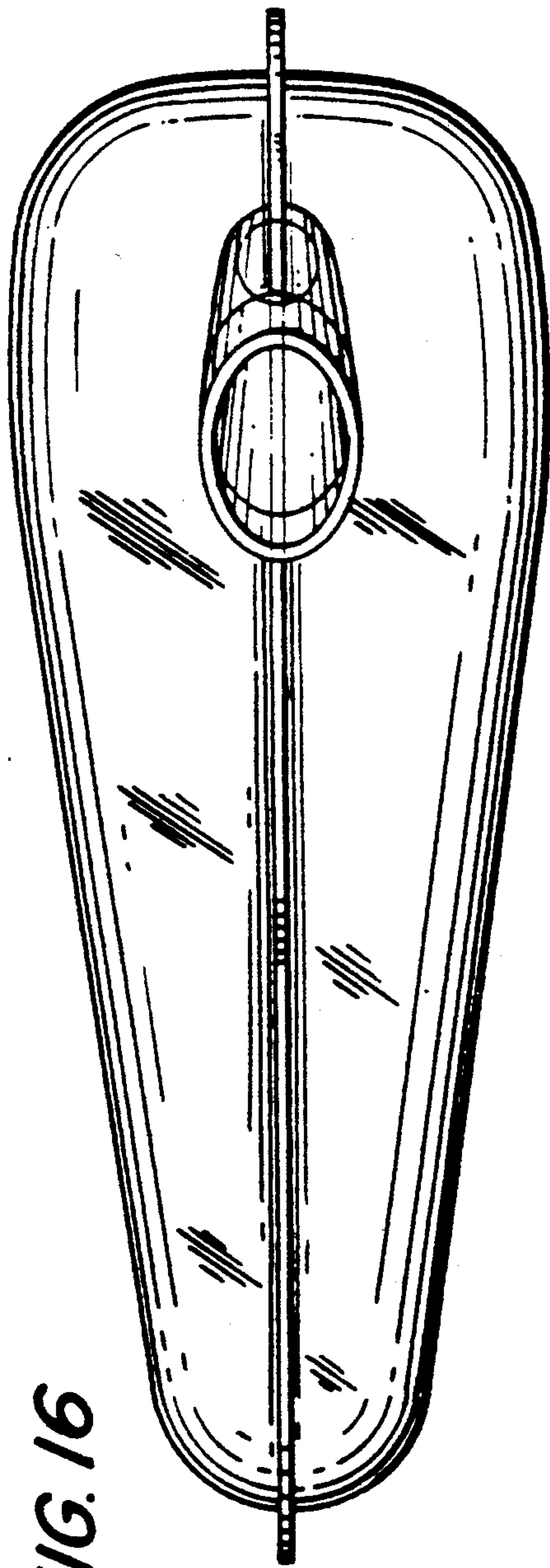

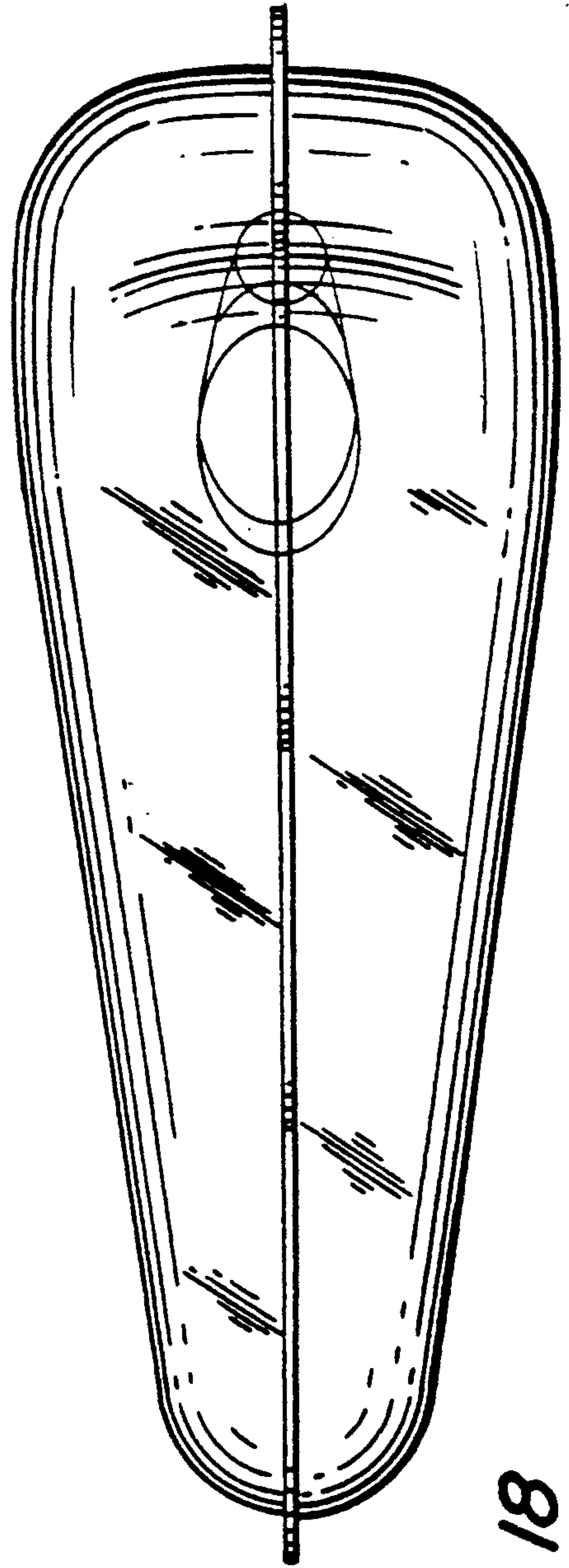

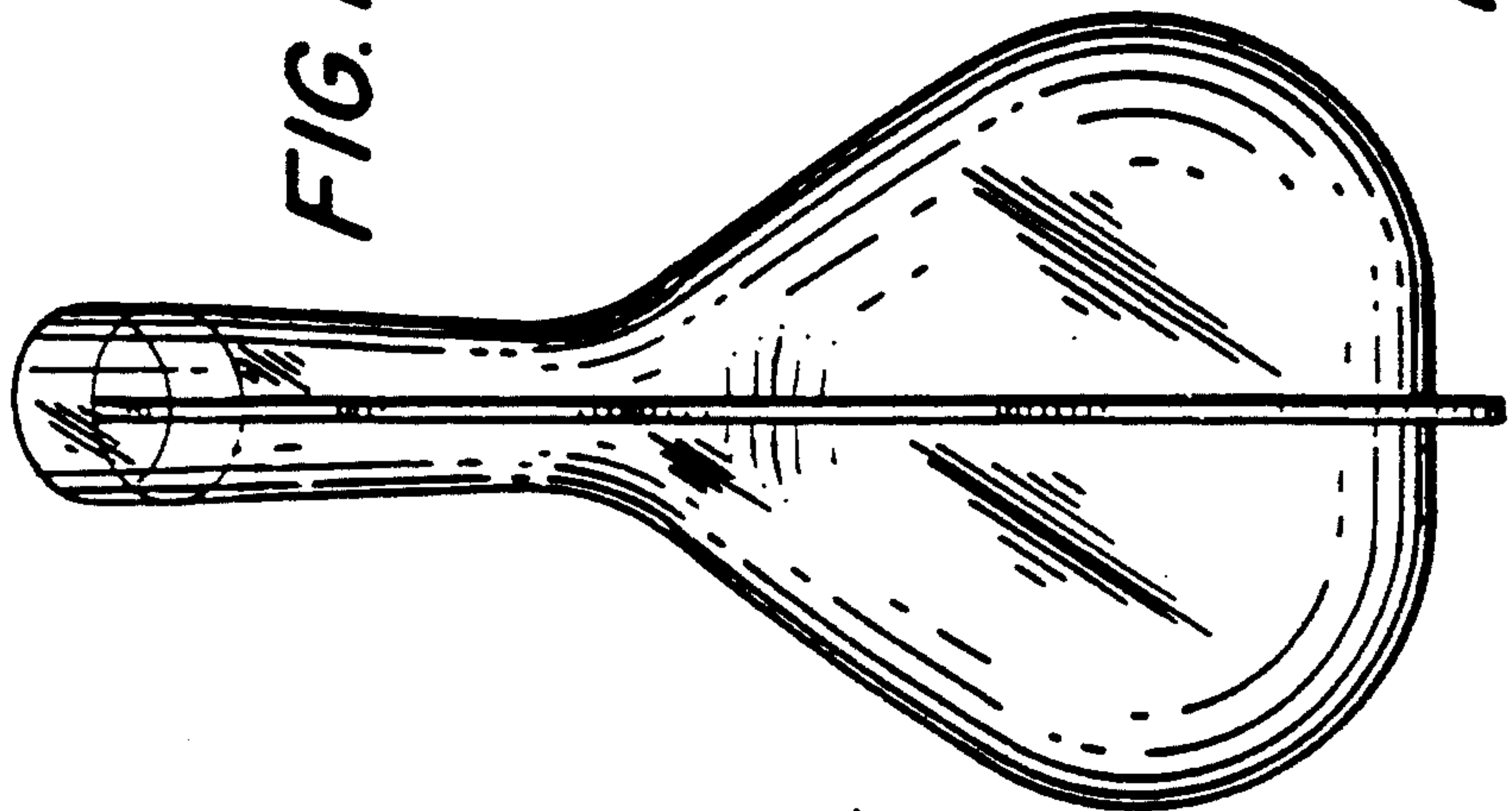
