FIG. 1 is a top plan view of table top showcase showing my new design;

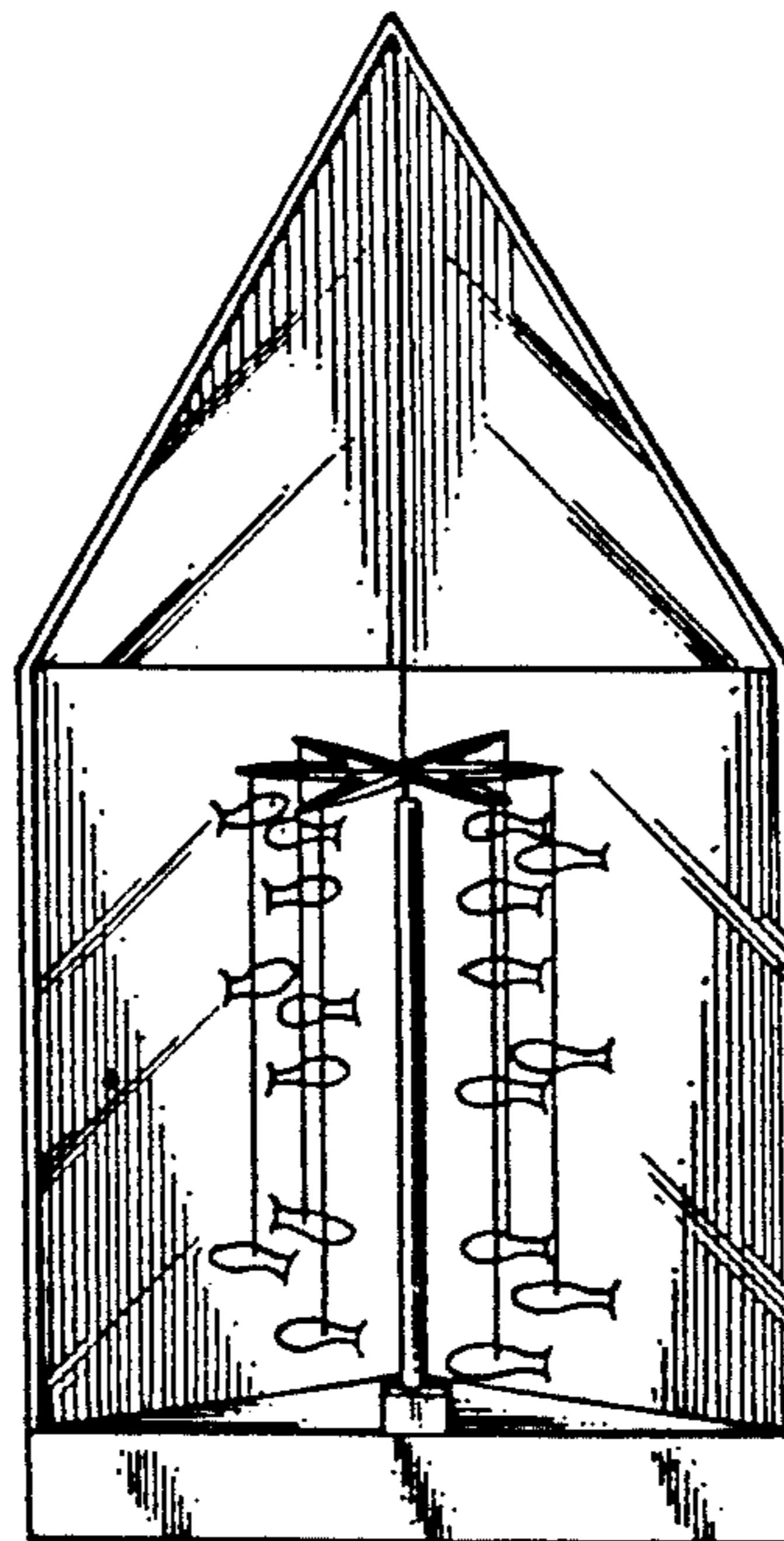
FIG. 2 is a bottom plan view thereof;

FIG. 6 is a side elevational view thereof showing the opposite side of FIG. 4.



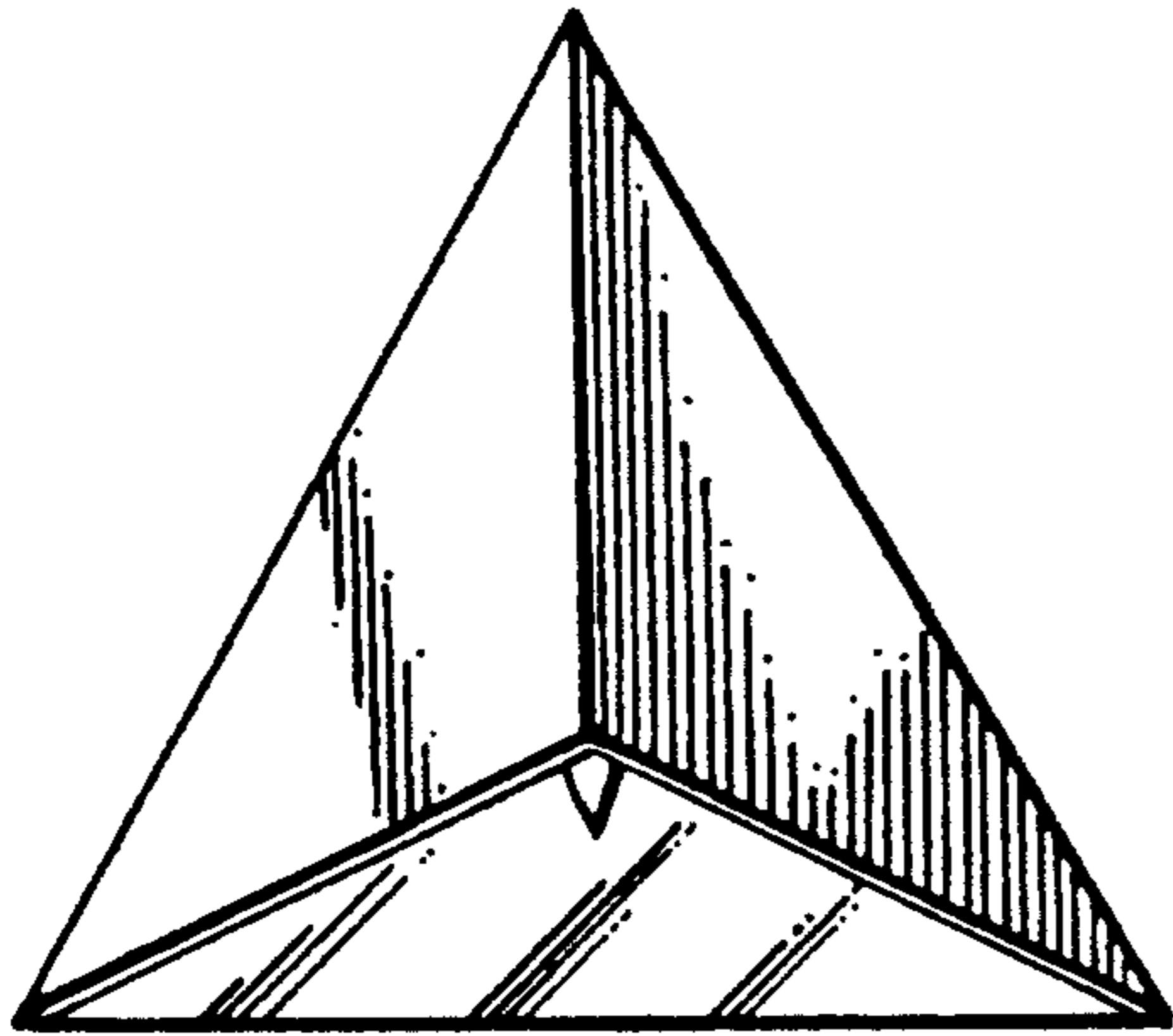

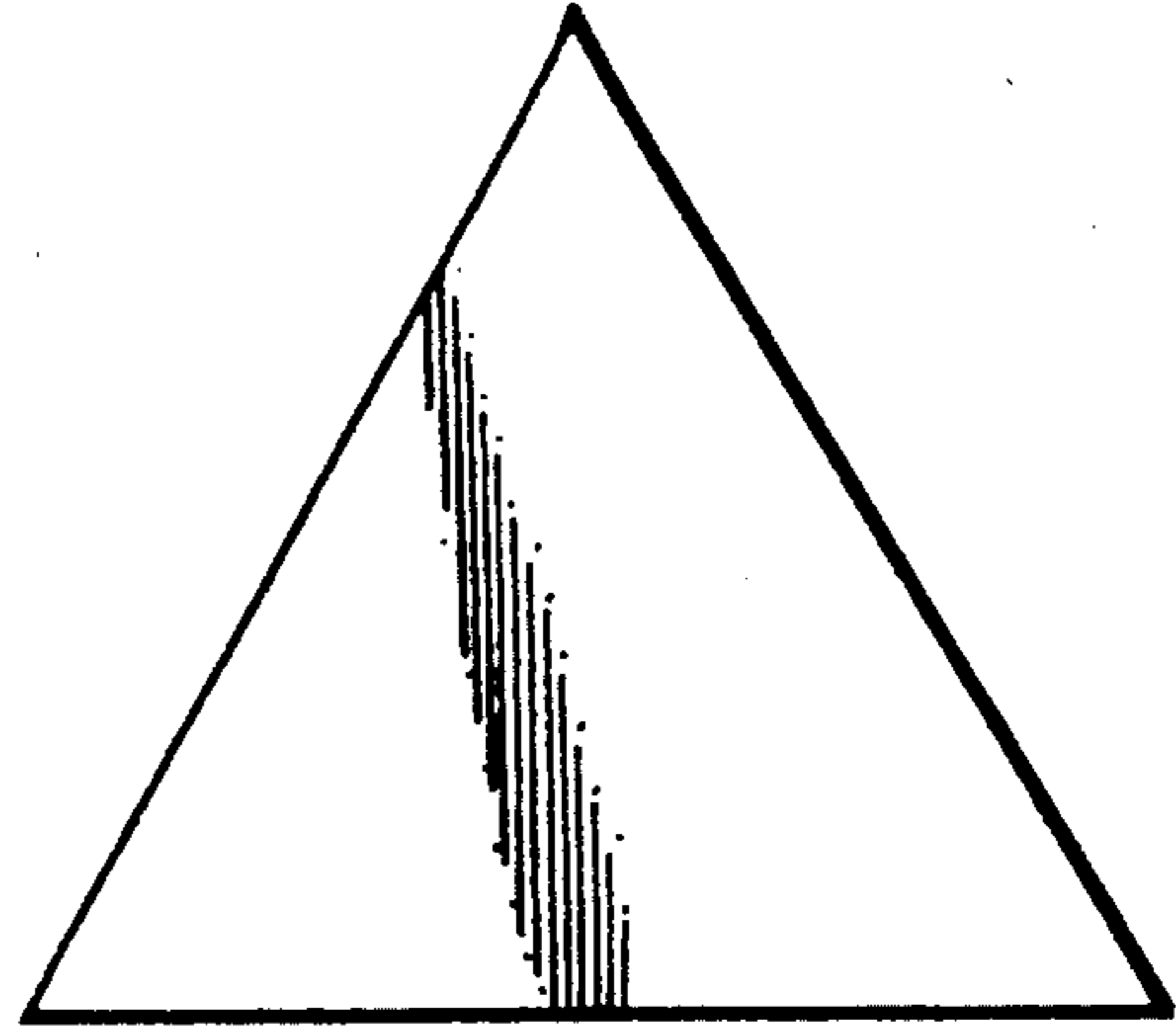

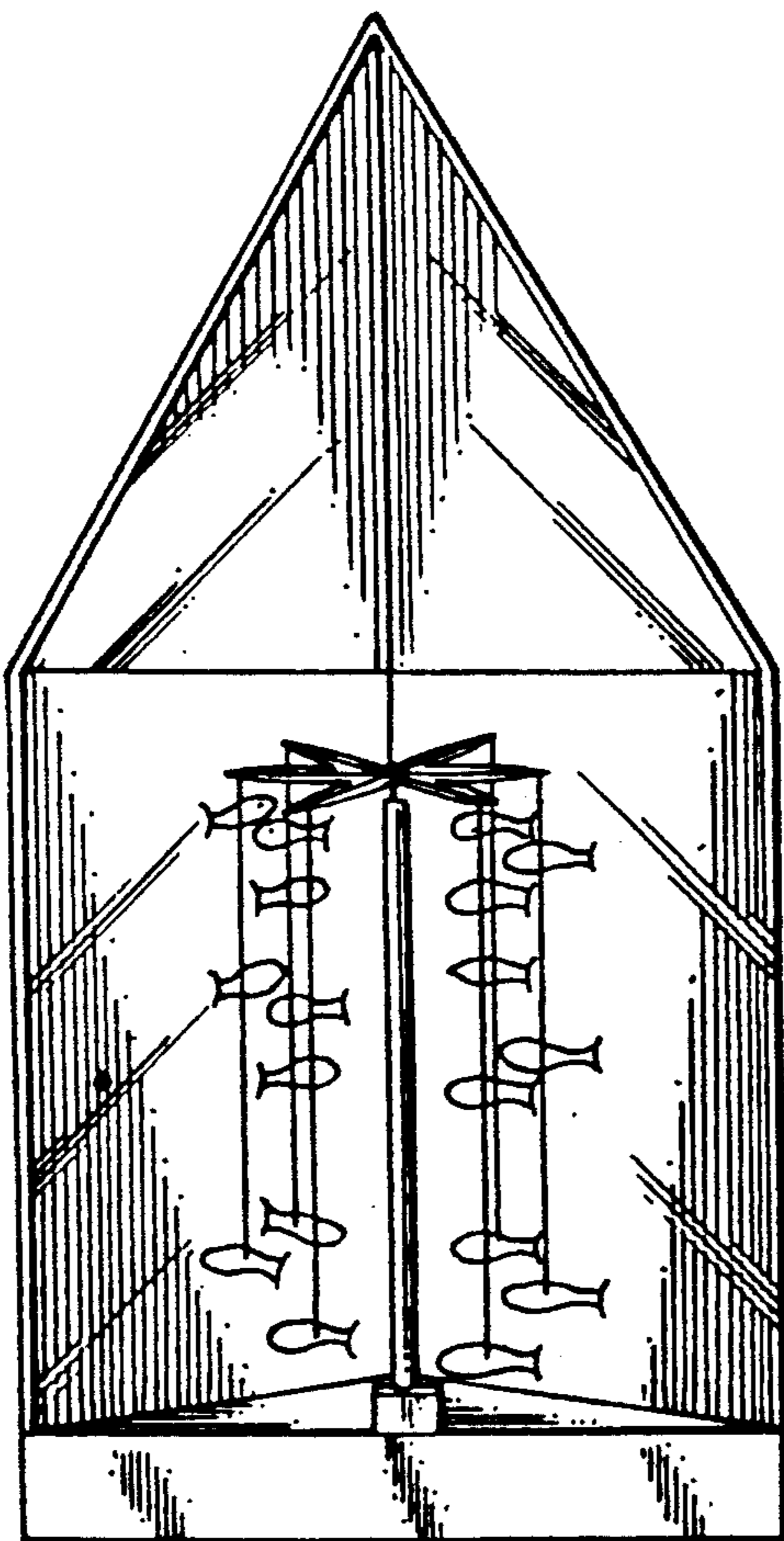

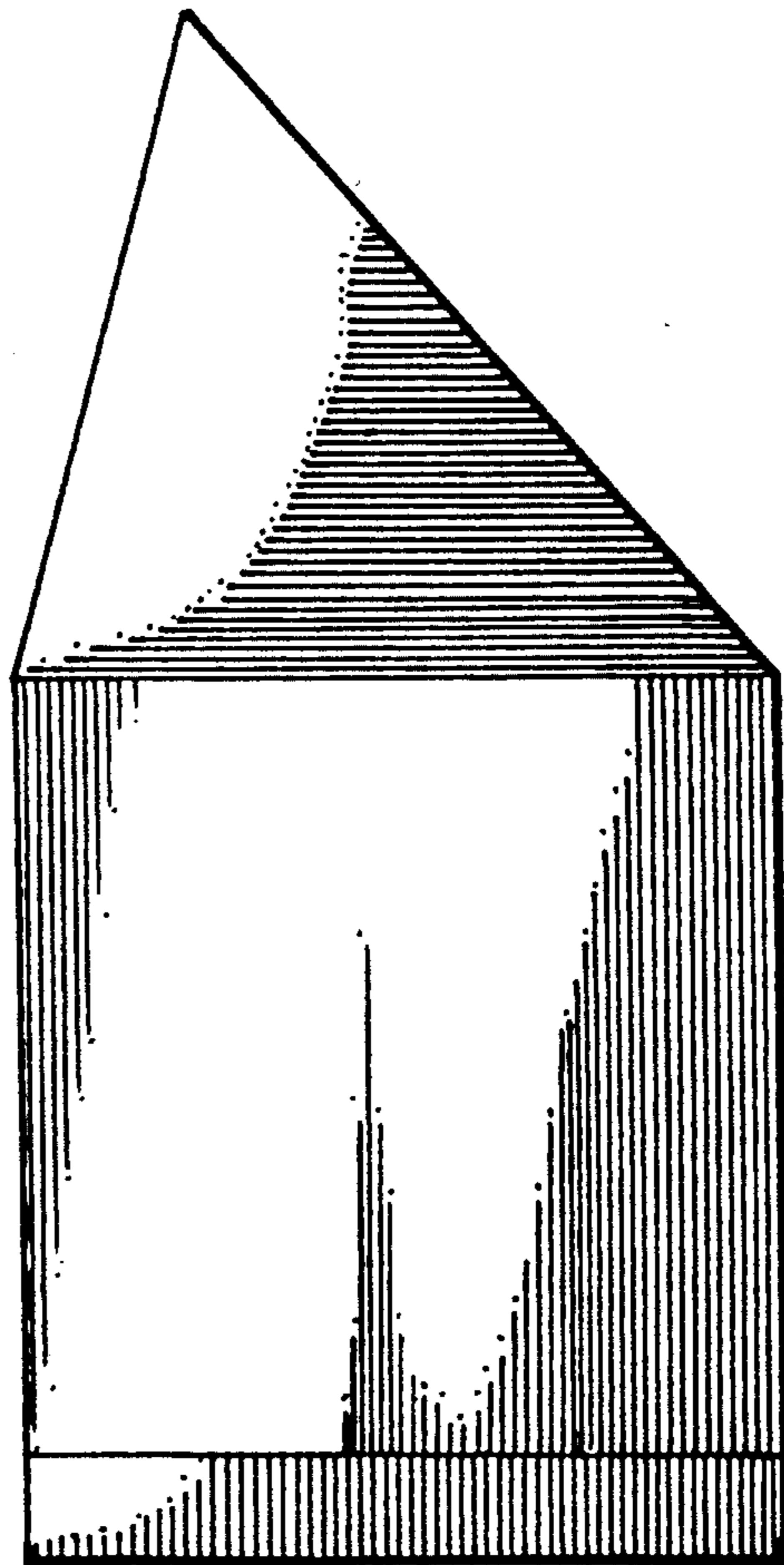

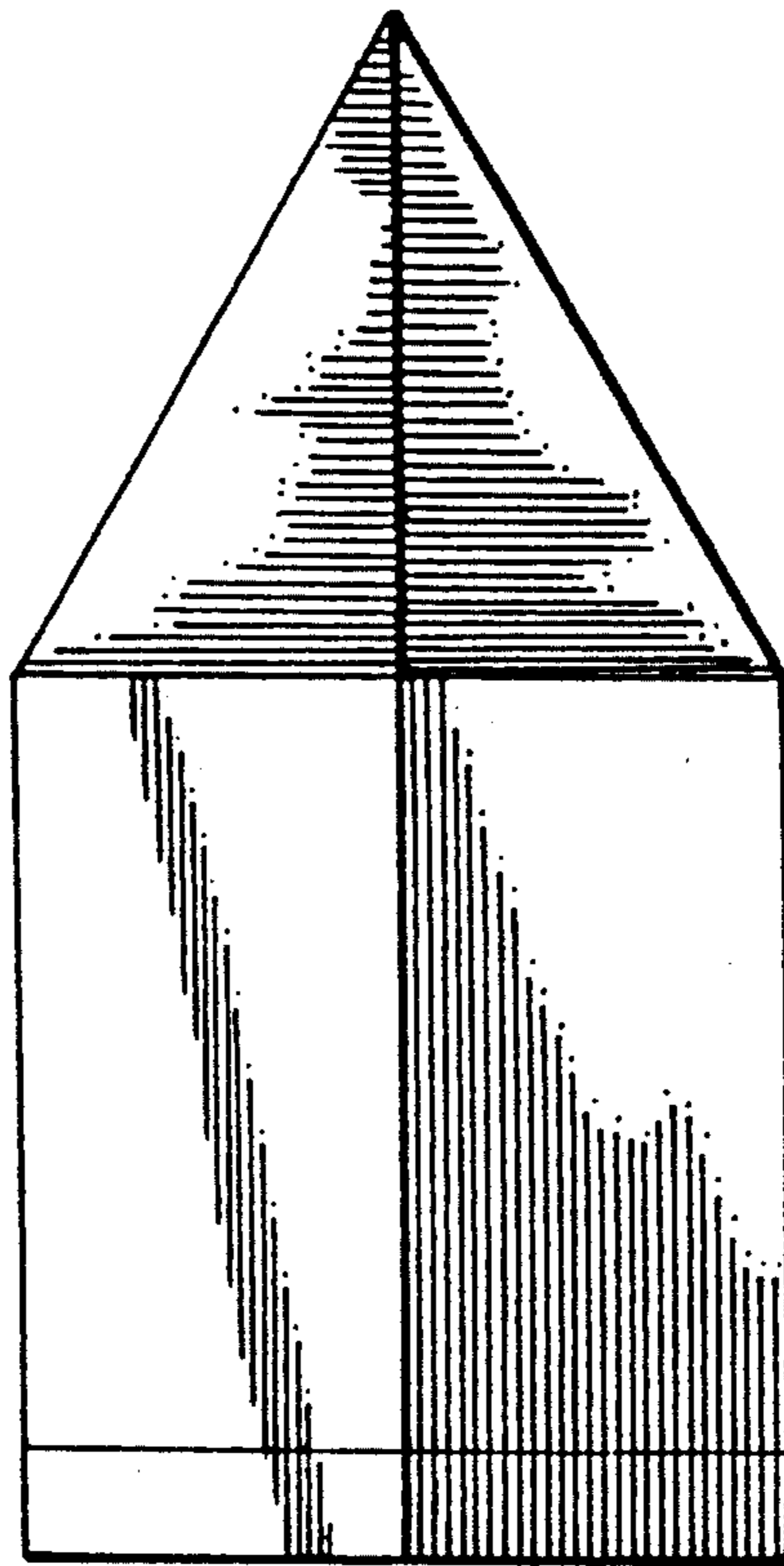

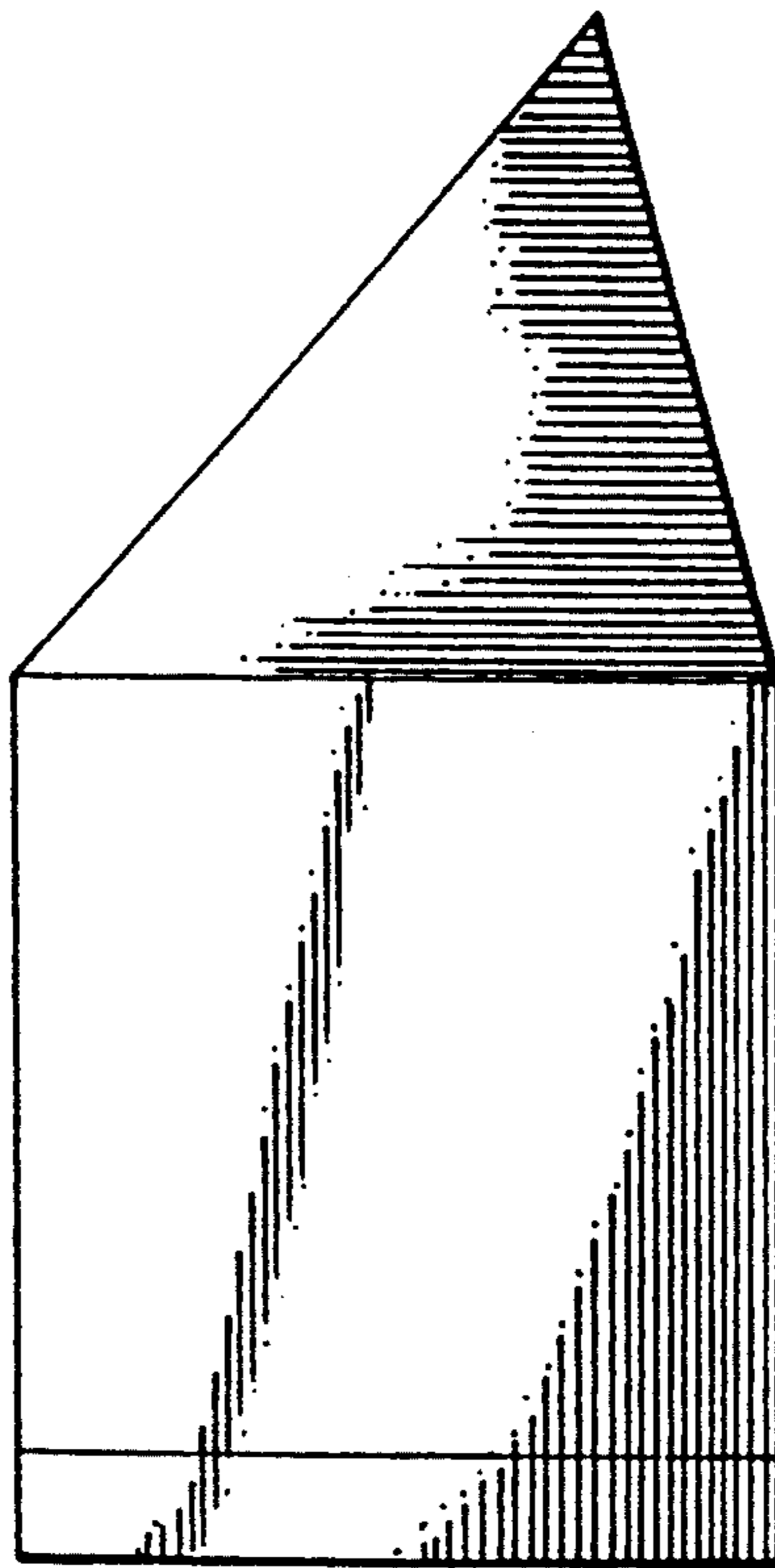
