





The ornamental design for a gravure roll or similar article, as shown and described.

**DESCRIPTION****FIG. 1** is a front elevational view of a gravure roll or similar article showing my new design, the opposite side being identical;**FIG. 2** is a top plan view, the opposite side being identical;**FIG. 3** is an end elevational view, the opposite side being identical;**FIG. 4** is an enlarged partial view of the pattern shown in a flattened condition; and,**FIG. 5** is a sectional view taken along lines 5—5.




