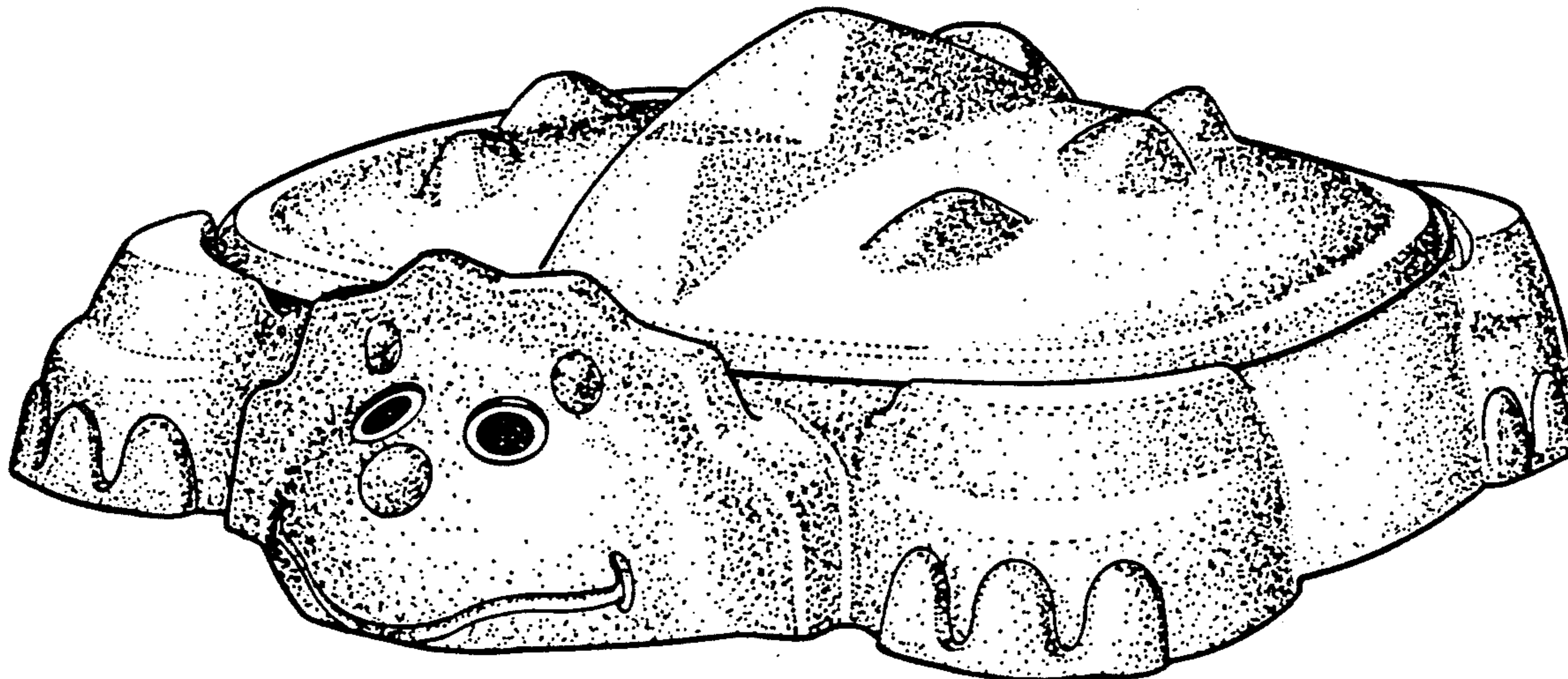

[57] CLAIM

The ornamental design for a sandbox, as shown and described.

DESCRIPTION

FIG. 1 is a top right front perspective view of a sandbox showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a right side elevational view thereof; the opposite side being a mirror image;
FIG. 5 is a top plan view thereof;
FIG. 6 is a top right front view of the base of the sandbox shown with the lid removed;
FIG. 7 is a front elevational view of the sandbox base;
FIG. 8 is a rear elevational view of the sandbox base;
FIG. 9 is a right side elevational view of the sandbox base; the opposite side being a mirror image; and,
FIG. 10 is a top plan view of the sandbox base.



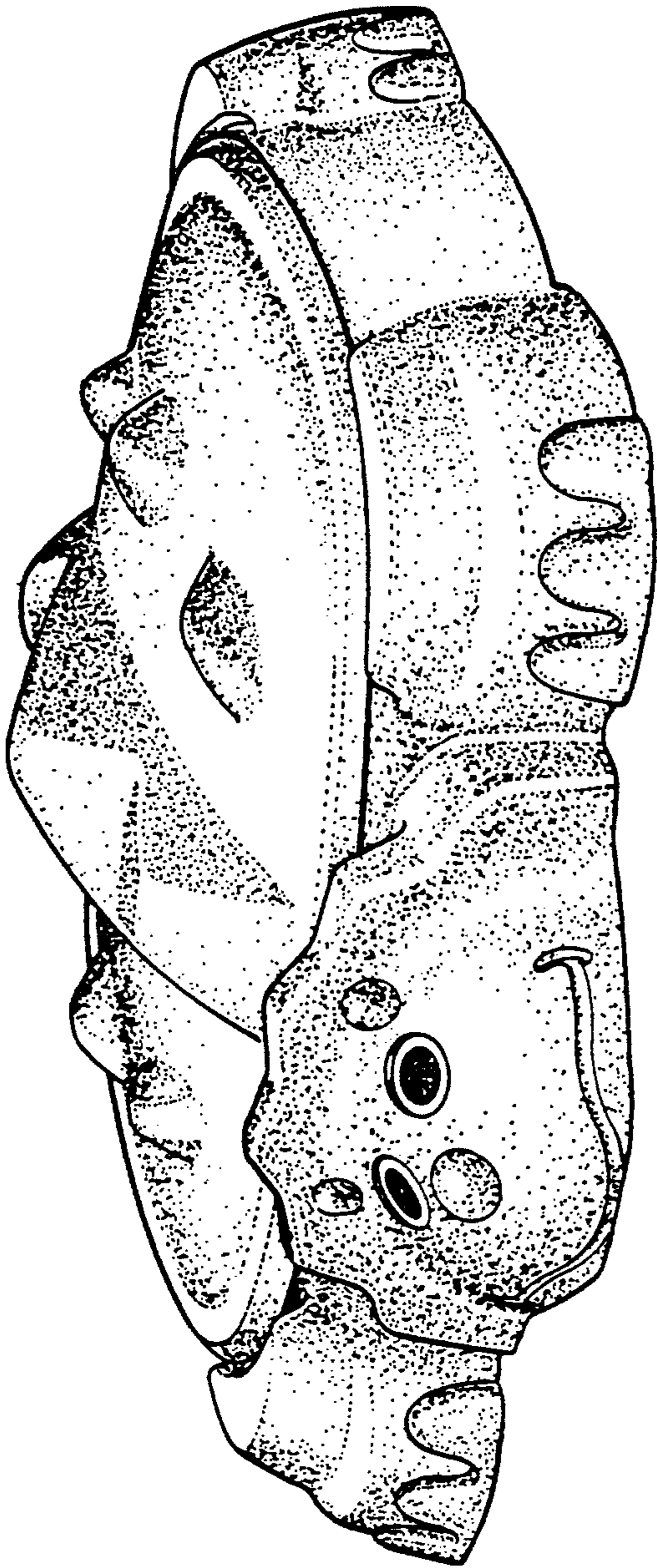

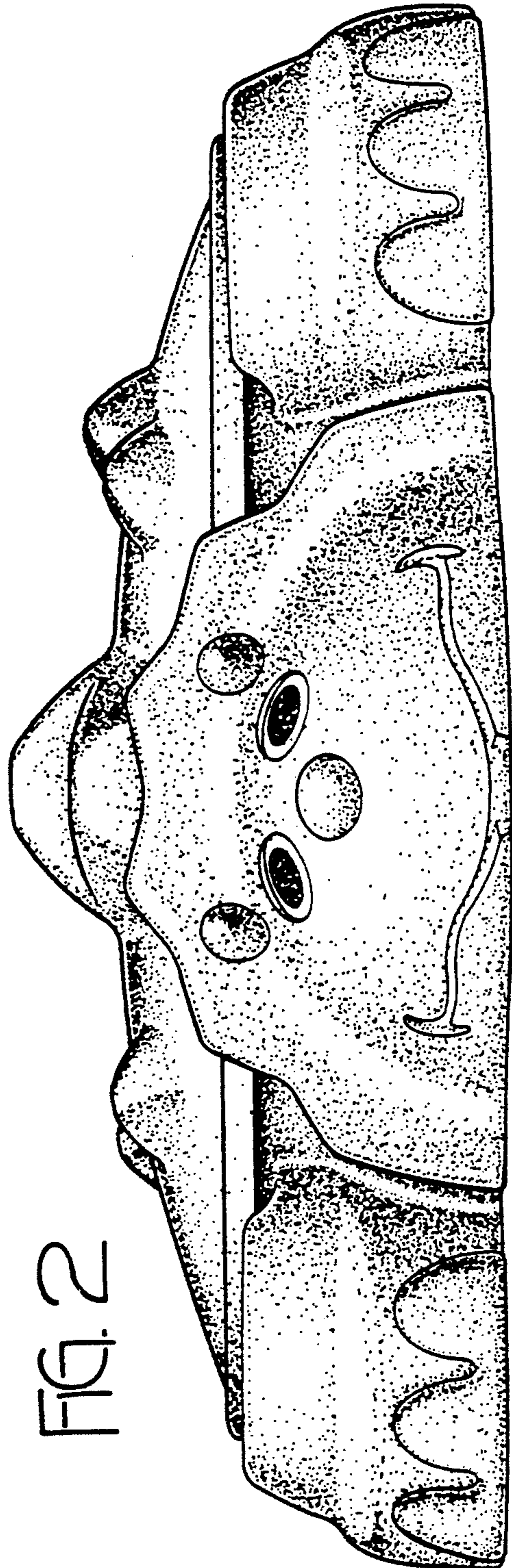

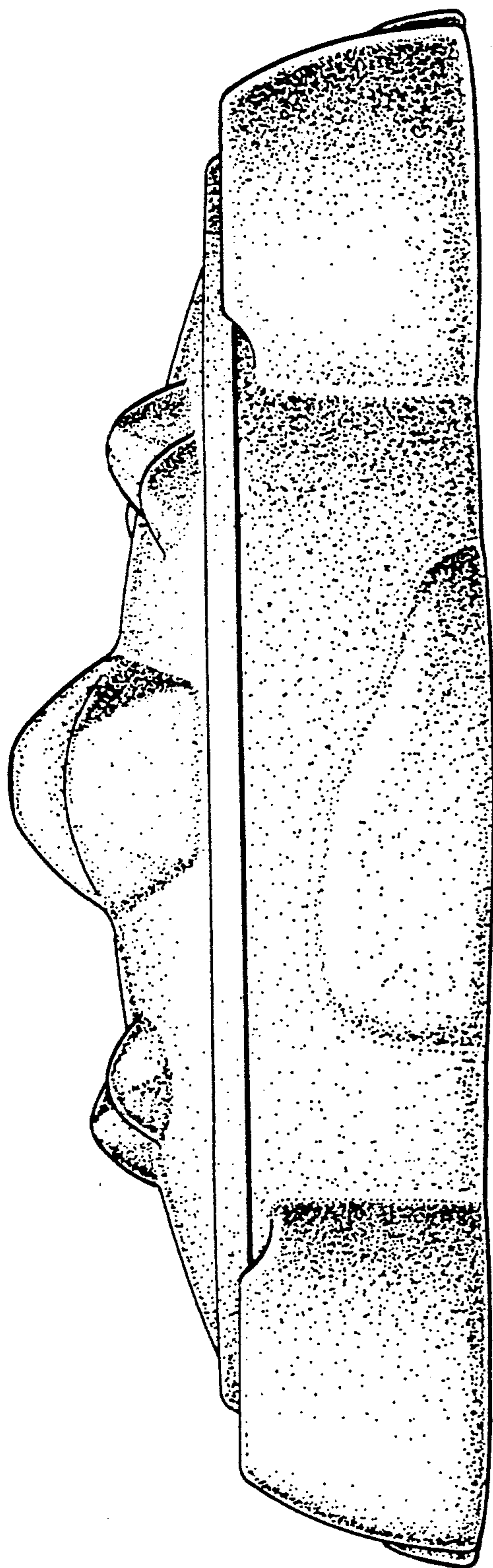

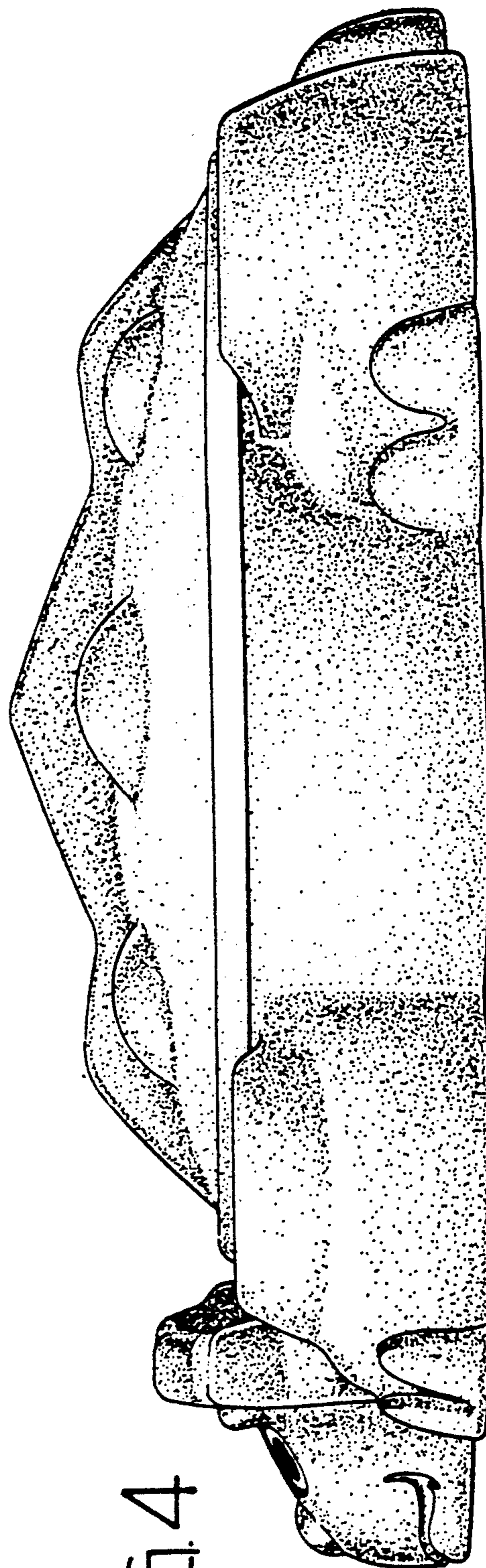

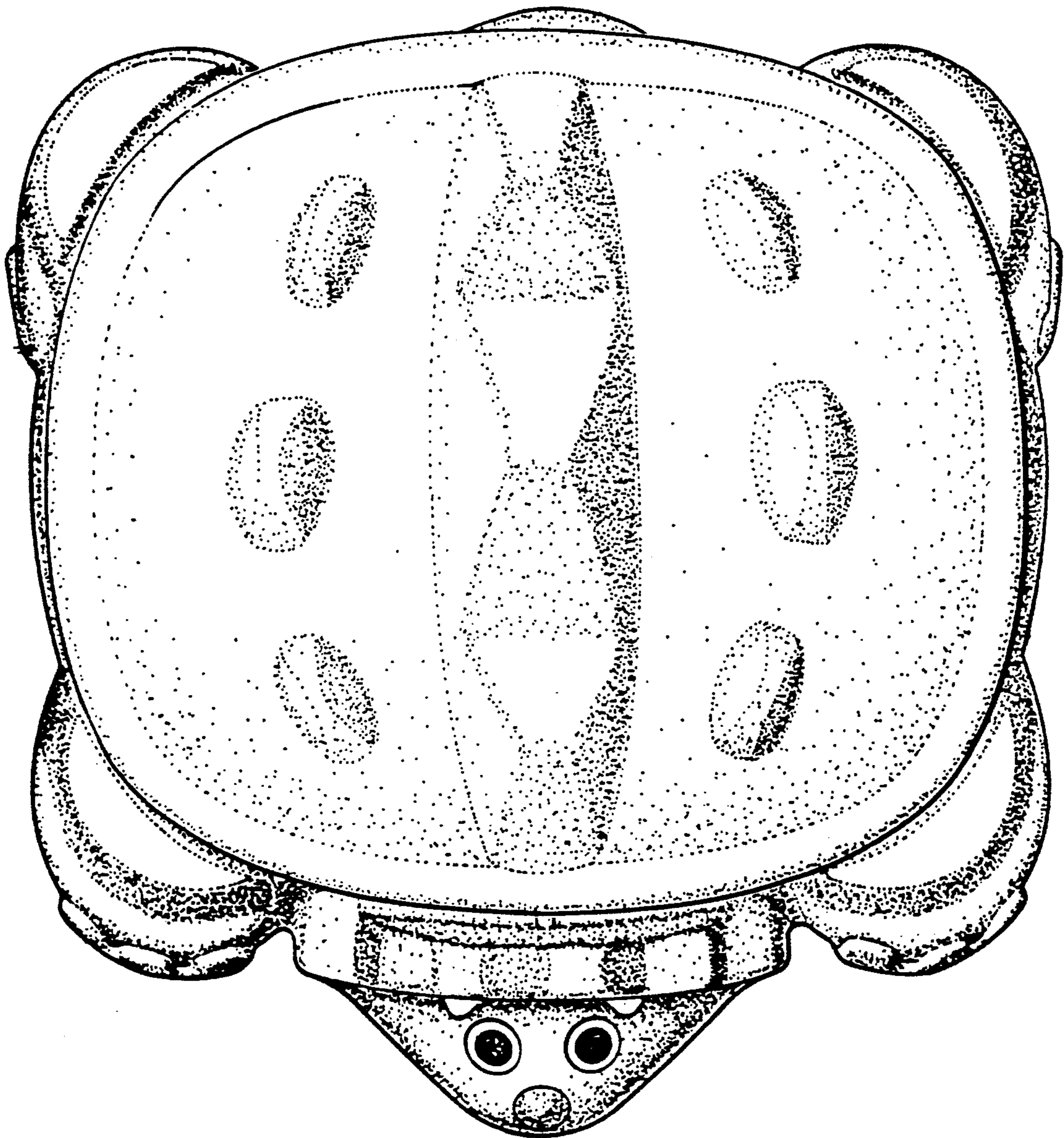

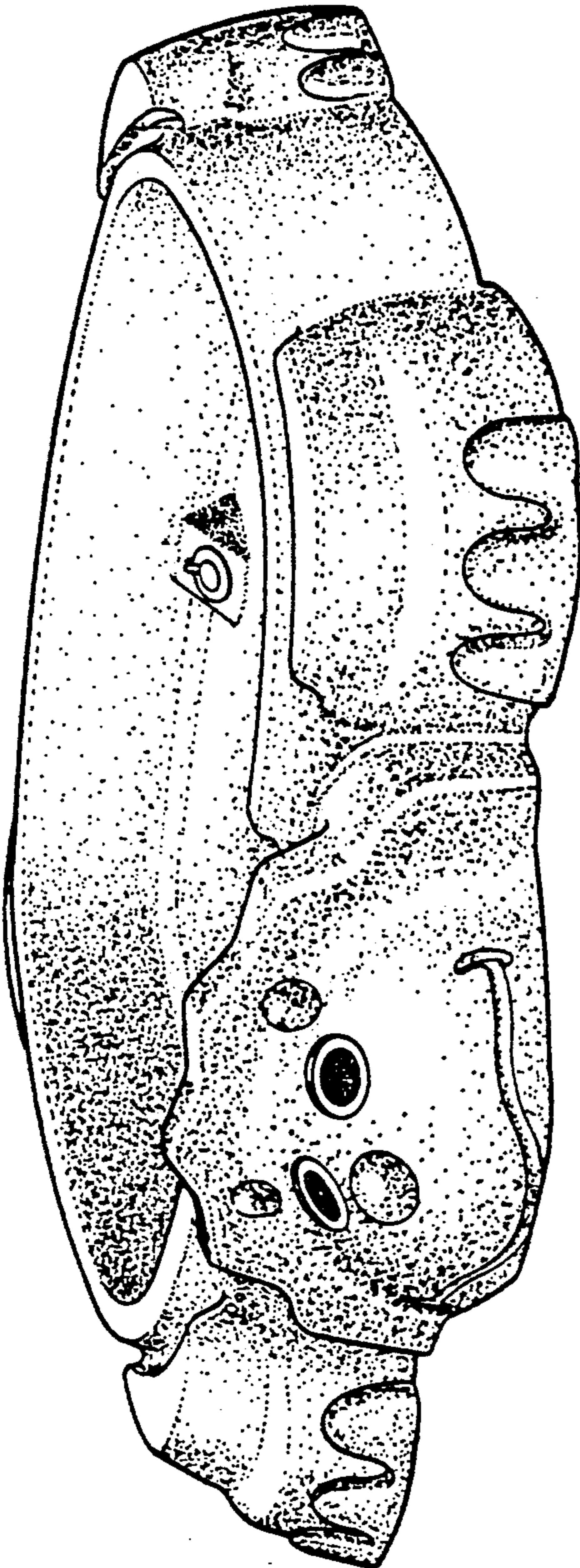

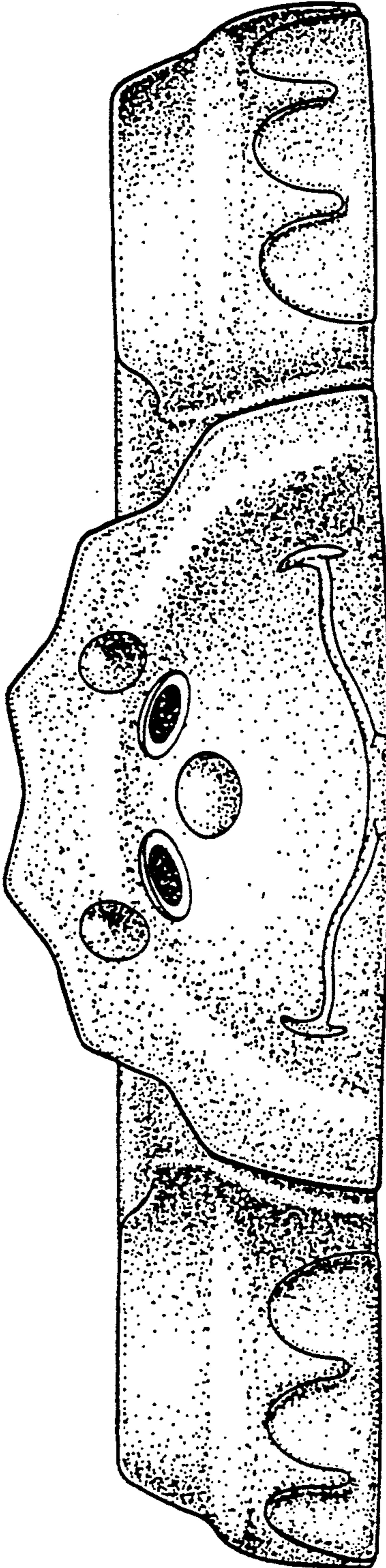

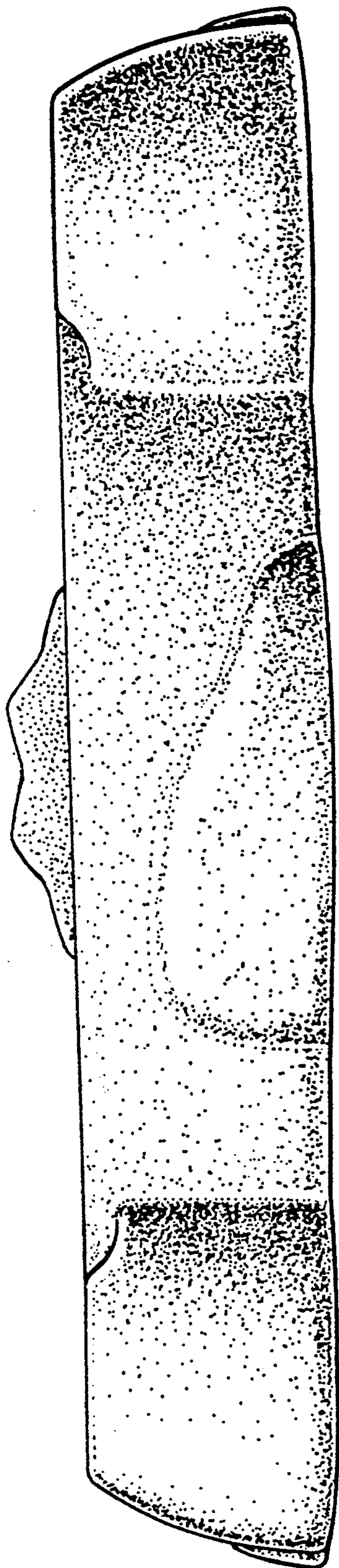

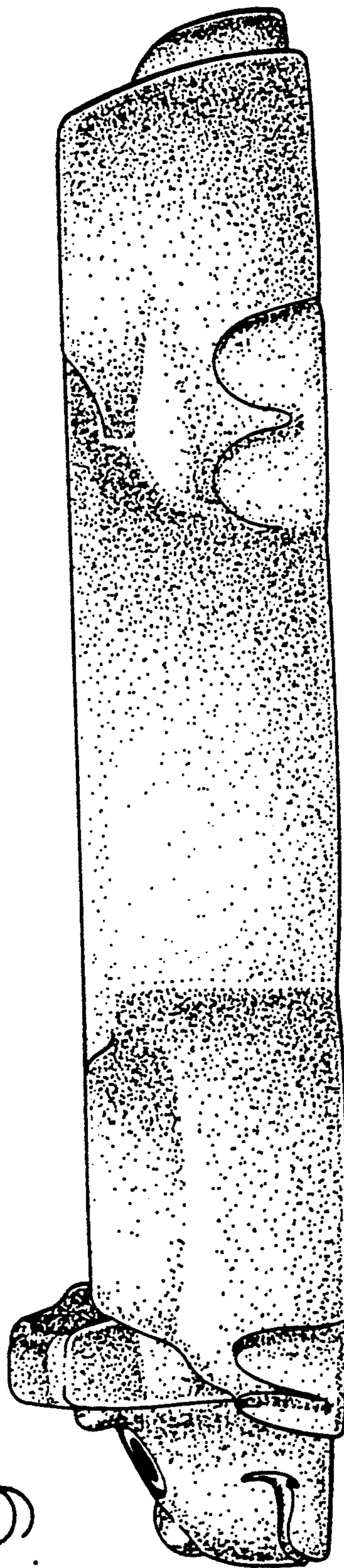

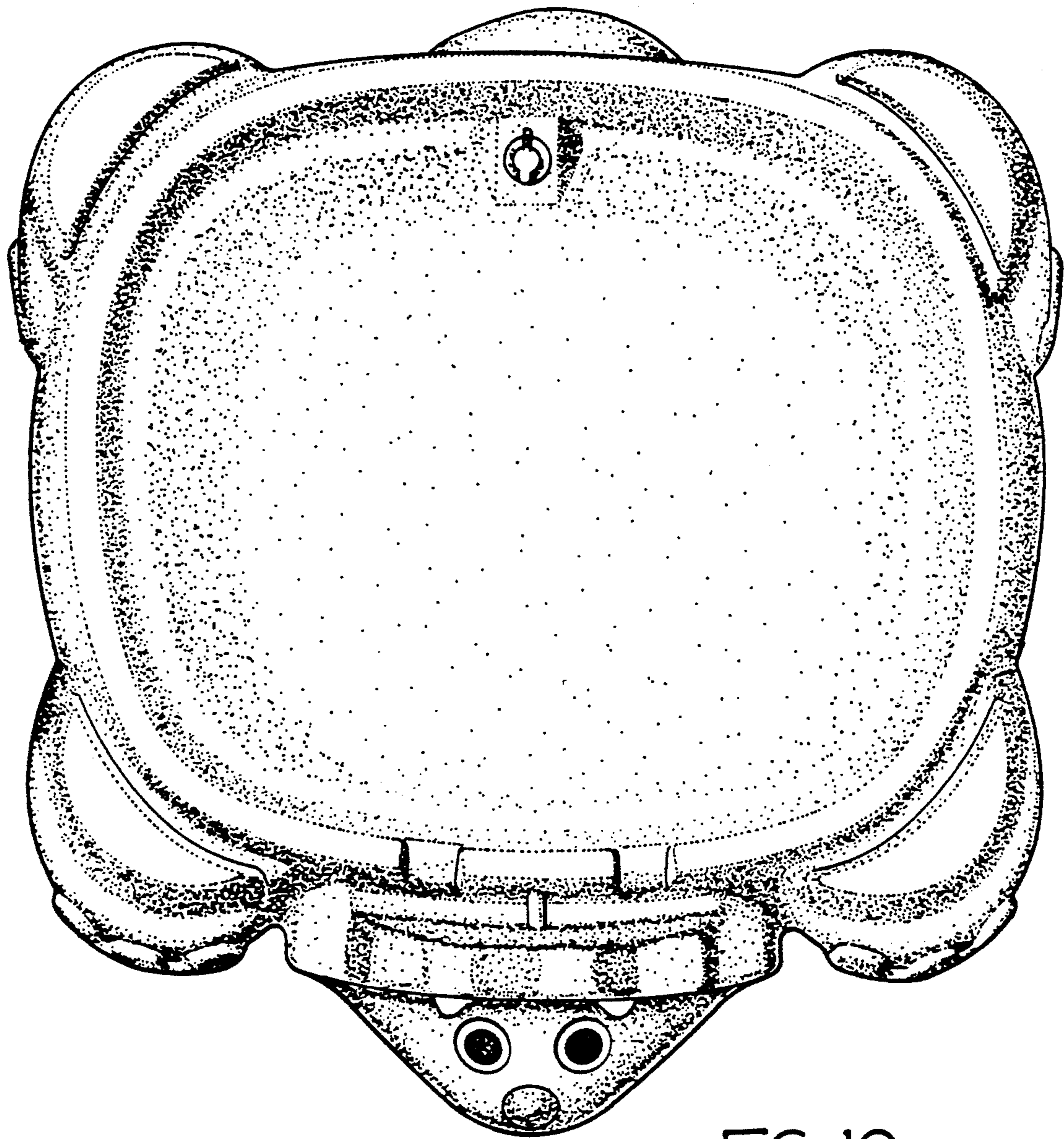
