### [57] CLAIM

The ornamental design for a cup shaped shoe sole, as shown and described.

### DESCRIPTION

FIG. 1 is a bottom plan of a cup shaped shoe sole showing my new design;  
 FIG. 2 is a side elevational view of one side of the cup shaped shoe sole shown in FIG. 1;  
 FIG. 3 is a side elevational view of the other side of the cup shaped shoe sole shown in FIG. 1;  
 FIG. 4 is a front elevational view of the cup shaped shoe sole shown in FIG. 1;  
 FIG. 5 is a rear elevational view of the cup shaped shoe sole shown in FIG. 1;  
 FIG. 6 is a cross sectional view taken along line 6—6 in FIG. 2;  
 FIG. 7 is a cross section taken along line 7—7 in FIG. 2;  
 FIG. 8 is a cross section taken along line 8—8 in FIG. 2;  
 FIG. 9 is a cross section taken along line 9—9 in FIG. 3;  
 FIG. 10 is a cross section taken along line 10—10 in FIG. 3;  
 FIG. 11 is a cross sectional view taken along line 11—11 in FIG. 3;  
 FIG. 12 is a cross sectional view taken along line 12—12 in FIG. 3;  
 FIG. 13 is a cross section taken along line 13—13 in FIG. 1;  
 FIG. 14 is a cross sectional view taken along line 14—14 in FIG. 1;  
 FIG. 15 is a cross section taken along line 15—15 in FIG. 1;  
 FIG. 16 is a cross sectional view taken along line 16—16 in FIG. 1; and,  
 FIG. 17 is a cross sectional view taken along line 17—17 in FIG. 1.

The broken line showing of a shoe upper in FIGS. 2-5 is for illustrative purposes and forms no part of the claimed design.

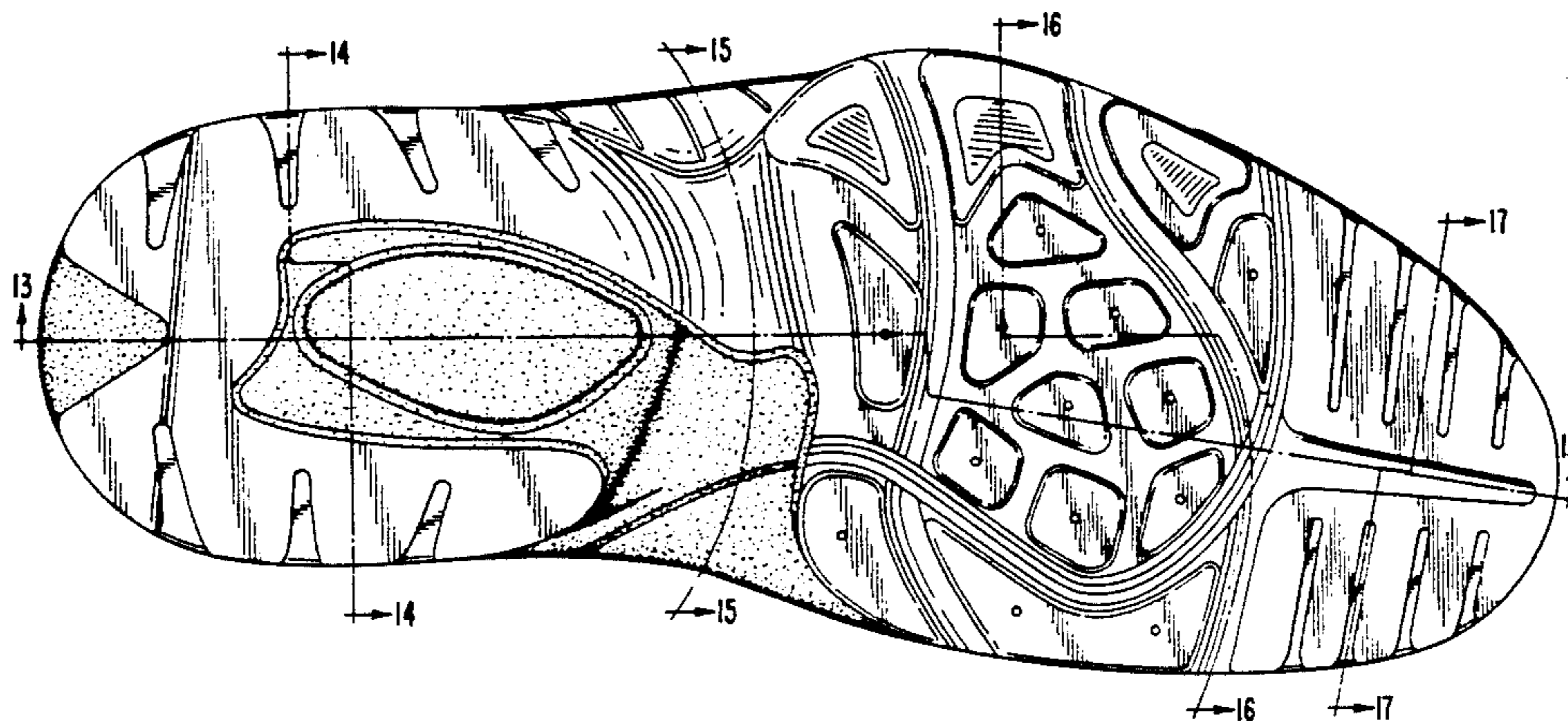
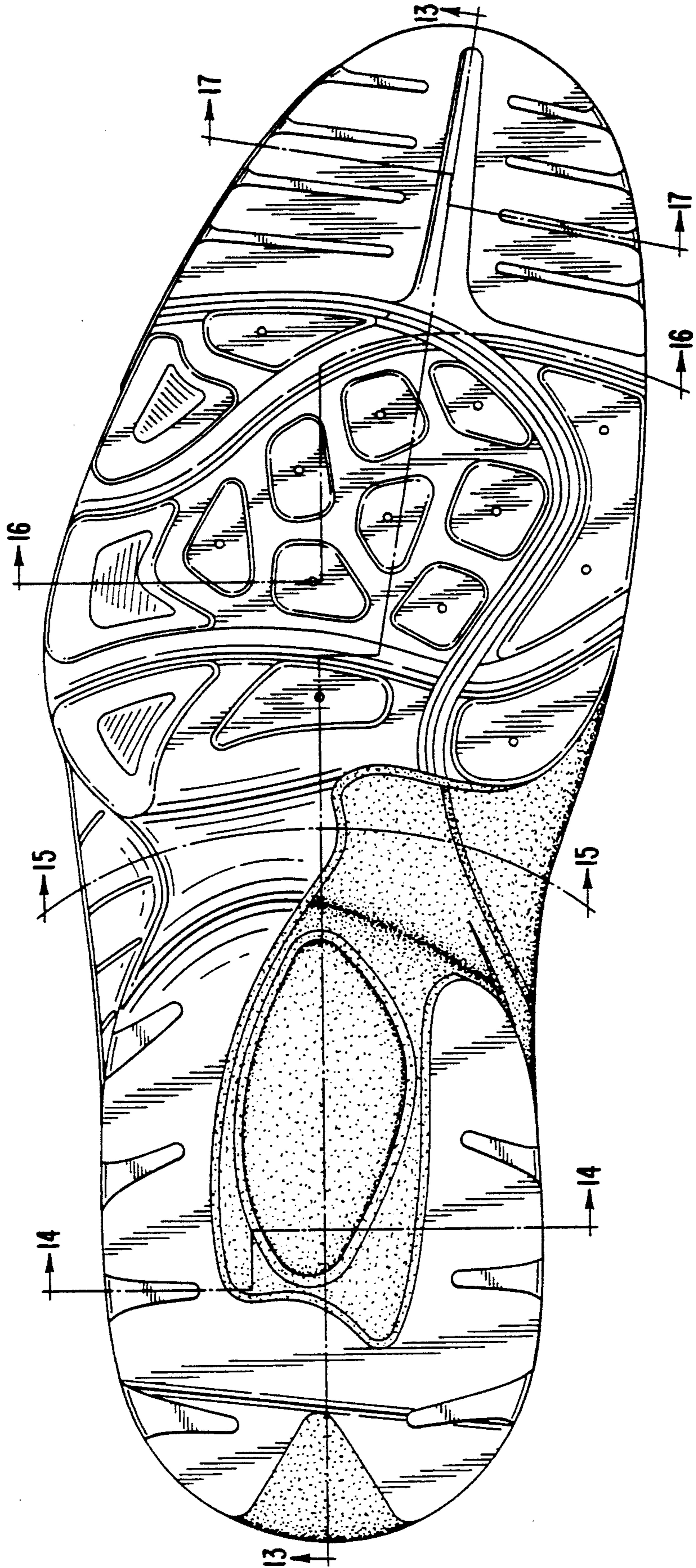

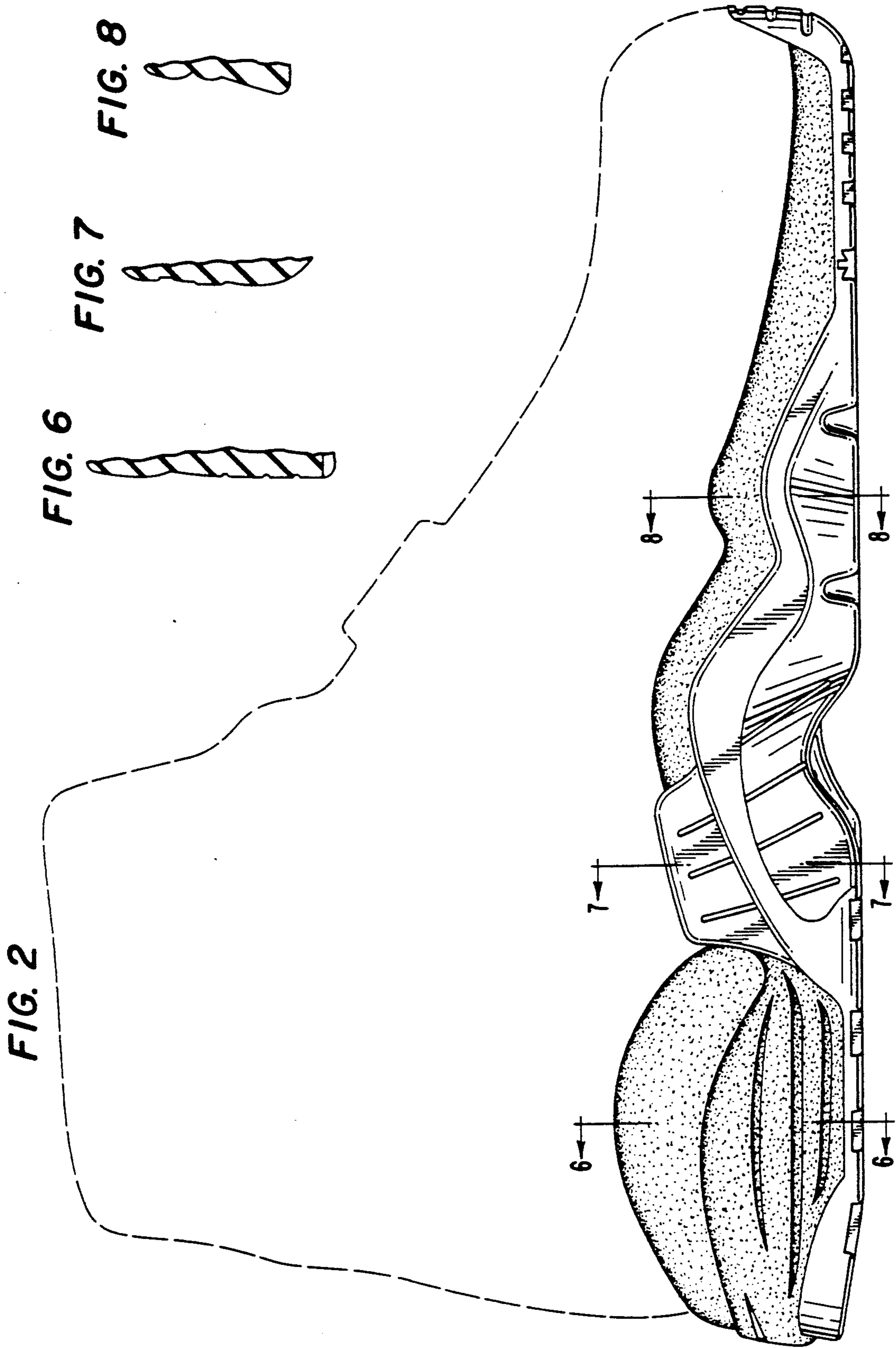


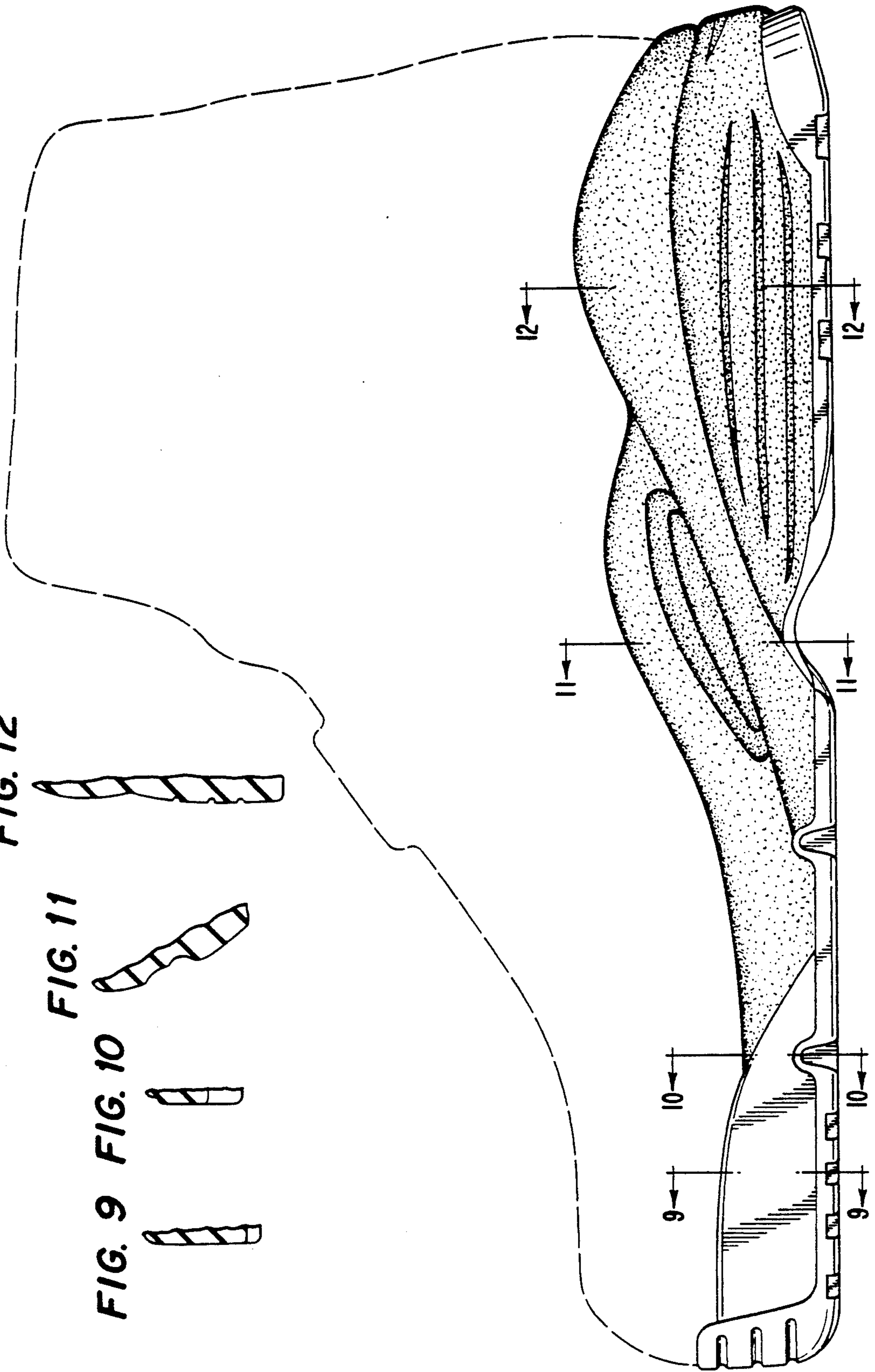

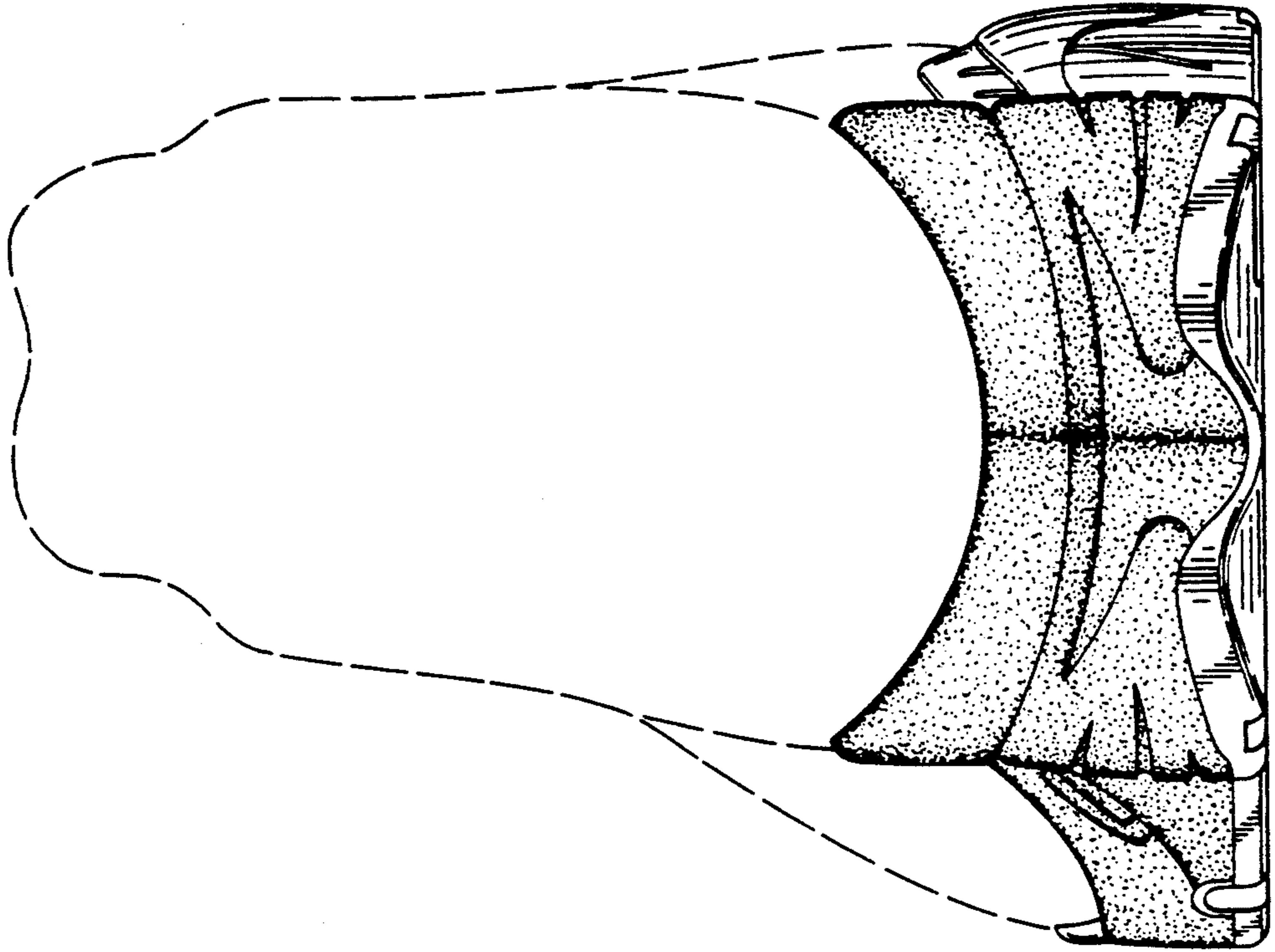

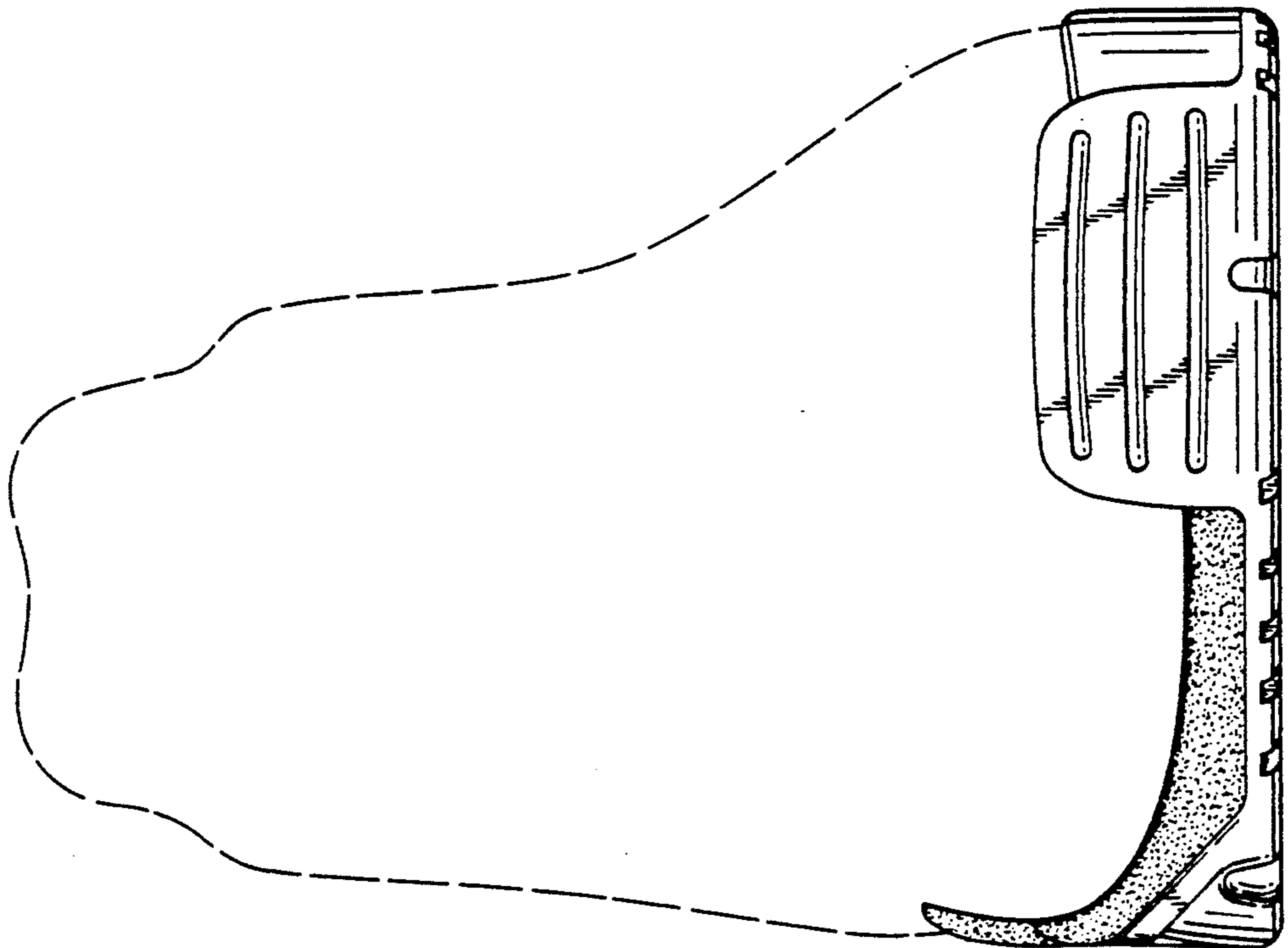

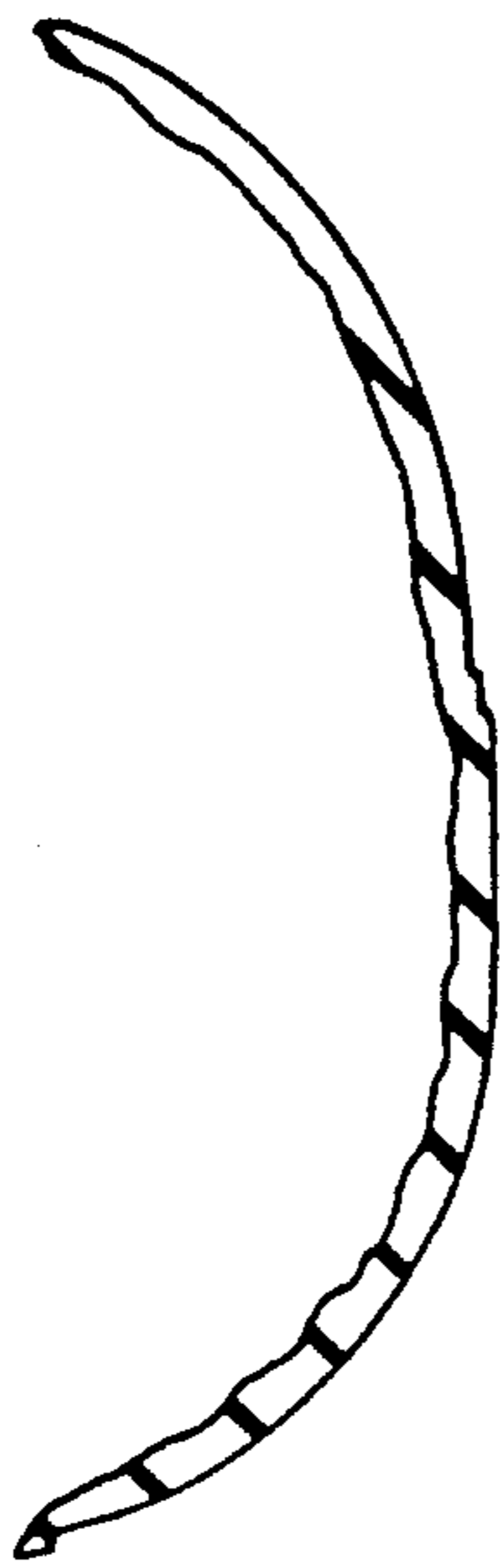
