[57] CLAIM

The ornamental design for portable cellular telephone carrying case with expandable, easy-access to battery, as shown and described.

DESCRIPTION

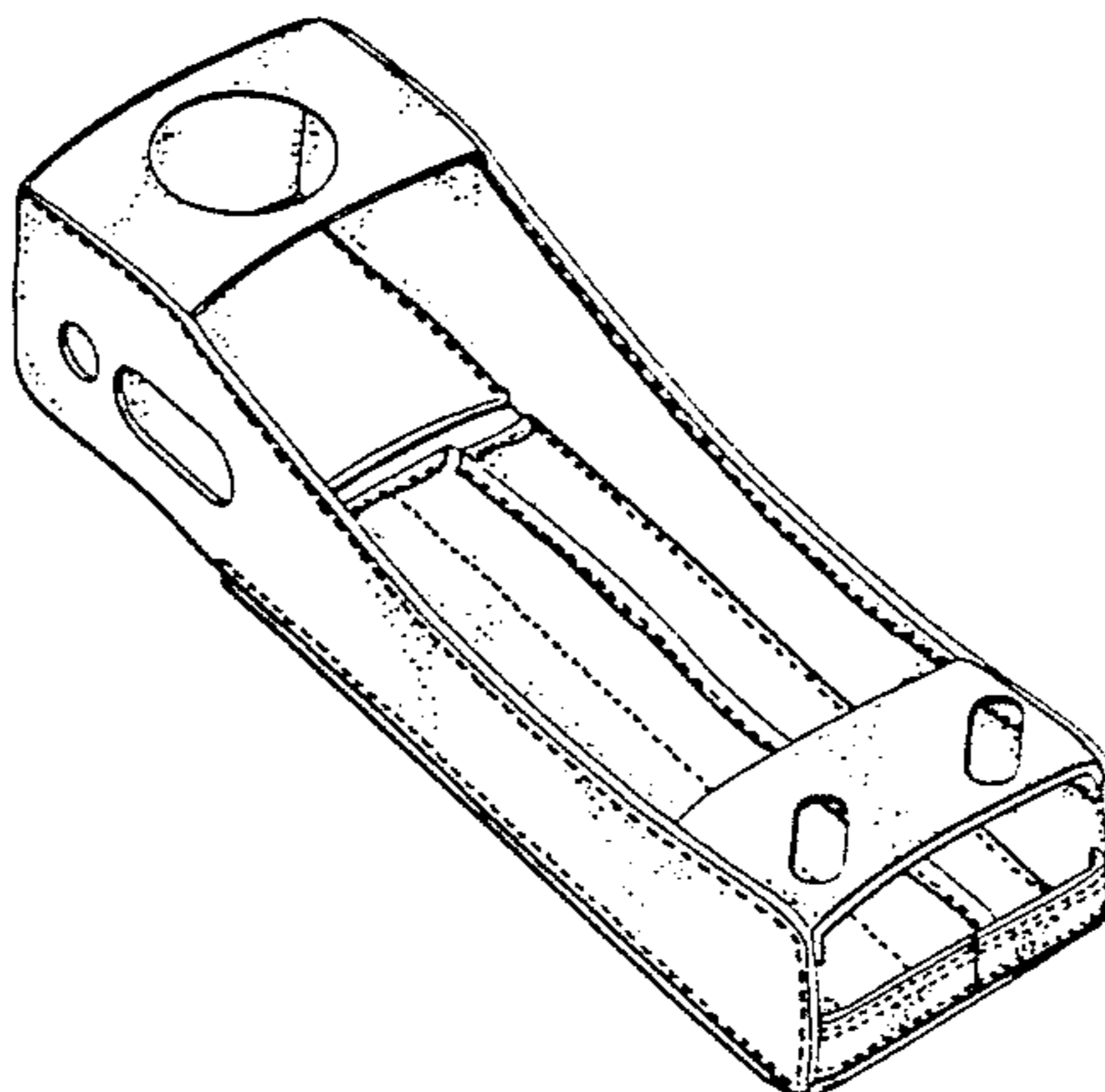

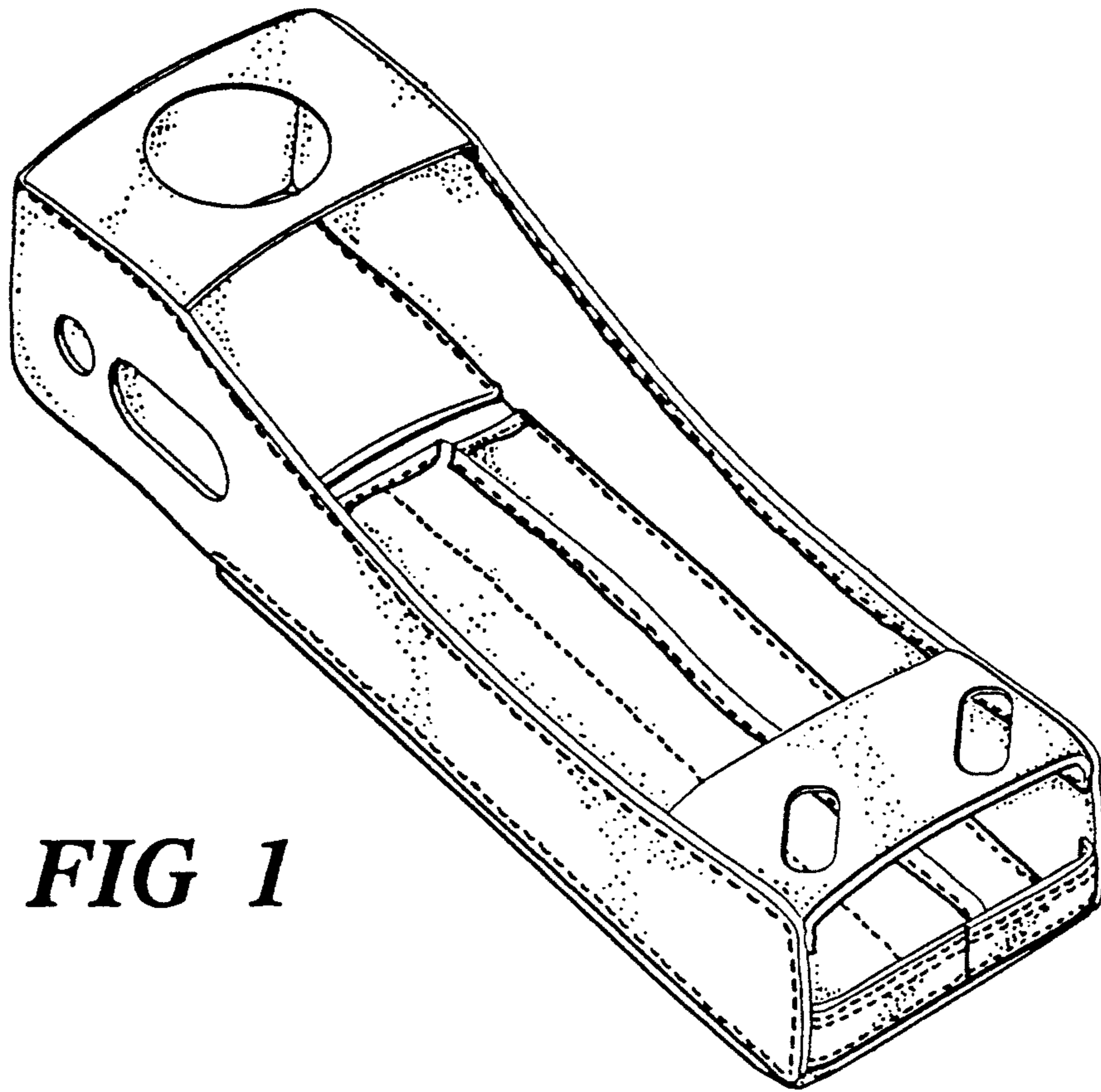

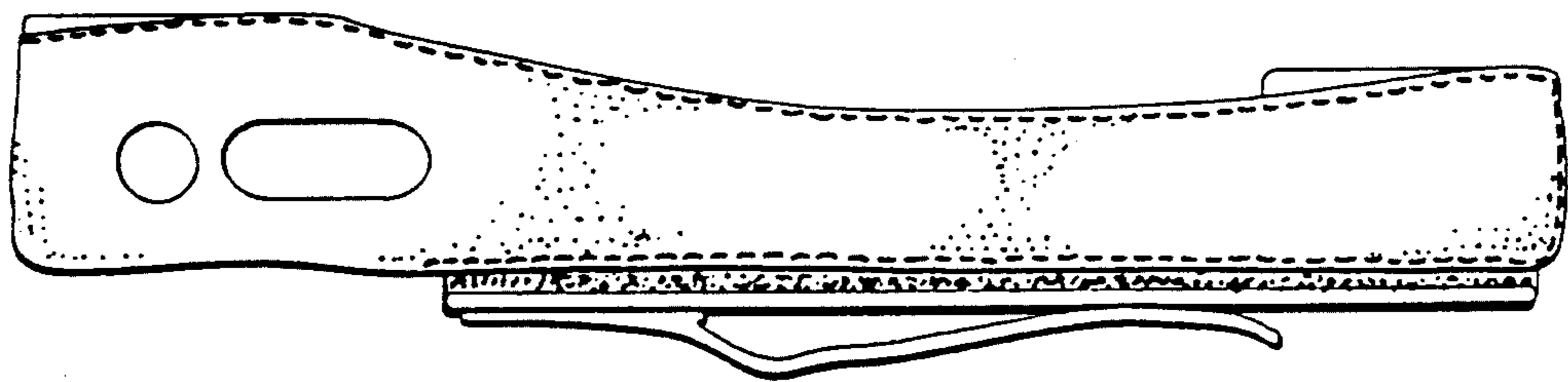

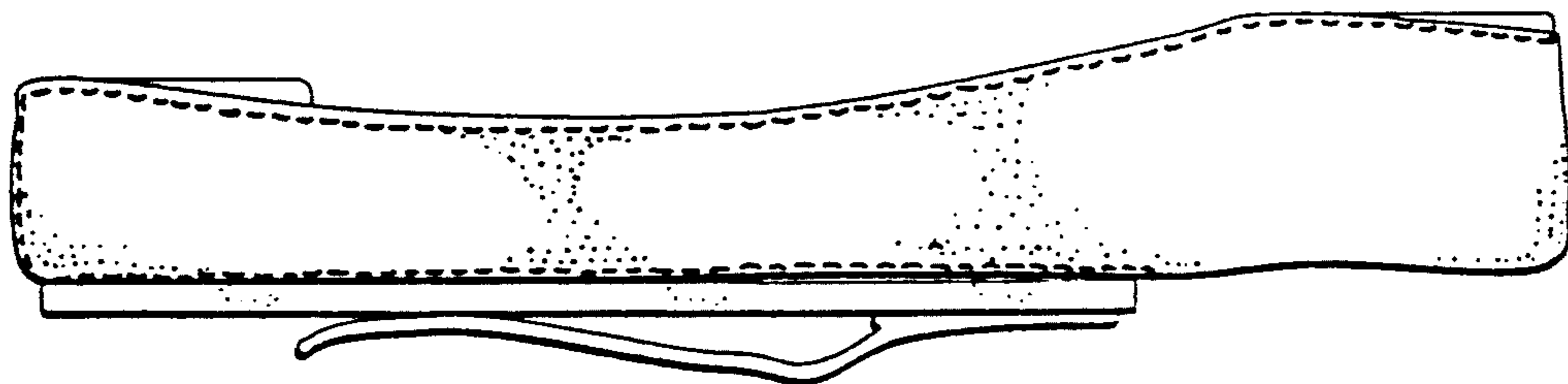

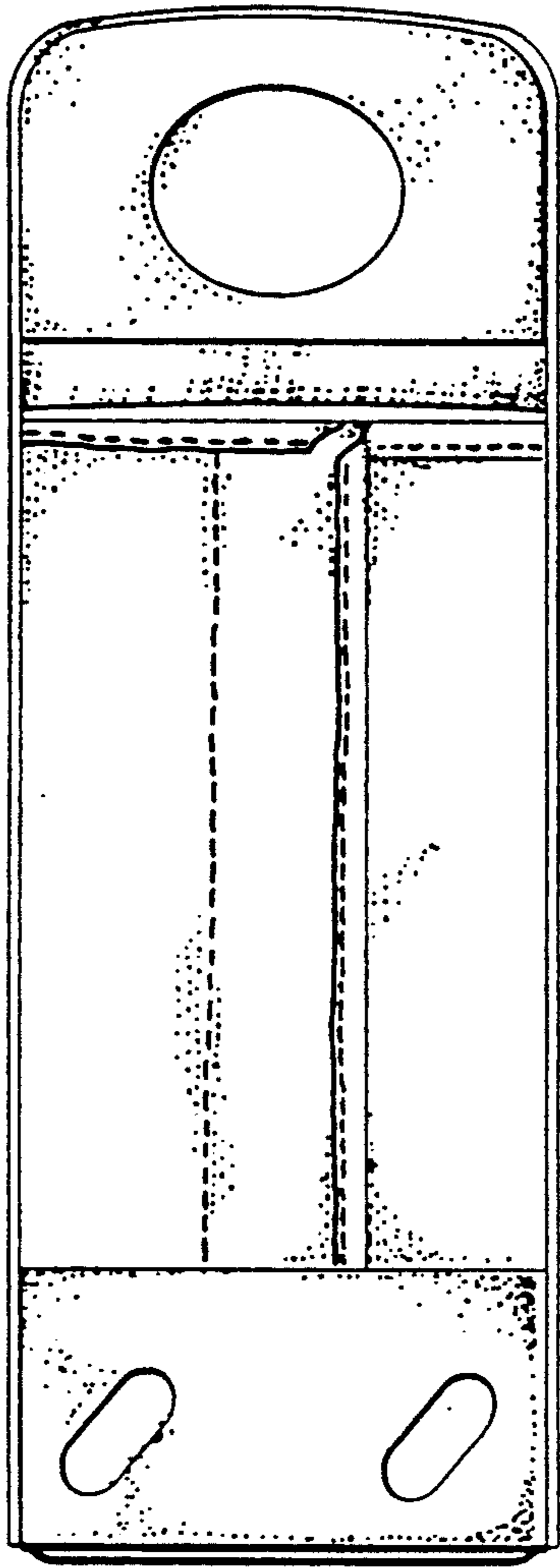

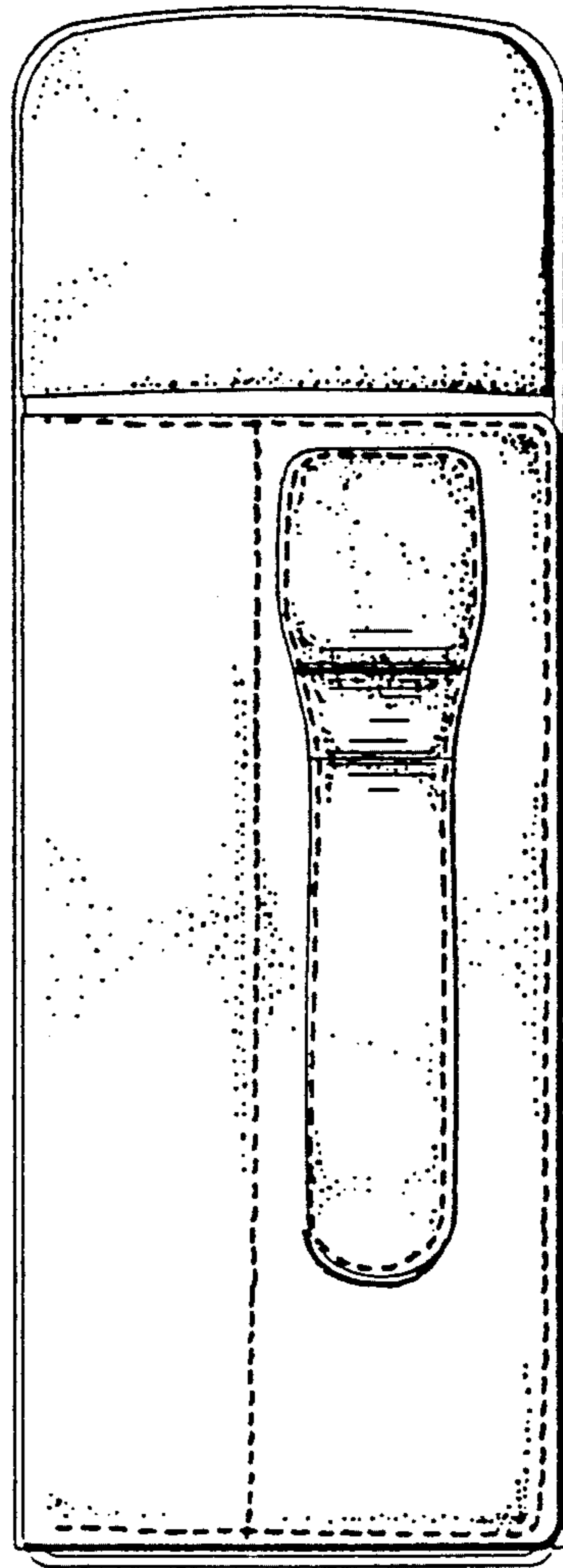

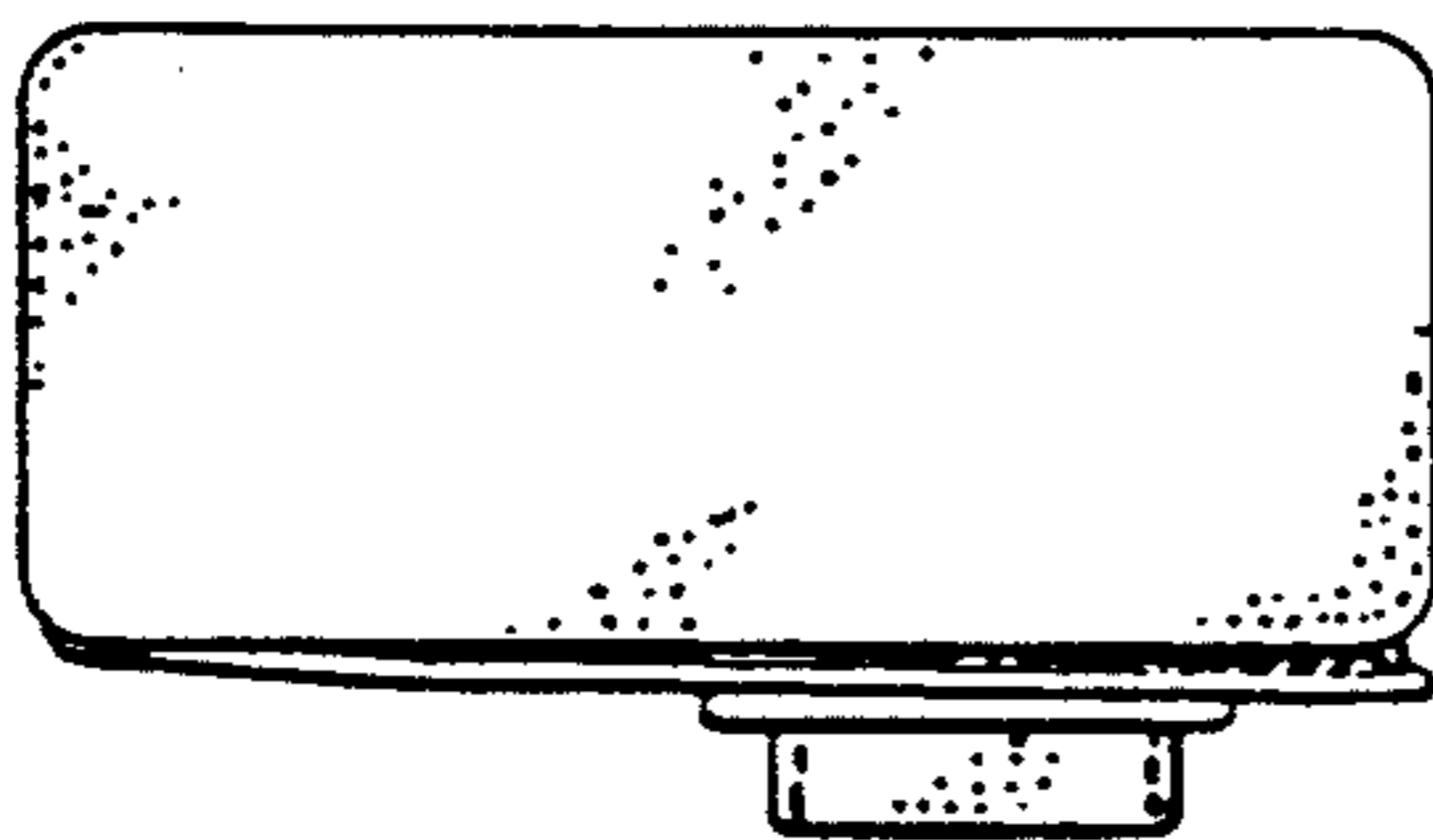

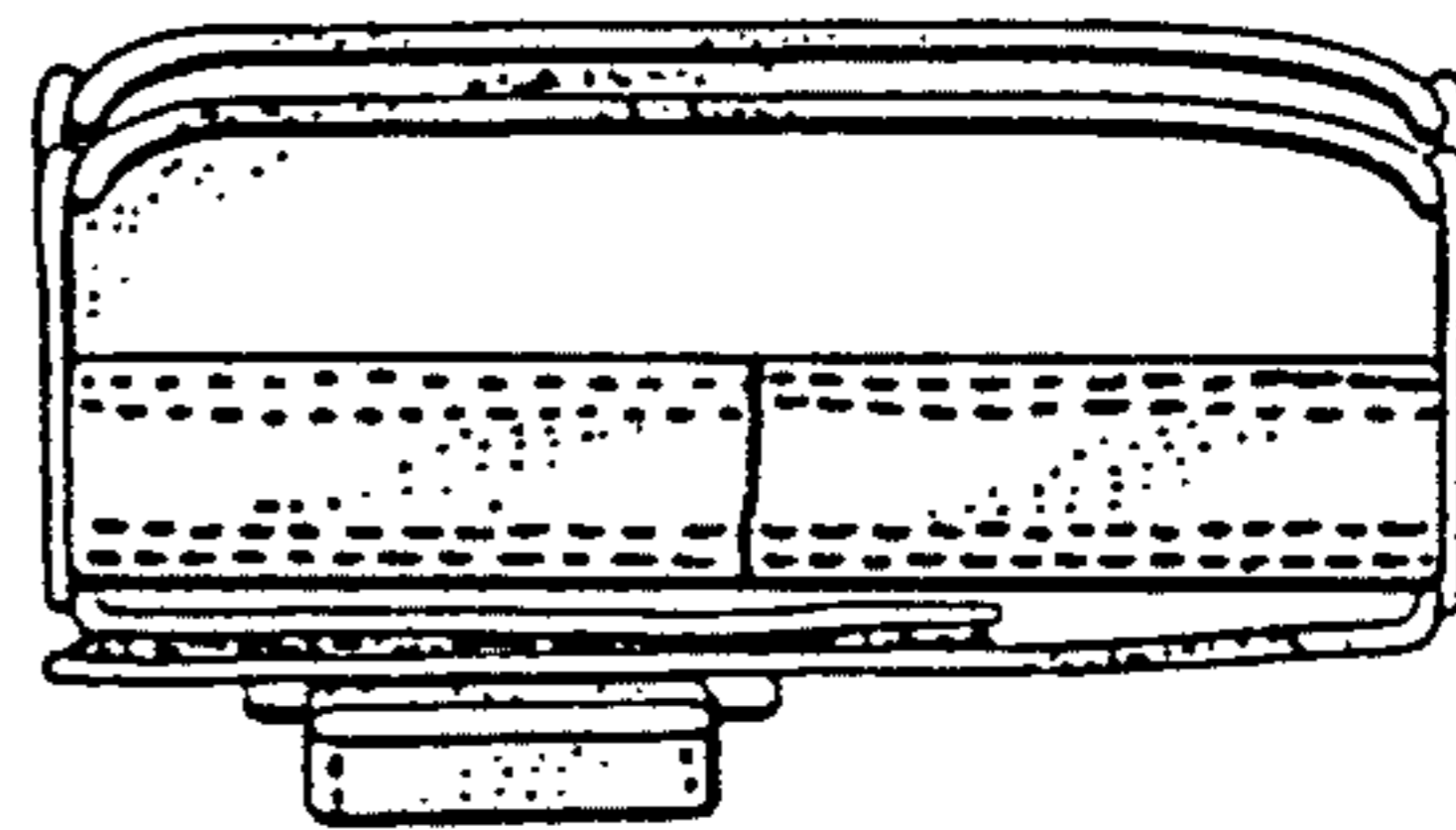

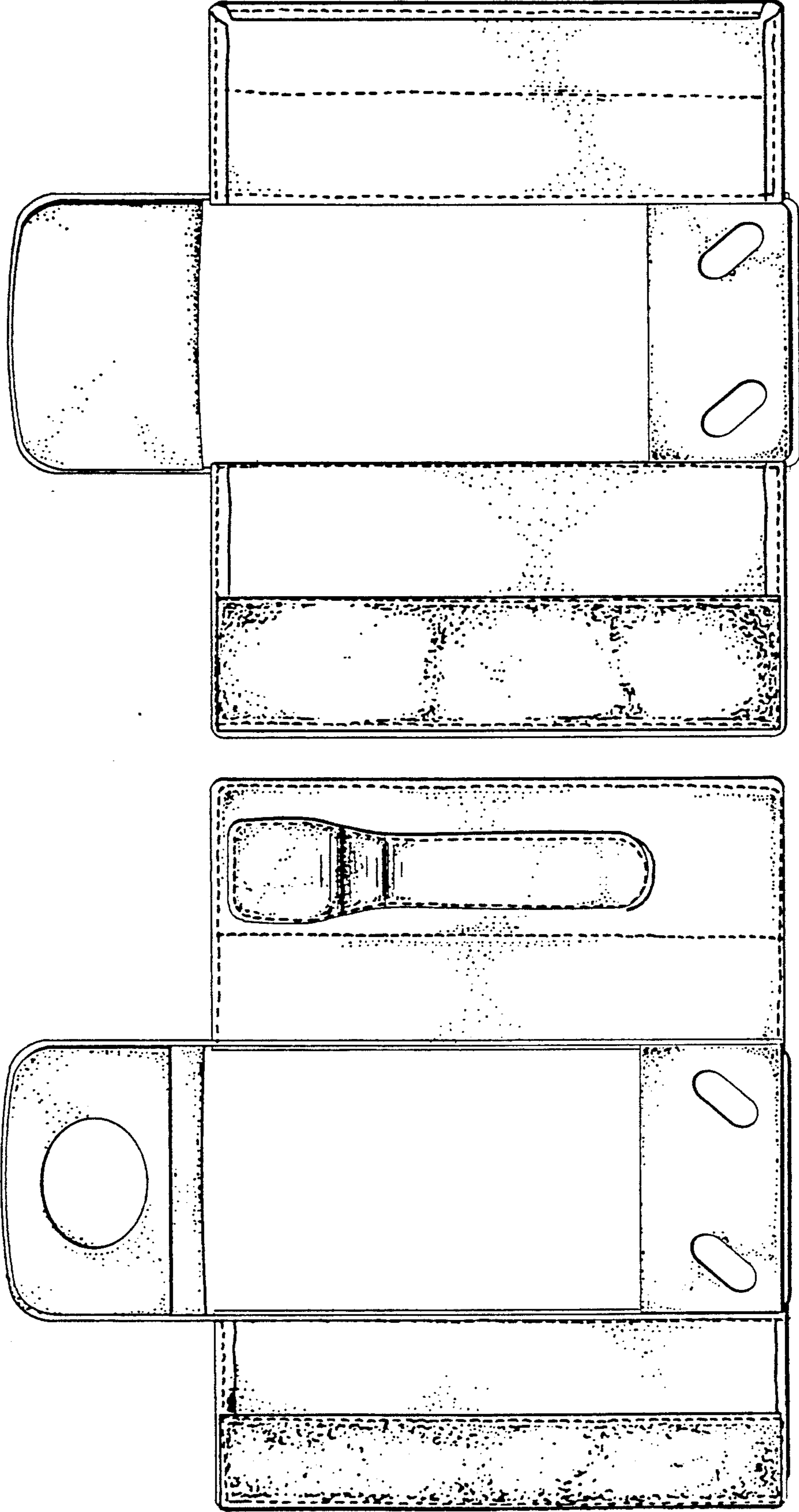

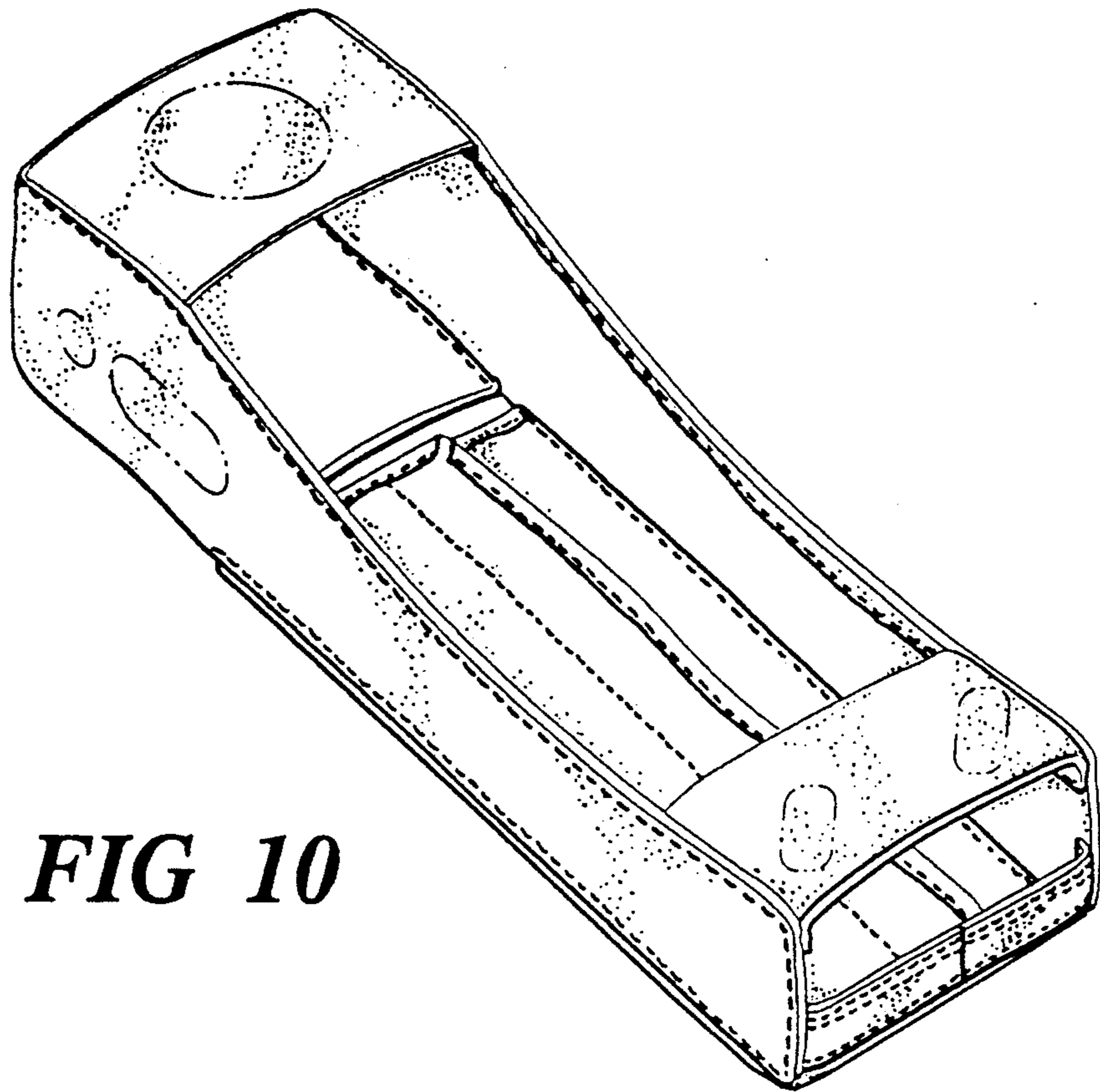

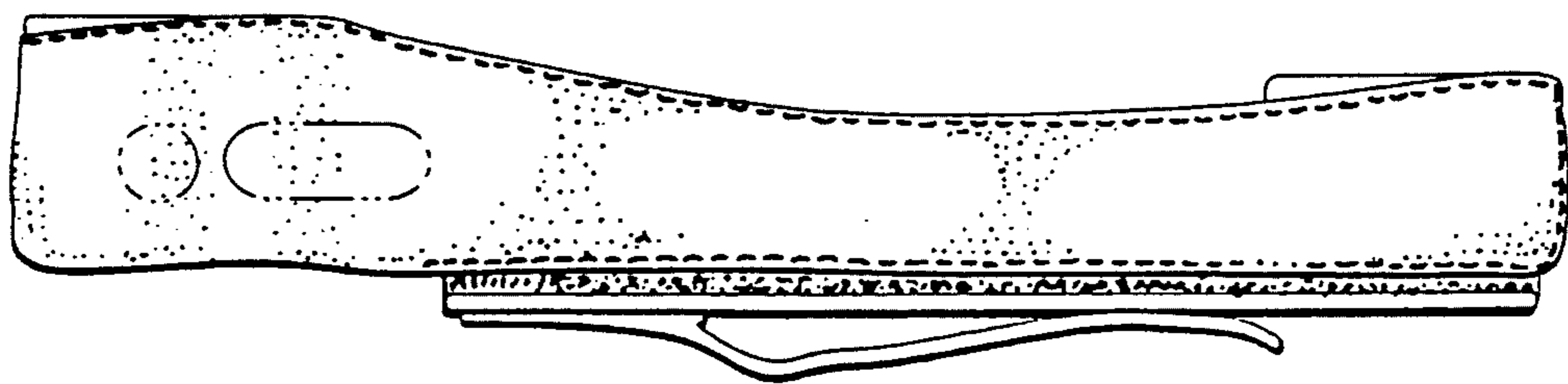

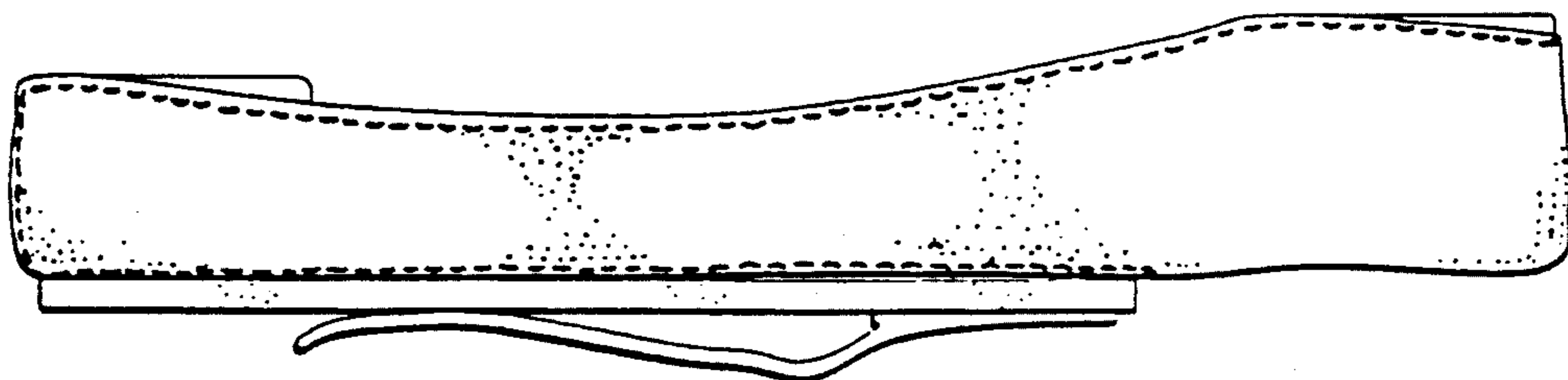

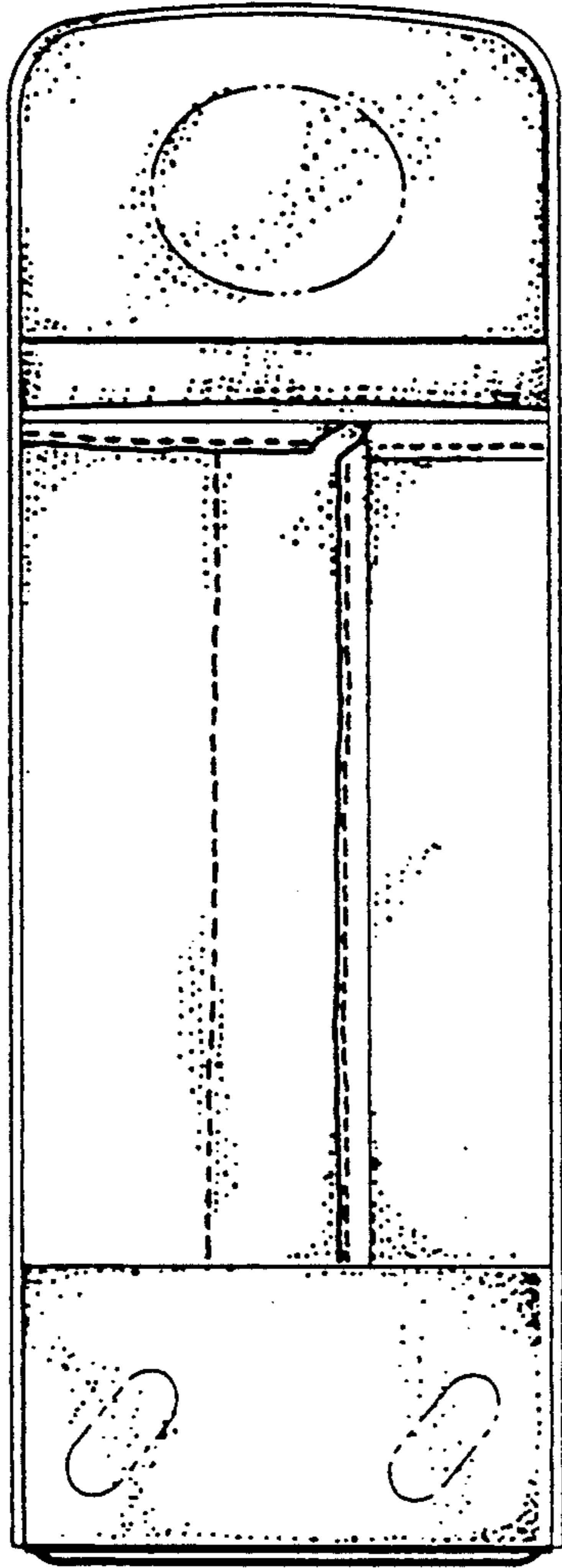

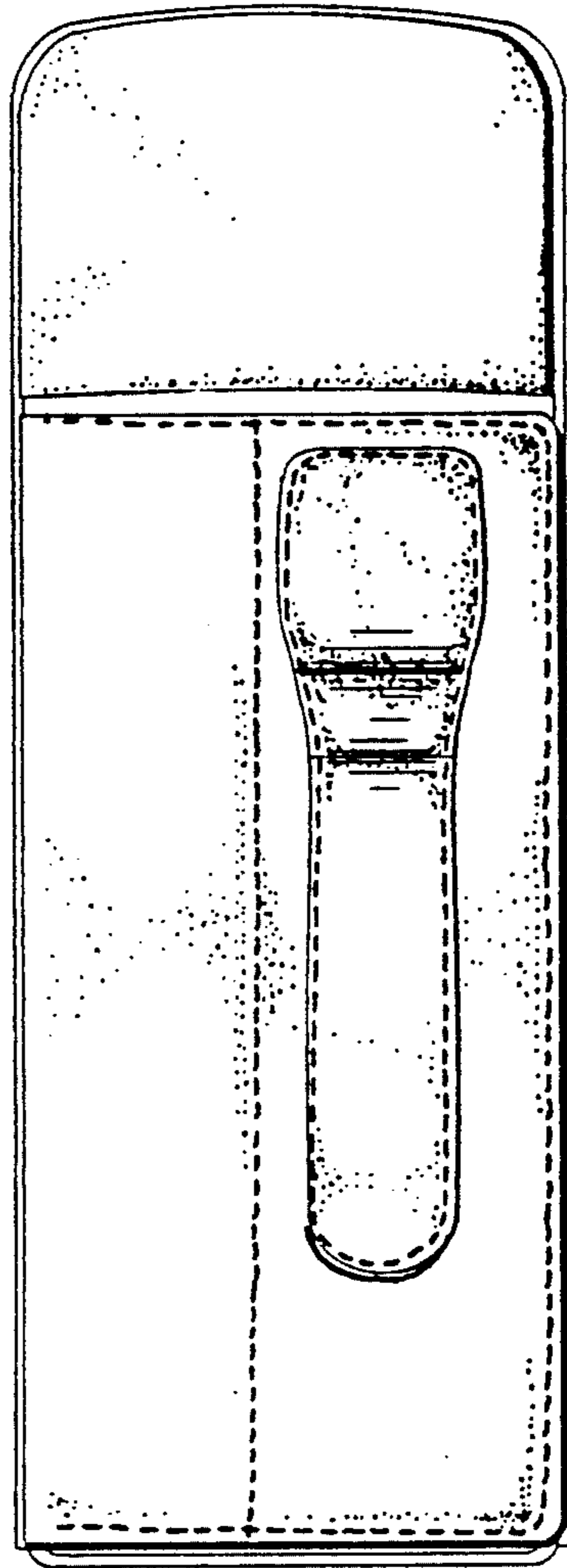

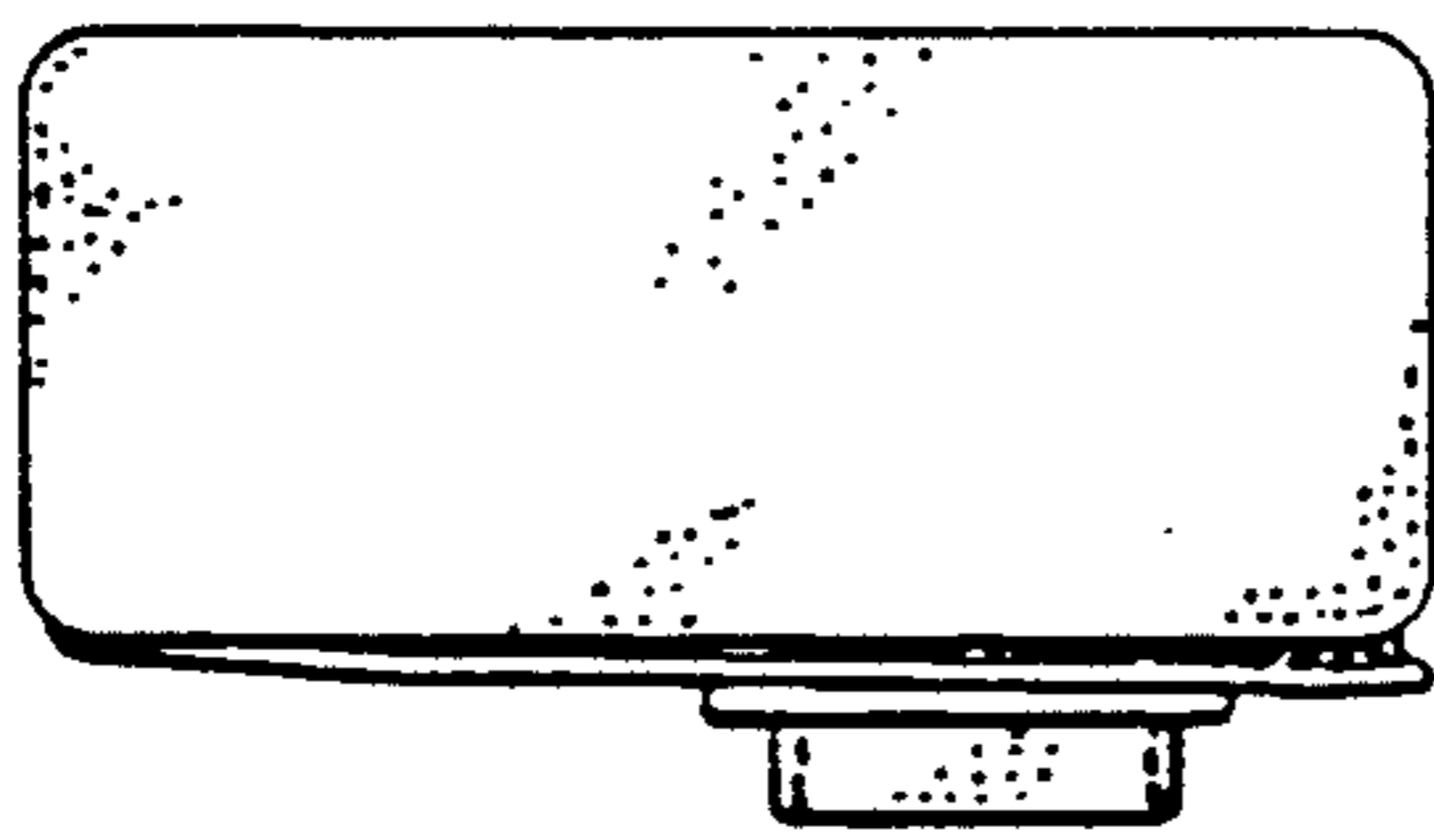

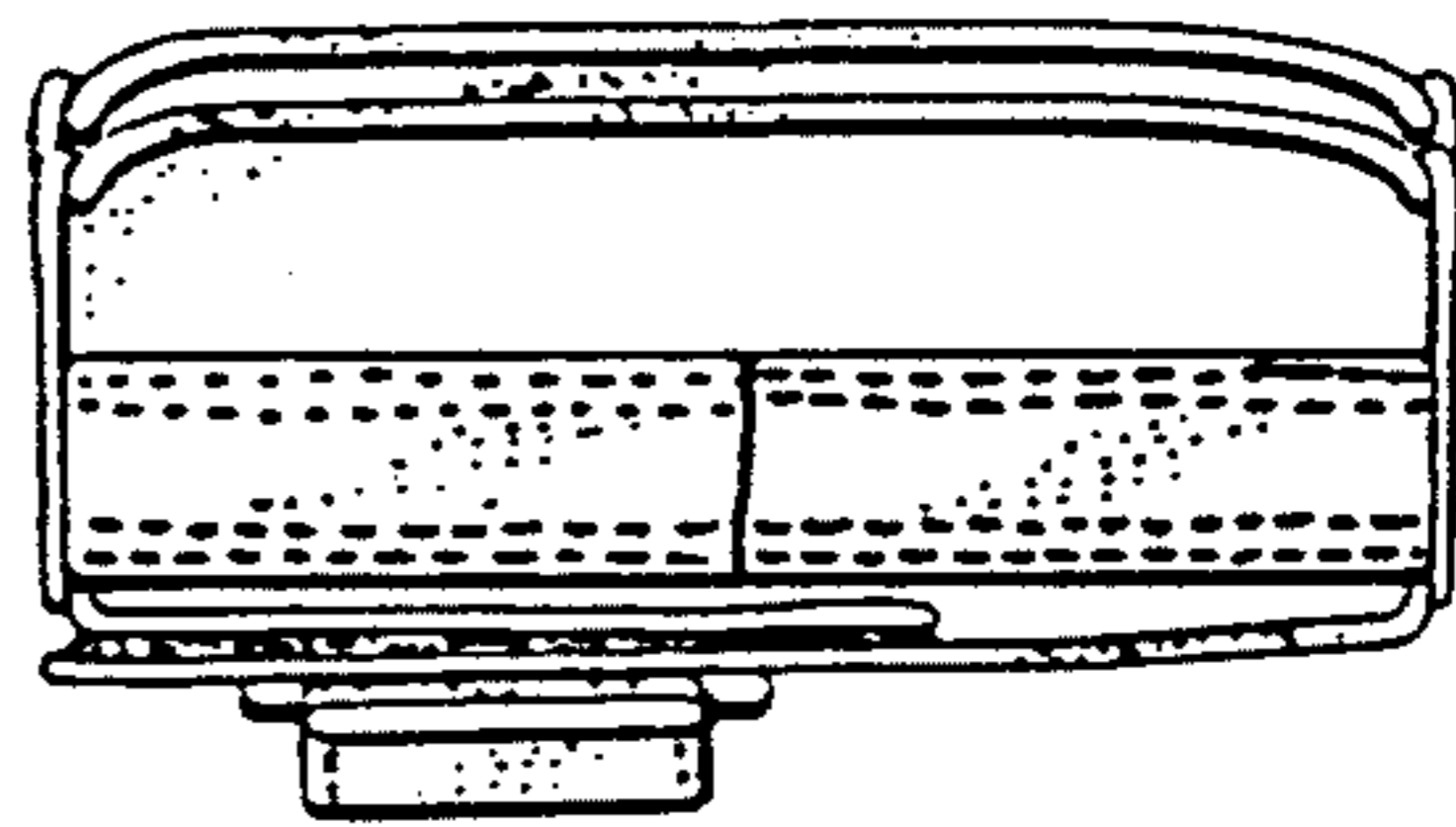

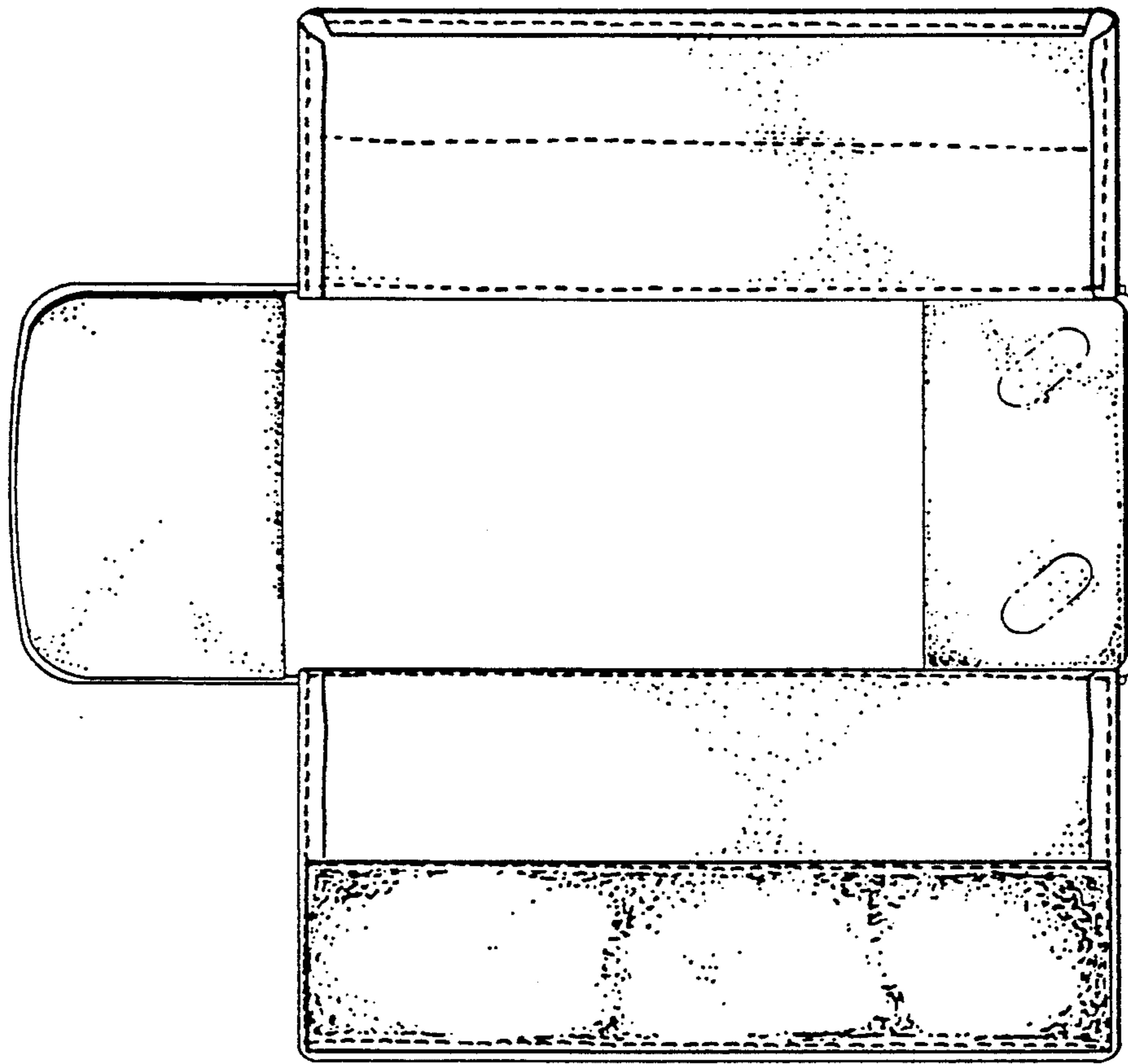

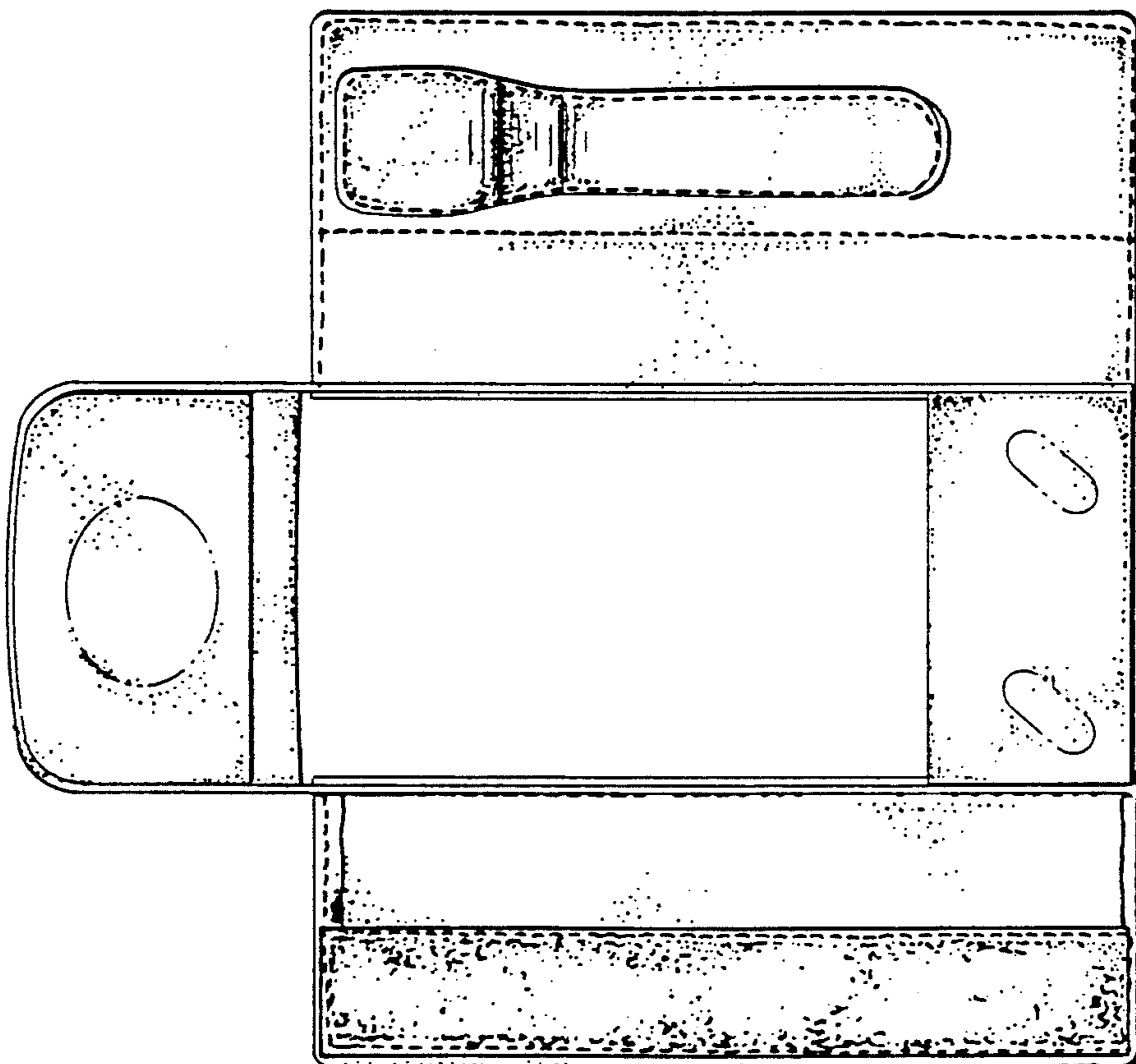

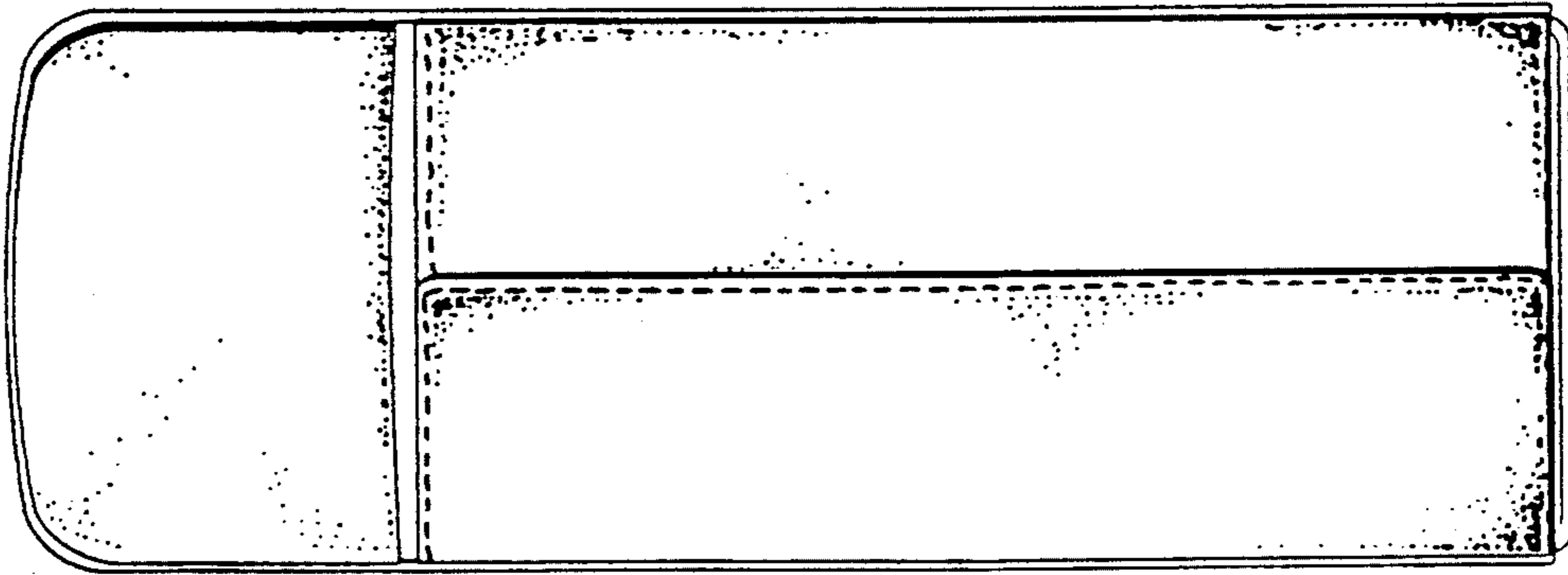

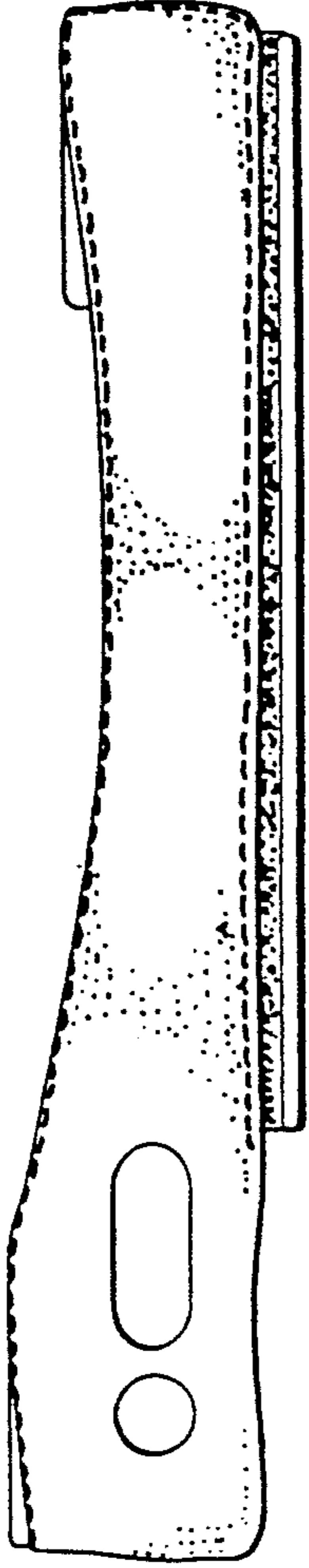

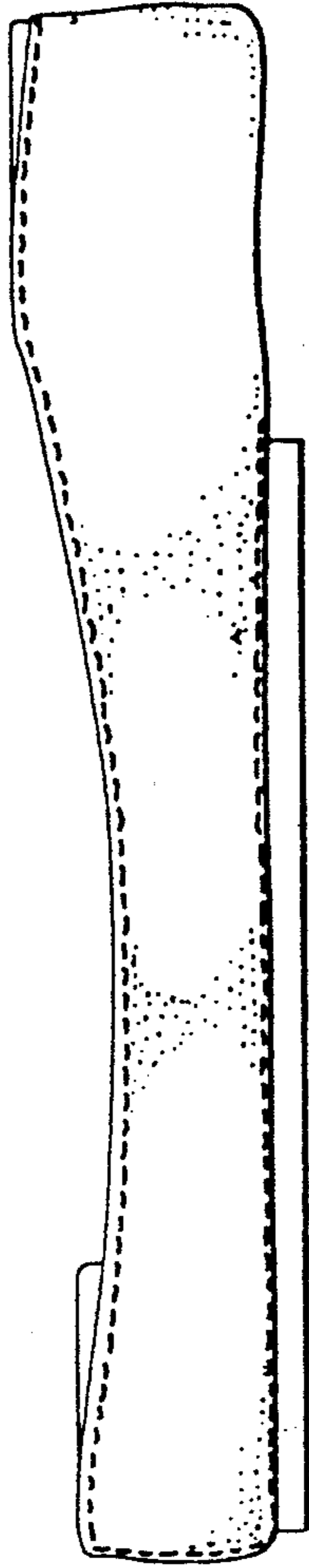

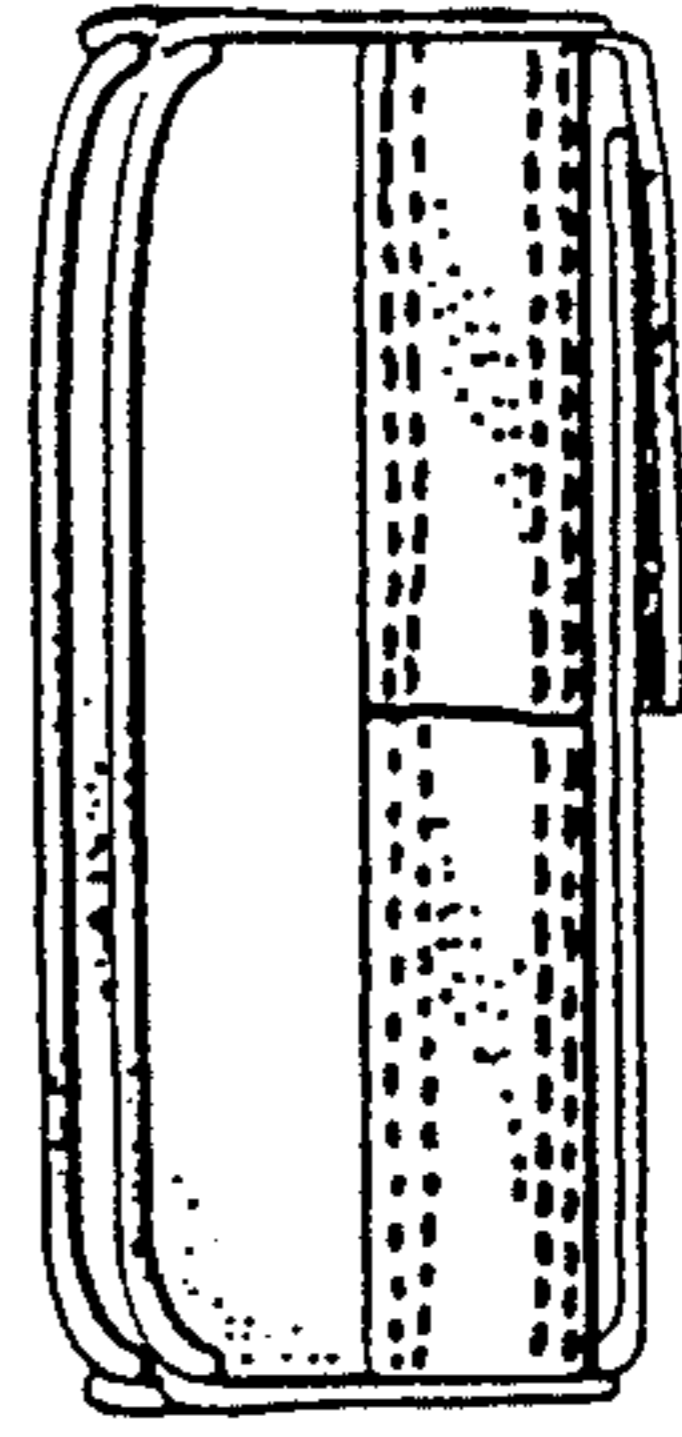

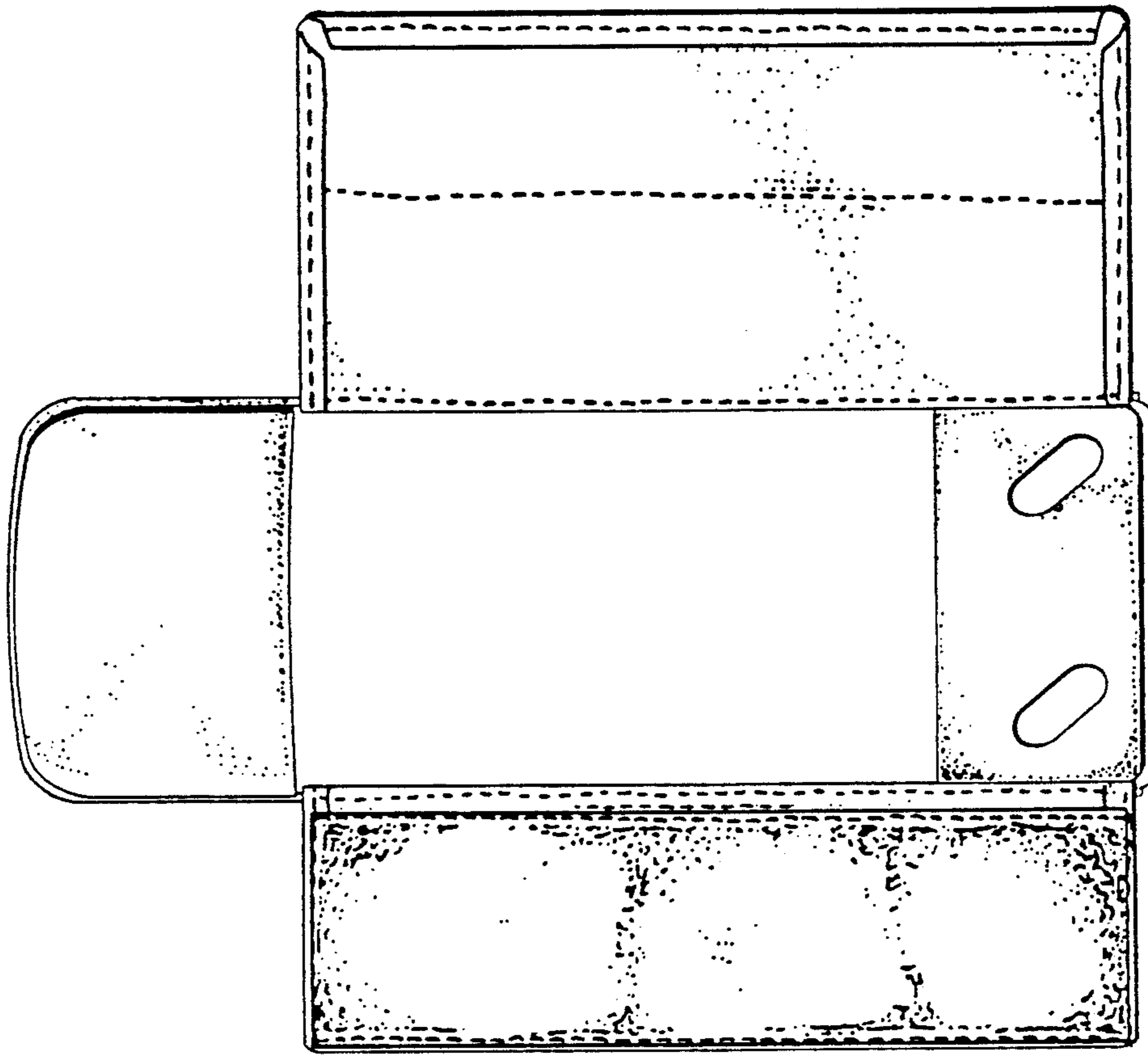

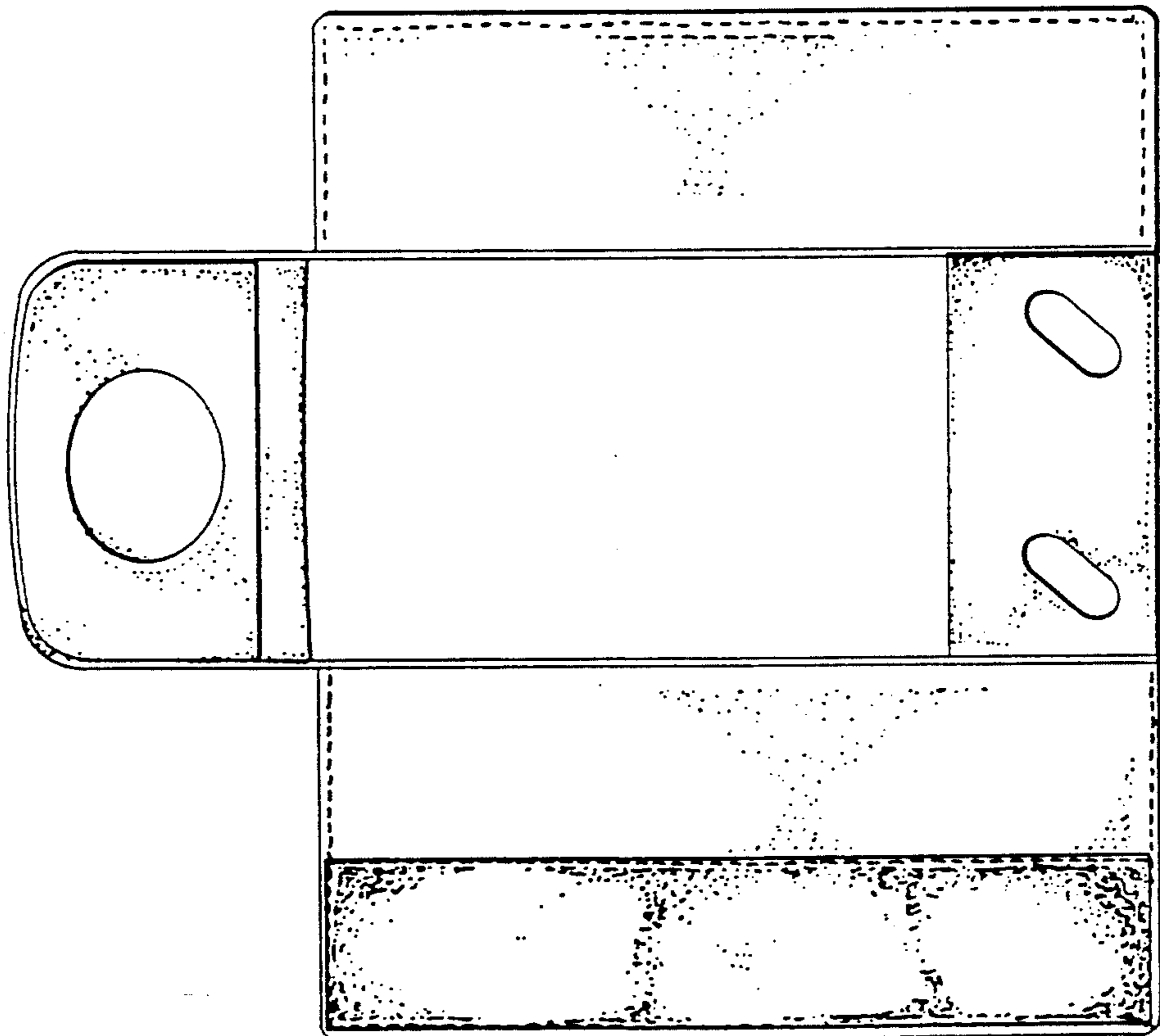

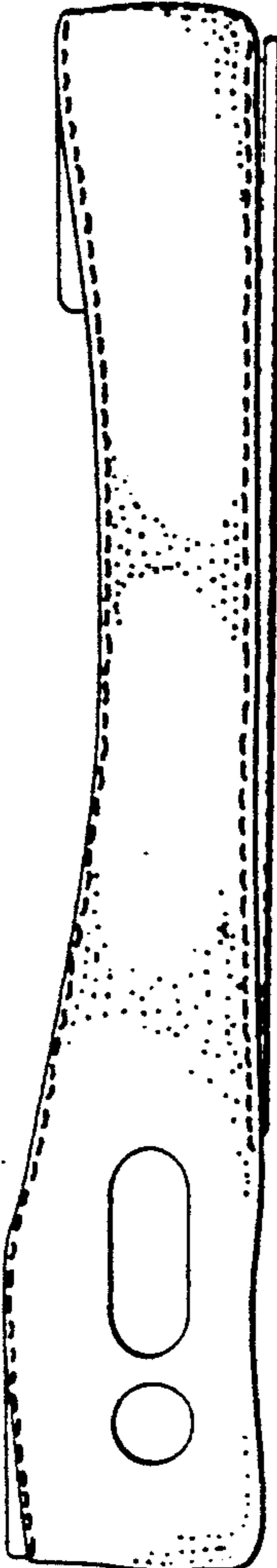

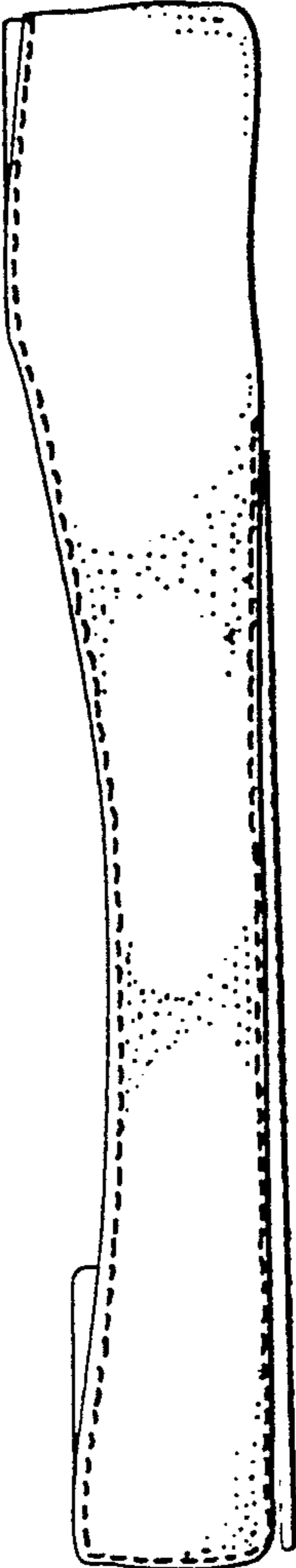

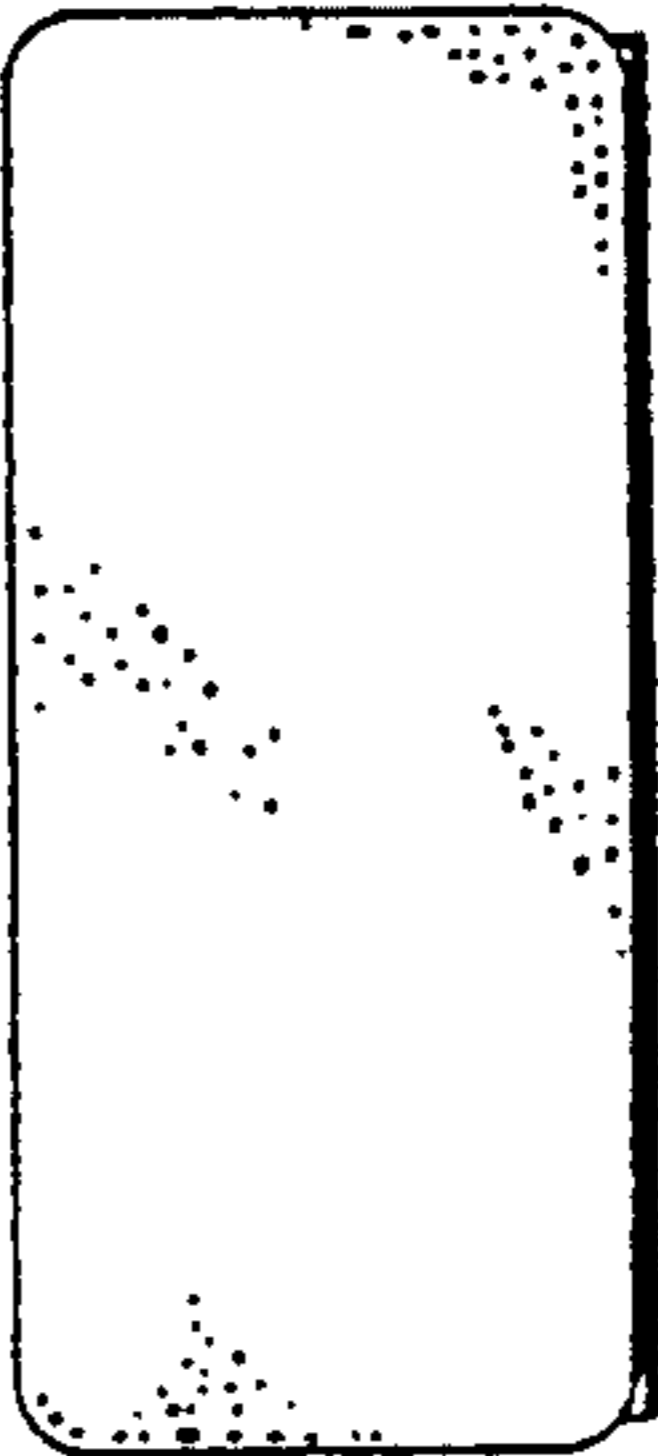

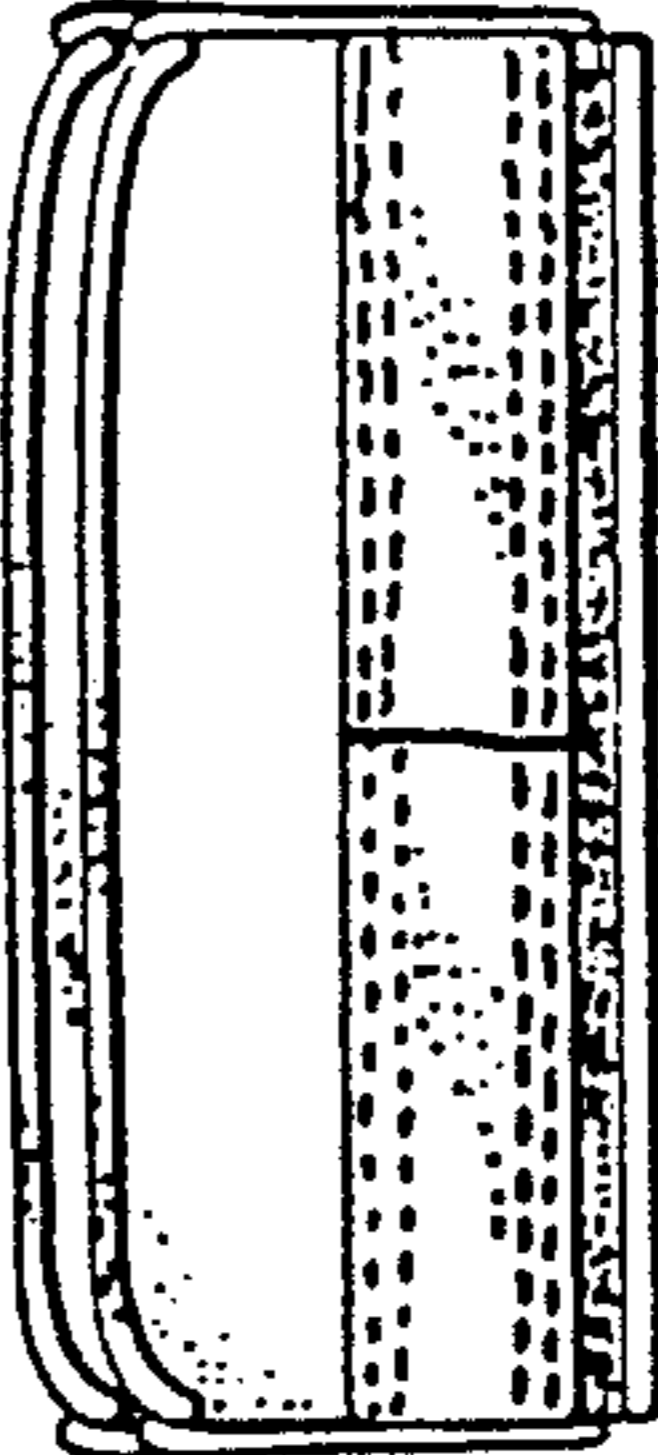

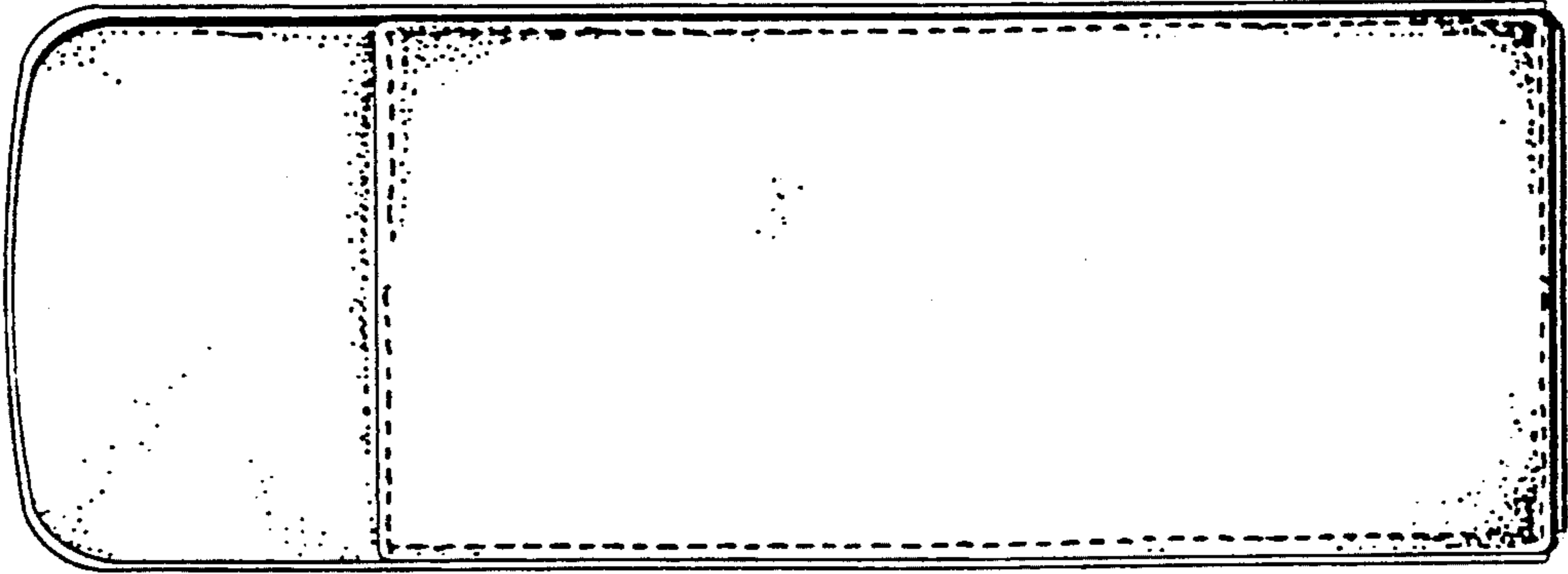

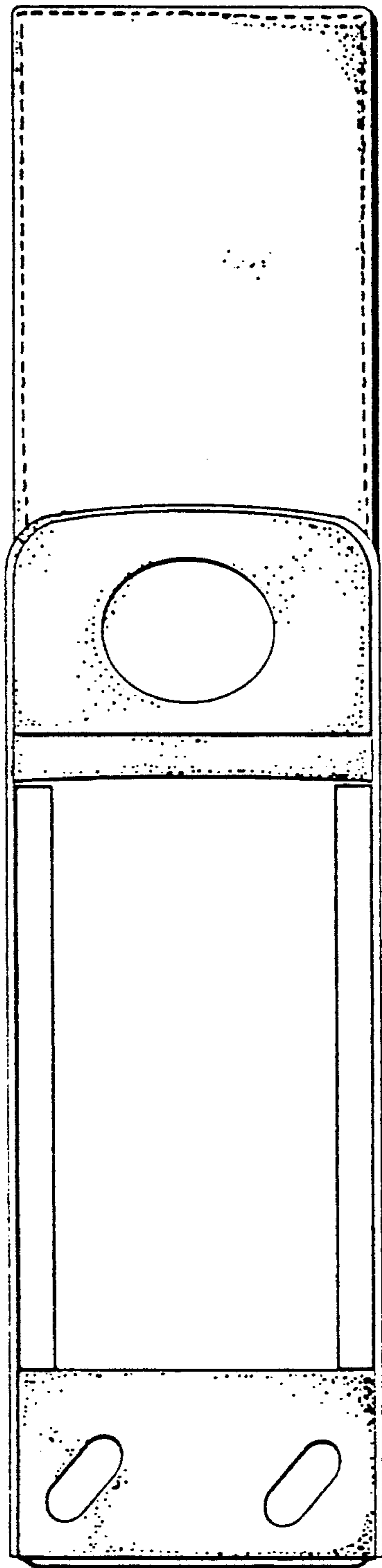

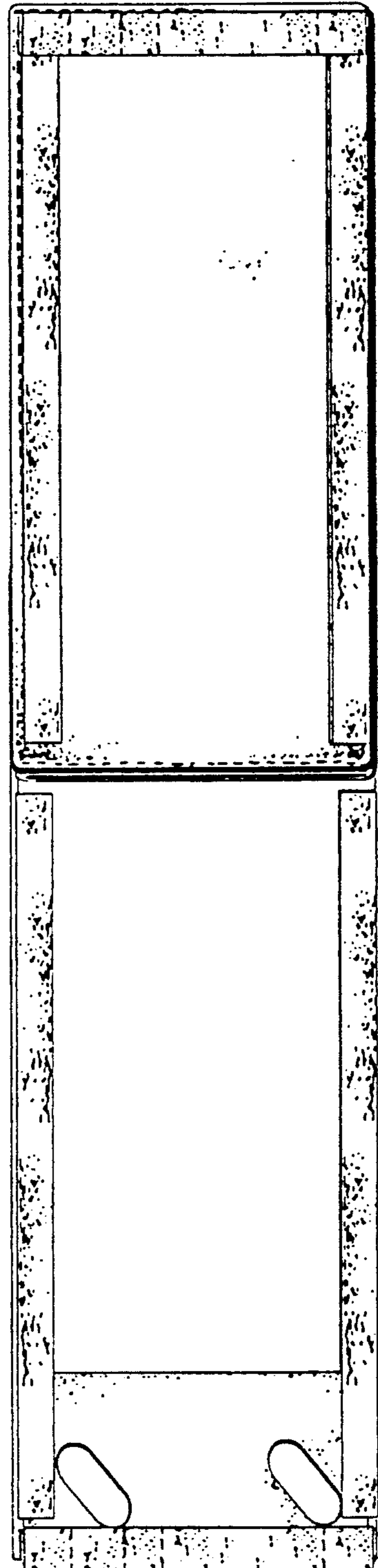

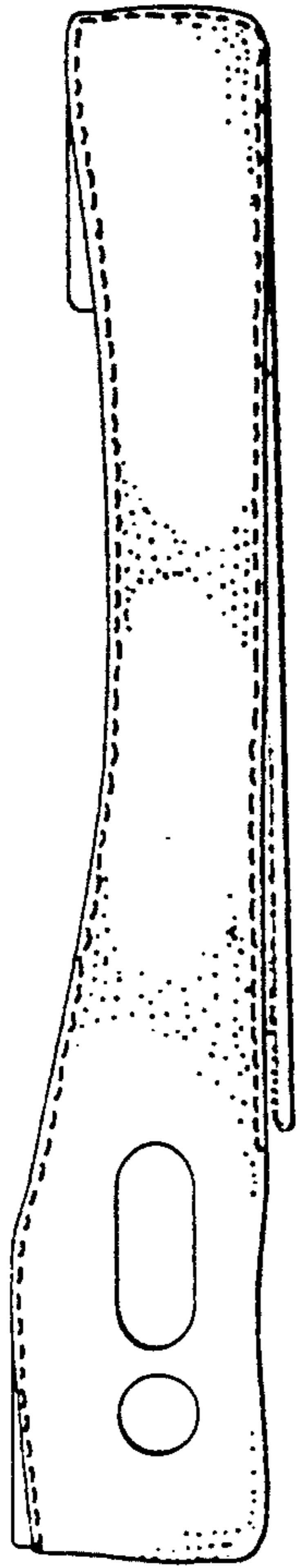

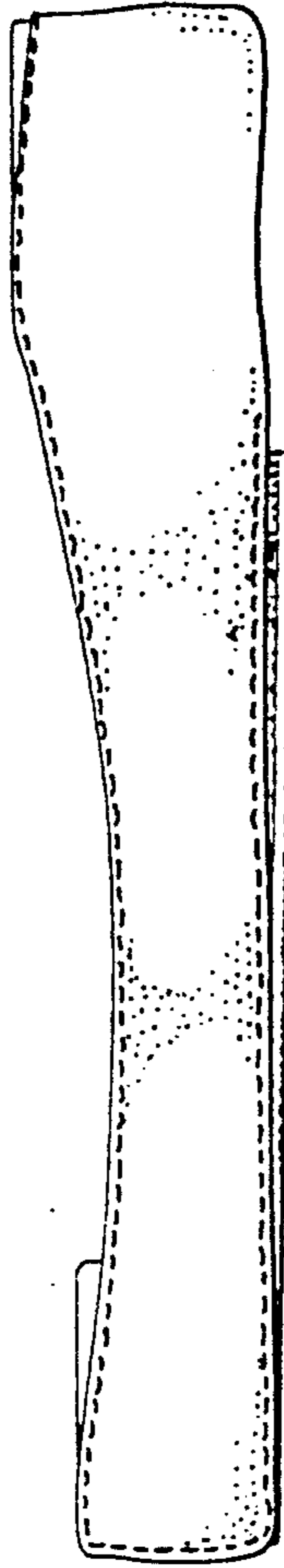

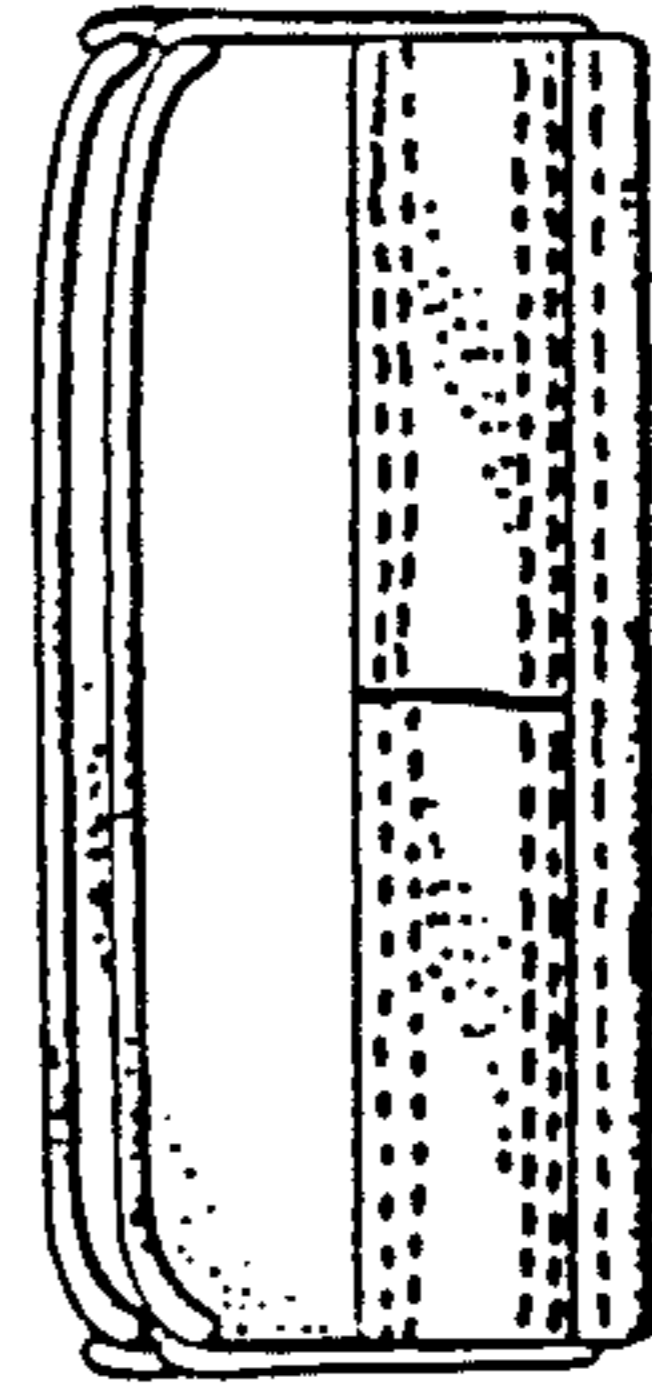

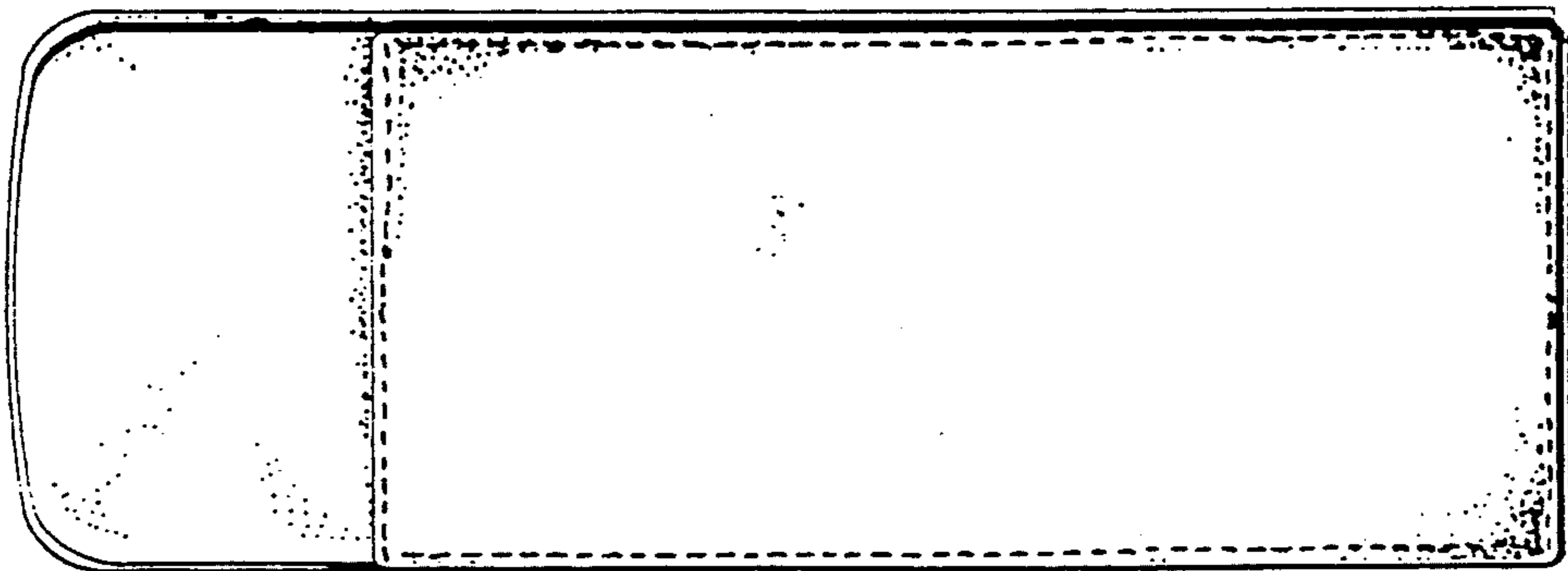

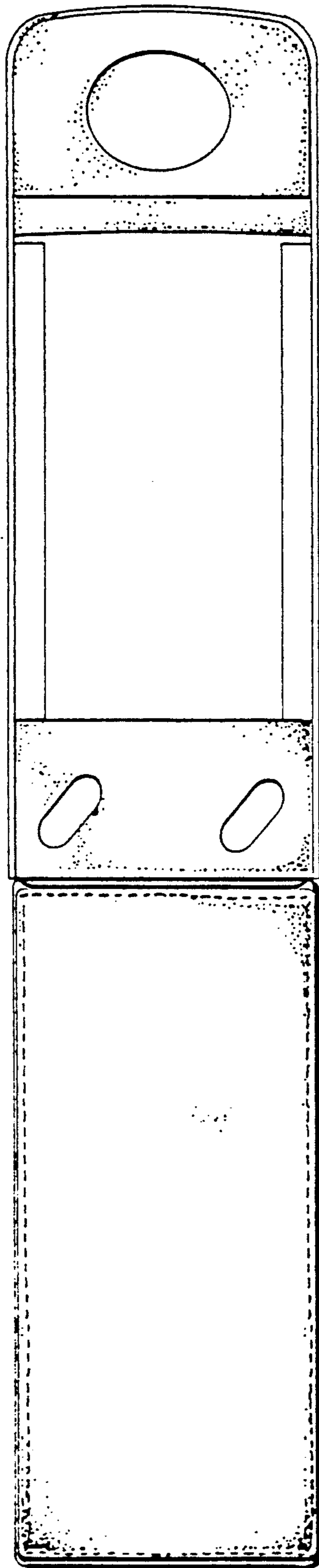

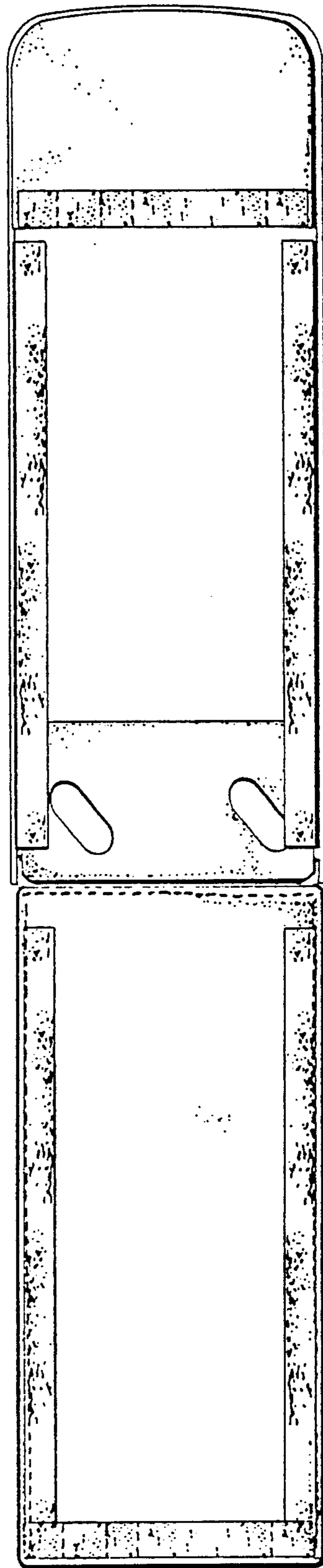
