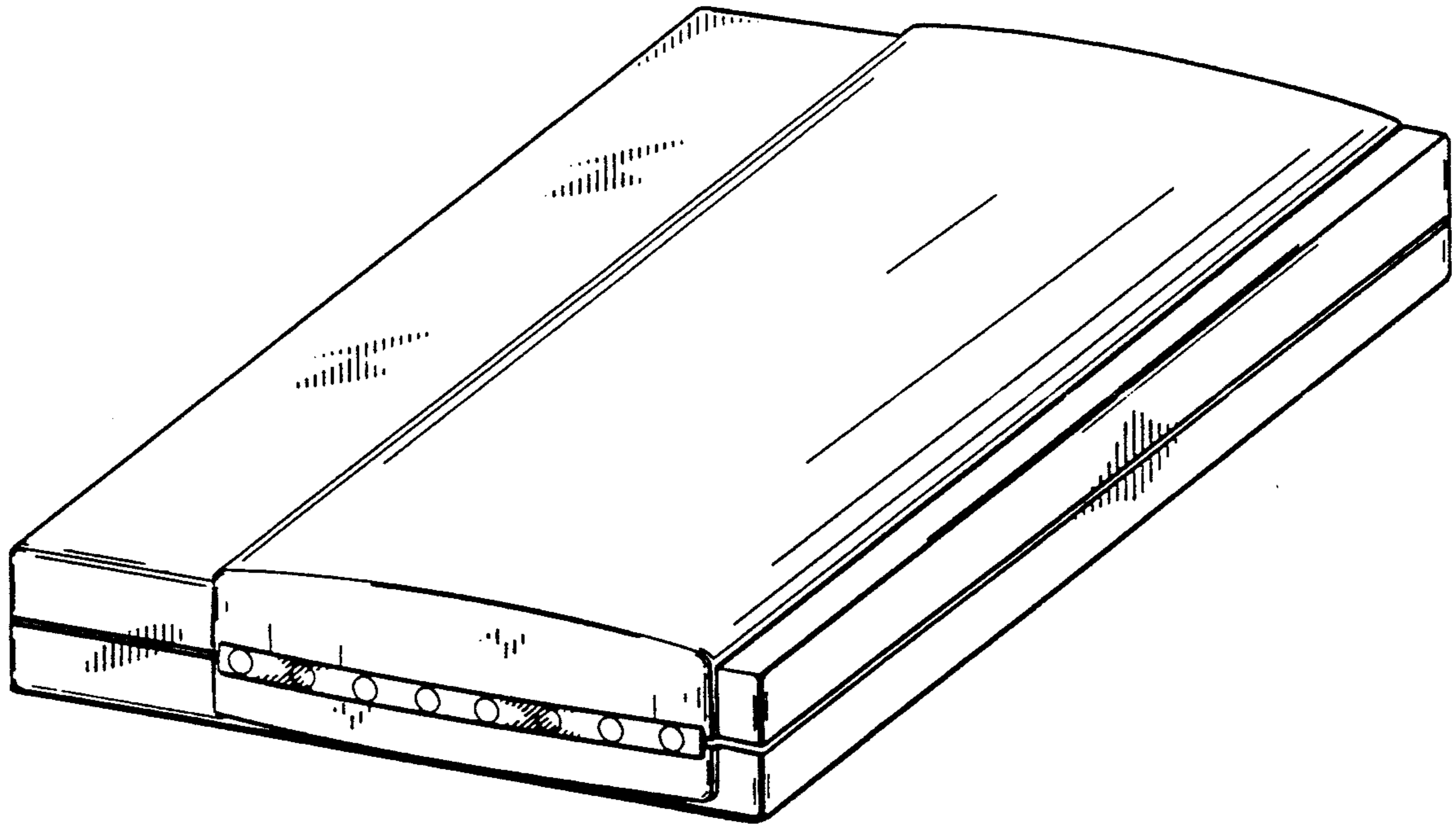

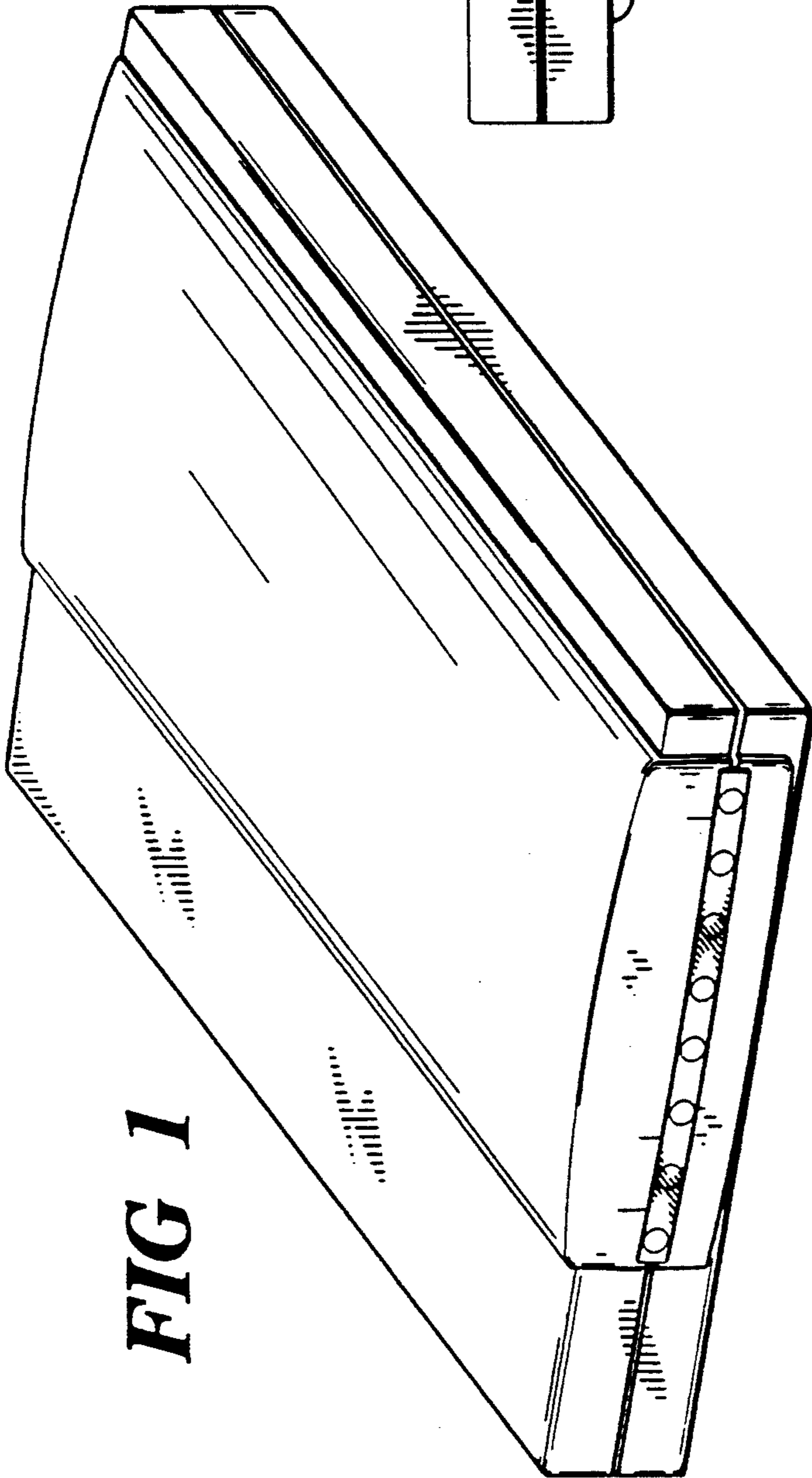
[57] **CLAIM**

The ornamental design for a modem, as shown.

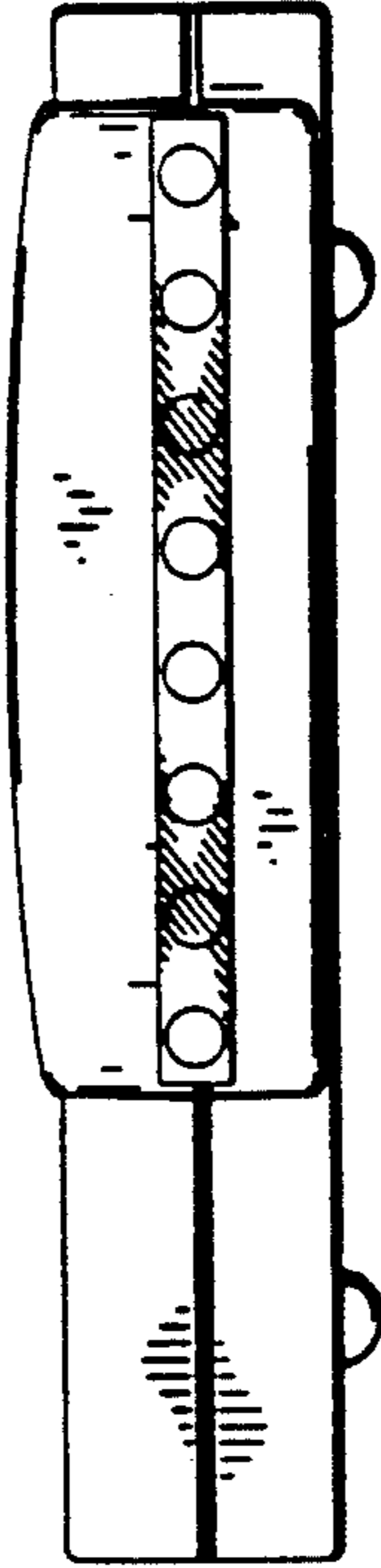
**DESCRIPTION**

FIG. 7 is a bottom plan view thereof.

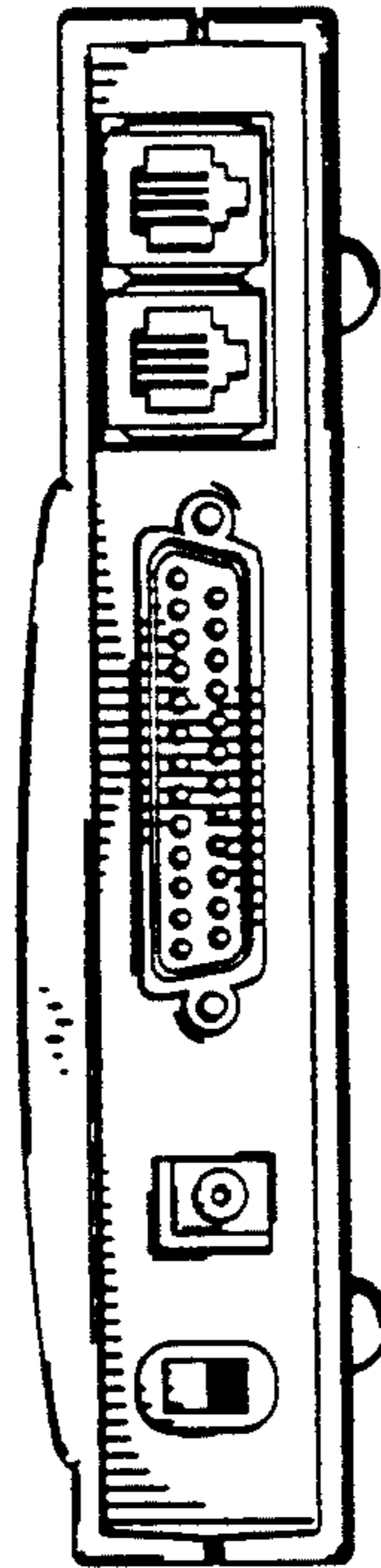




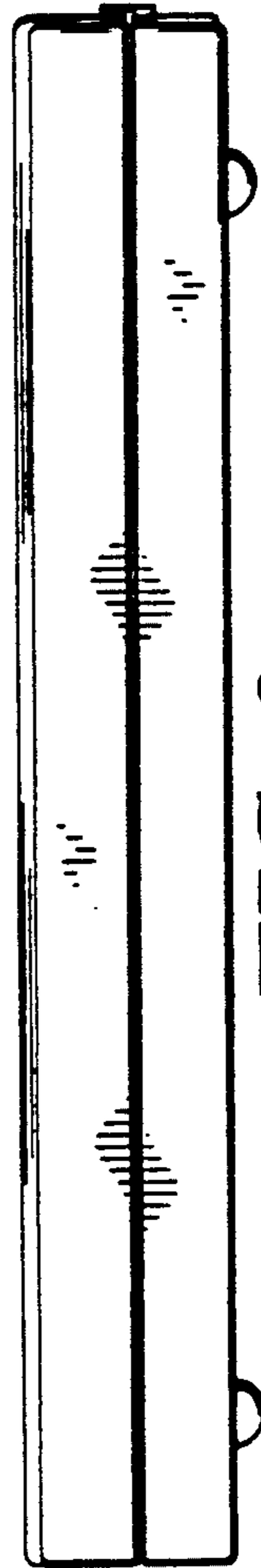

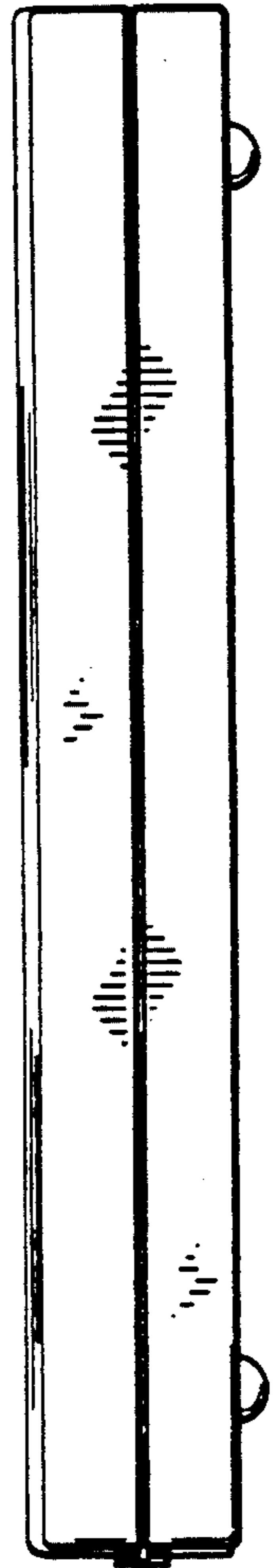

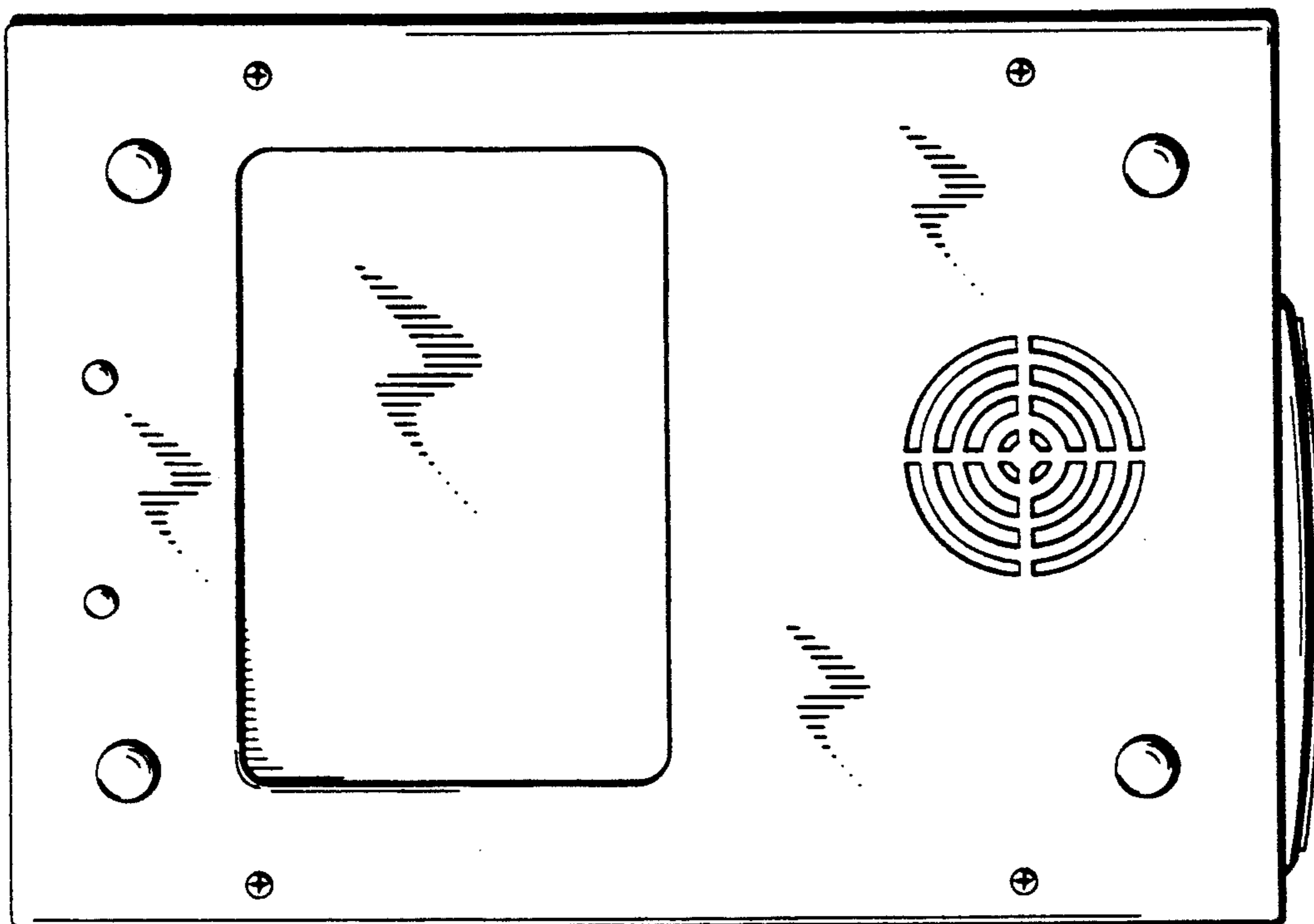

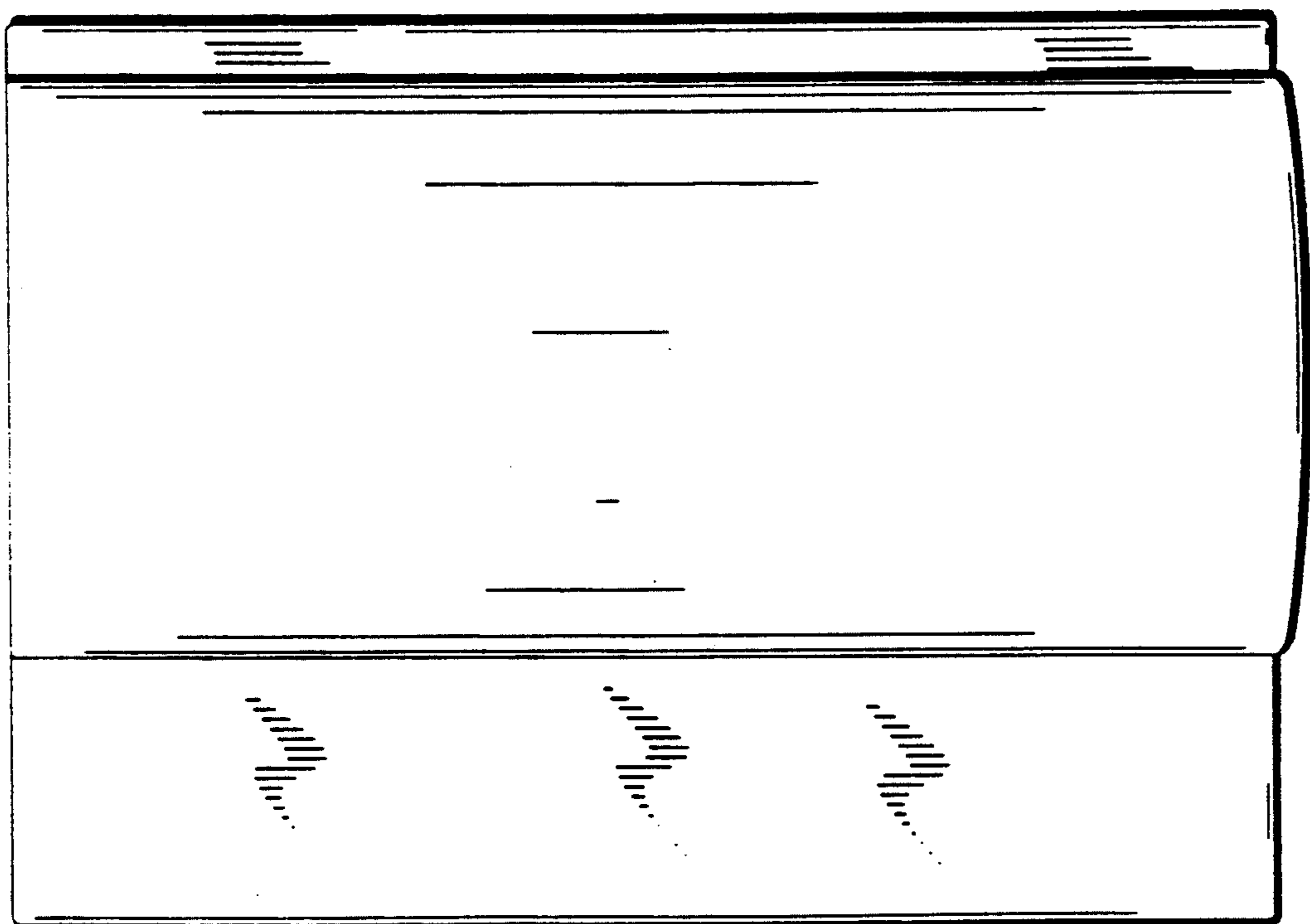
