[57] CLAIM

The ornamental design for a plumbing fitting handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from the top, front and right side of a plumbing fitting handle showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view thereof, the left side being a mirror image of the right side;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a perspective view taken from the top, front and right side of a second embodiment thereof;

FIG. 8 is a front elevational view of FIG. 7;

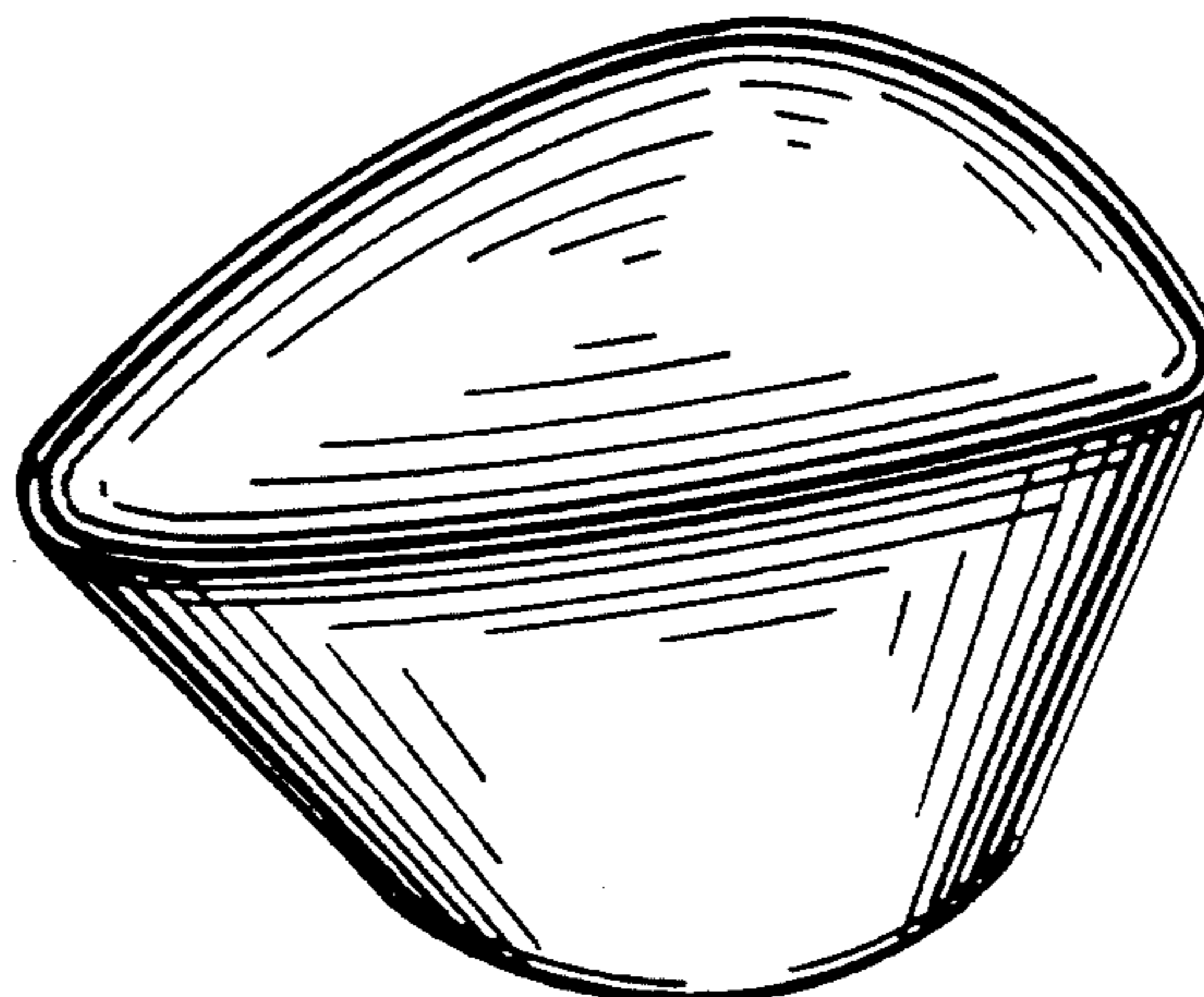
FIG. 9 is a right side elevational view of FIG. 7, the left side being a mirror image of the right side;

FIG. 10 is a top plan view of FIG. 7;

FIG. 11 is a bottom plan view of FIG. 7; and,

FIG. 12 is a rear elevational view of FIG. 7.

The fragmentary broken line representation of a hole in FIG. 6 is for the purpose of illustration only and forms no part of the claimed design.



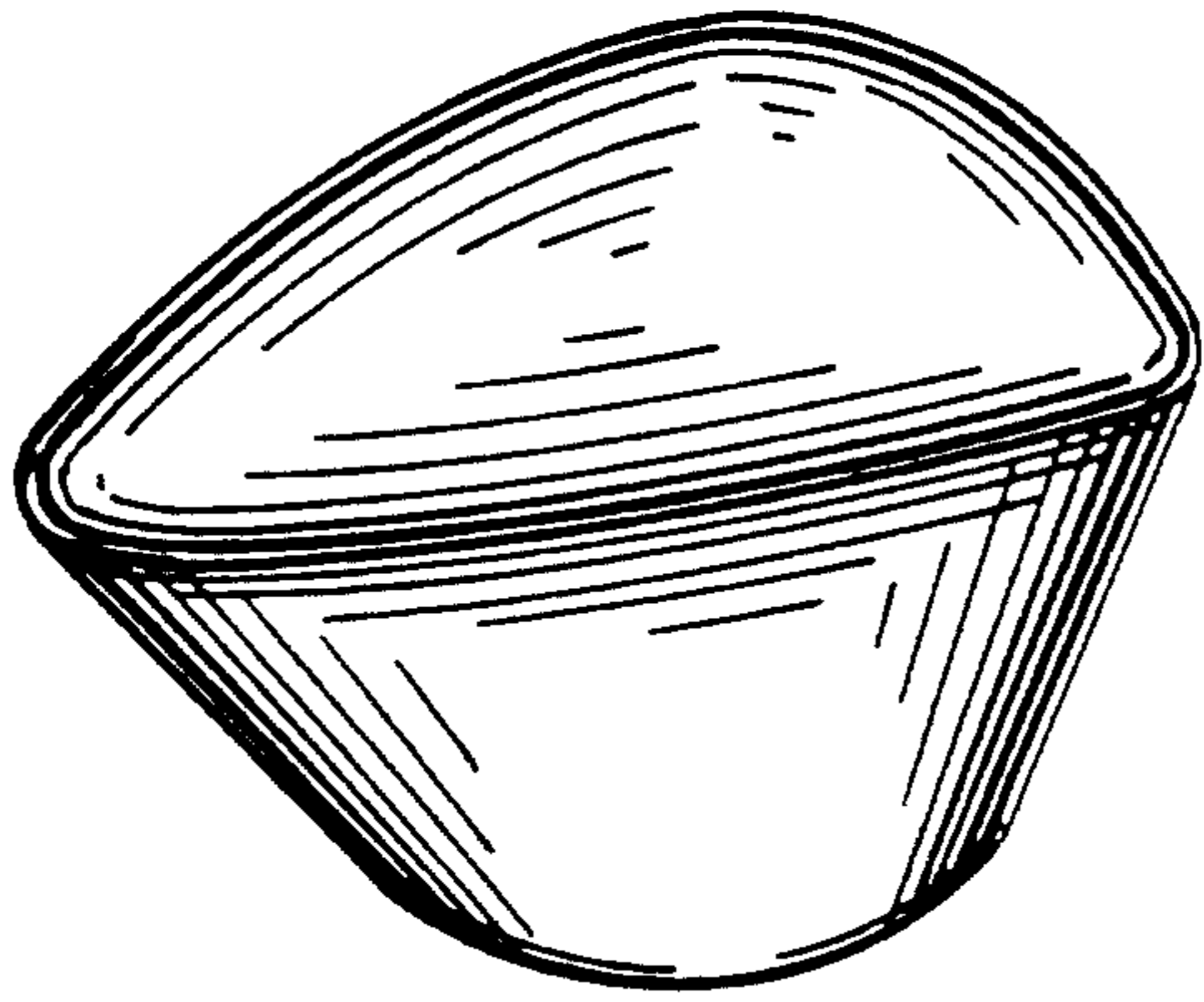

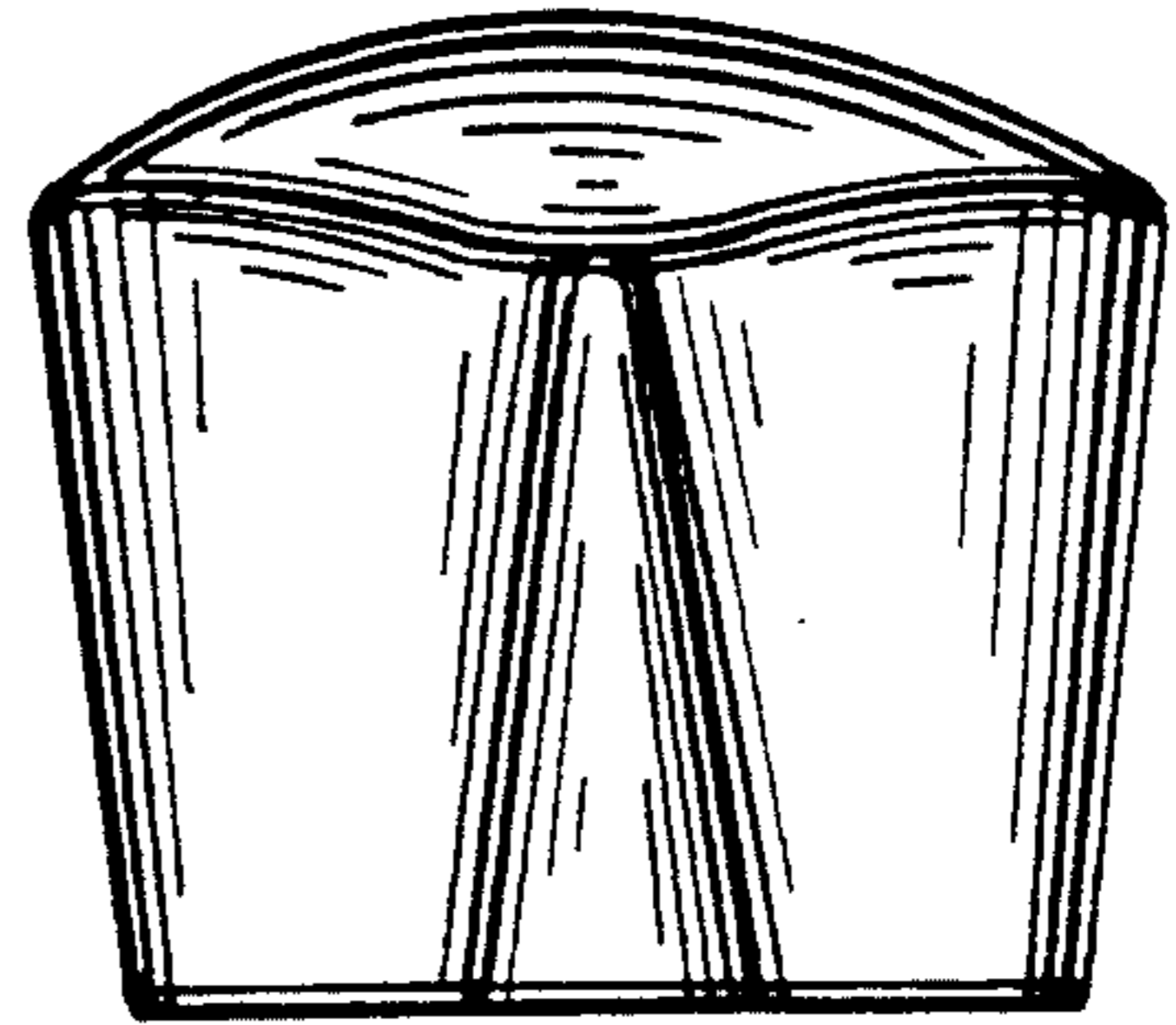

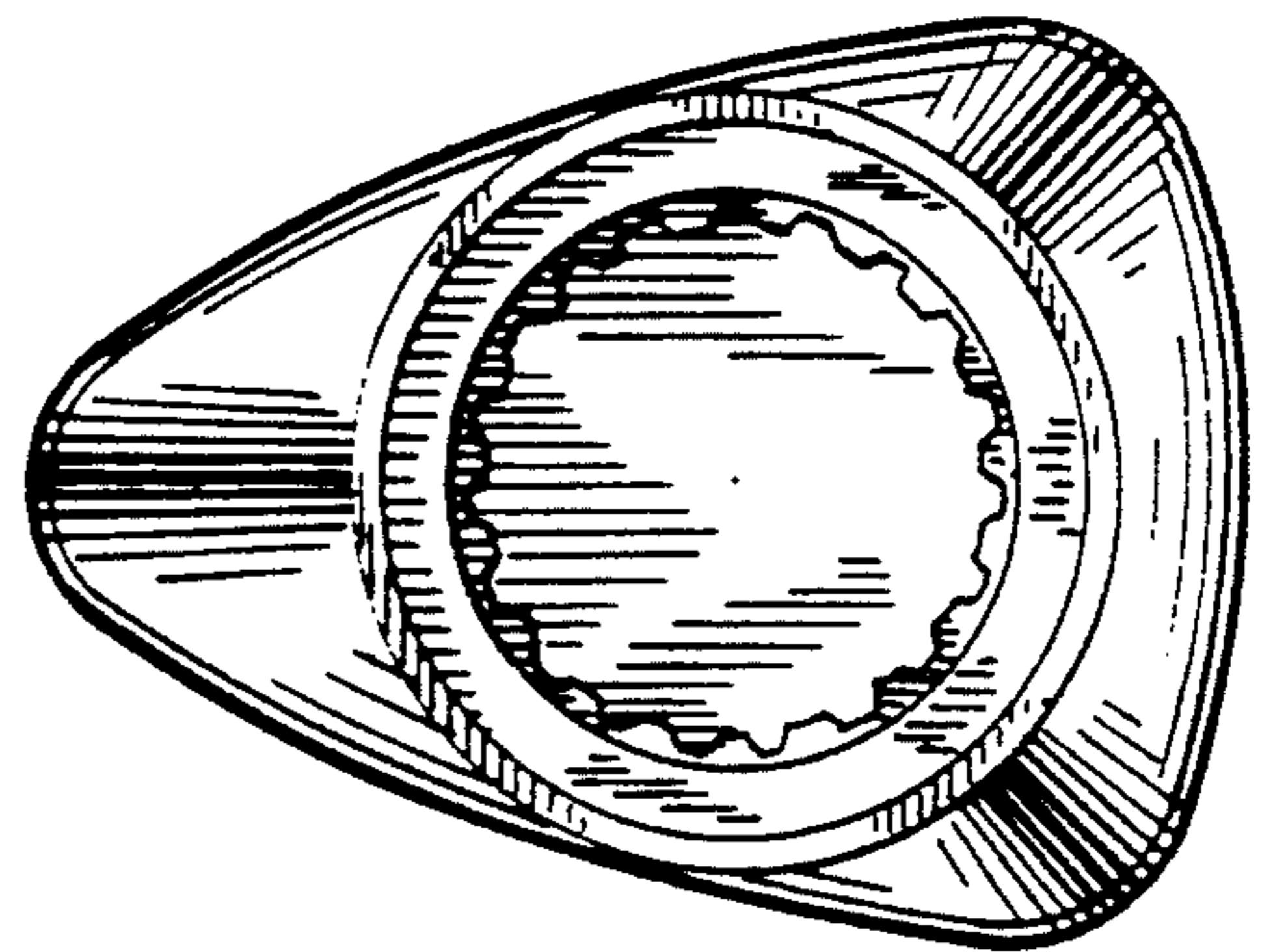
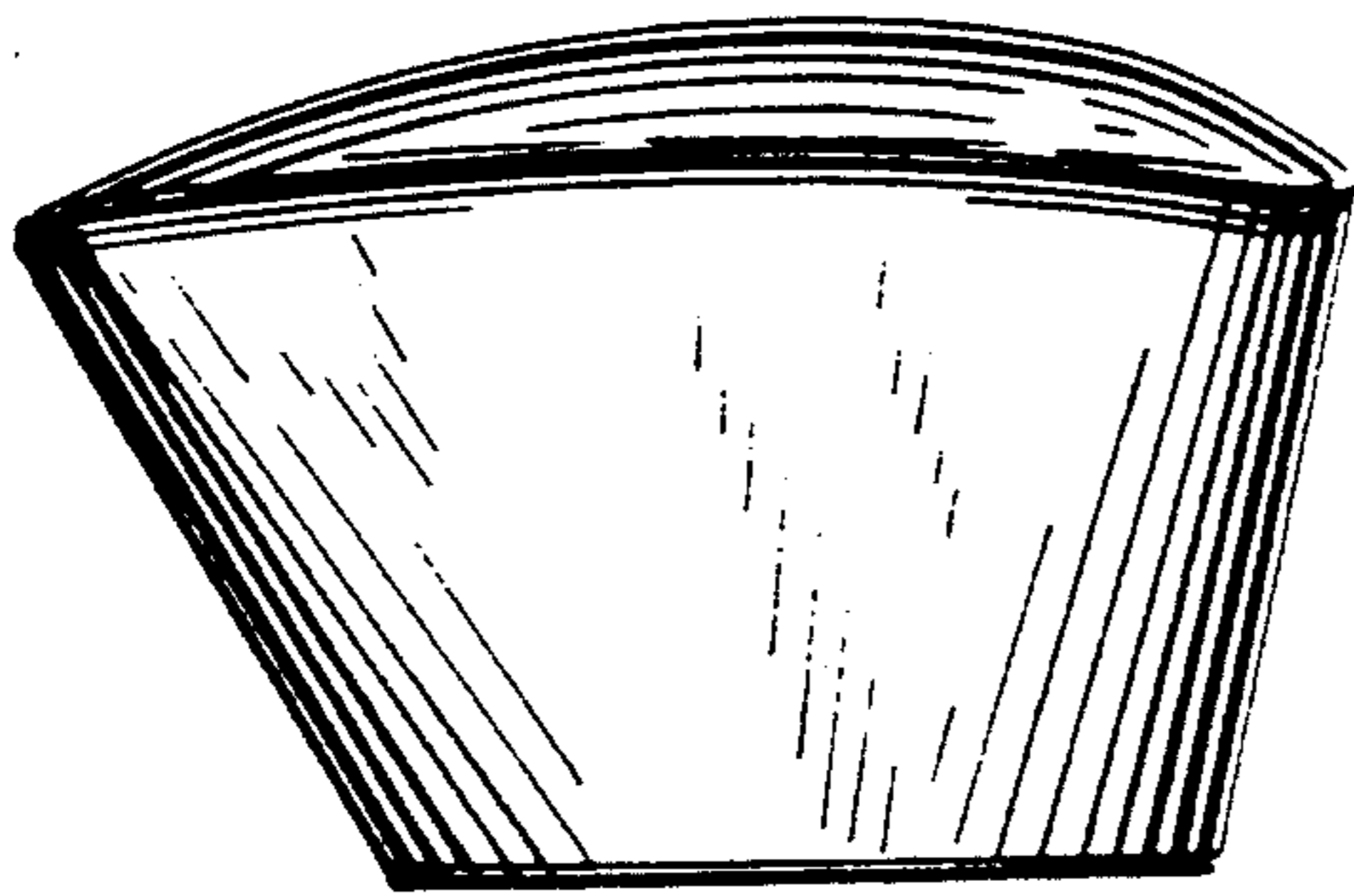

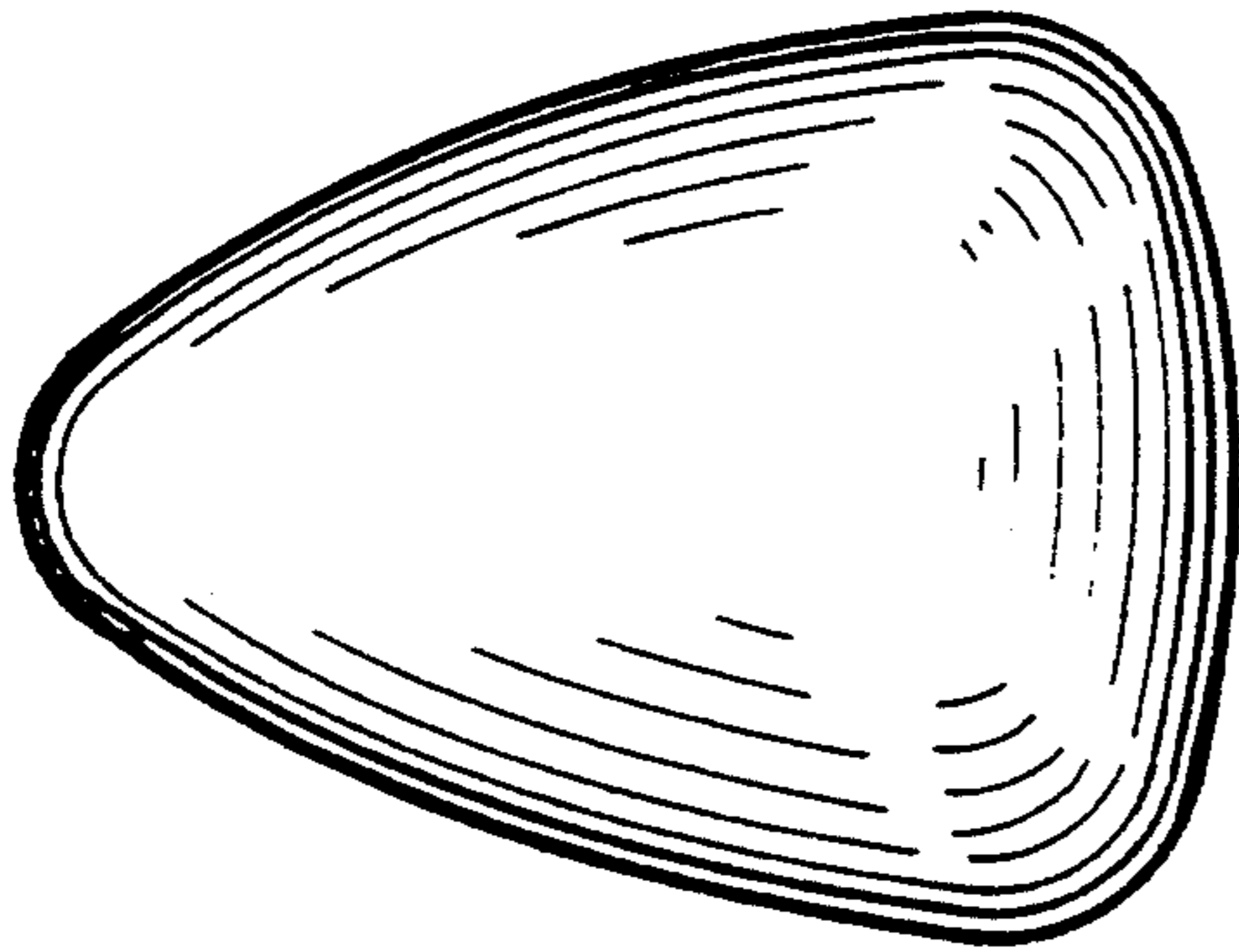

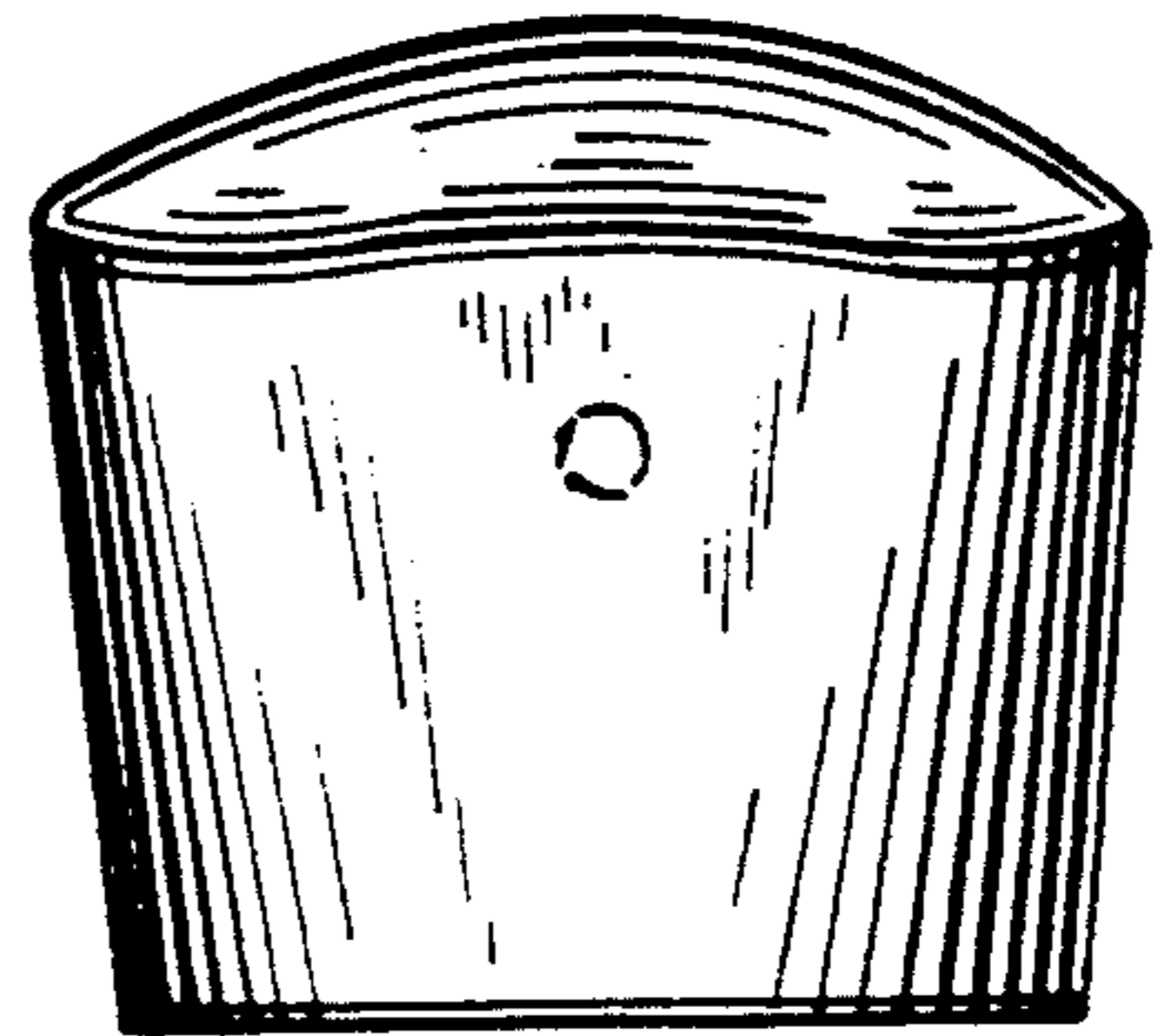

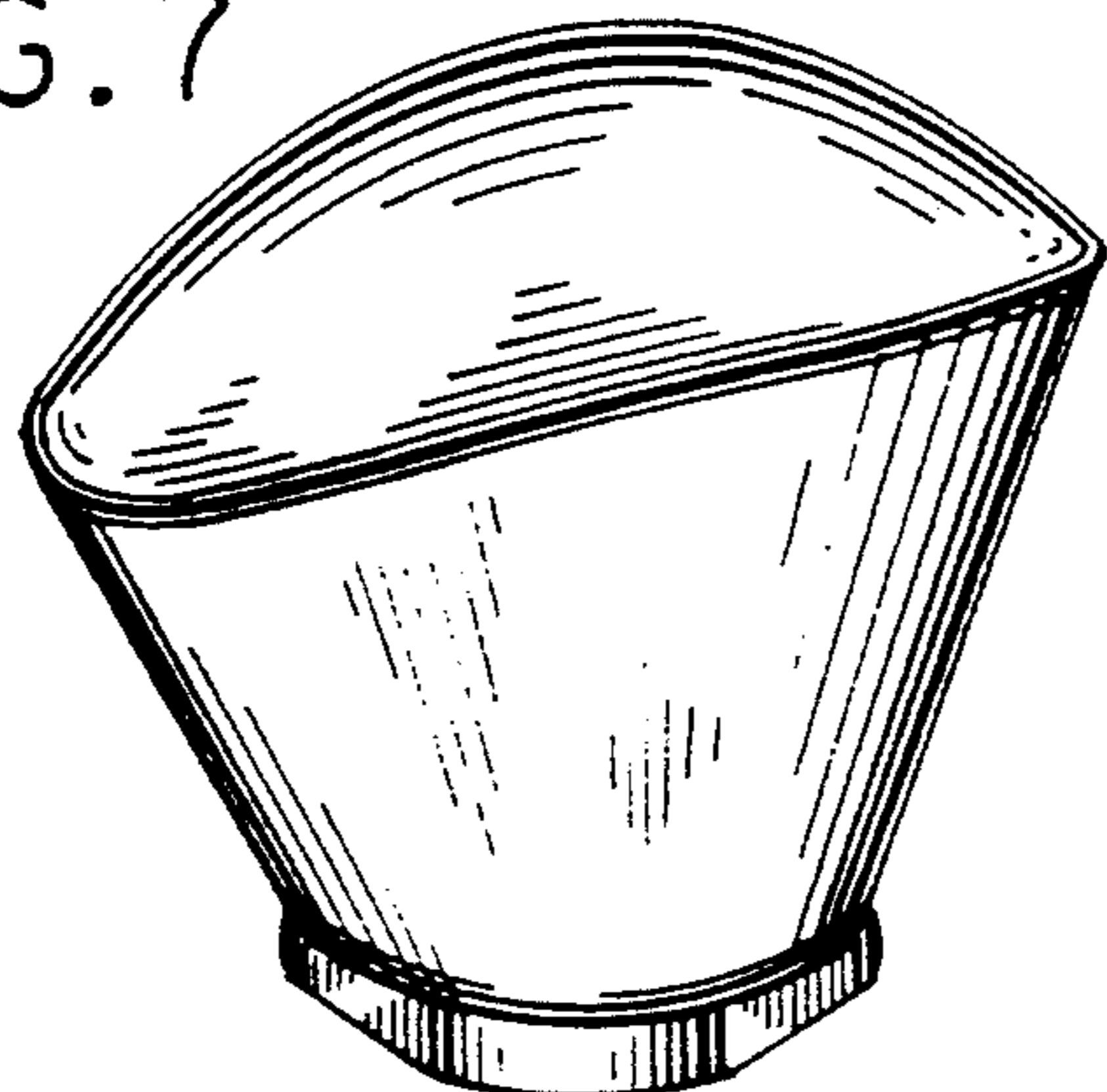

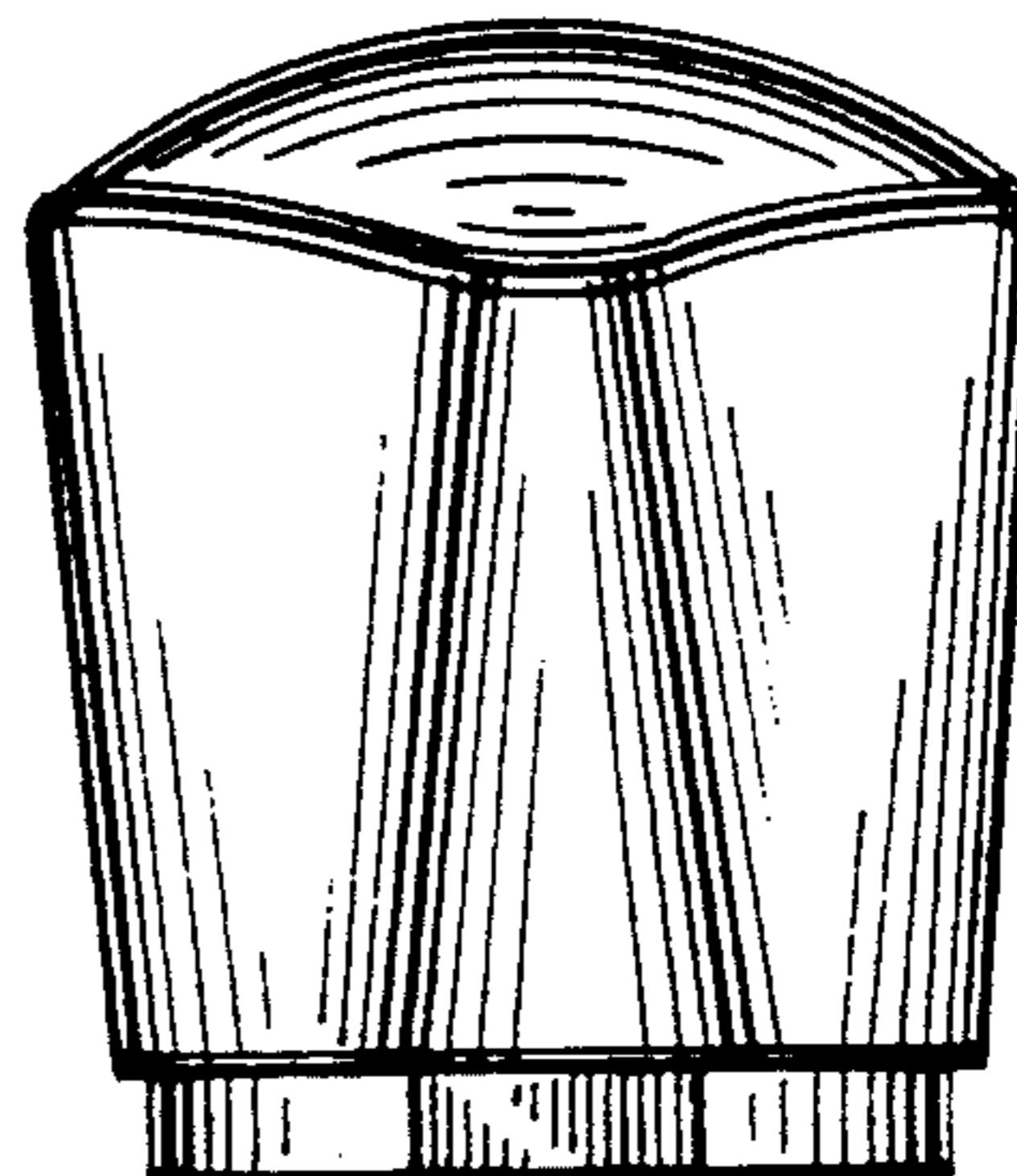

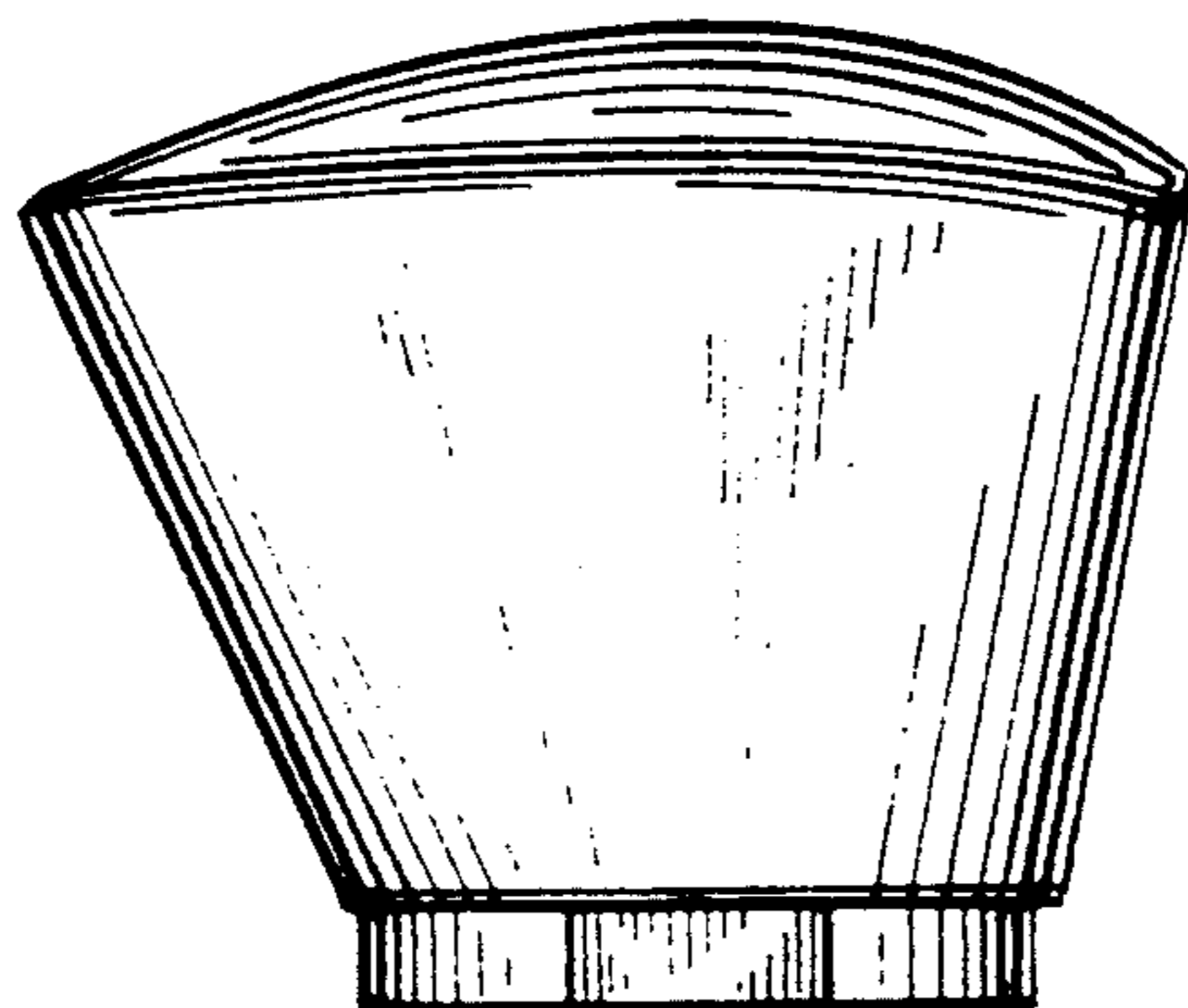

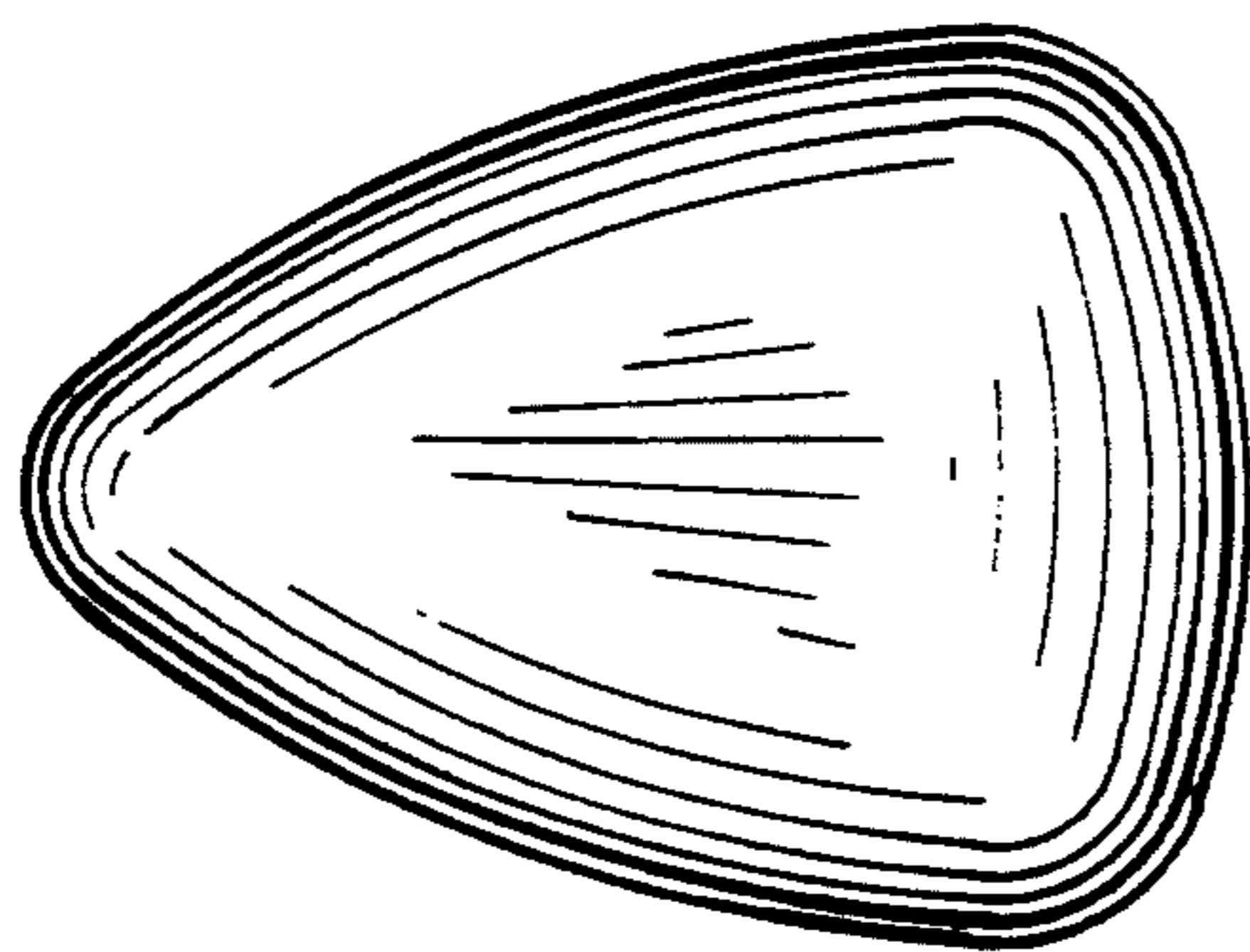
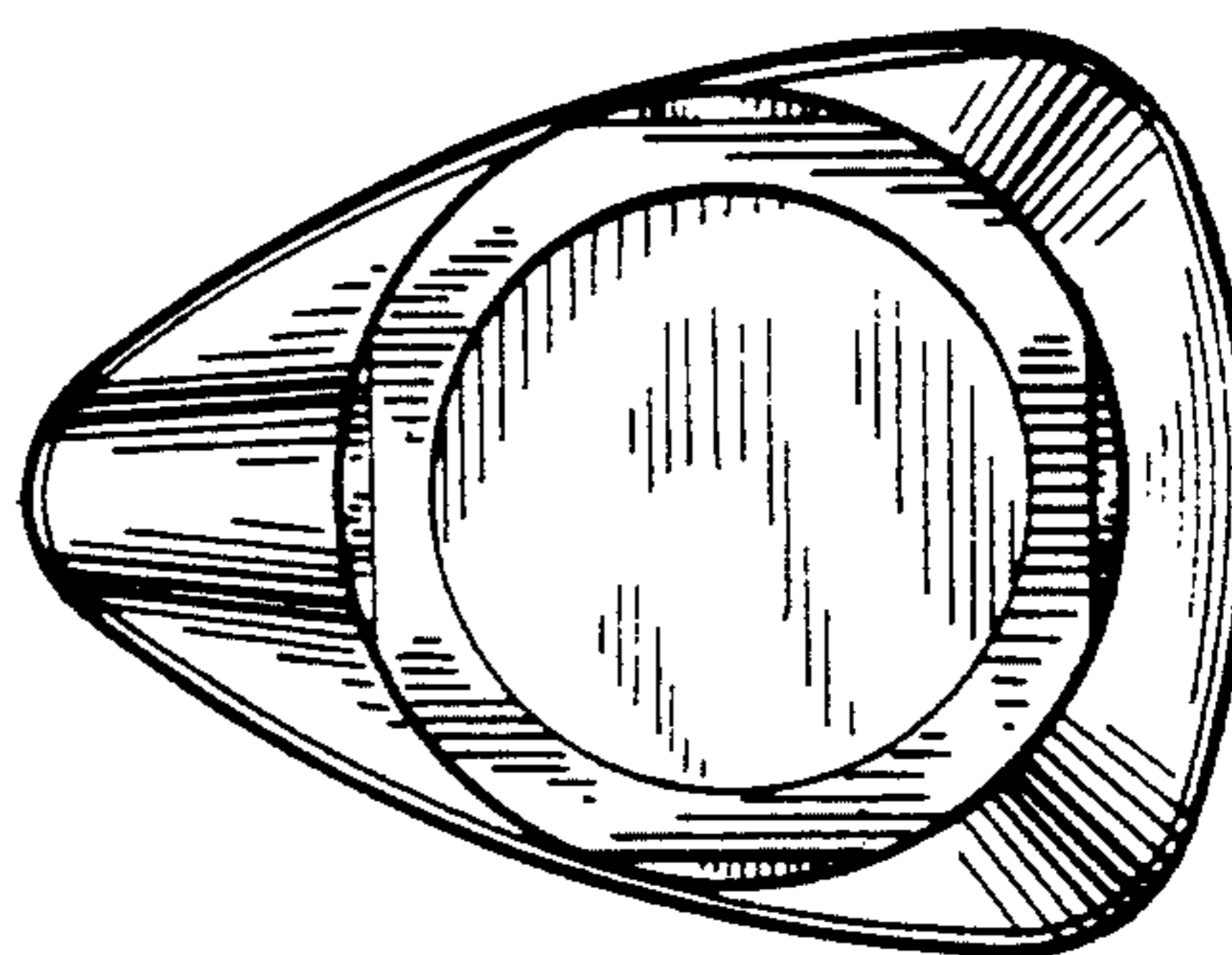

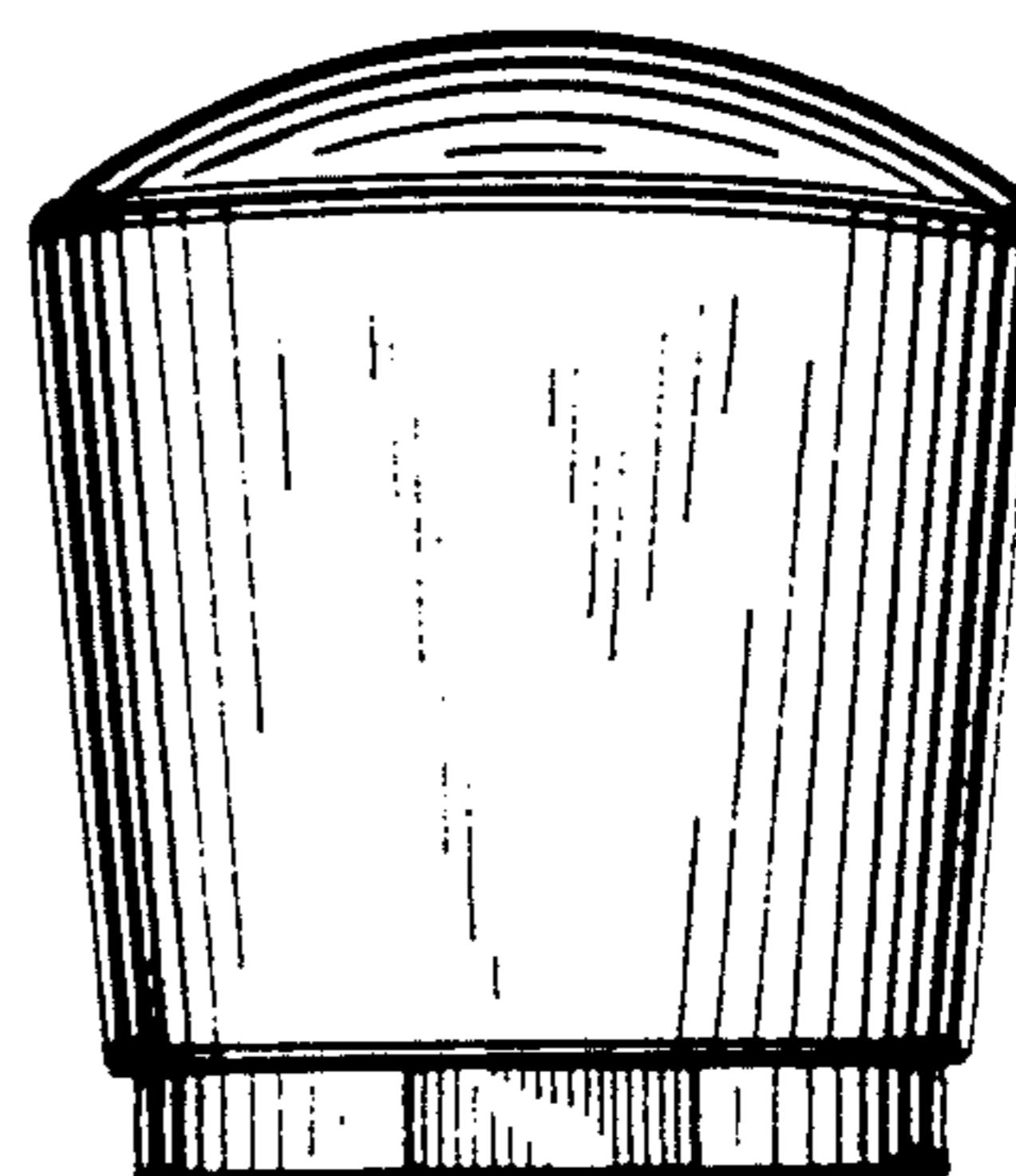
