### [57] CLAIM

The ornamental design for a denture bath container, as shown and described.

### DESCRIPTION

FIG. 1 is a top plan view thereof, with the container closed;  
 FIG. 2 is a bottom plan view thereof;  
 FIG. 3 is a front elevational view thereof;  
 FIG. 4 is a rear elevational view thereof;  
 FIG. 5 is a right side elevational view thereof, the left side being a mirror image;  
 FIG. 6 is top plan view thereof with the container open; and,  
 FIG. 7 is a right side elevational view thereof, the left side being a mirror image.

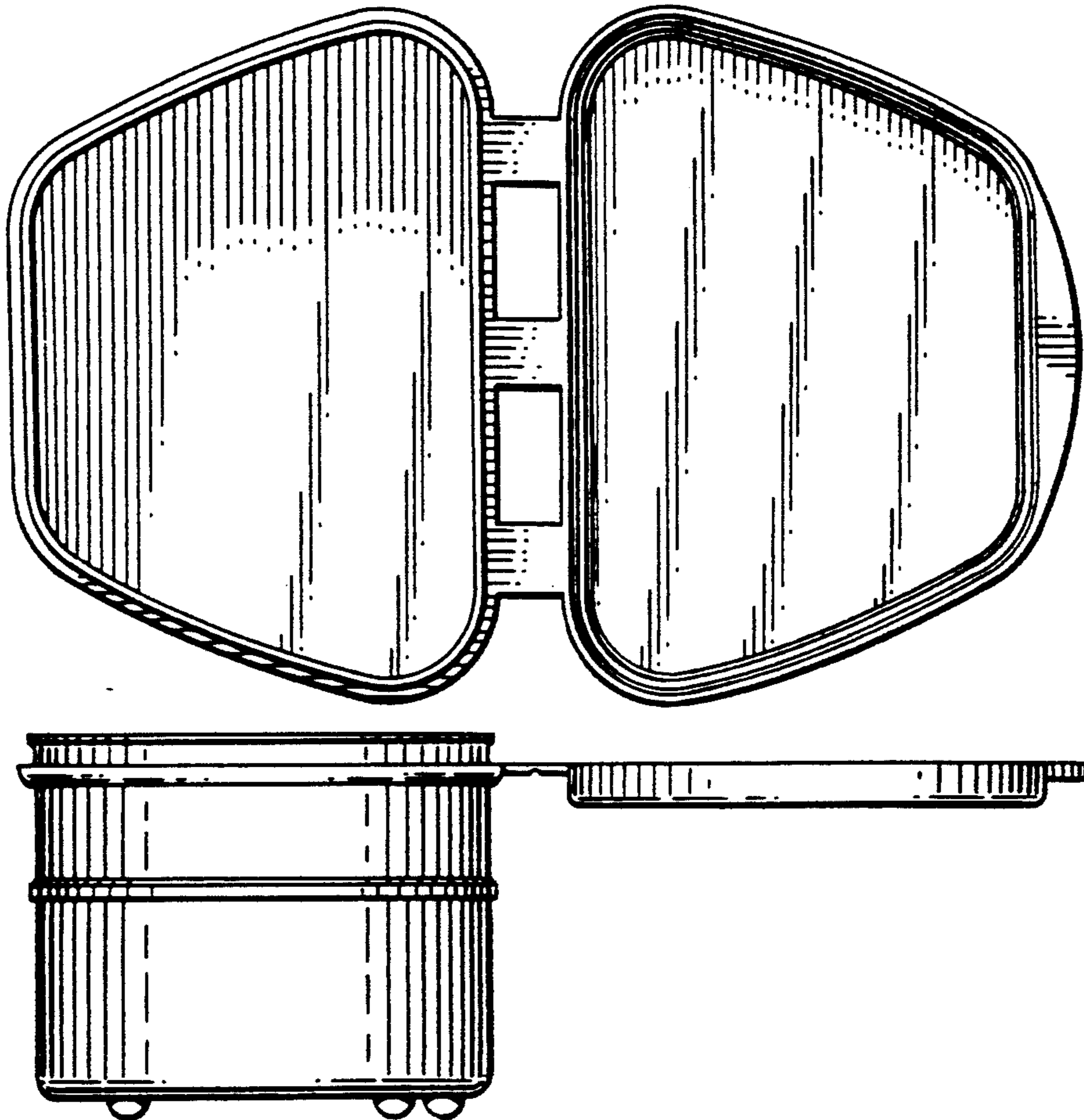

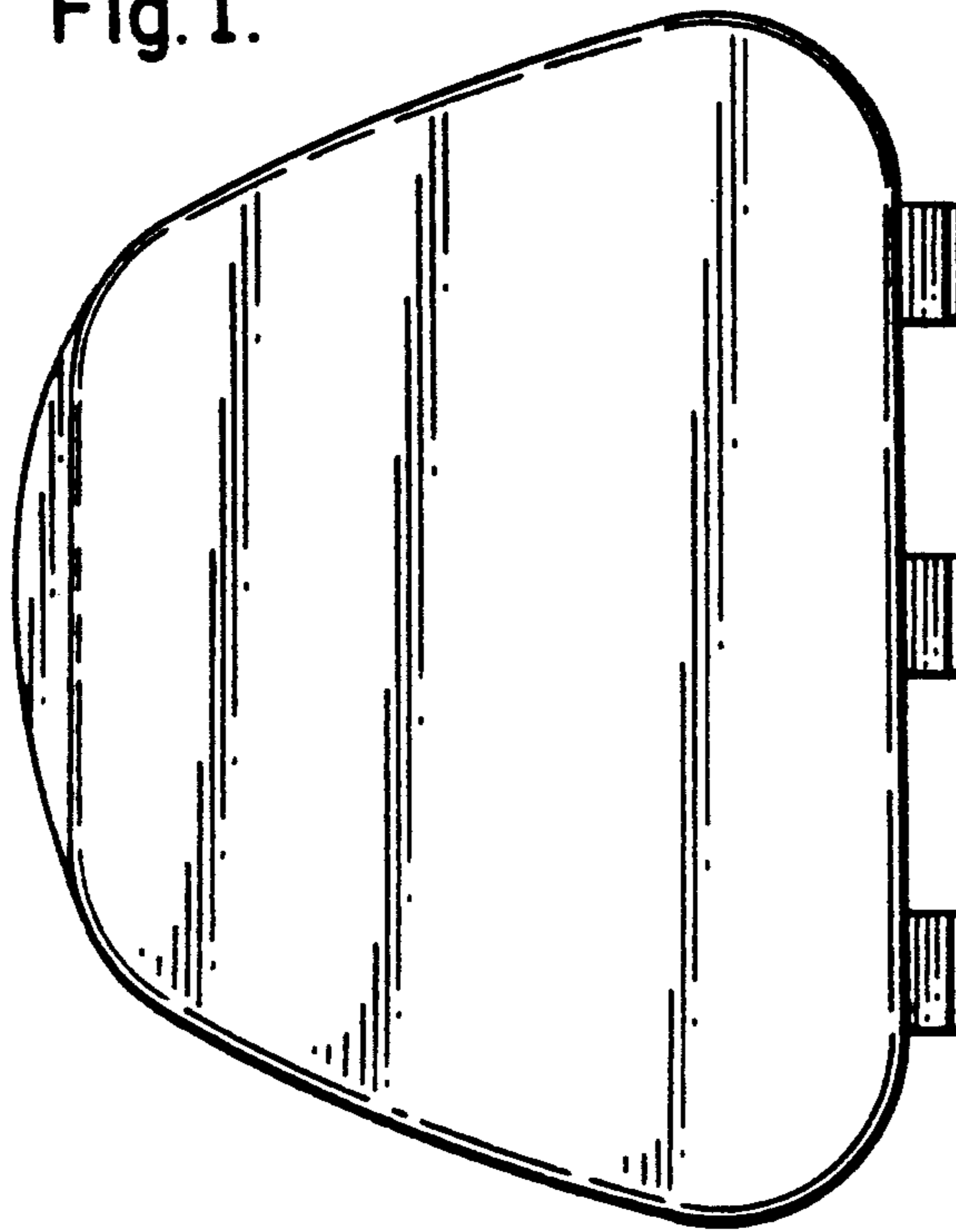

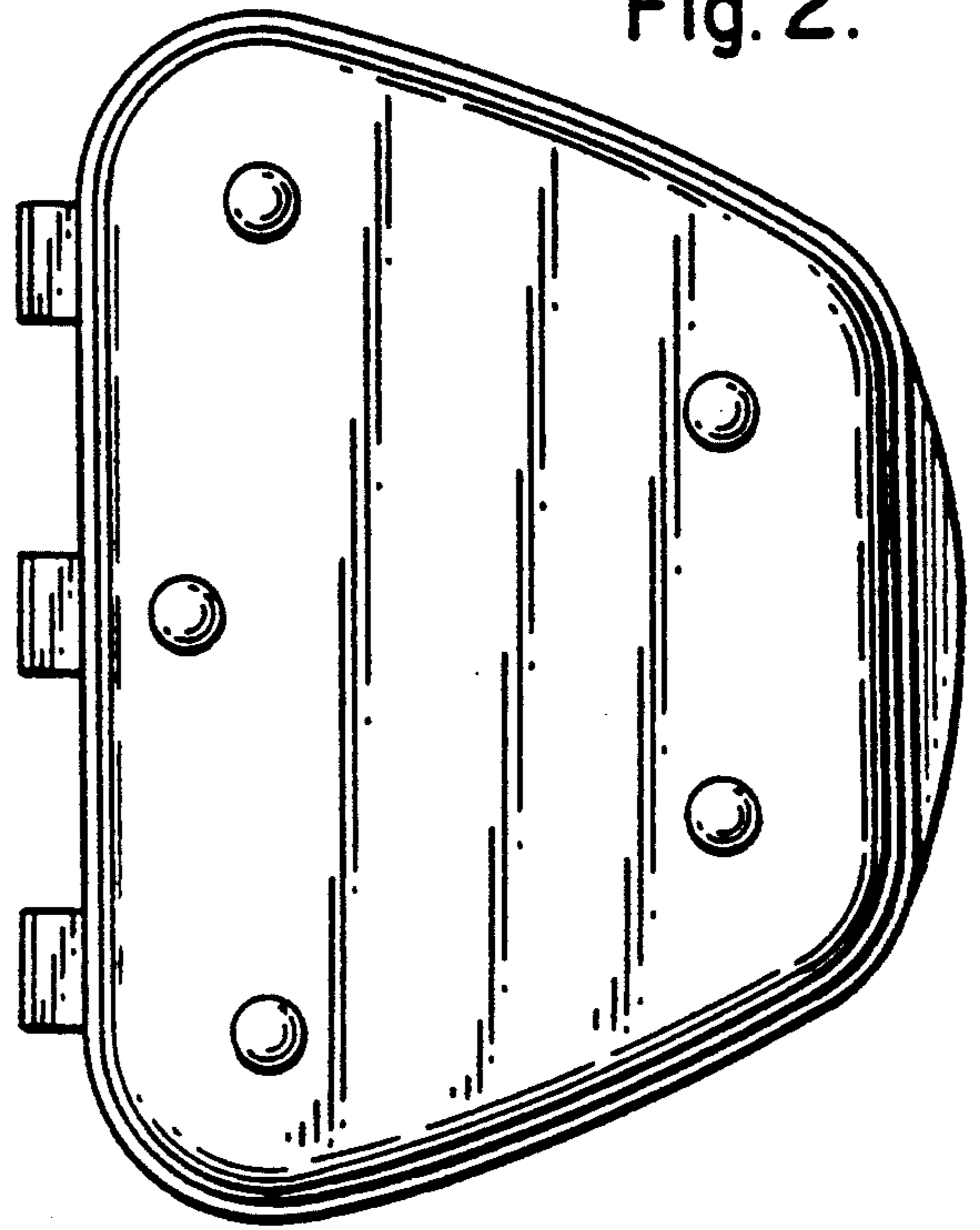

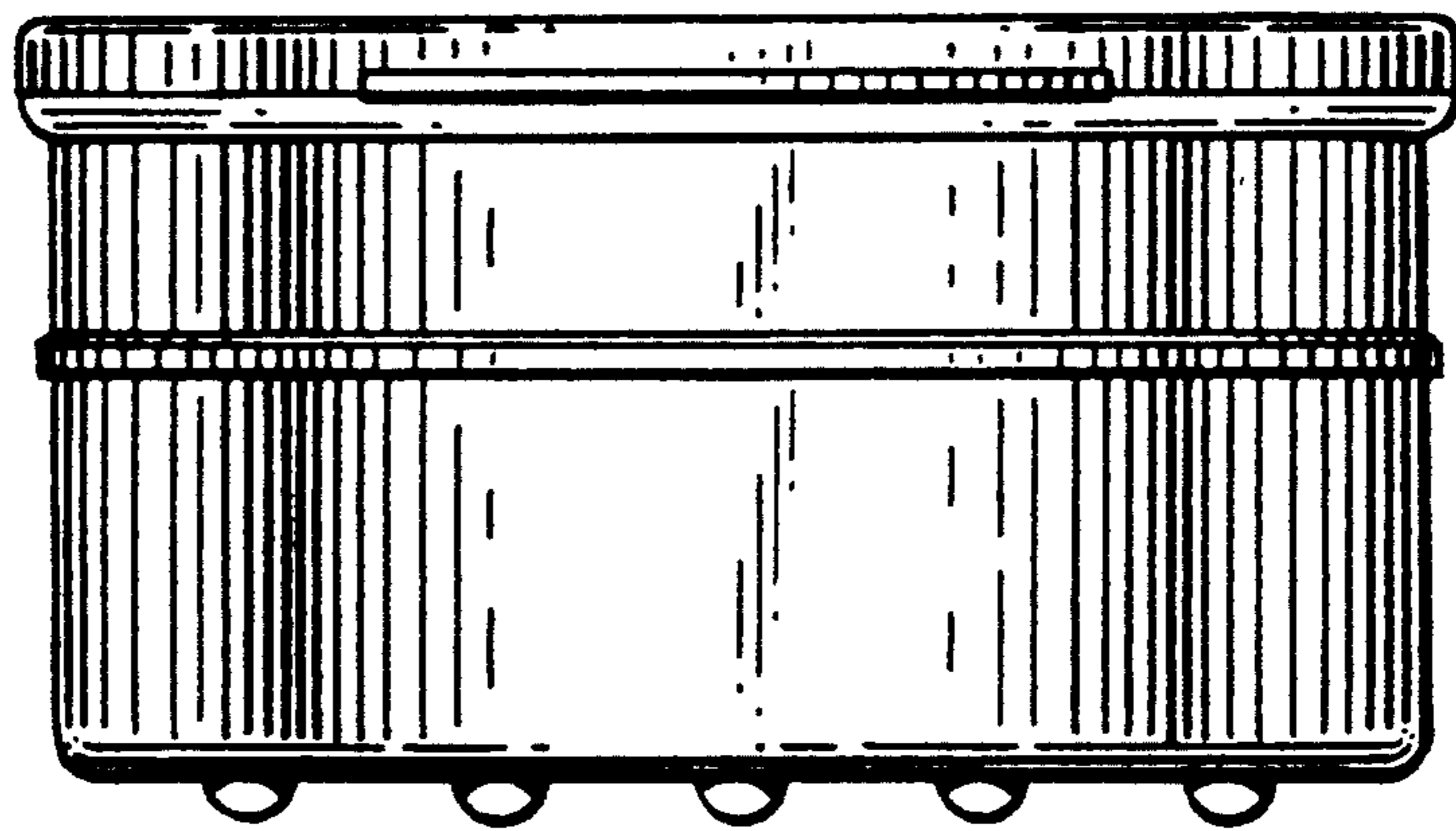

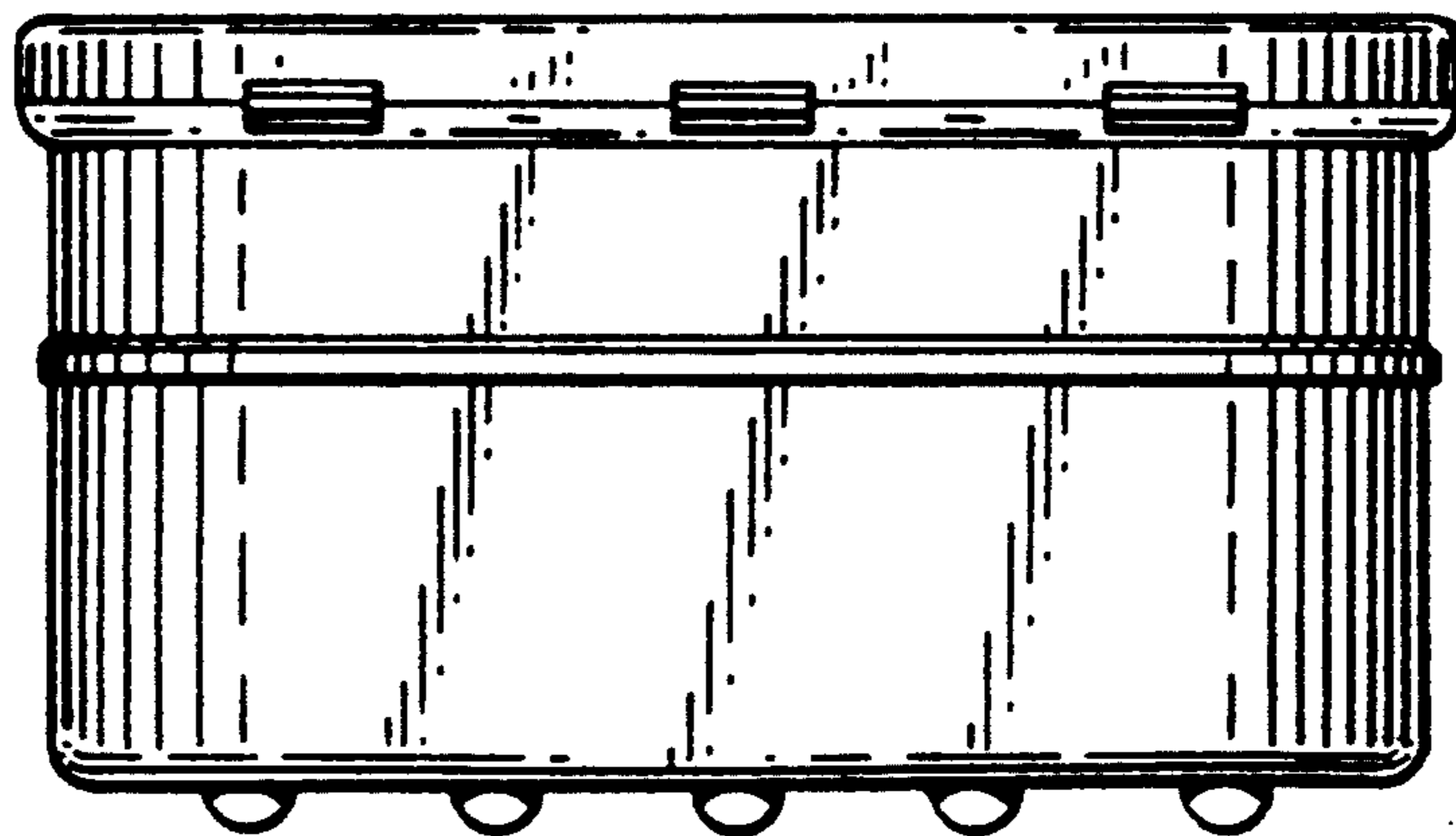

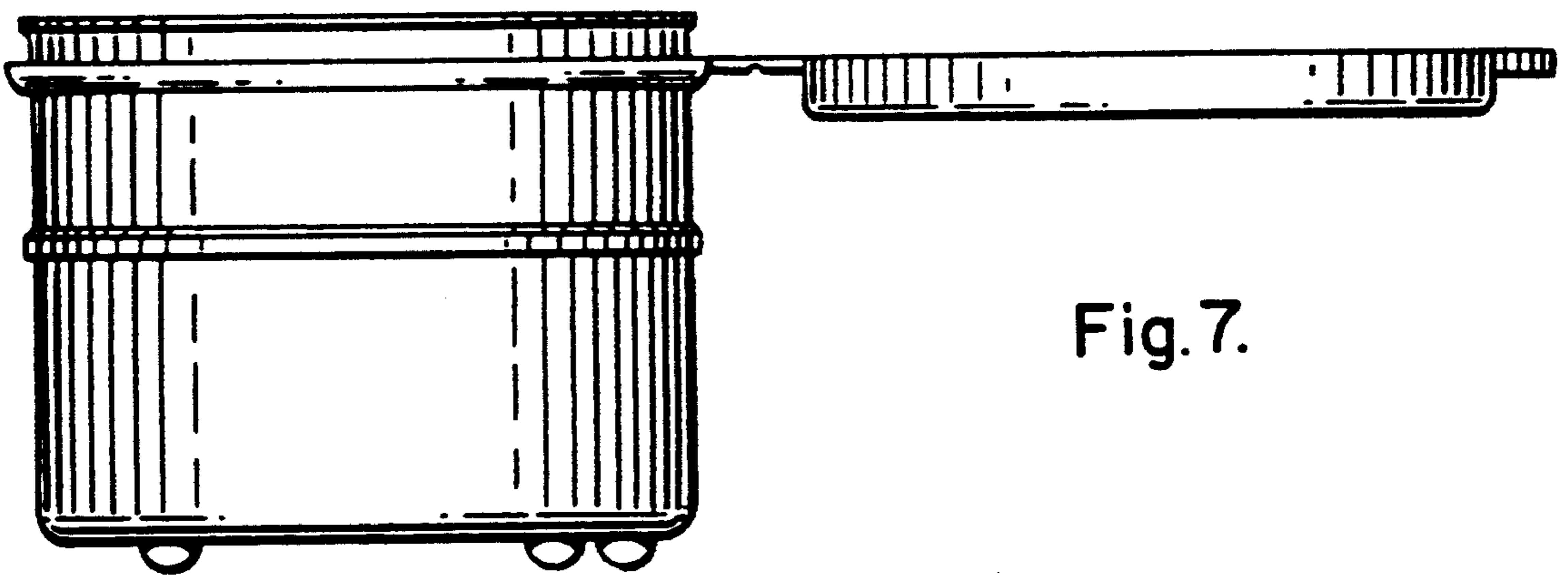
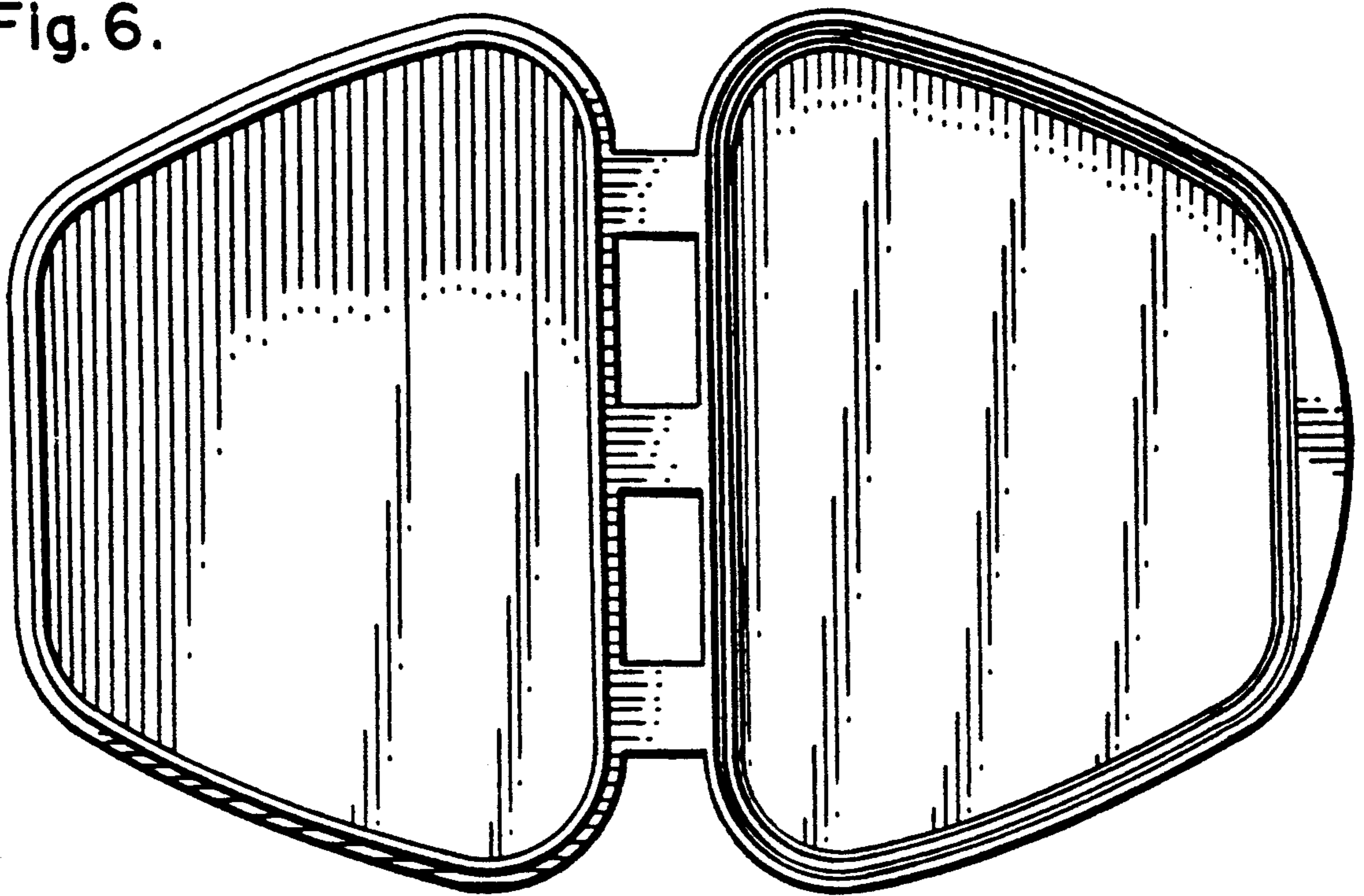

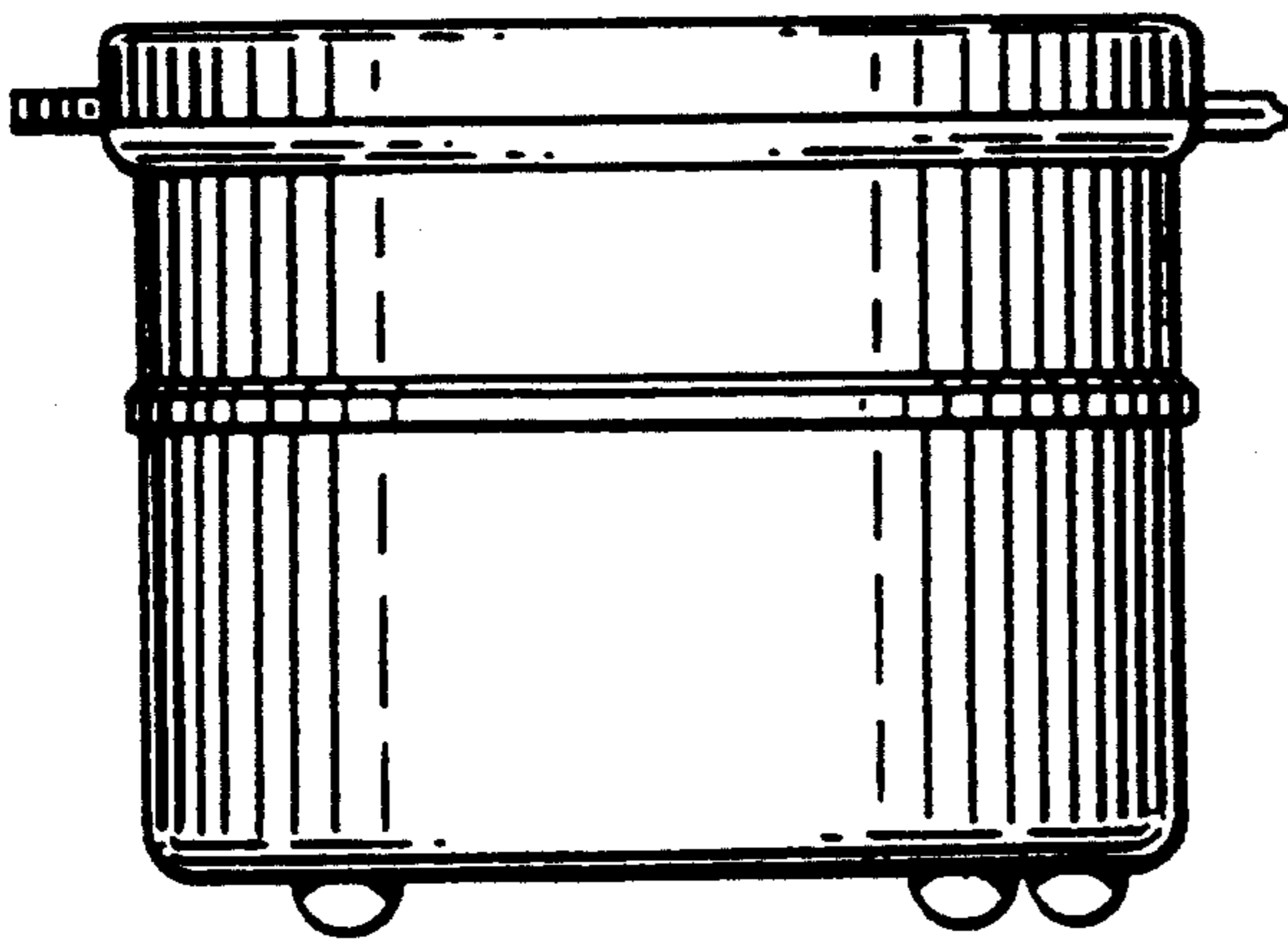
