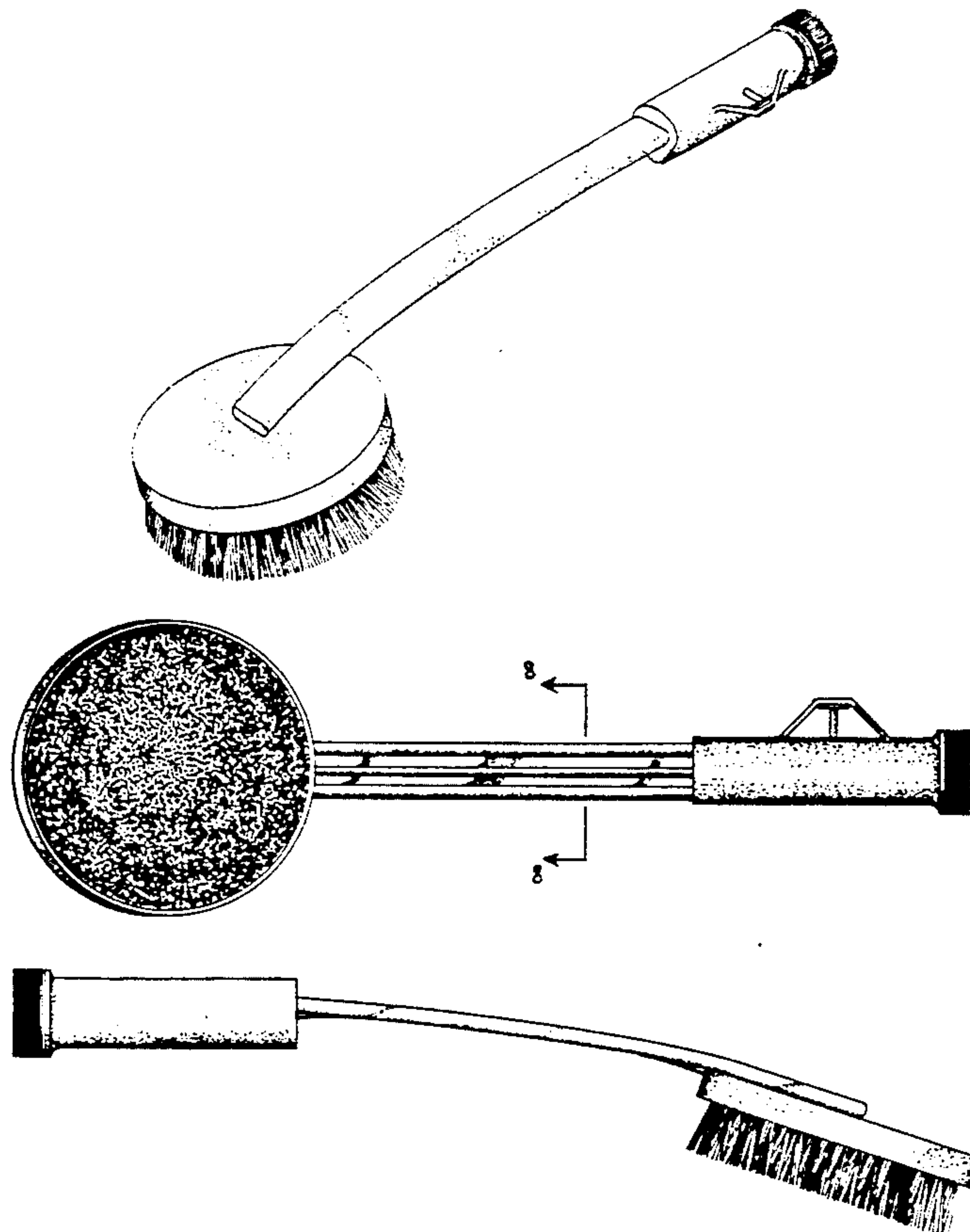

 FIG. 8 is a sectional view taken along line 8—8 in FIG. 3.



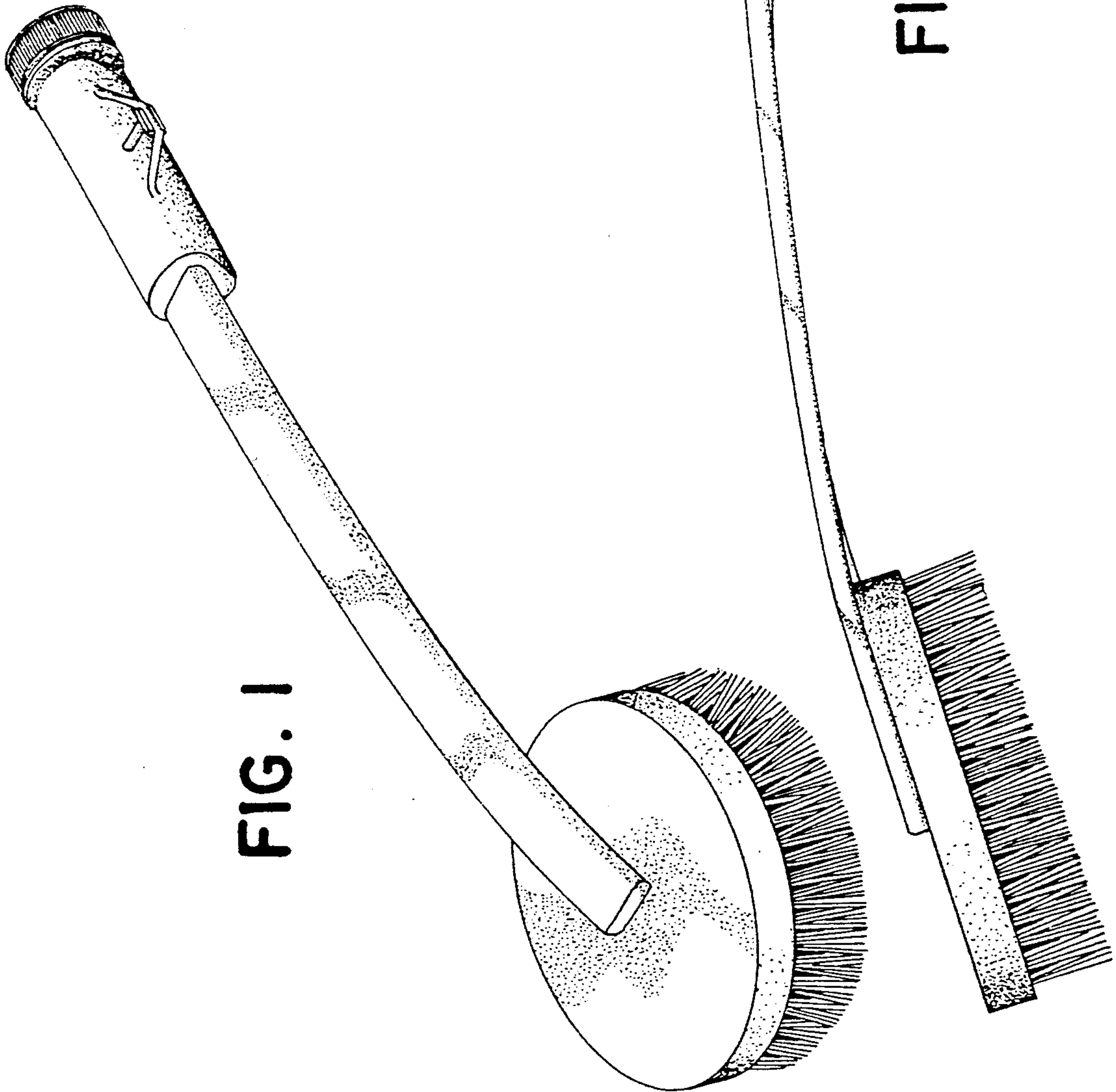

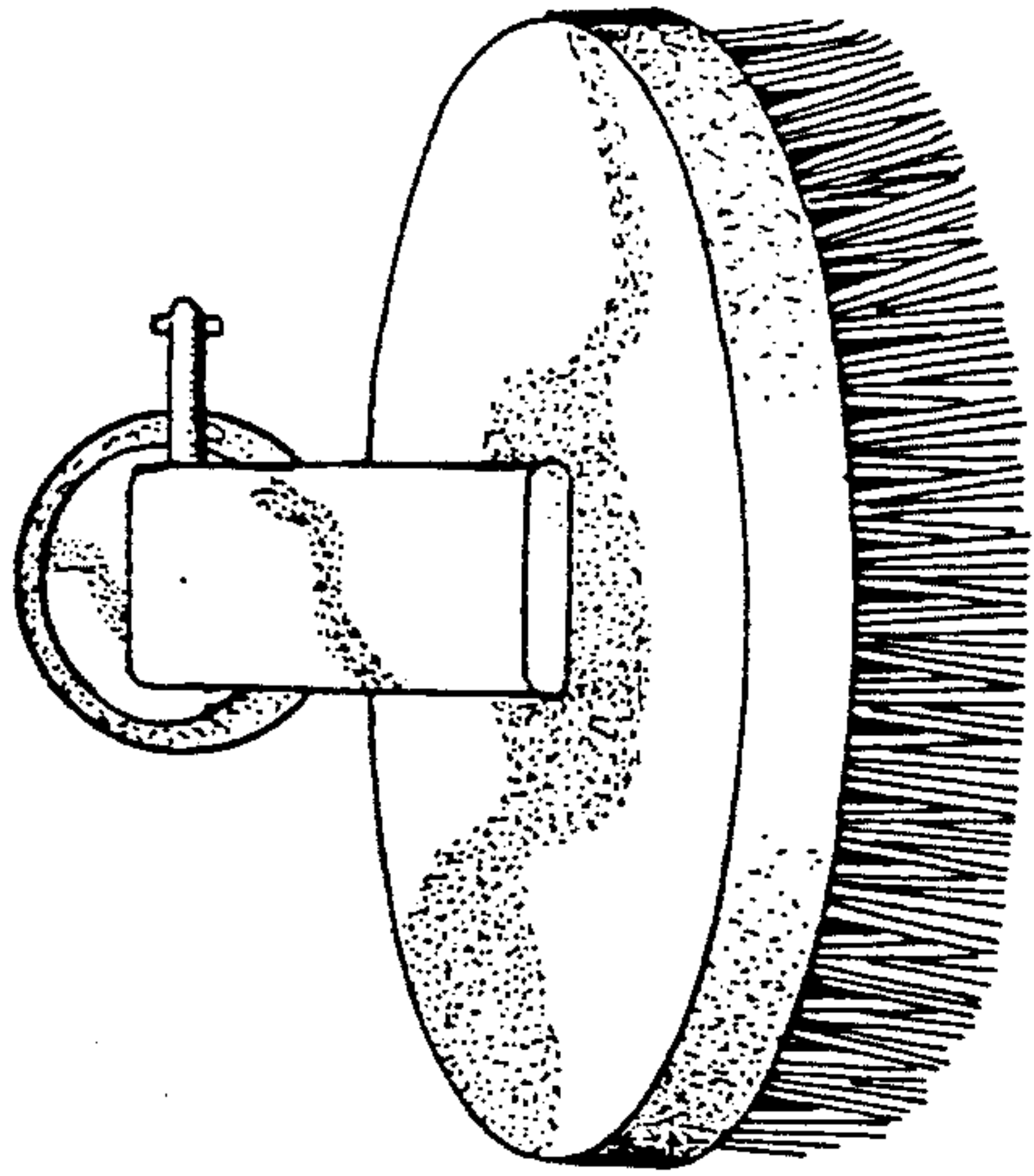

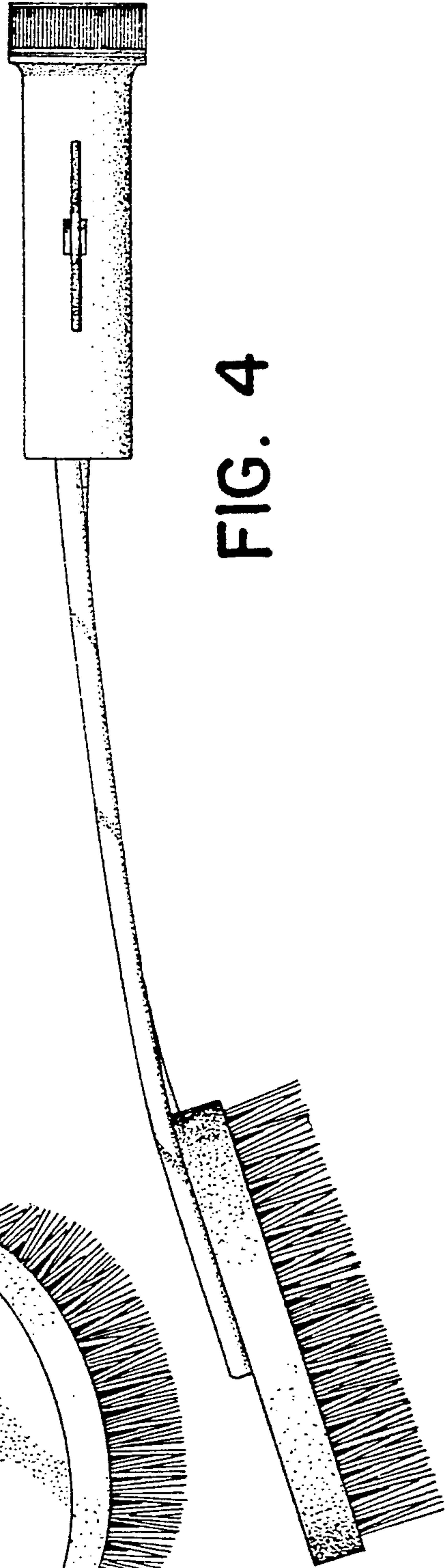

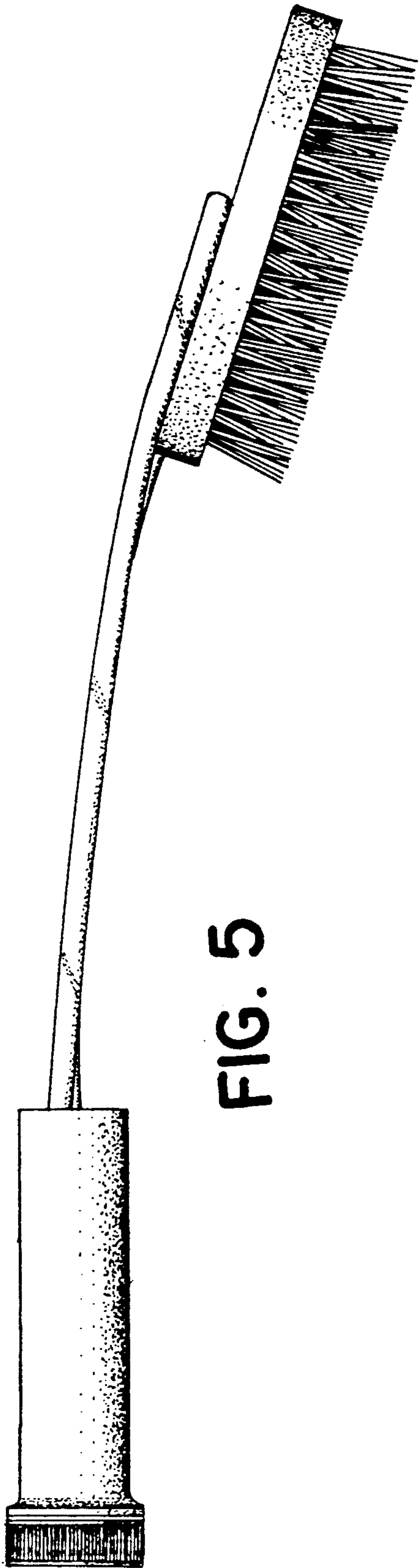

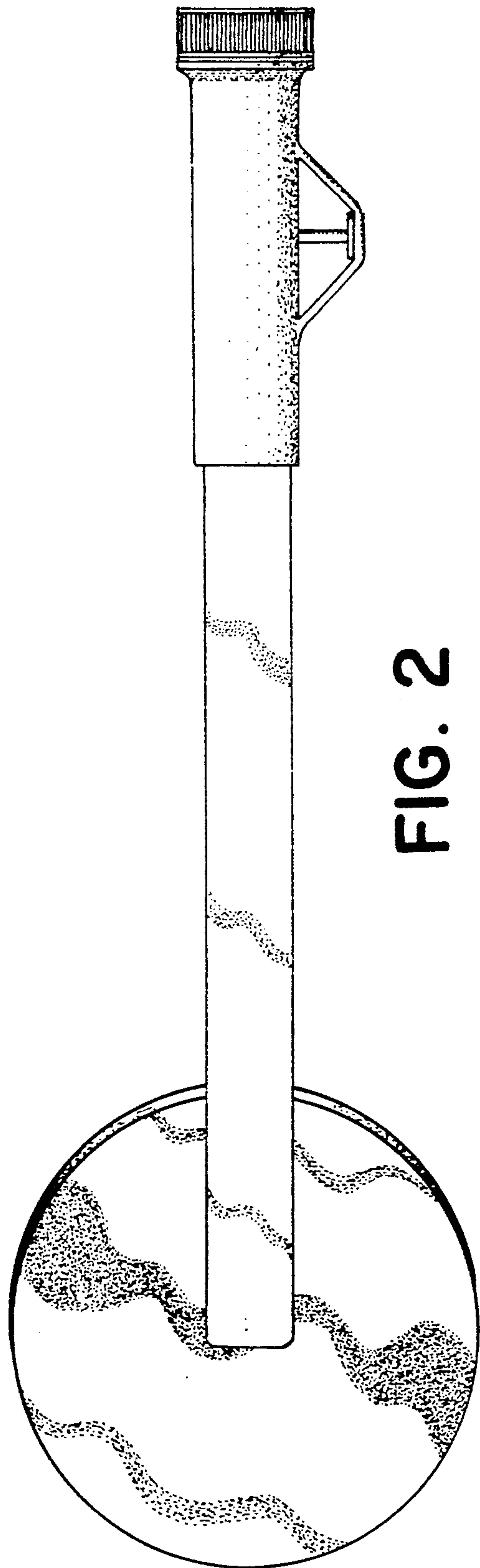

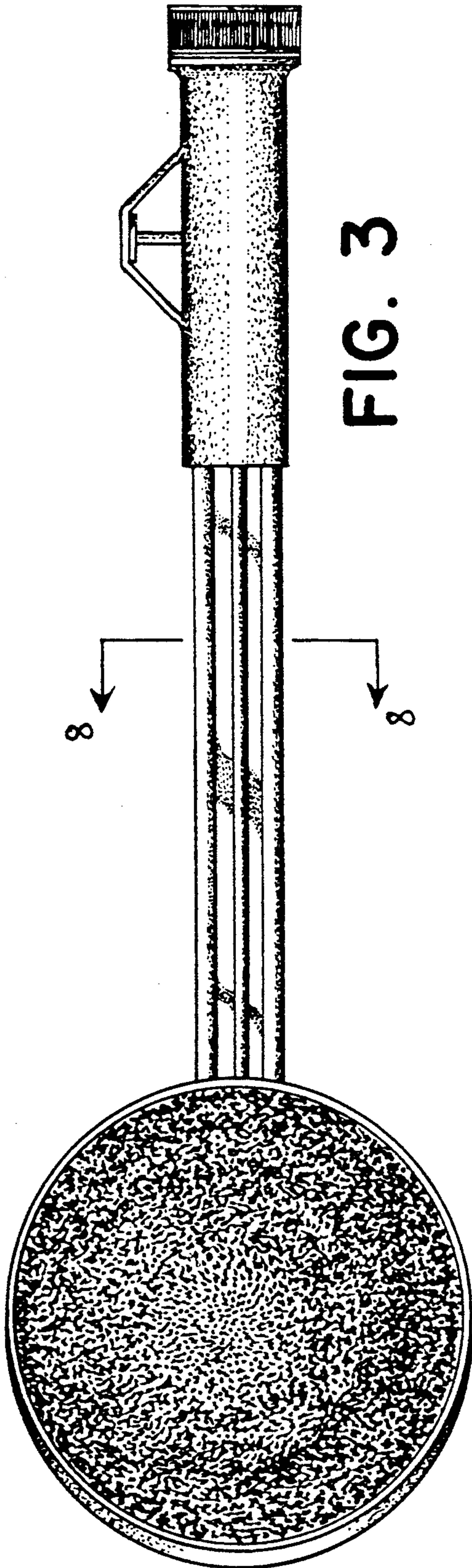

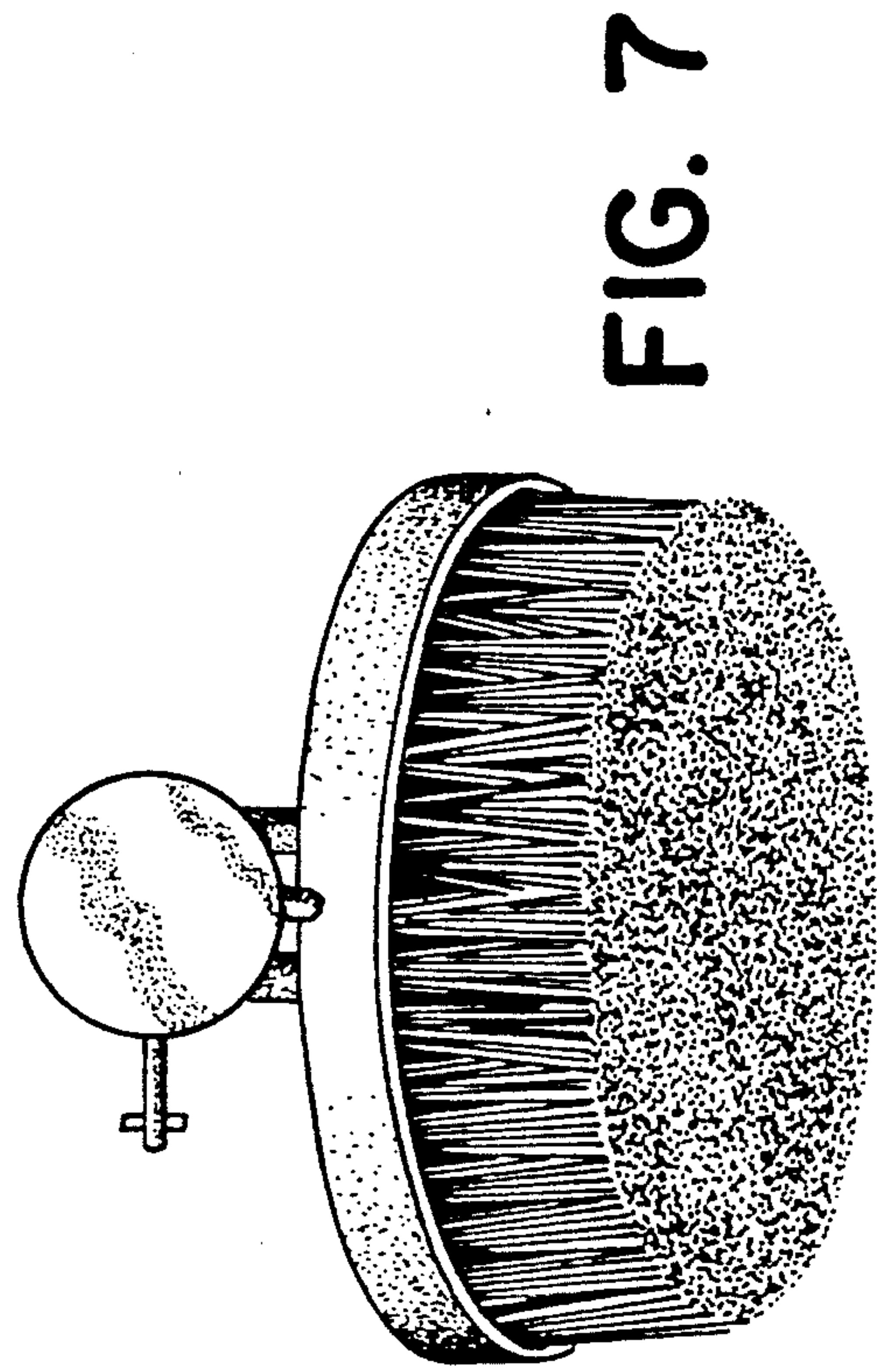
