FIG. 1 is a right front perspective view of a napkin holder showing my new design;

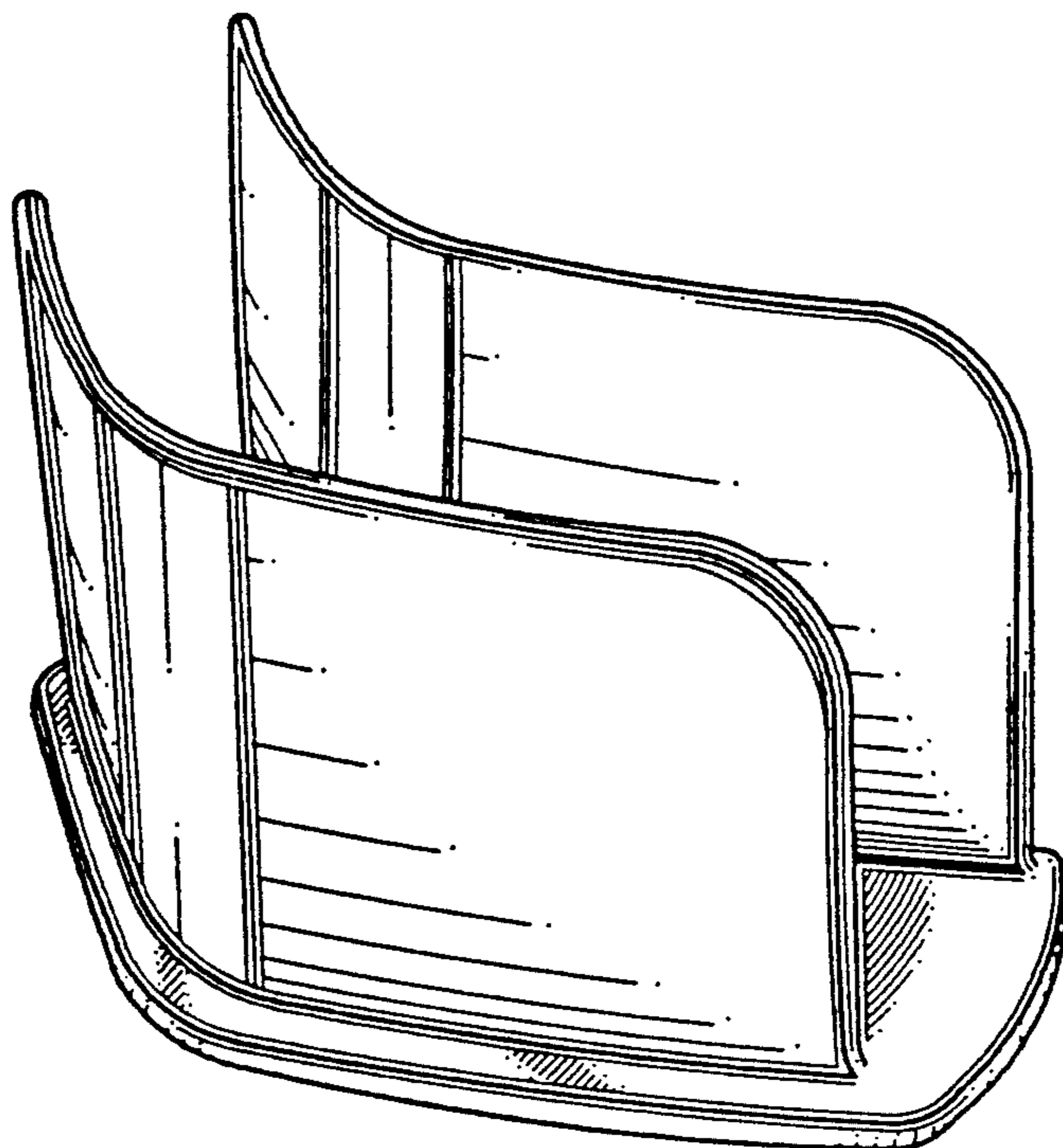
FIG. 2 is a top plan view thereof;

FIG. 6 is a front elevational view thereof.



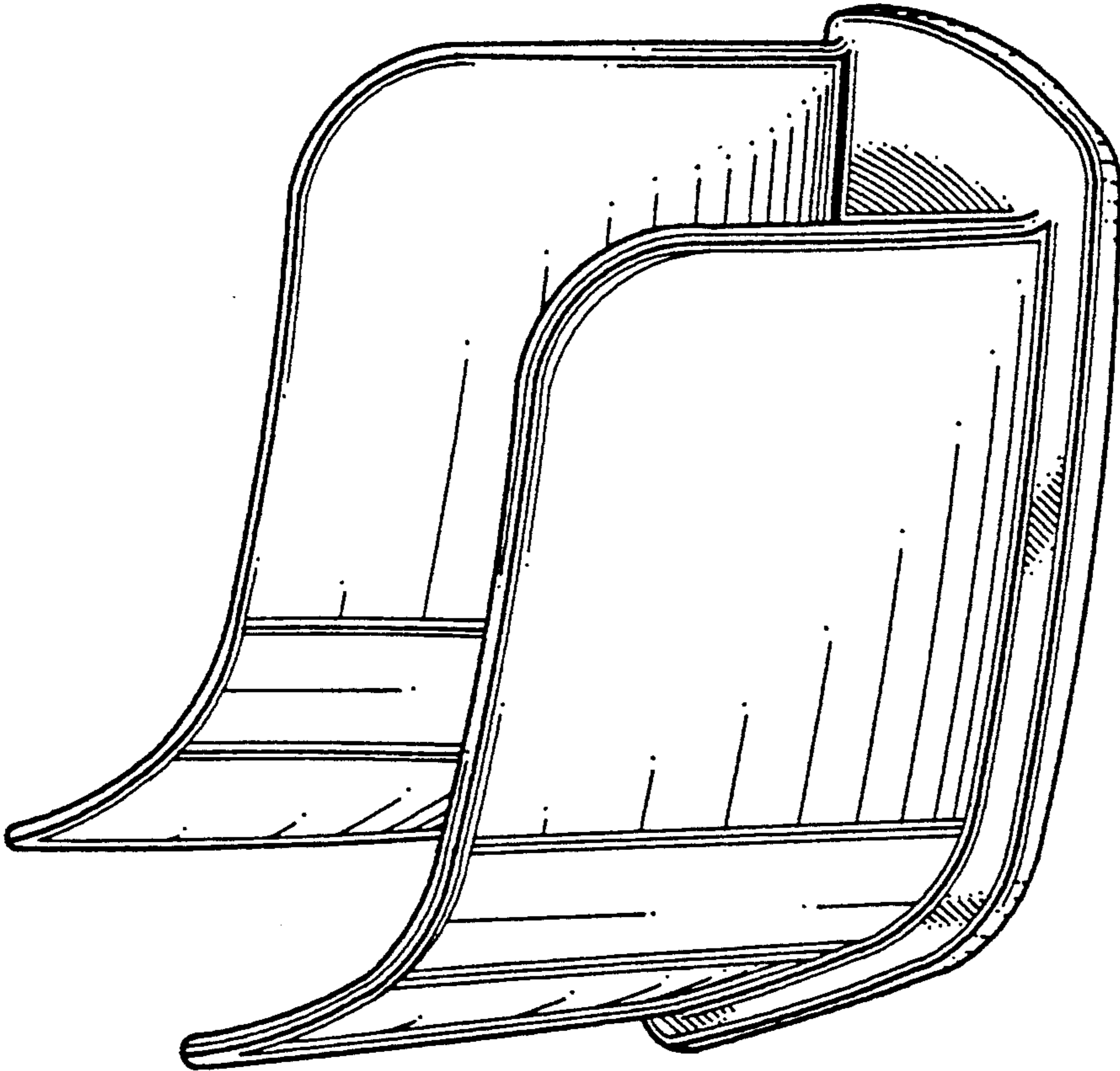

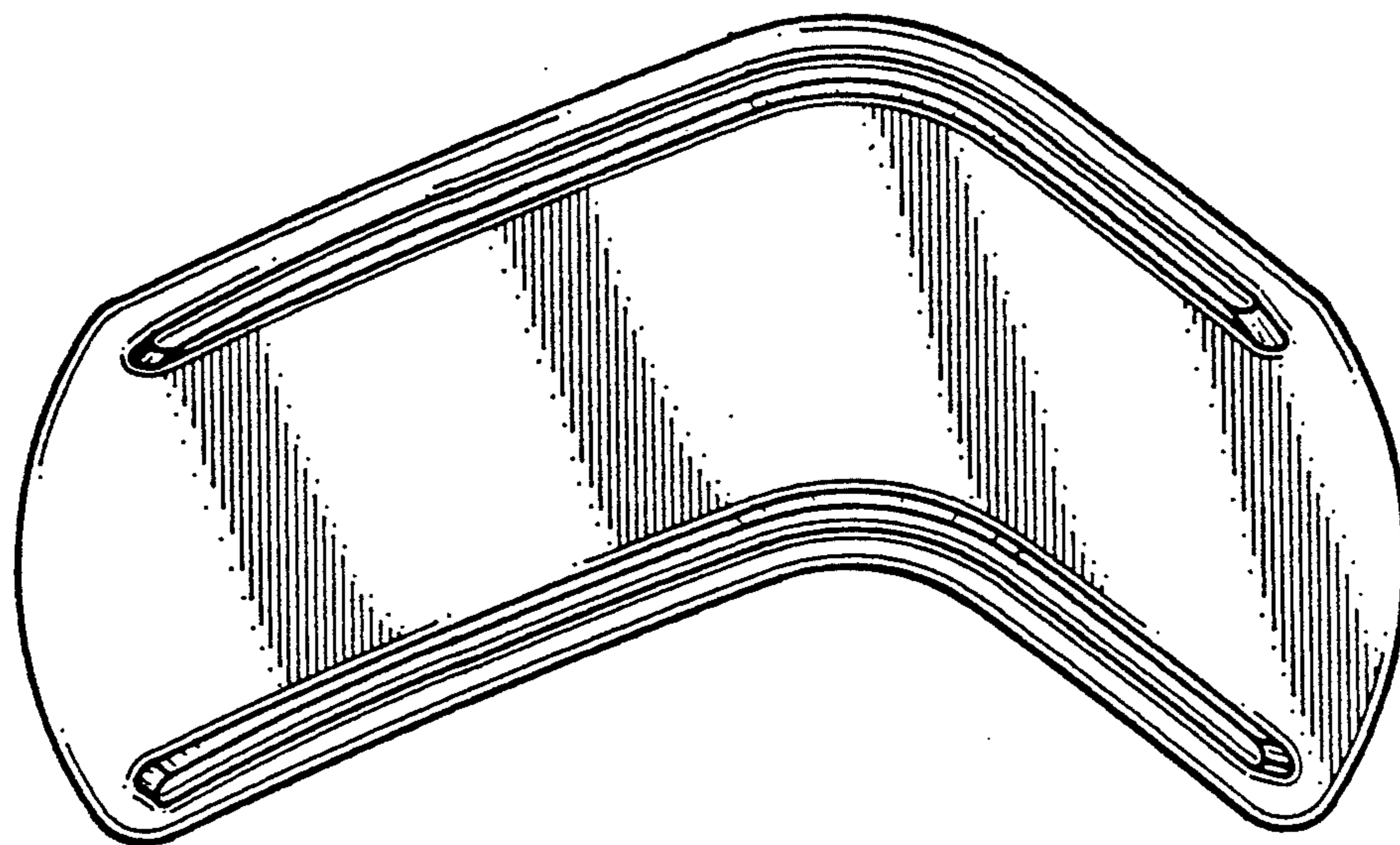

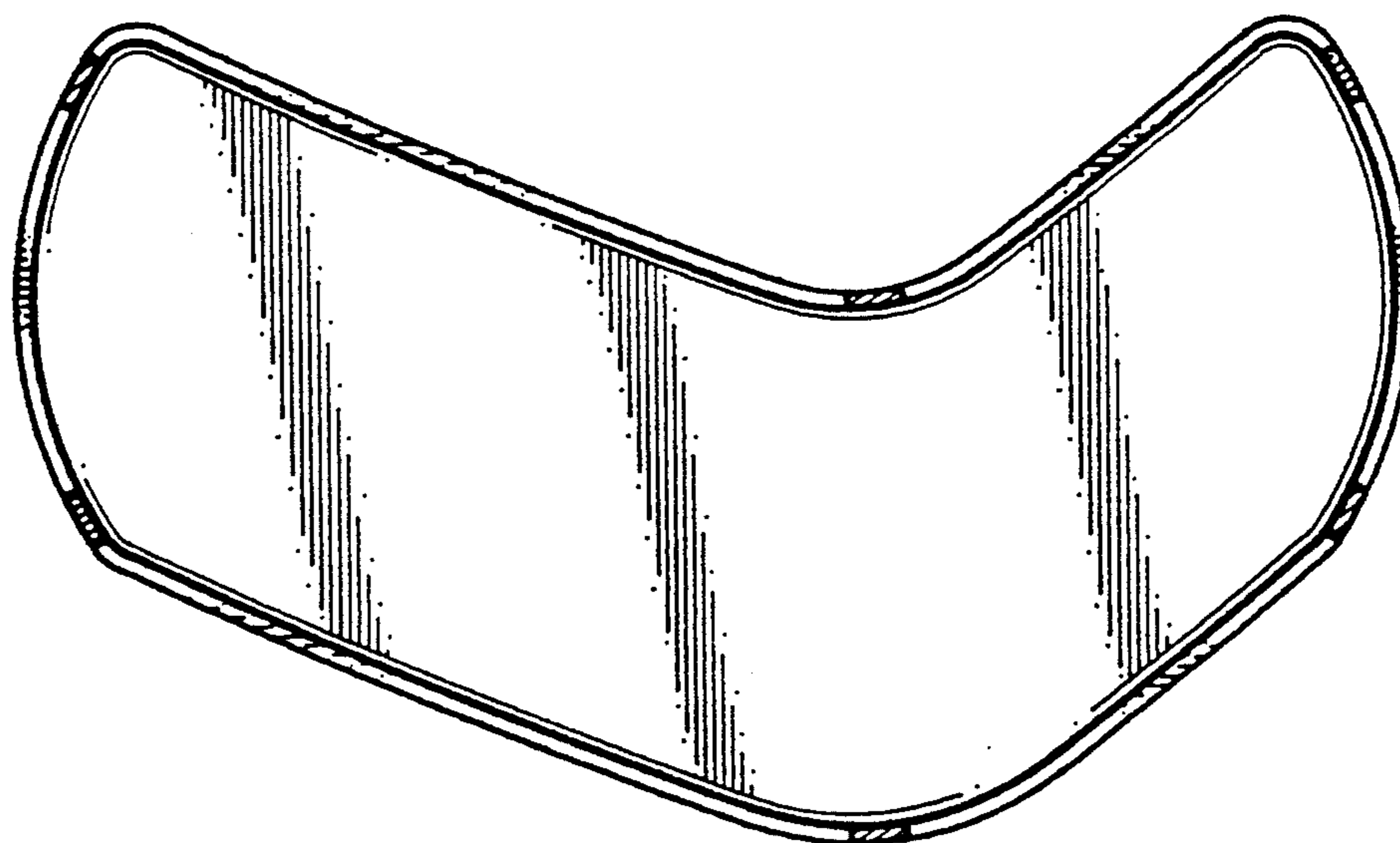

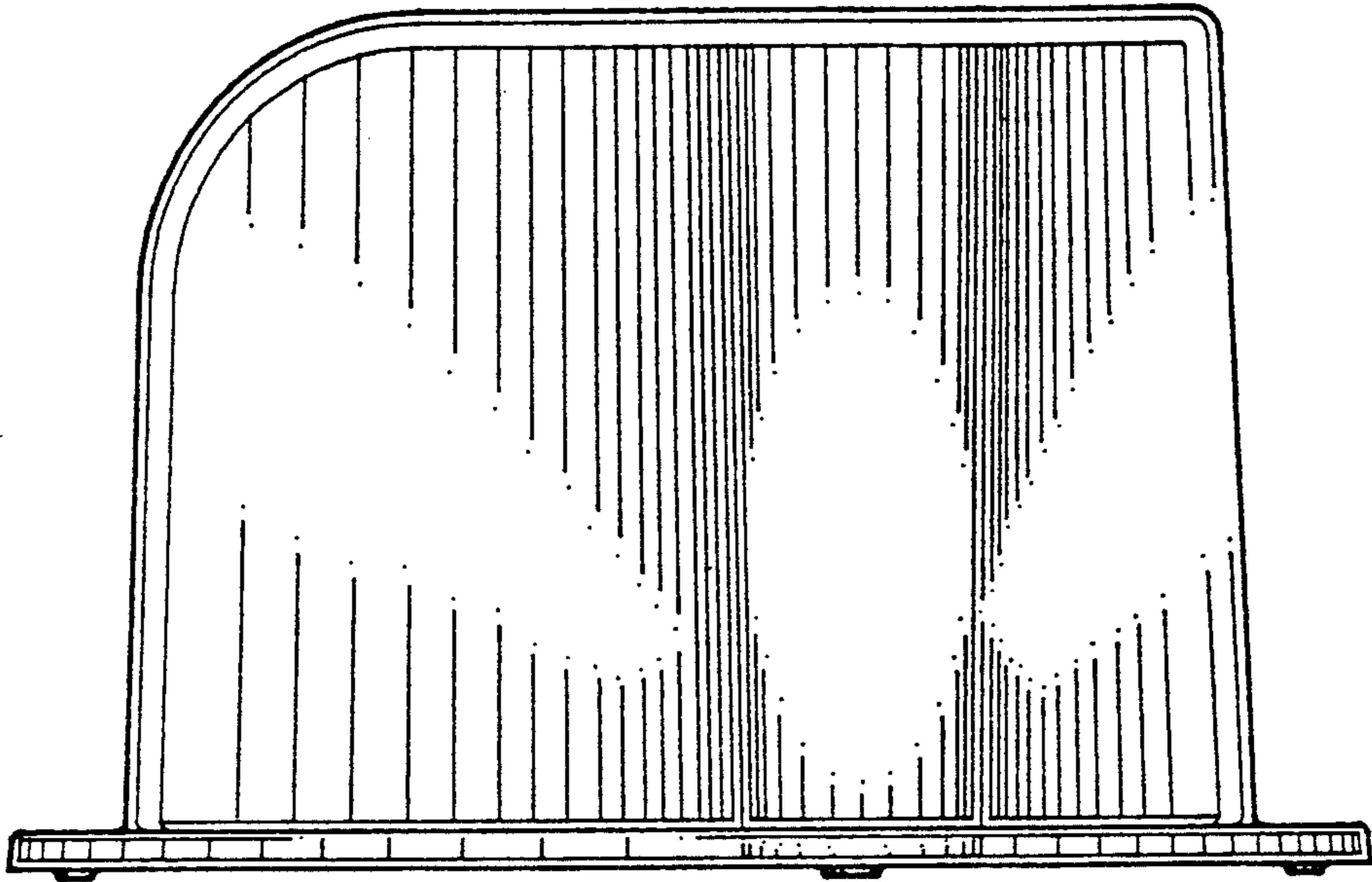

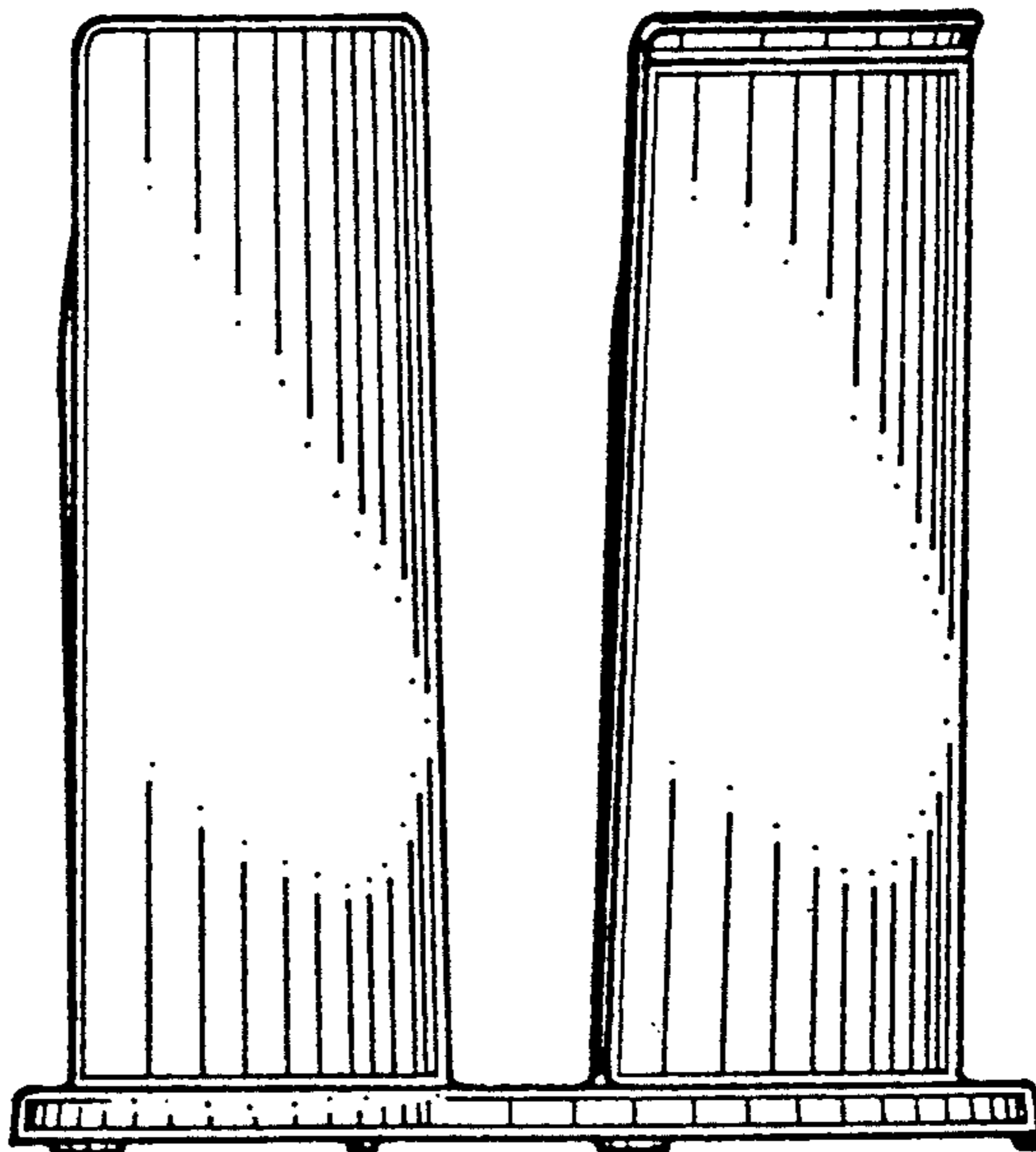

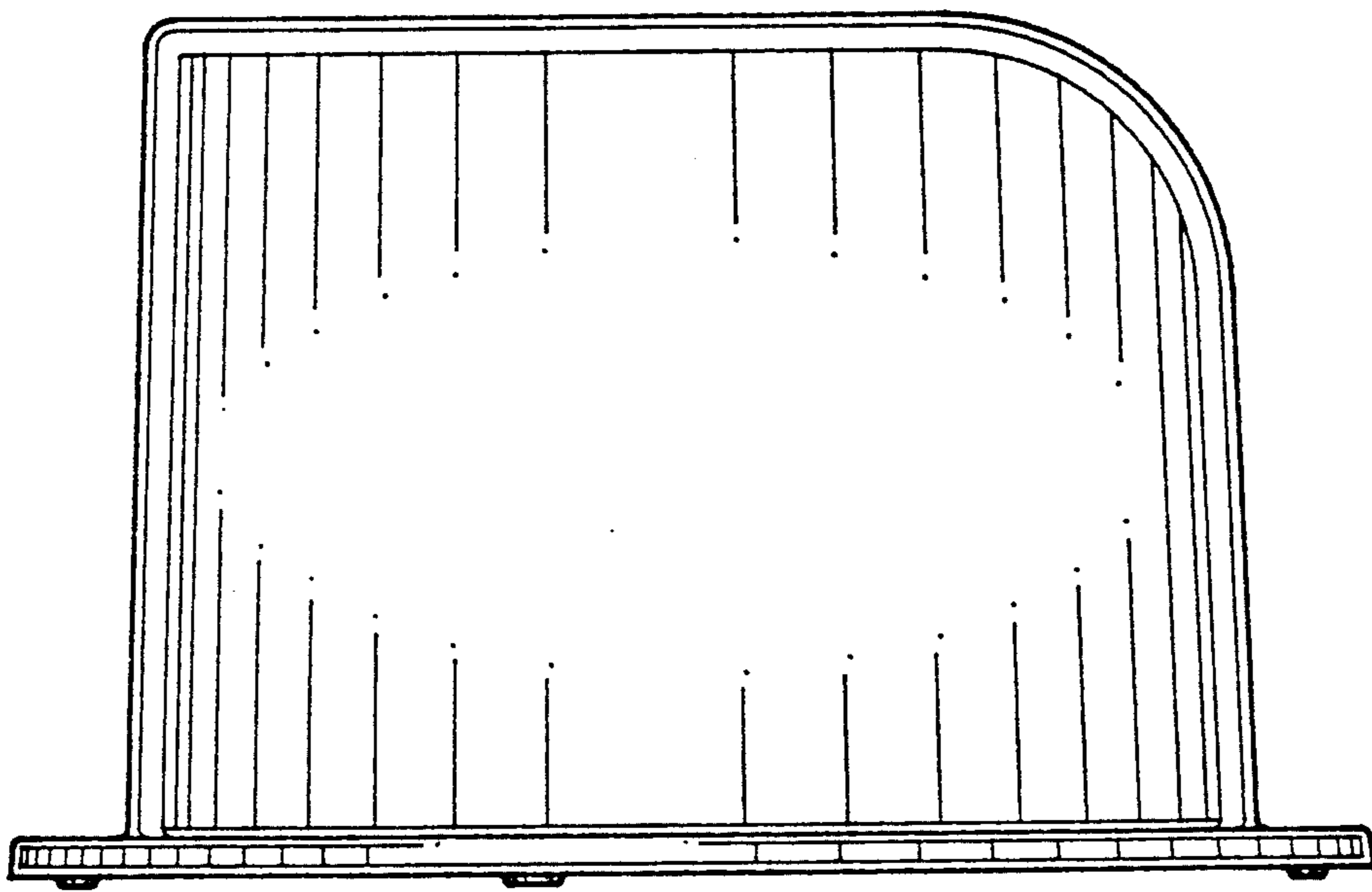
