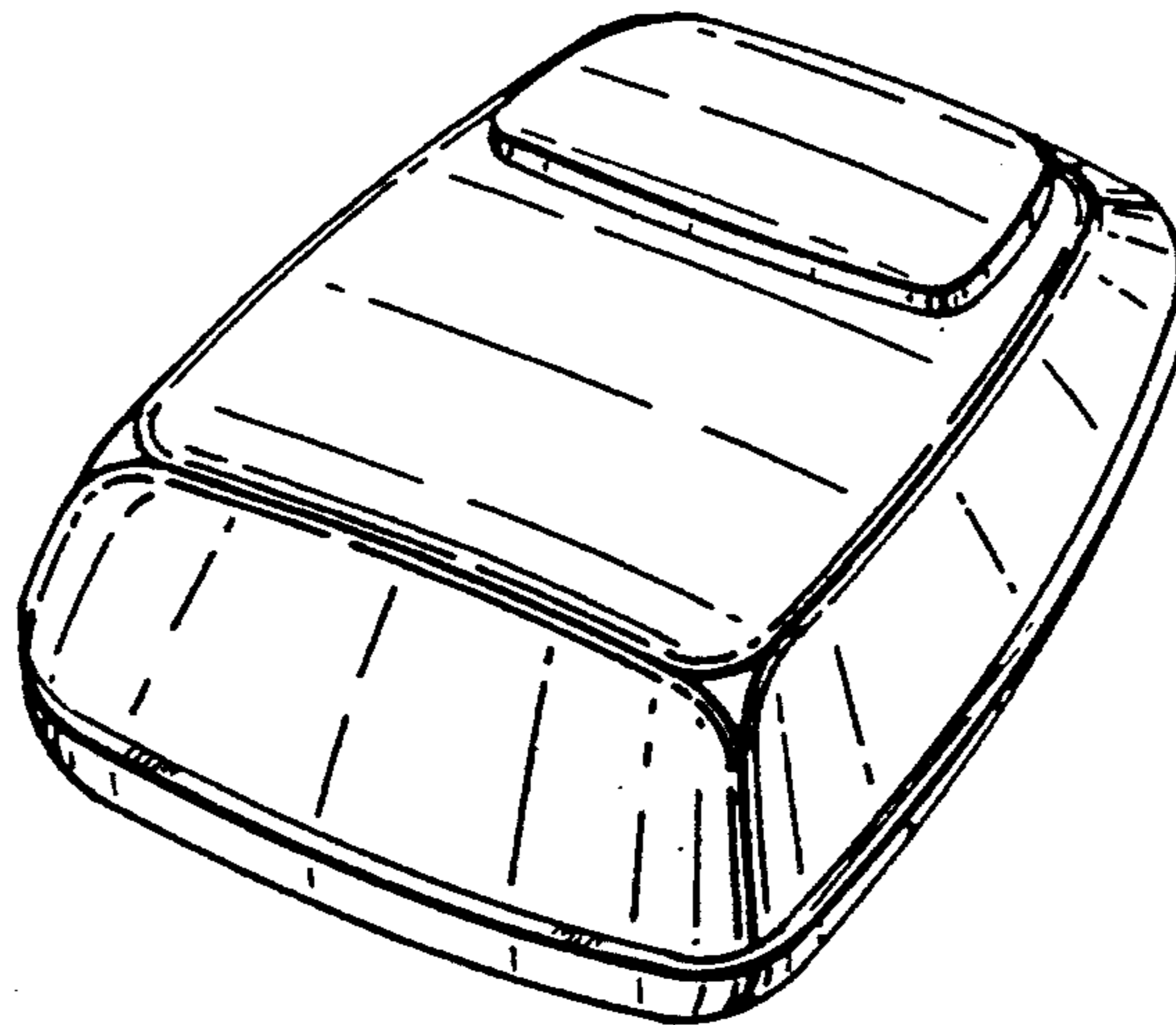

The ornamental design for a cellular phone remote control device, as shown and described.

DESCRIPTION

FIG. 1 is a rear, top, and left side perspective view of a cellular phone remote control device showing our new design;

 FIG. 6 is a rear view thereof.



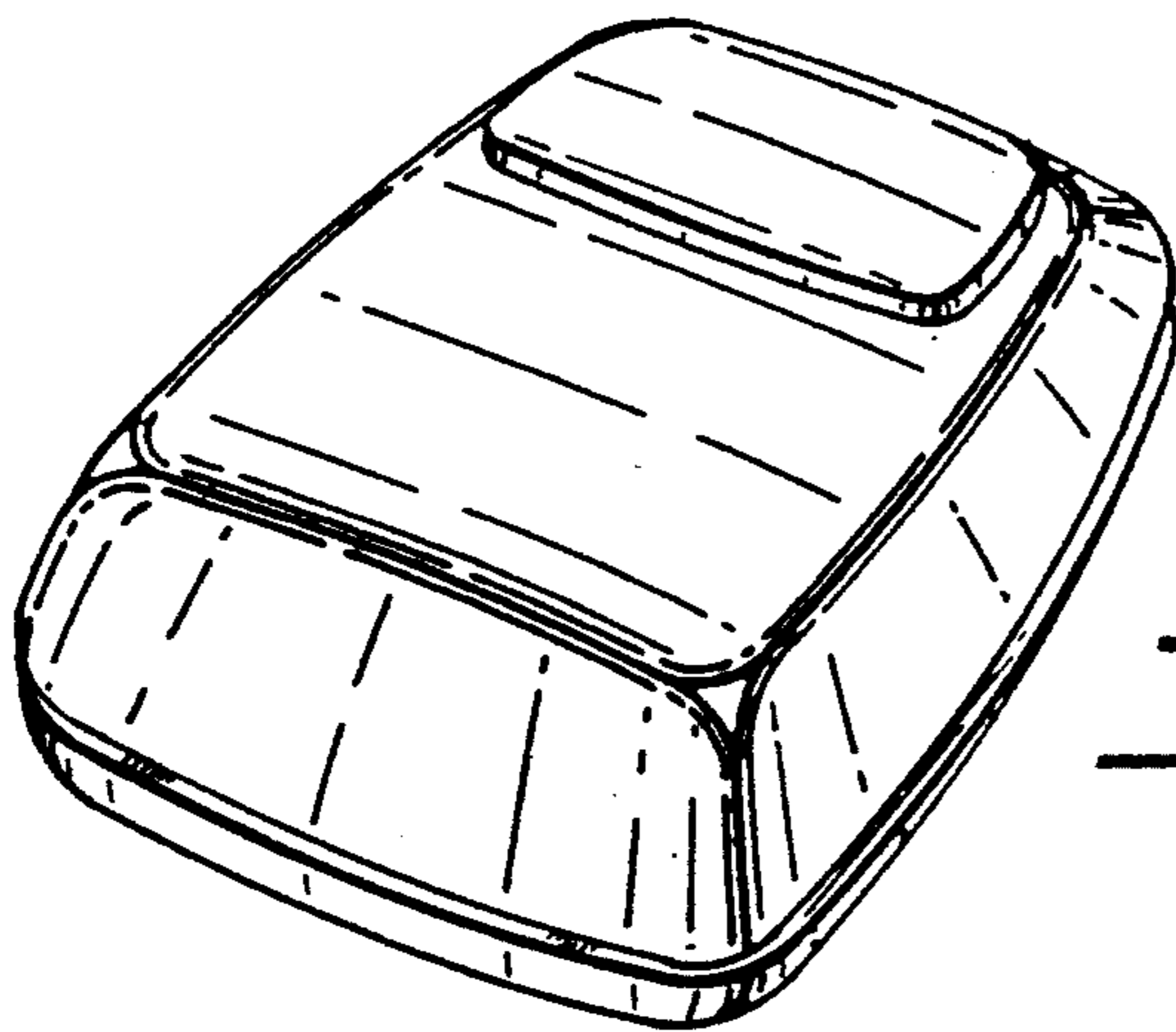

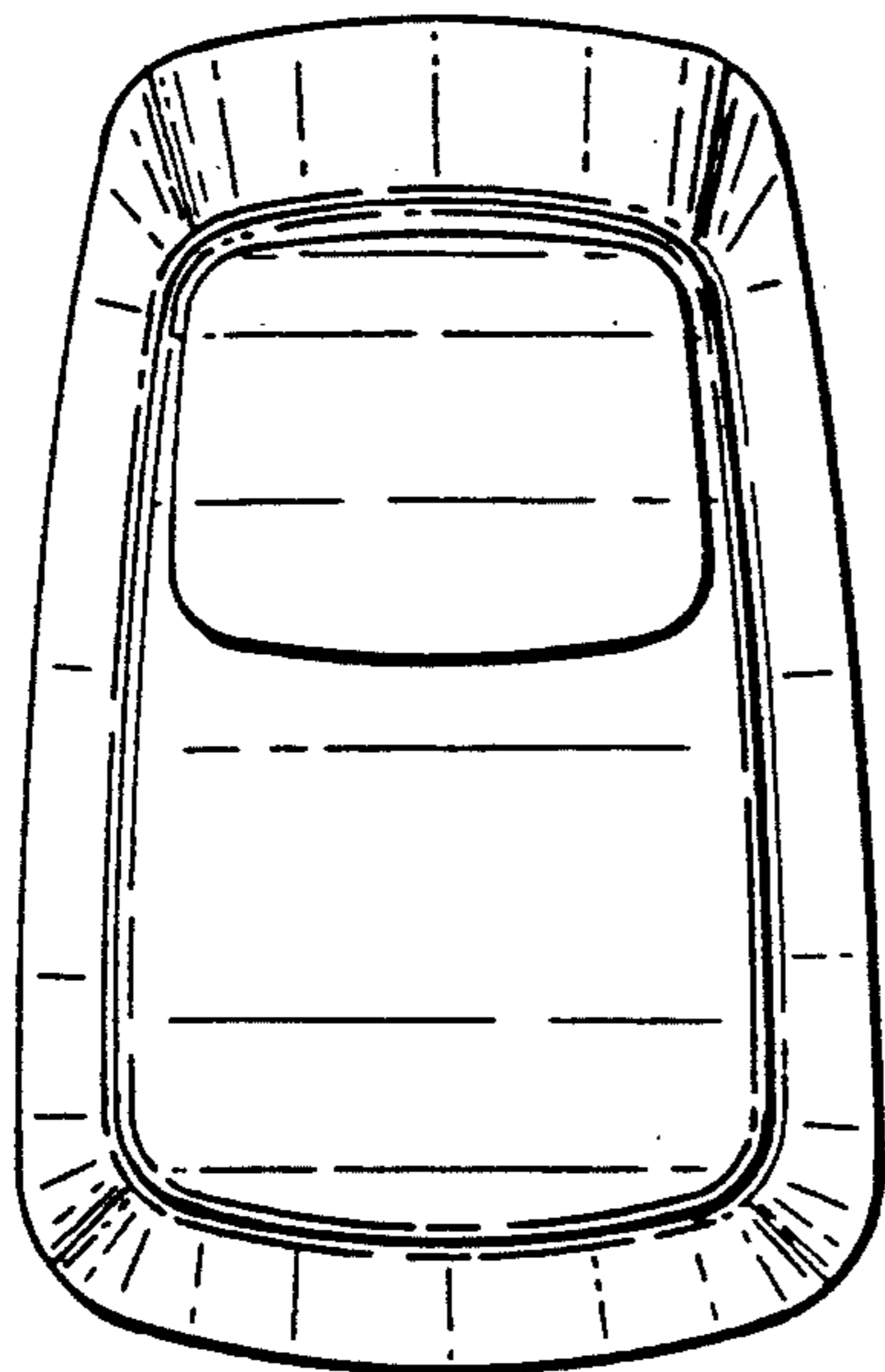

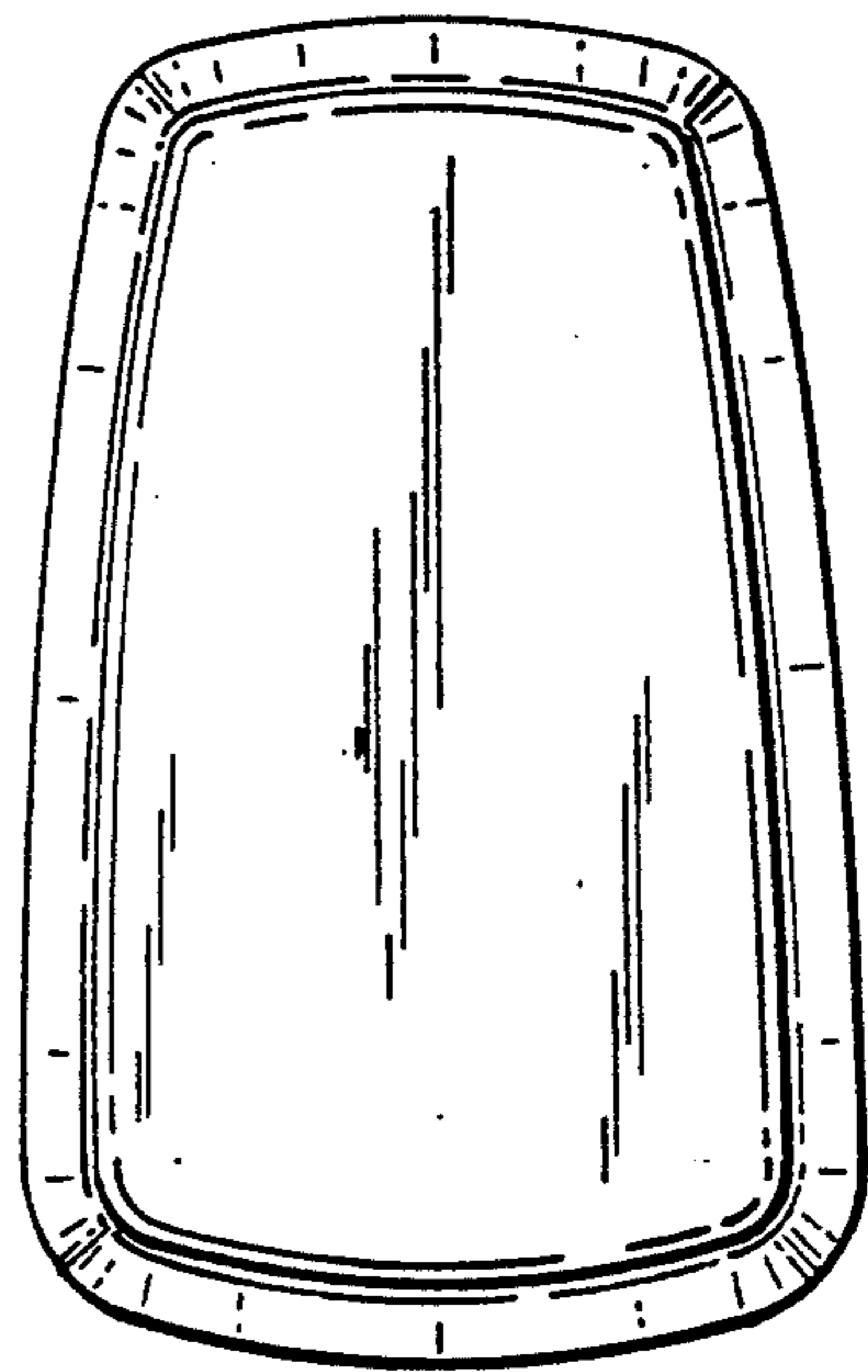

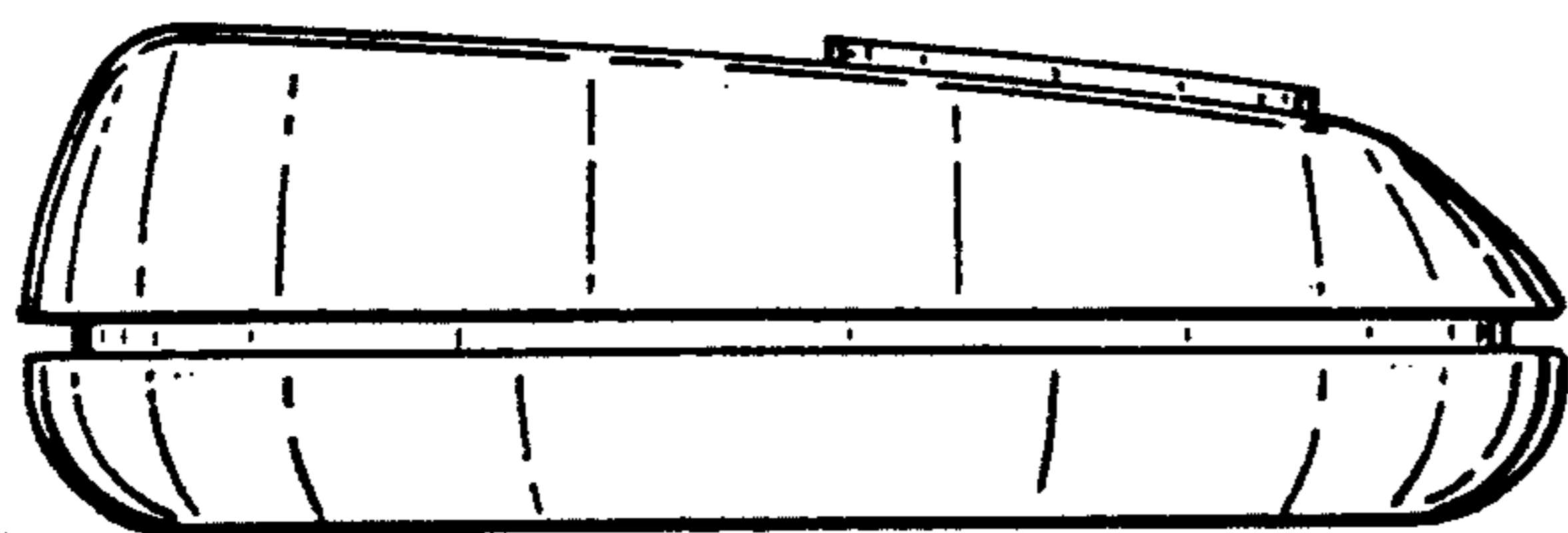

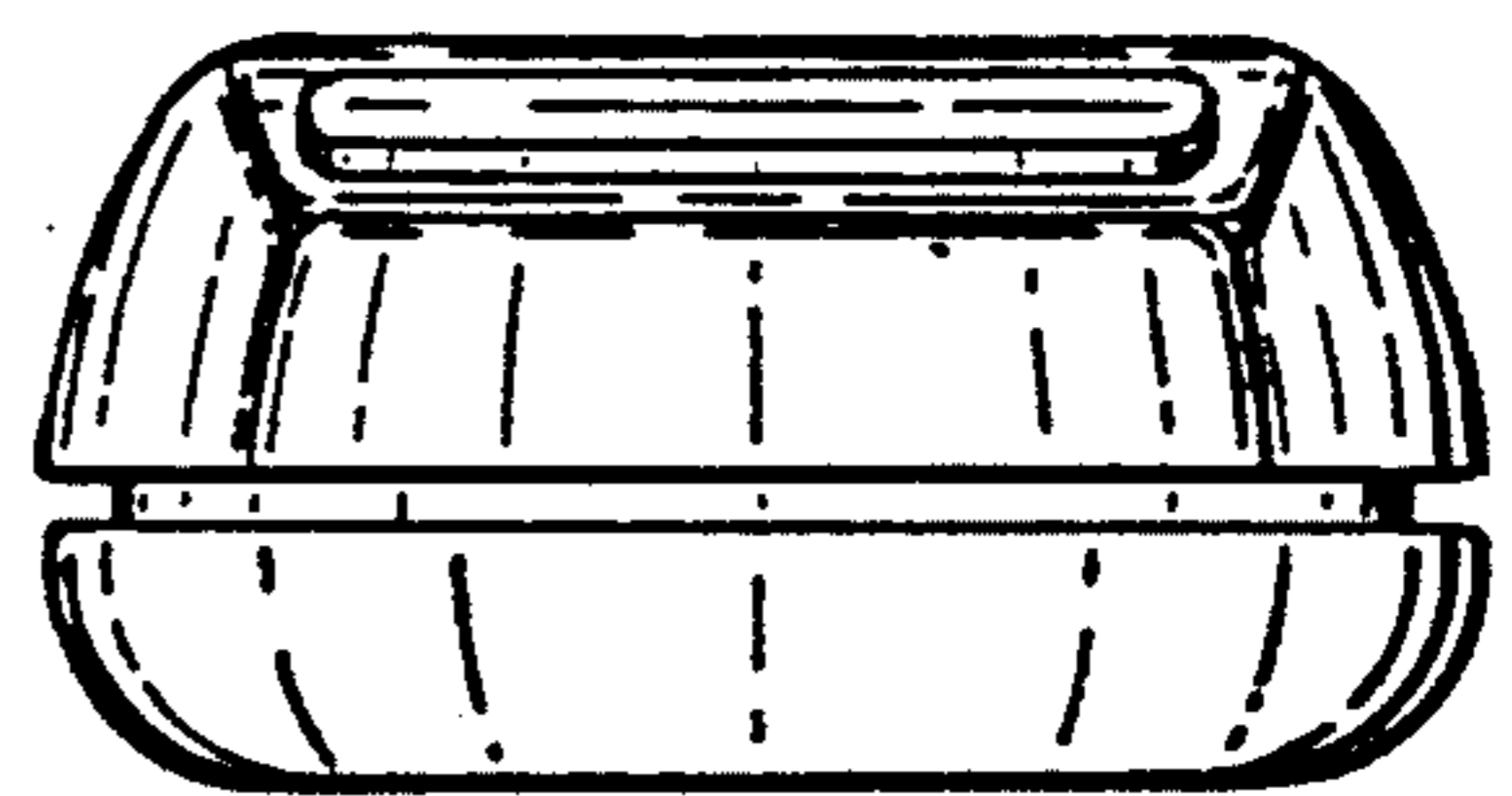
